(57) **CLAIM**

The ornamental design for a therapeutic eyelid patch with adhesive layer containing therapeutic medicines, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, left perspective view of a therapeutic eyelid patch with adhesive layer containing therapeutic medicines showing our new design;  
FIG. 2 is a top plan view thereof, the bottom plan view being a mirror image thereof;  
FIG. 3 is a front view thereof;  
FIG. 4 is a rear view thereof;  
FIG. 5 is a right side elevational view thereof, the left side elevational view being a mirror image thereof; and,  
FIG. 6 is a perspective view thereof, the broken line showing a person's head illustrating an environment of use and forming no part of the claimed design.

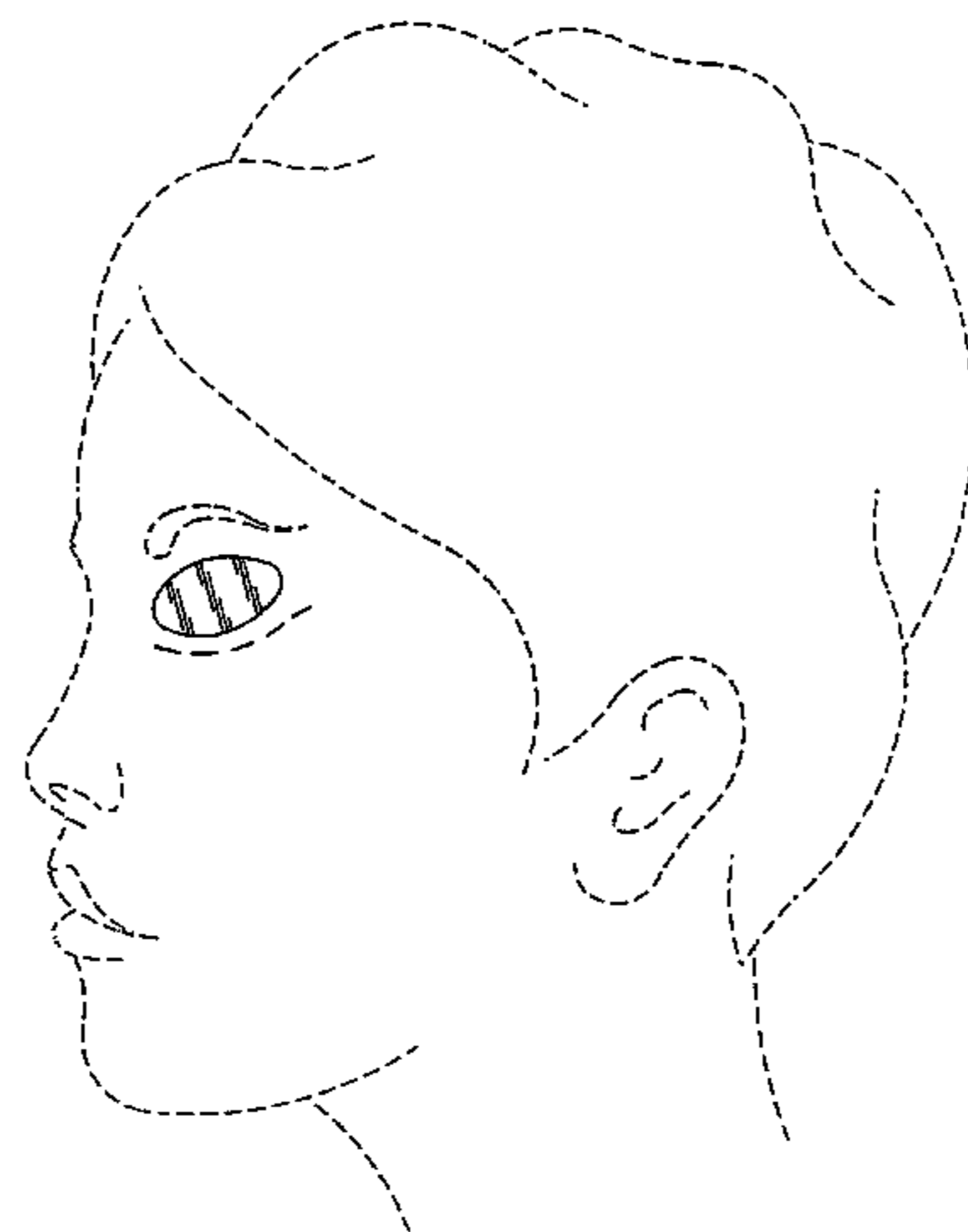

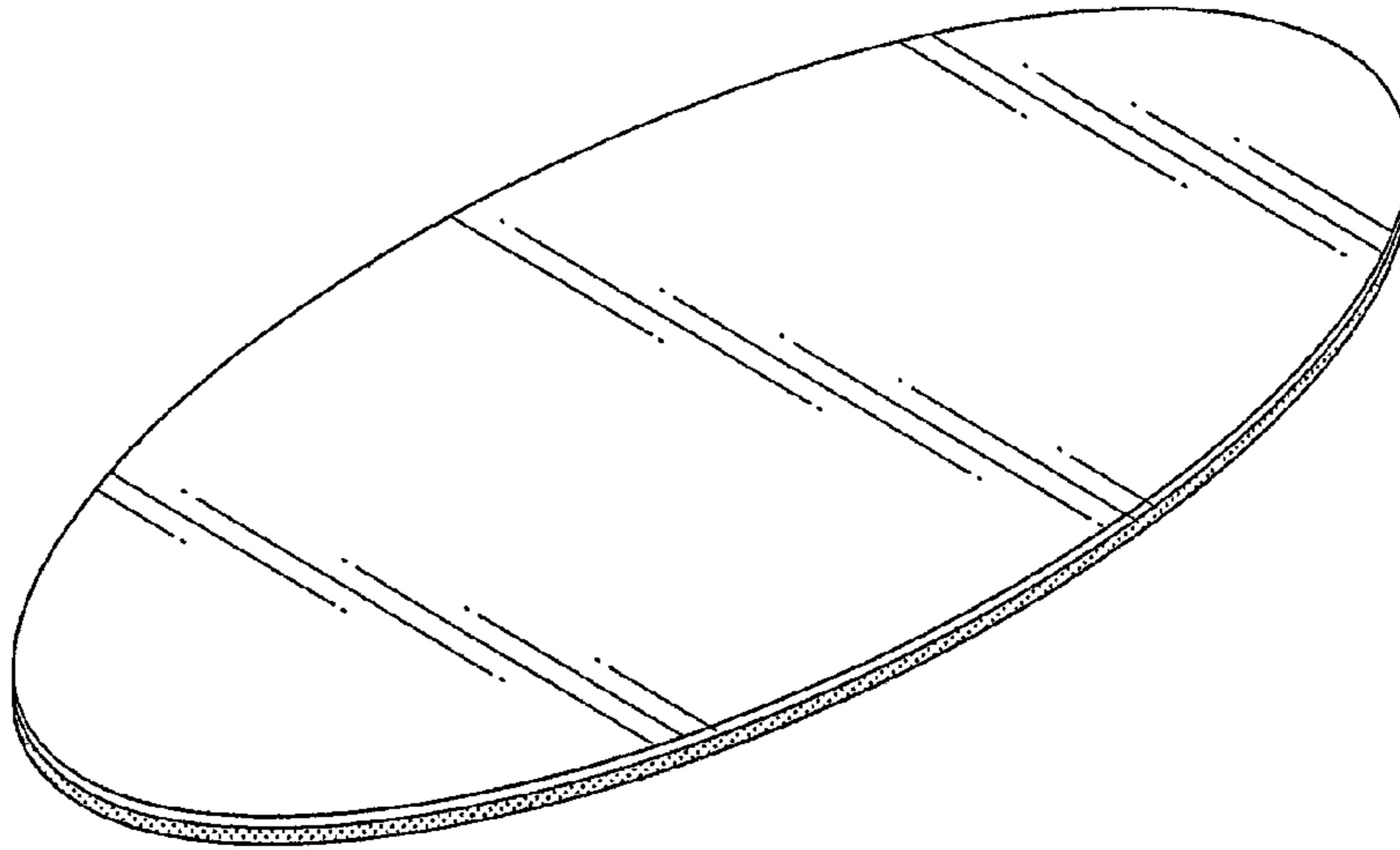

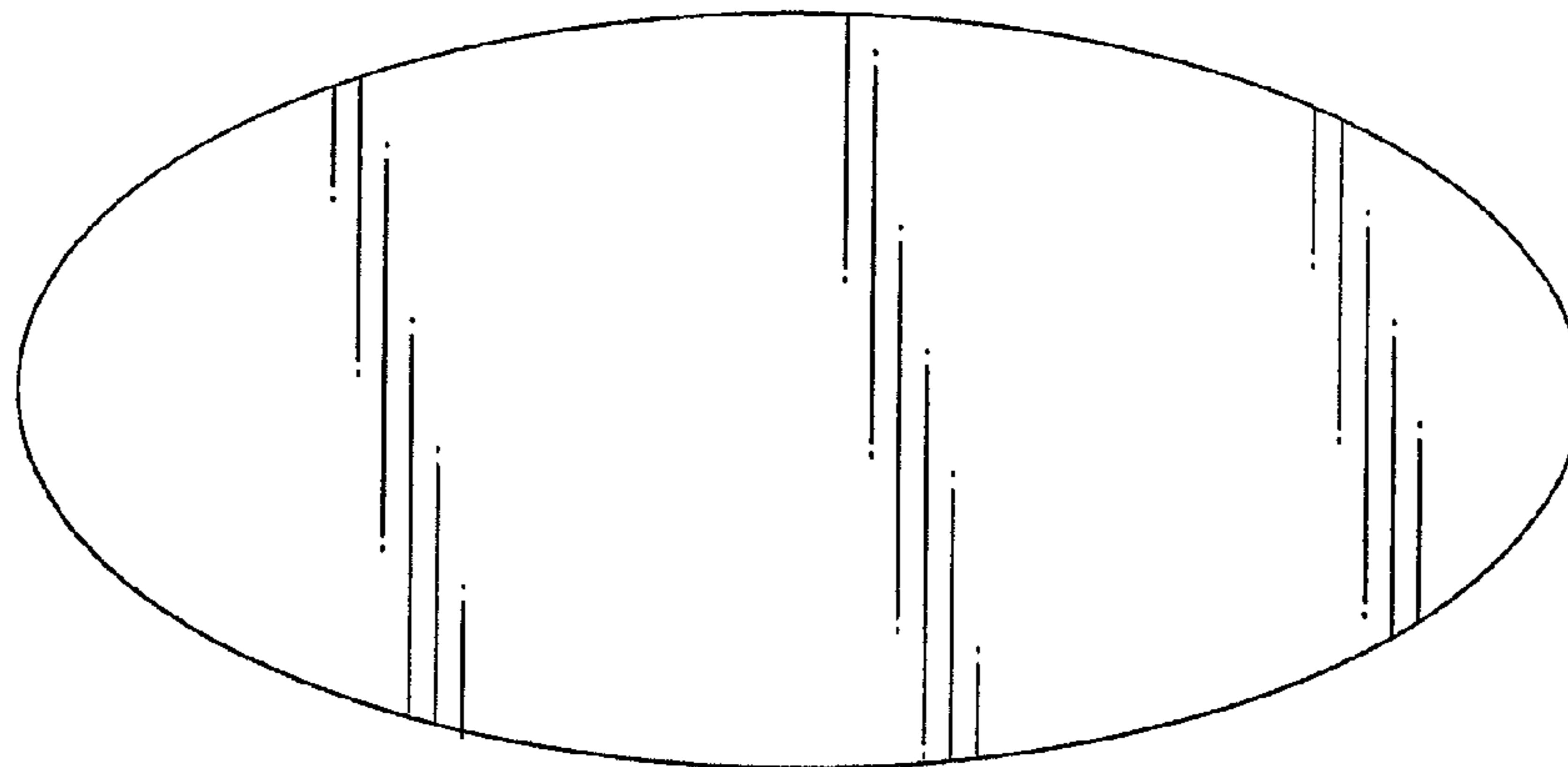

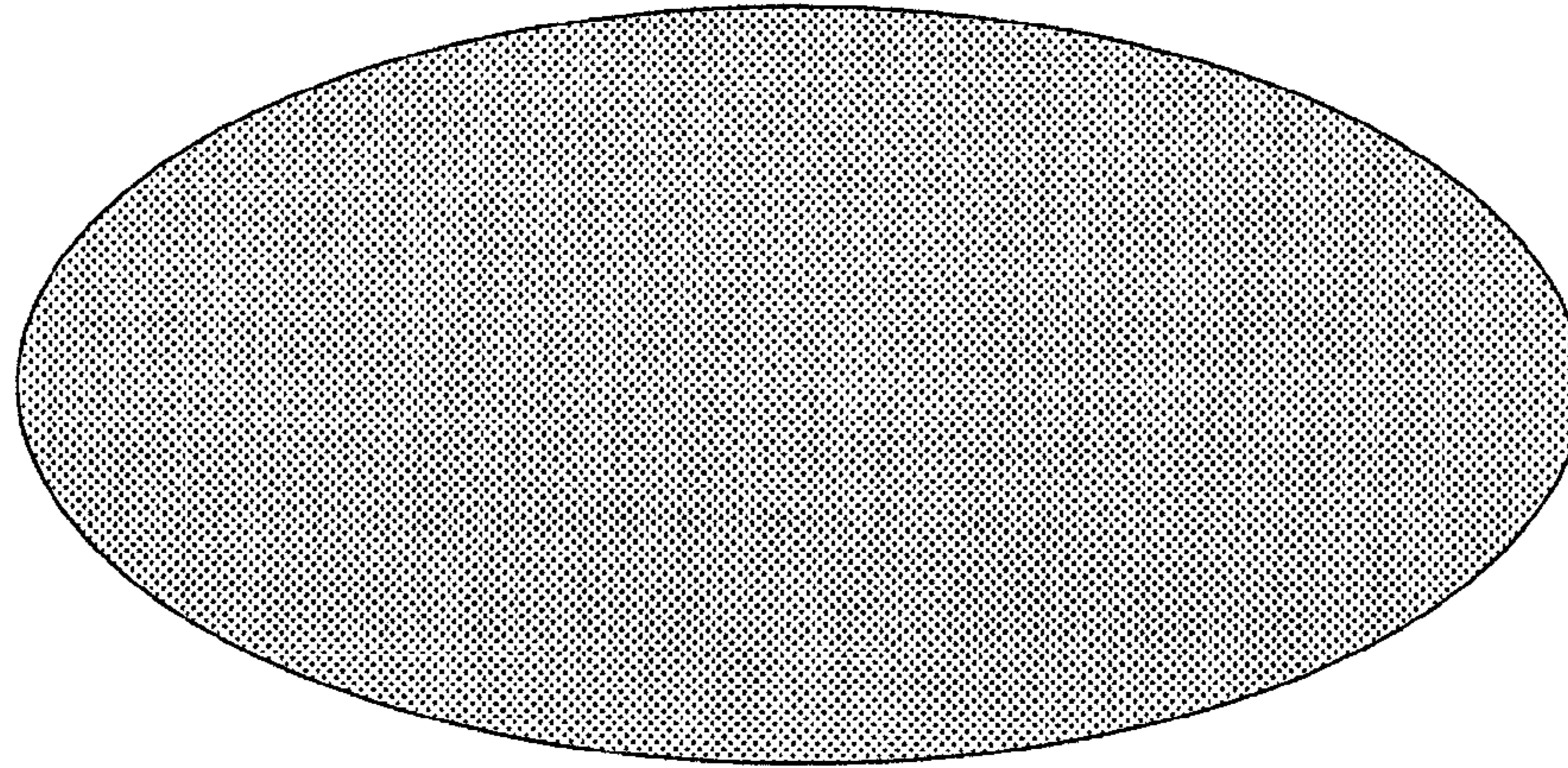
