(57) **CLAIM**
I claim ornamental design for an interlocking rail barrier, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an interlocking rail barrier; FIG. 2 is a sectional view of the interlocking rail barrier of FIG. 1 taken along line 2-2; FIG. 3 is a front perspective view of the rail barrier FIG. 1; FIG. 4 is a back perspective view of the rail barrier of FIG. 1; FIG. 5 is a back view of the rail barrier of FIG. 1; FIG. 6 is a side view of the rail barrier of FIG. 1; FIG. 7 is a top elevation view of an interlocking rail barrier. FIG. 8 is a bottom elevation view of an interlocking rail barrier. FIG. 9 is a front view of the rail barrier of FIG. 1; and, FIG. 10 is a perspective view of two rail barriers of FIG. 1. The dashed lines are provided for illustrative purposes only and form no part of the claimed design.

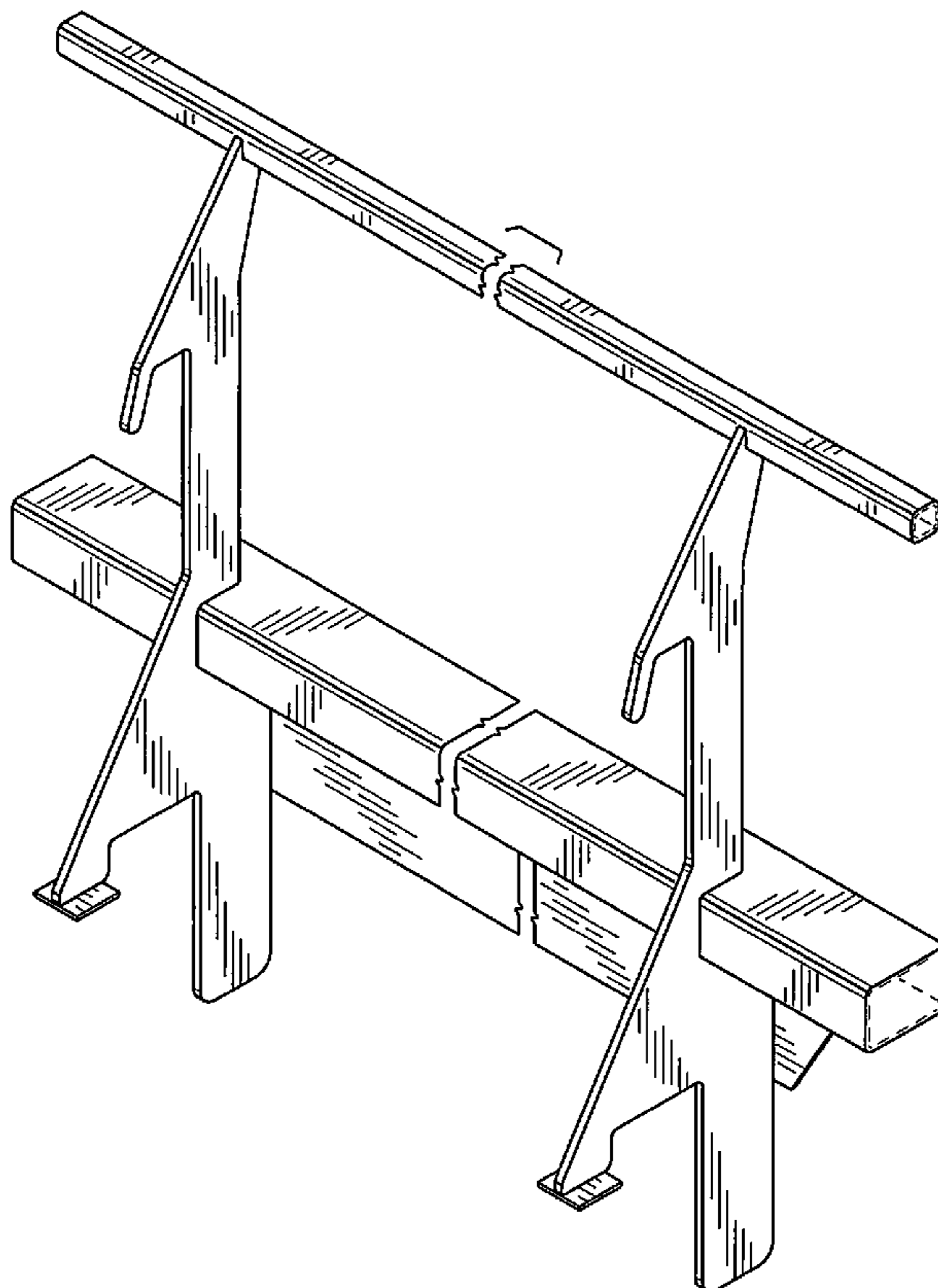

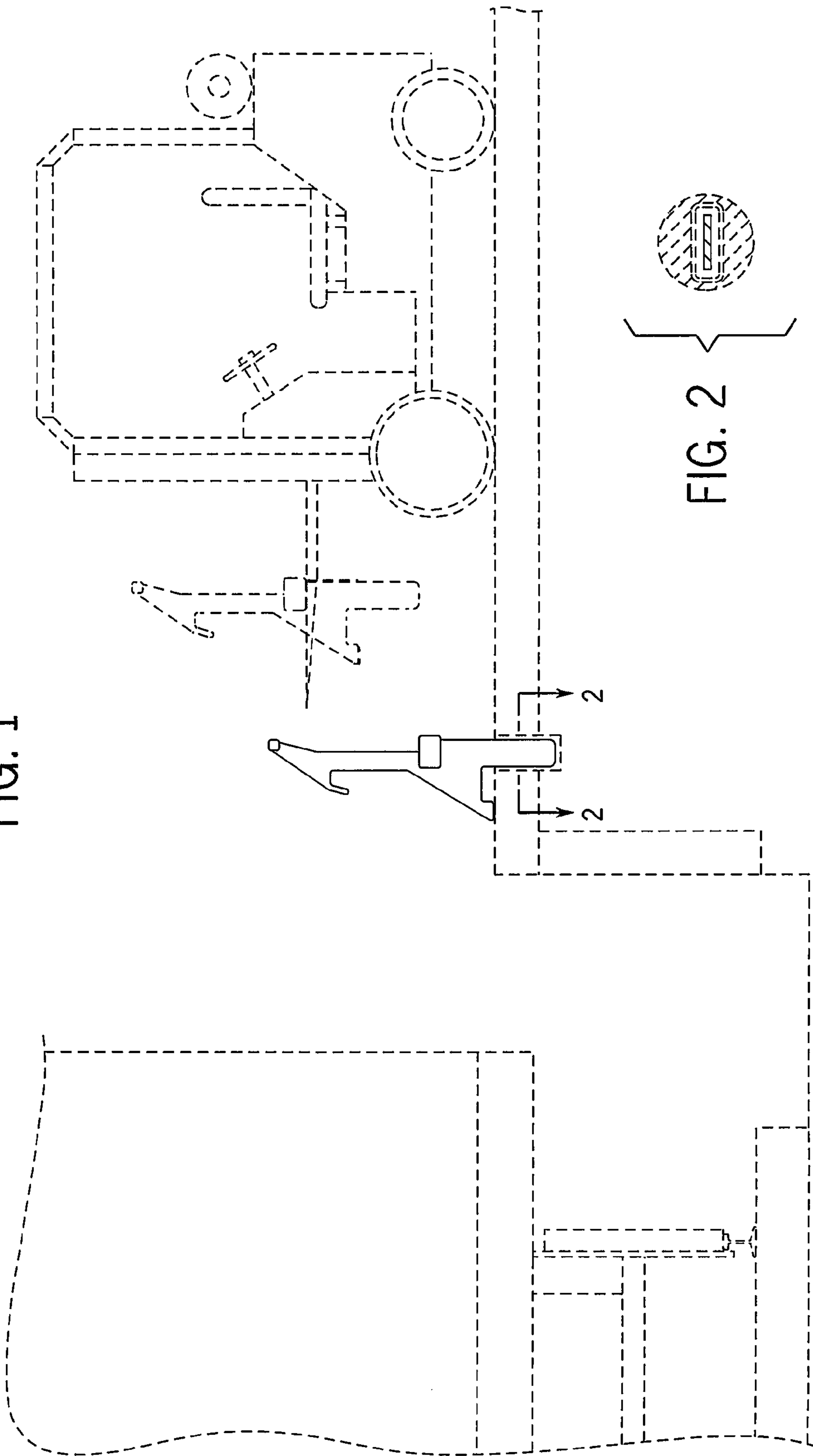
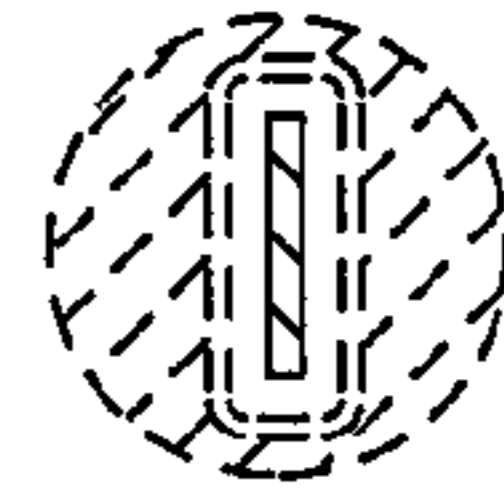

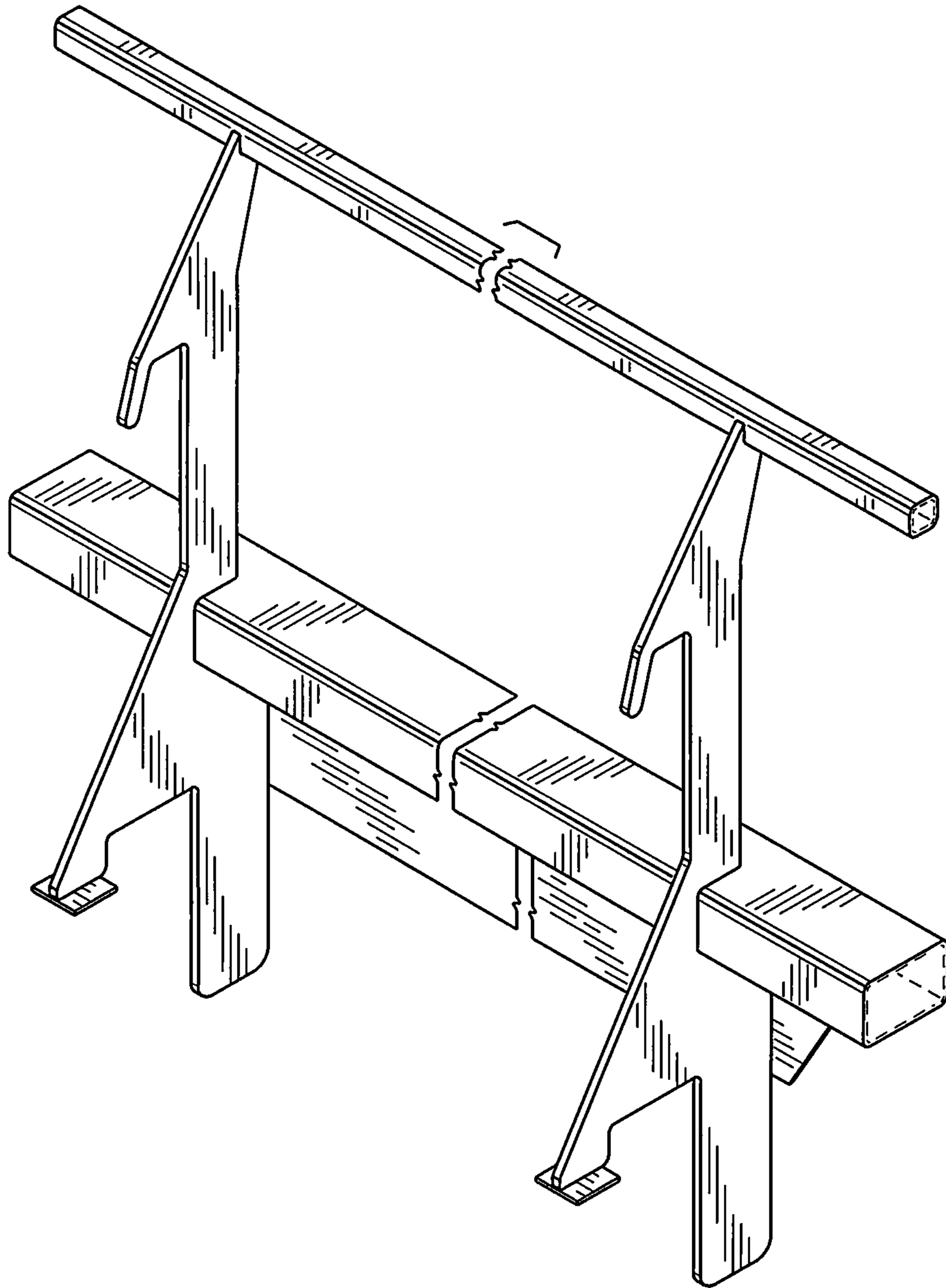

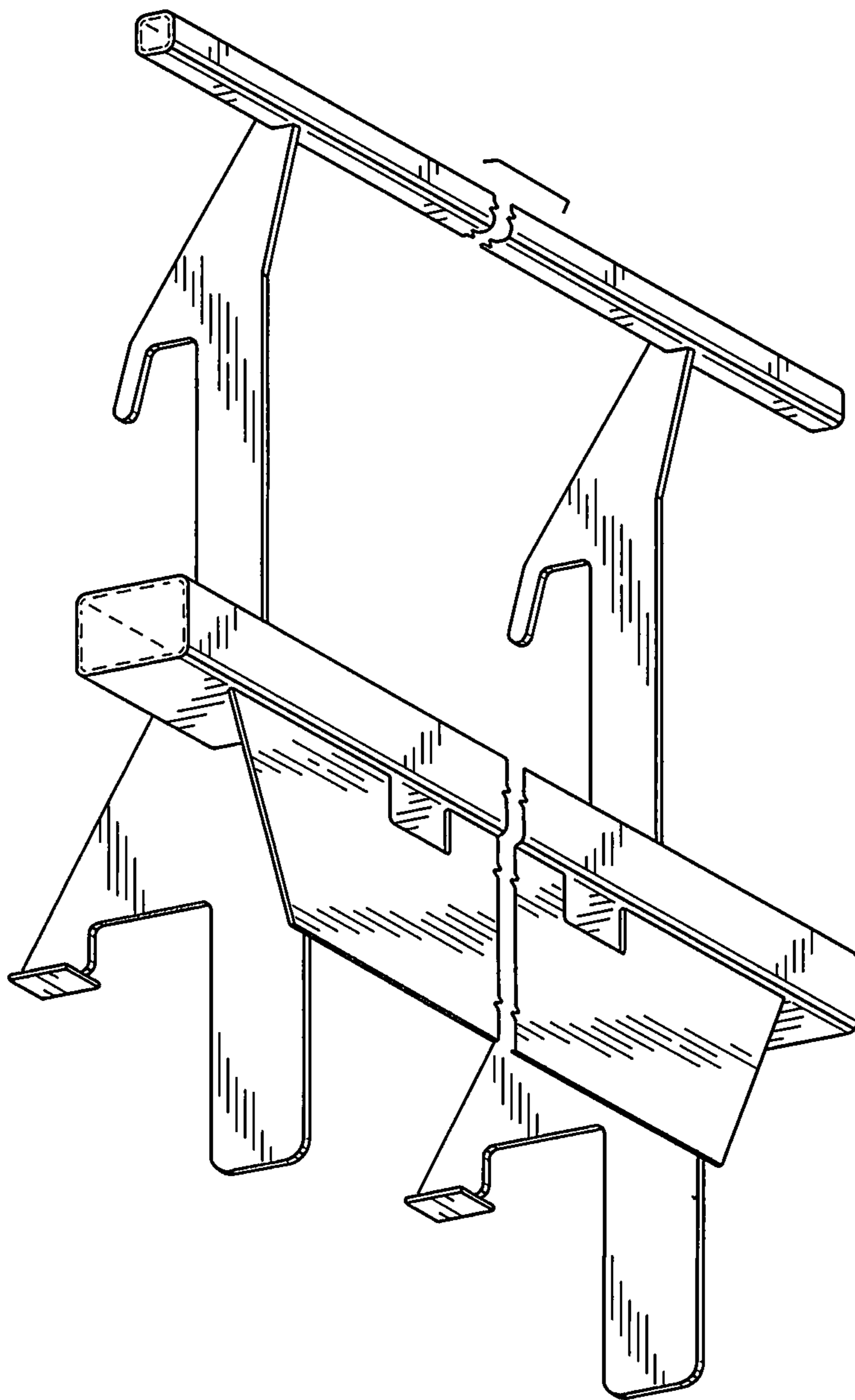

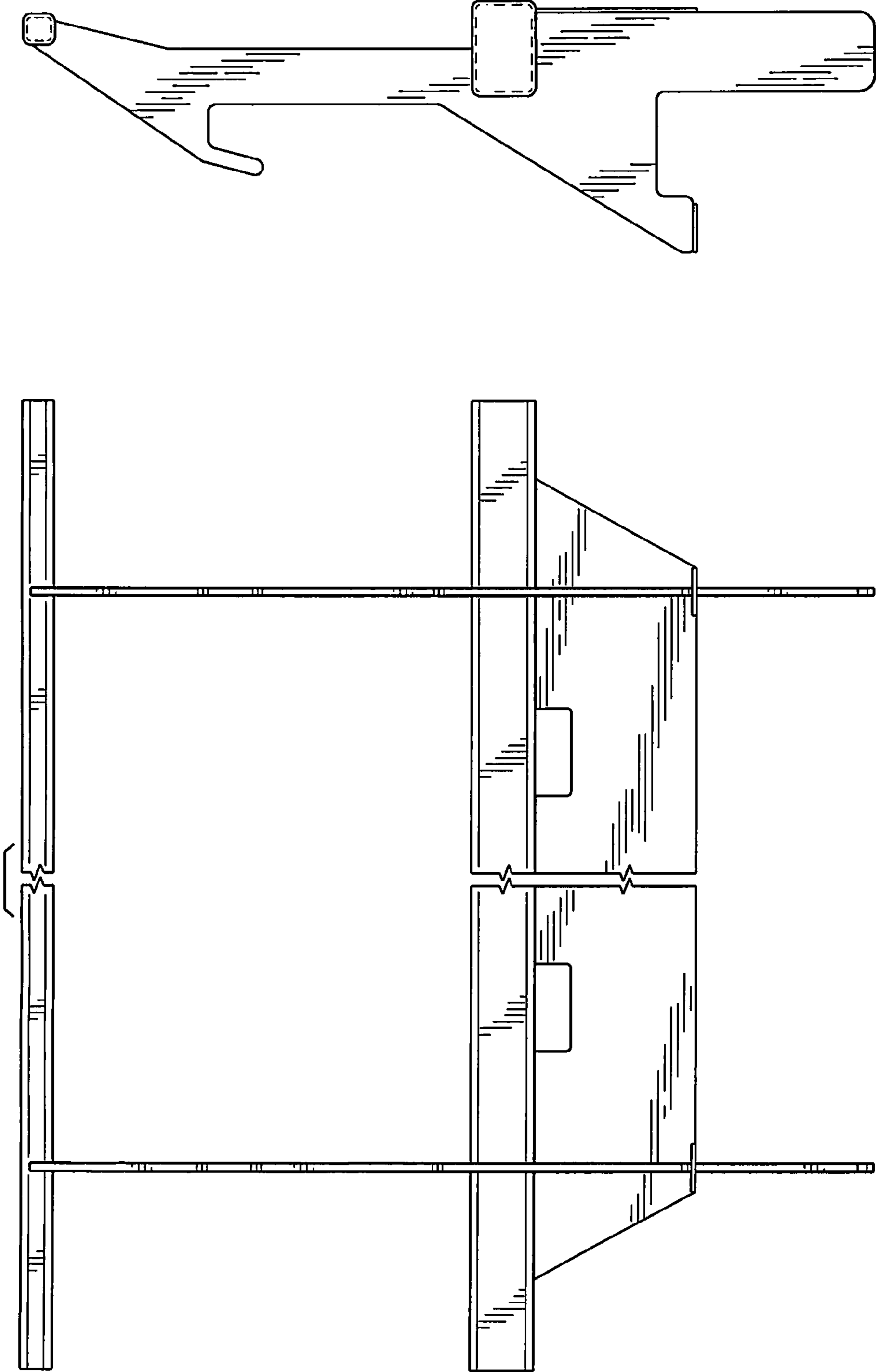

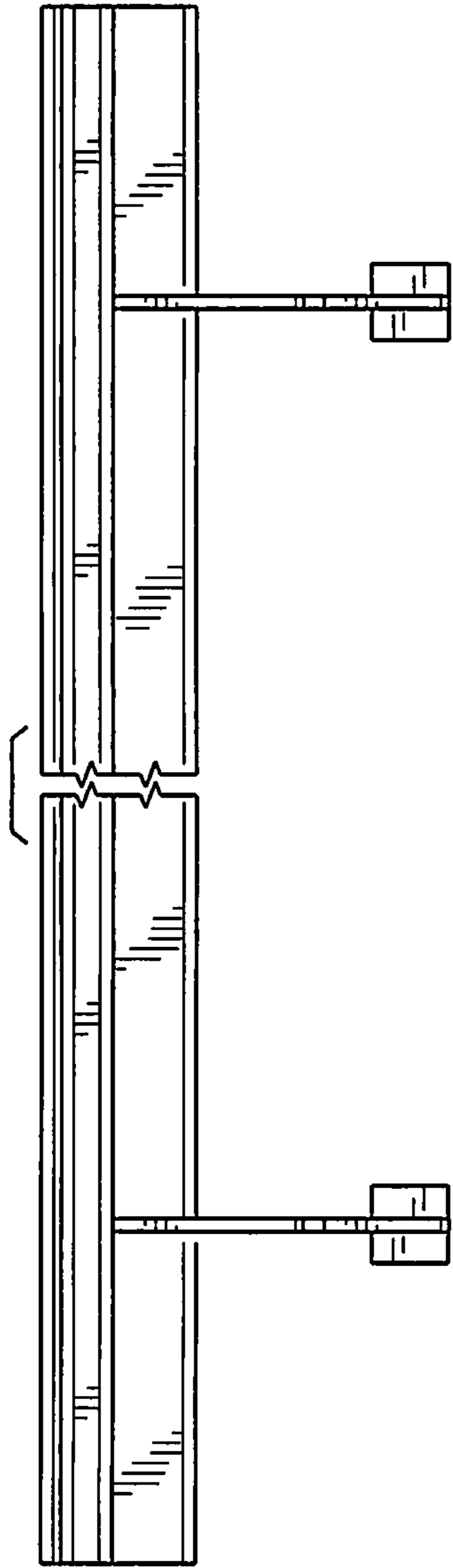

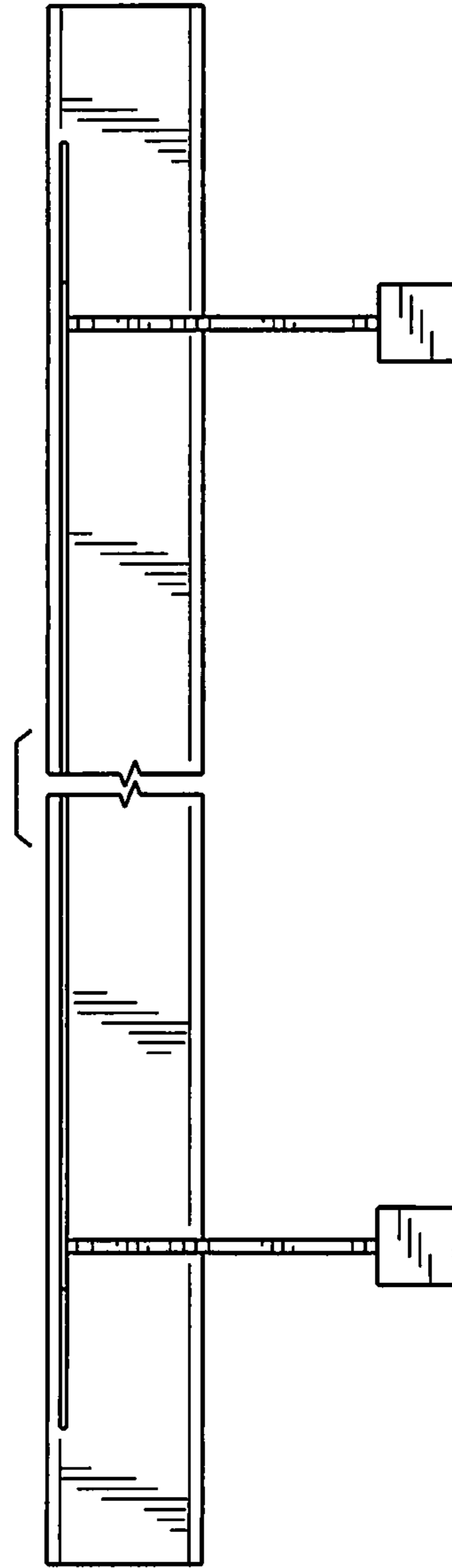

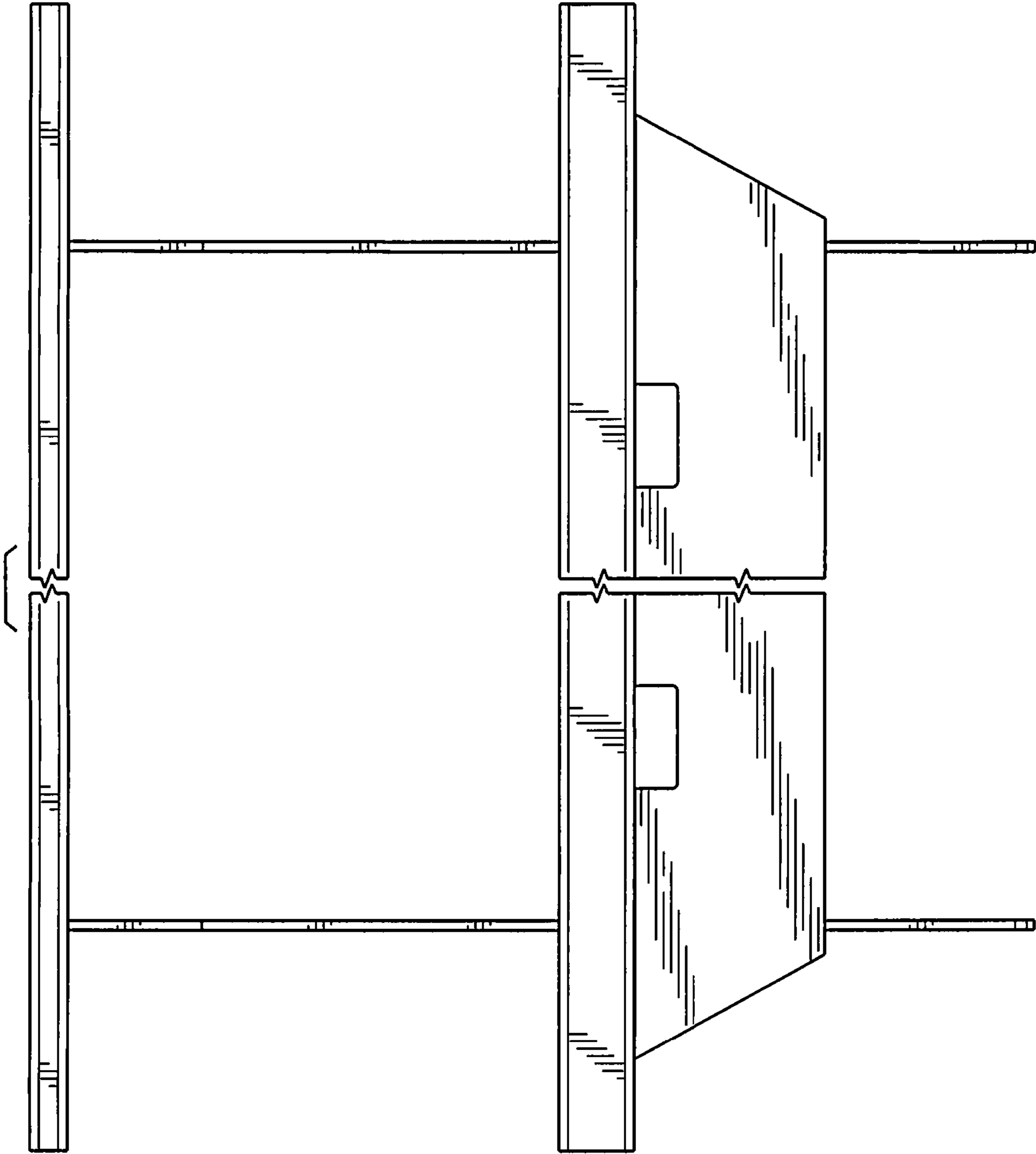

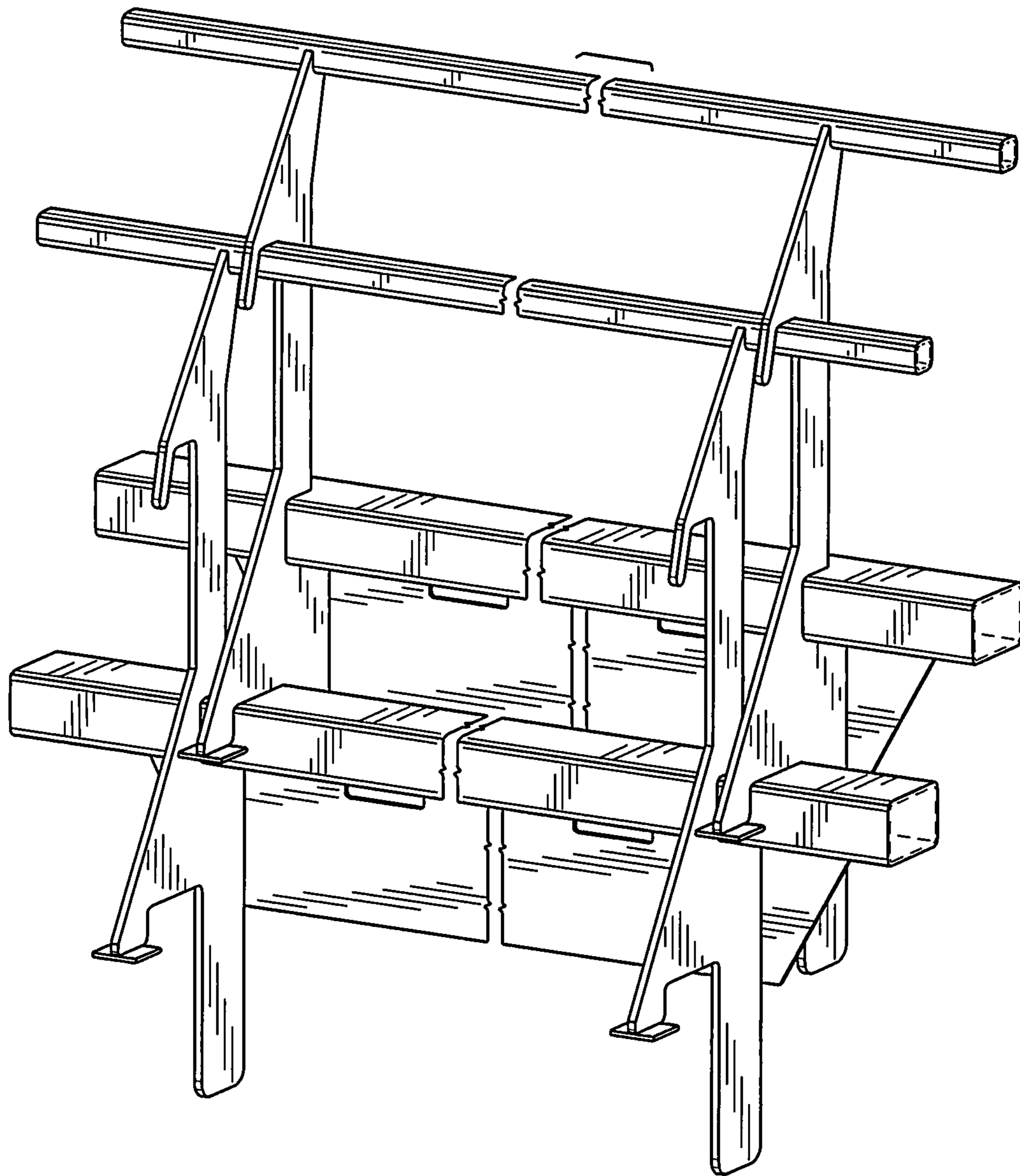
