FIG. 6 is a front elevational view of the template shown in FIG. 4; and,

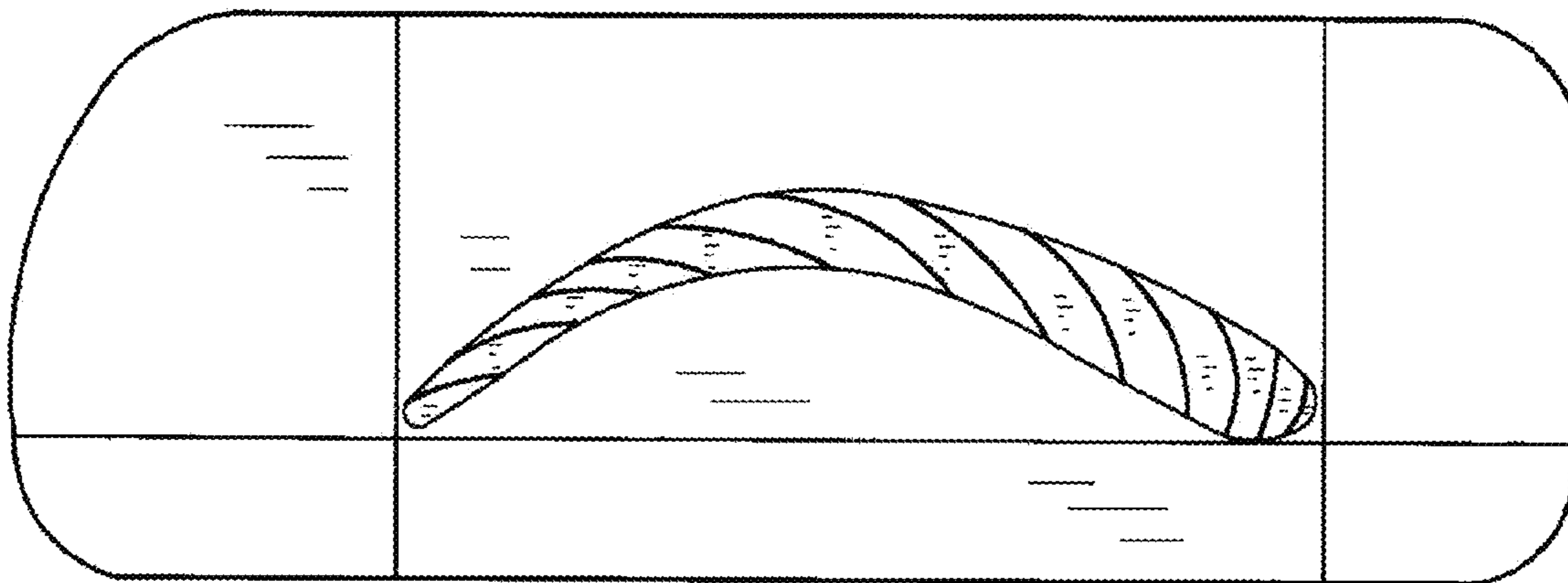
FIG. 7 is a rear elevational view of the template shown in FIG. 4.

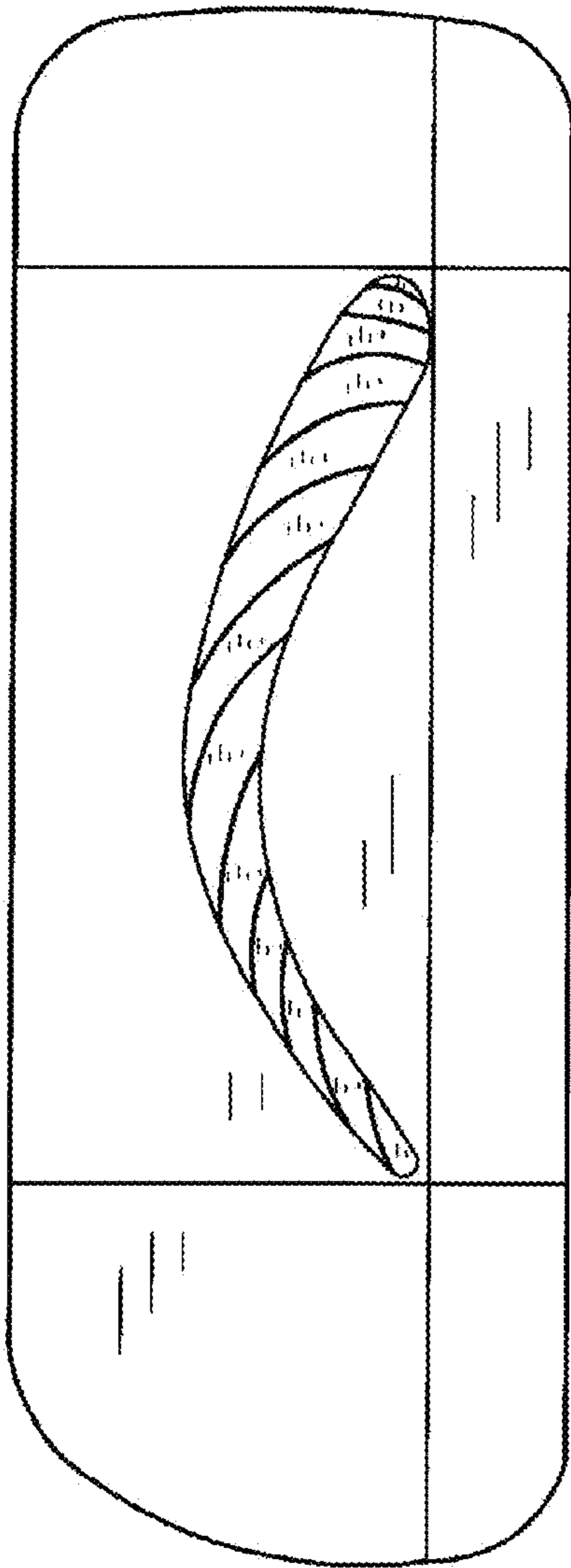

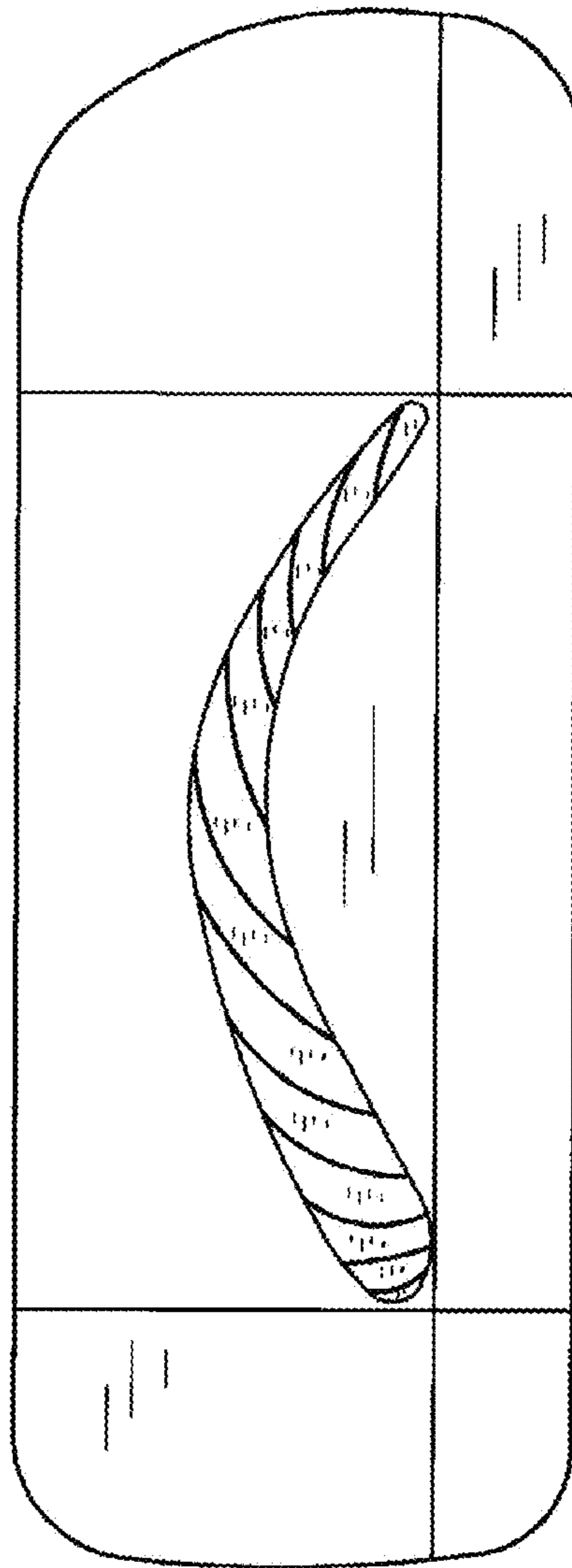

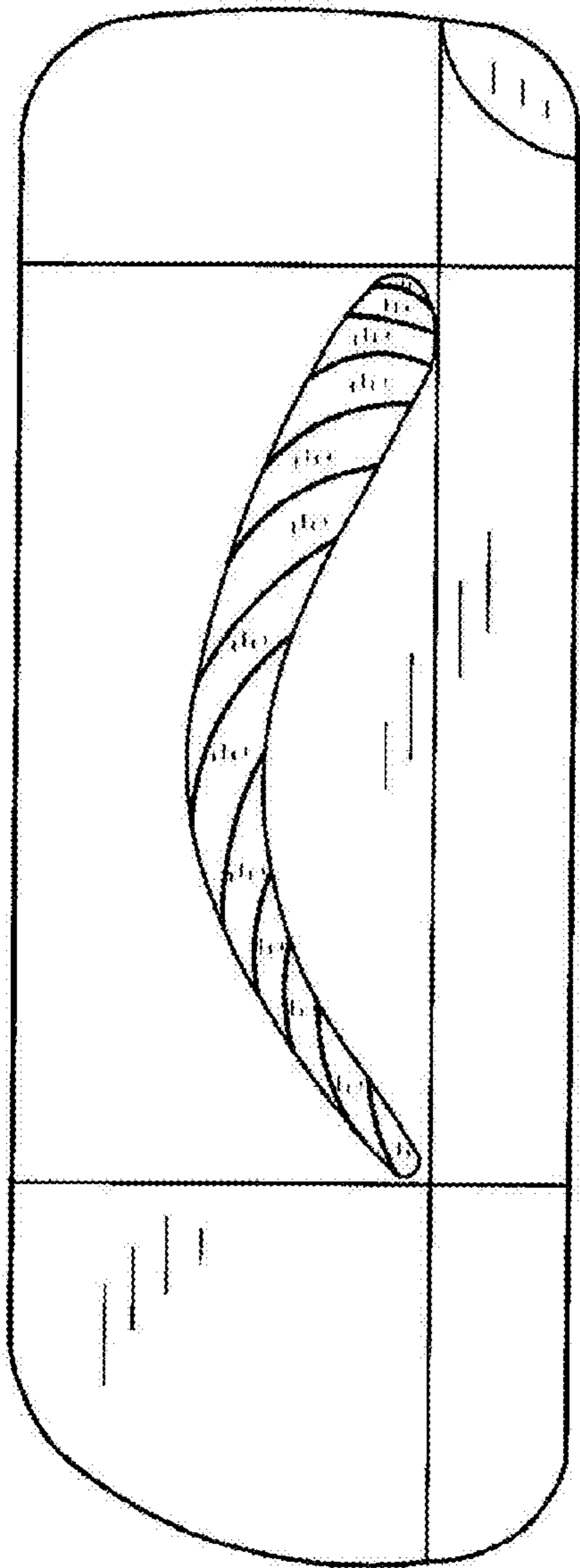

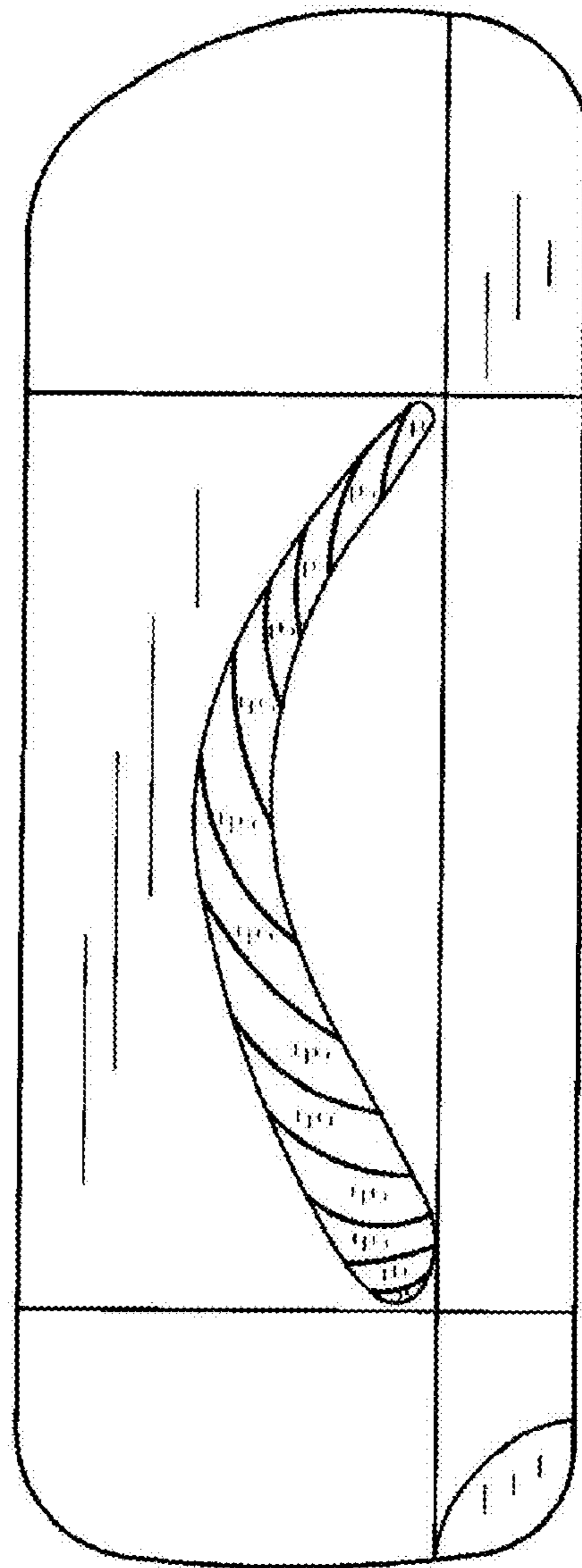
