(57) **CLAIM**

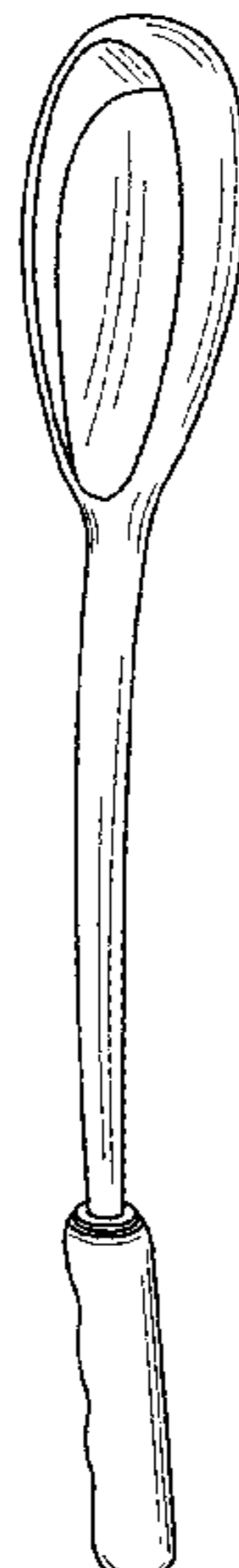
The ornamental design for a beautician client ear protector, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a beautician client ear protector showing my new design;
 FIG. 2 is a front view thereof;

 FIG. 5 is a top view thereof;
 FIG. 6 is a bottom view thereof;
 FIG. 7 is a side perspective view thereof, shown in a used condition;

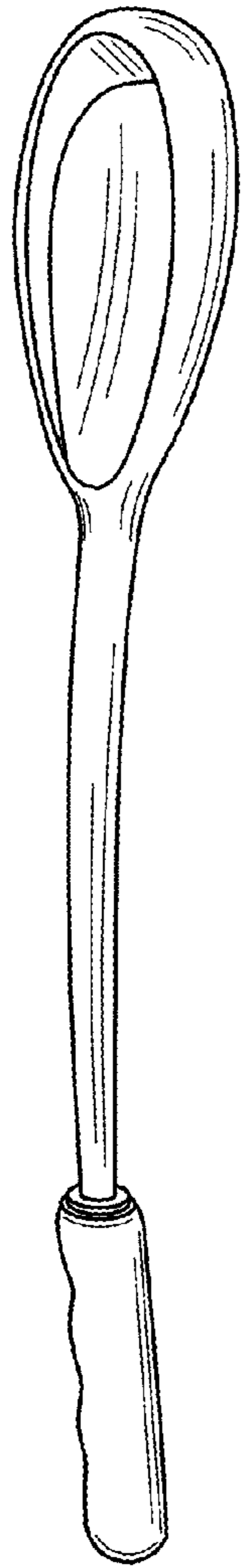

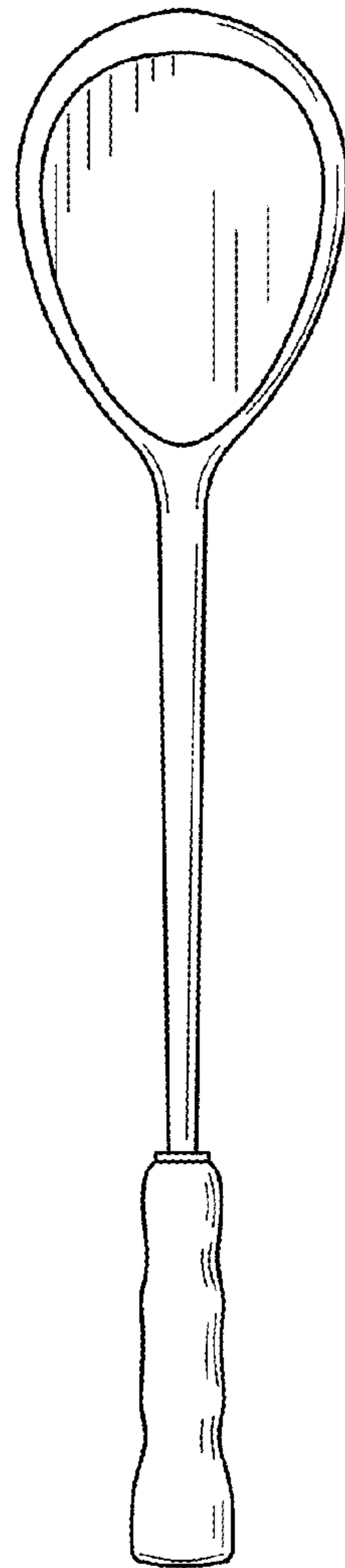

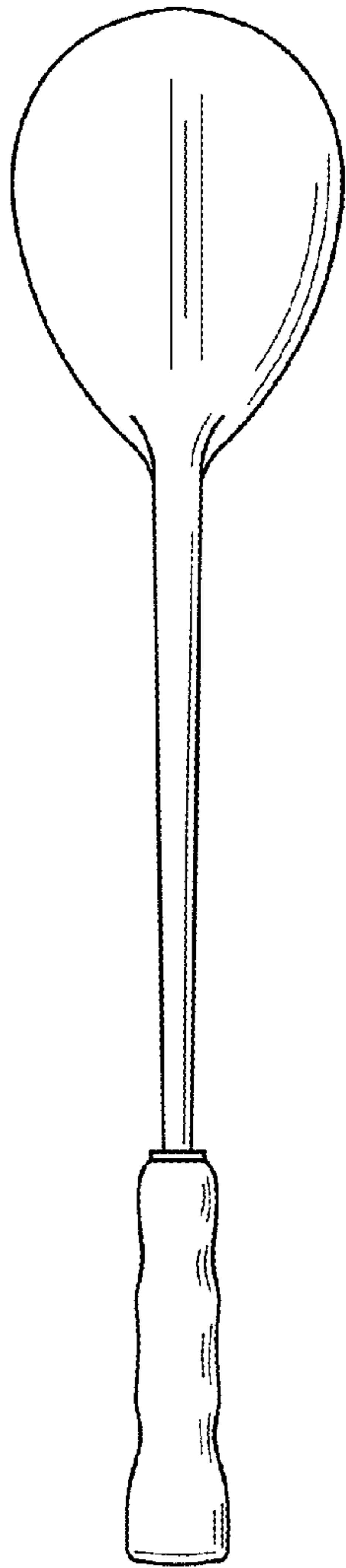

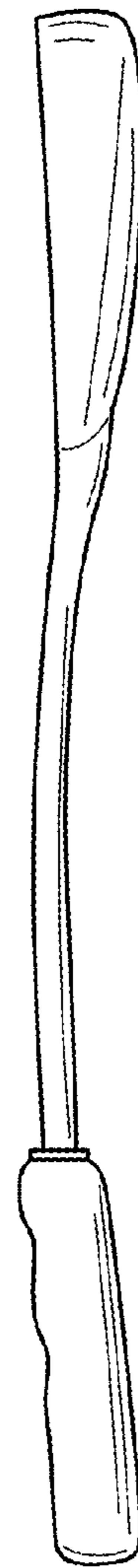

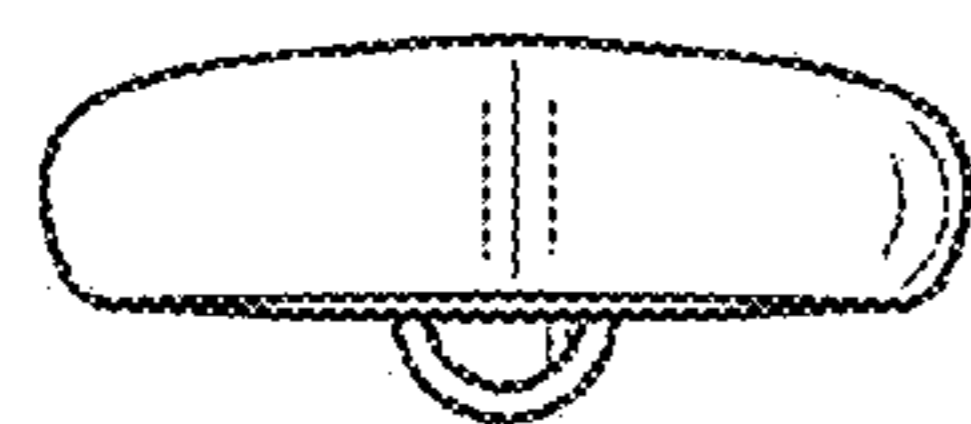

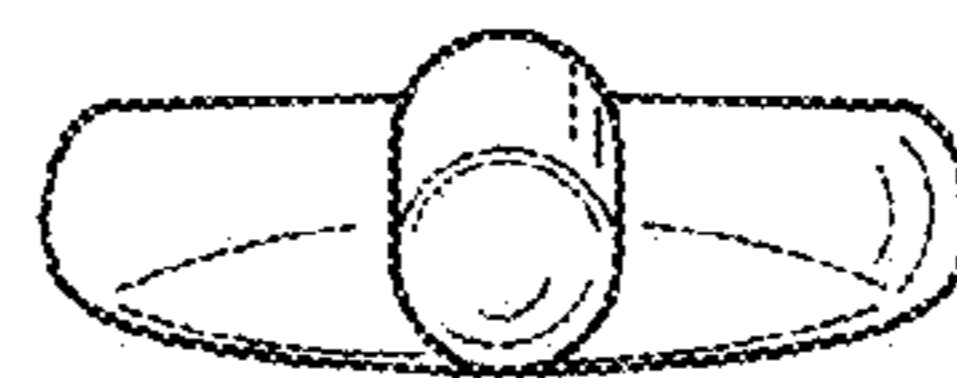

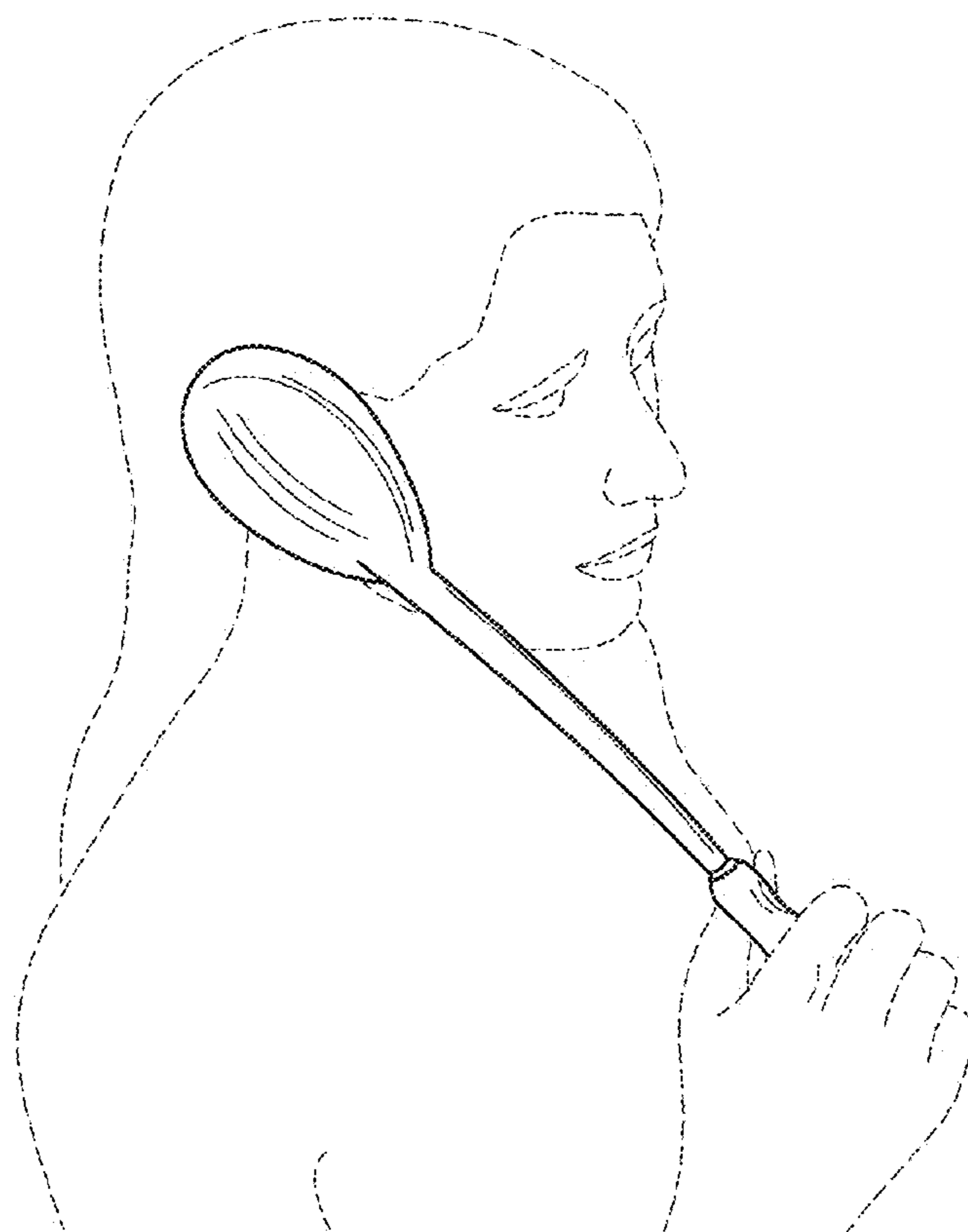

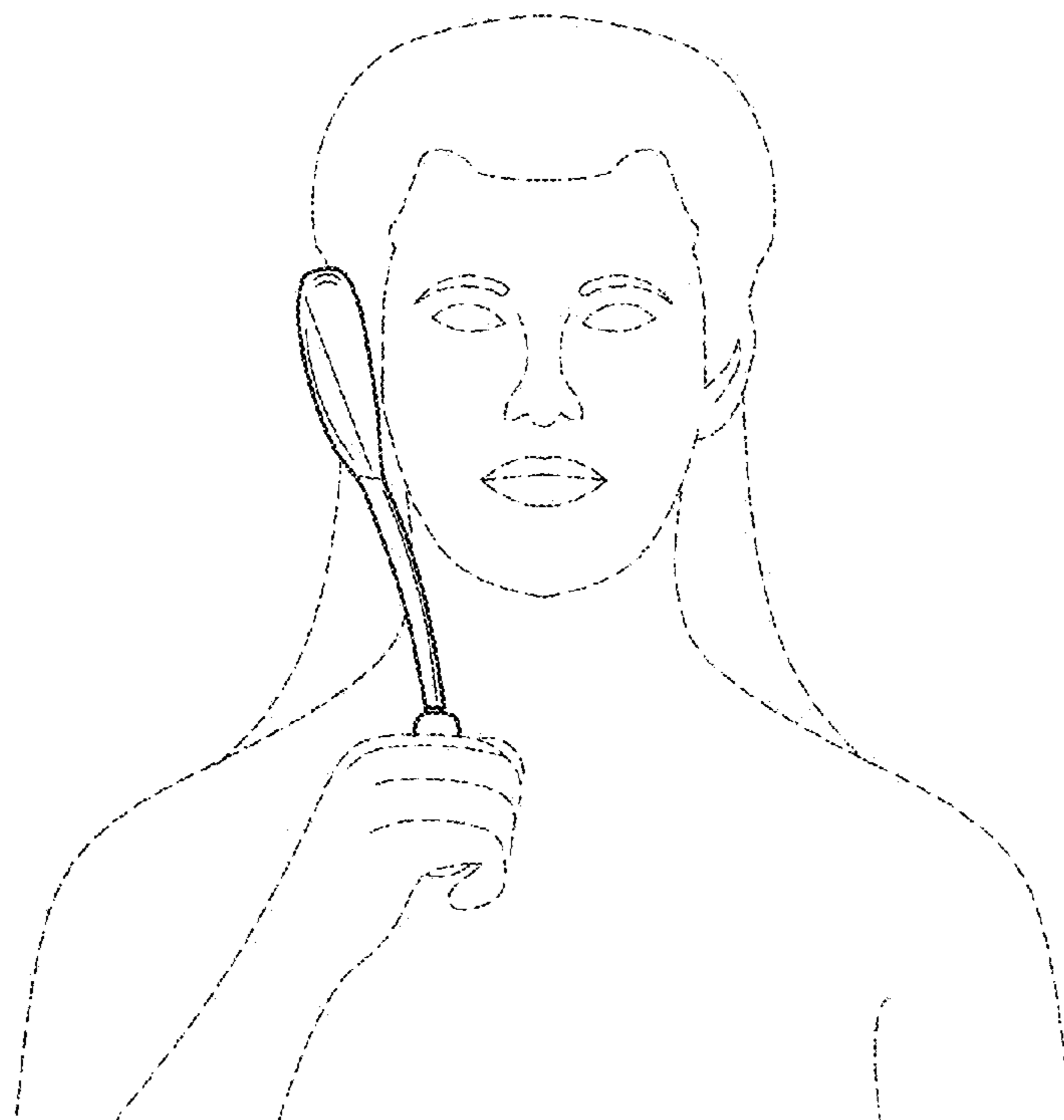

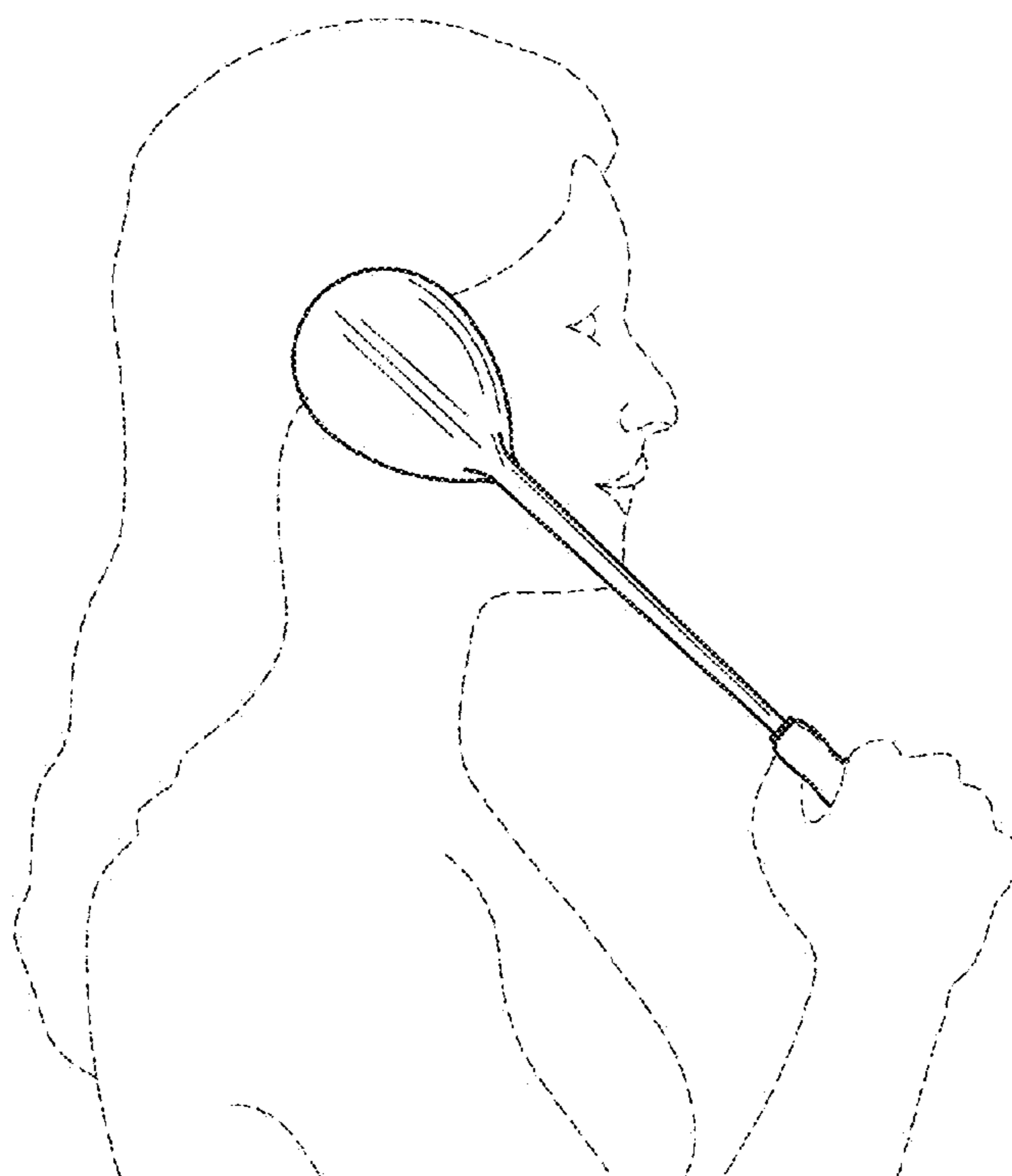
