FIG. 1 is an exploded perspective view of a combined litter box canopy and cover.

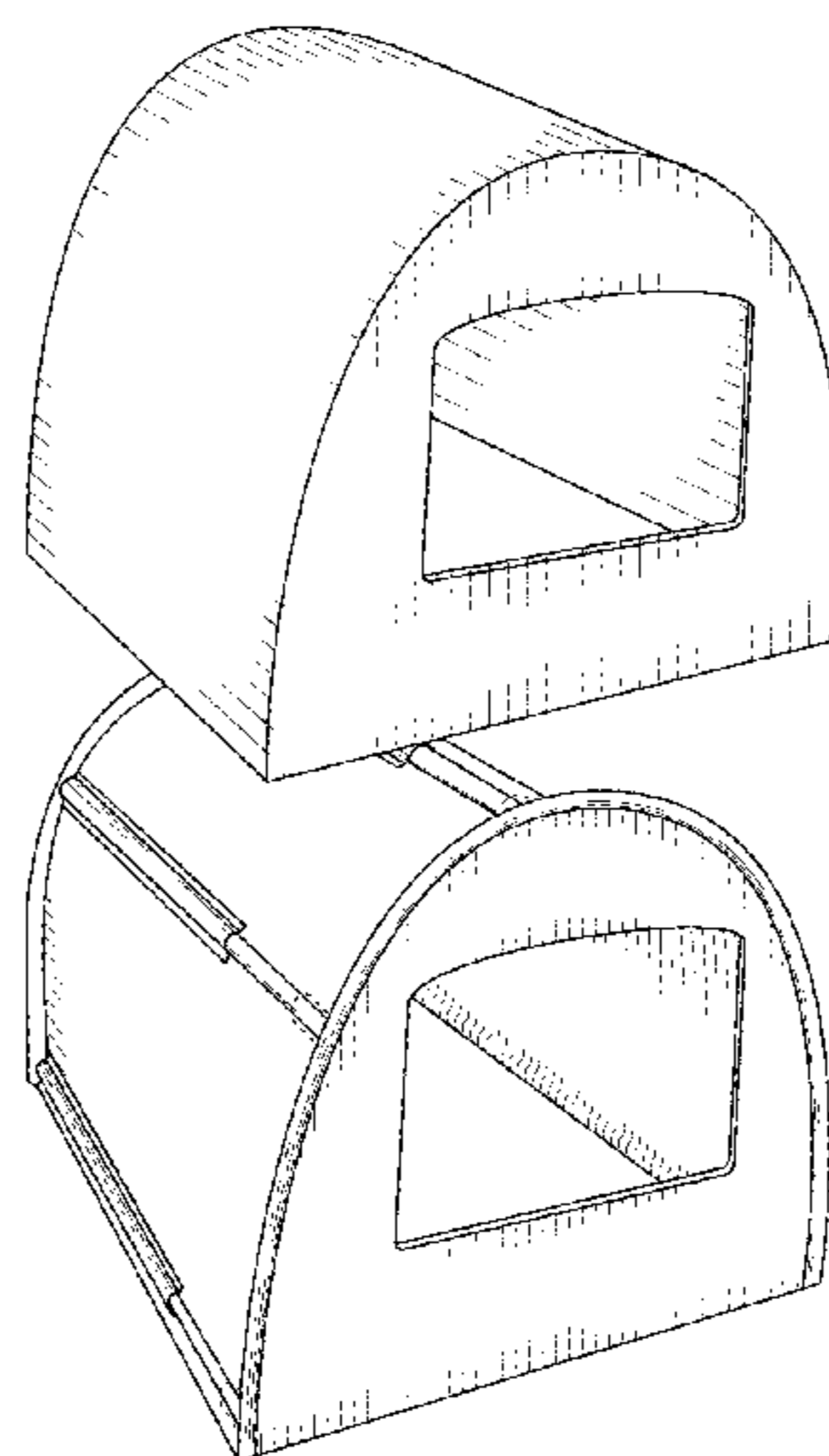
FIG. 2 is an exploded side elevation view thereof.

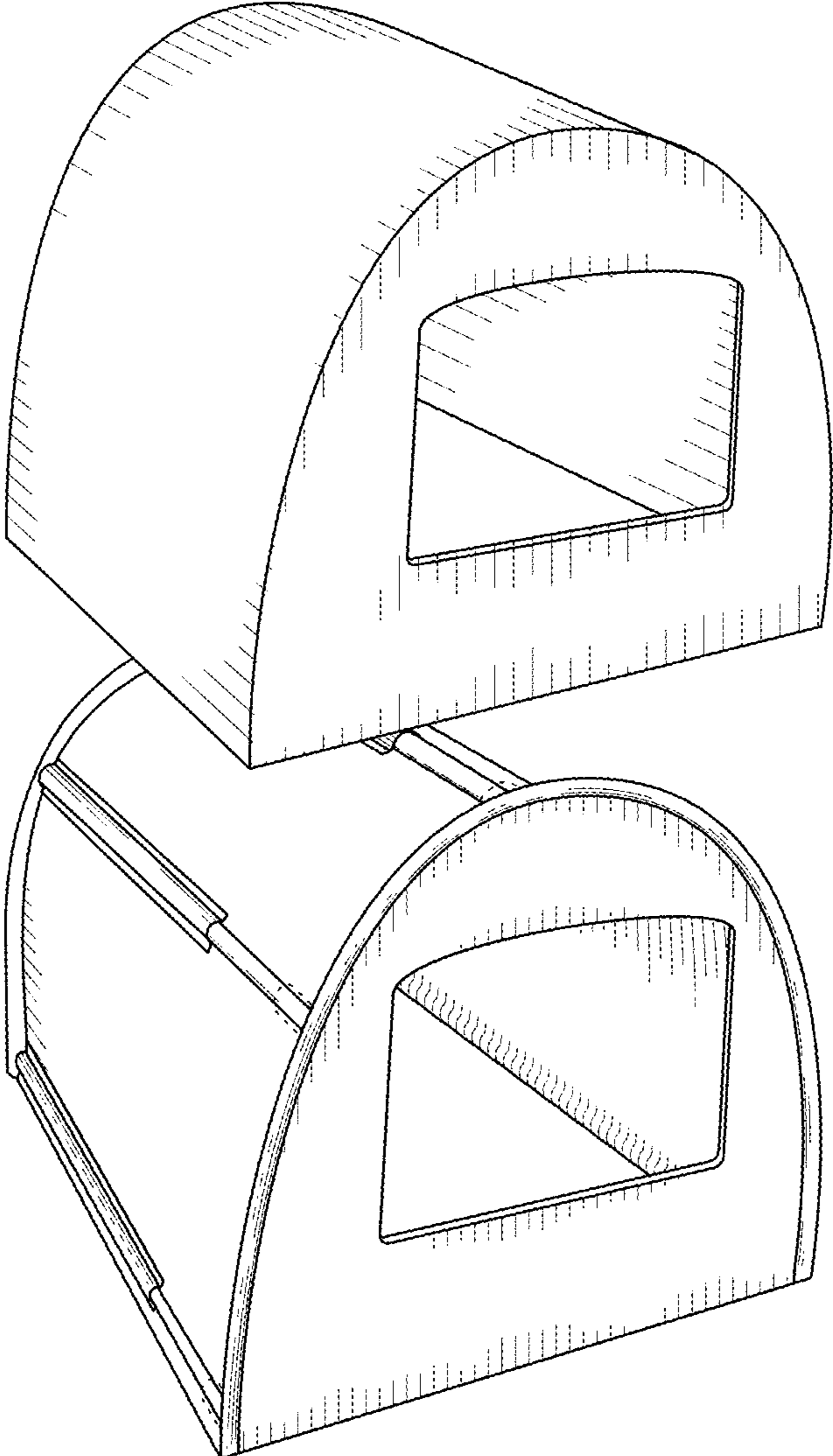

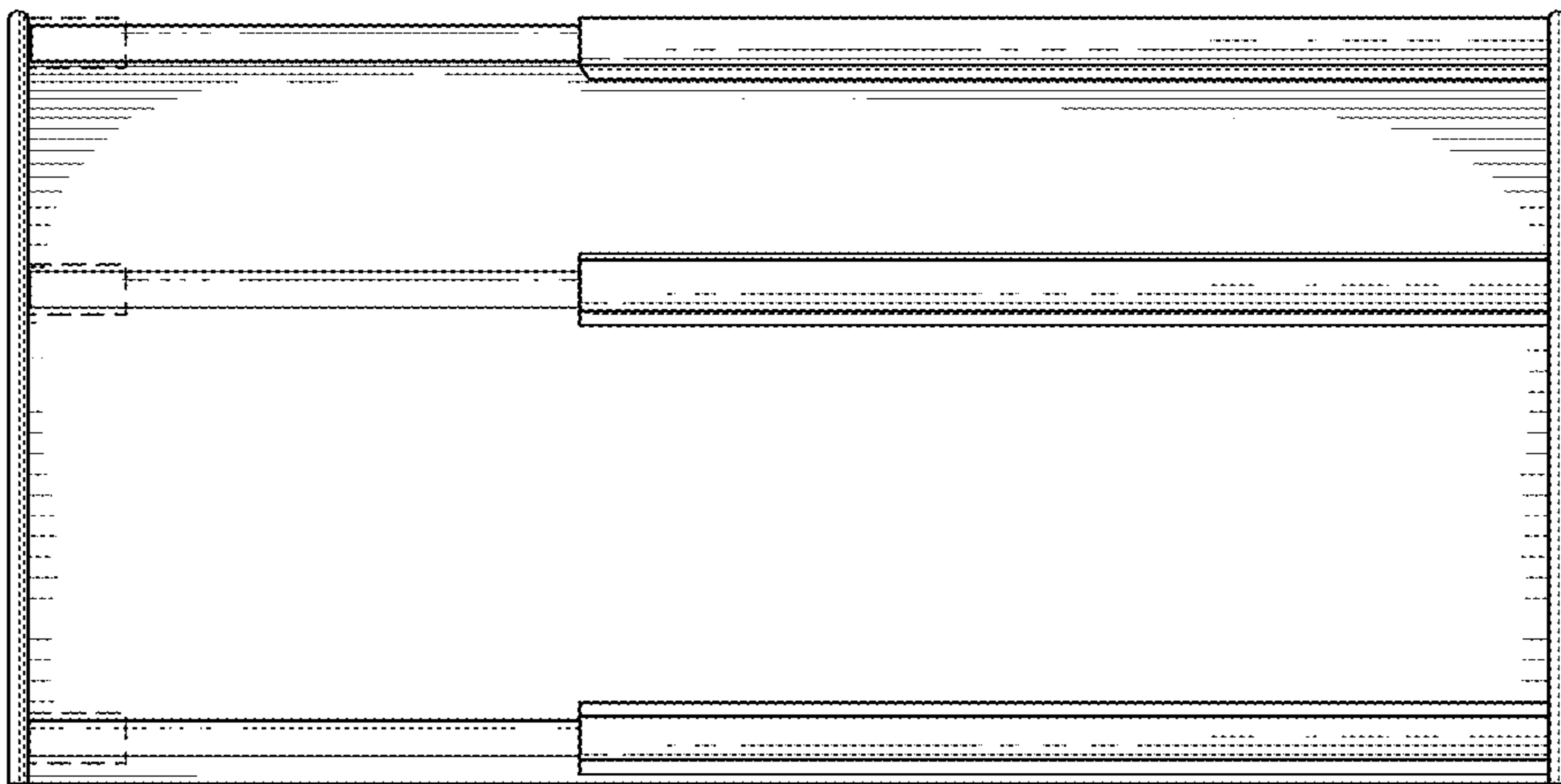
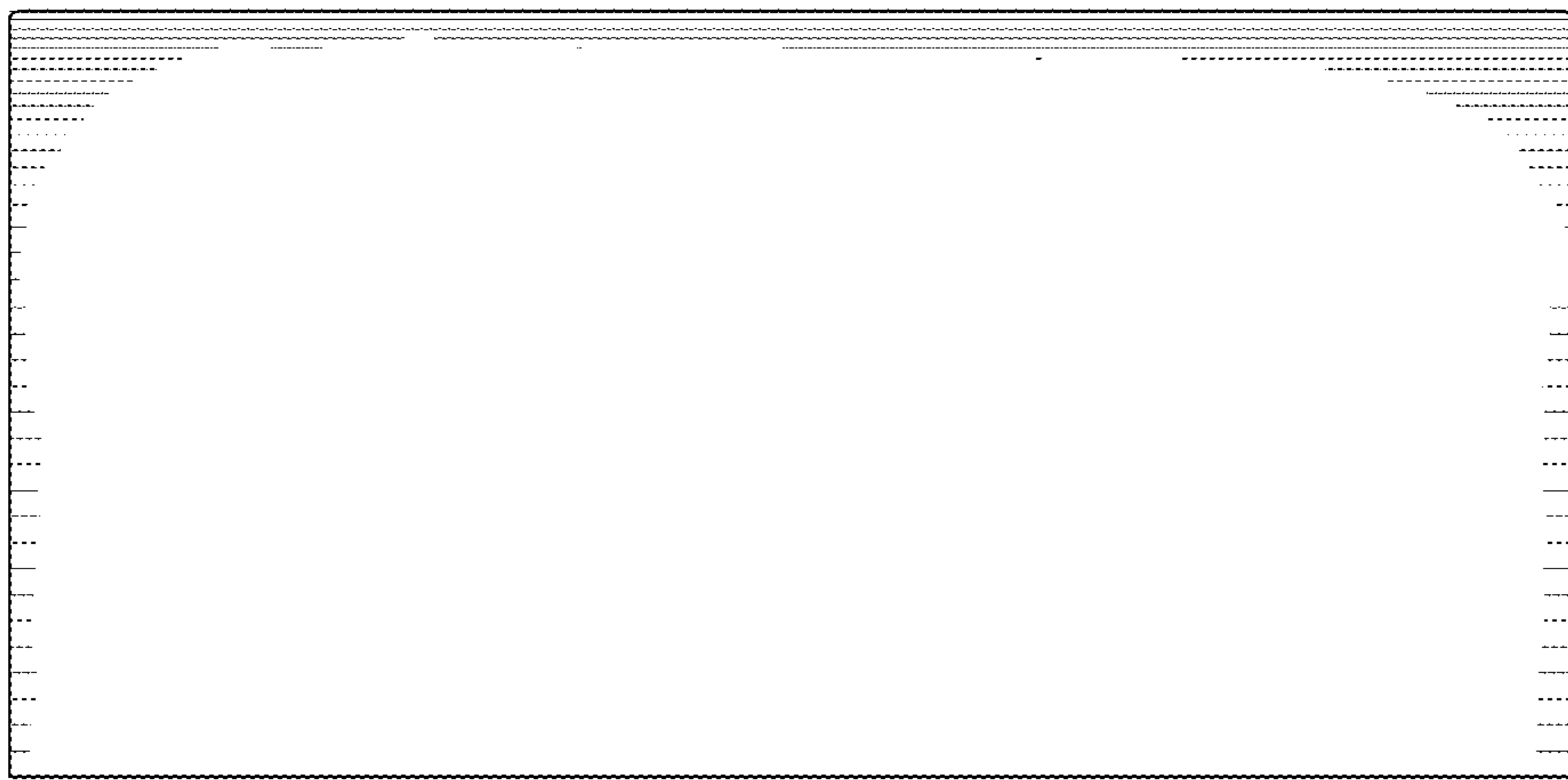

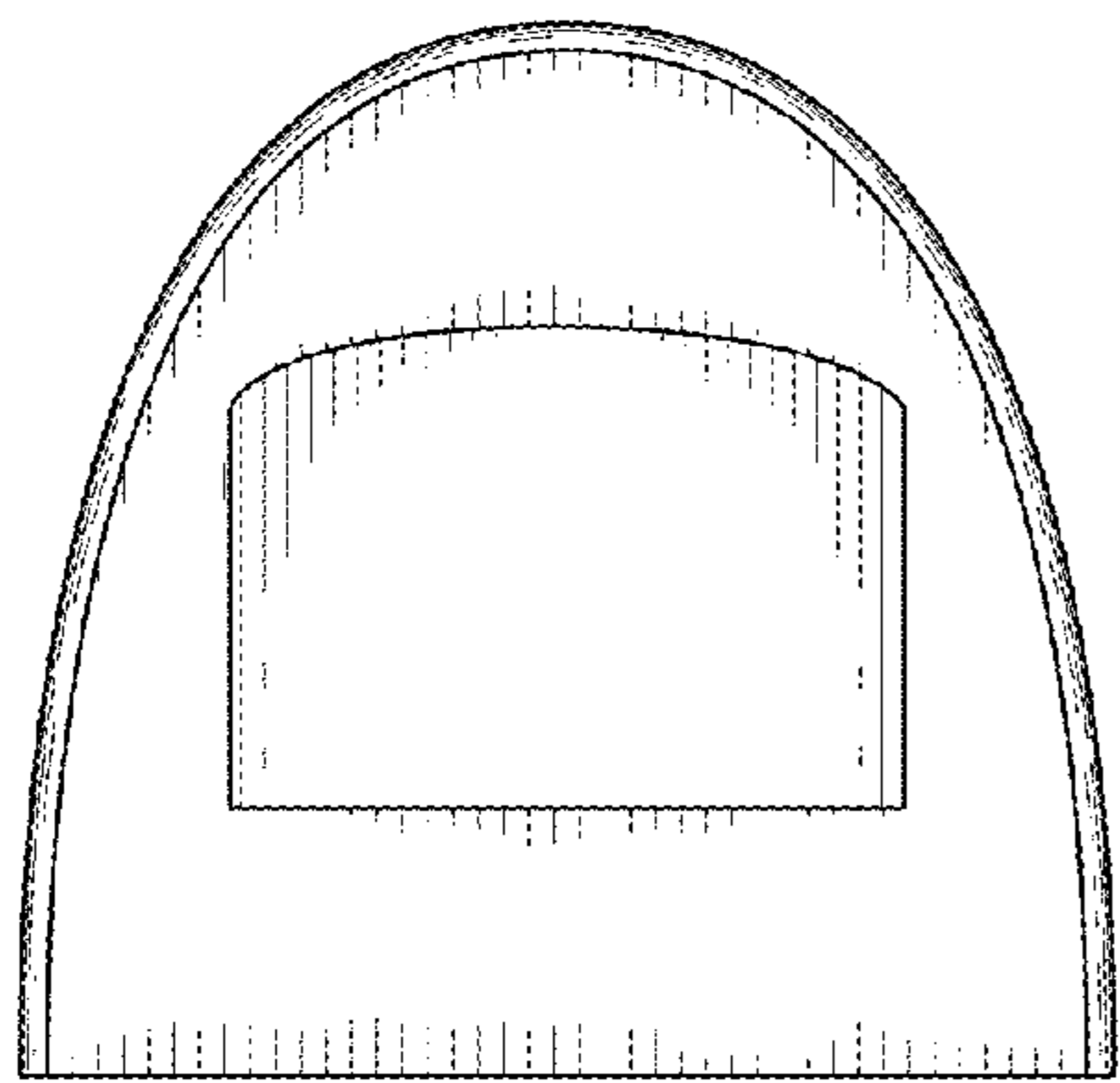
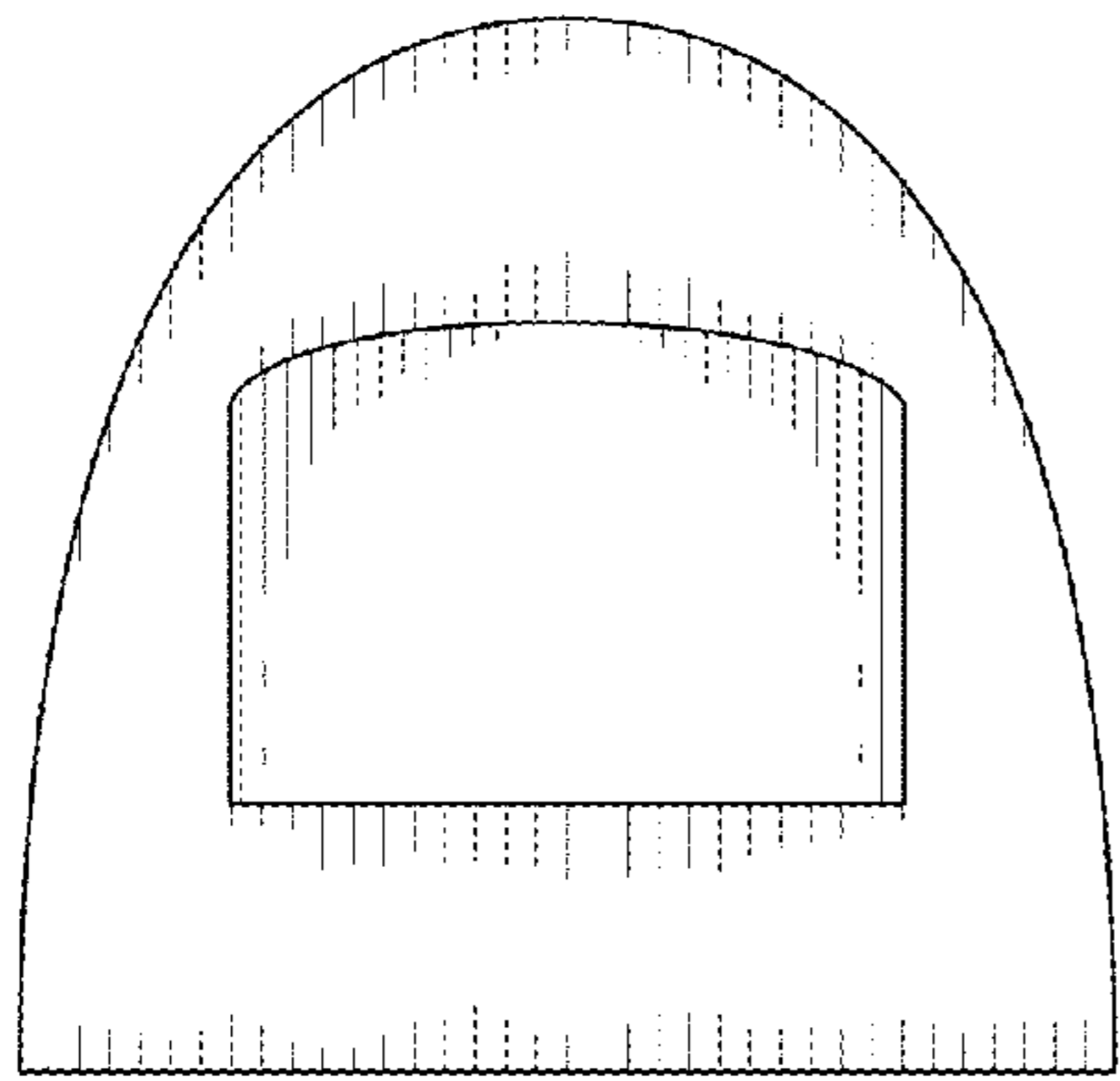

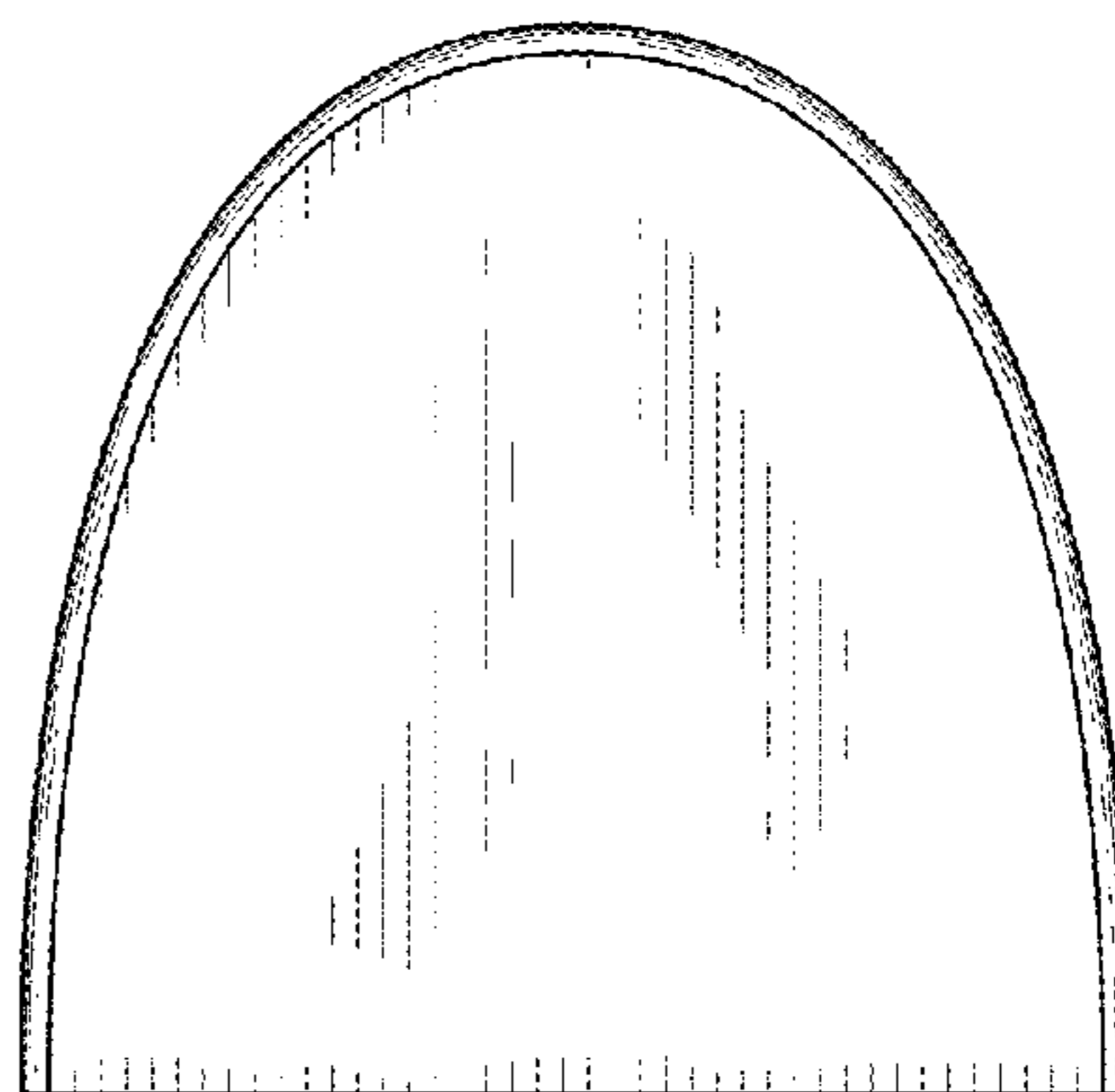
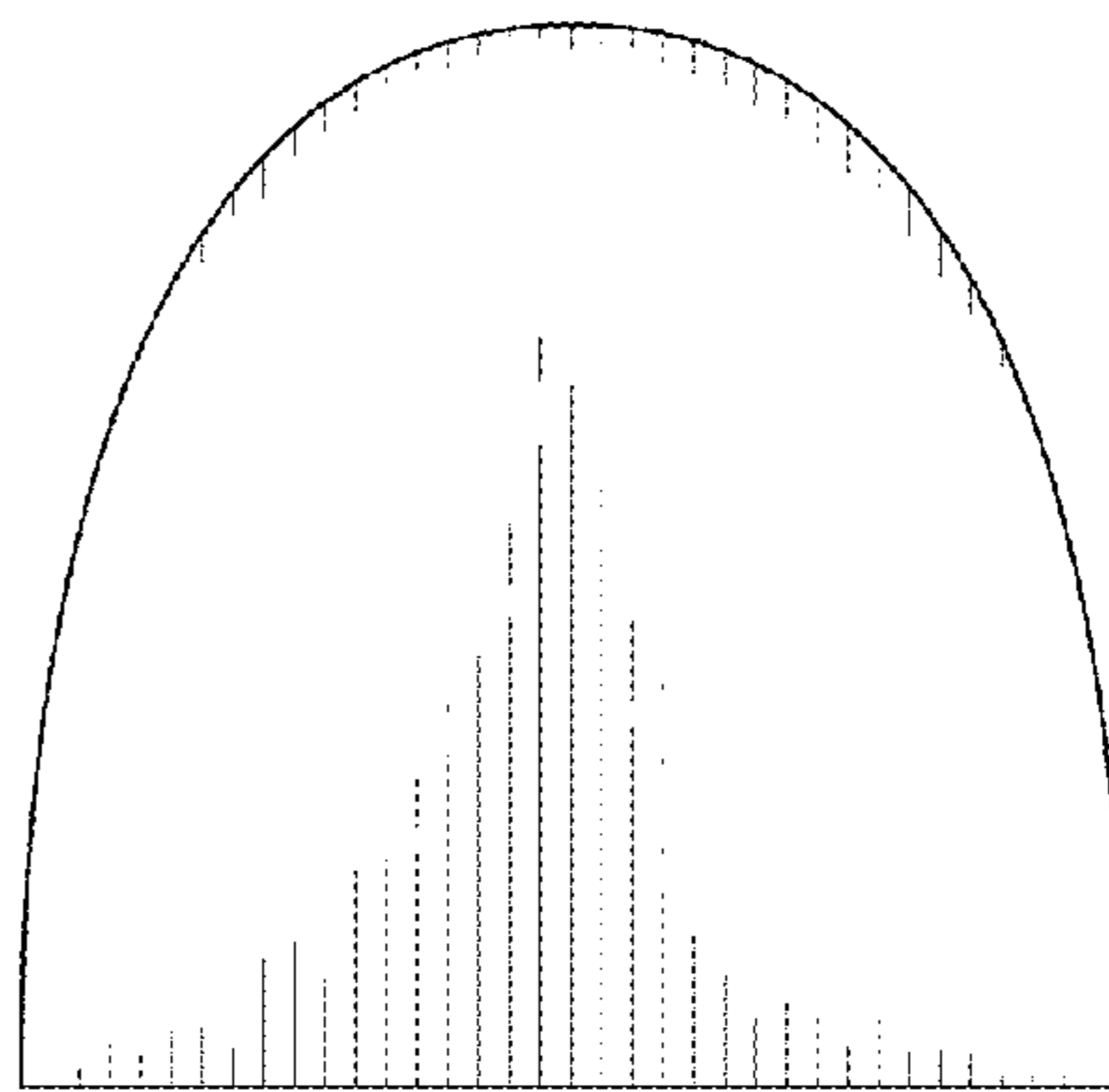
