(57) **CLAIM**

I claim the ornamental design for a scarf with neck pillow pocket, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a scarf with neck pillow pocket, showing a first embodiment of my new design in a worn configuration;

FIG. 2 is a rear elevational view thereof, except that the claimed design of FIG. 1 is shown laid on a flat surface, rather than being worn;

FIG. 3 is a front elevational view of the scarf as shown in FIG. 2;

FIG. 4 is a right-side elevational view of the scarf as shown in FIG. 2;

FIG. 5 is a left-side elevational view of the scarf as shown in FIG. 2;

FIG. 6 is a top plan view of the scarf as shown in FIG. 2;

FIG. 7 is a bottom plan view of the scarf as shown in FIG. 2;

FIG. 8 is a perspective view of a second embodiment thereof in the worn configuration;

FIG. 9 is a rear elevational view thereof, except that the claimed design of FIG. 8 is shown laid on a flat surface, rather than being worn;

FIG. 10 is a front elevational view of the scarf as shown in FIG. 9;

FIG. 11 is a left-side elevational view of the scarf as shown in FIG. 9;

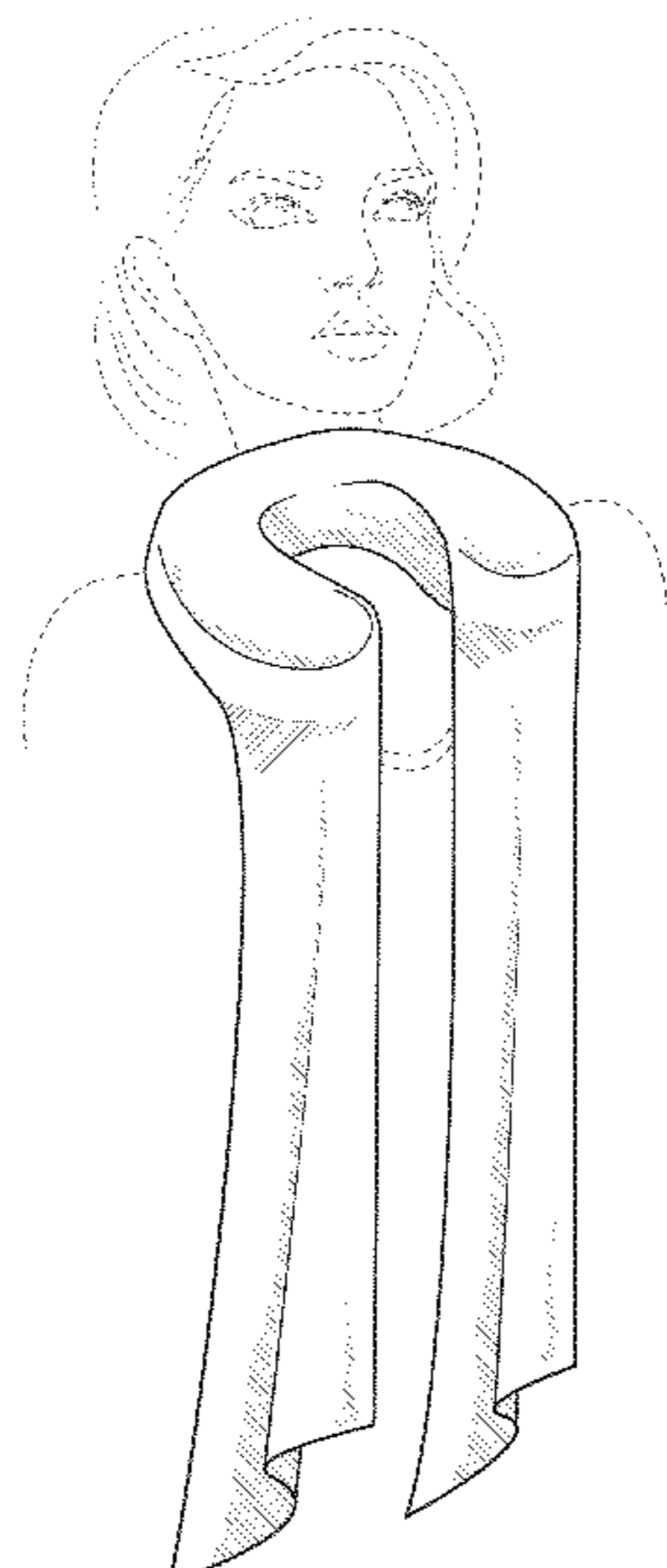
FIG. 12 is a right-side elevational view of the scarf as shown in FIG. 9;

FIG. 13 is a top plan view of FIG. the scarf as shown in 9; and,

FIG. 14 is a bottom plan view of the scarf as shown in FIG. 9.

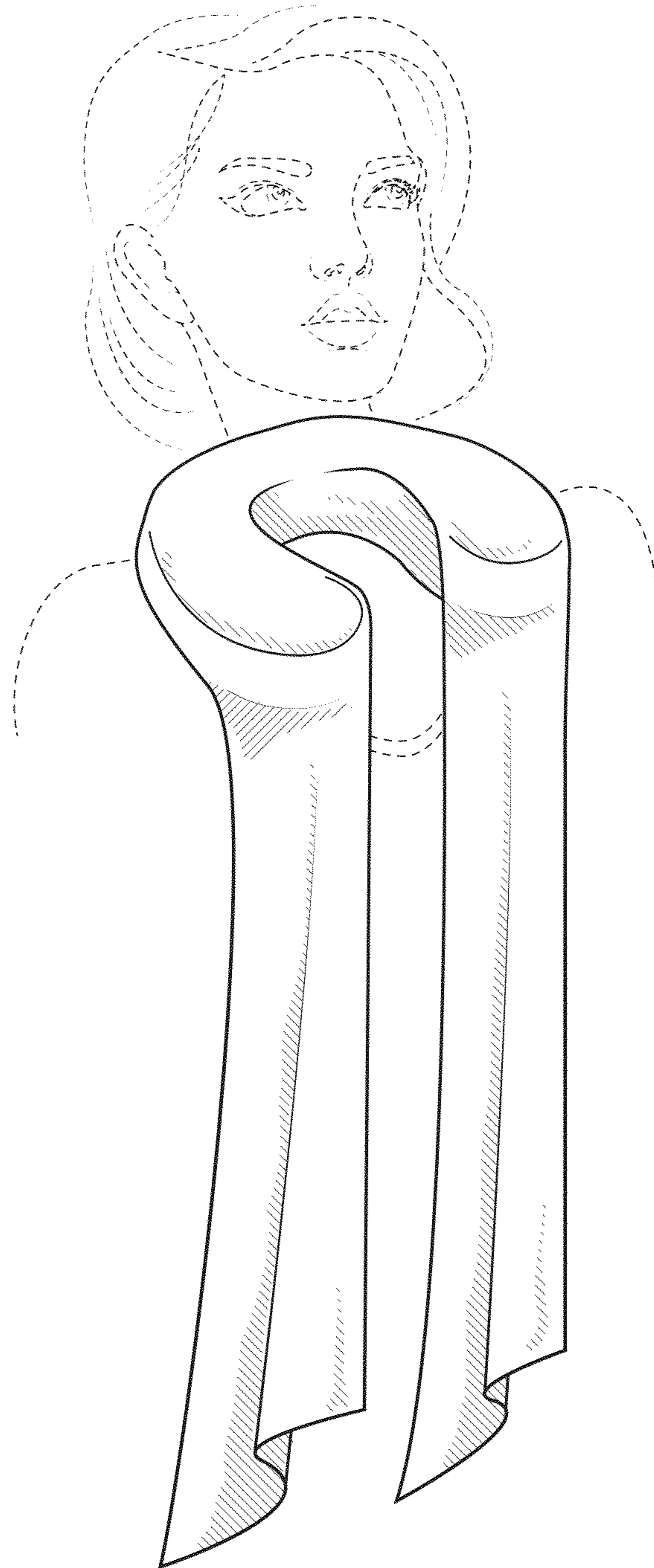

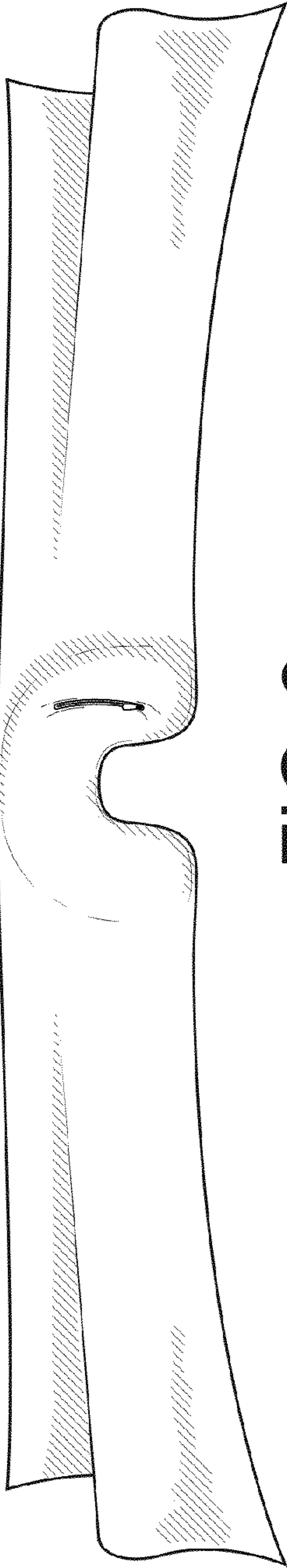

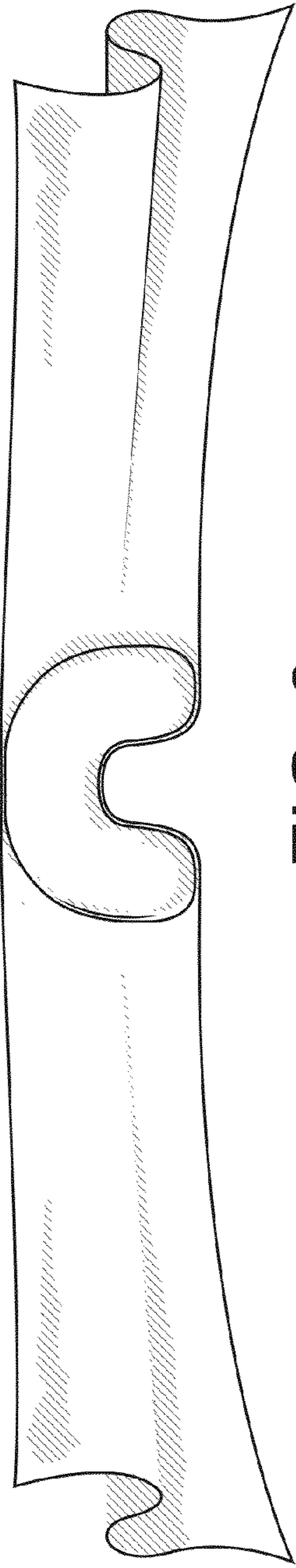

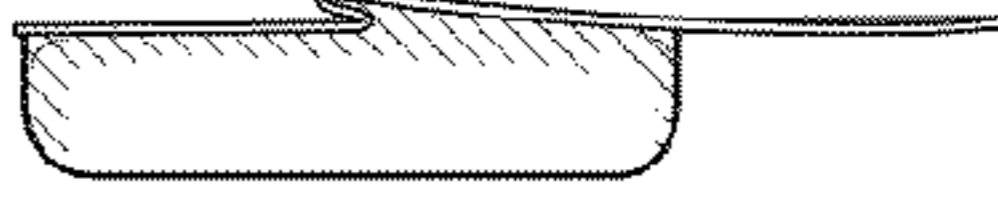

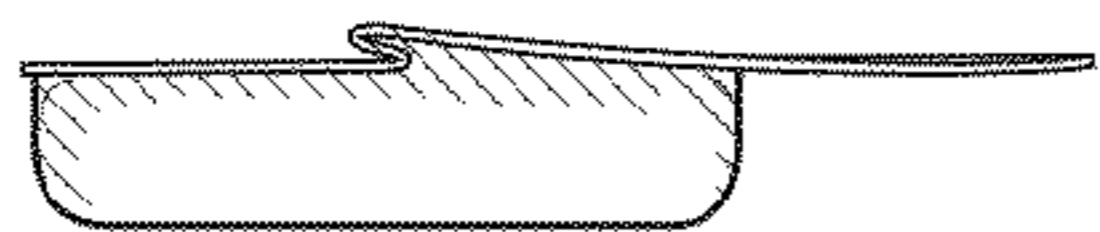

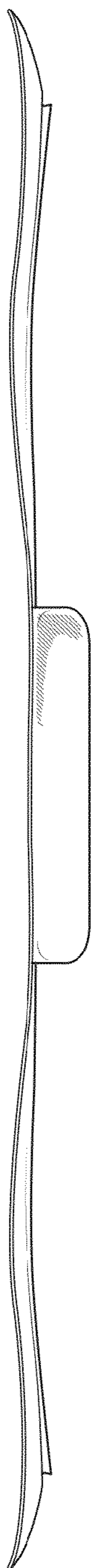

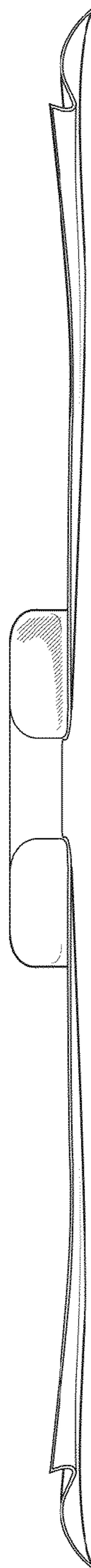

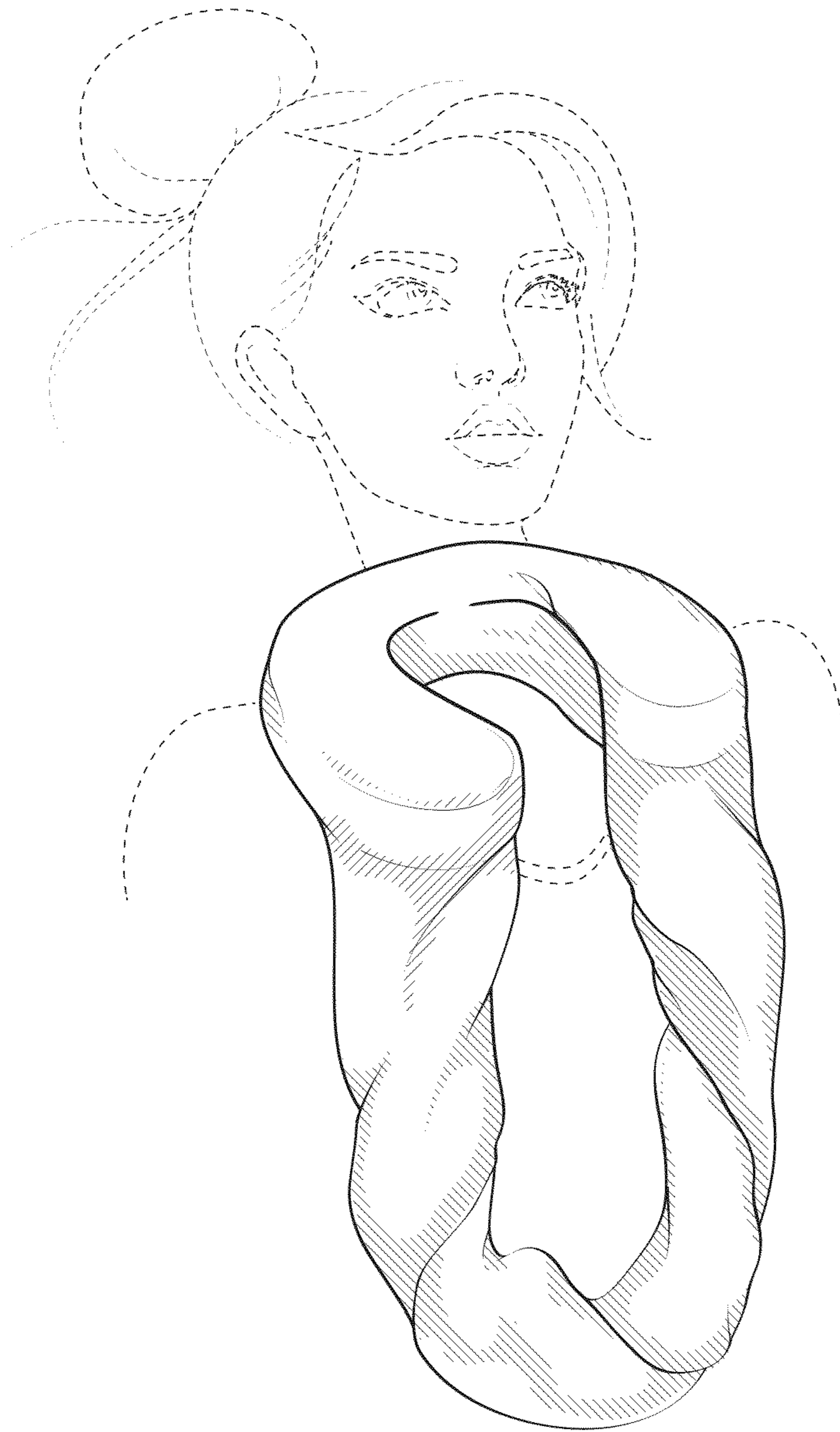

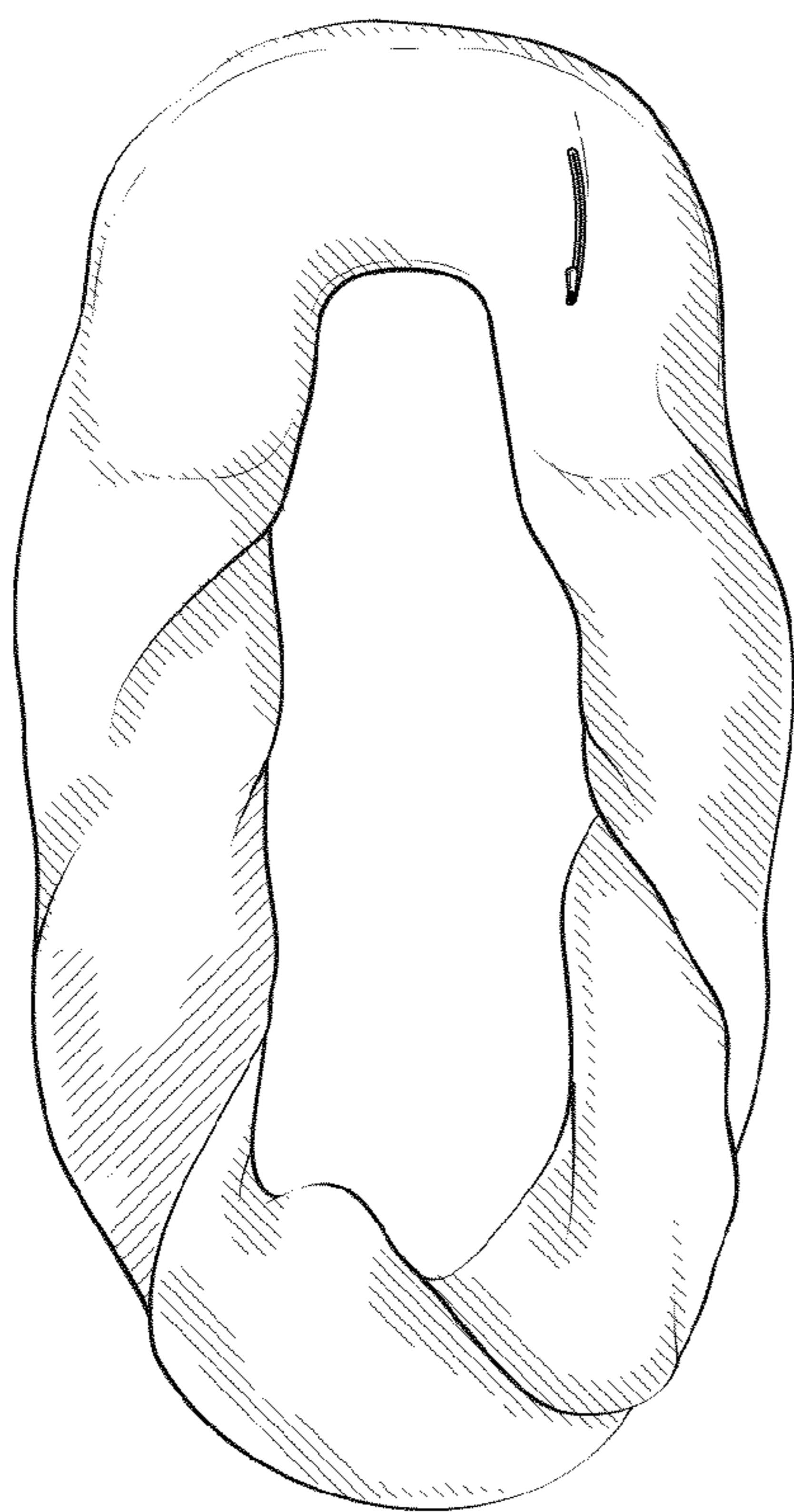

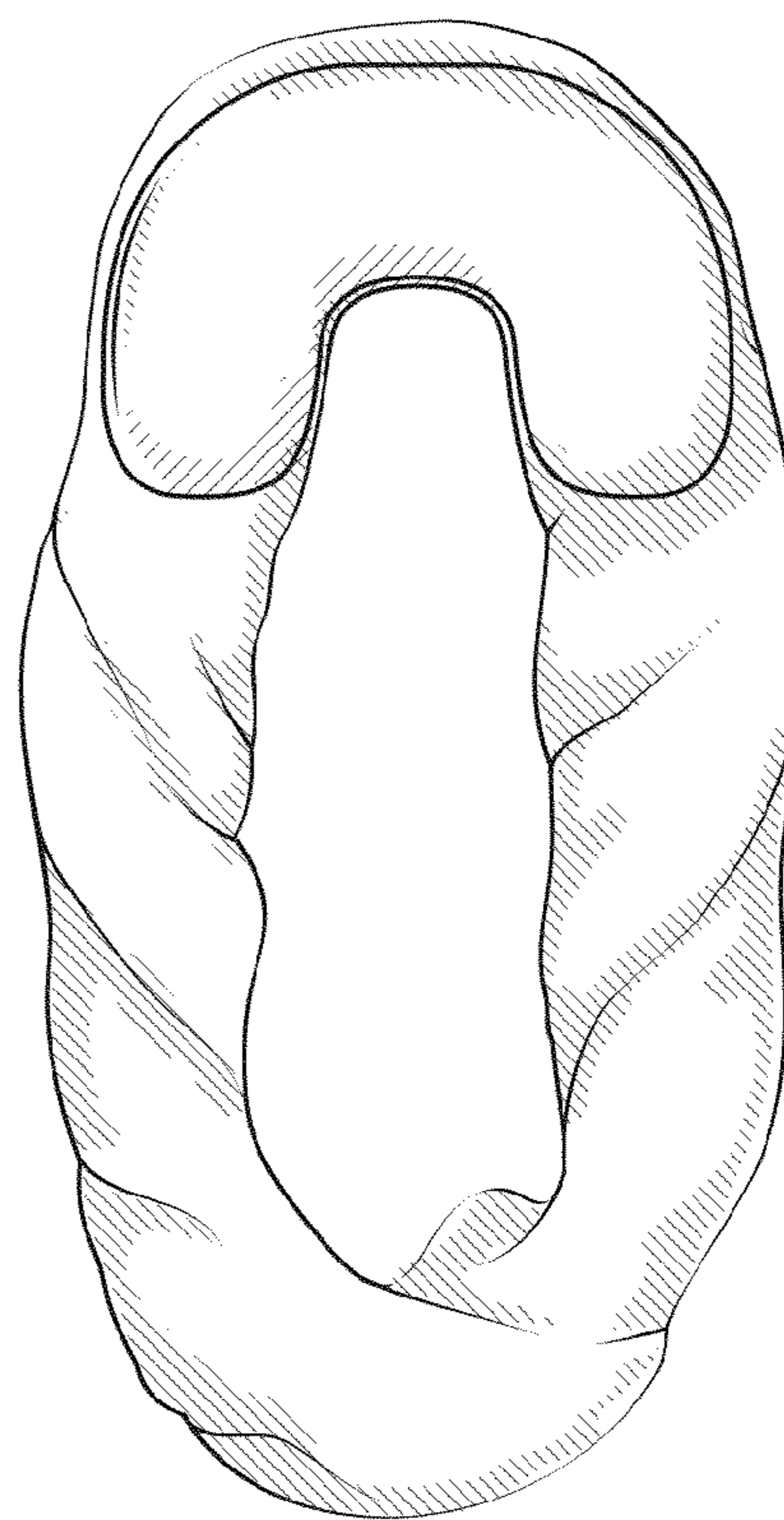

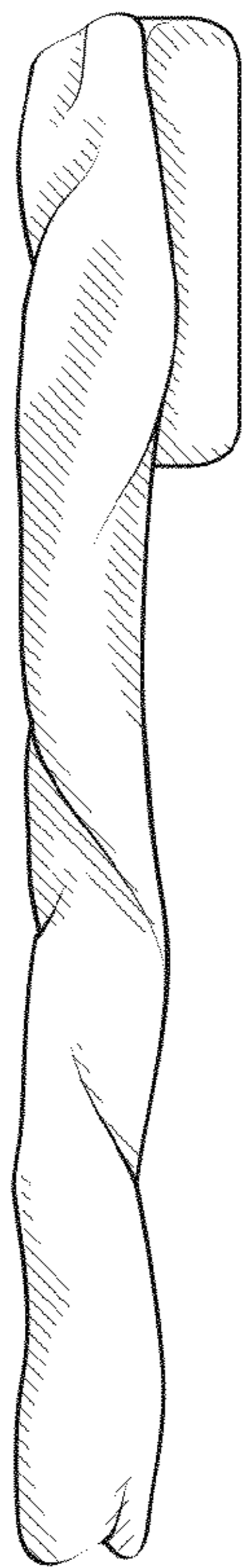

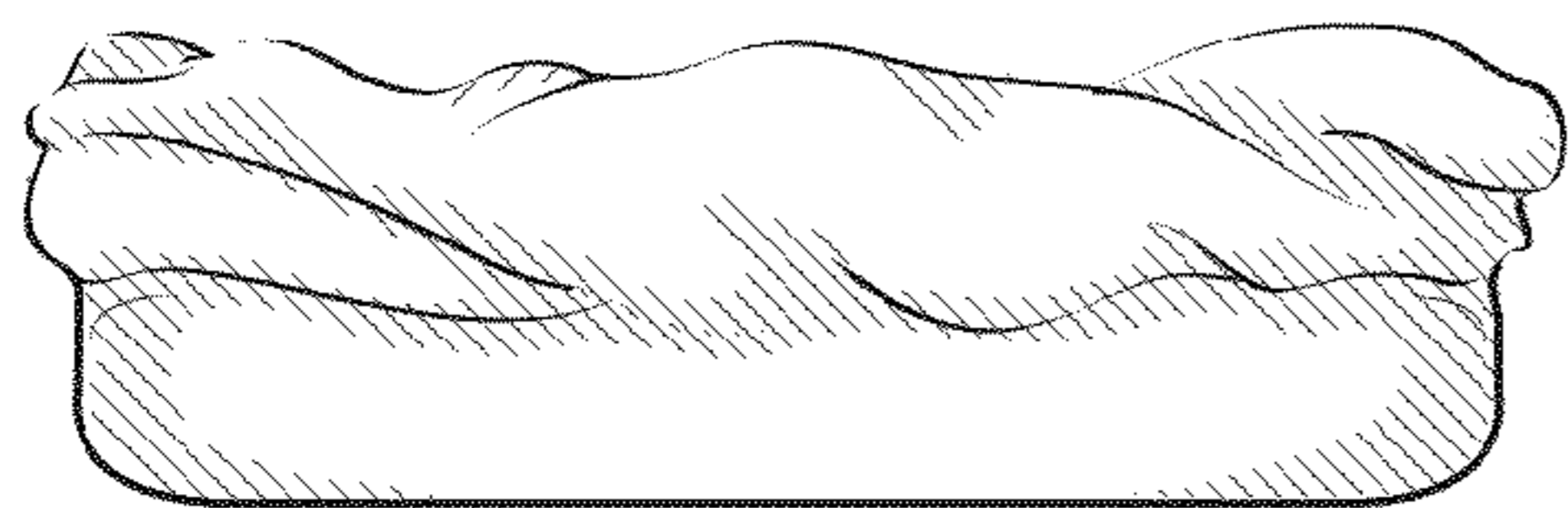

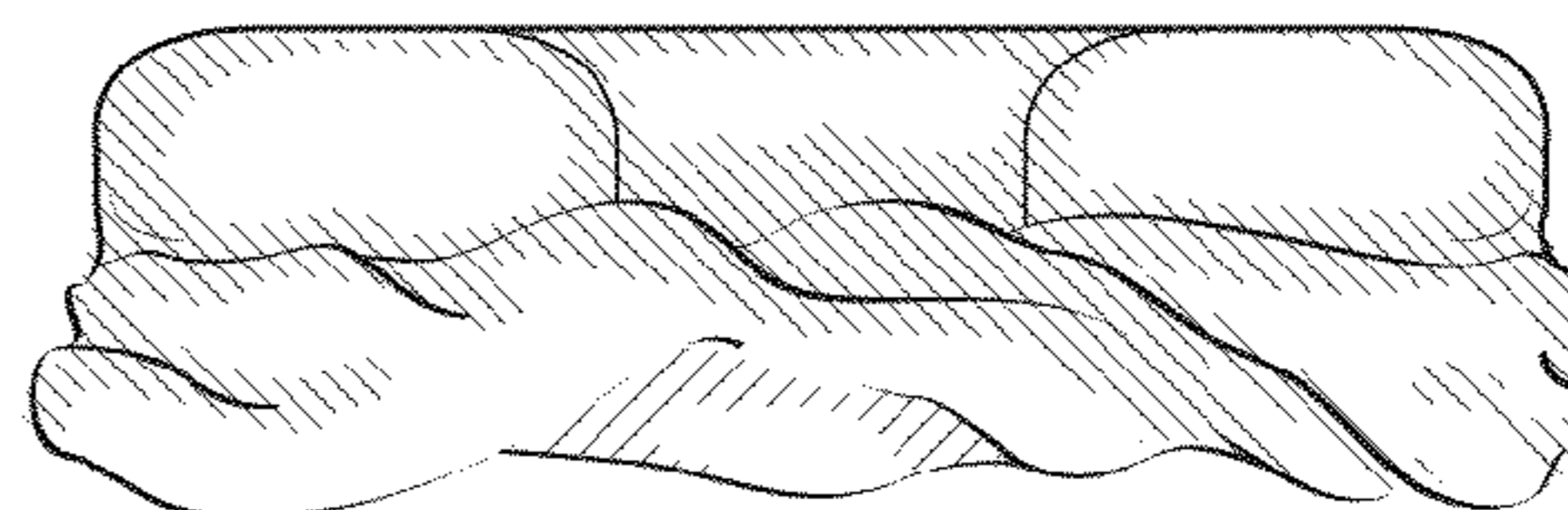
