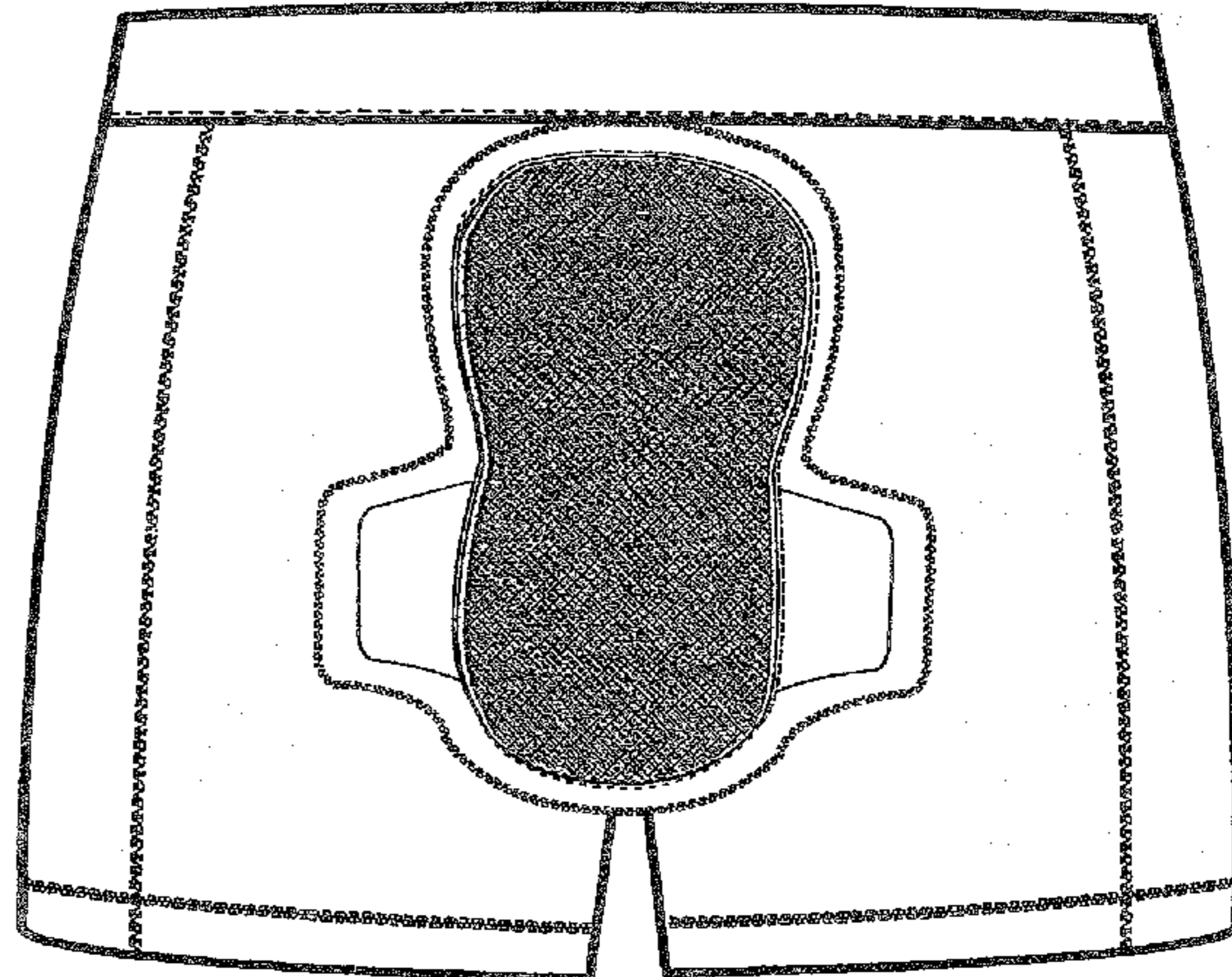
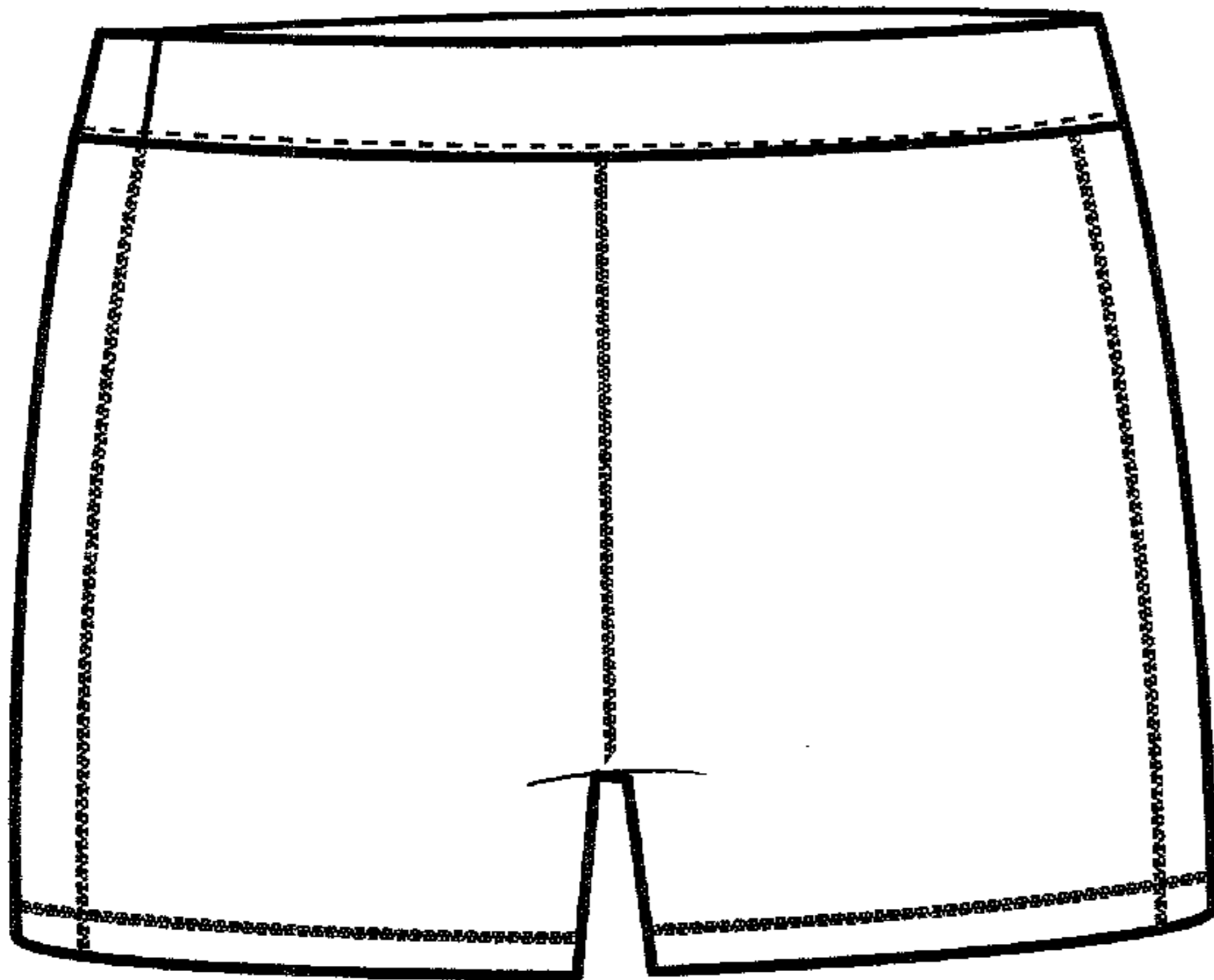
(57) **CLAIM**

The ornamental design for a protective garment, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a protective garment showing our new design;
FIG. 2 is a rear elevational view thereof;
FIG. 3 is a left side elevational view thereof, the right side elevational view being a mirror image thereof;
FIG. 4 is a top-front perspective view thereof; and,
FIG. 5 is a bottom-rear perspective view thereof.
The broken lines shown in the figures represent stitching and form part of the claimed design.

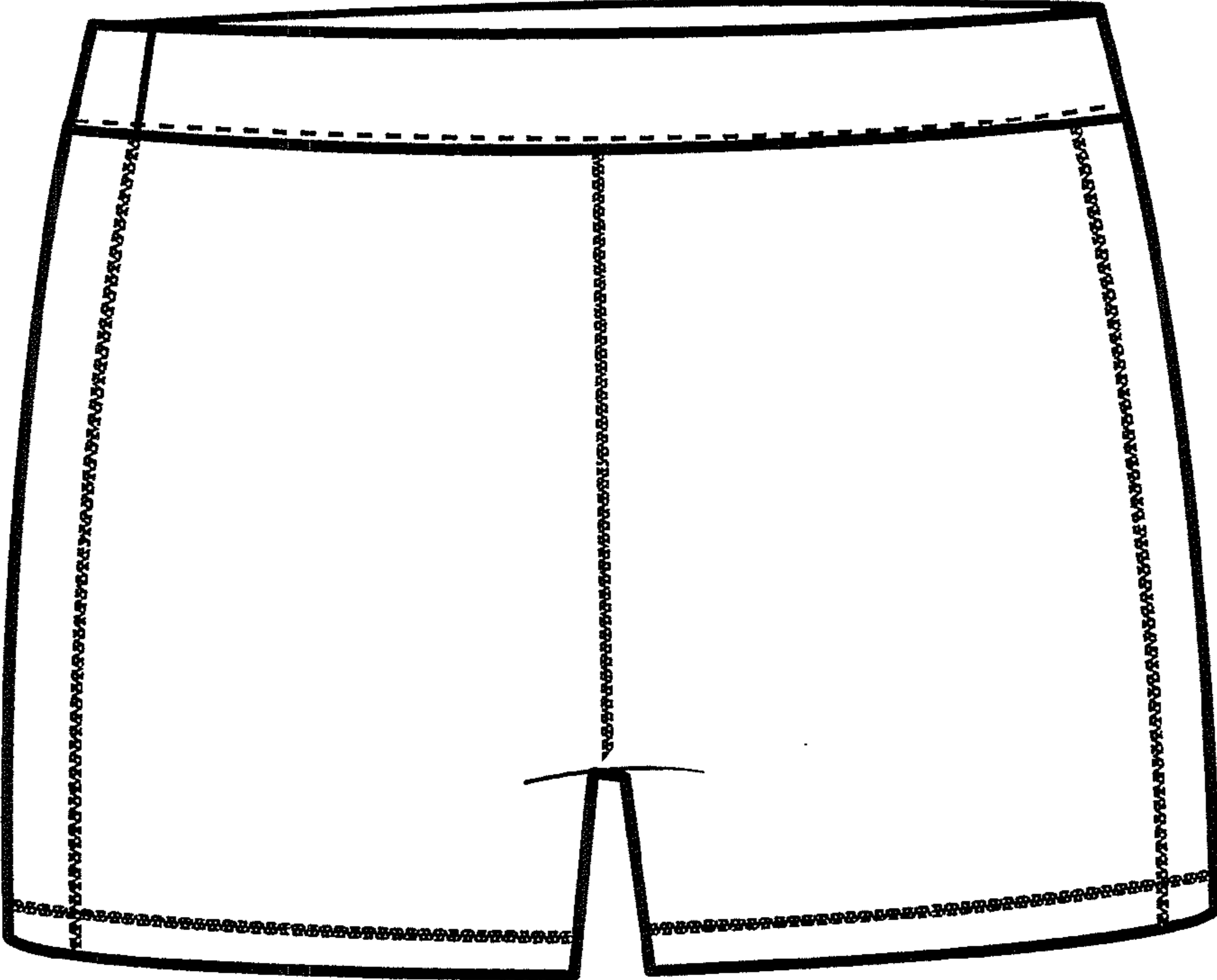

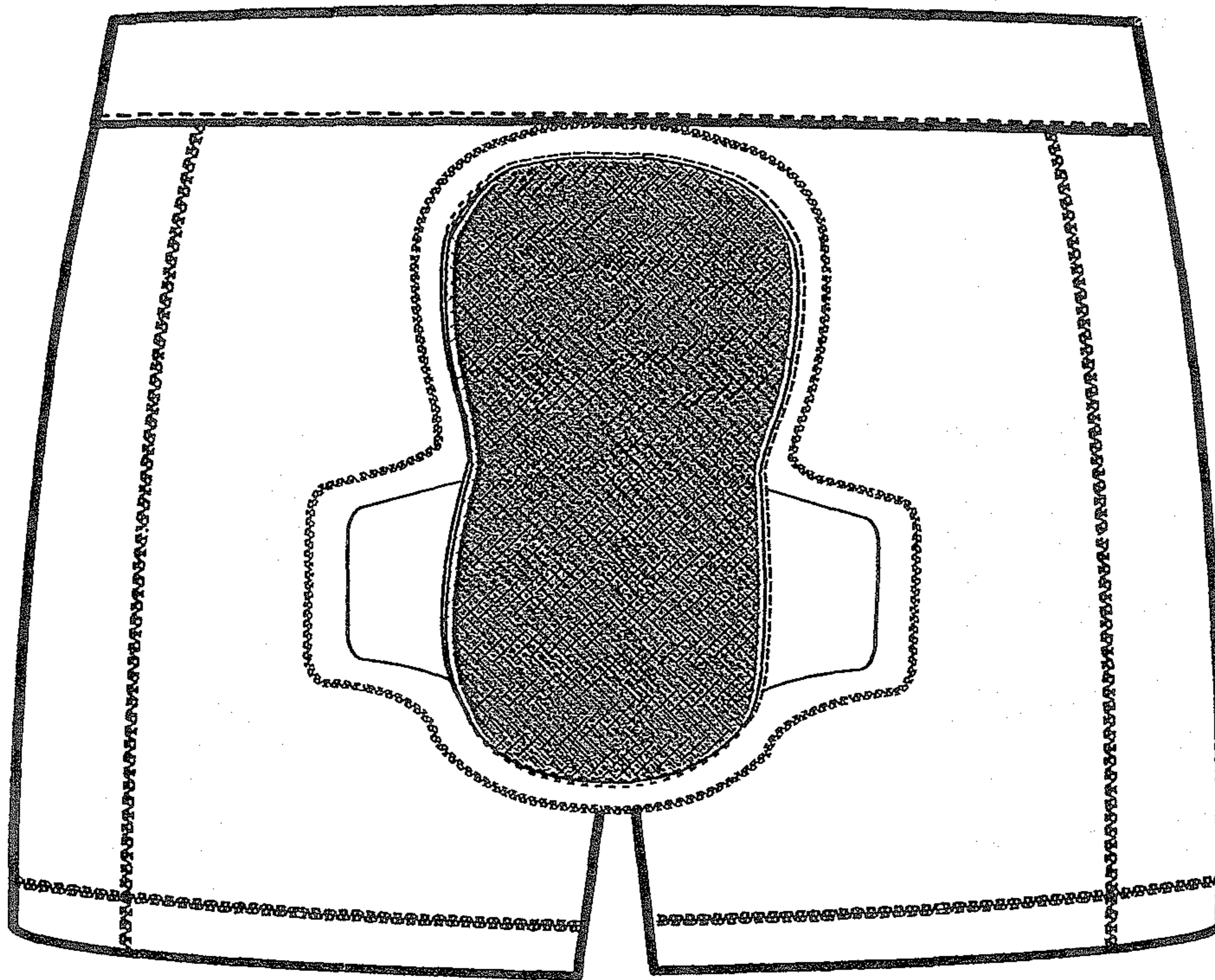

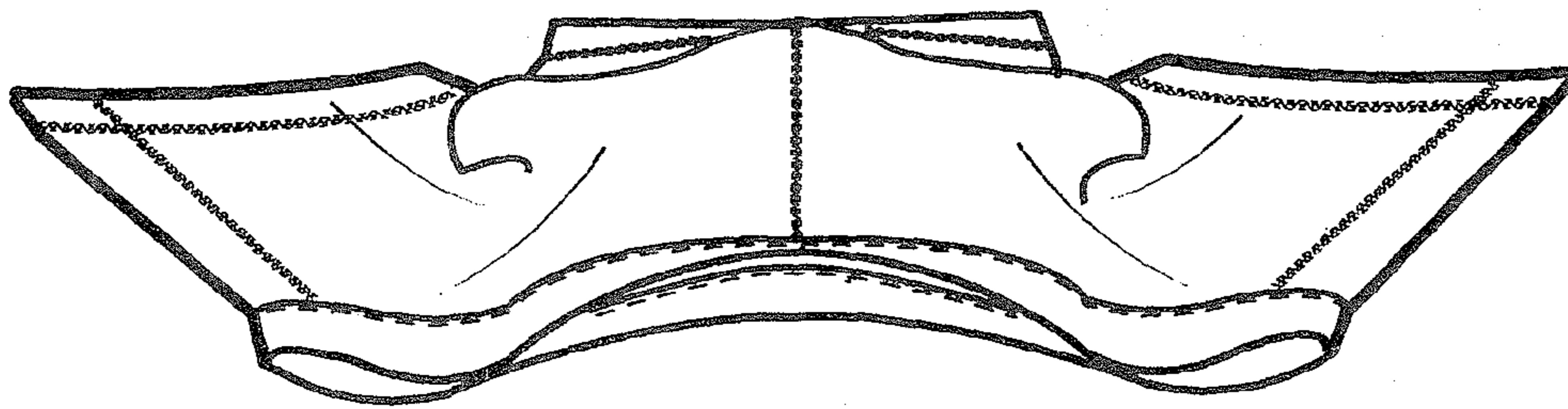

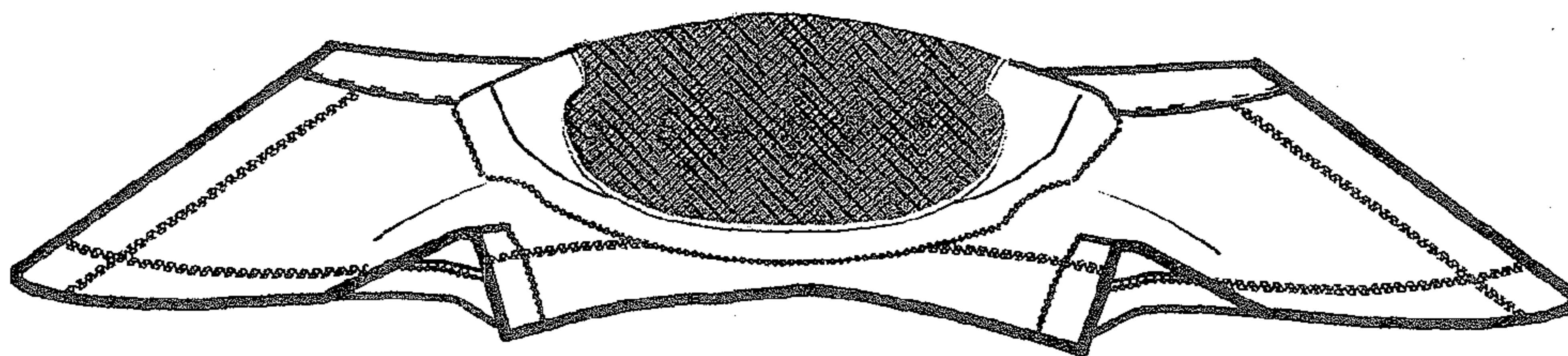
