(57) **CLAIM**

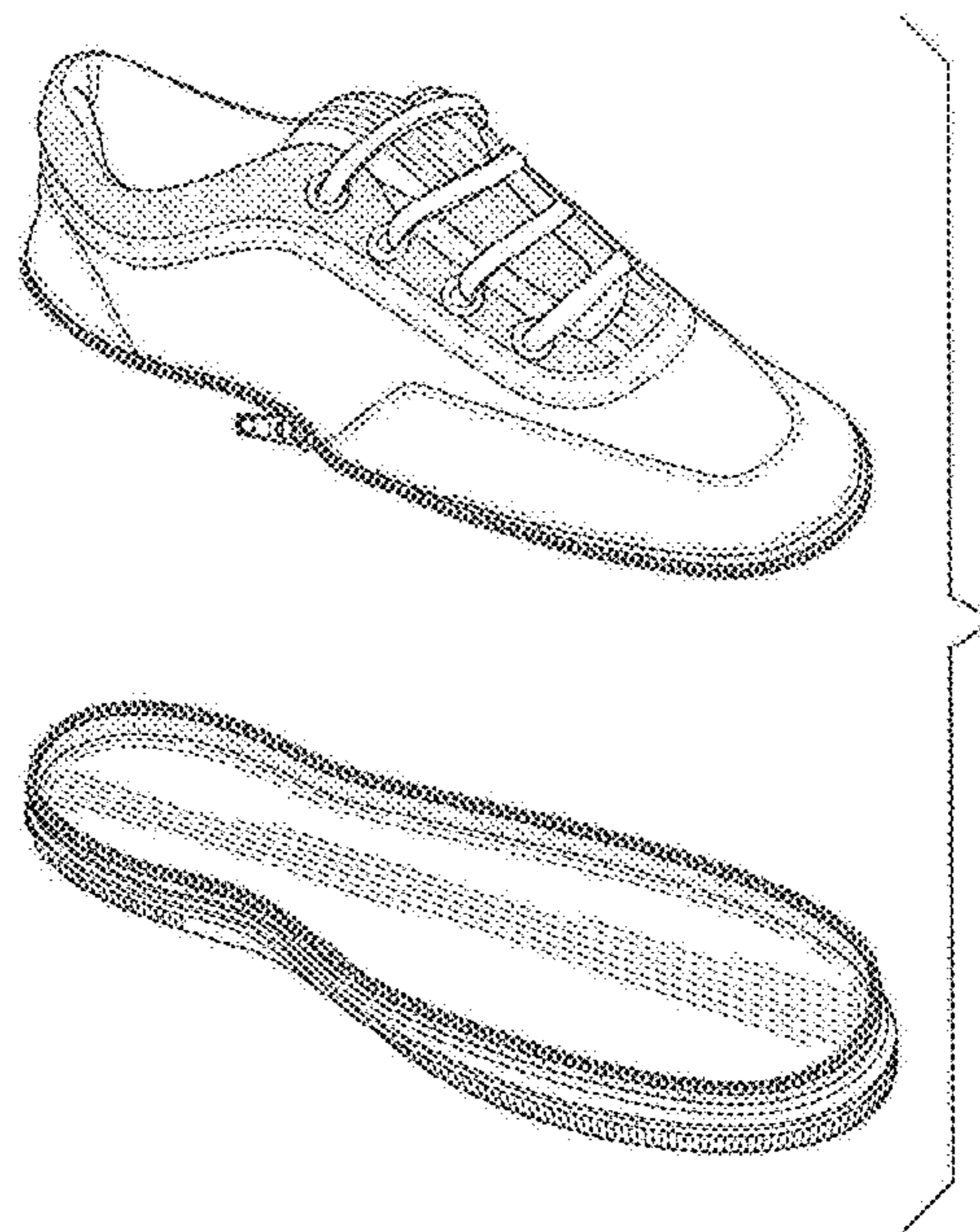
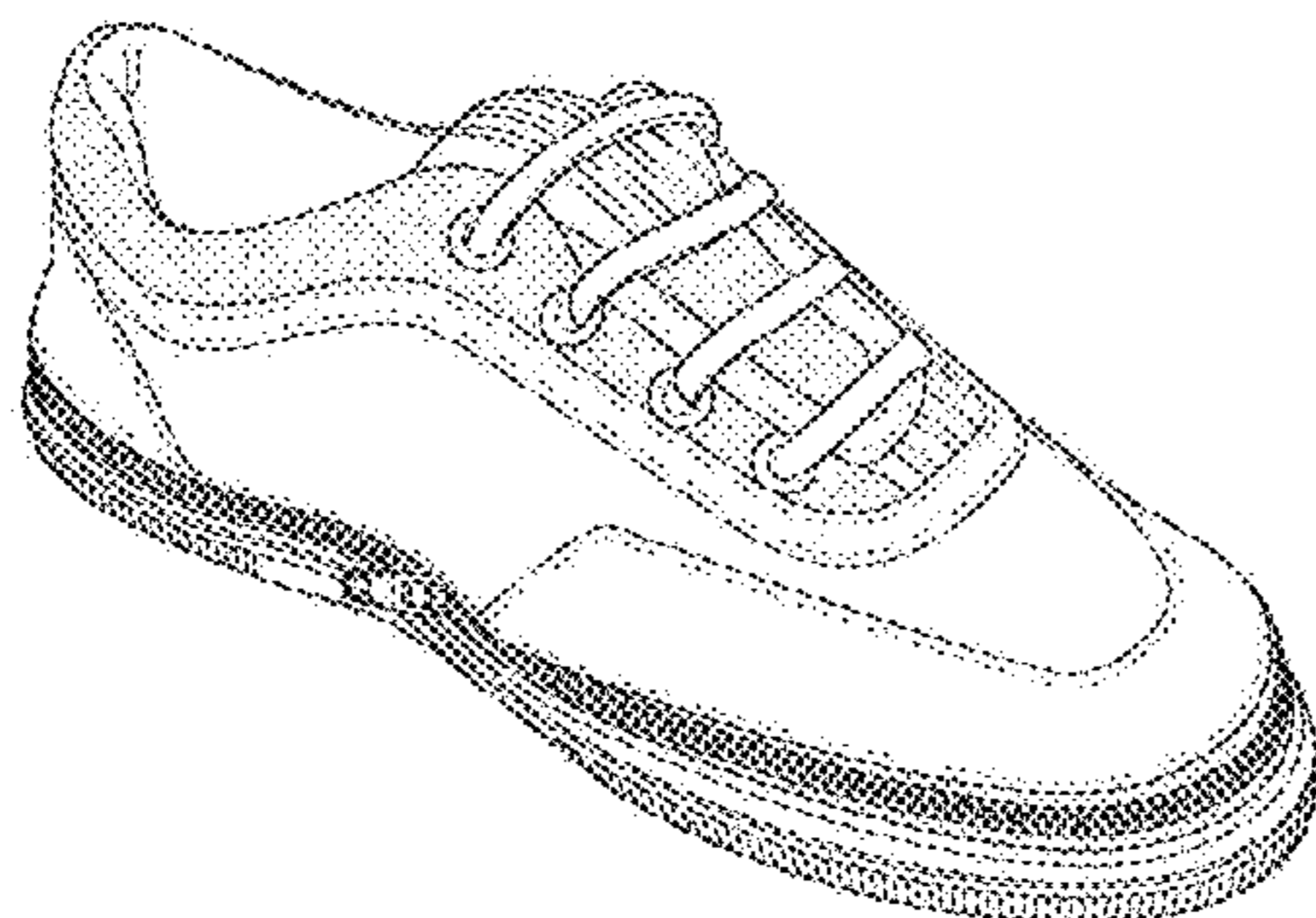
The ornamental design for a zipper shoe, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of a zipper shoe showing my new design;
FIG. 2 is a bottom back perspective view thereof;
FIG. 3 is an exploded front perspective view thereof shown in a detached configuration;
FIG. 4 is a right side view thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is a front view thereof;
FIG. 7 is a back view thereof;
FIG. 8 is a top view thereof; and,
FIG. 9 is a bottom view thereof.

The broken lines shown on the zipper shoe represent thread stitching.

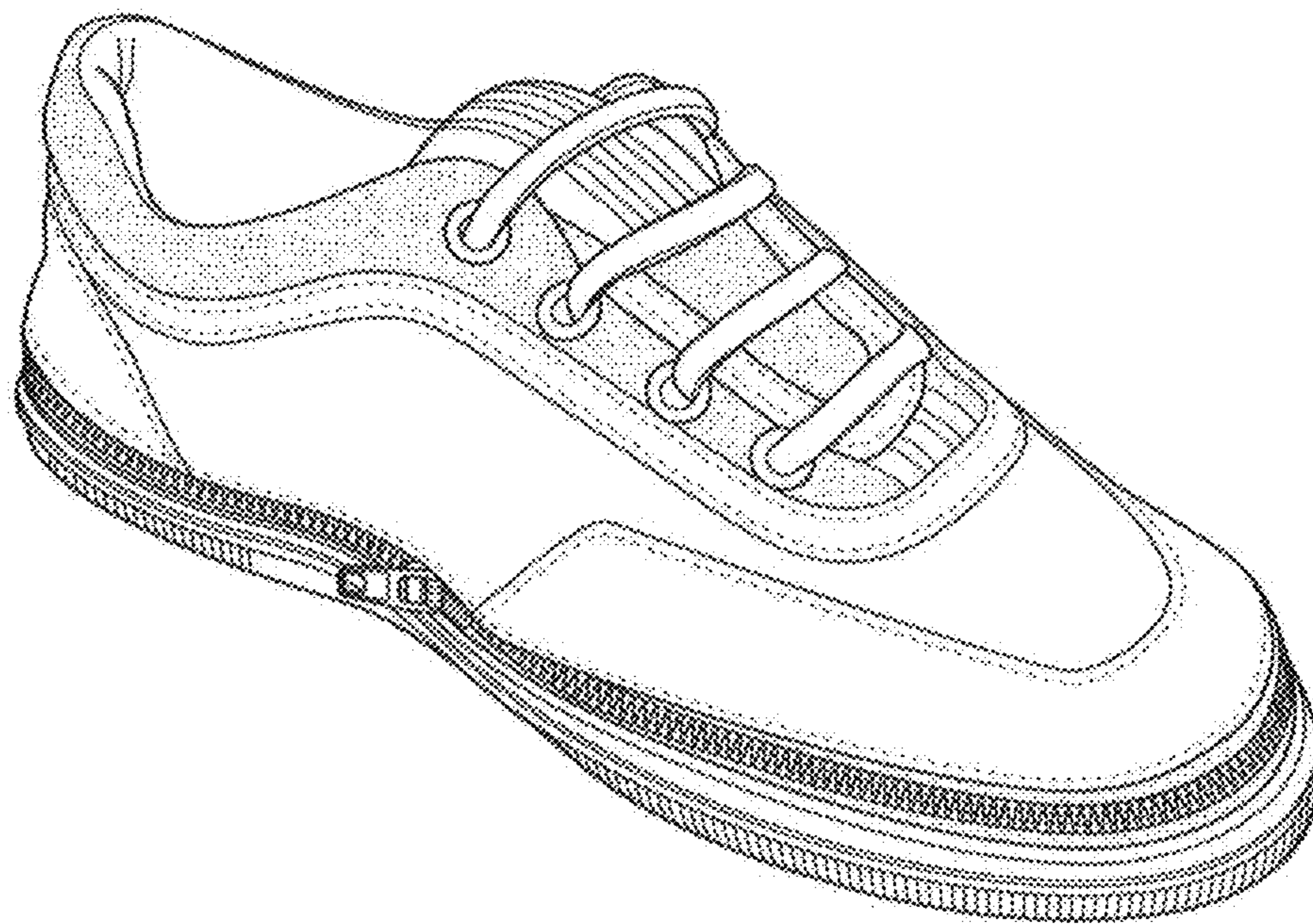

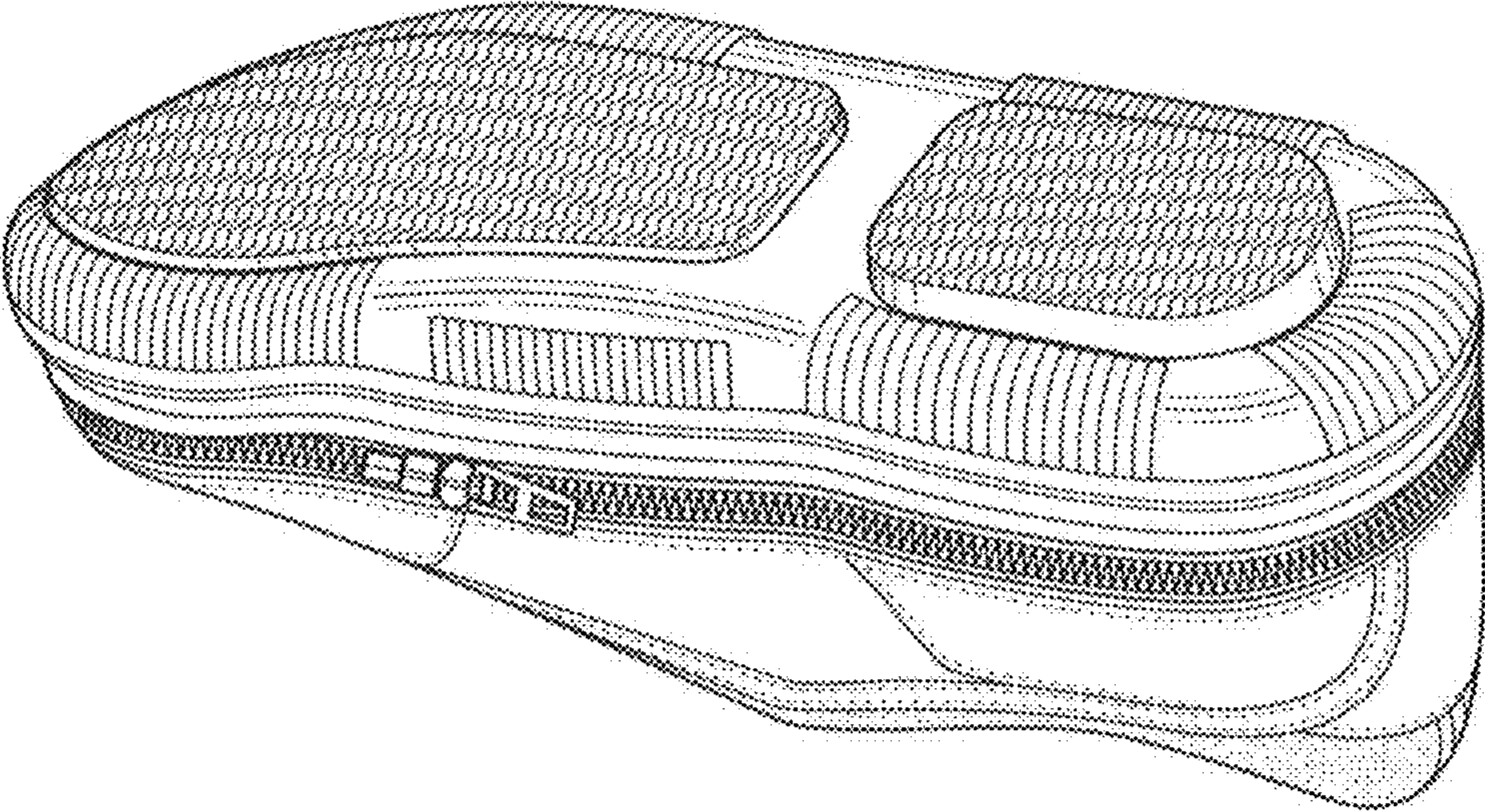

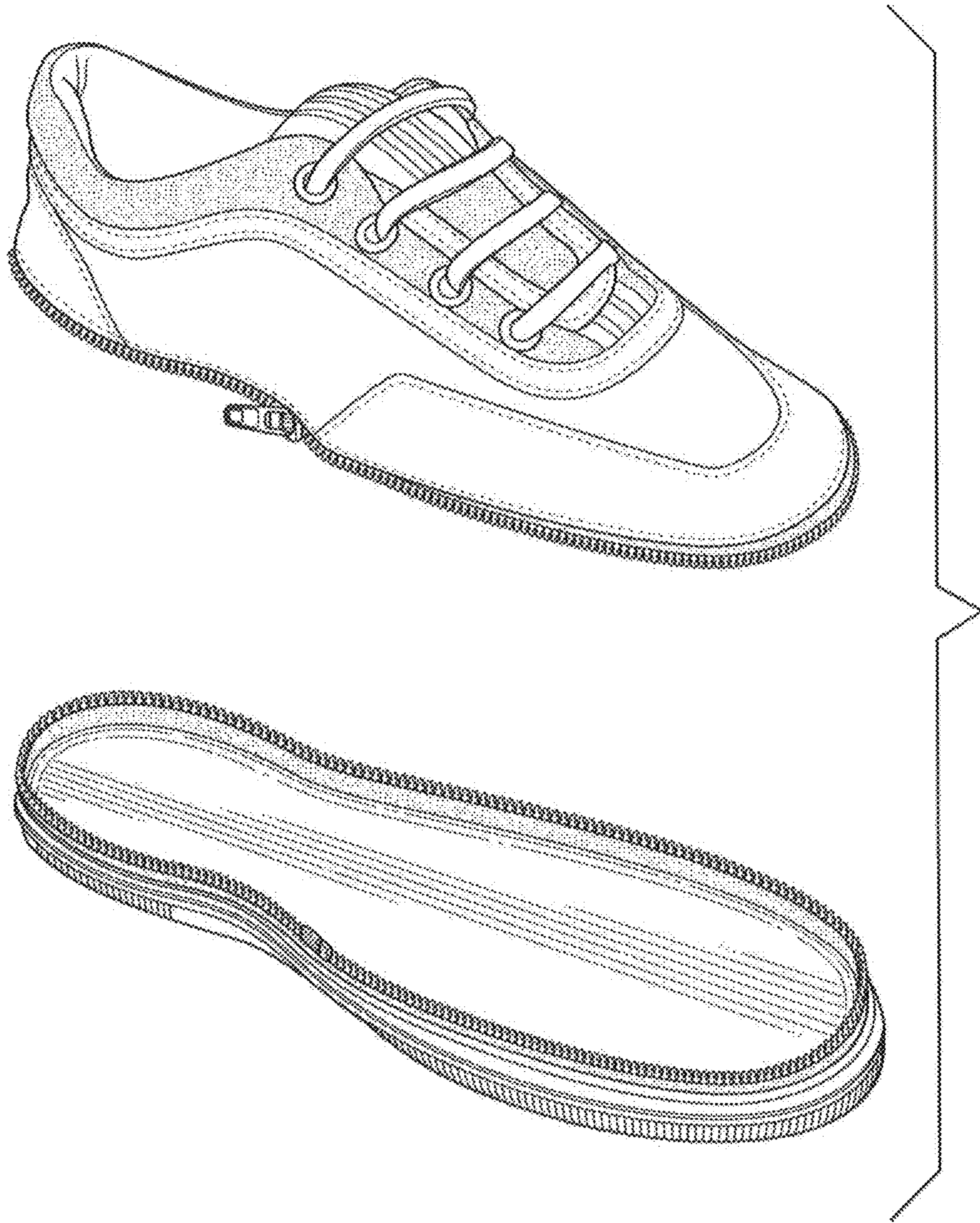

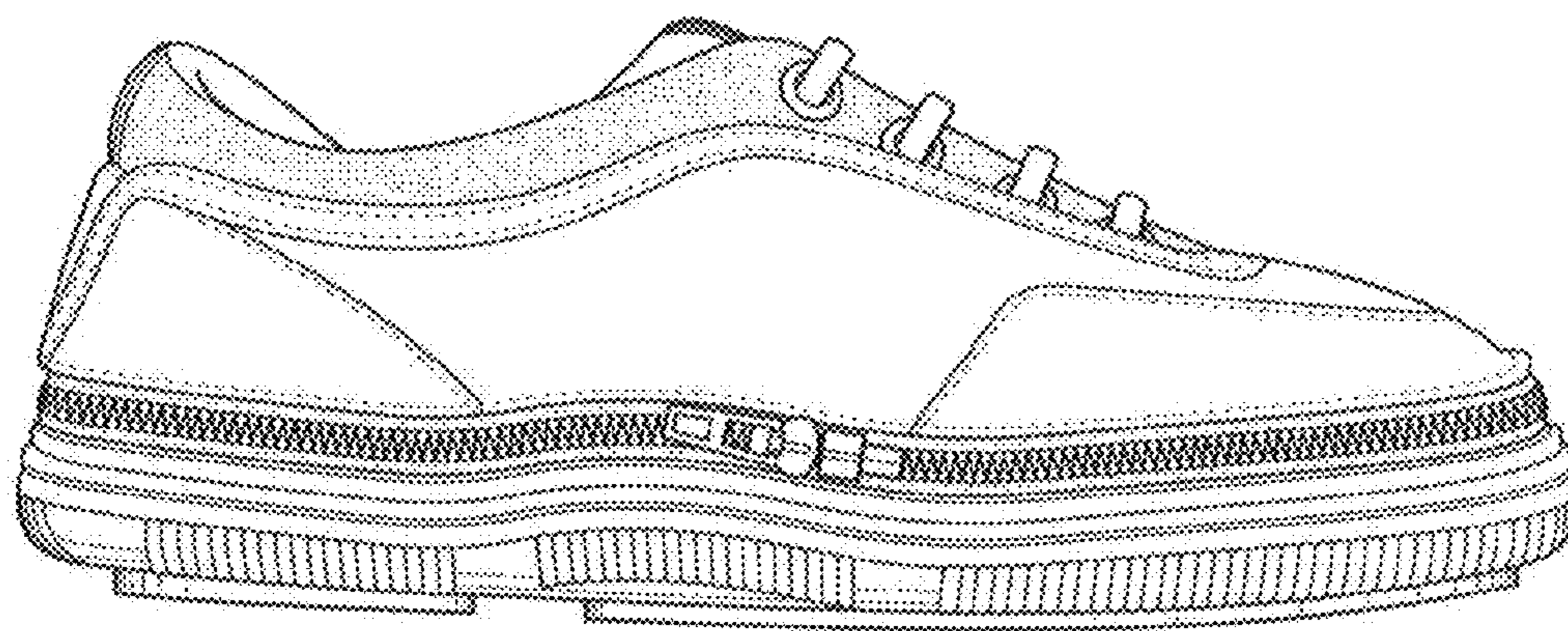

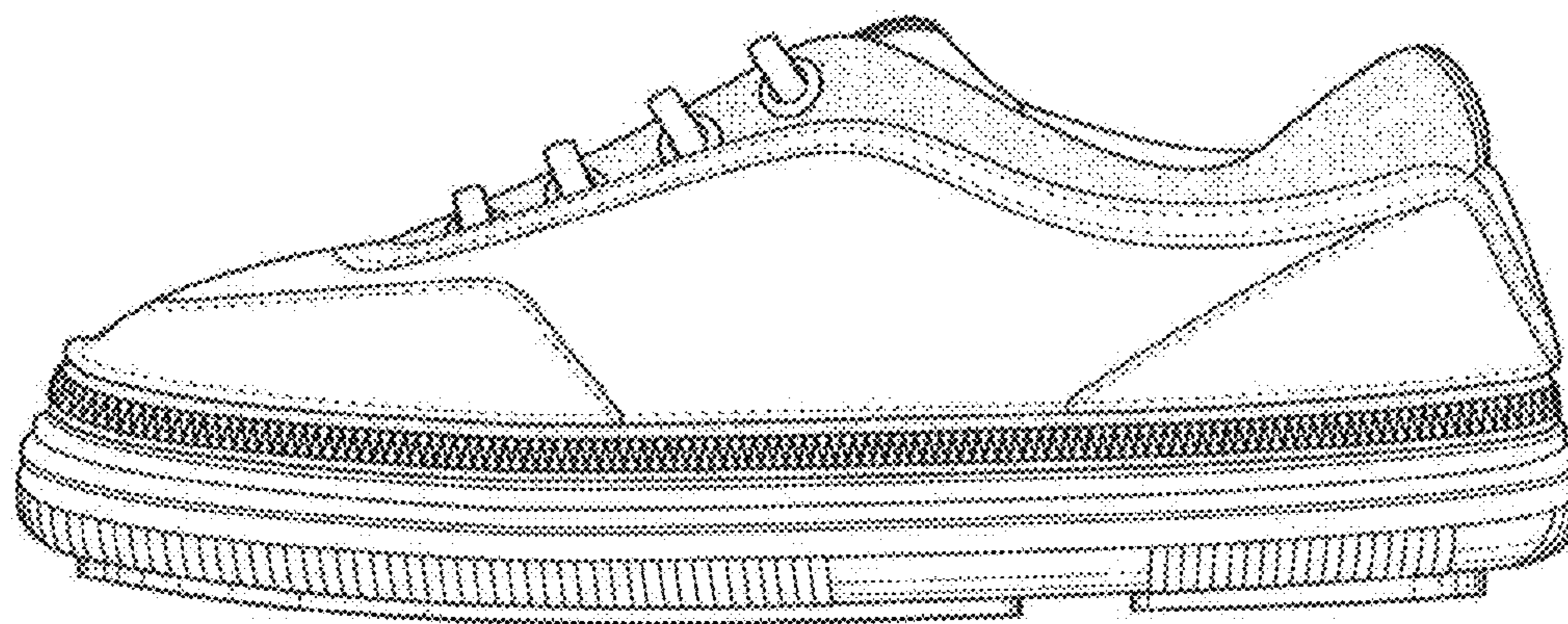

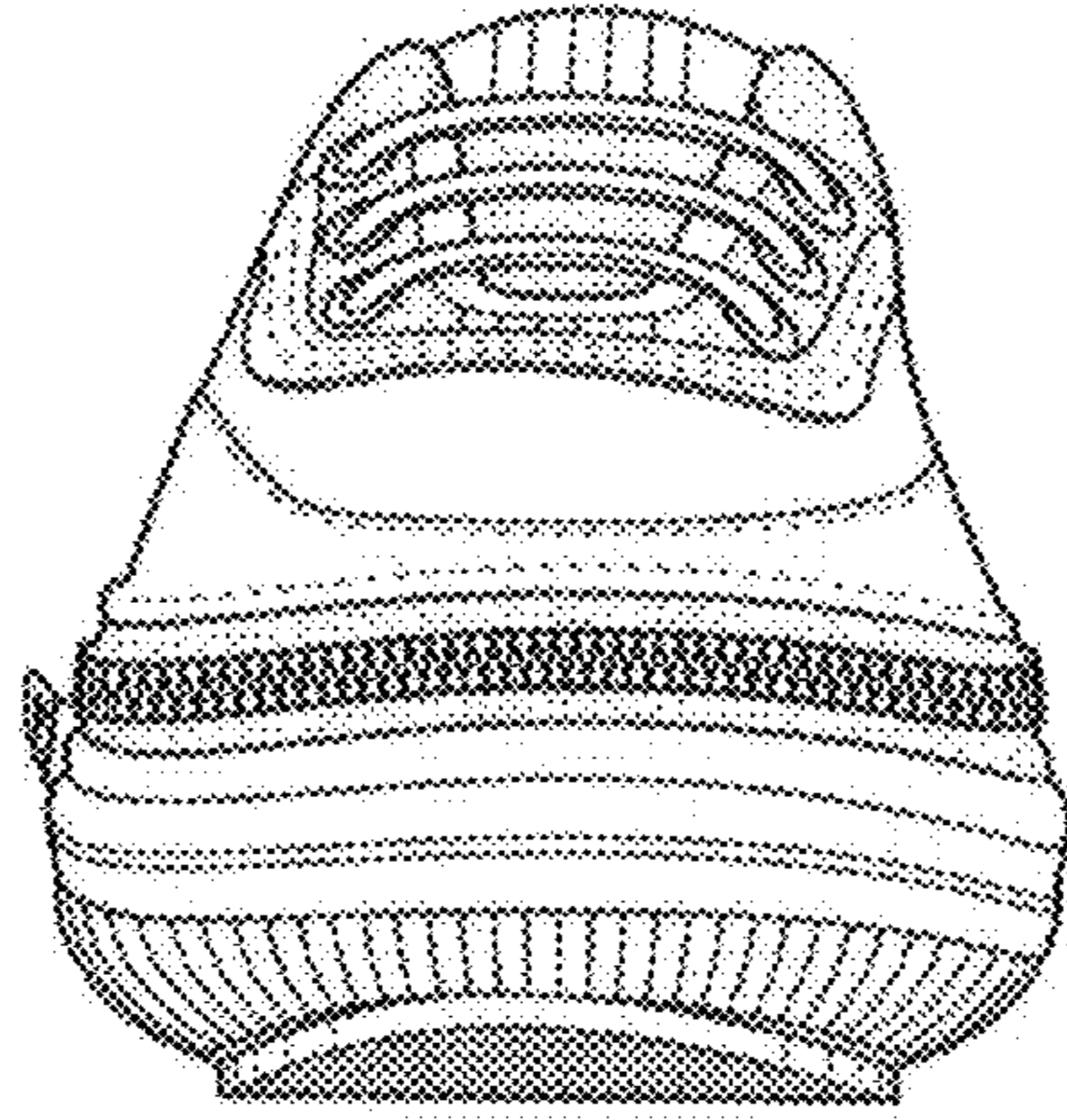

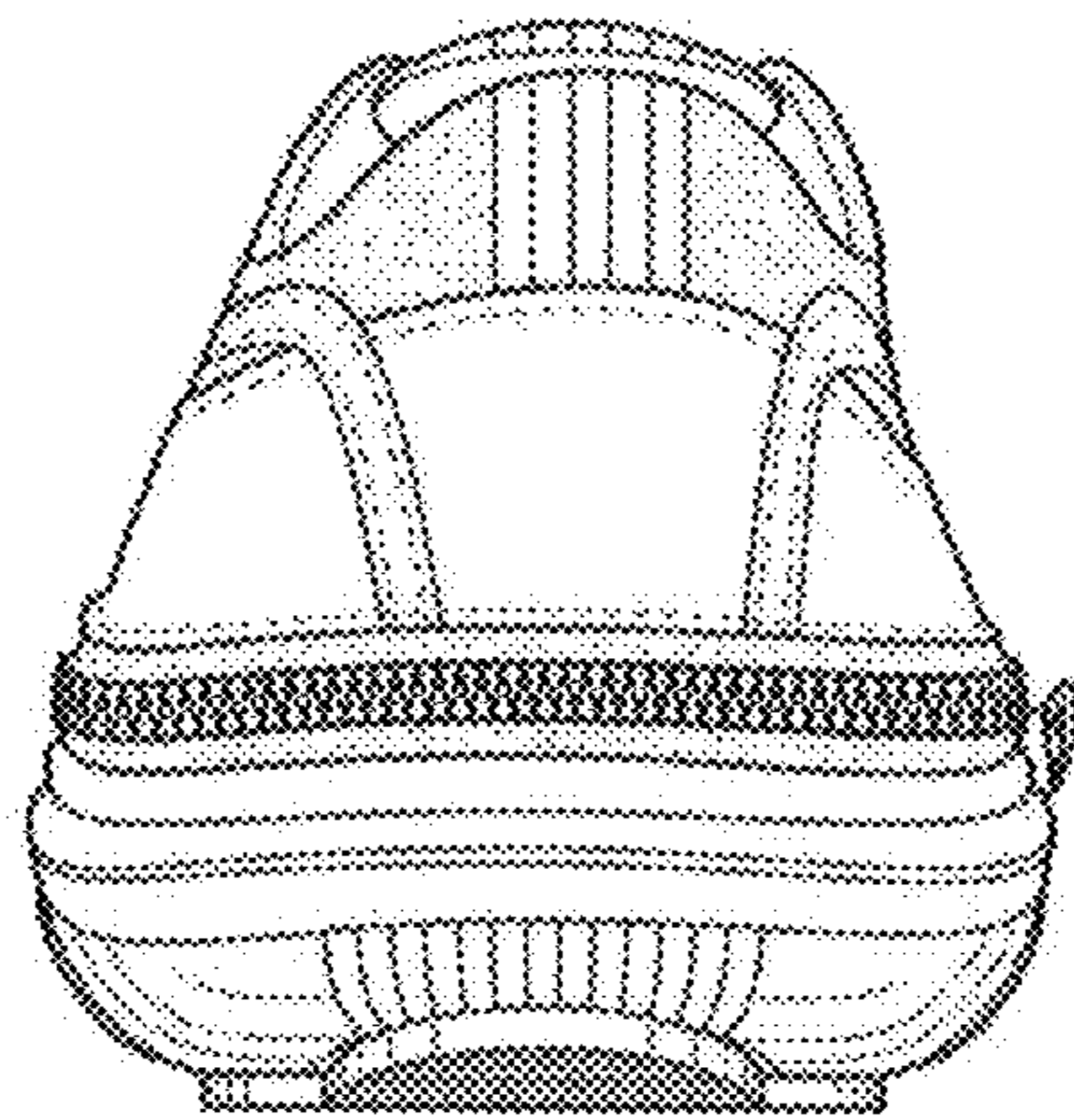

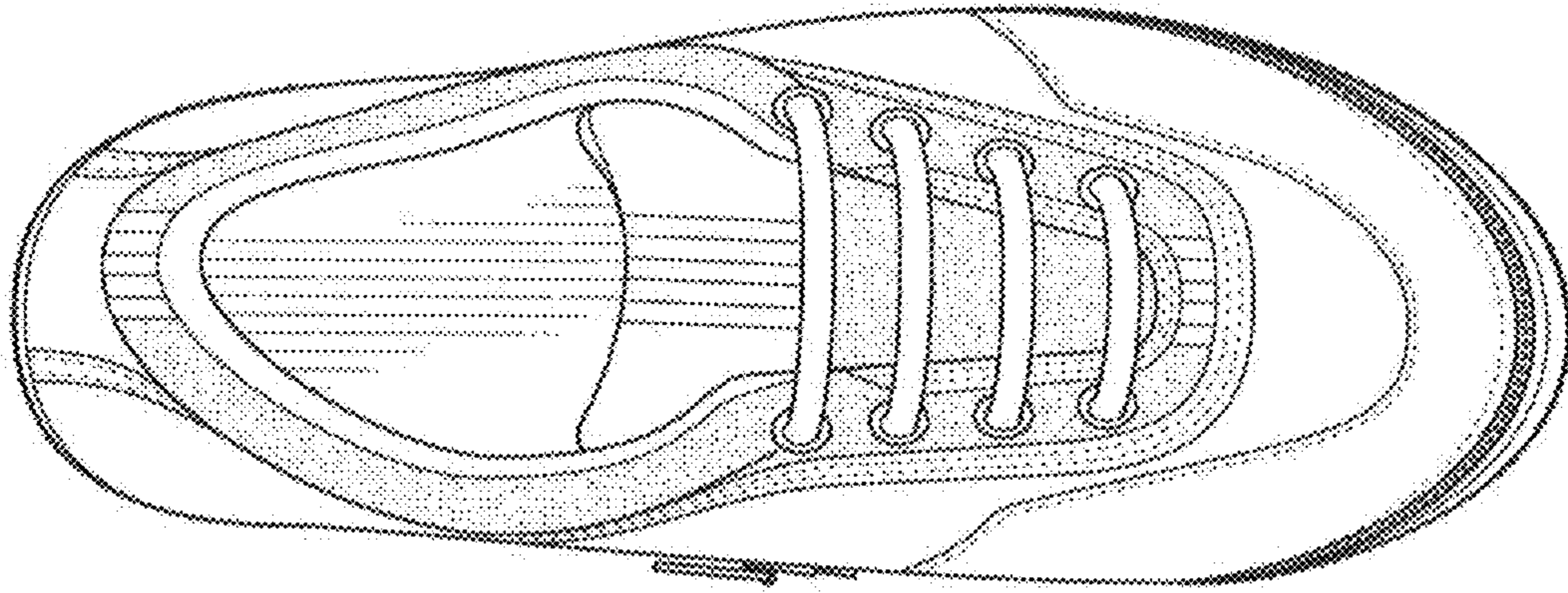

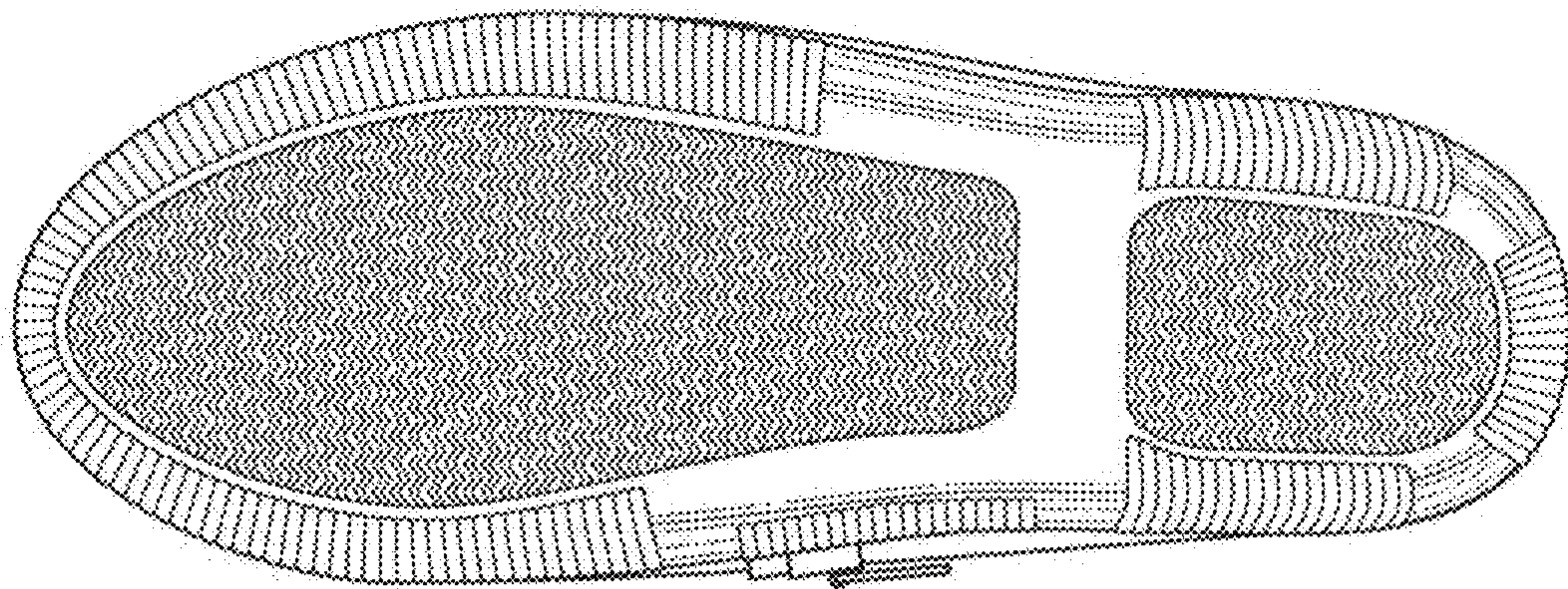
