(57) **CLAIM**
The ornamental design for a footwear outsole, as shown and described.

DESCRIPTION

FIG. 1 is a left side view of a footwear outsole showing my new design;
FIG. 2 is a right side view of FIG. 1;
FIG. 3 is another left side view of FIG. 1, the boot shown in broken lines being removed for ease of illustration;
FIG. 4 is a perspective view of FIG. 1;
FIG. 5 is a back view of FIG. 1;
FIG. 6 is a bottom view of FIG. 1; and,
FIG. 7 is a top view of FIG. 1.
The broken lines shown in the drawings represent portions of the footwear outsole that form no part of the claimed design. All surfaces not shown form no part of the claimed design.

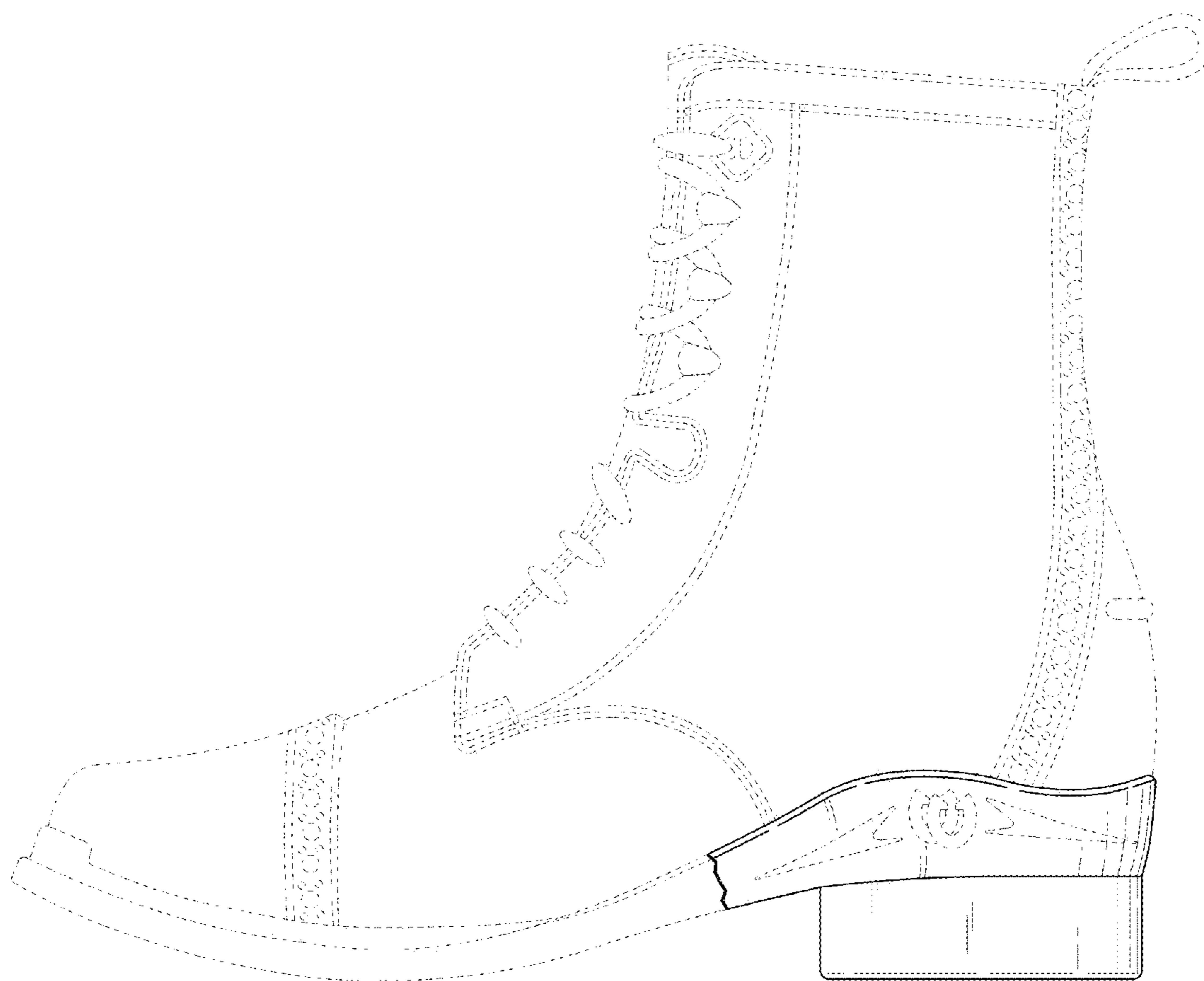

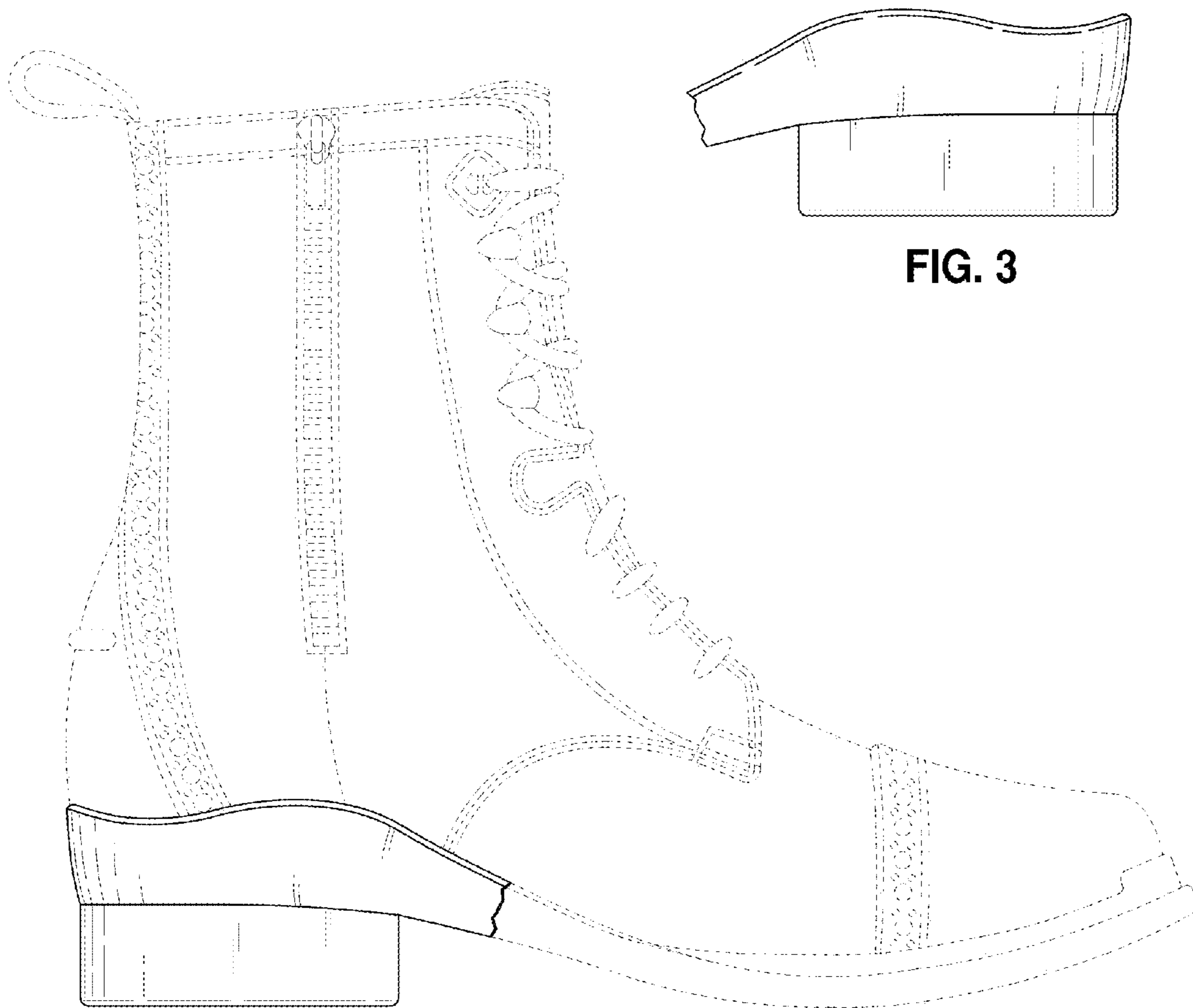

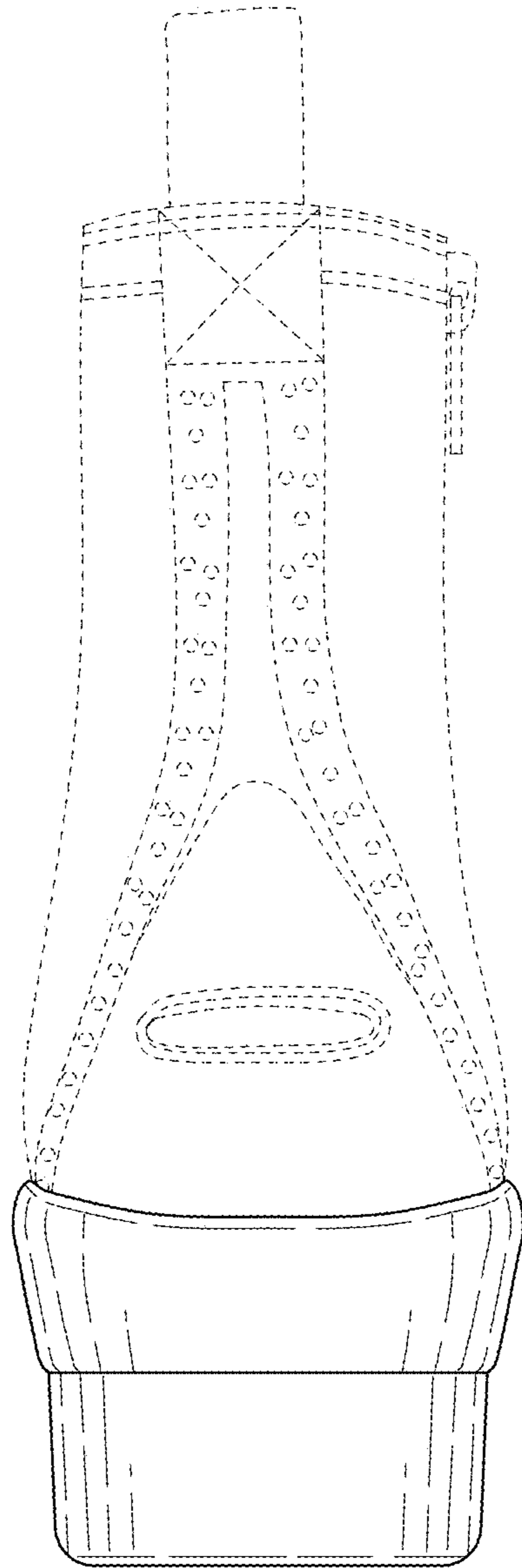

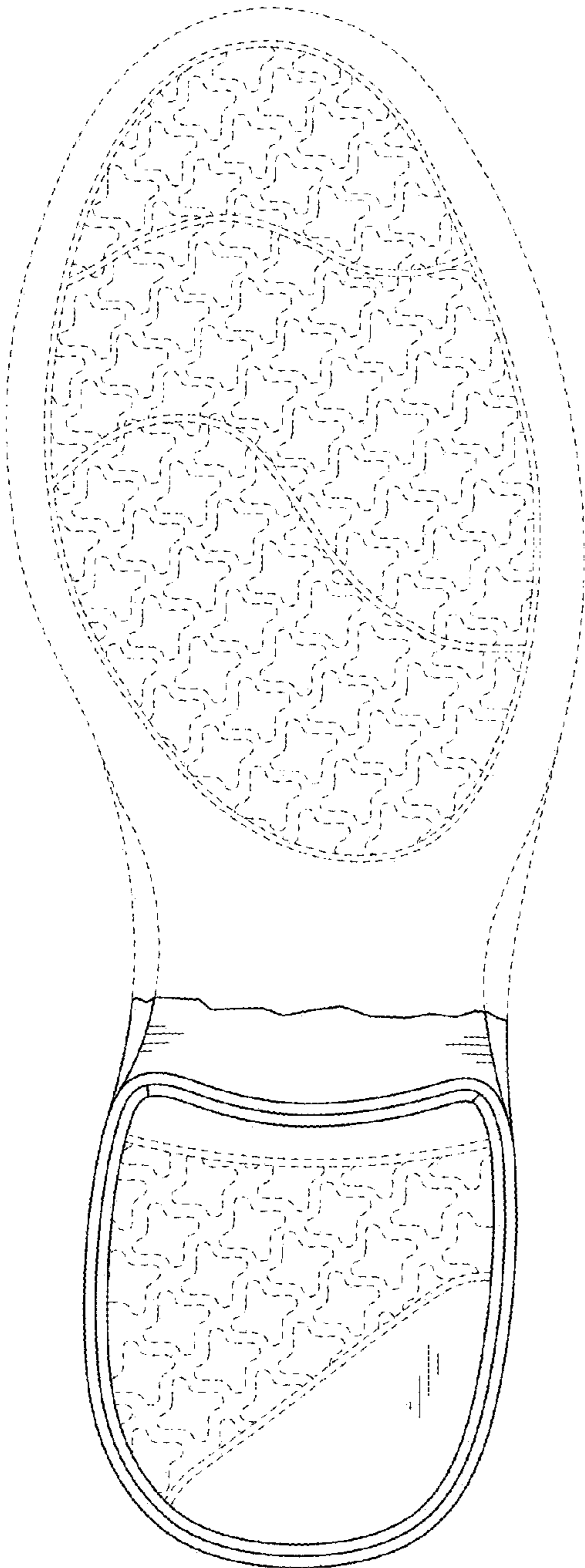

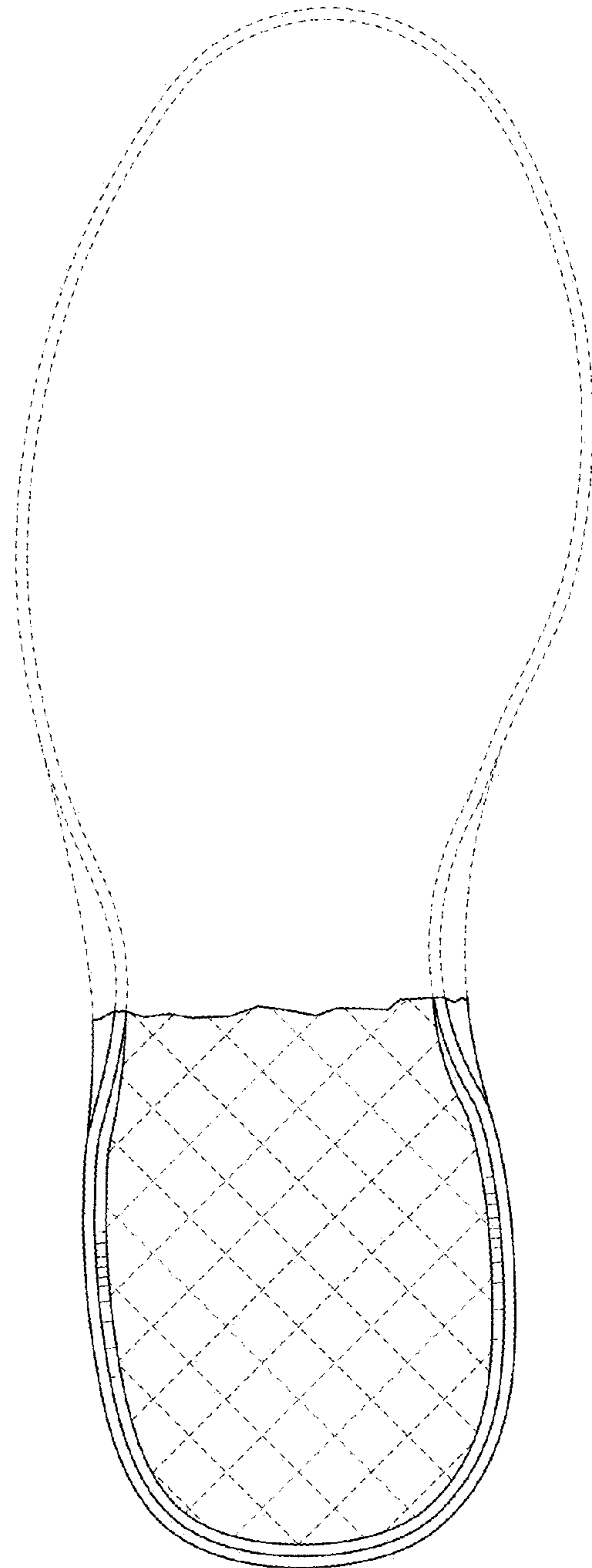
