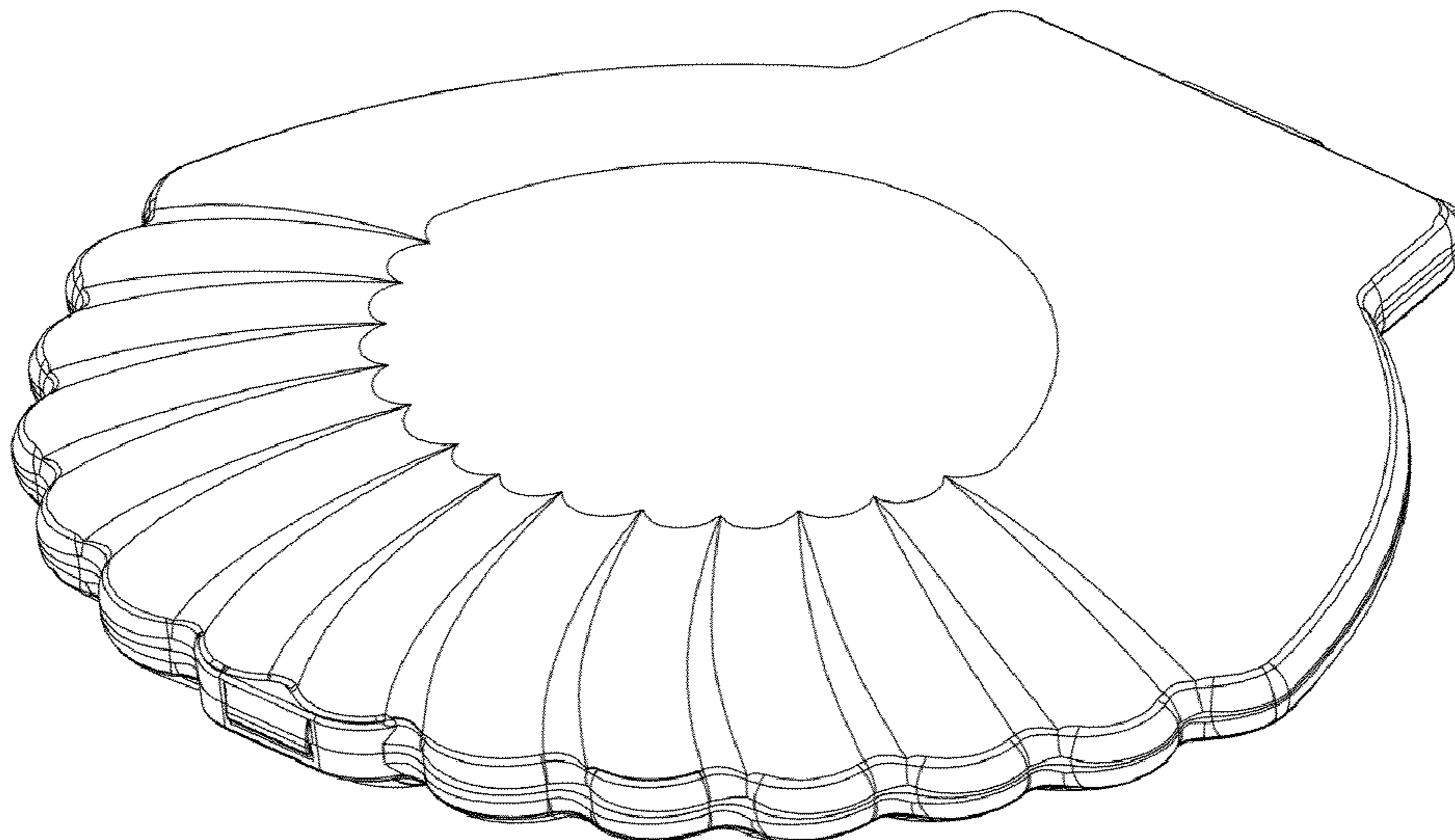
FIG. 1 is a front perspective view of the seafood platter of the claimed design, in a closed position;
FIG. 2 is a front perspective view of the seafood platter of the claimed design, in a partially open position;
FIG. 3 is another front perspective view of the seafood platter of the claimed design, in a partially open position;
FIG. 4 is an enlarged perspective view of the latch of a seafood platter, in a locked position;
FIG. 5 is an enlarged perspective view of the latch of a seafood platter, in an unlocked position;
FIG. 6 is a top view of the seafood platter of the claimed design;
FIG. 7 is a front side view of the seafood platter of the claimed design;
FIG. 8 is a front perspective view of the seafood platter of the claimed design, in a fully open position;
FIG. 9 is an enlarged perspective view of the hinge portion of the seafood platter of the claimed design, which includes a receptacle that is configured to receive a fork;
FIG. 10 is a front perspective view of the seafood platter of the claimed design, in a fully open position, which shows the hinge portion in a detached position; and,
FIG. 11 is an enlarged perspective view of the hinge portion of the seafood platter of the claimed design in a detached position.

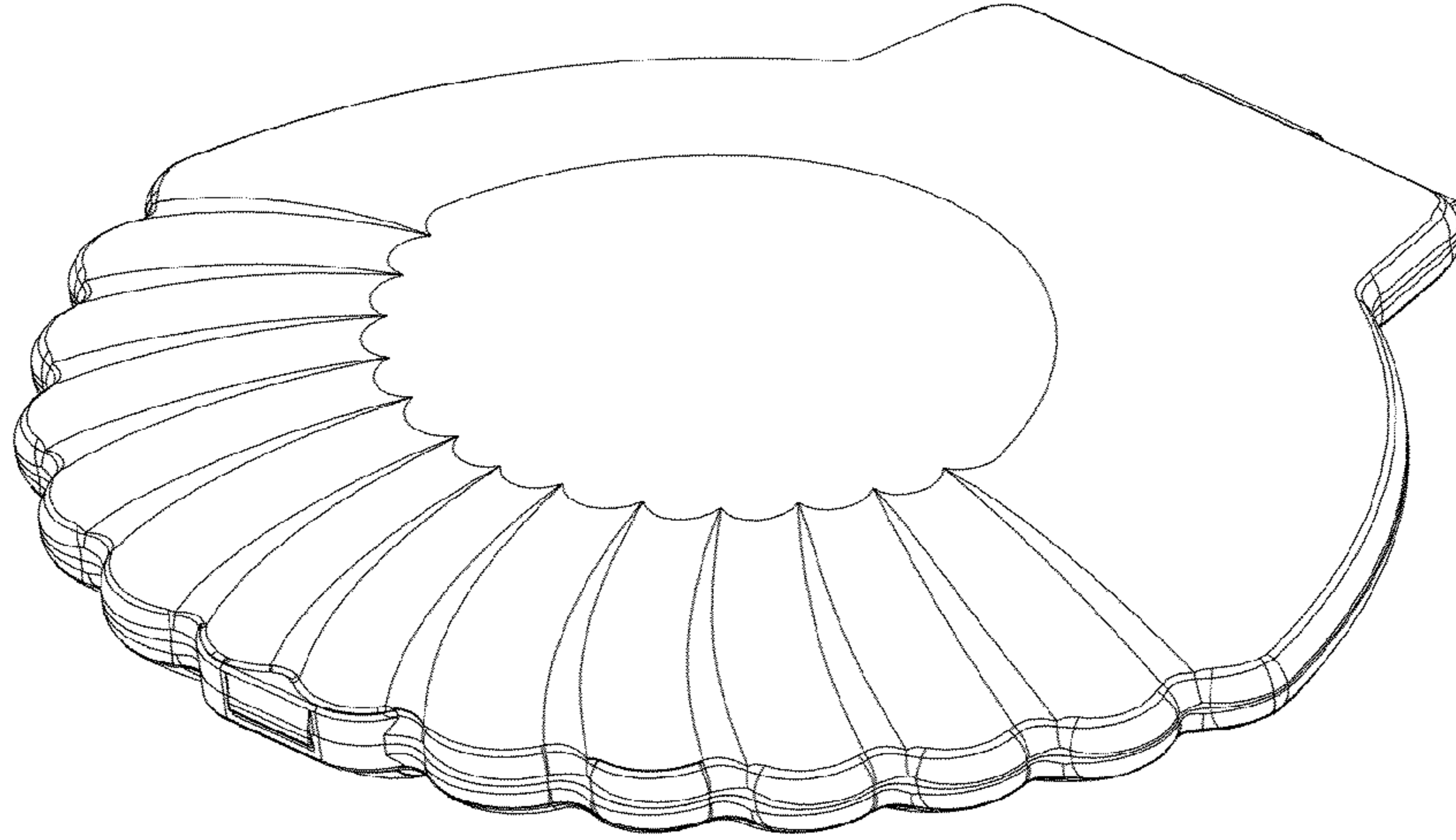

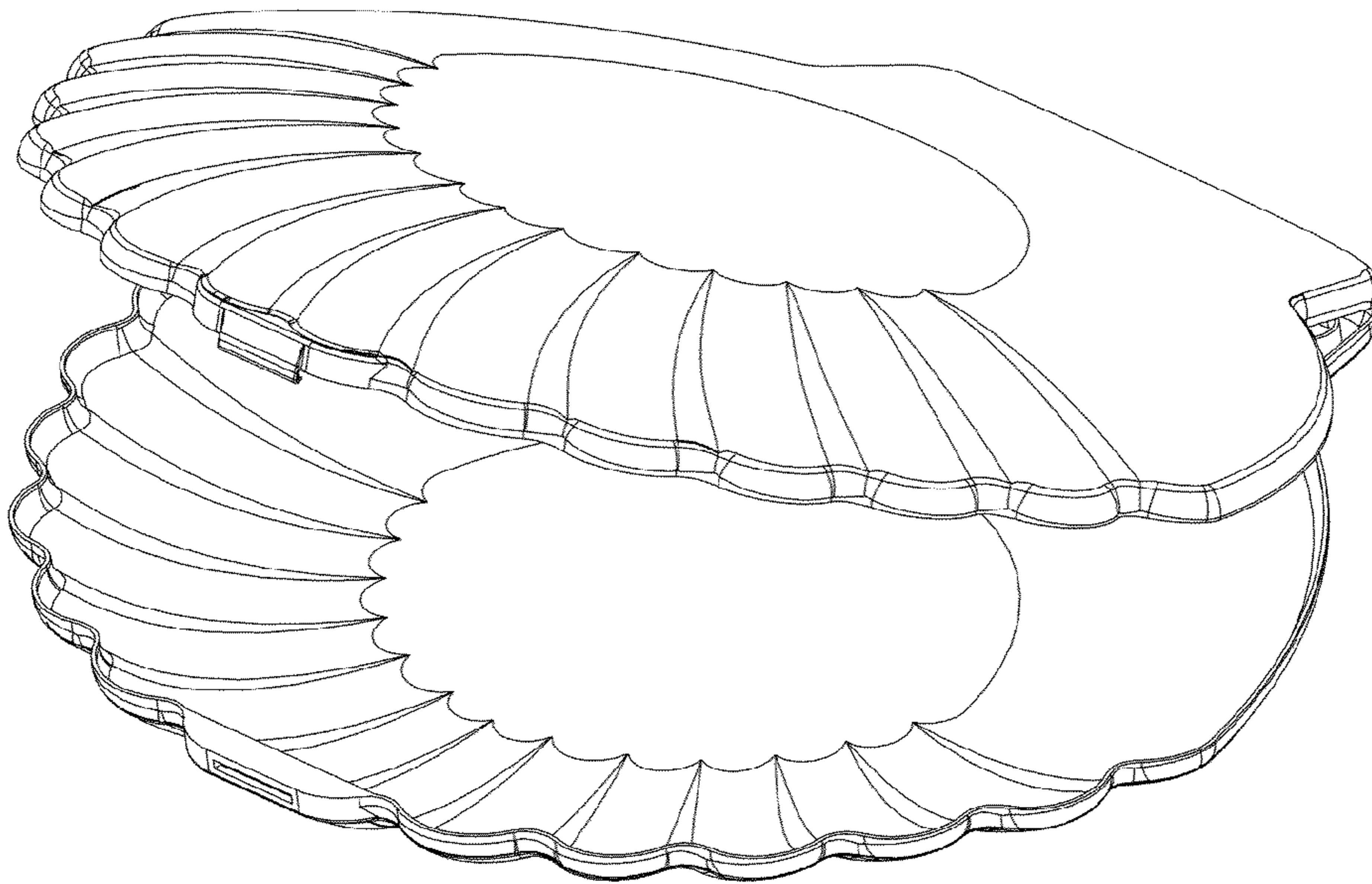

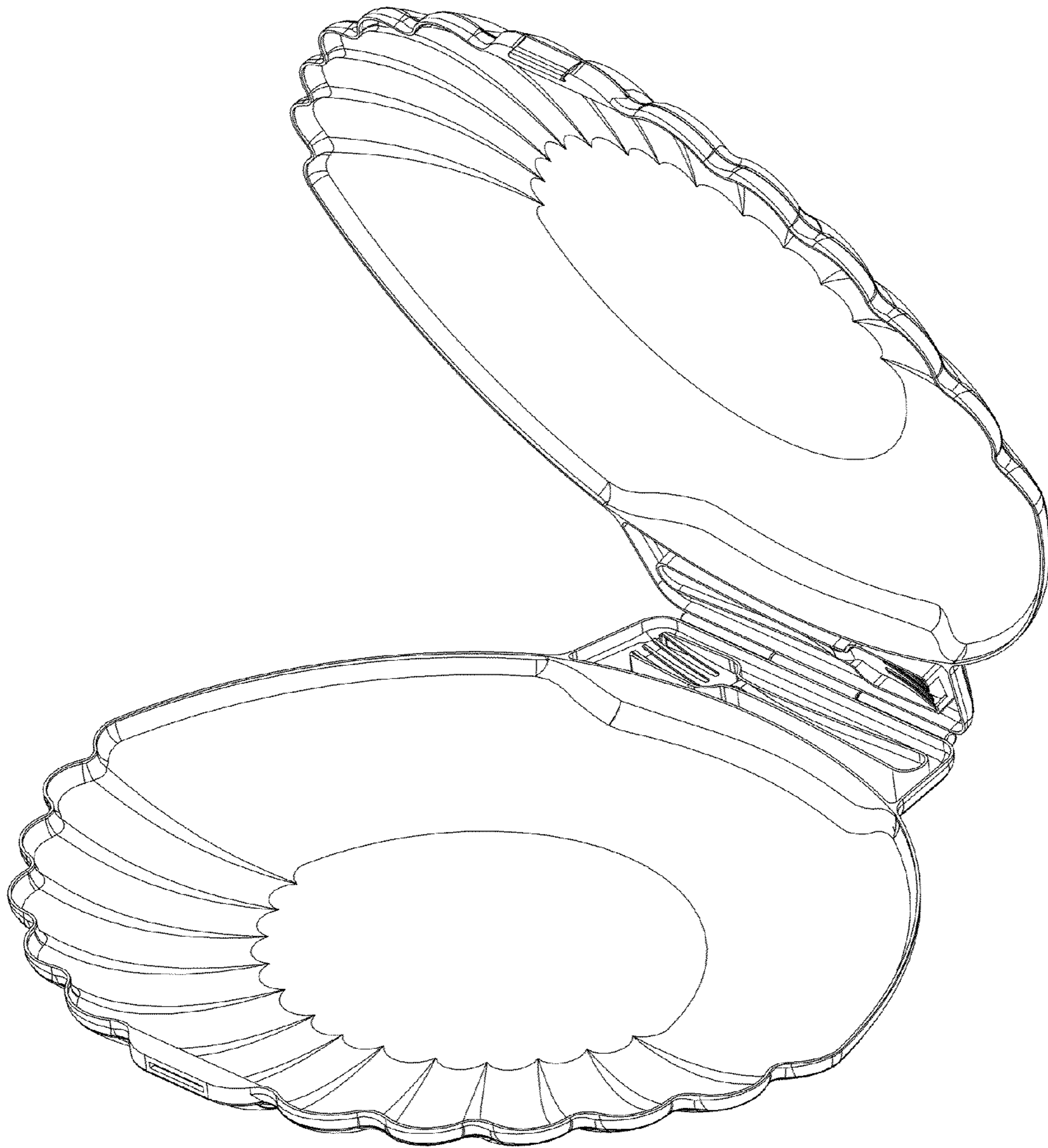

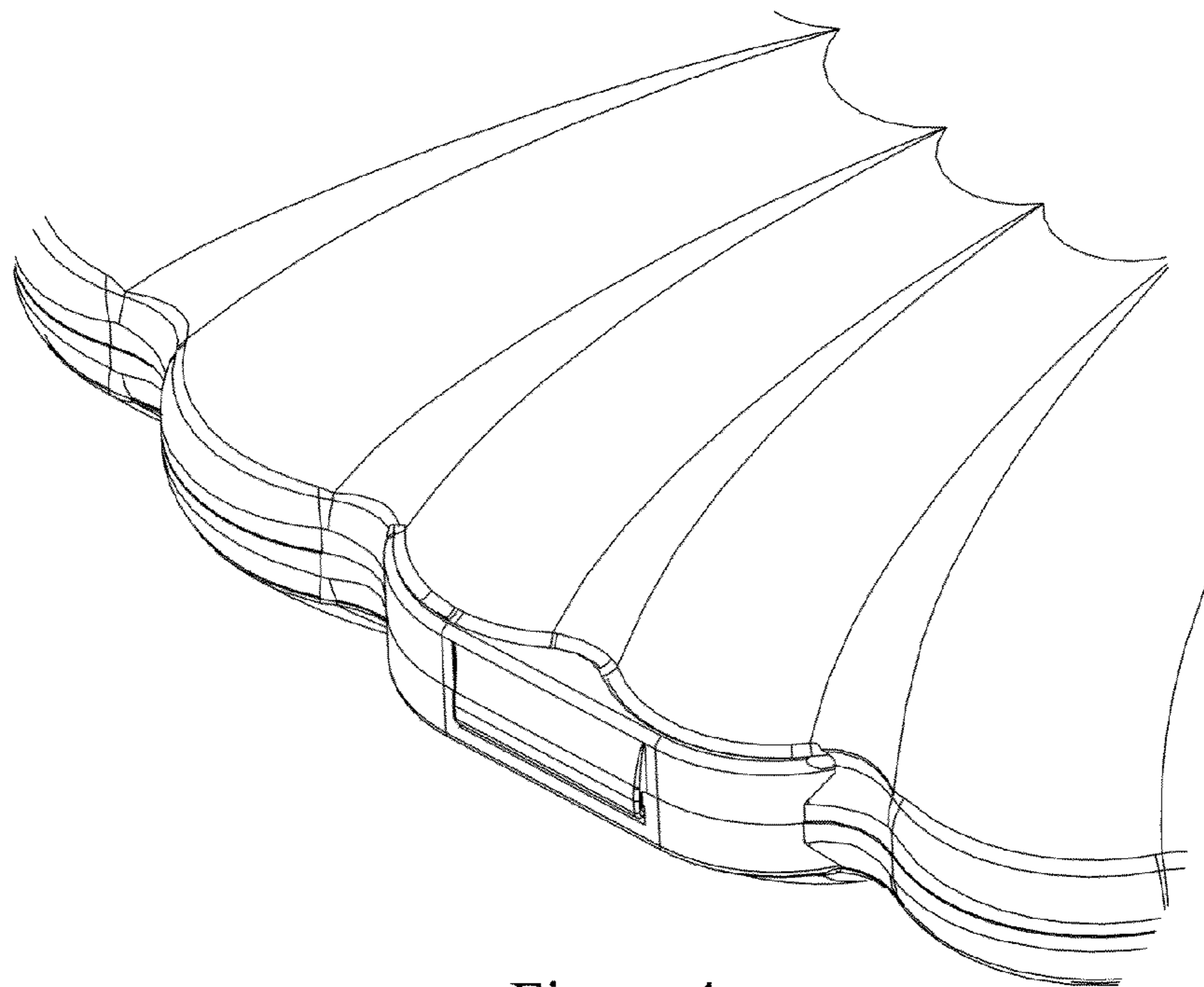

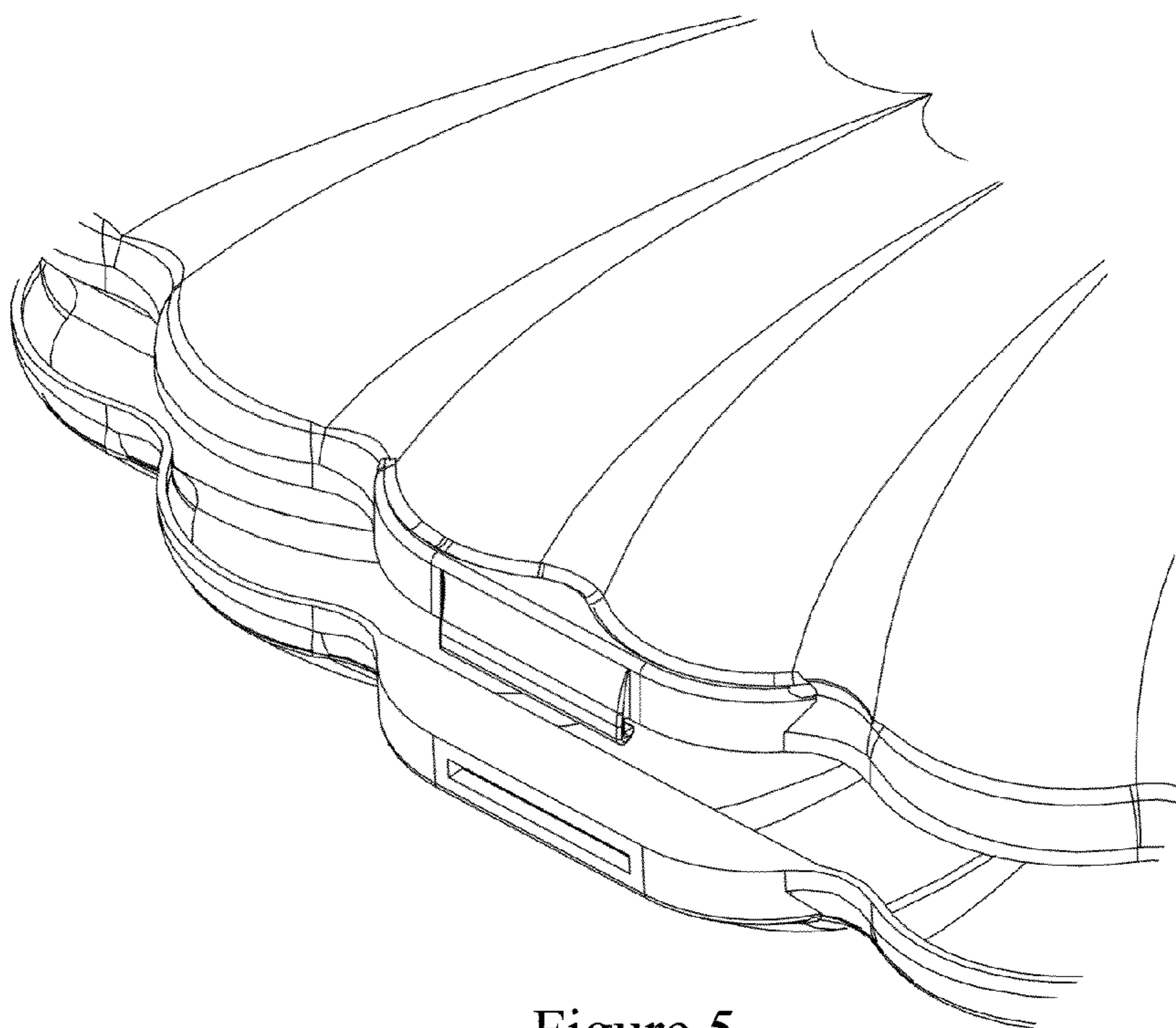

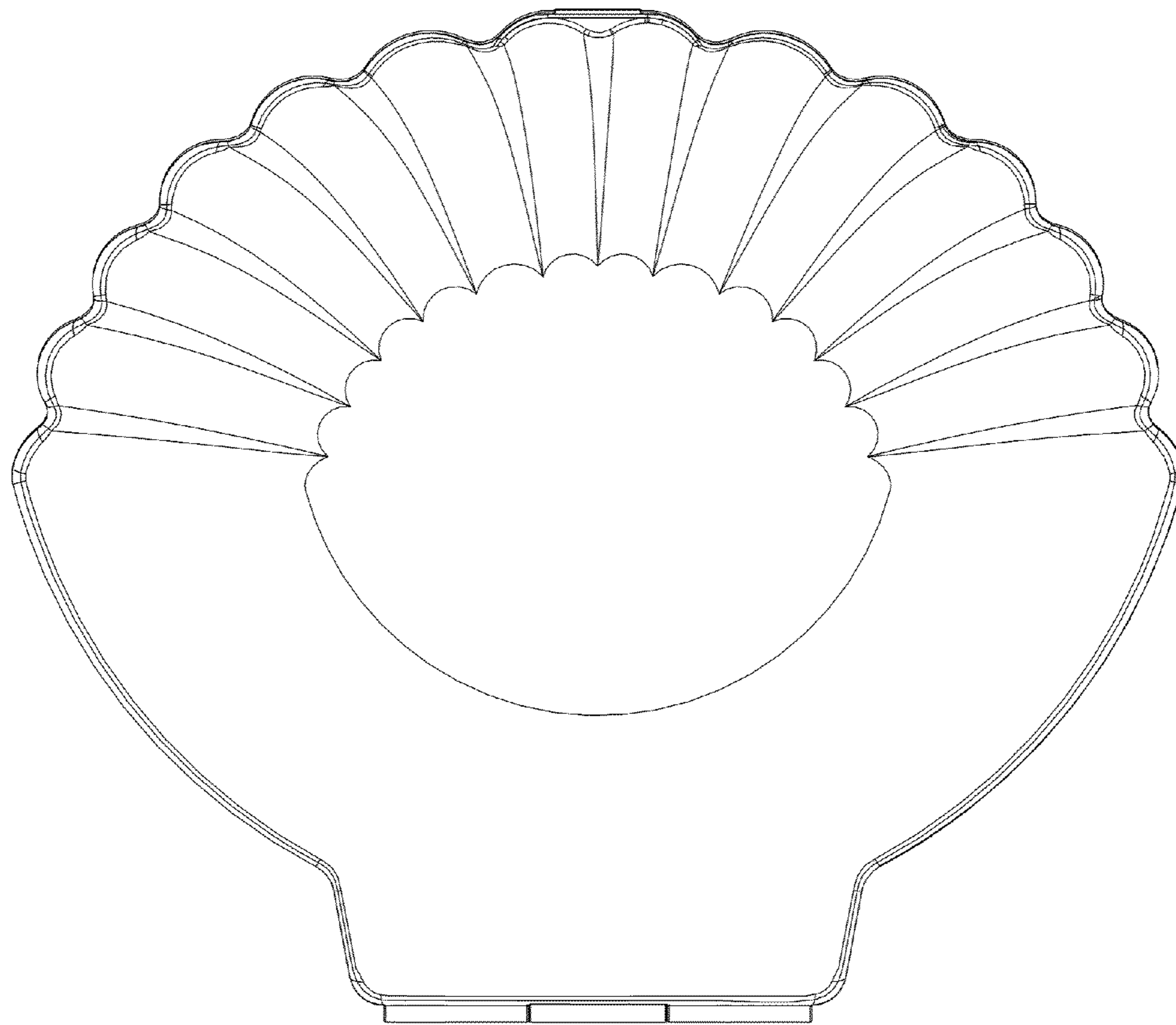

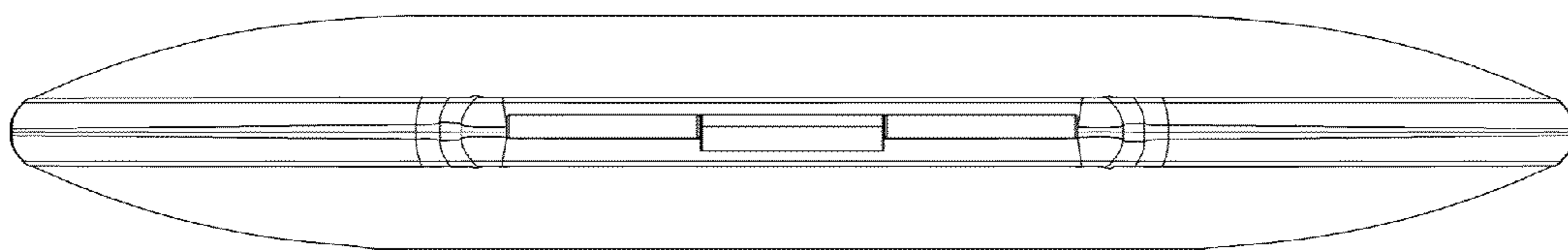

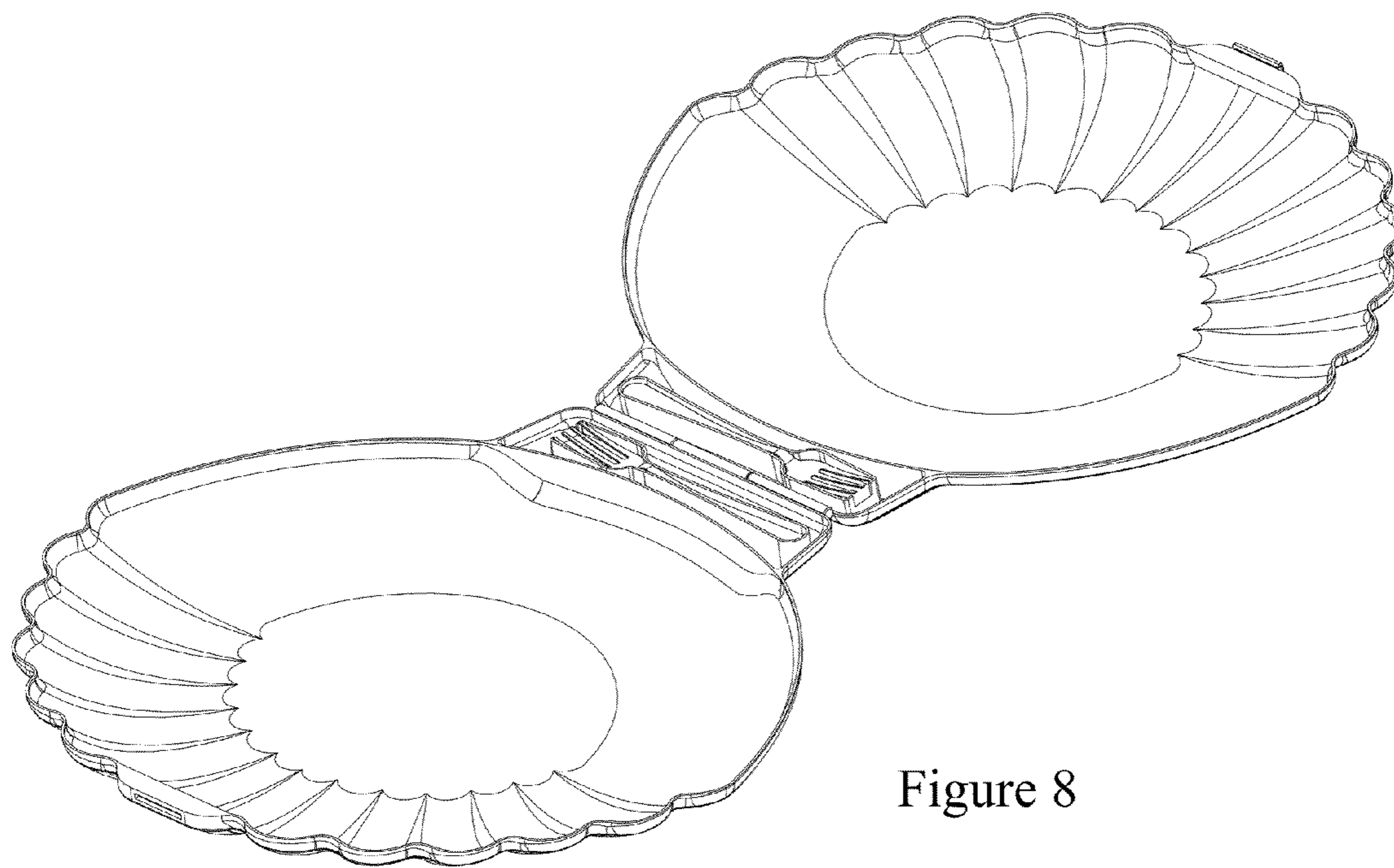

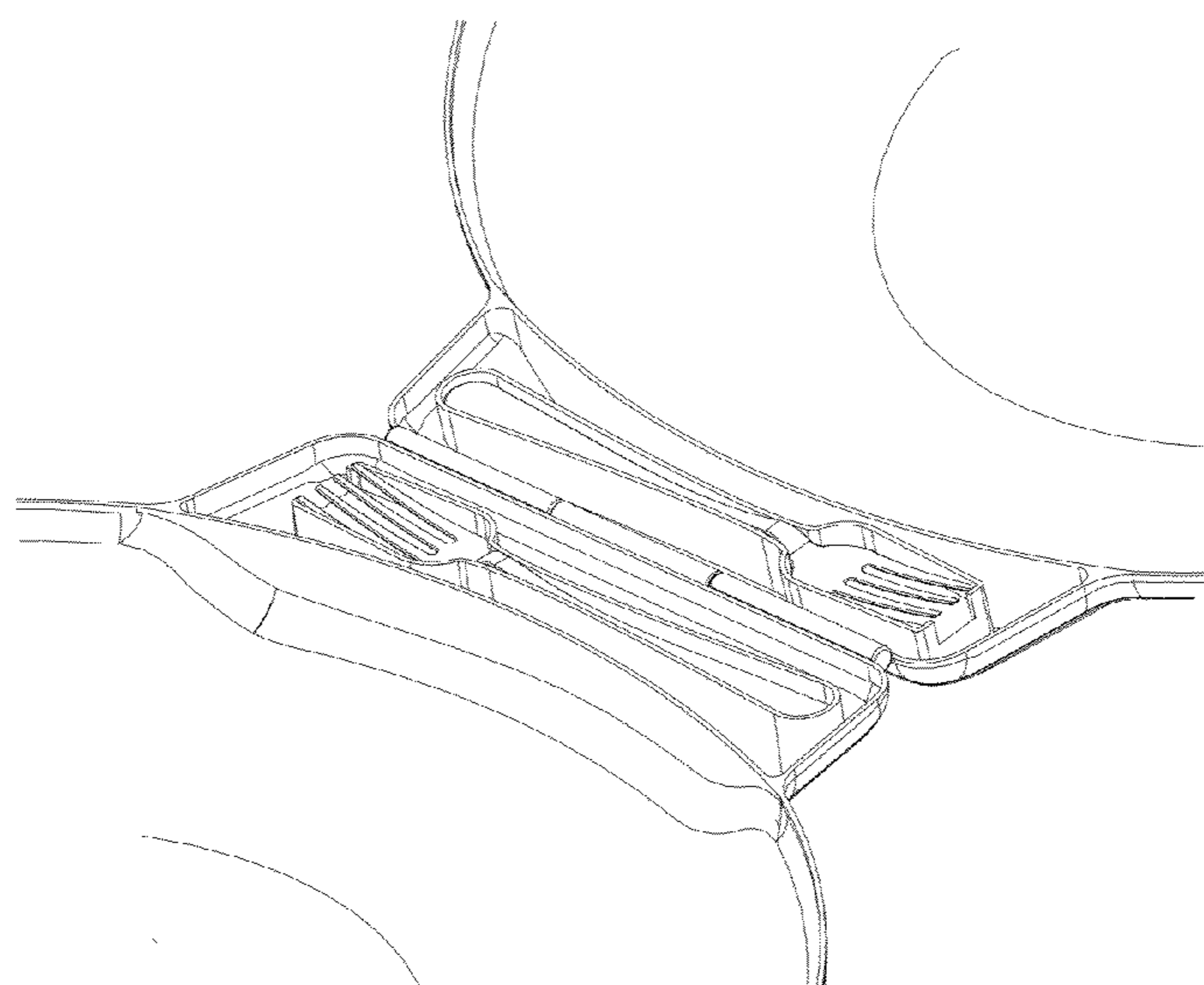

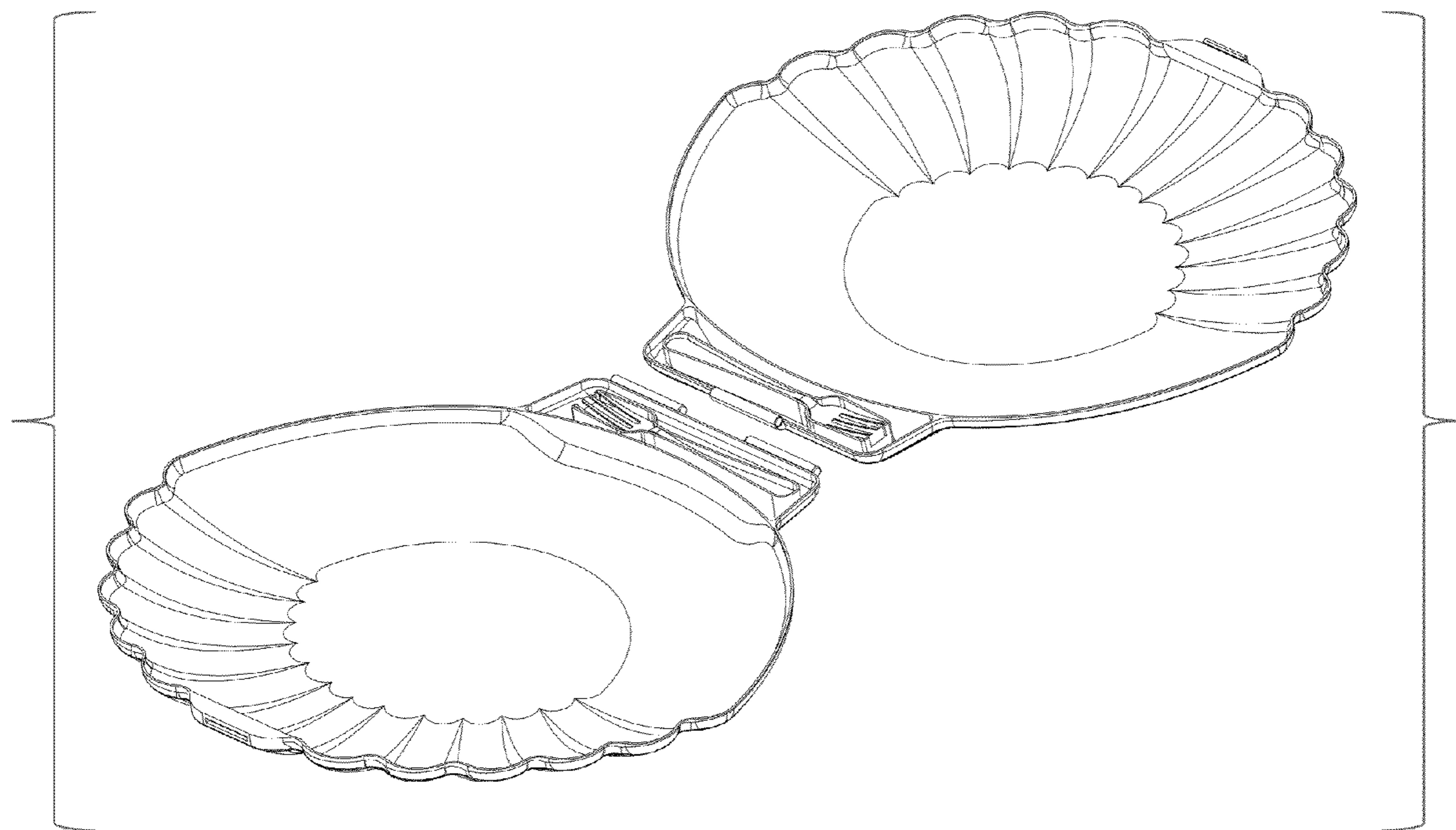

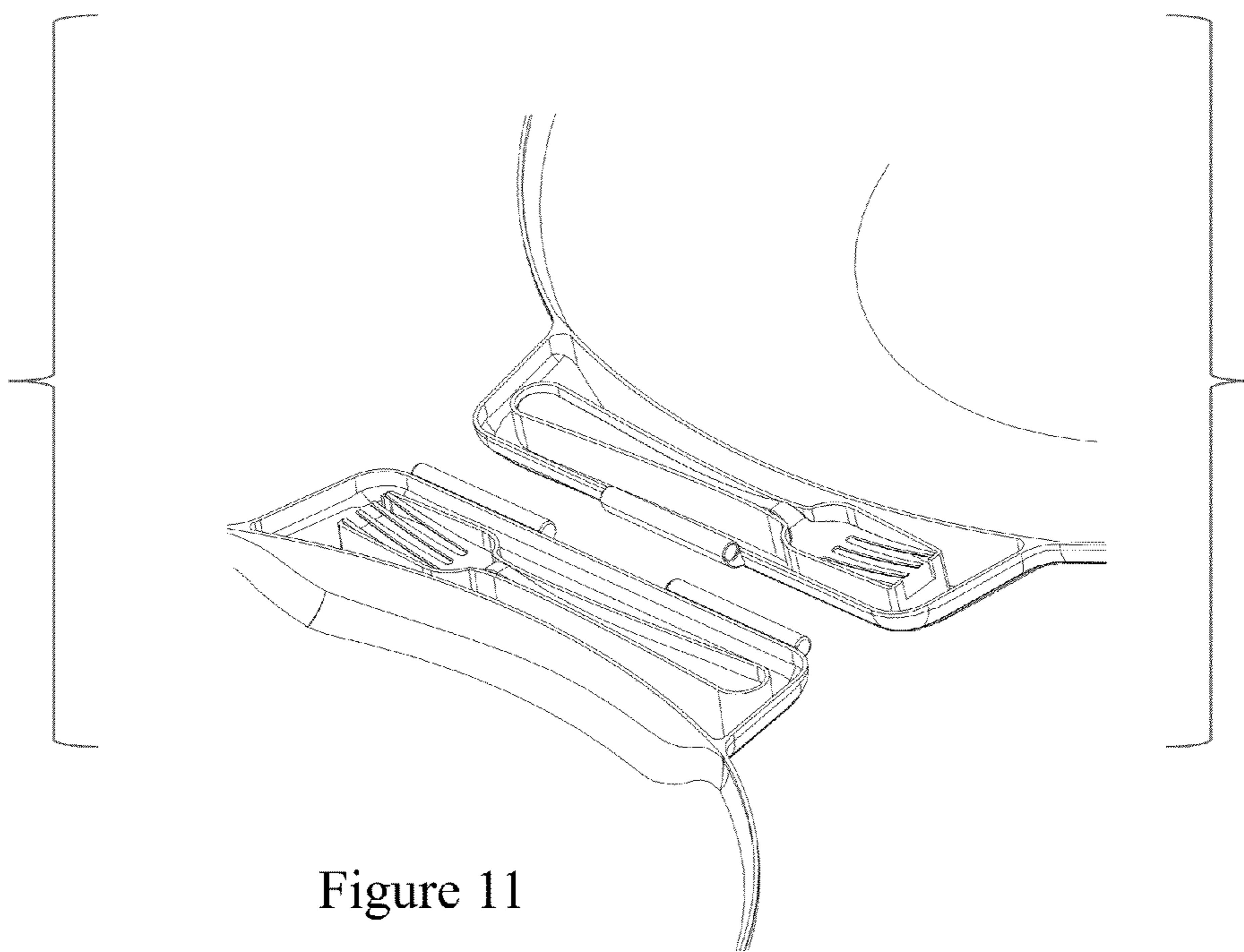
