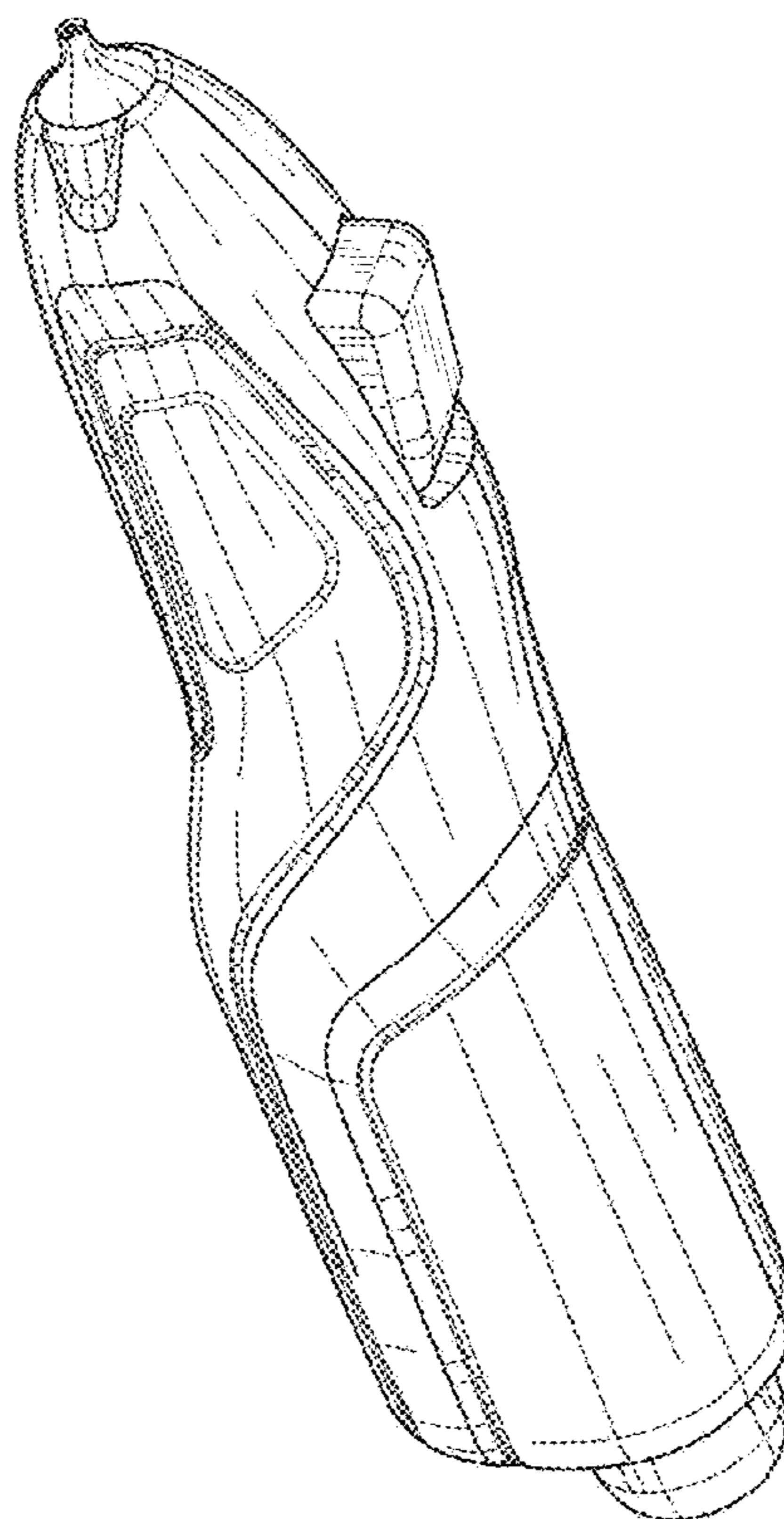
(57) **CLAIM**

The ornamental design for a glue applicator, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a glue applicator showing my new design;

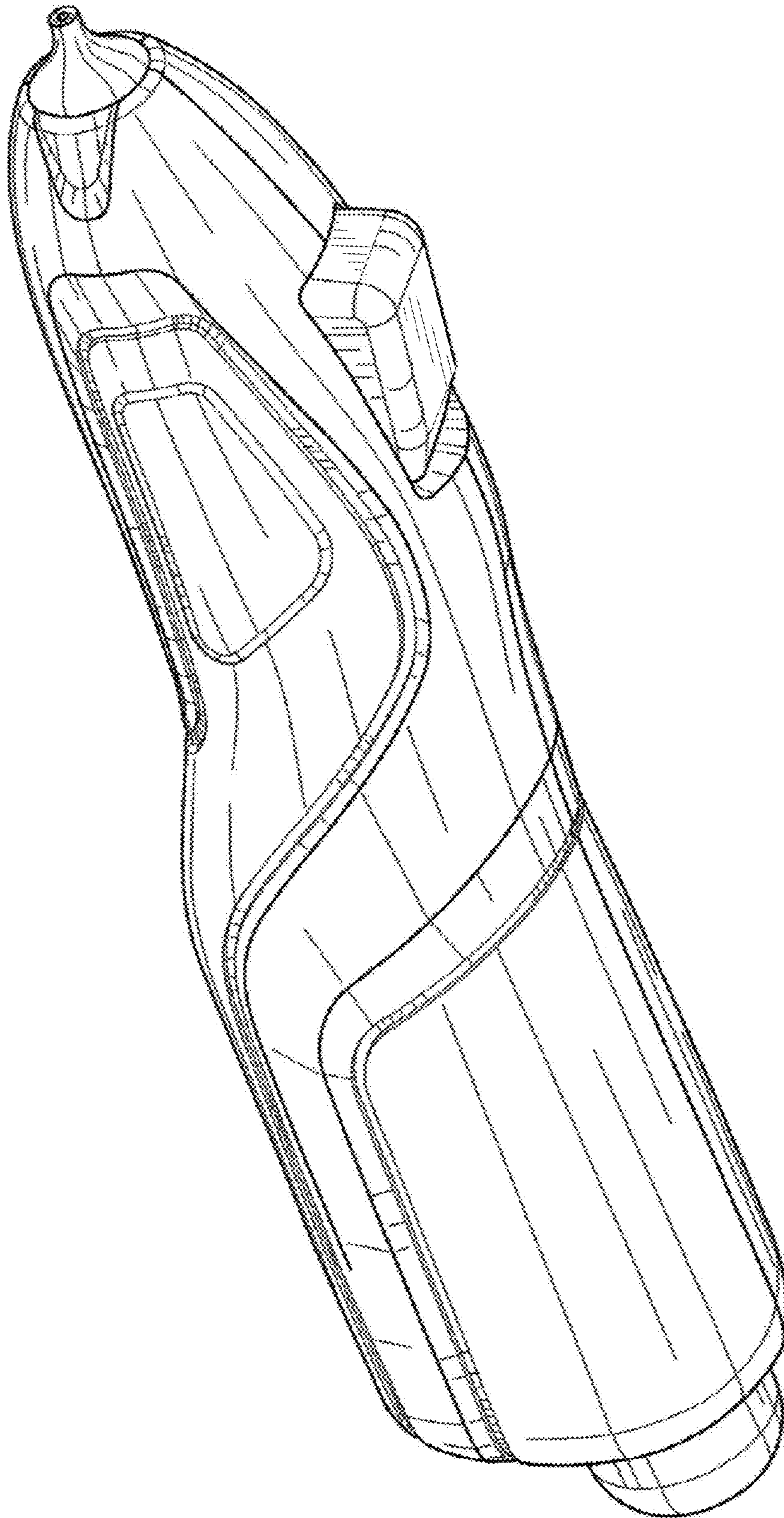

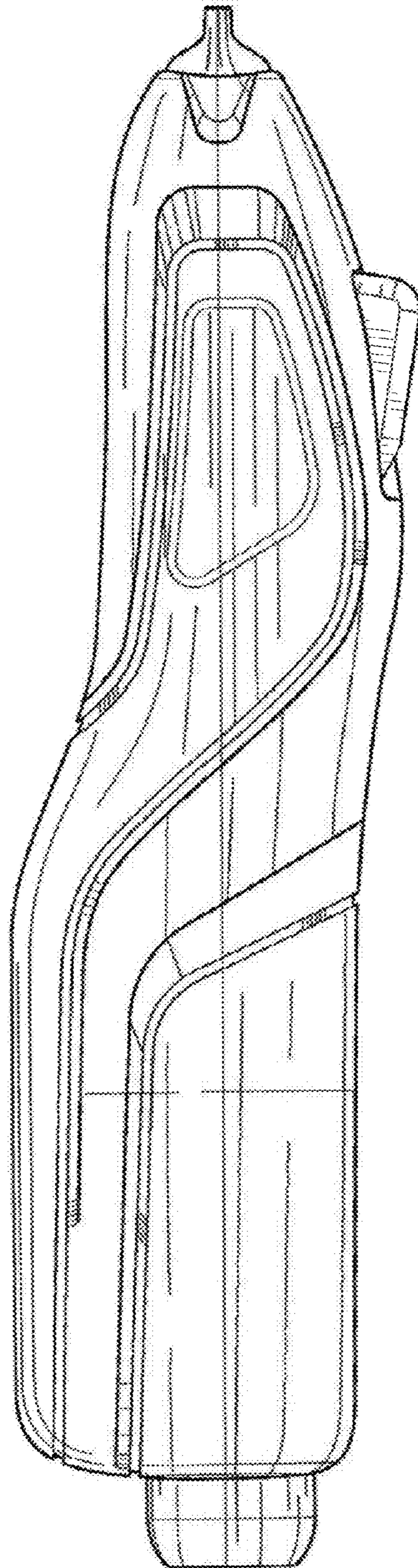

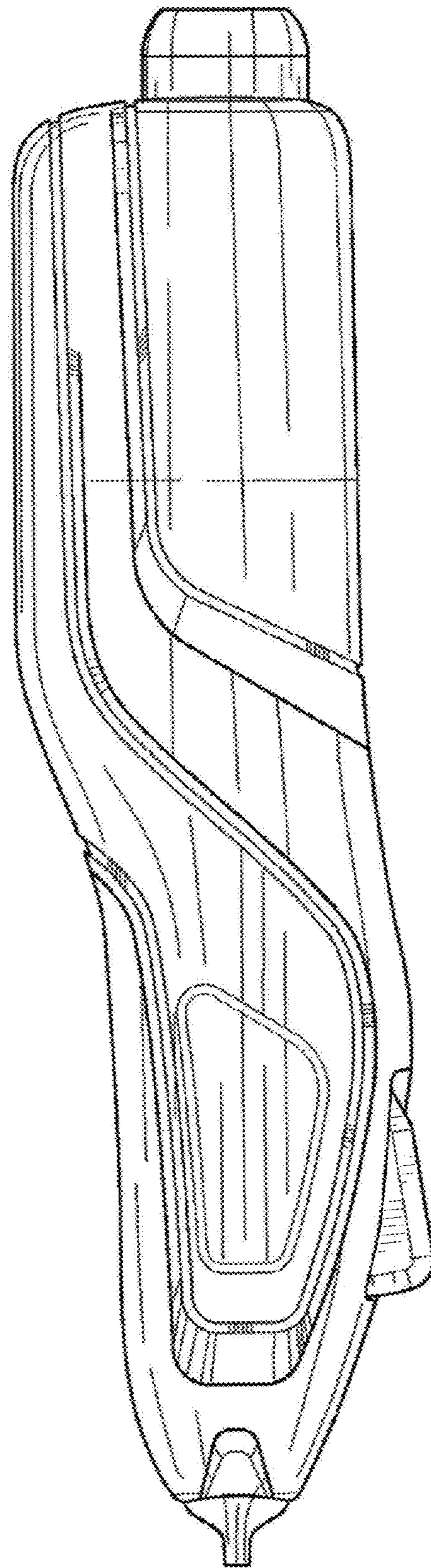

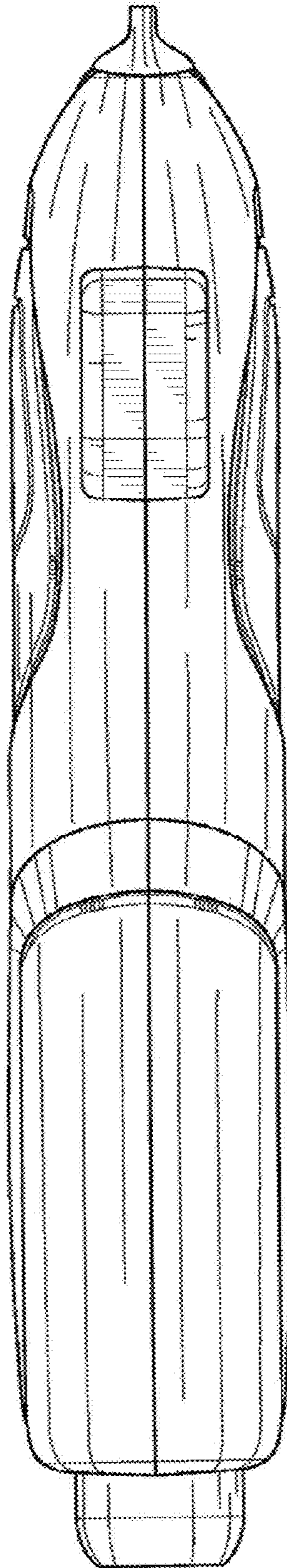

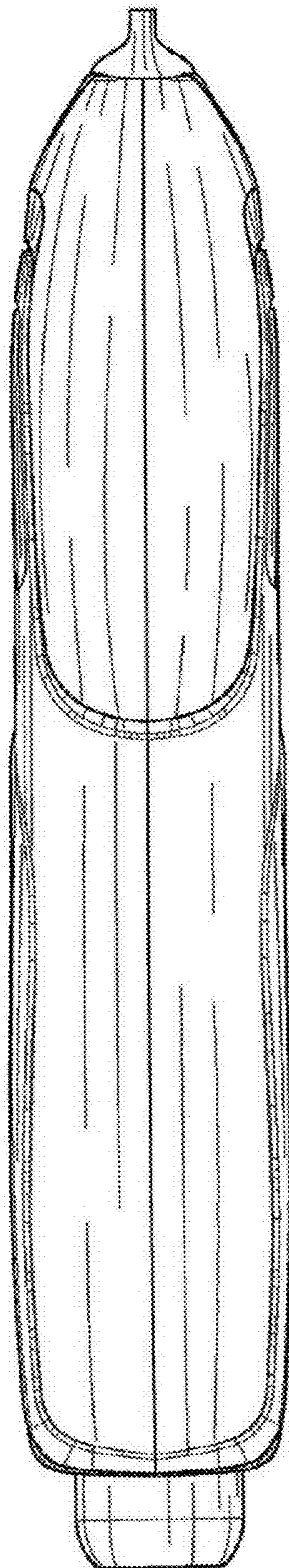

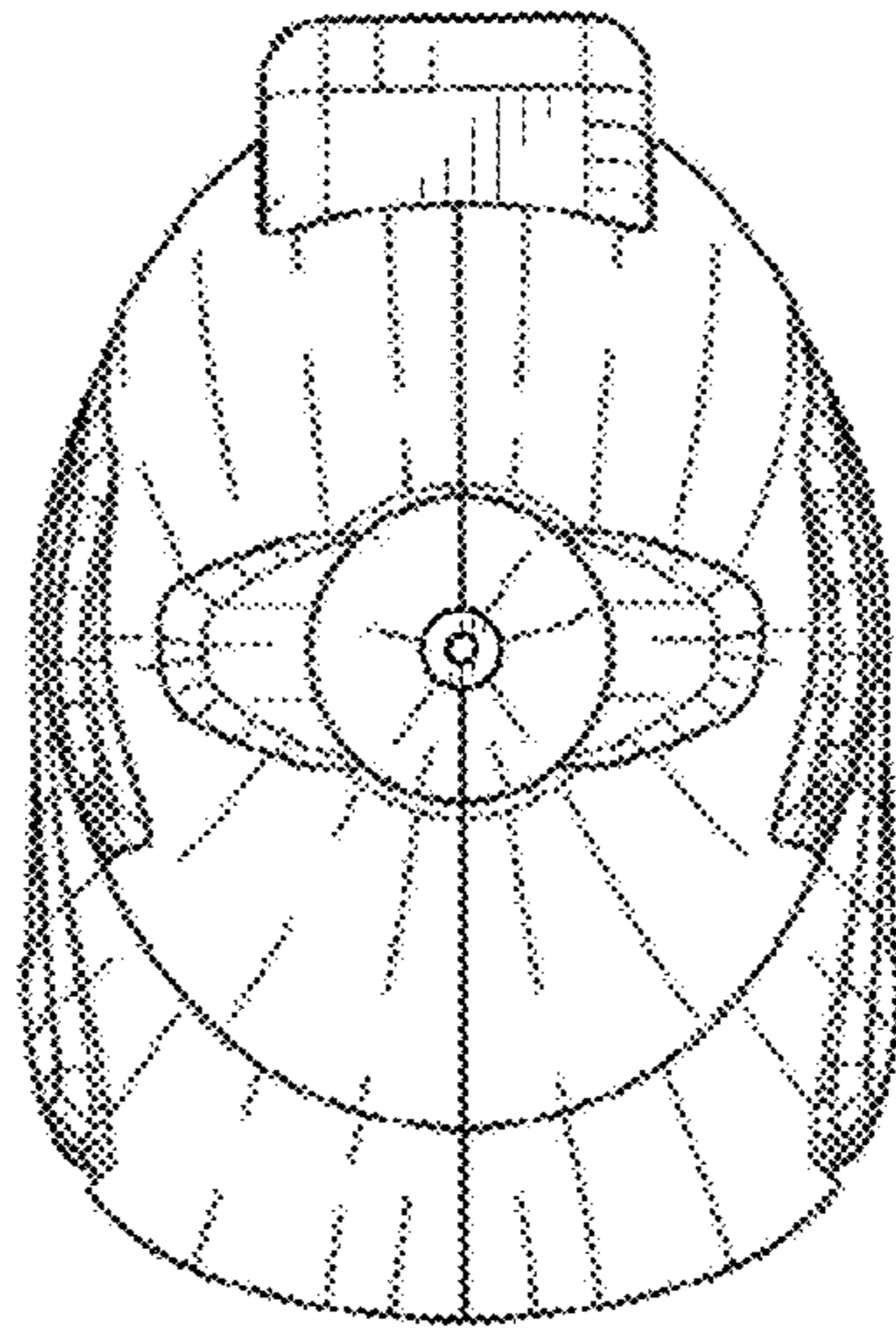
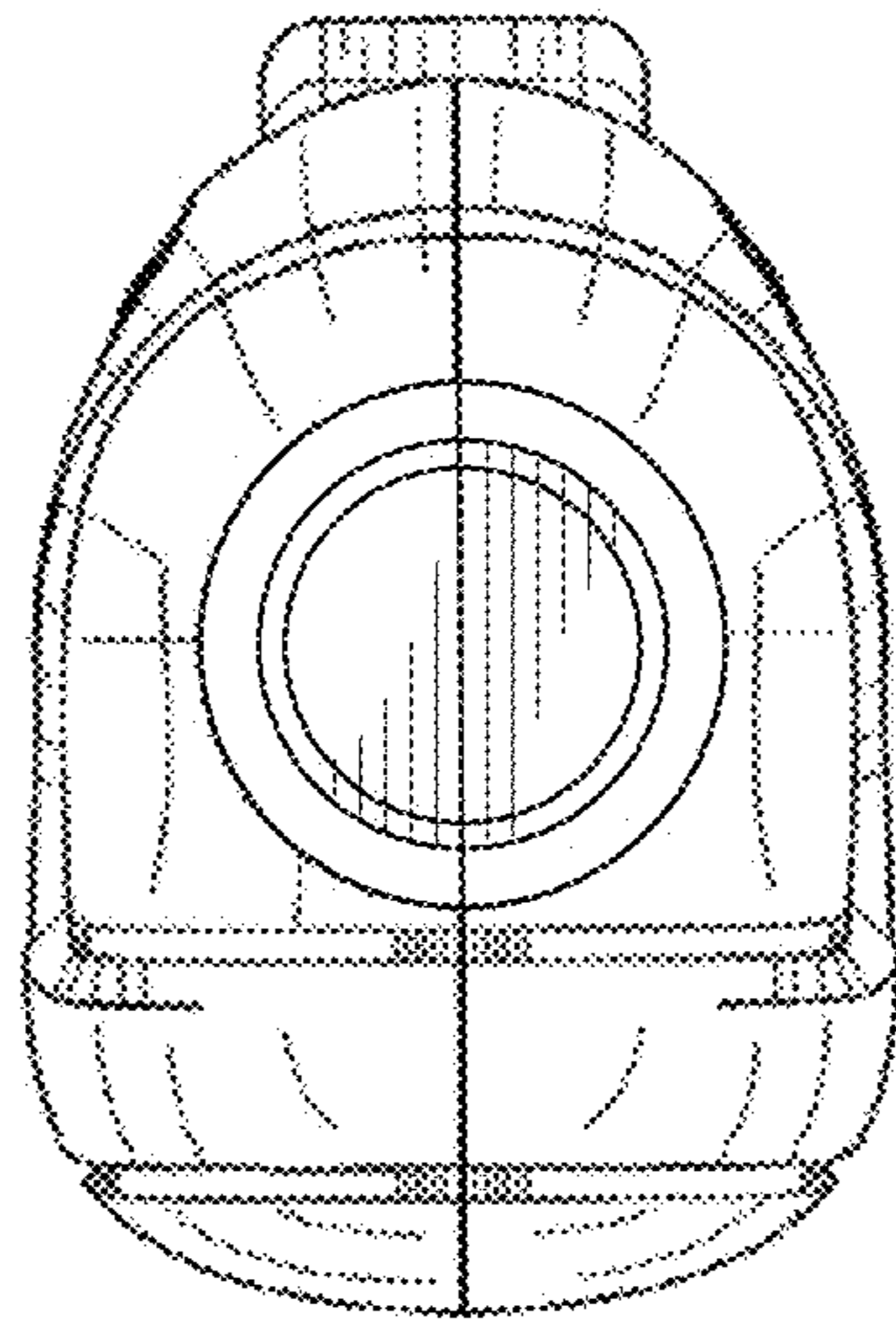
