(57) **CLAIM**

The ornamental design for a hand-held sanding implement, as shown and described.

DESCRIPTION

FIG. 1 is a left side elevational view of the present invention.

FIG. 2 is a right side elevational view thereof.

FIG. 3 is a top plan view thereof.

FIG. 4 is an enlarged rear elevational view thereof.

FIG. 5 is a left front perspective view thereof.

FIG. 6 is a bottom plan view of an enlarged head portion thereof; and,

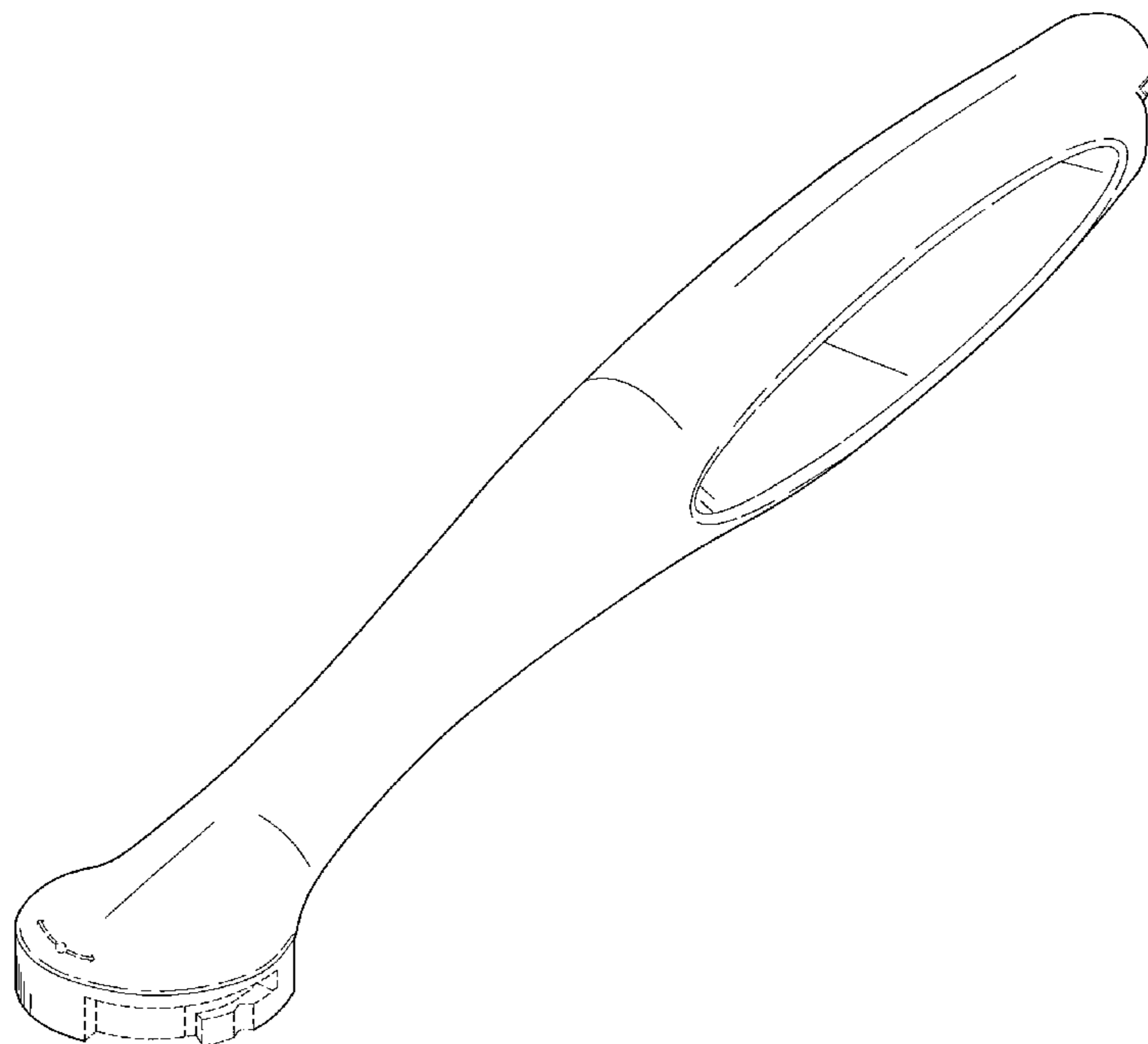
FIG. 7 is a left side elevational view of an enlarged head portion thereof, the right side being a mirror image.

Certain views have been omitted as duplicative. The right side elevational view of the head portion of the present invention is a mirror image of the left side elevational view of the head portion shown in FIG. 7.

To the extent any surface is not shown or discernible from the other views shown in the figures, it is to be understood that that surface is flat and includes no surface ornamentation. It should be understood that the bottom surfaces are, except as apparent from the views shown in the other figures, flat and include no surface ornamentation.

Broken lines in the drawings illustrate features of the hand-held sanding implement that form no part of the claim.

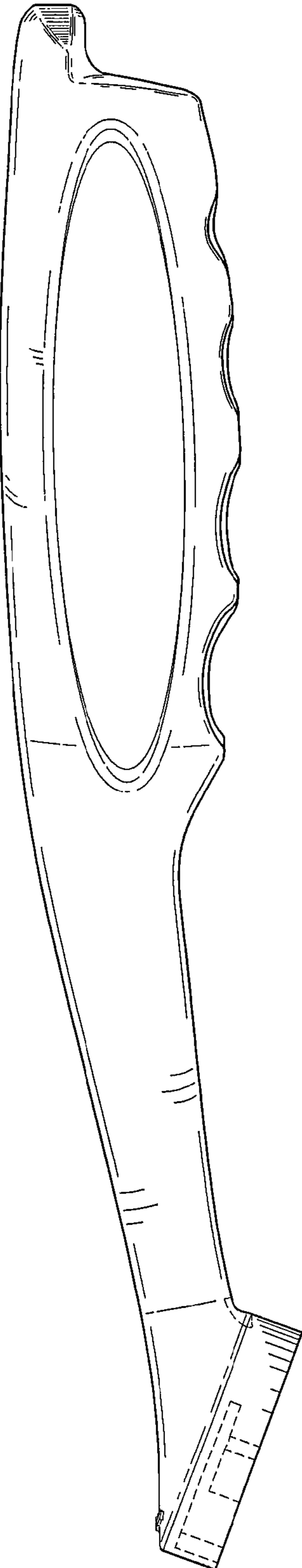

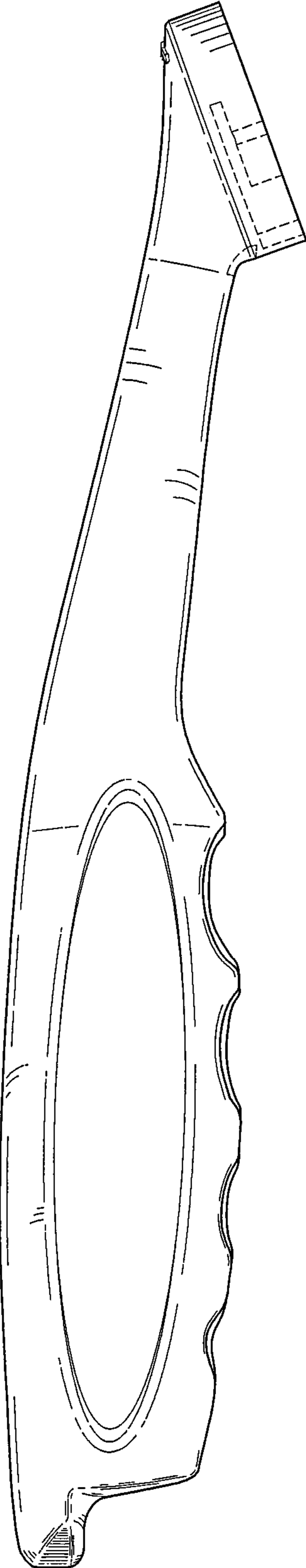

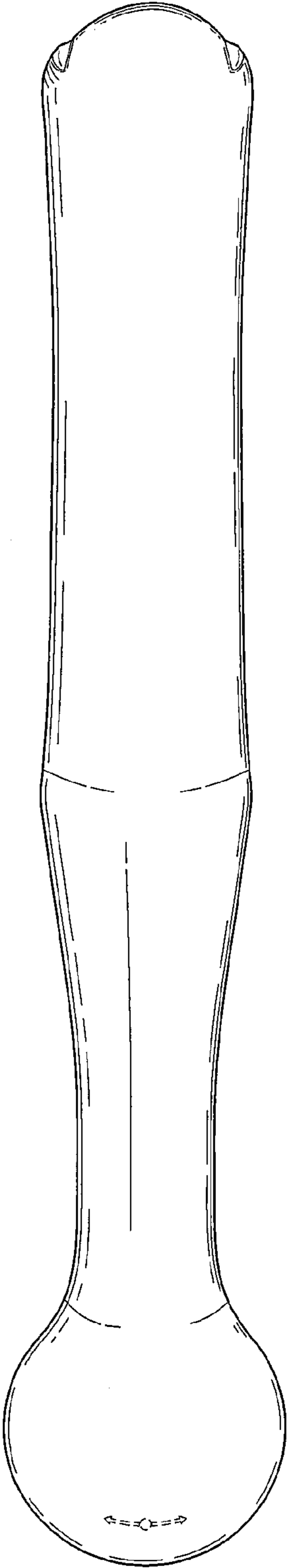

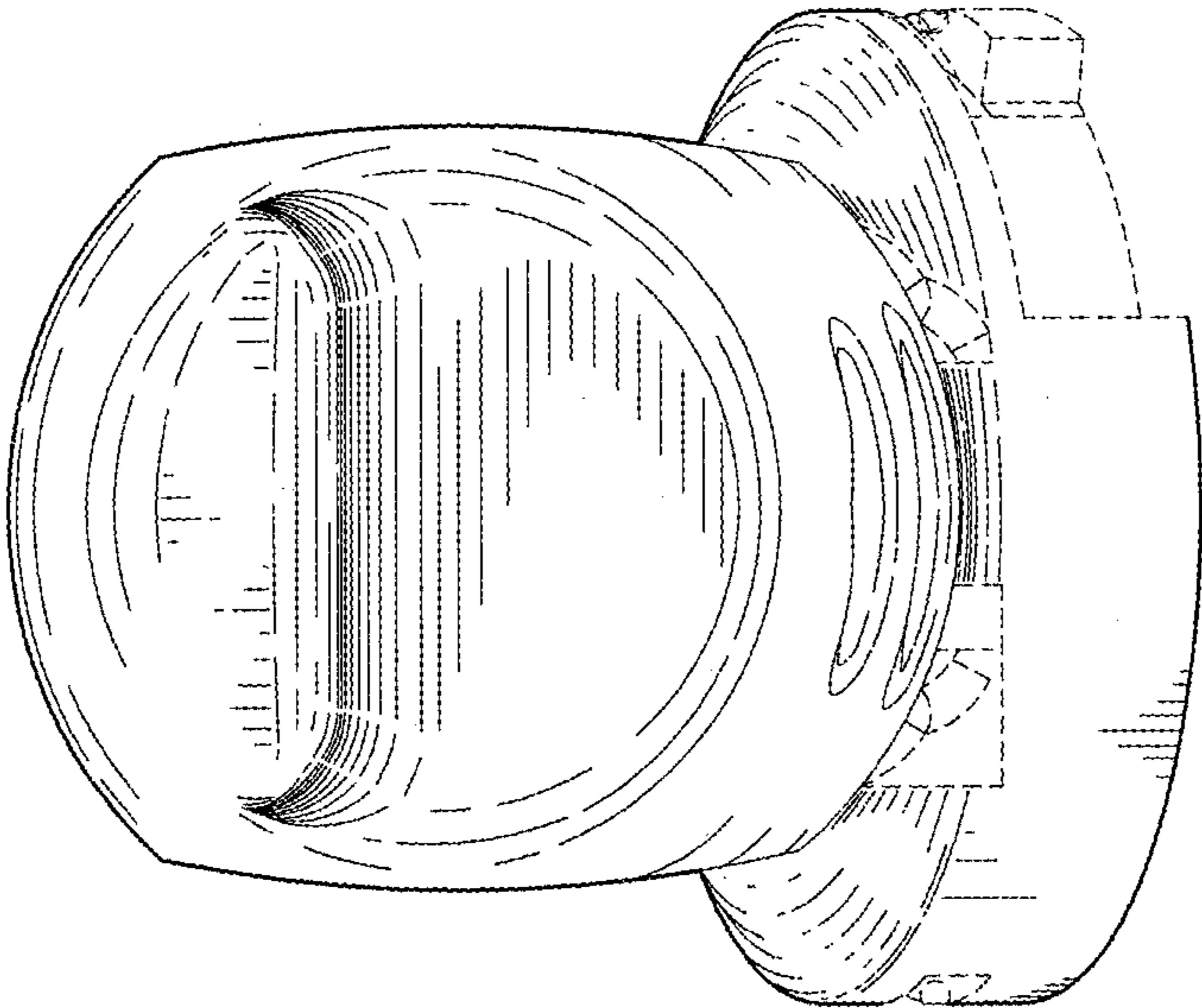

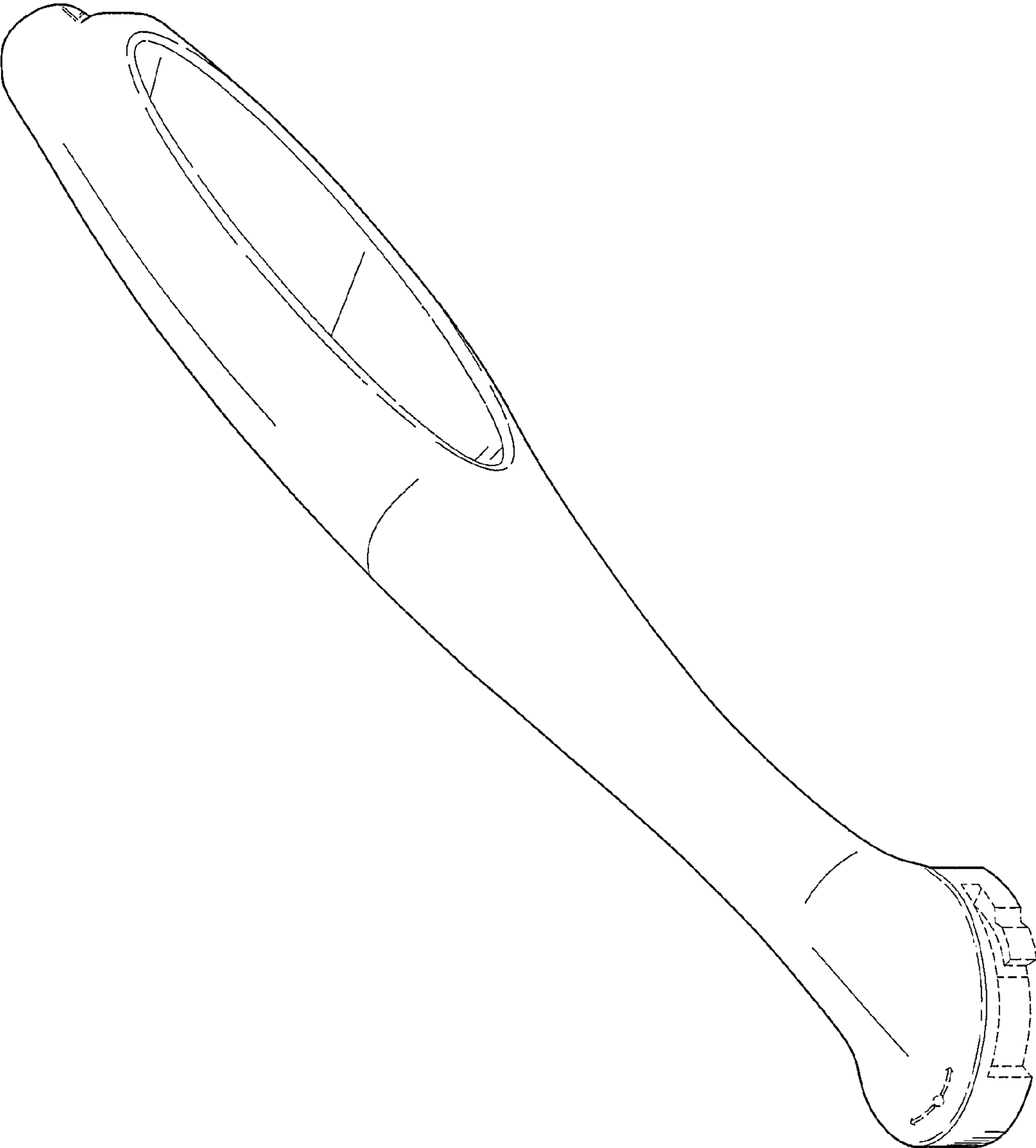

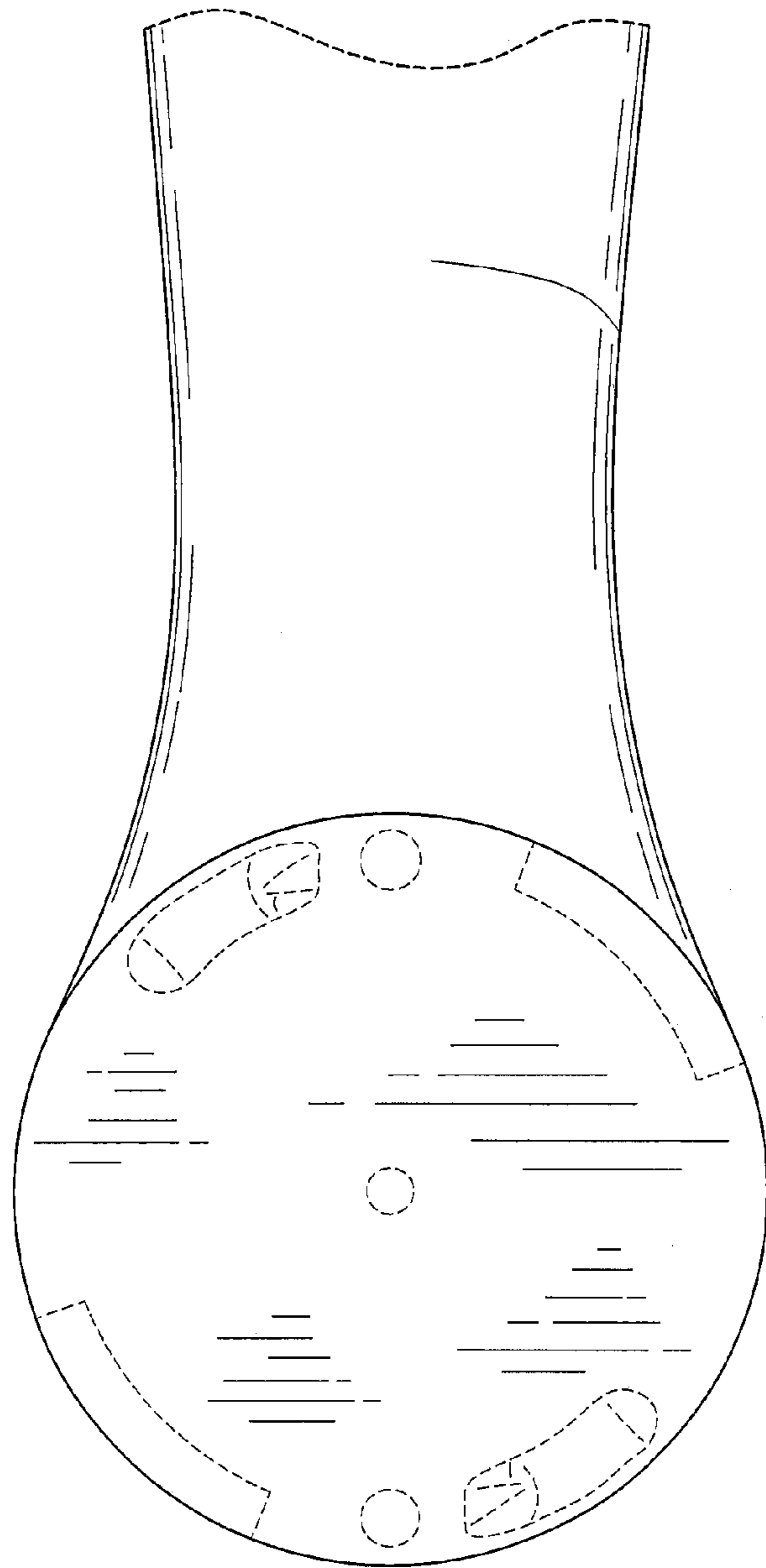

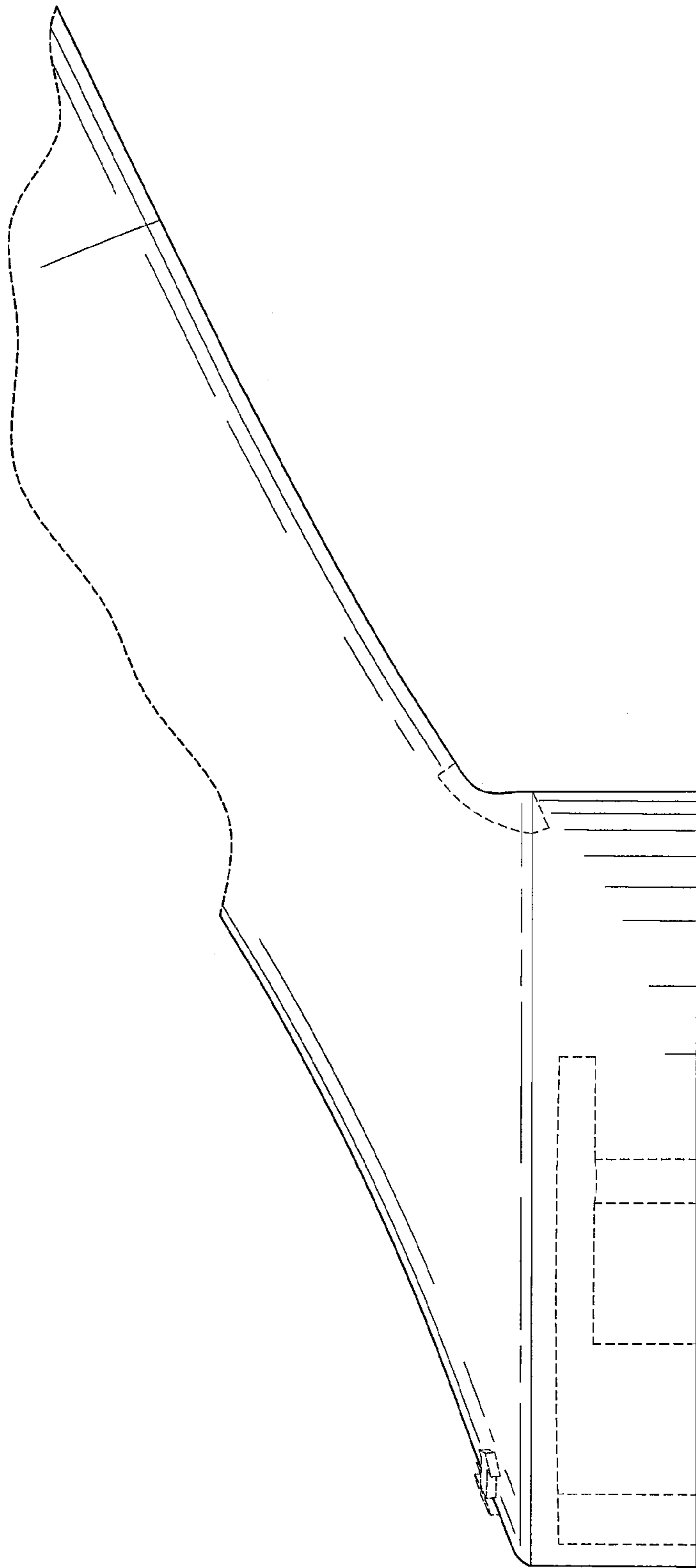
