FIG. 5 is an opposite side elevation view thereof;

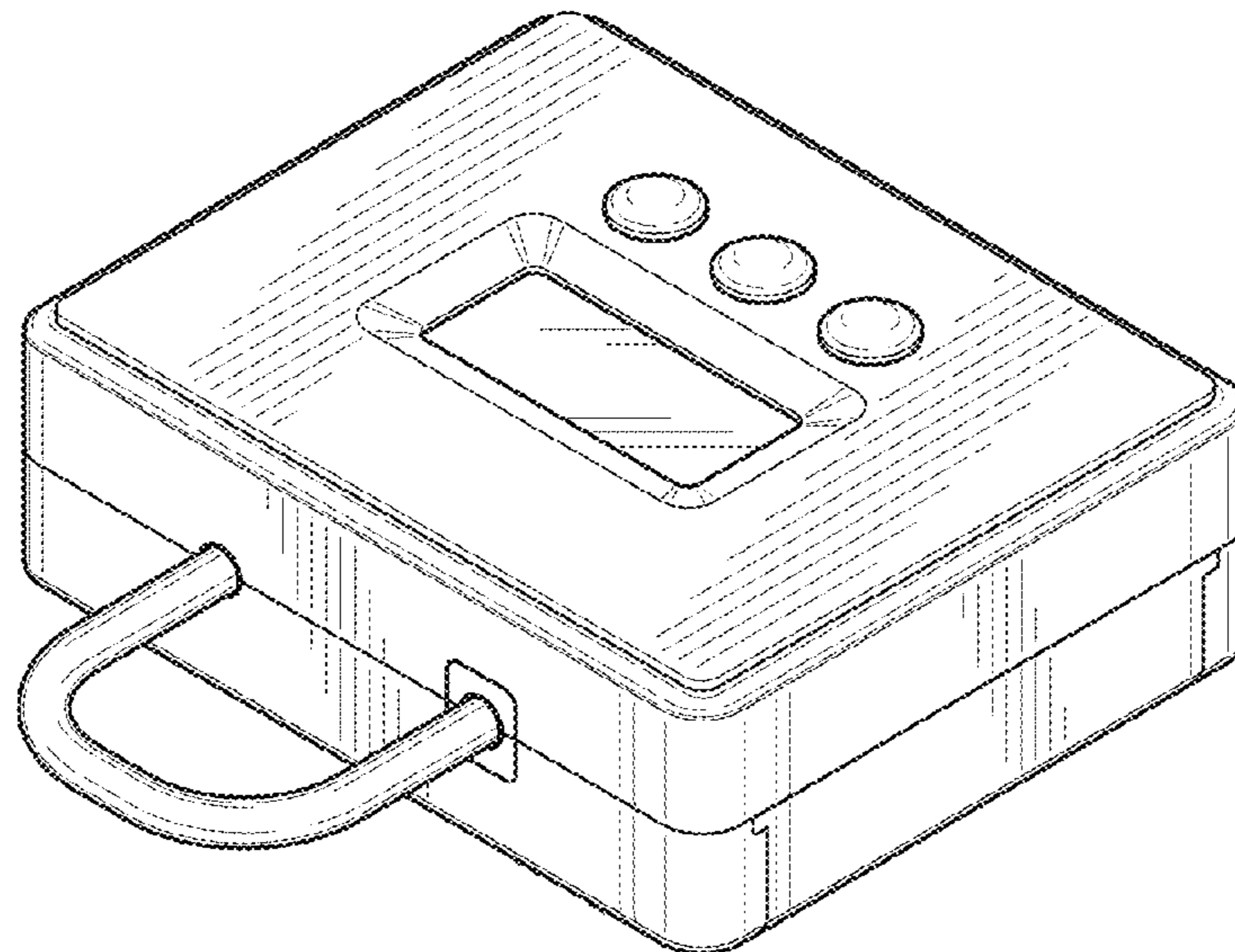
FIG. 6 is a top plan view thereof;

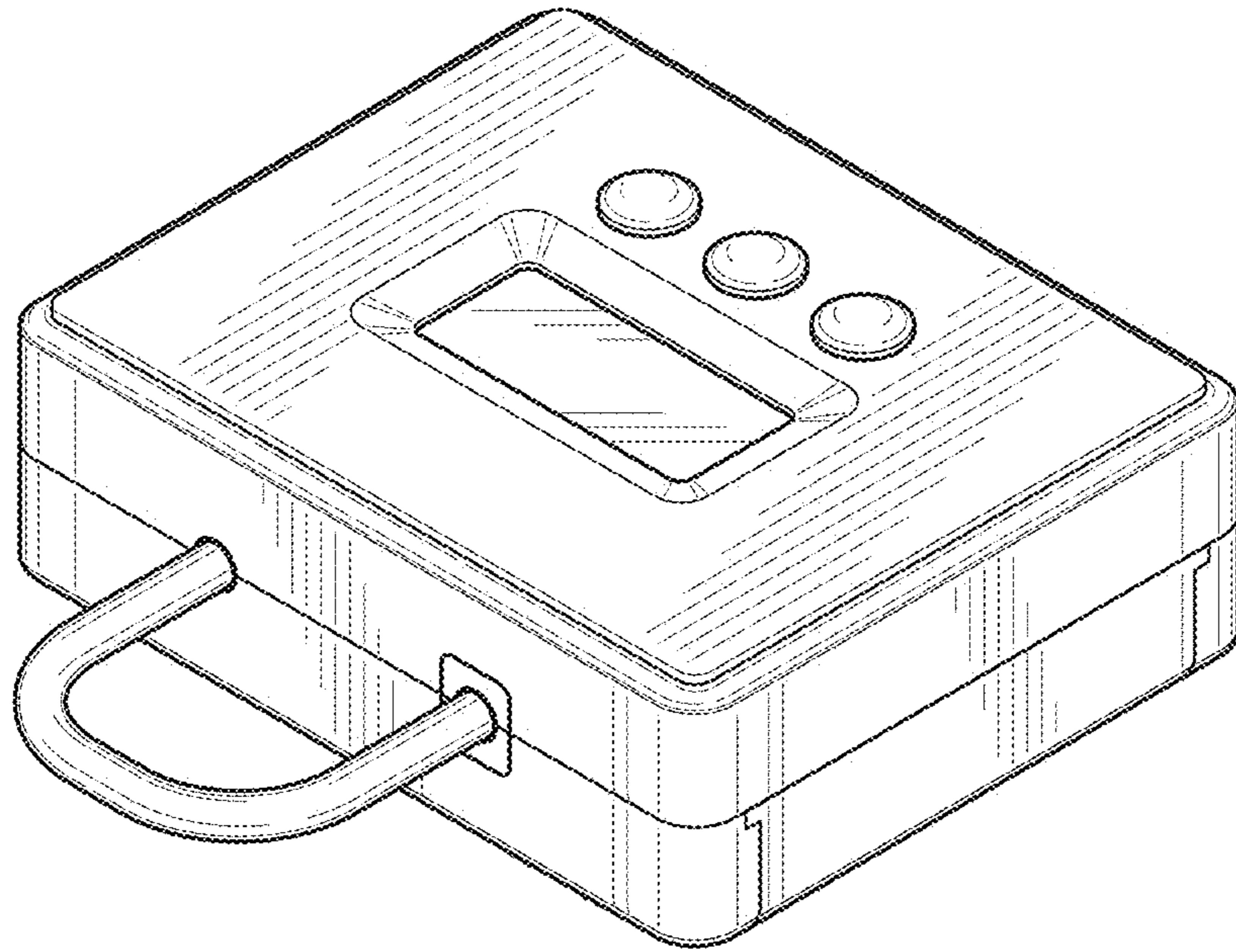

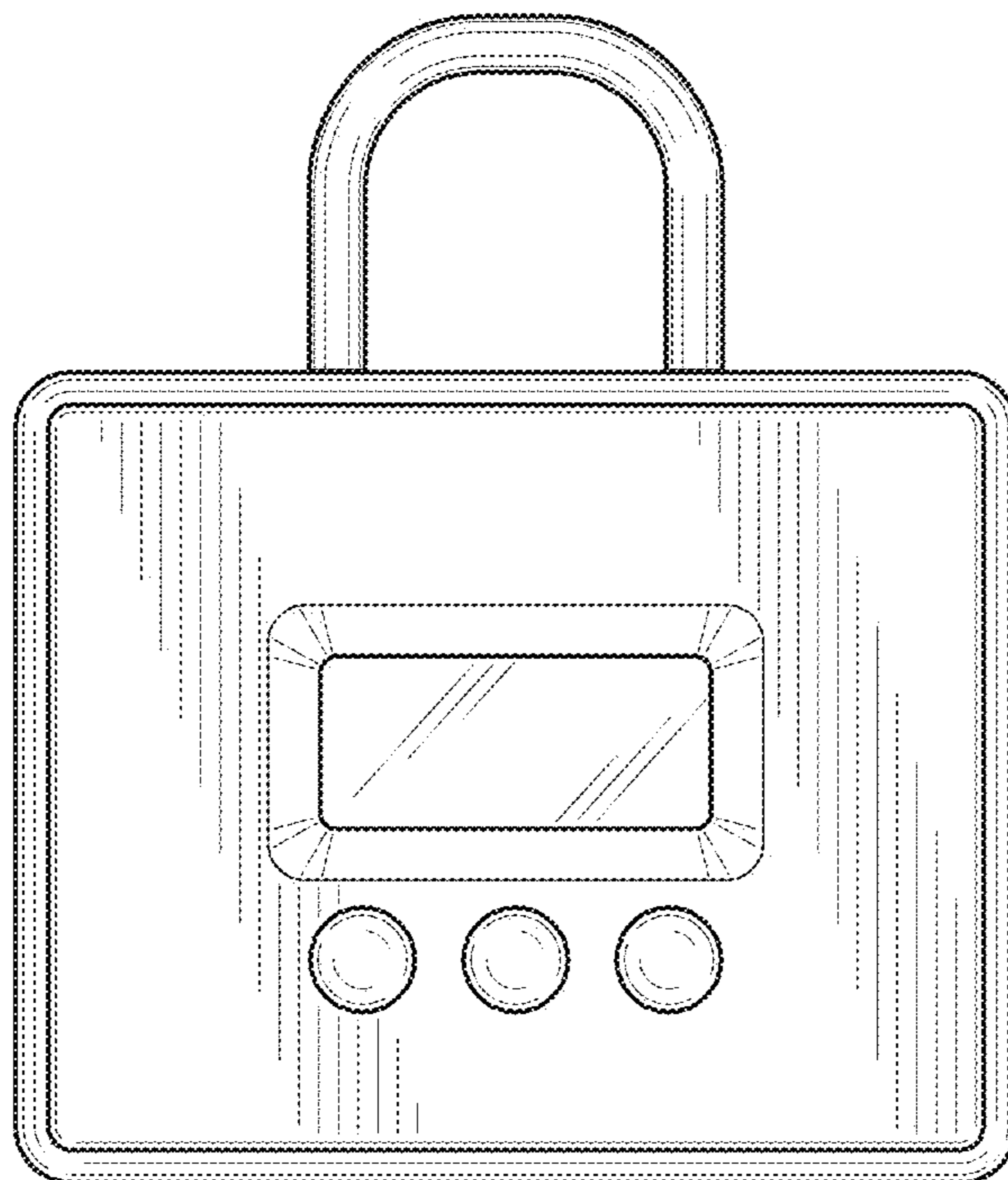

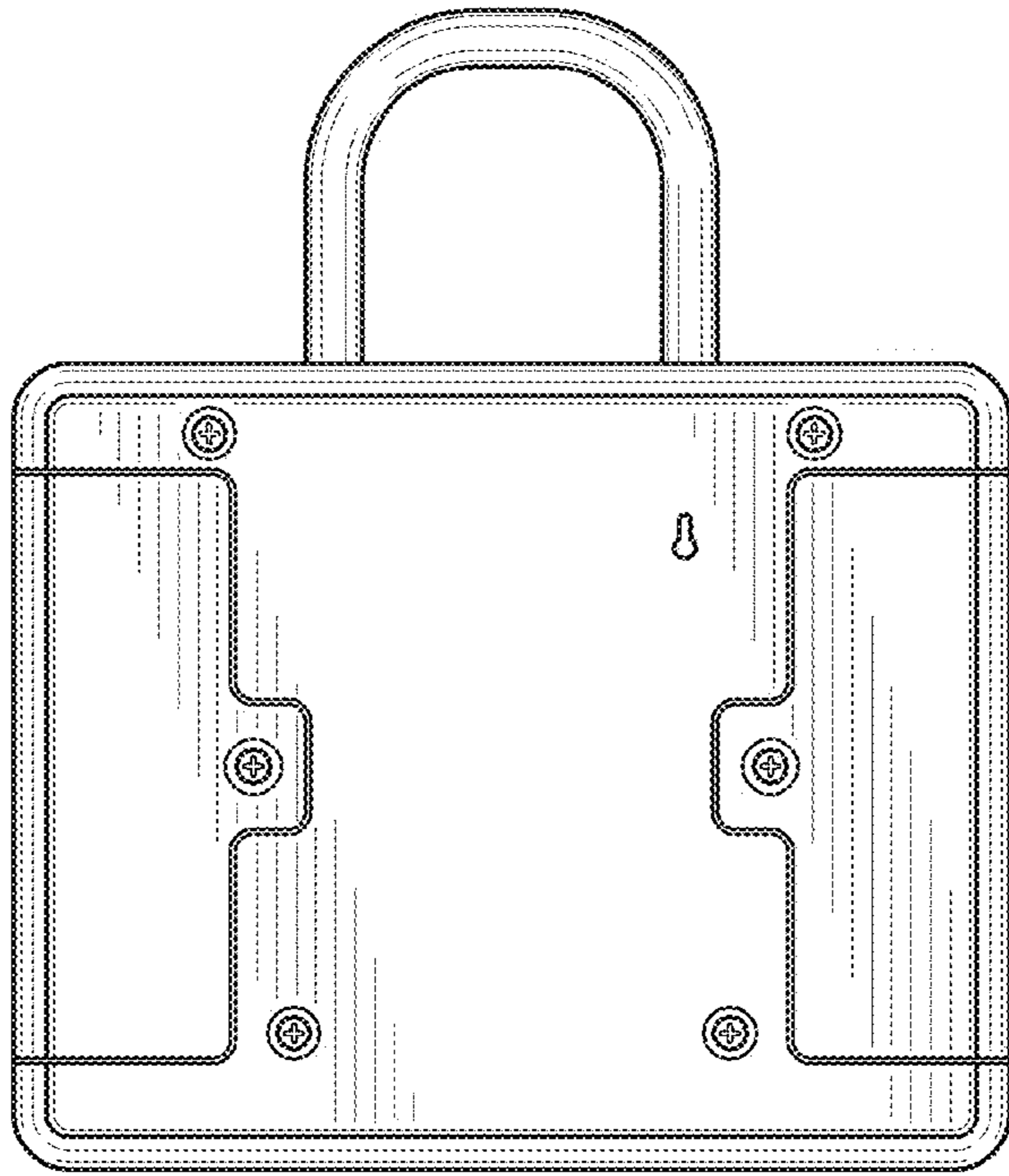

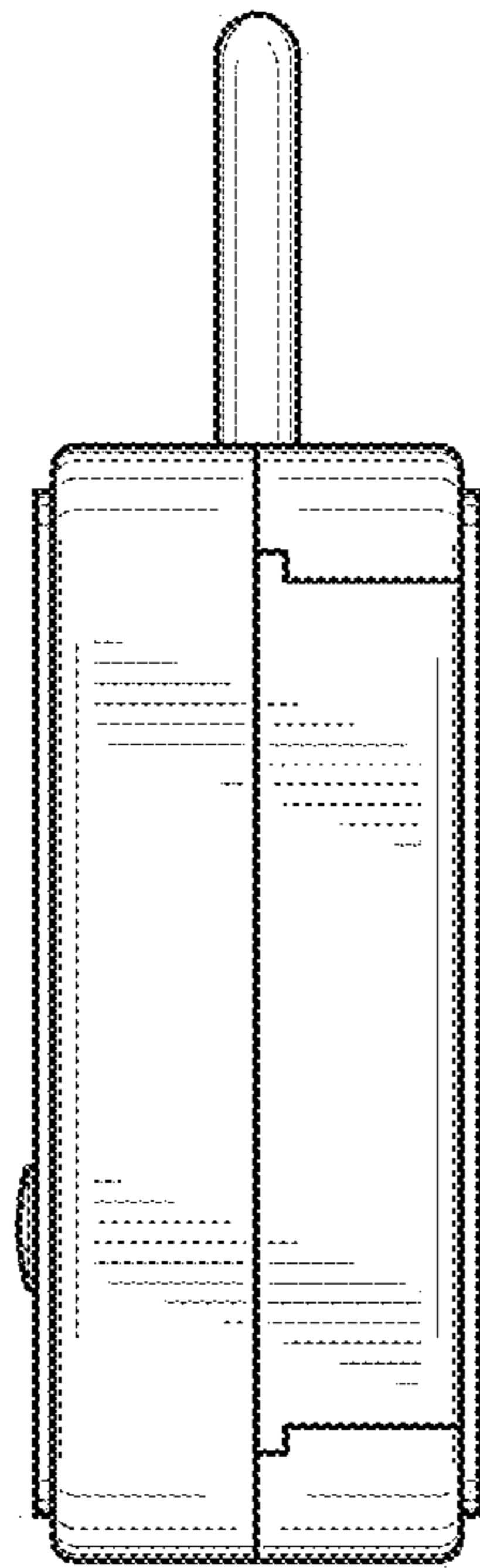

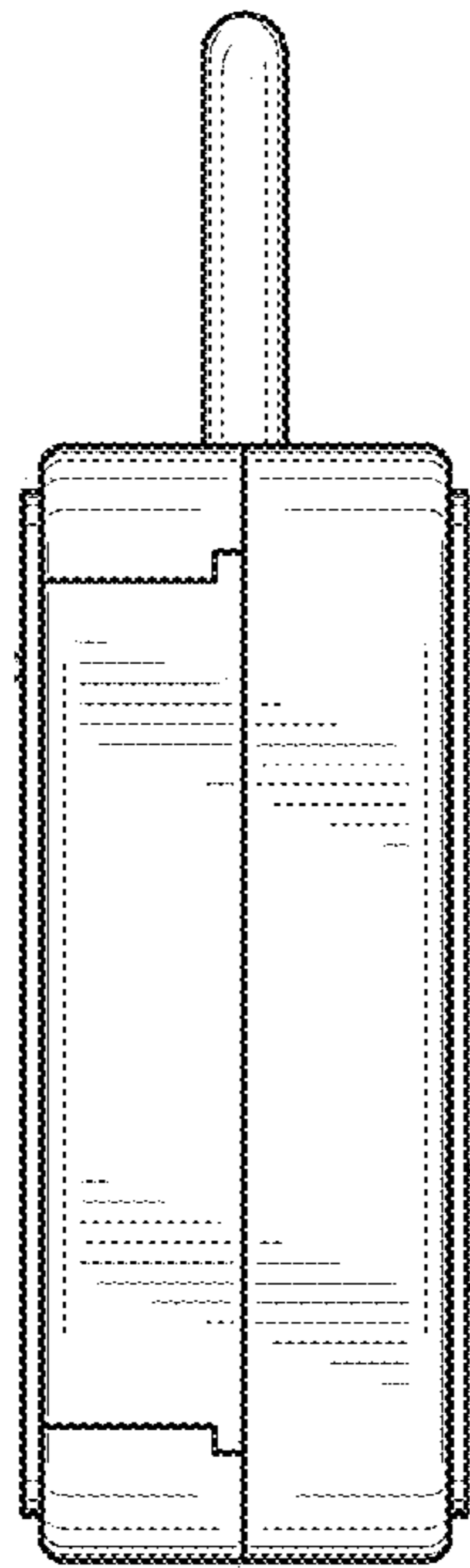

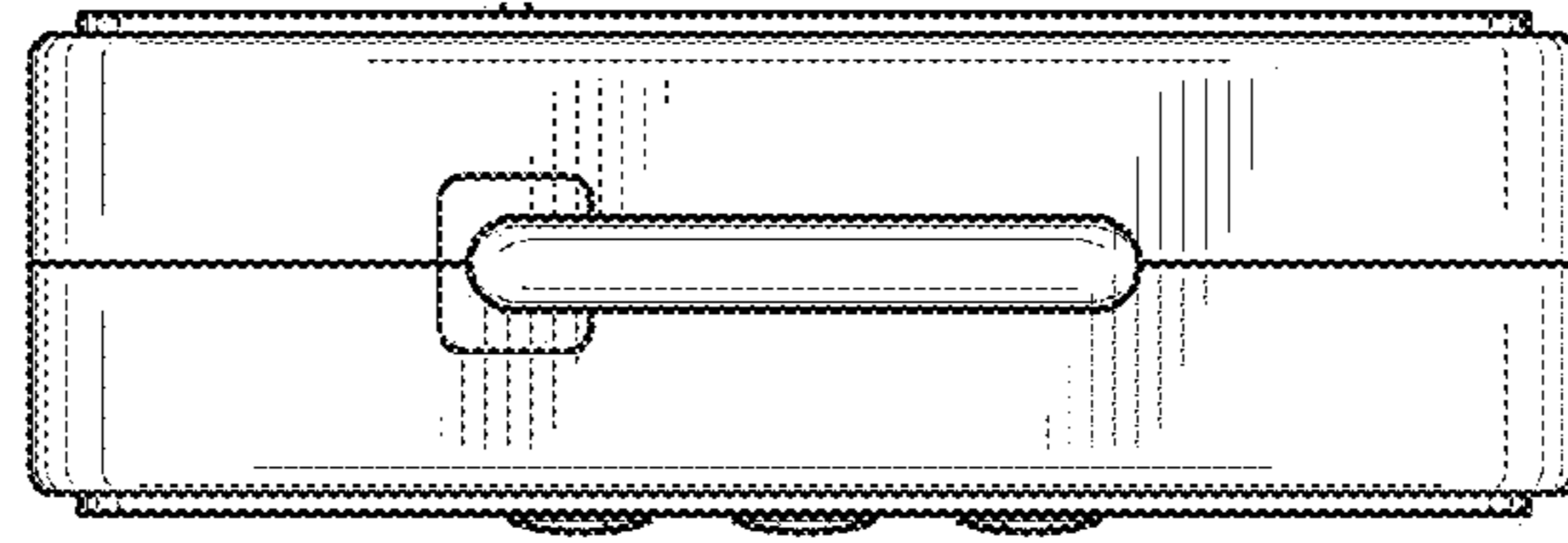

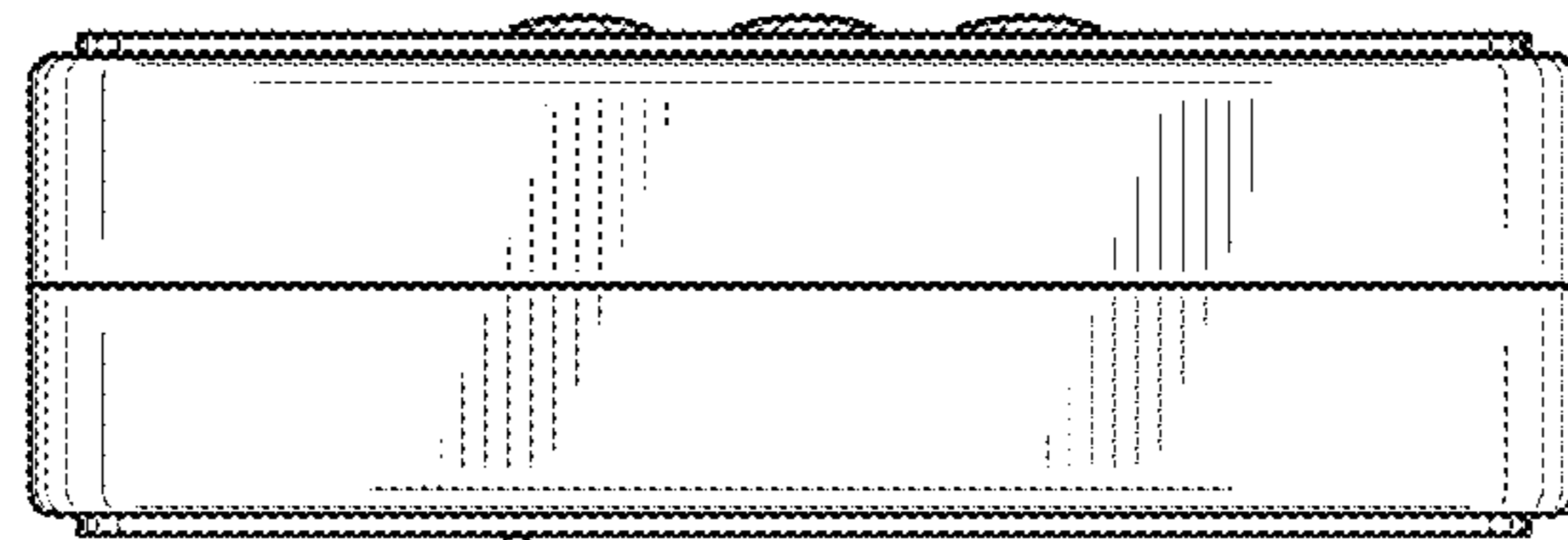

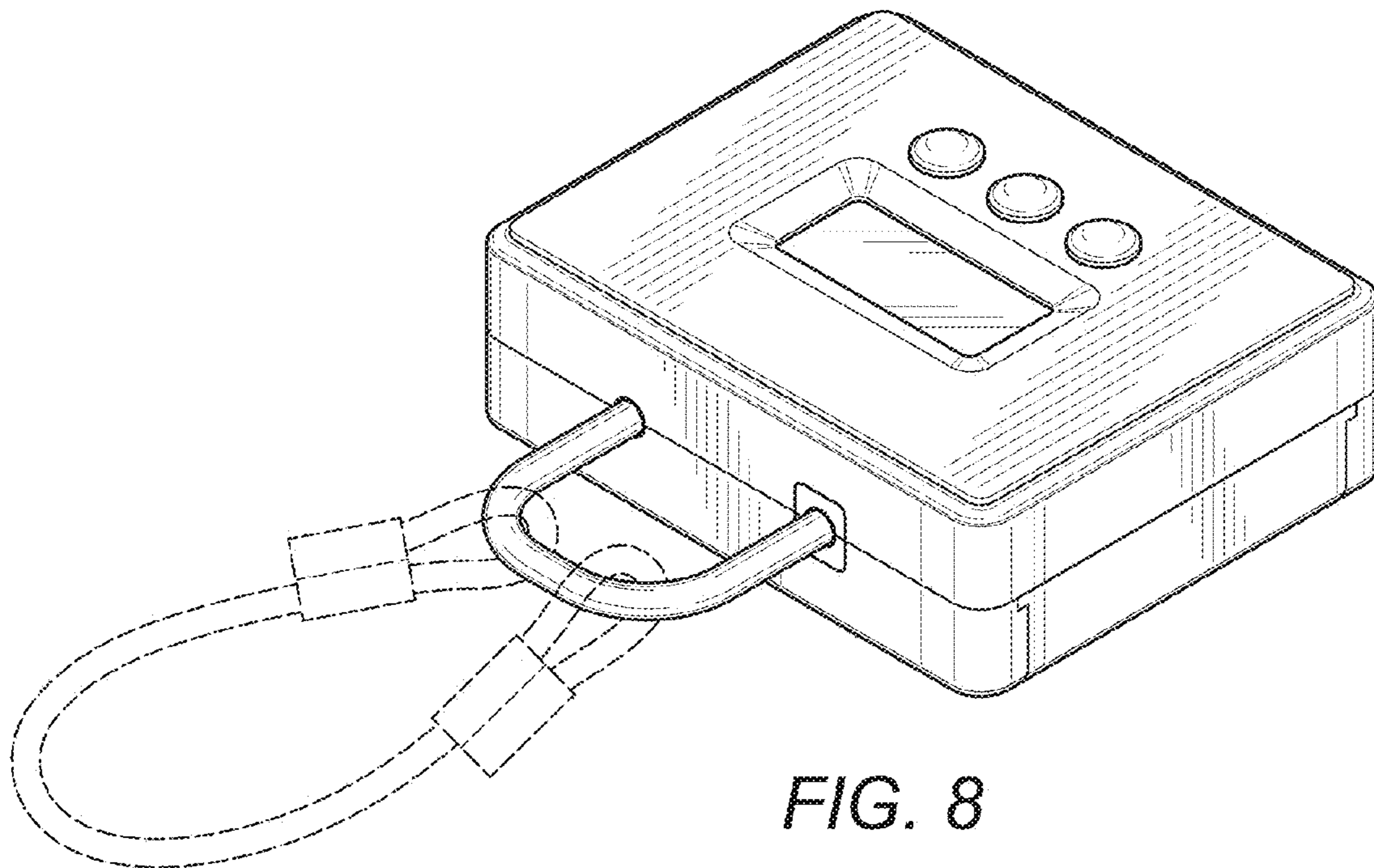
