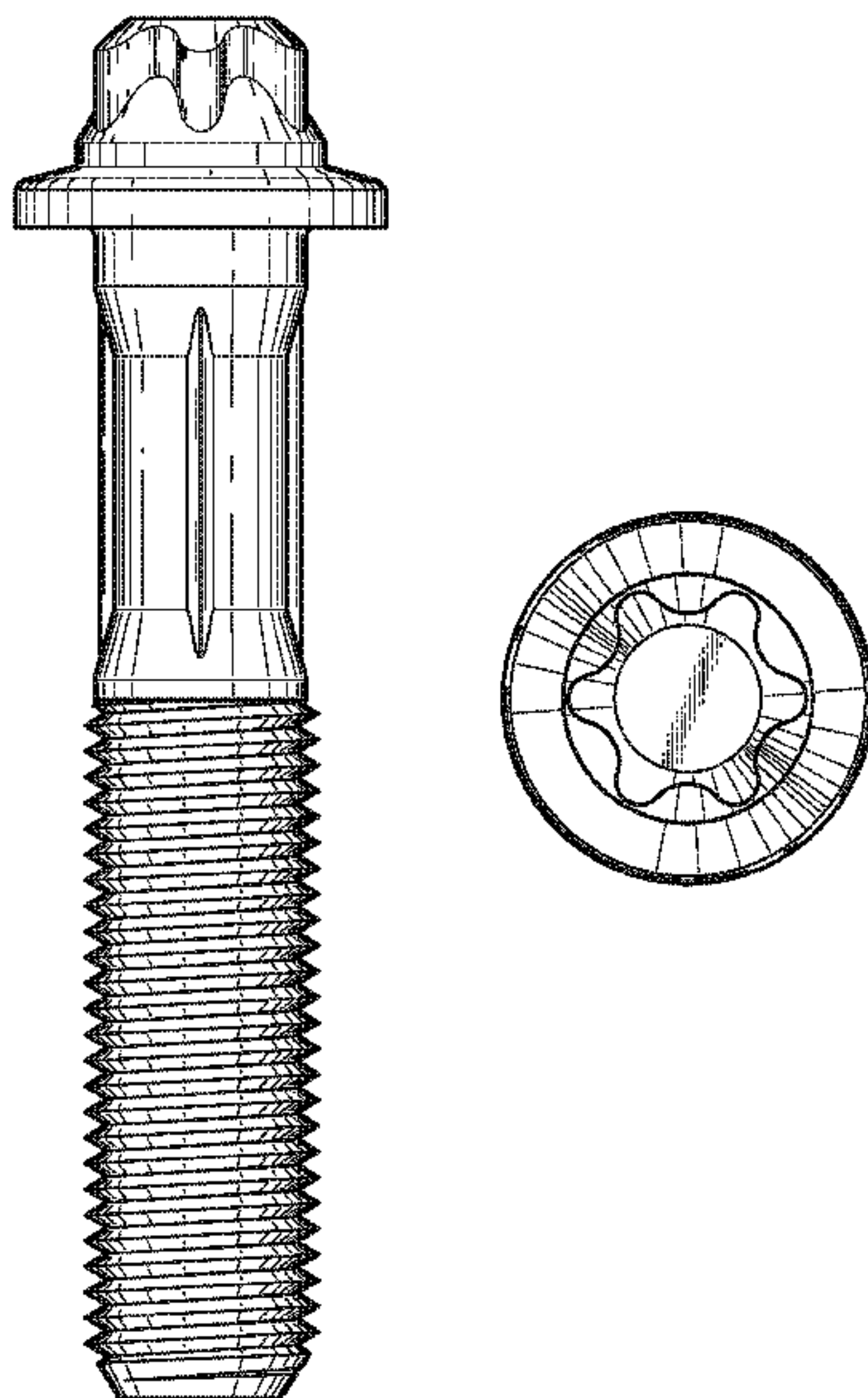

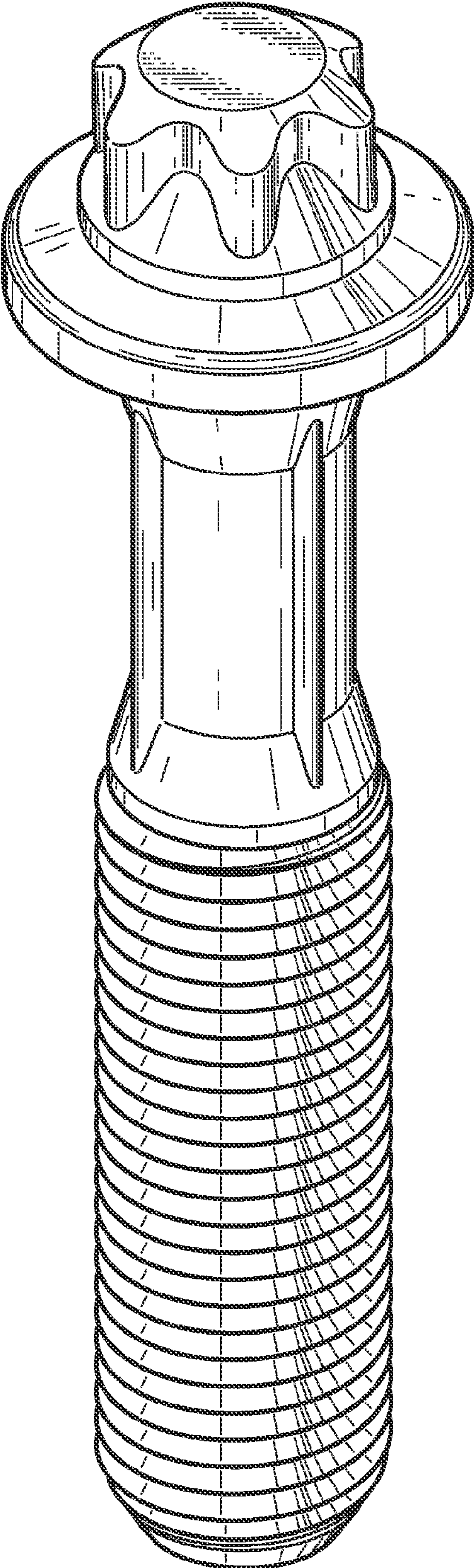
The ornamental design of a screw, as shown and described.

FIG. 7 is a bottom view thereof.

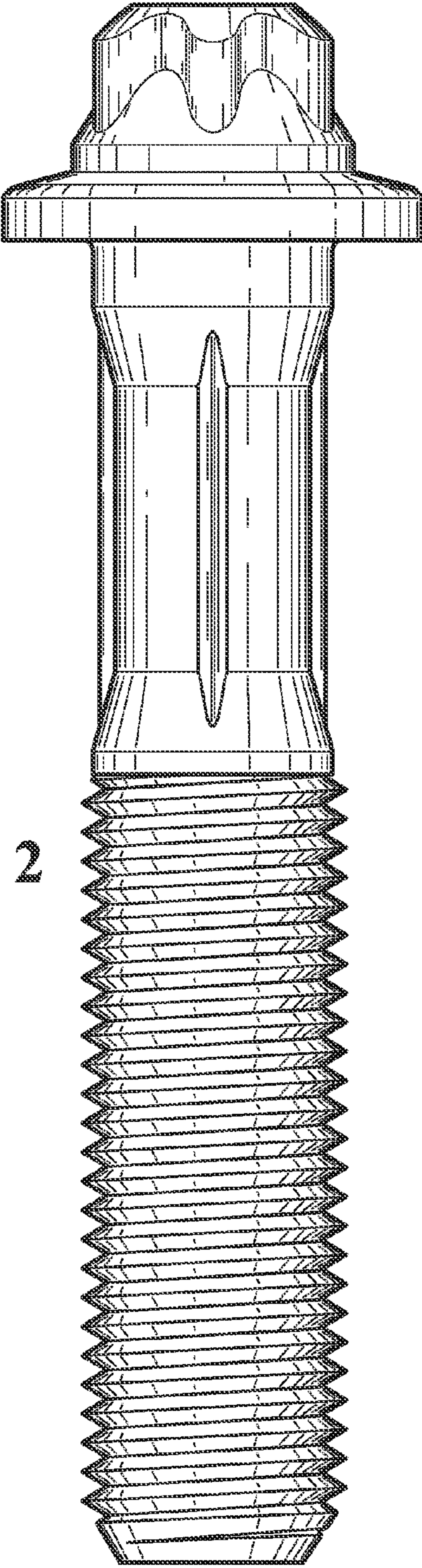

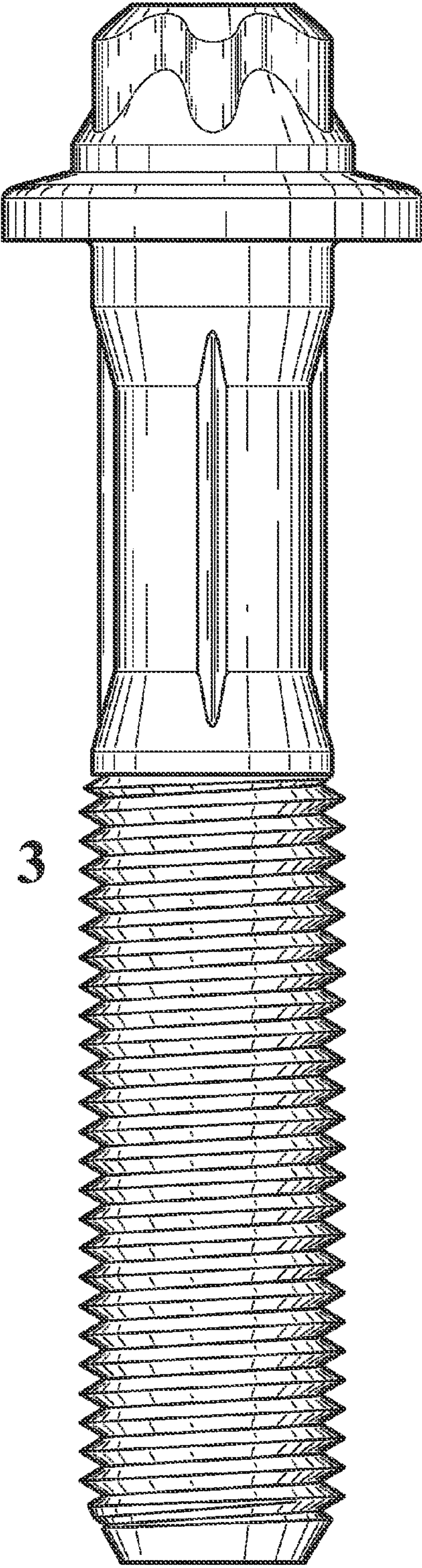

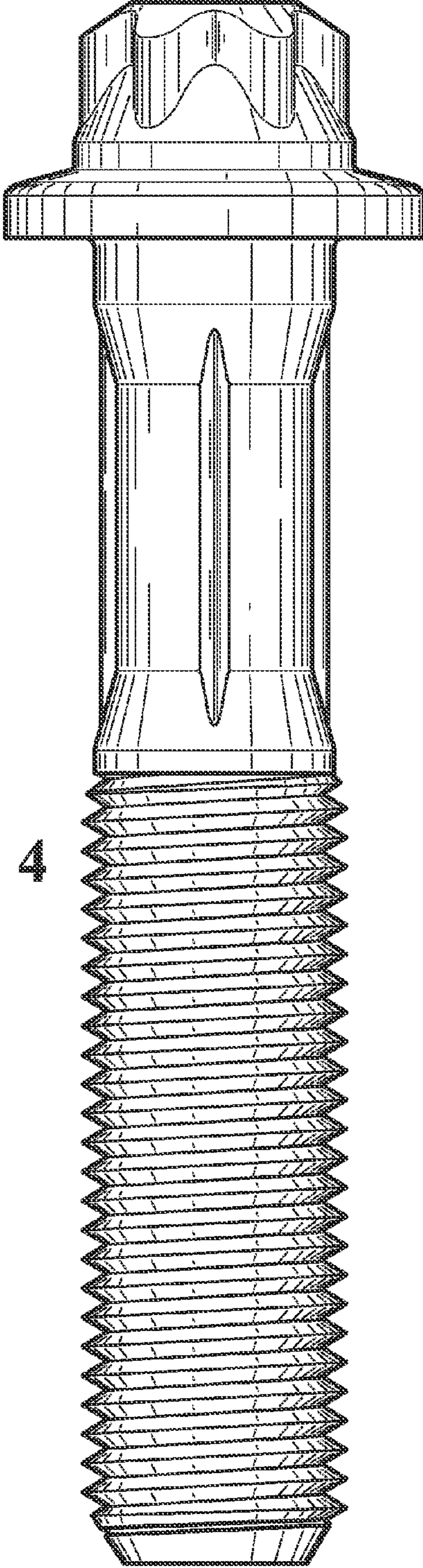

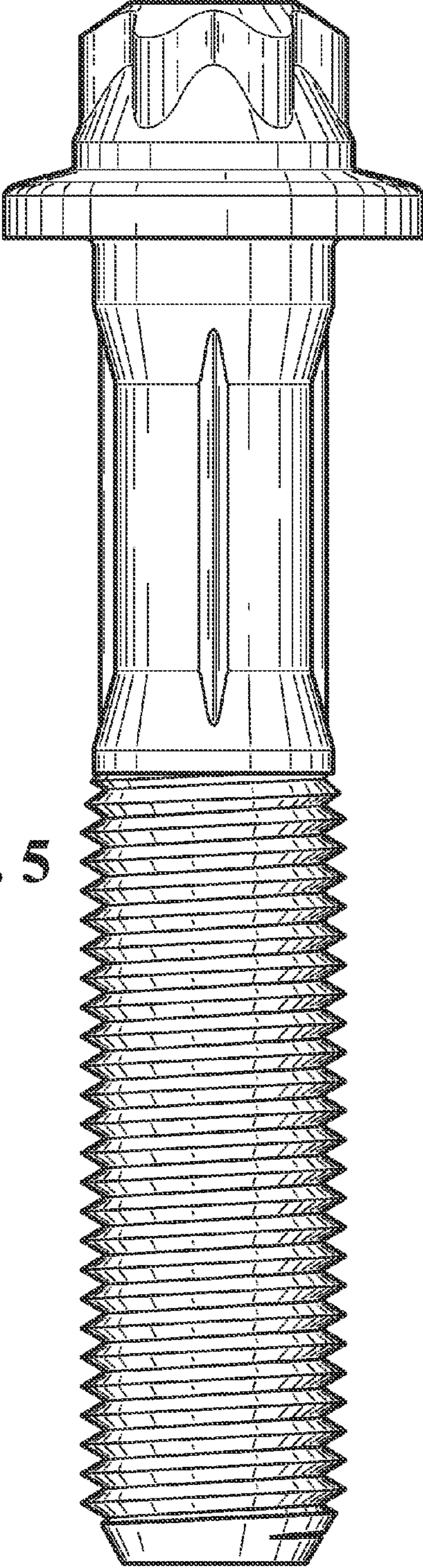

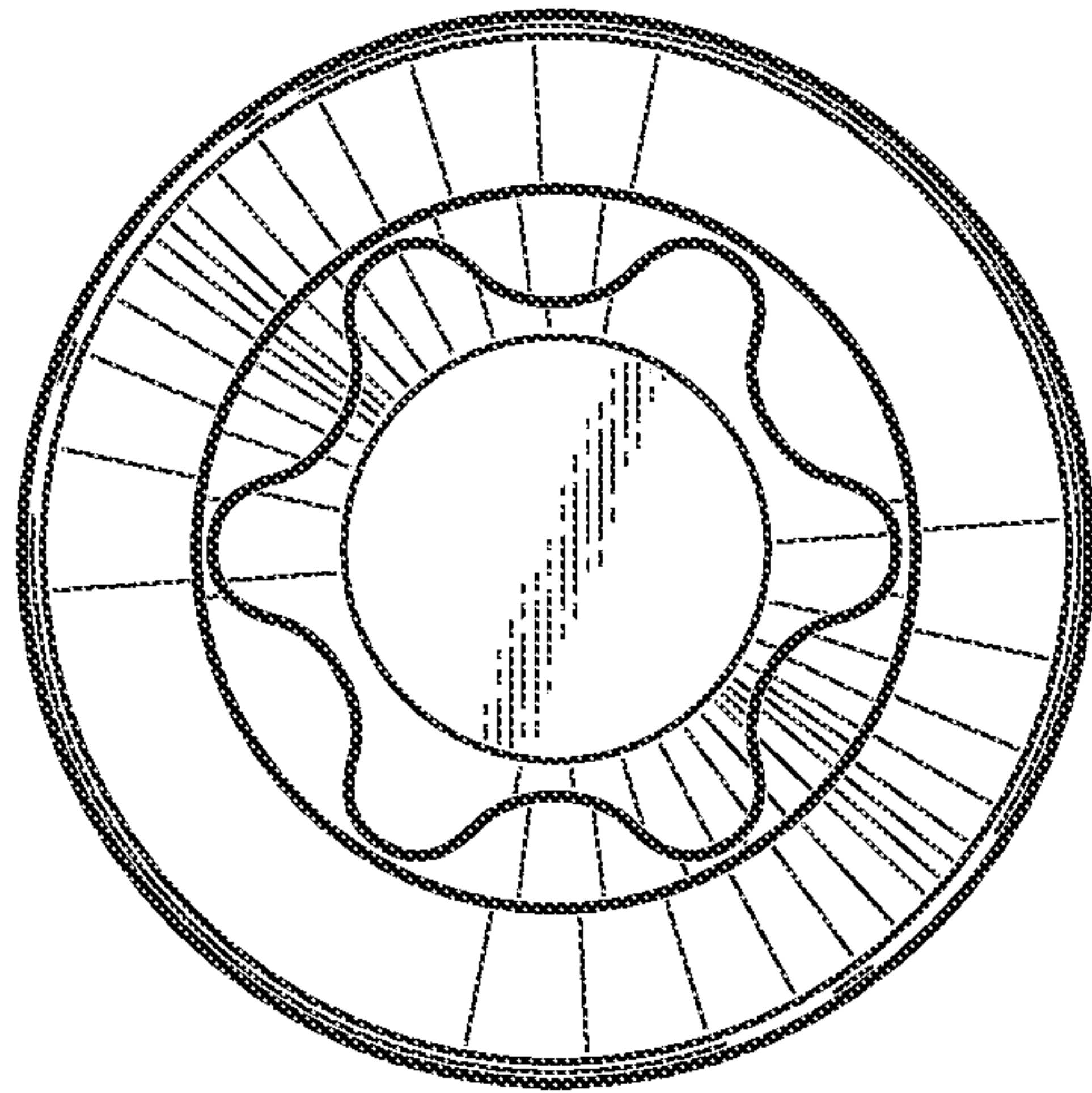




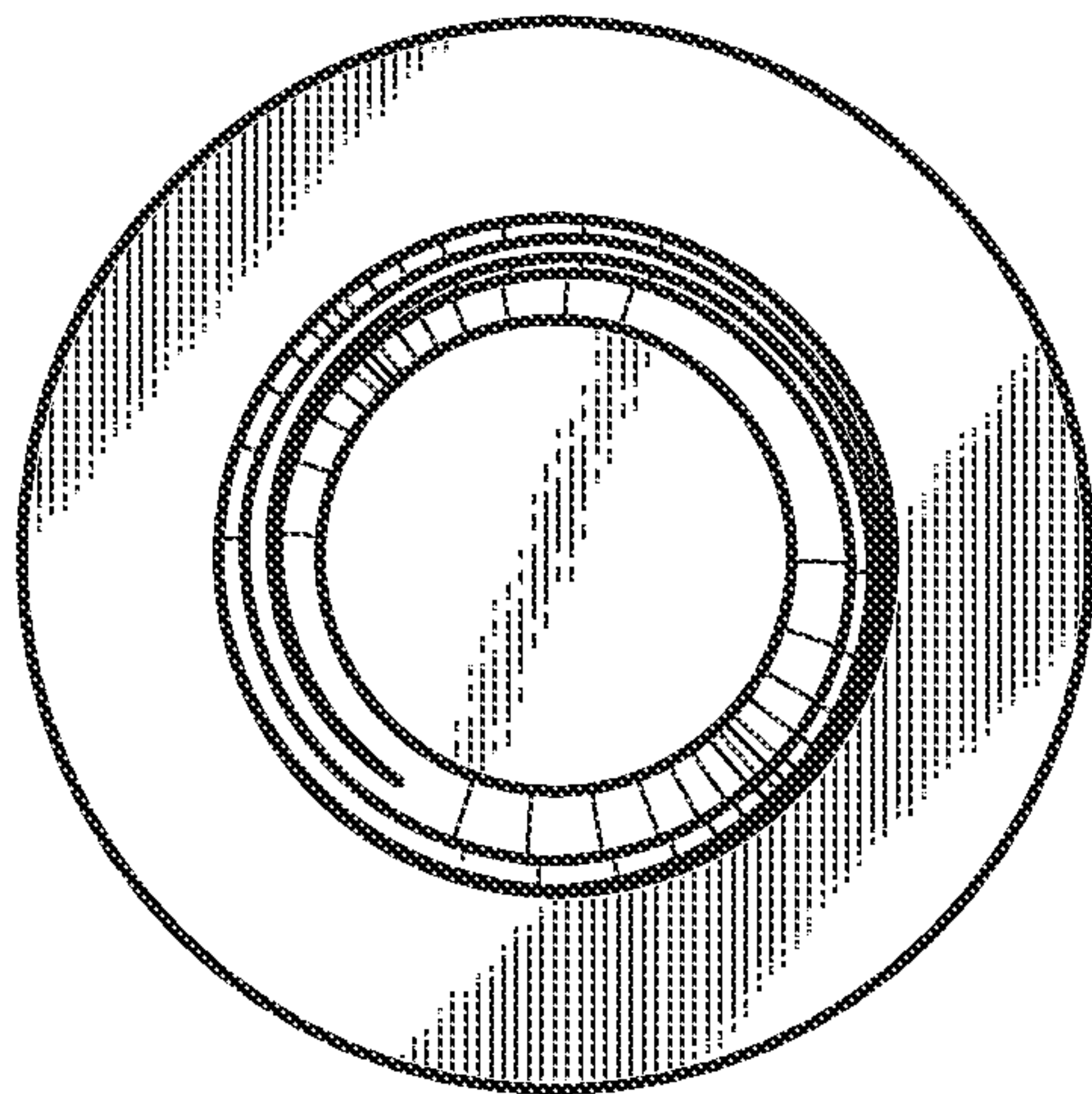
