(57) **CLAIM**

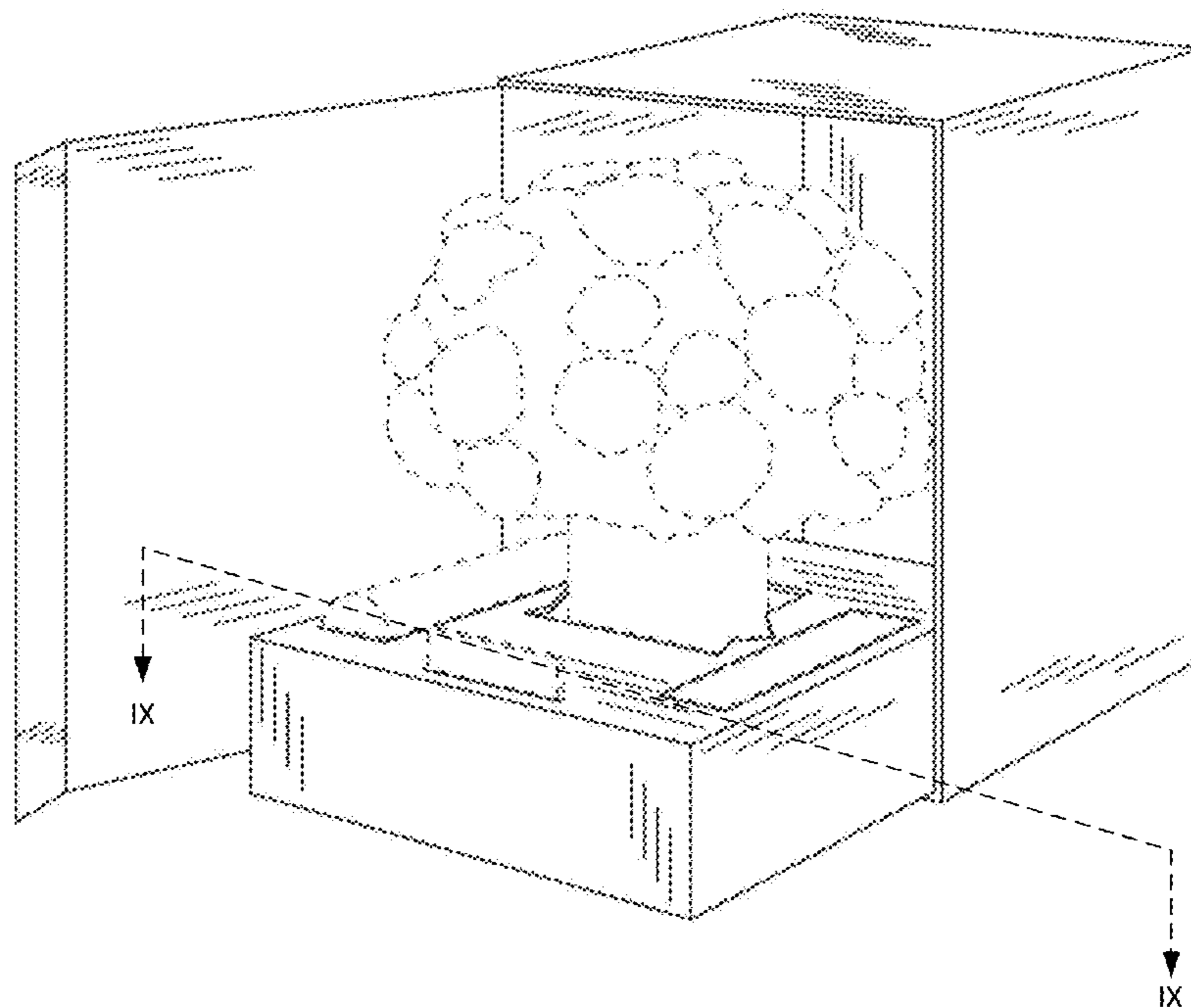
The ornamental design for a floral delivery container, as

**DESCRIPTION**

FIG. 1 is a front perspective view of a delivery container with  
a sliding inner base in a protruding position;  
FIG. 2 is a front perspective view of a delivery container with  
the sliding inner base in an enclosed position;  
FIG. 3 is a right-side view of the delivery container of FIG. 2;  
FIG. 4 is a left-side view of the delivery container of FIG. 2;  
FIG. 5 is a front view of the delivery container of FIG. 2;  
FIG. 6 is a rear view of the delivery container of FIG. 2;  
FIG. 7 is a top view of the delivery container of FIG. 2;  
FIG. 8 is a bottom view of the delivery container of FIG. 2;

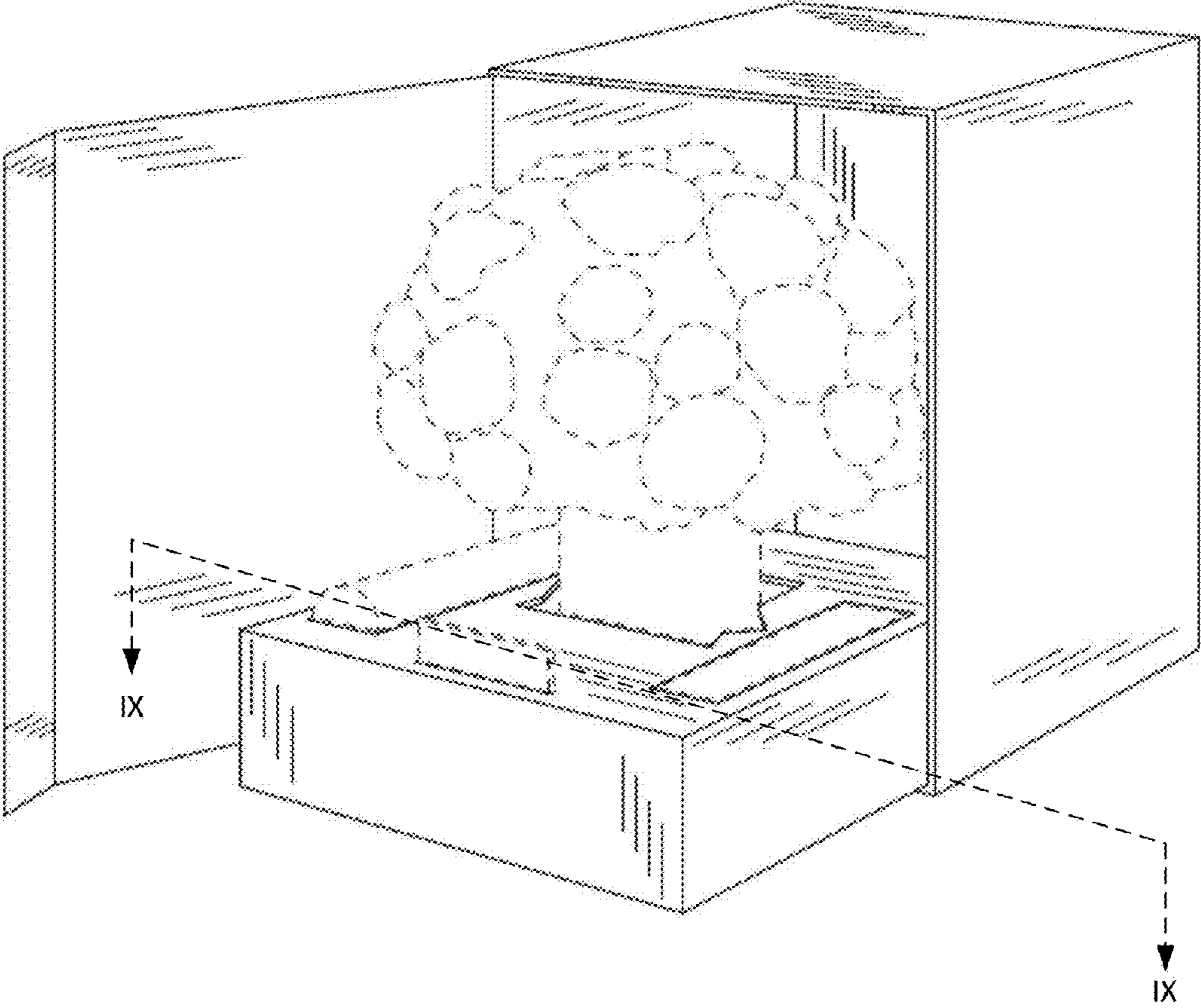

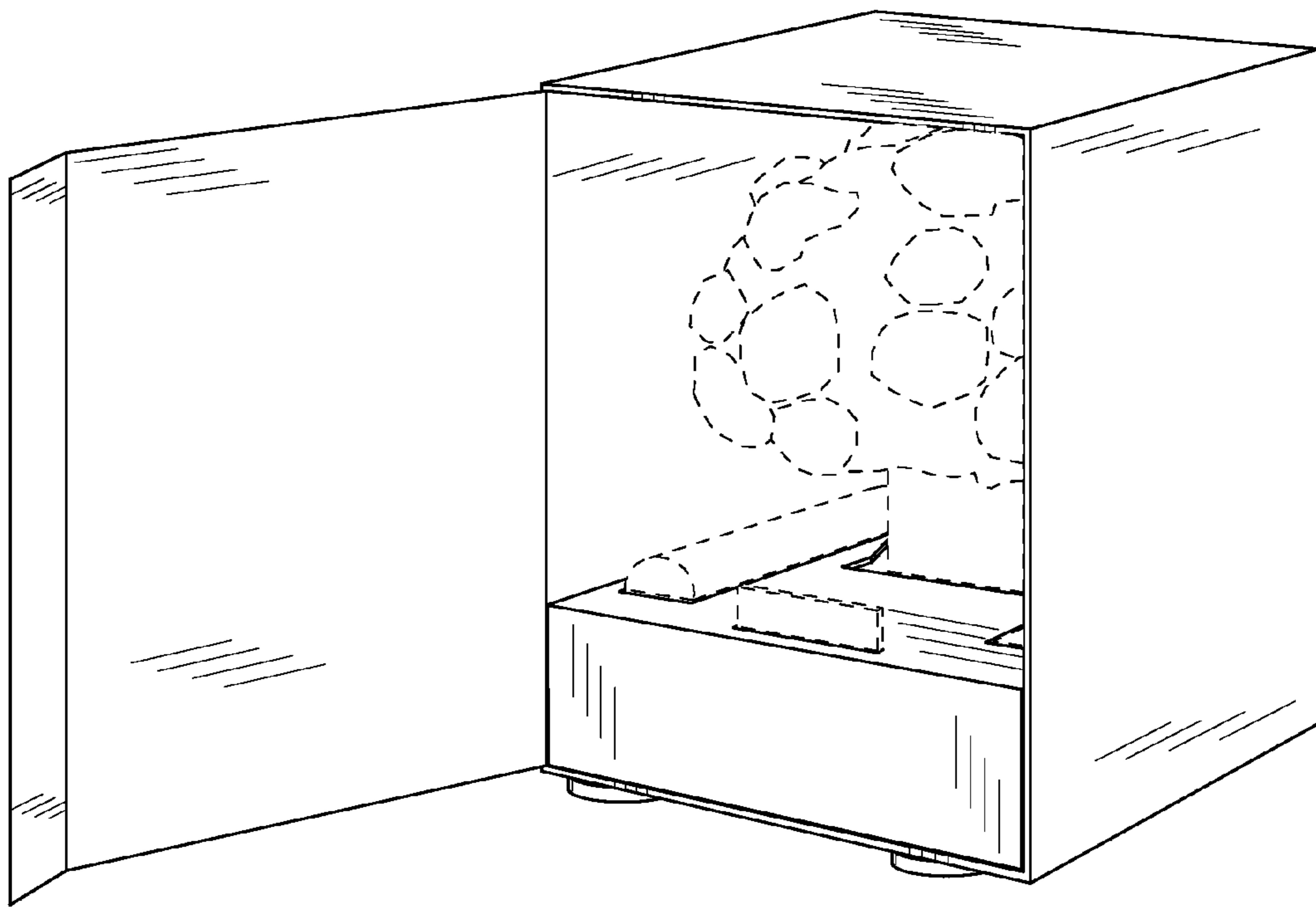

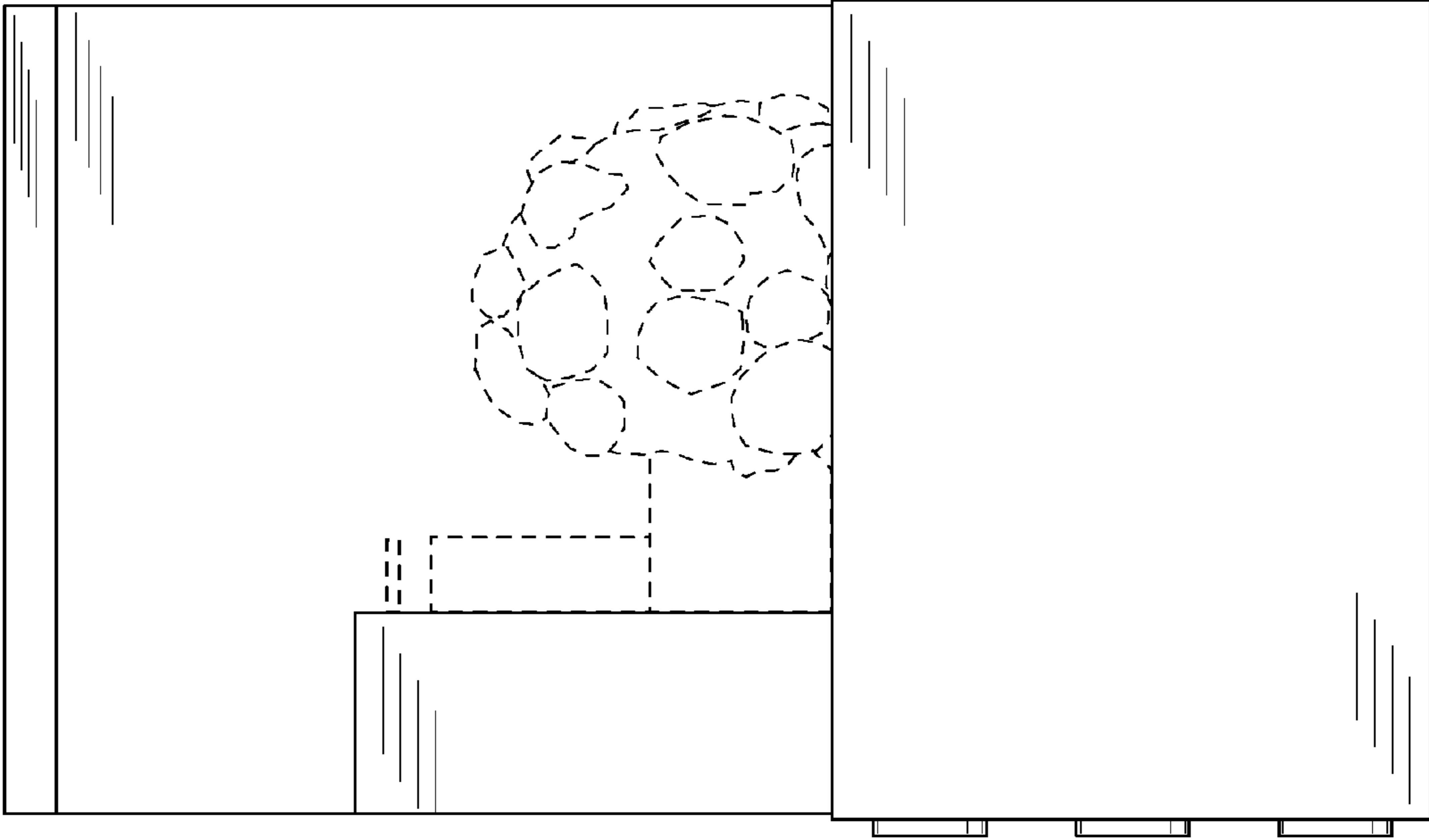

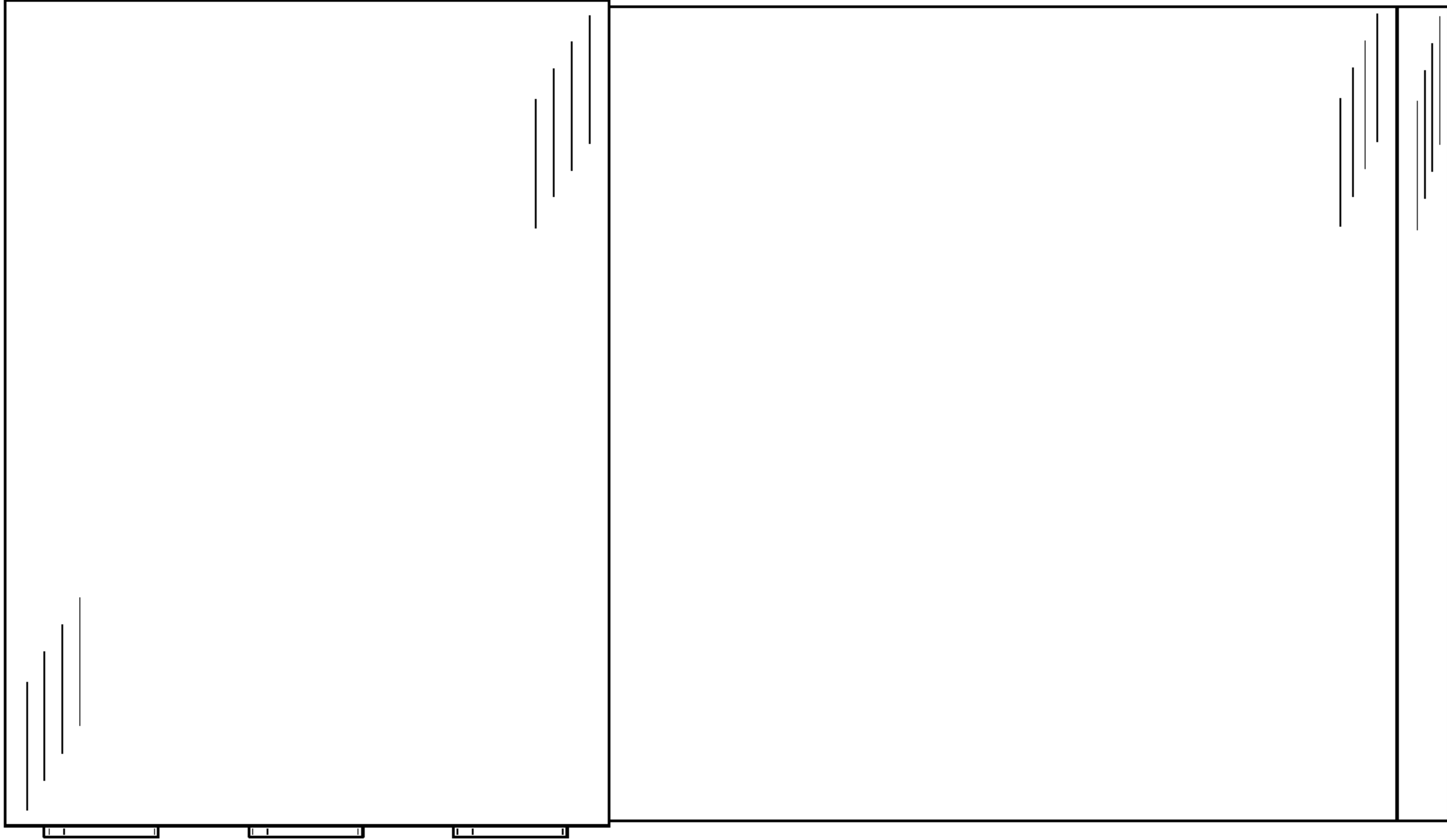

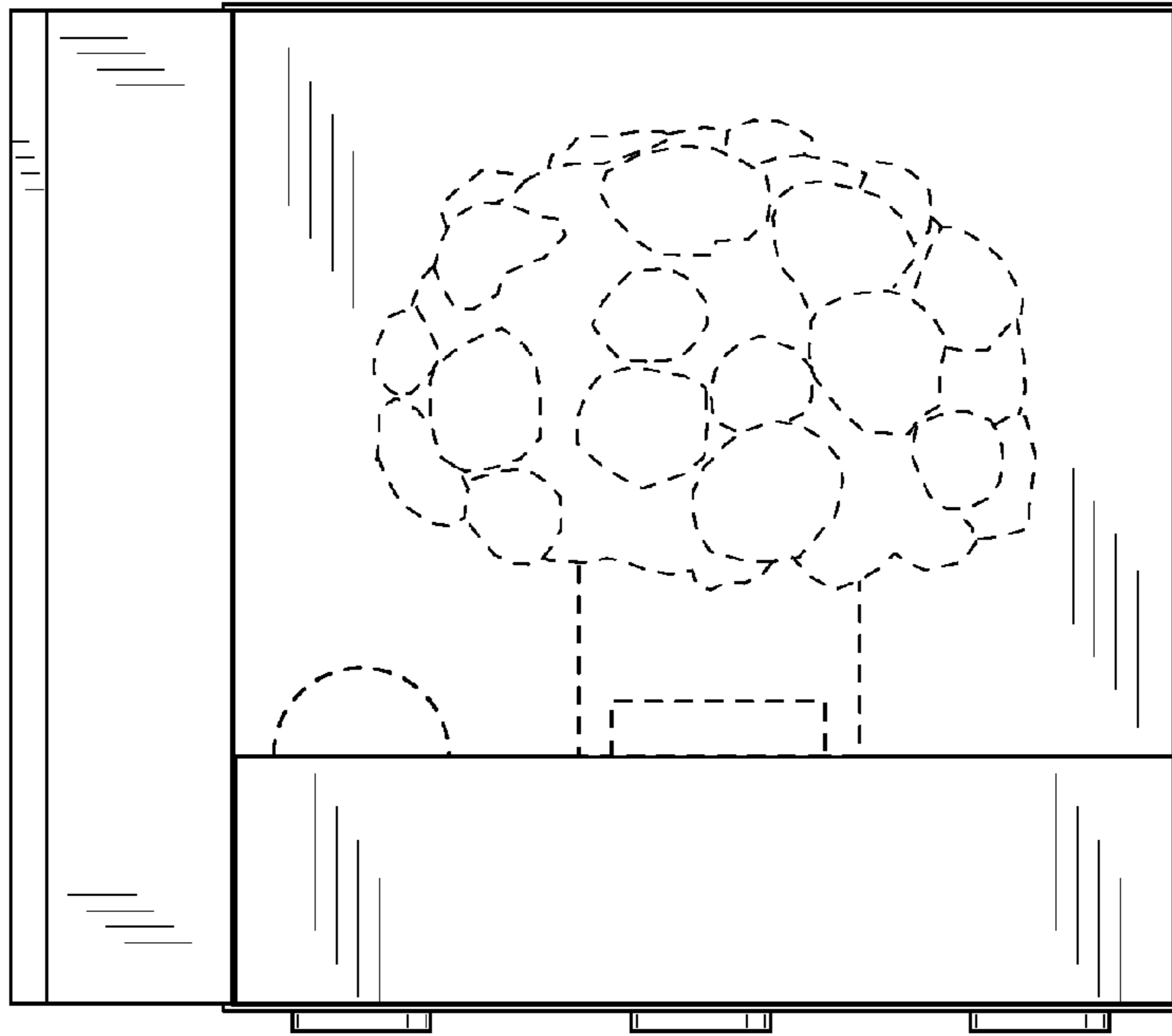

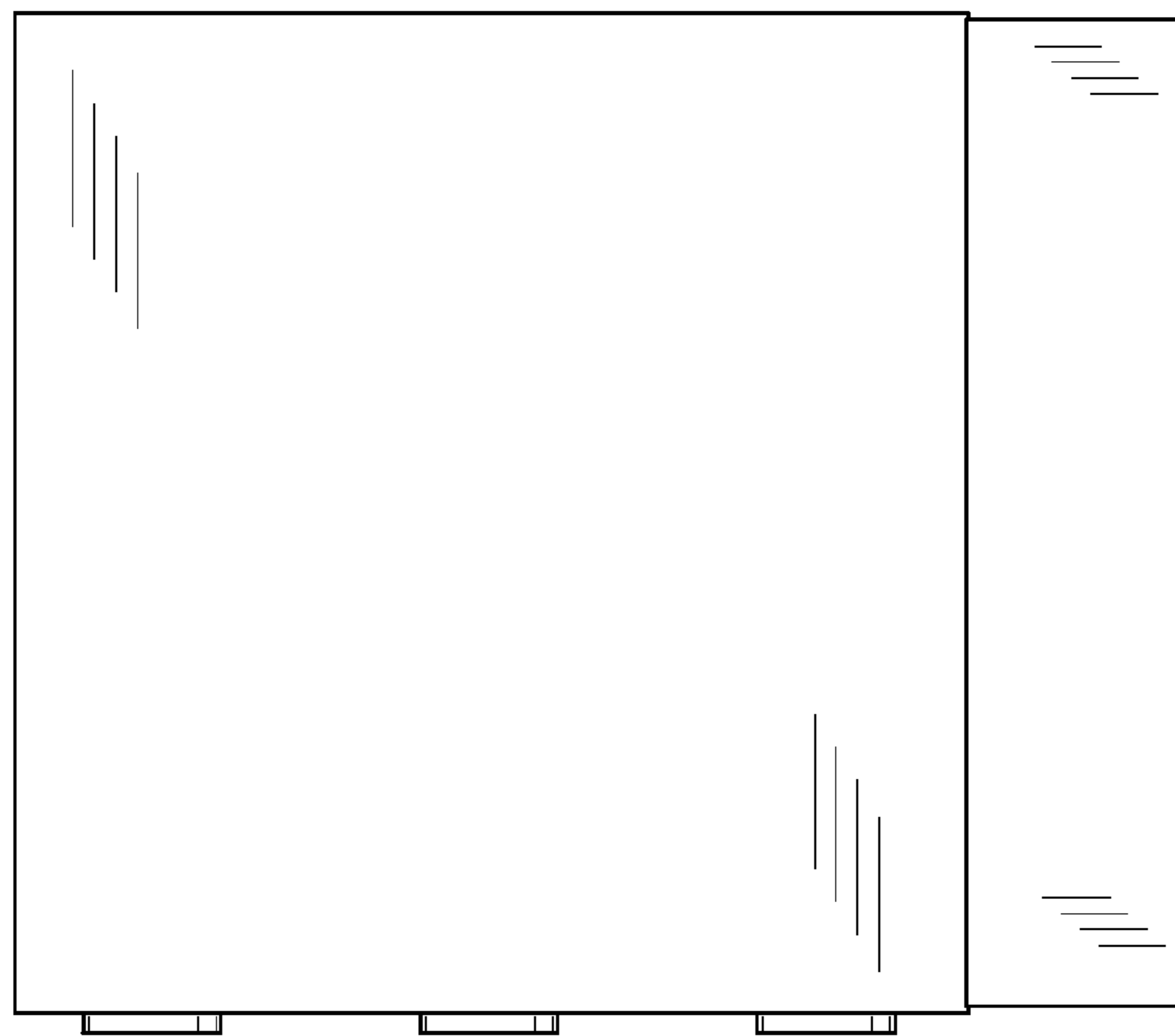

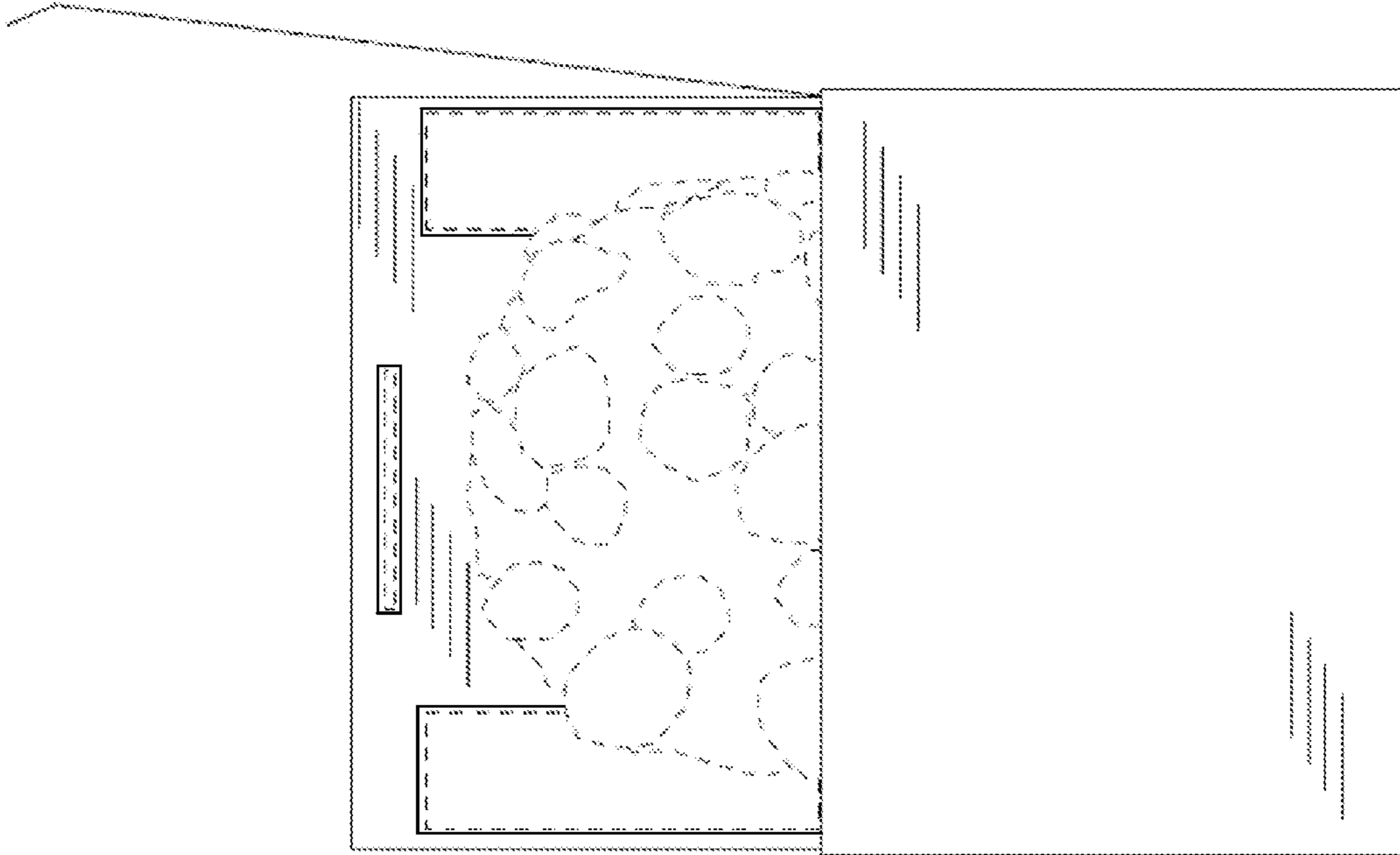

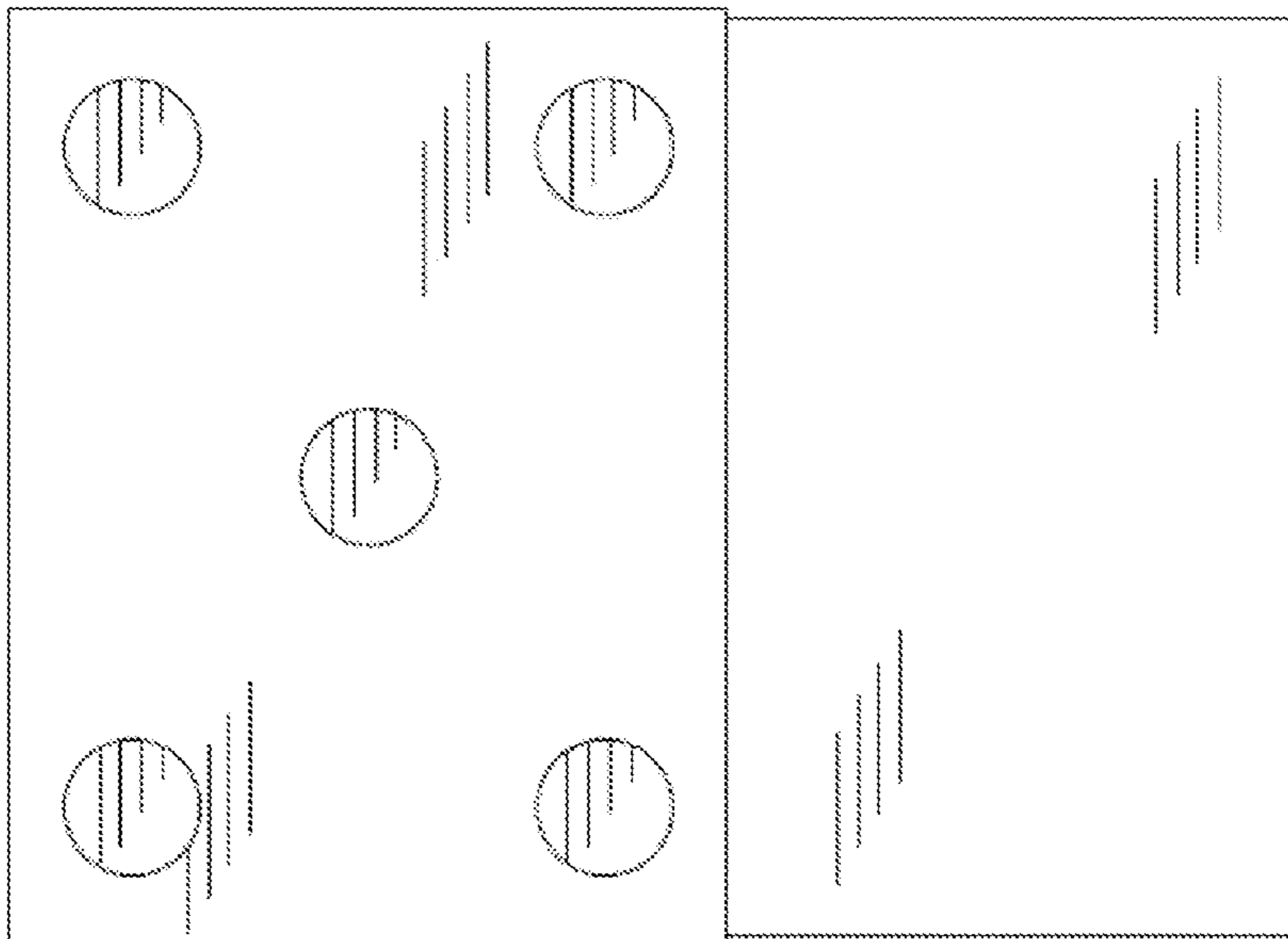

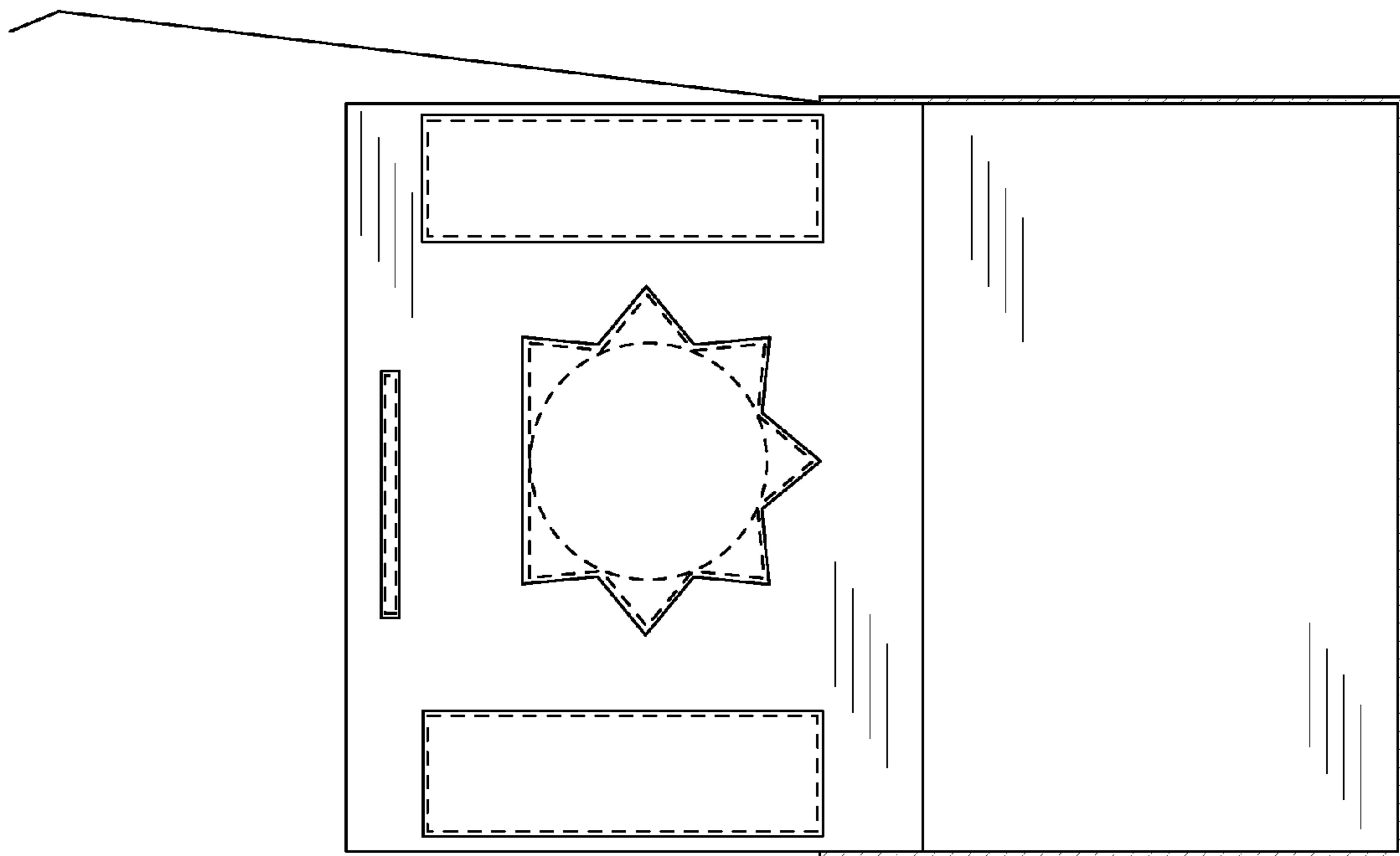
