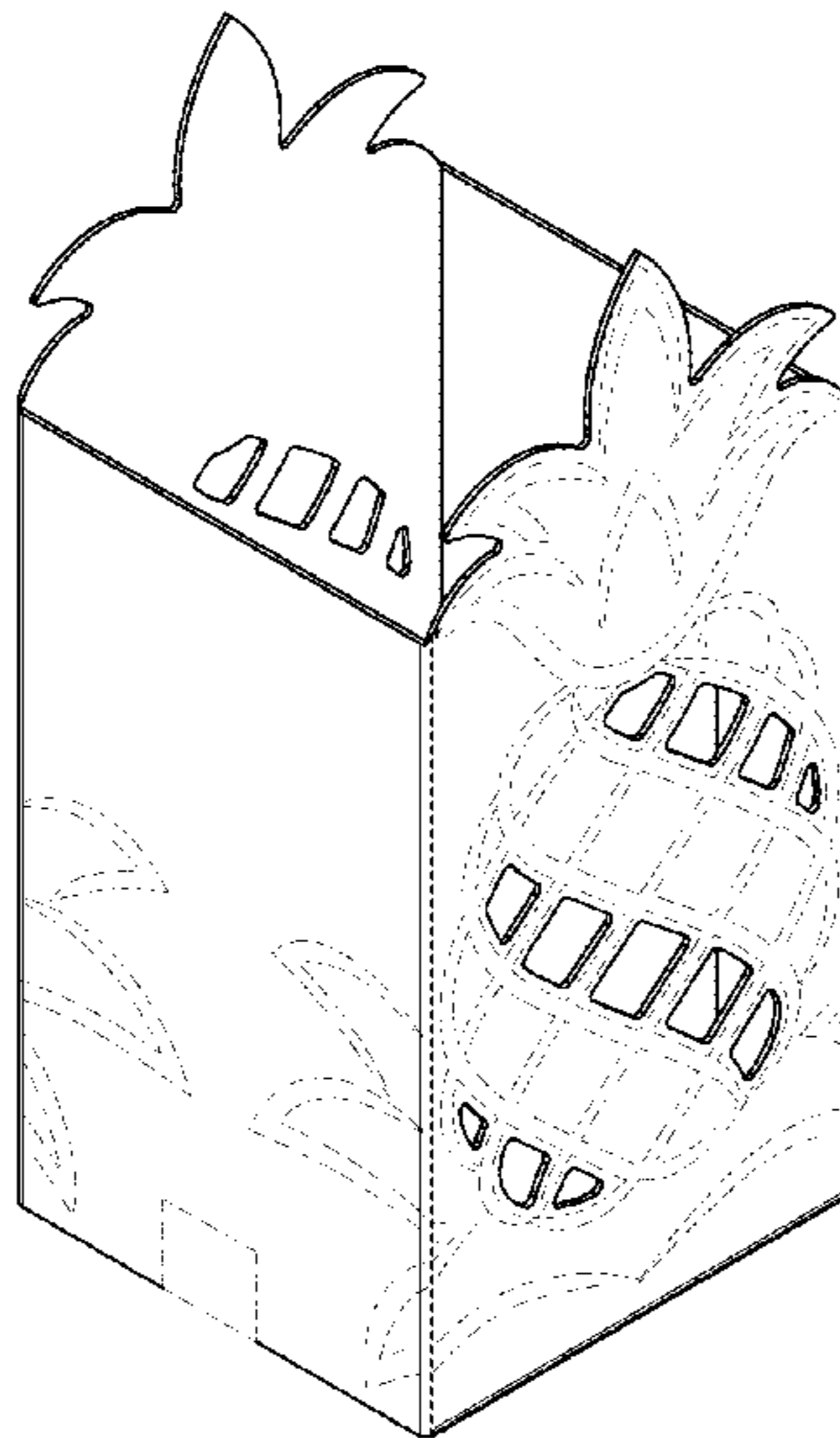
FIG. 1 is a perspective view of the box sleeve of my new design from the front top left;

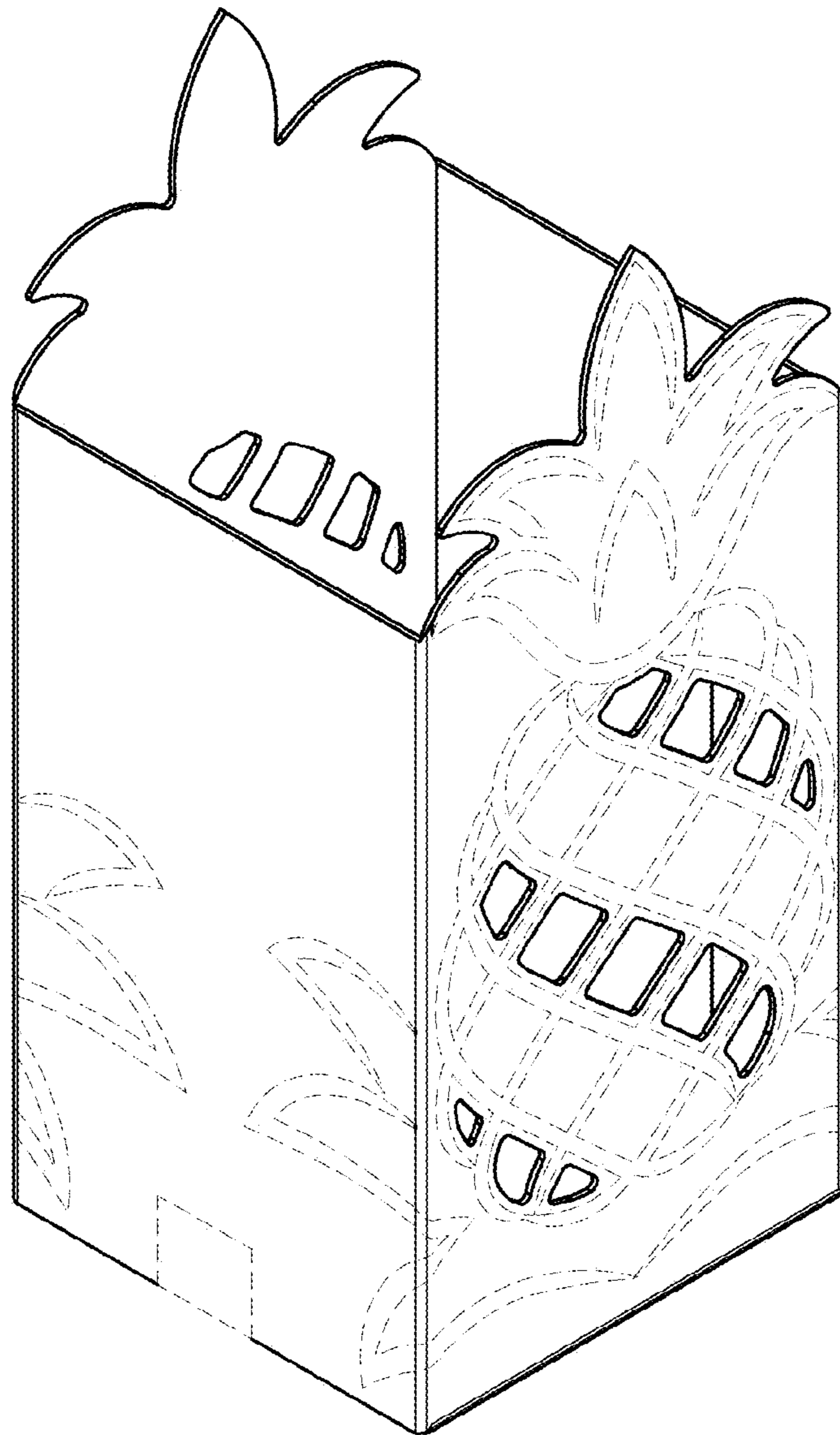

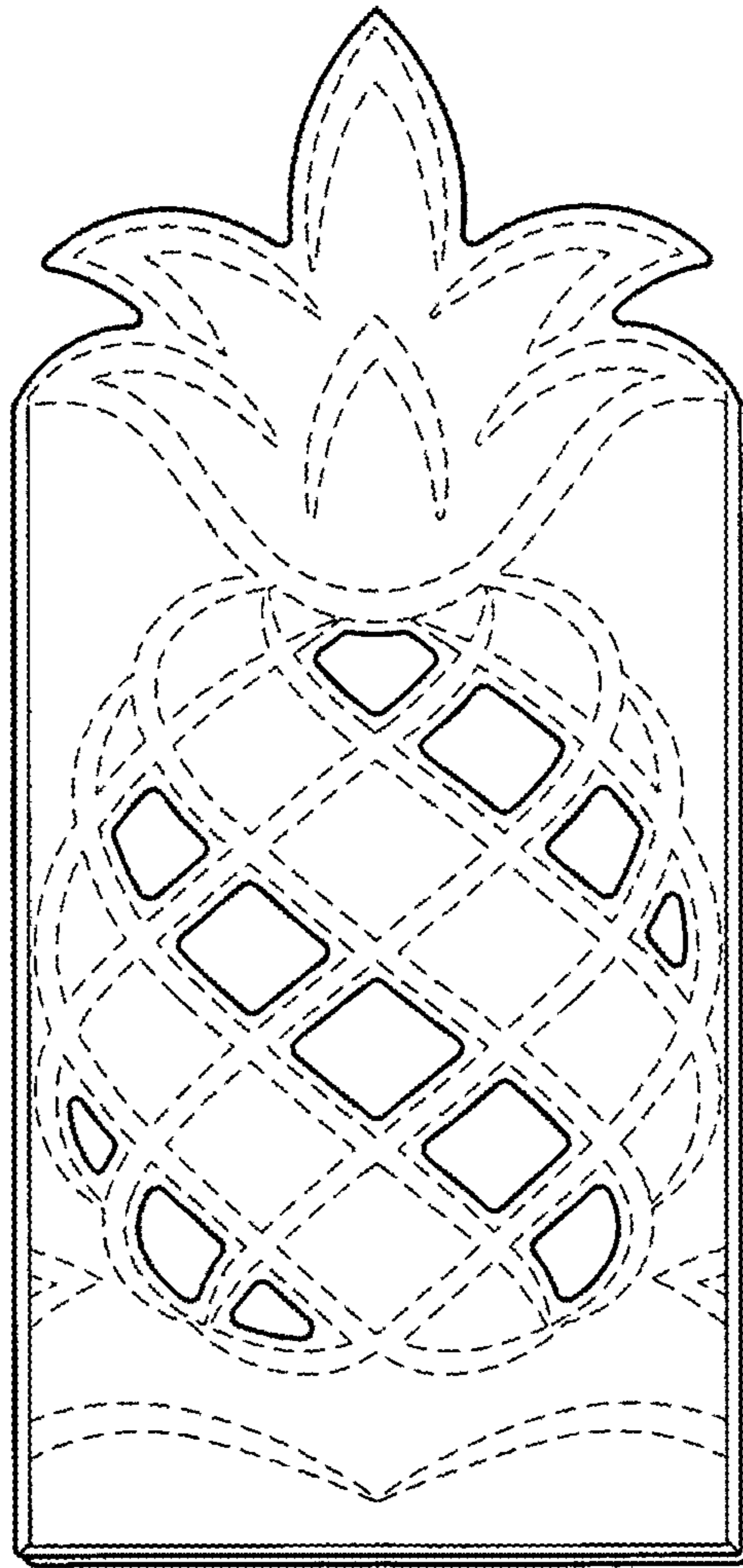

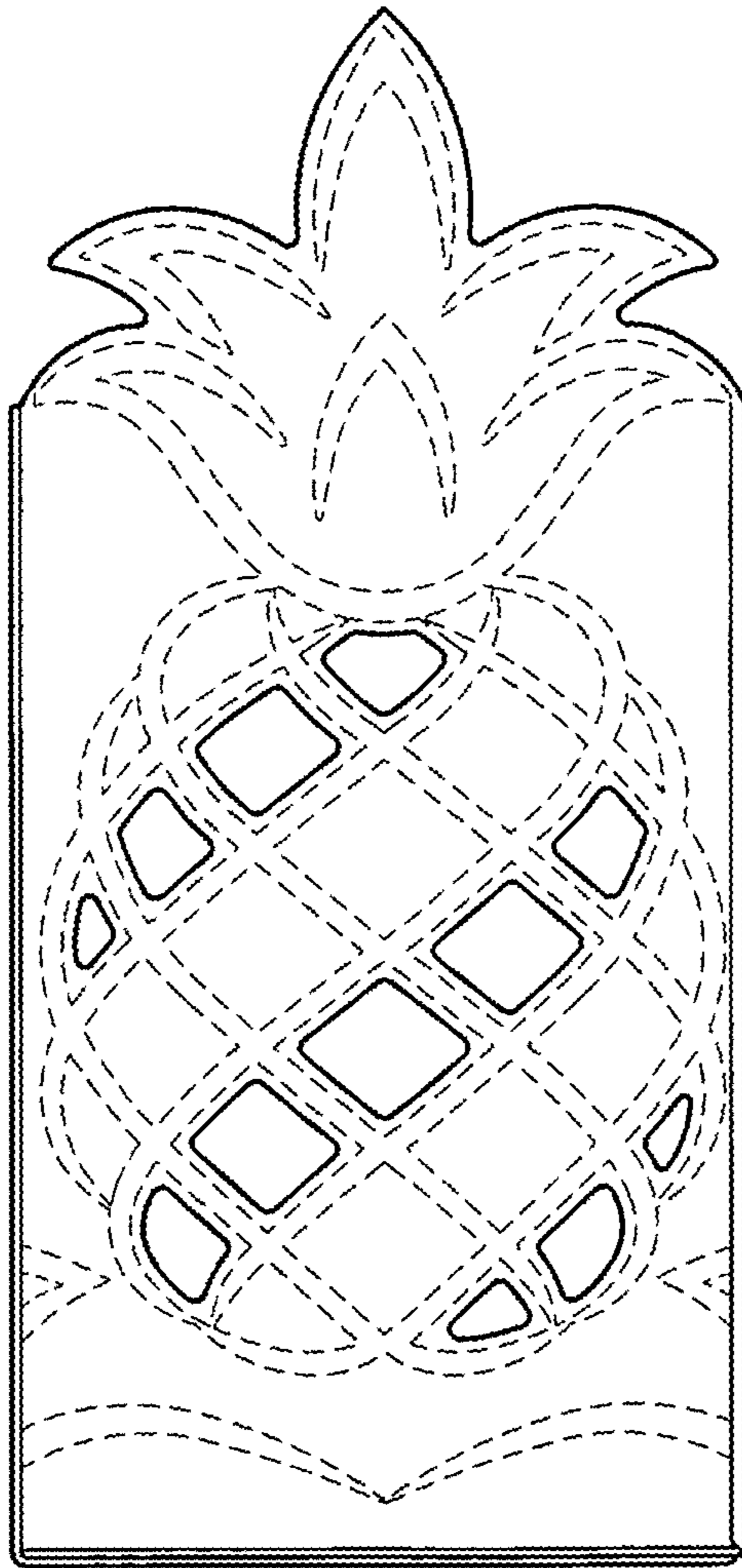

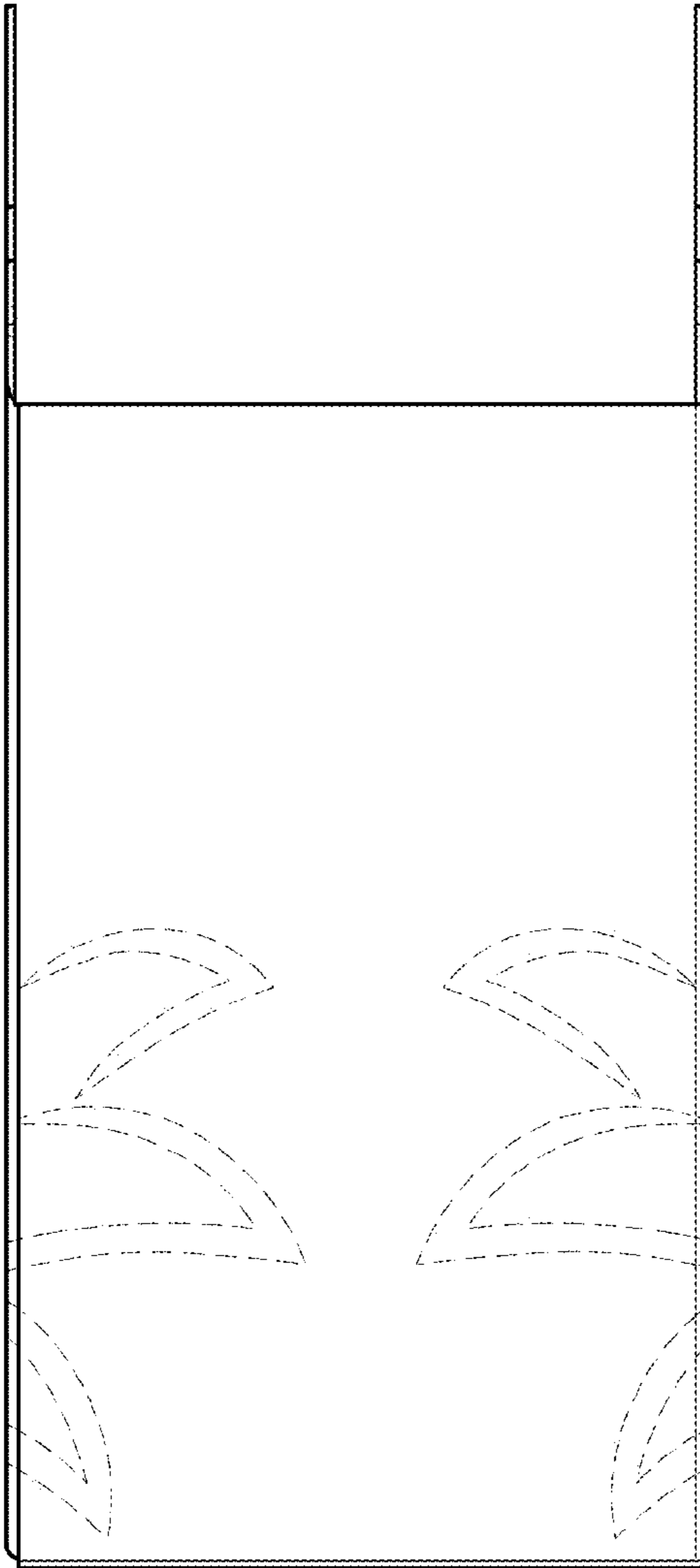

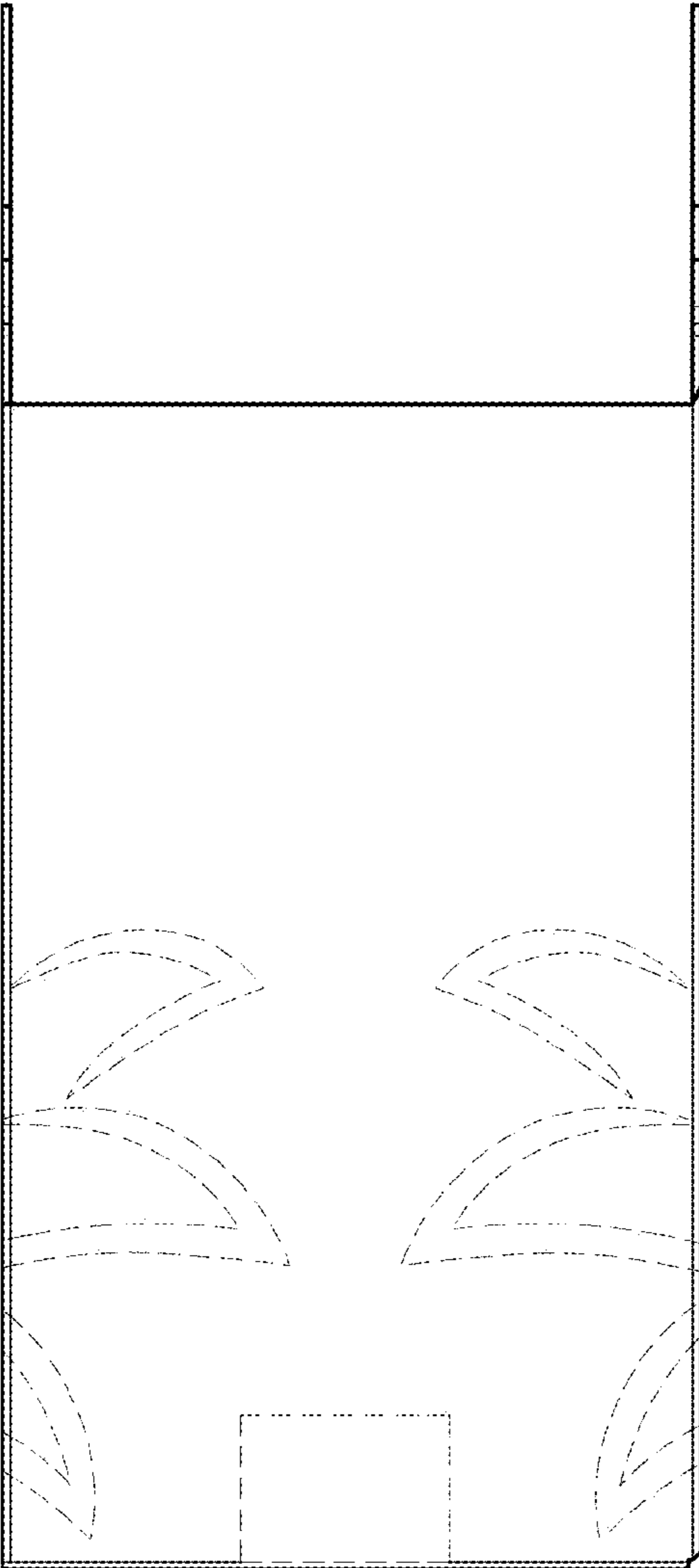

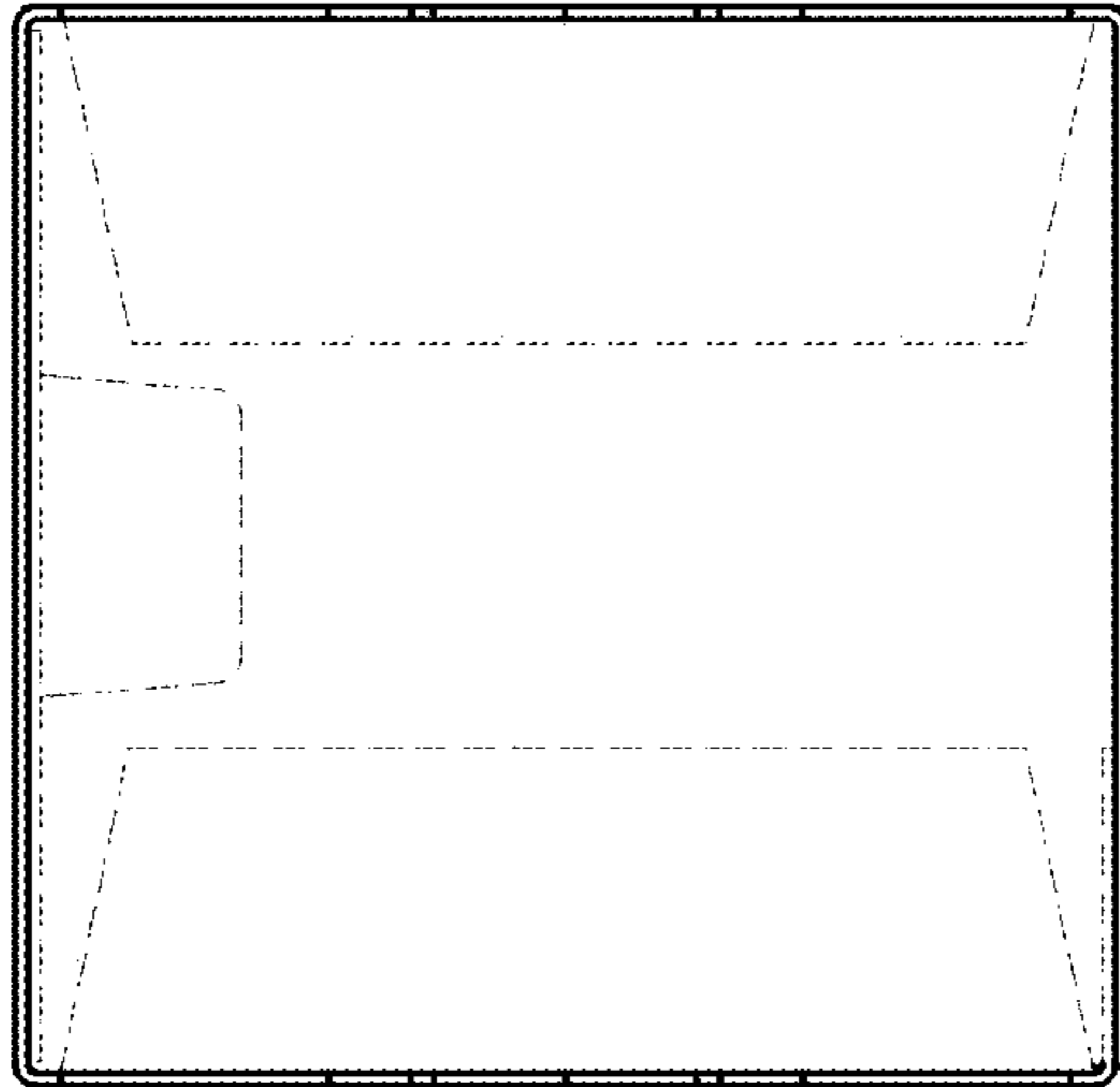

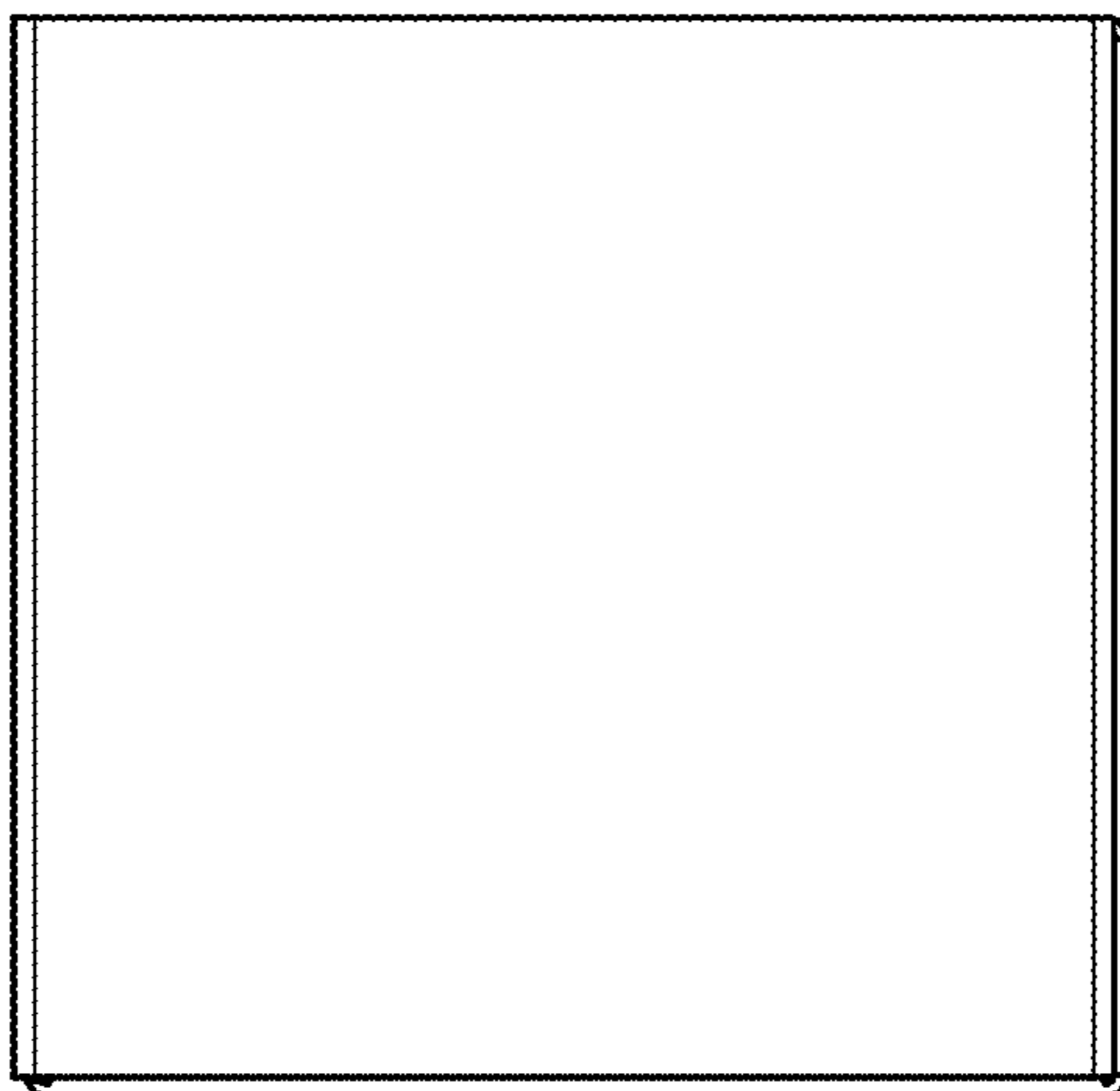

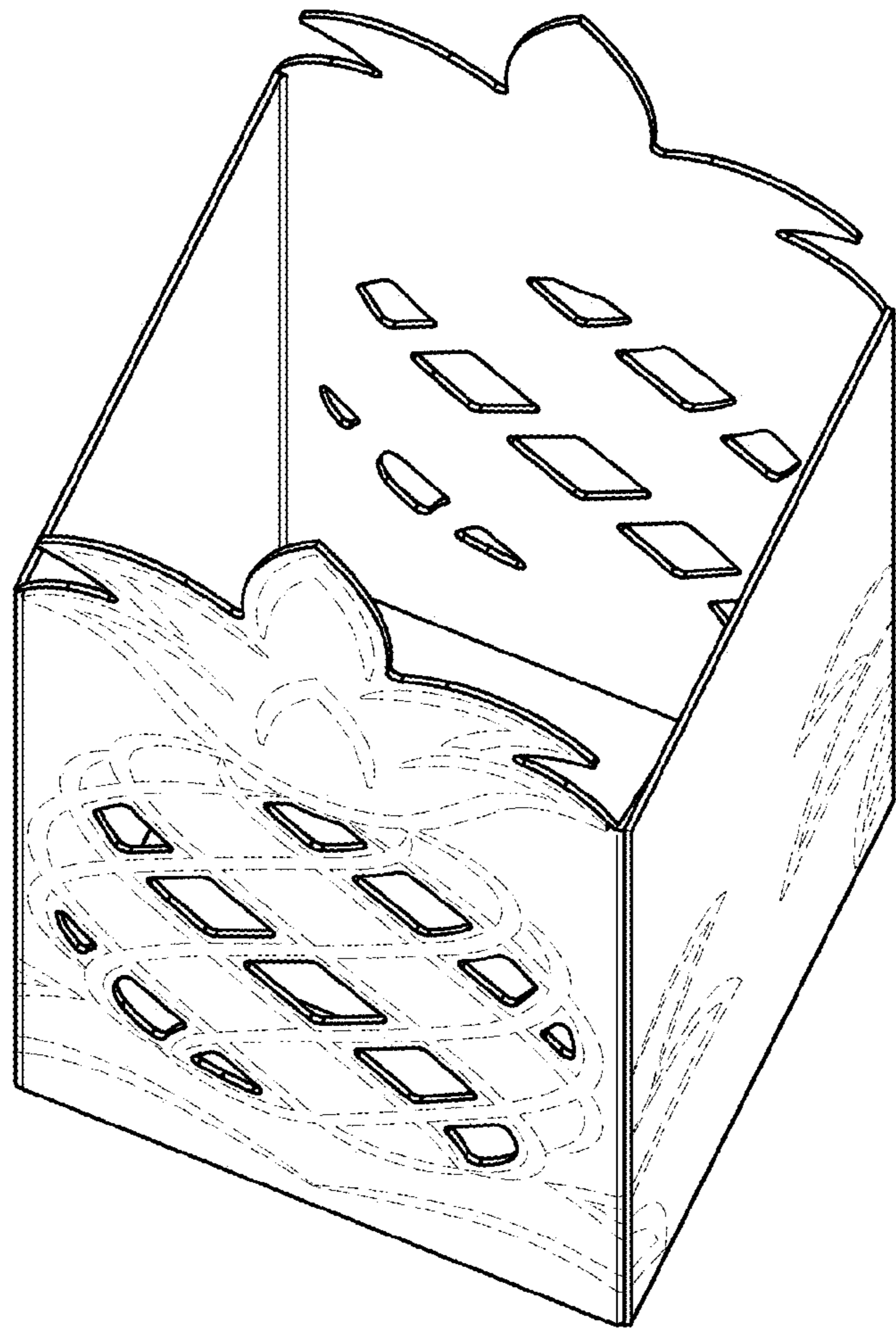

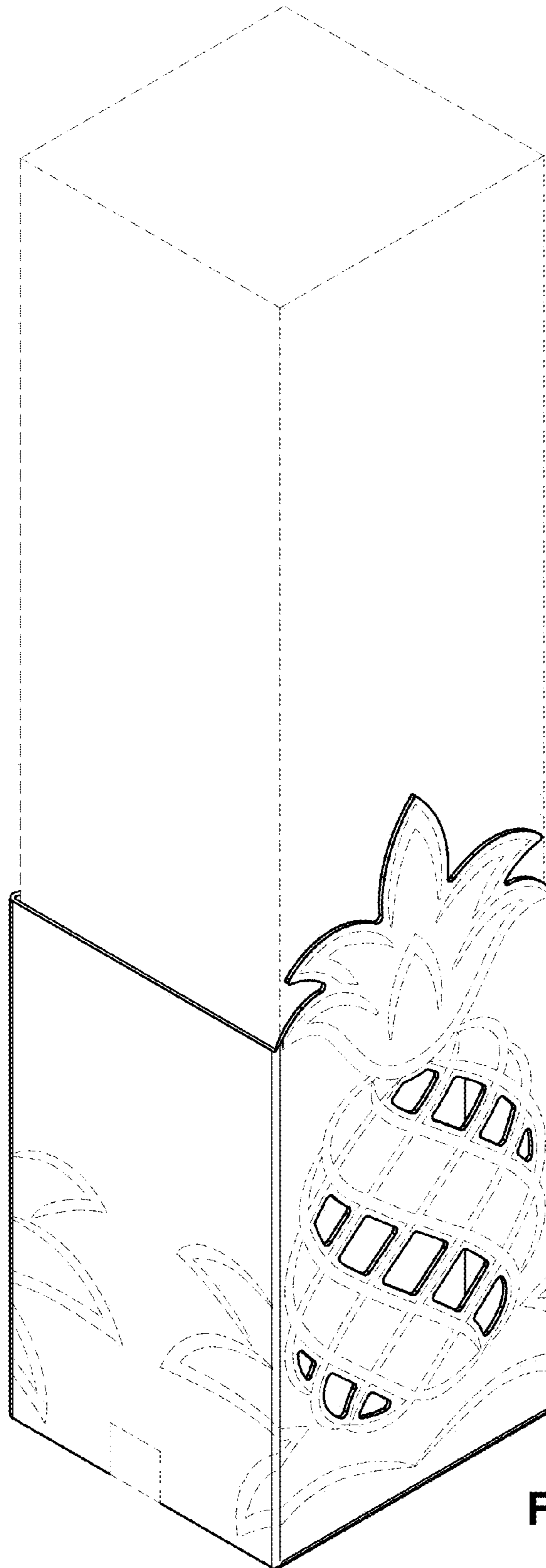

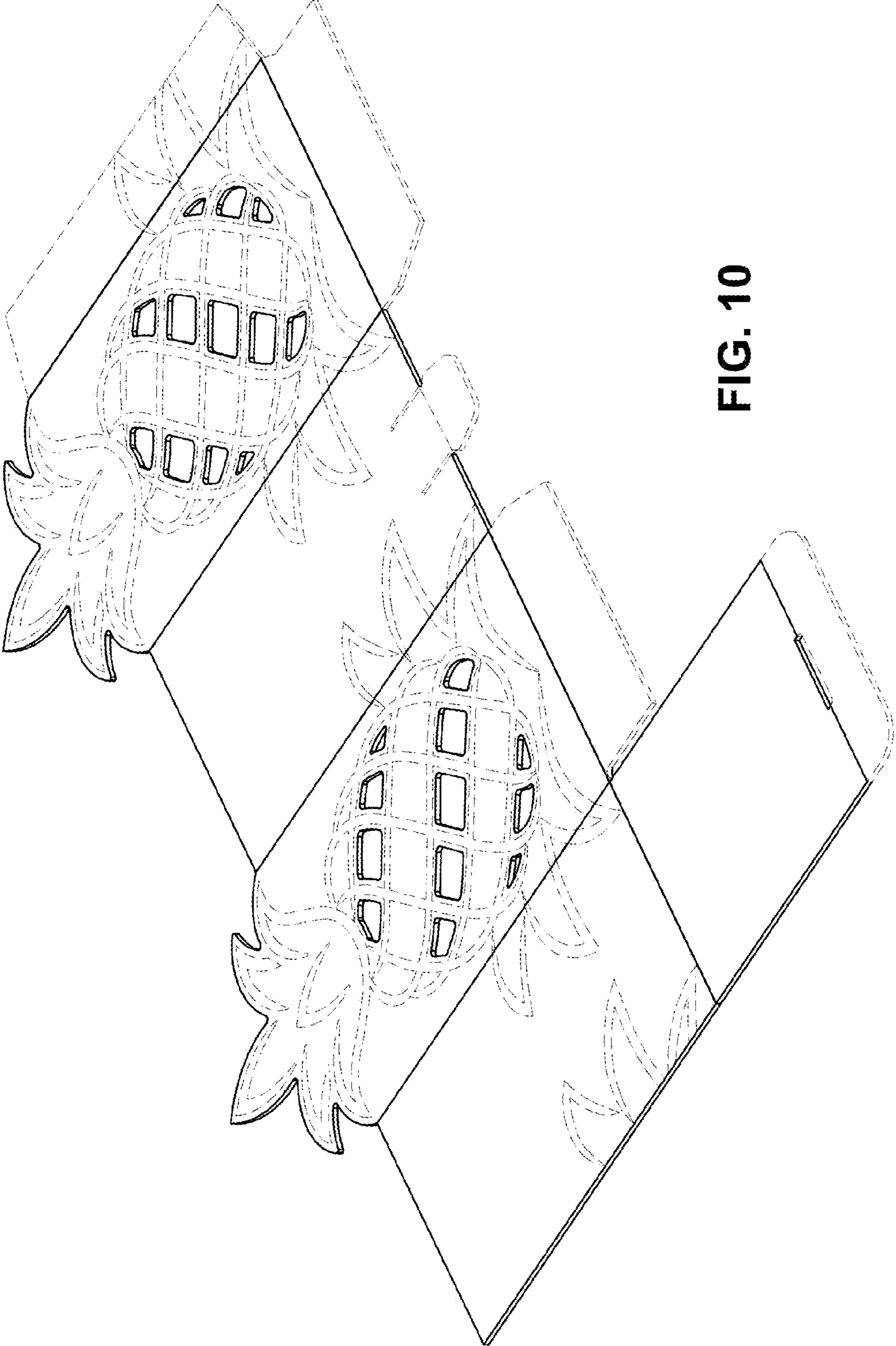

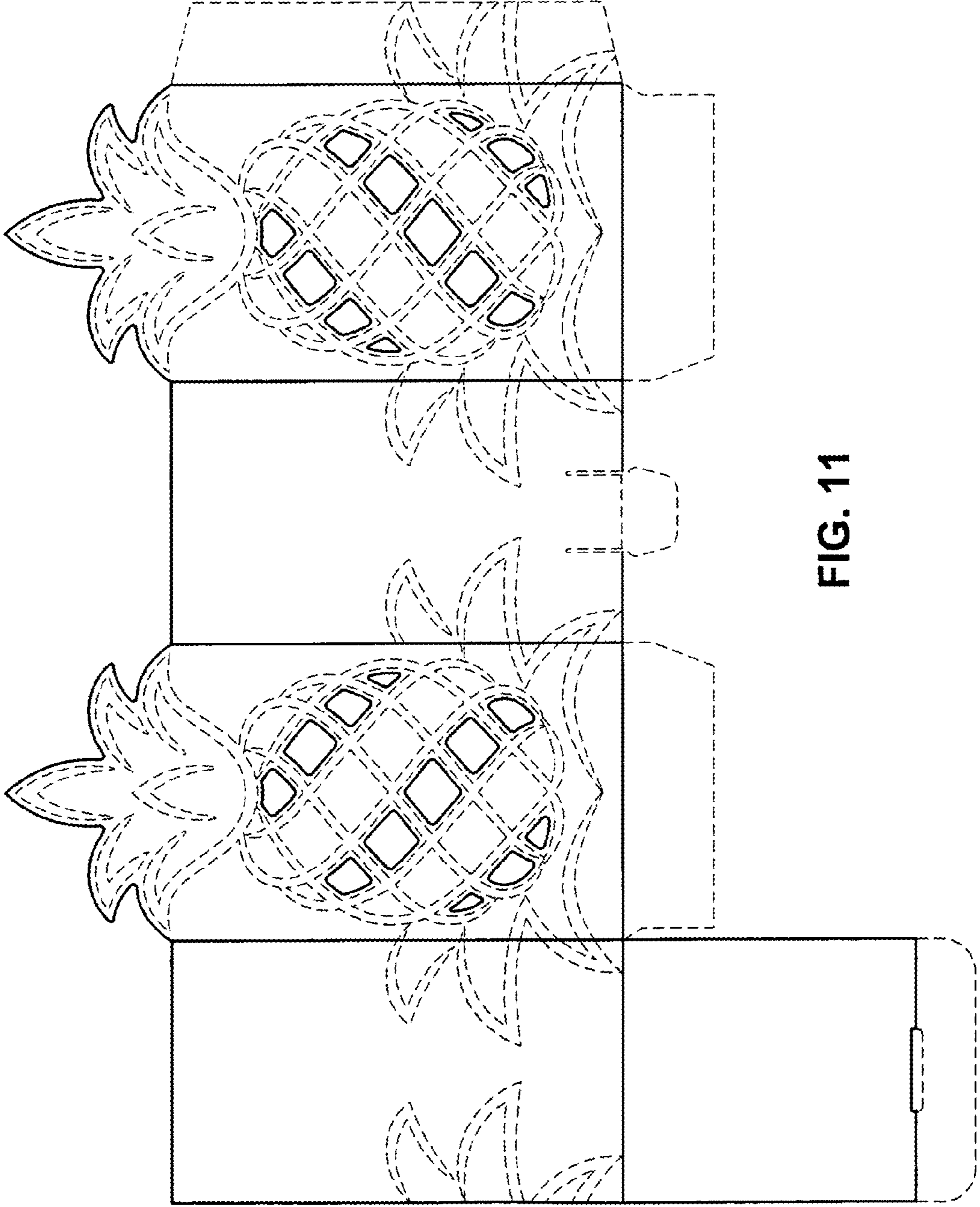

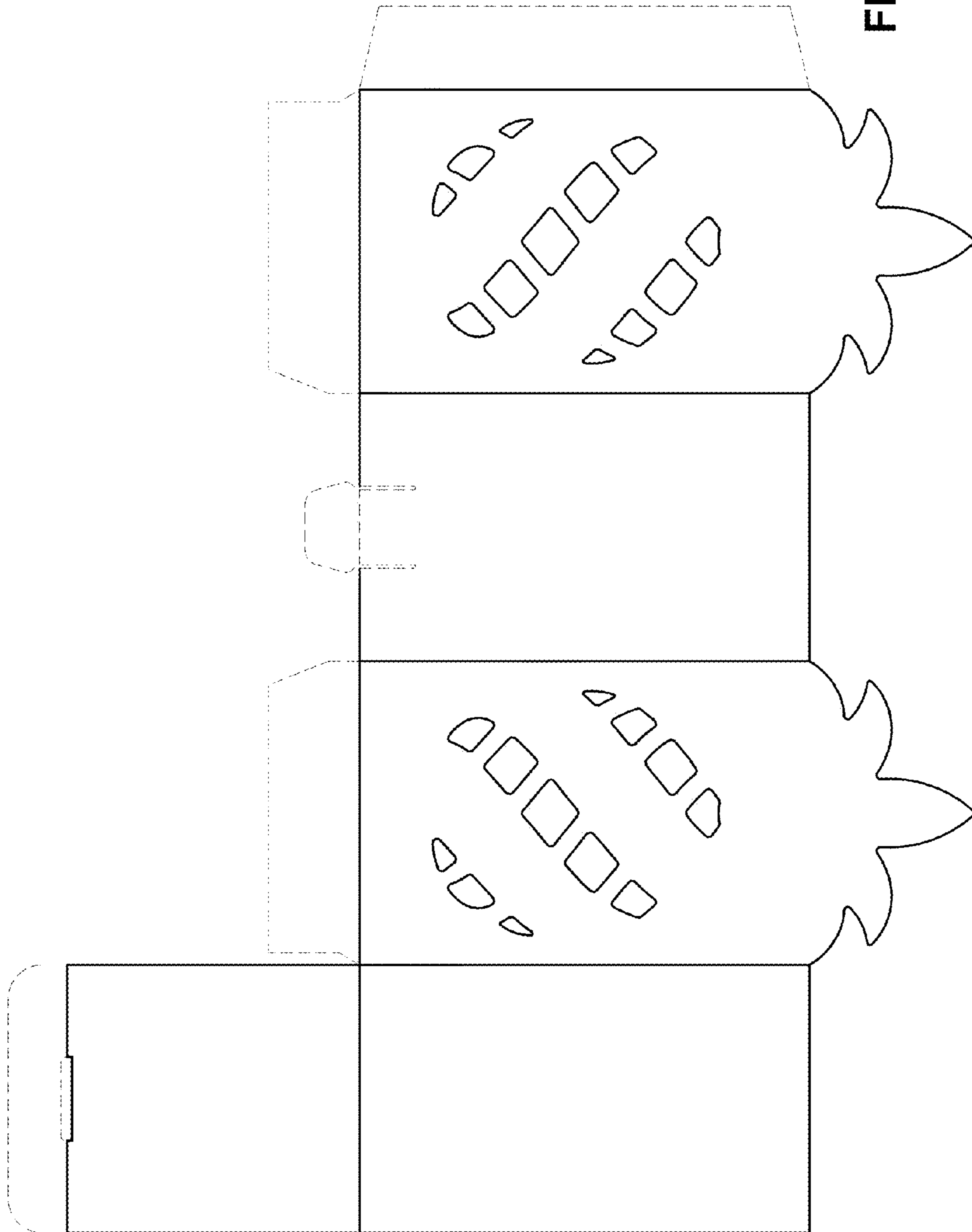
