DESCRIPTION

FIG. 13 is a front side view thereof;

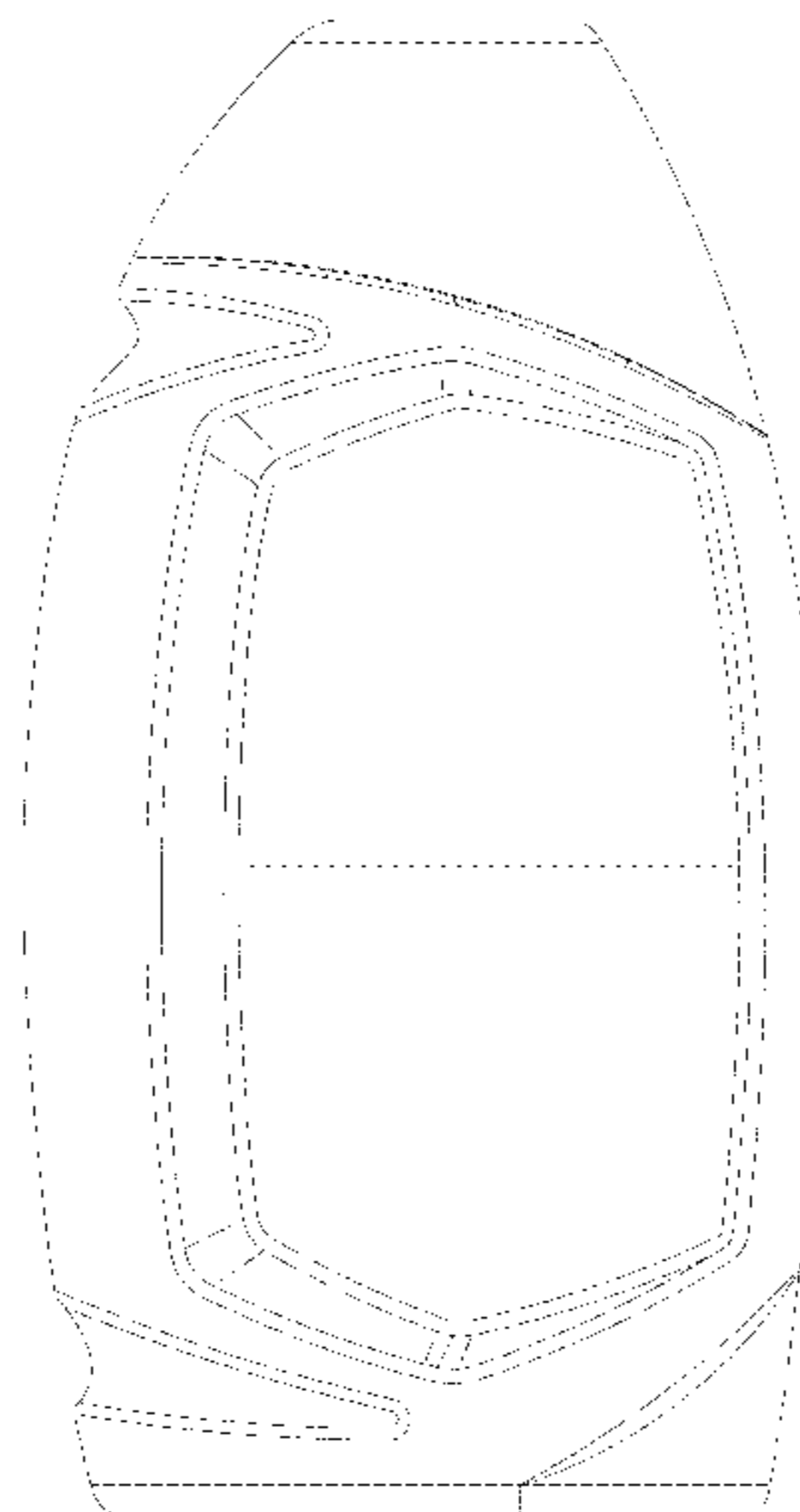
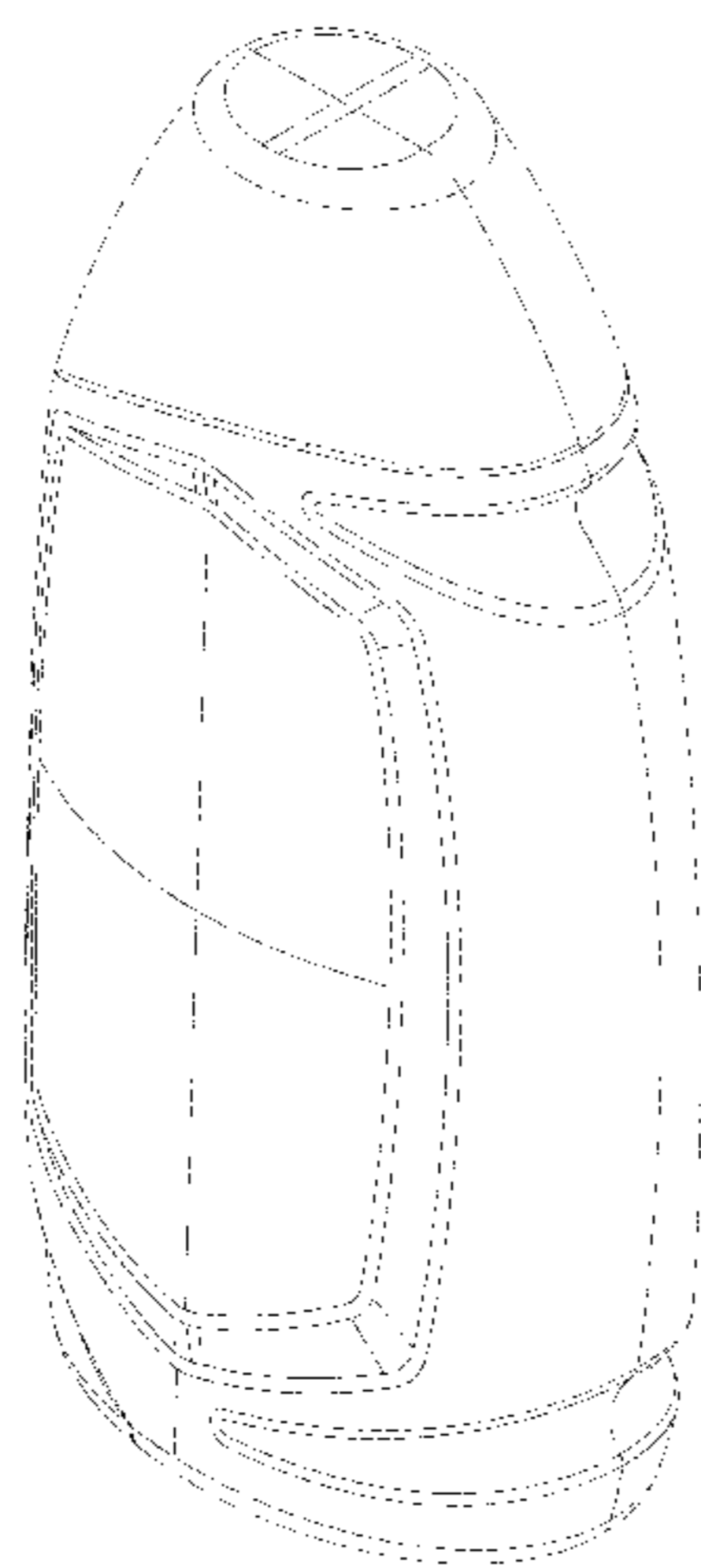
FIG. 14 is a rear side view thereof;

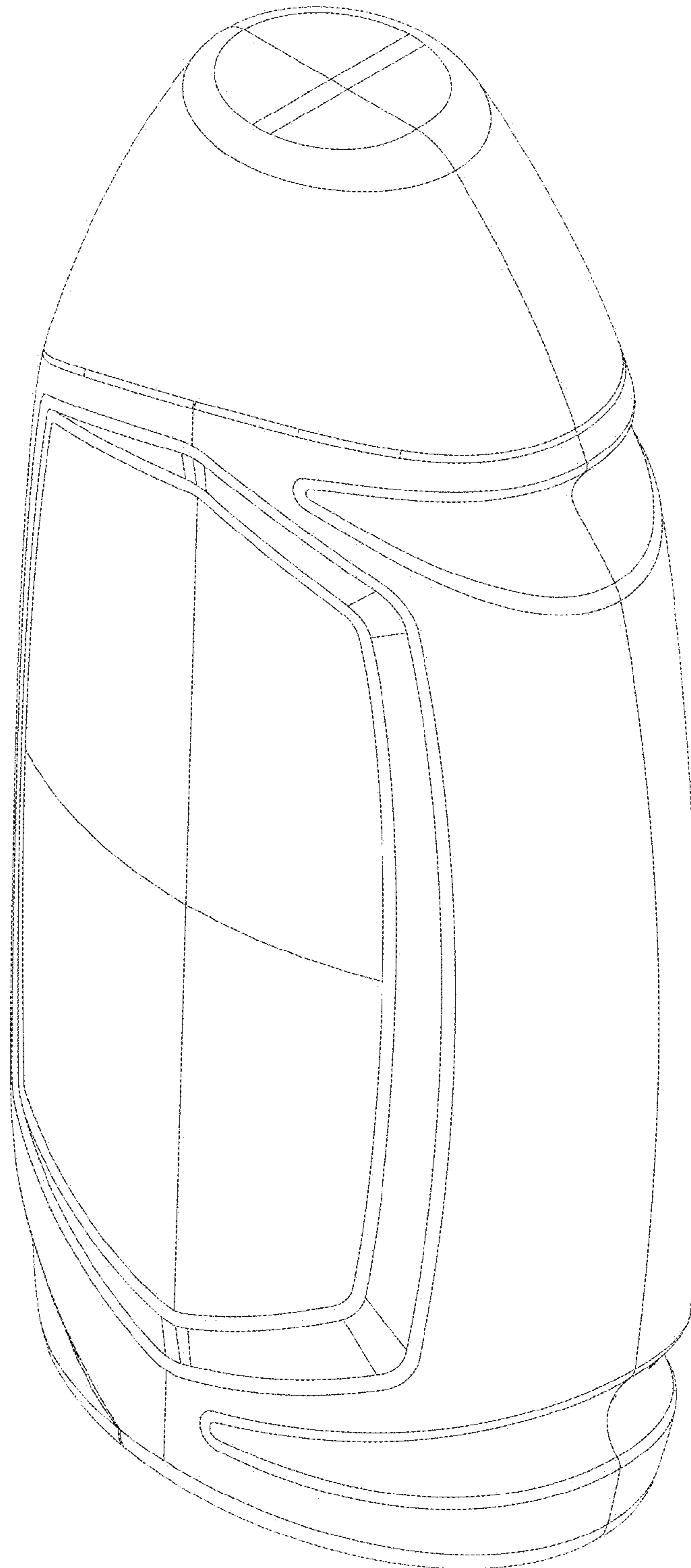

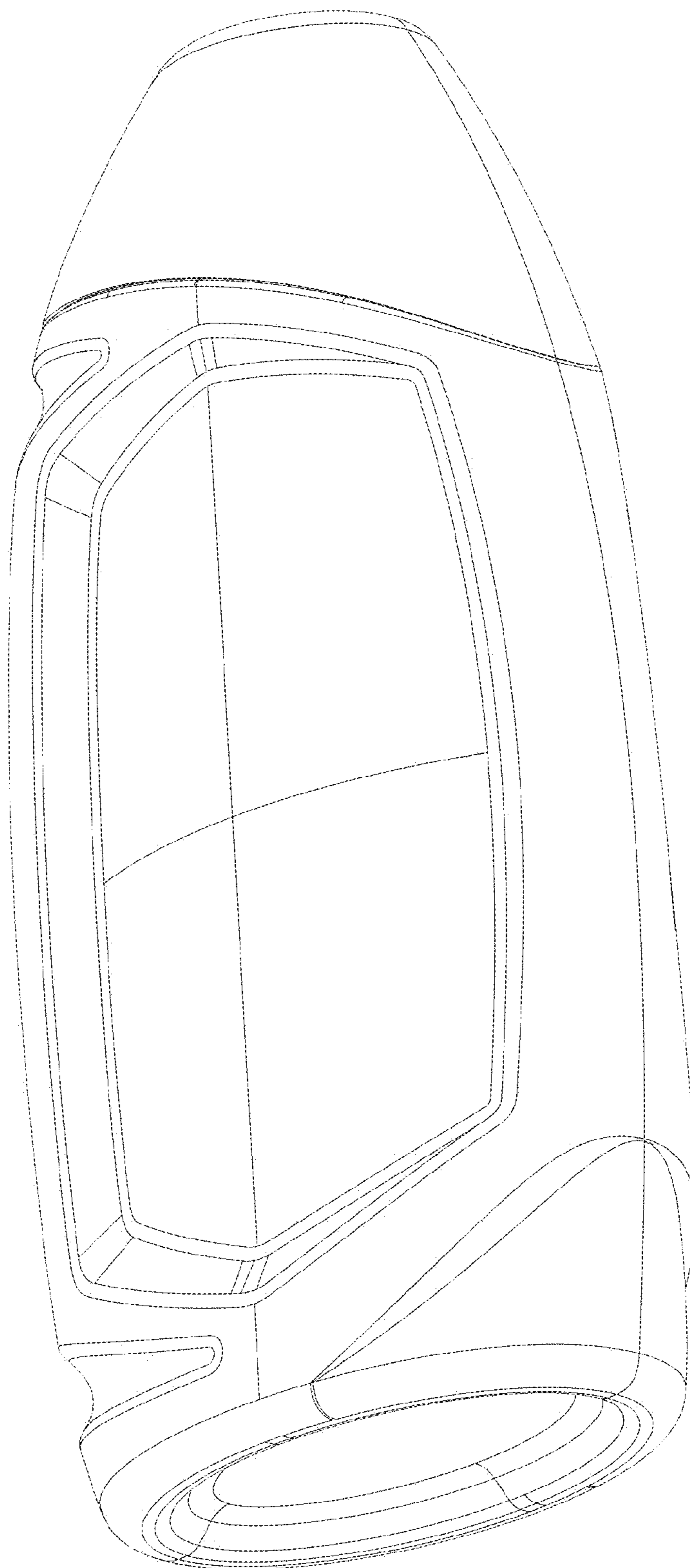

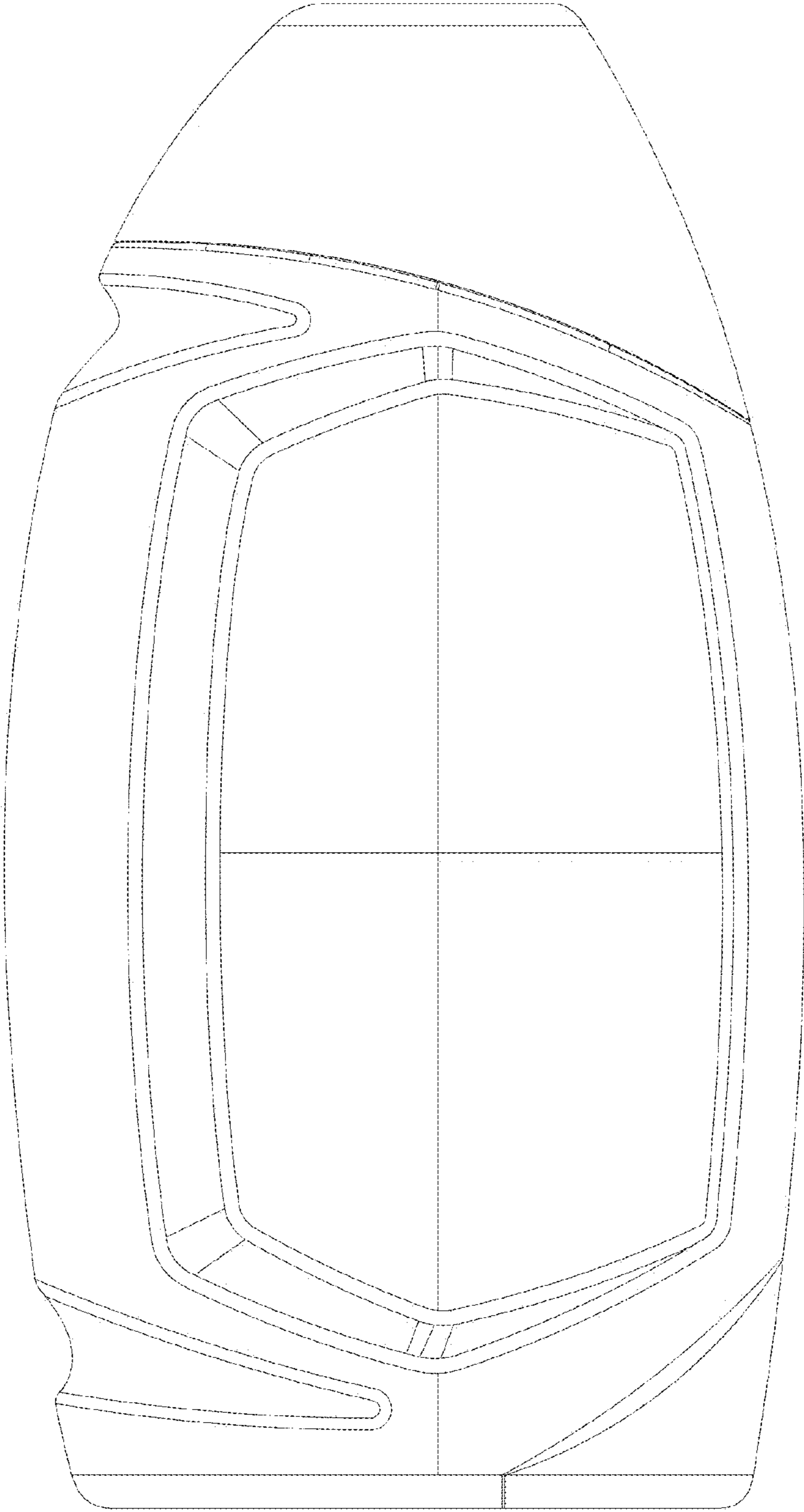

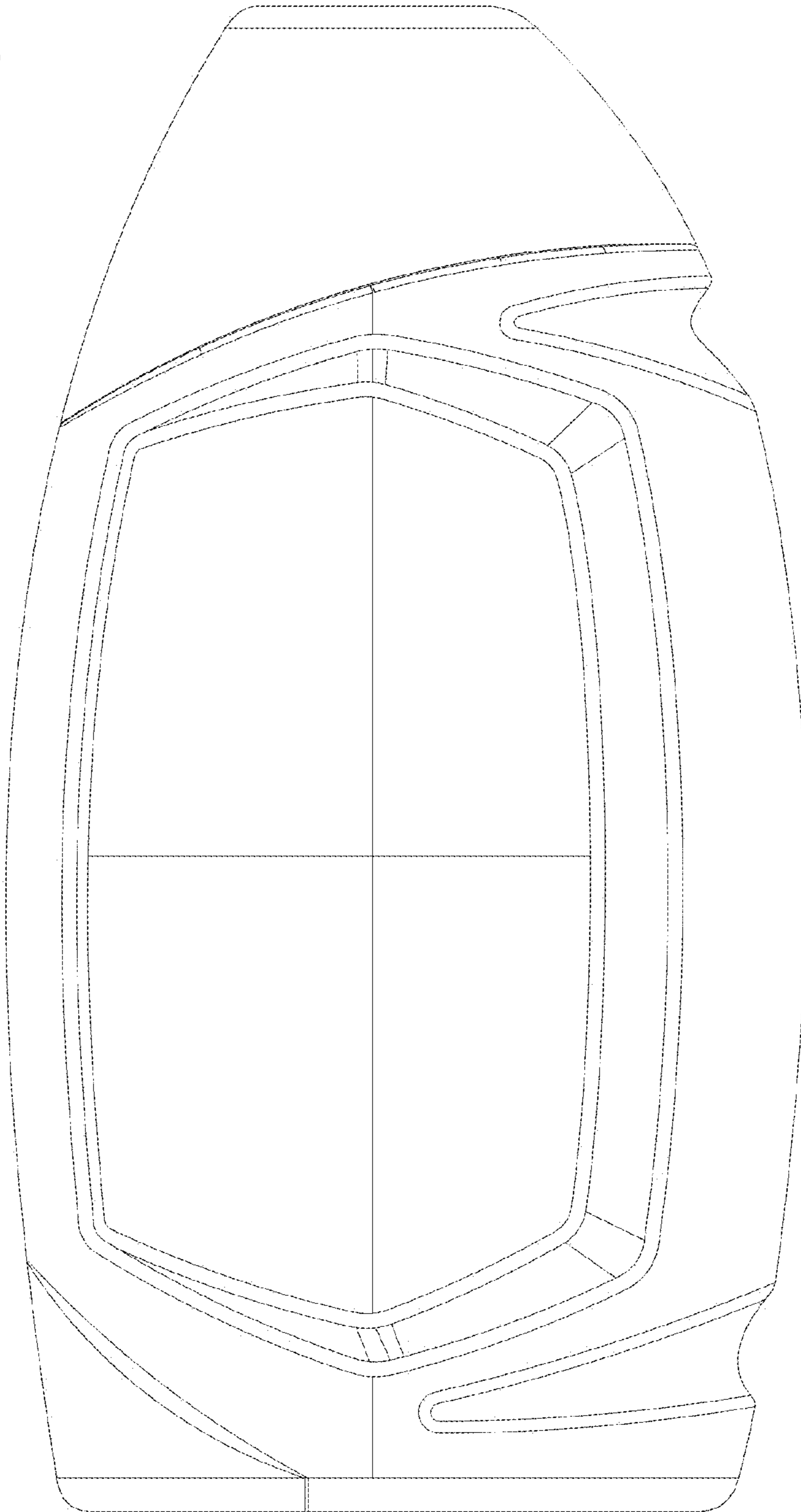

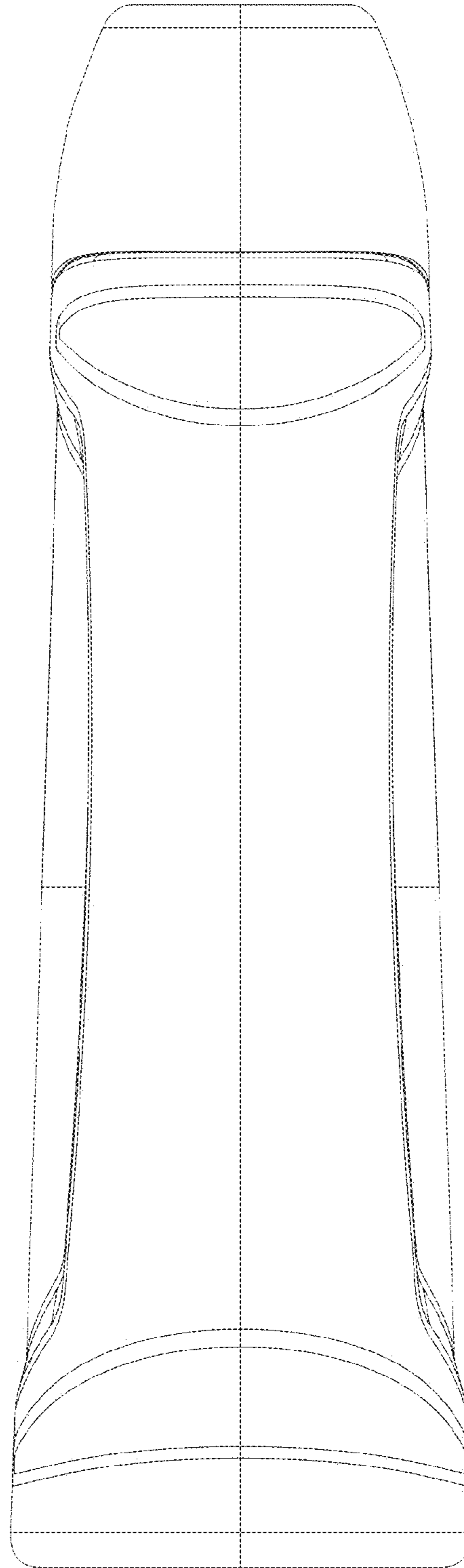

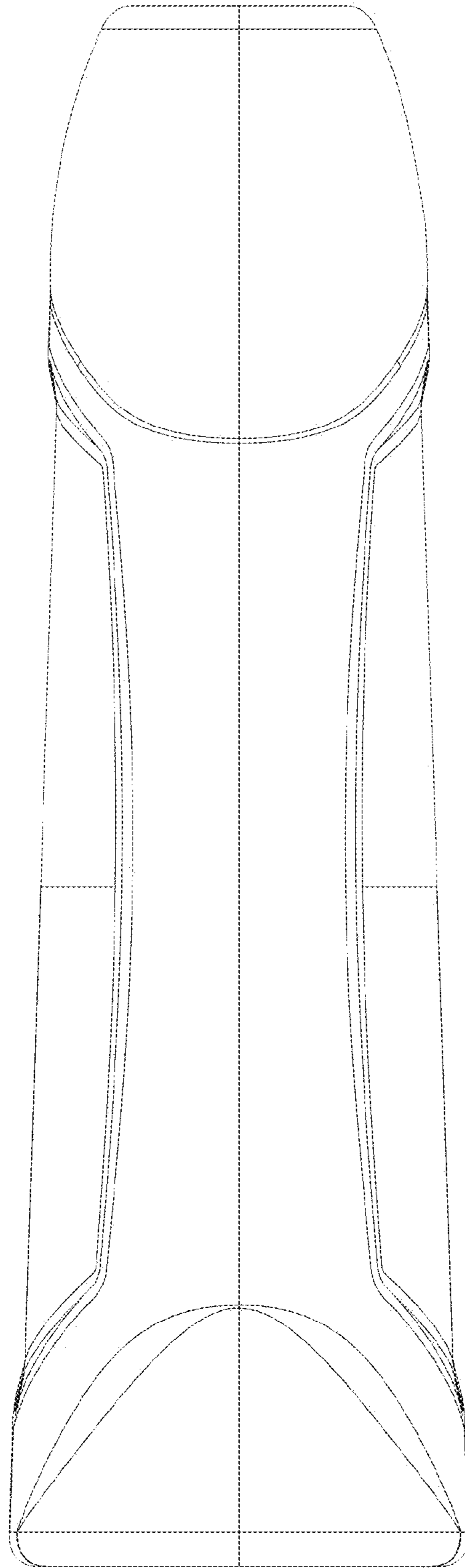

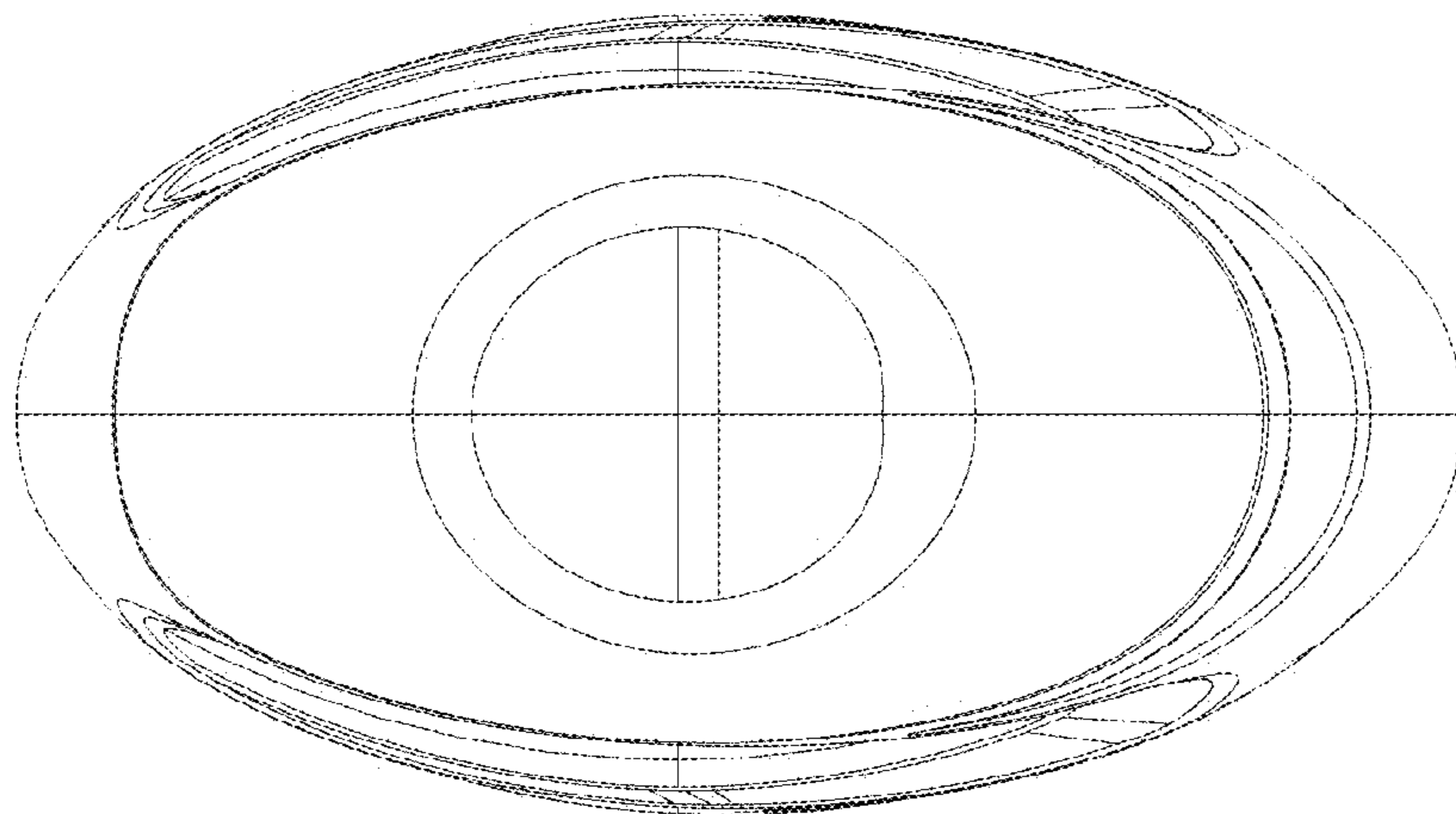

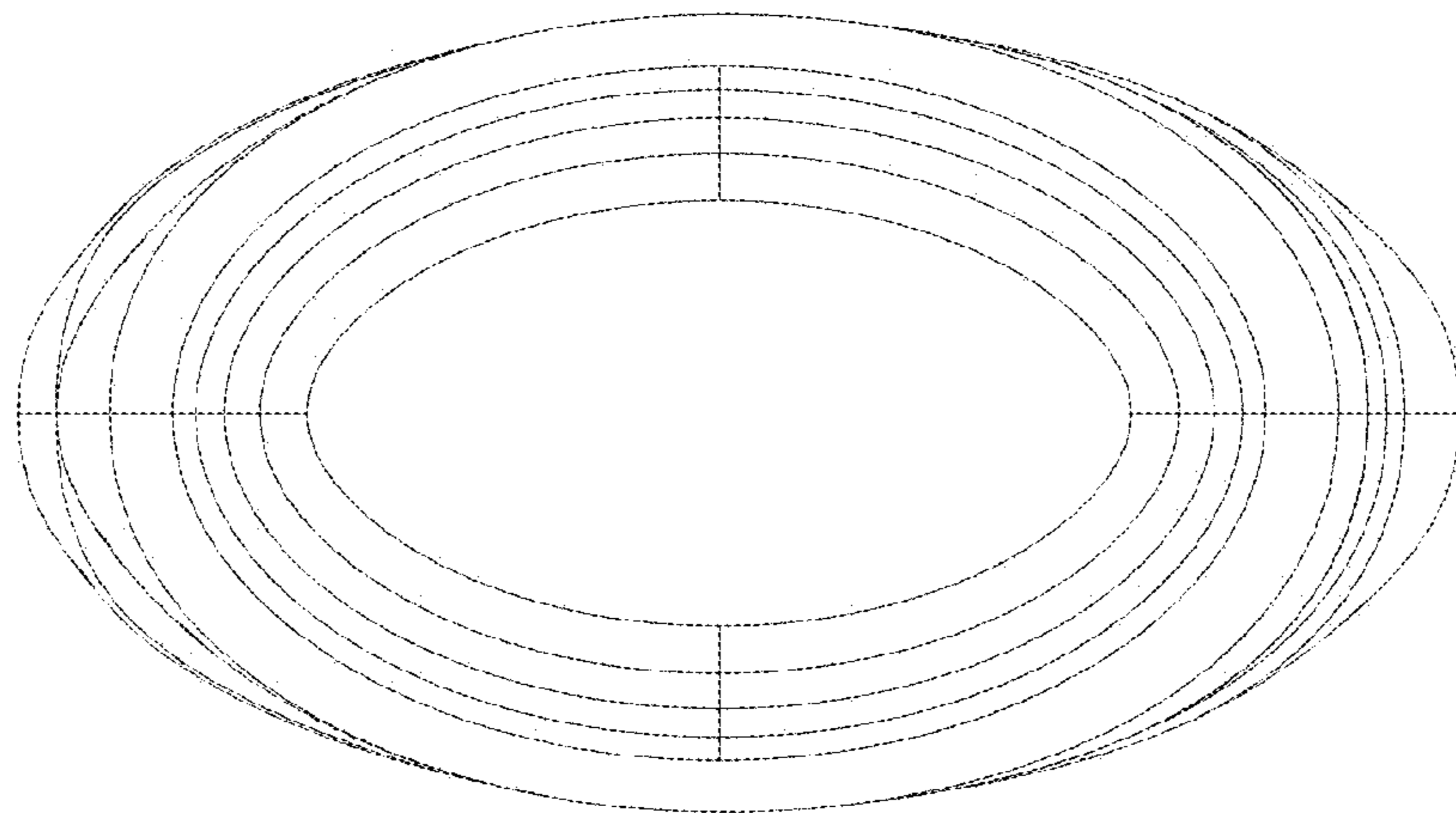

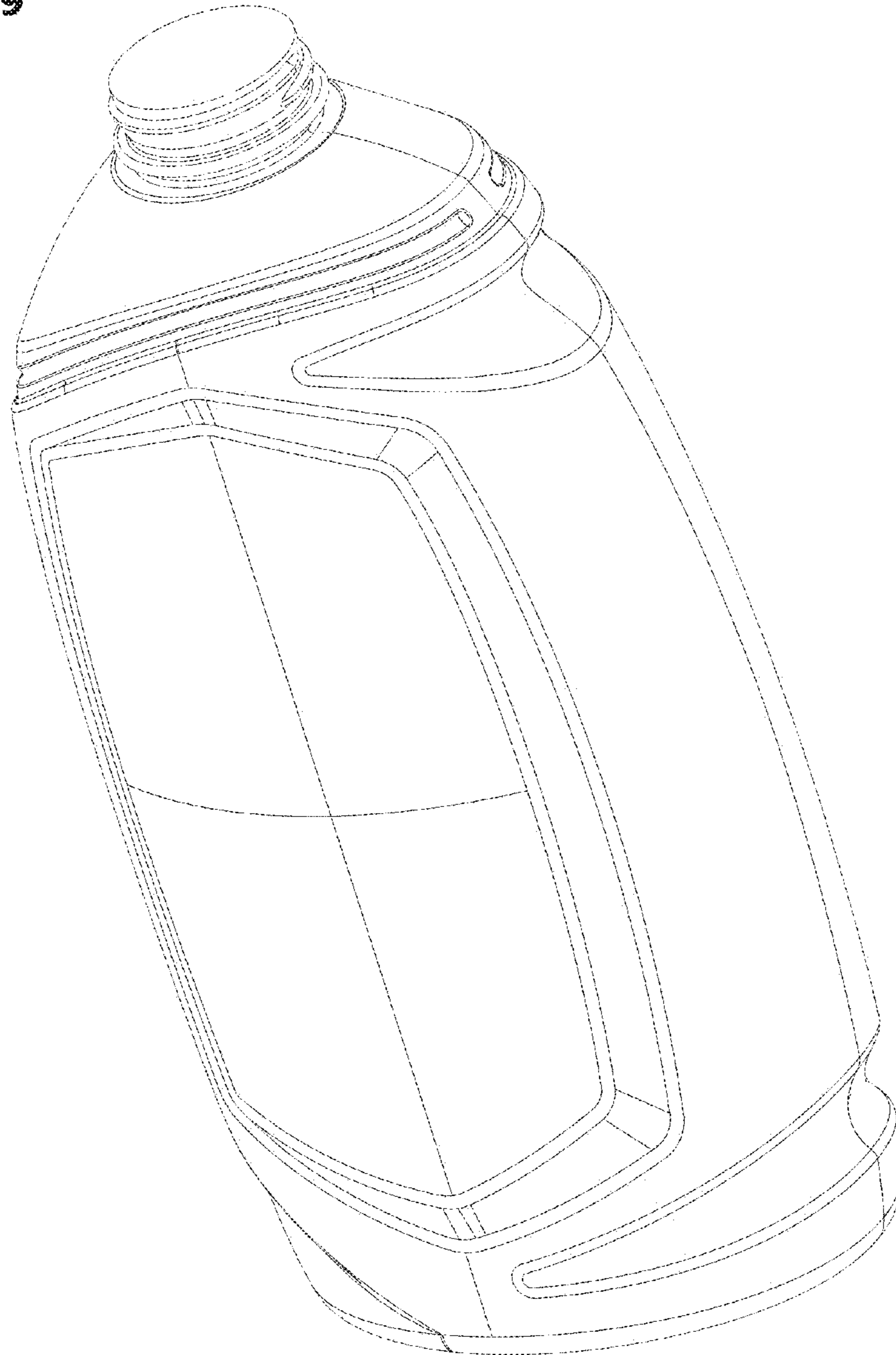

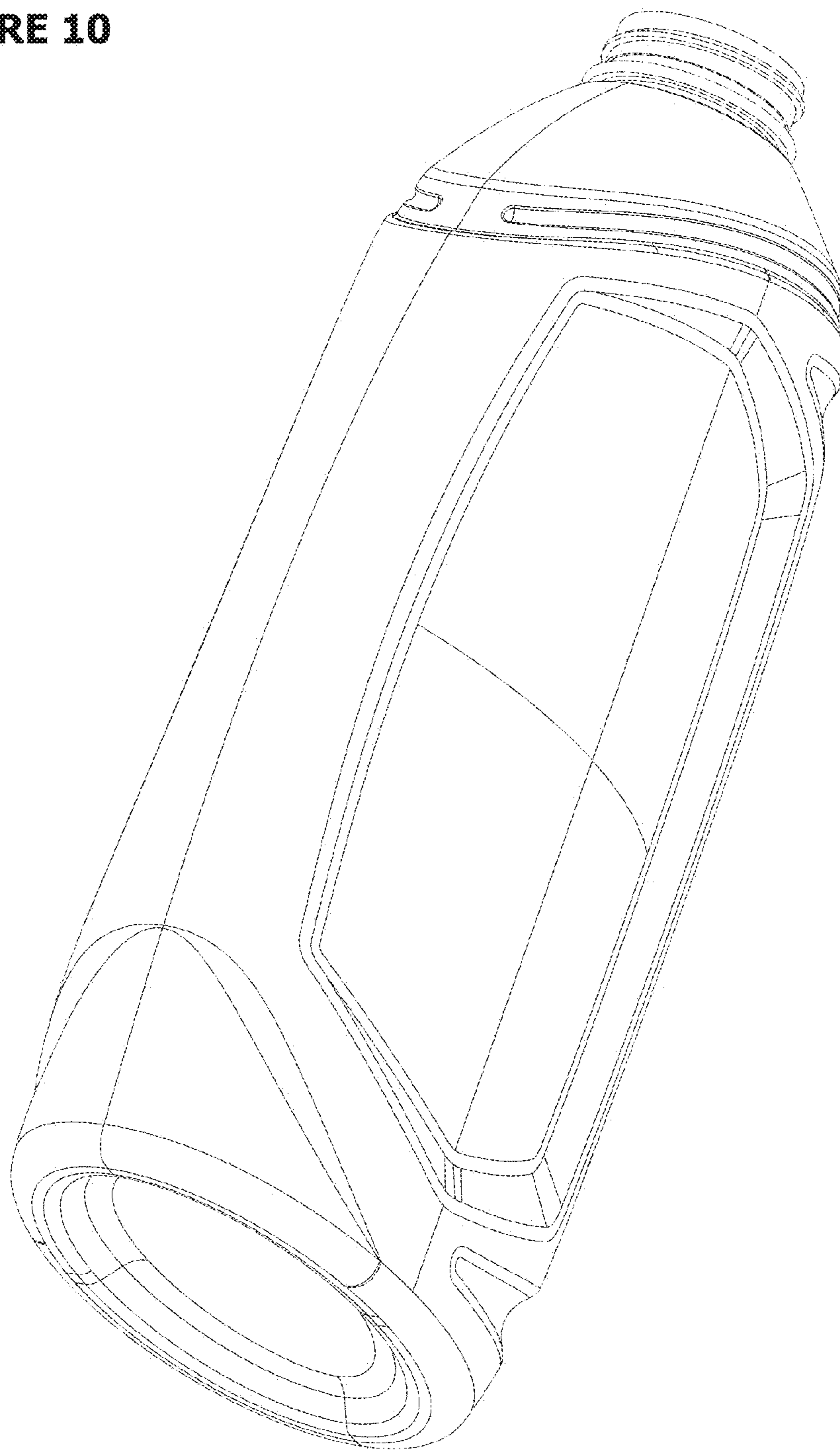

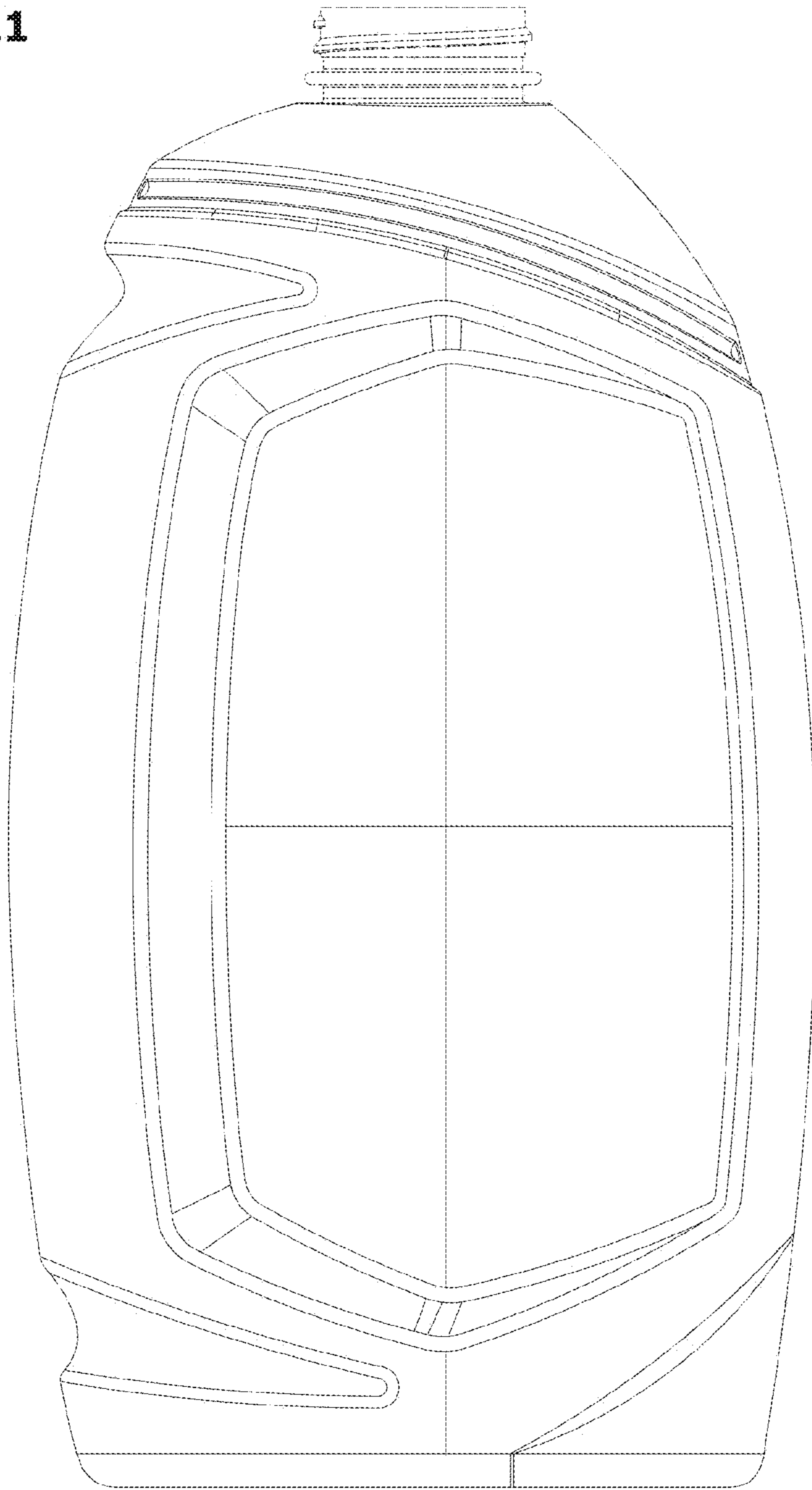

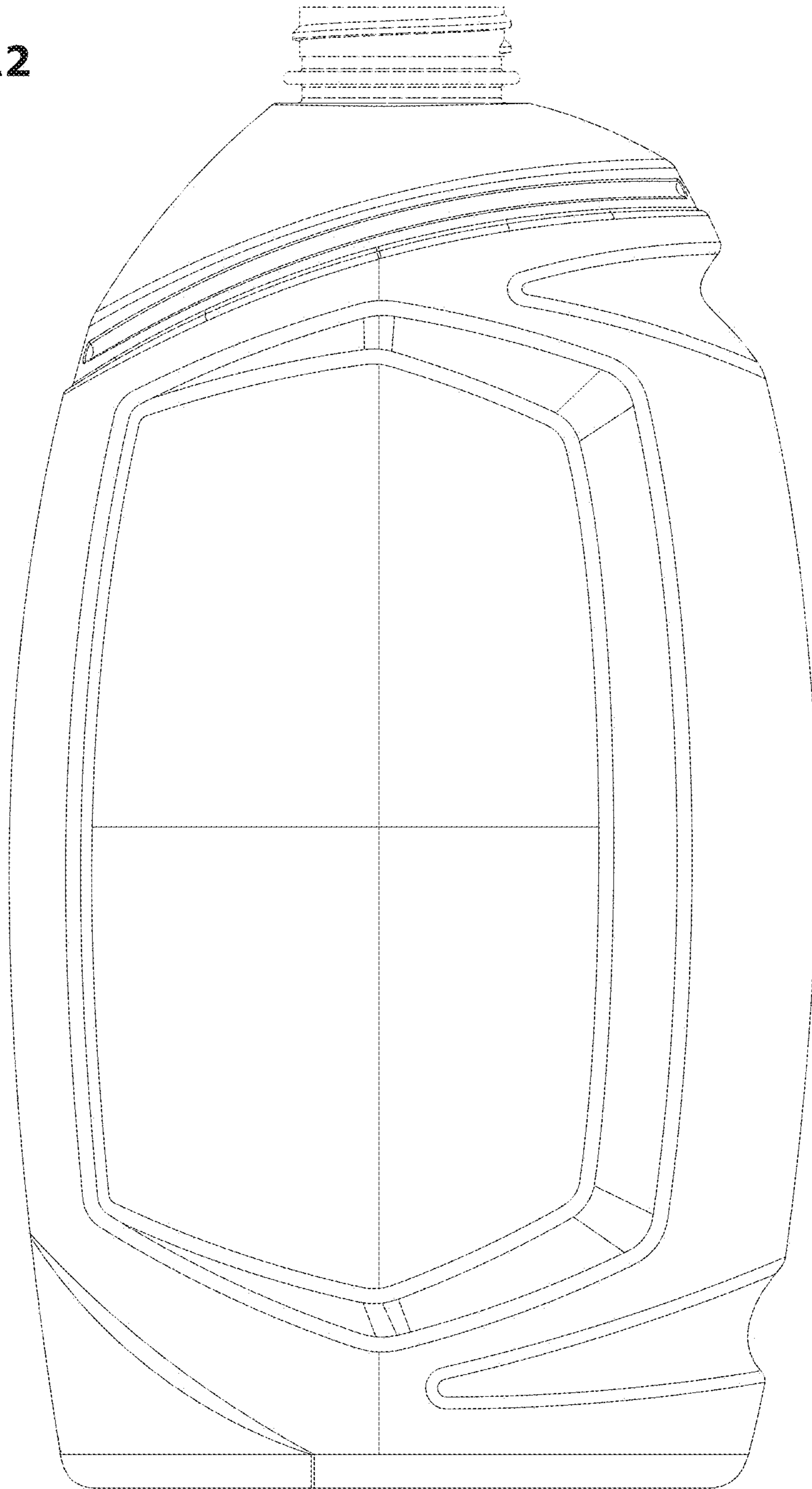

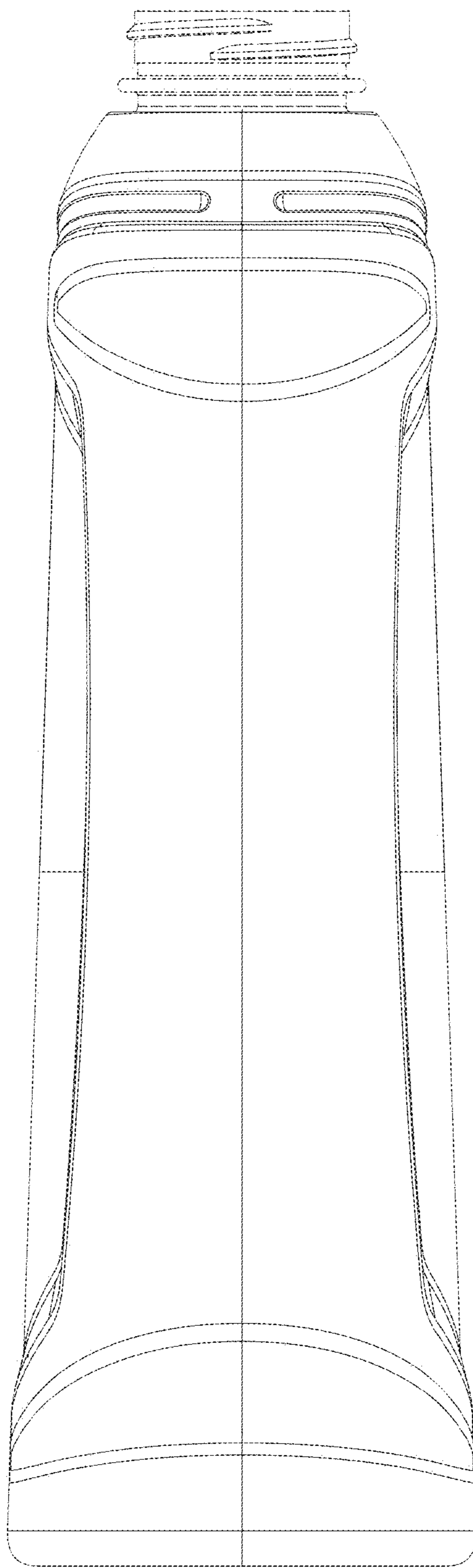

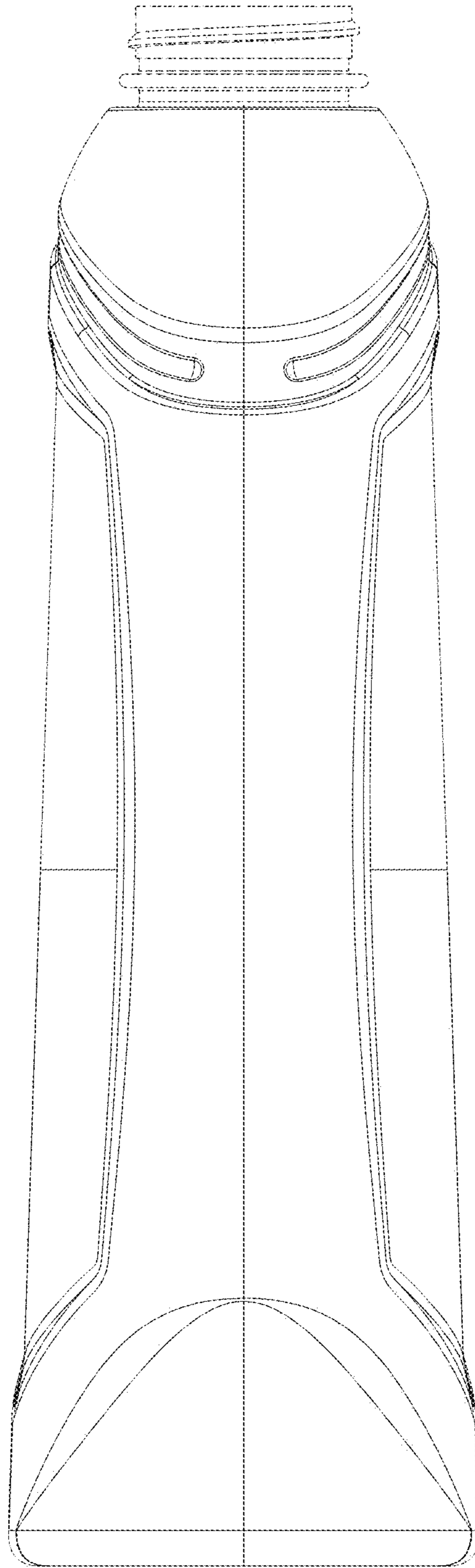

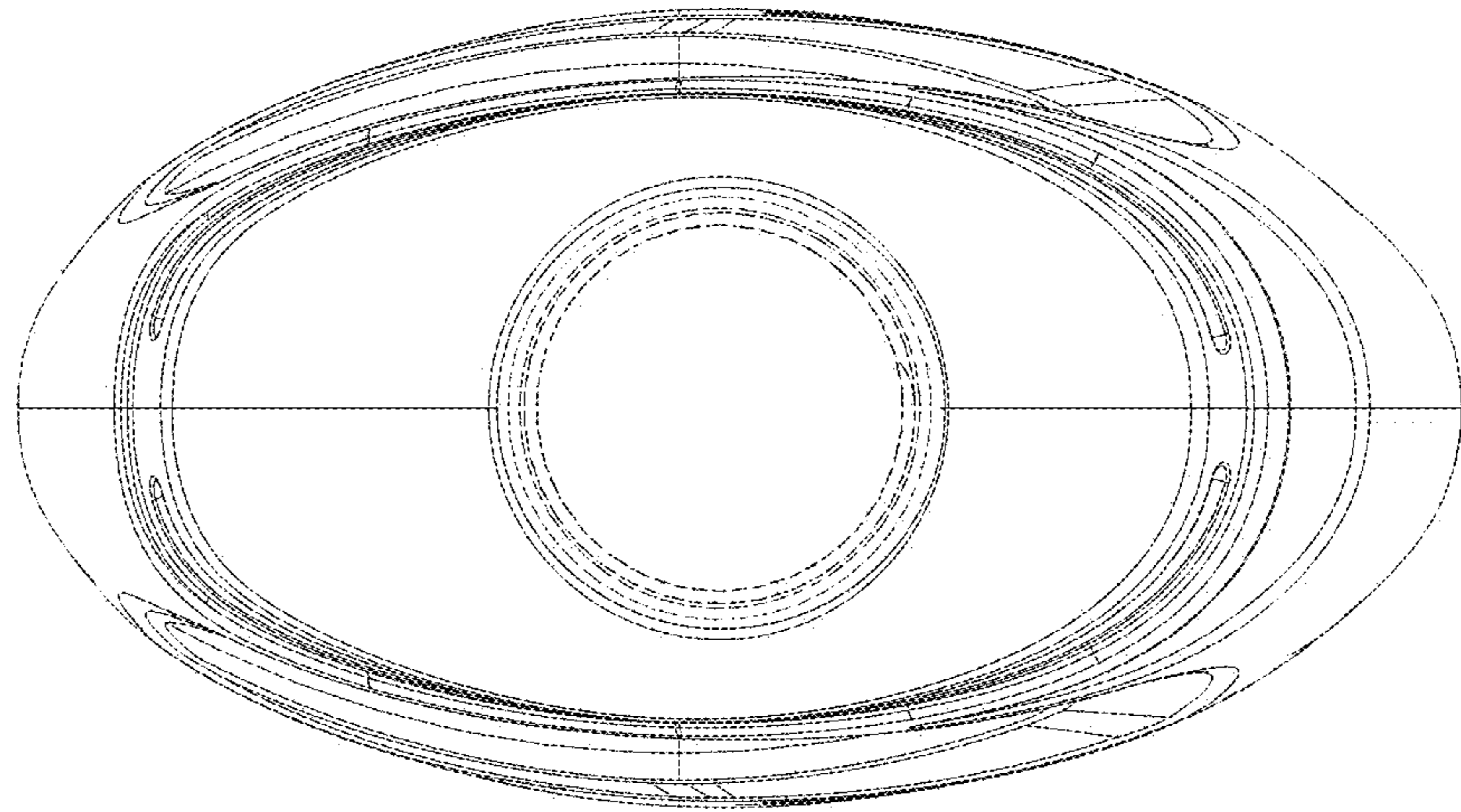
