DESCRIPTION

FIG. 1 is a perspective view of a pack for pasta, showing my new design;

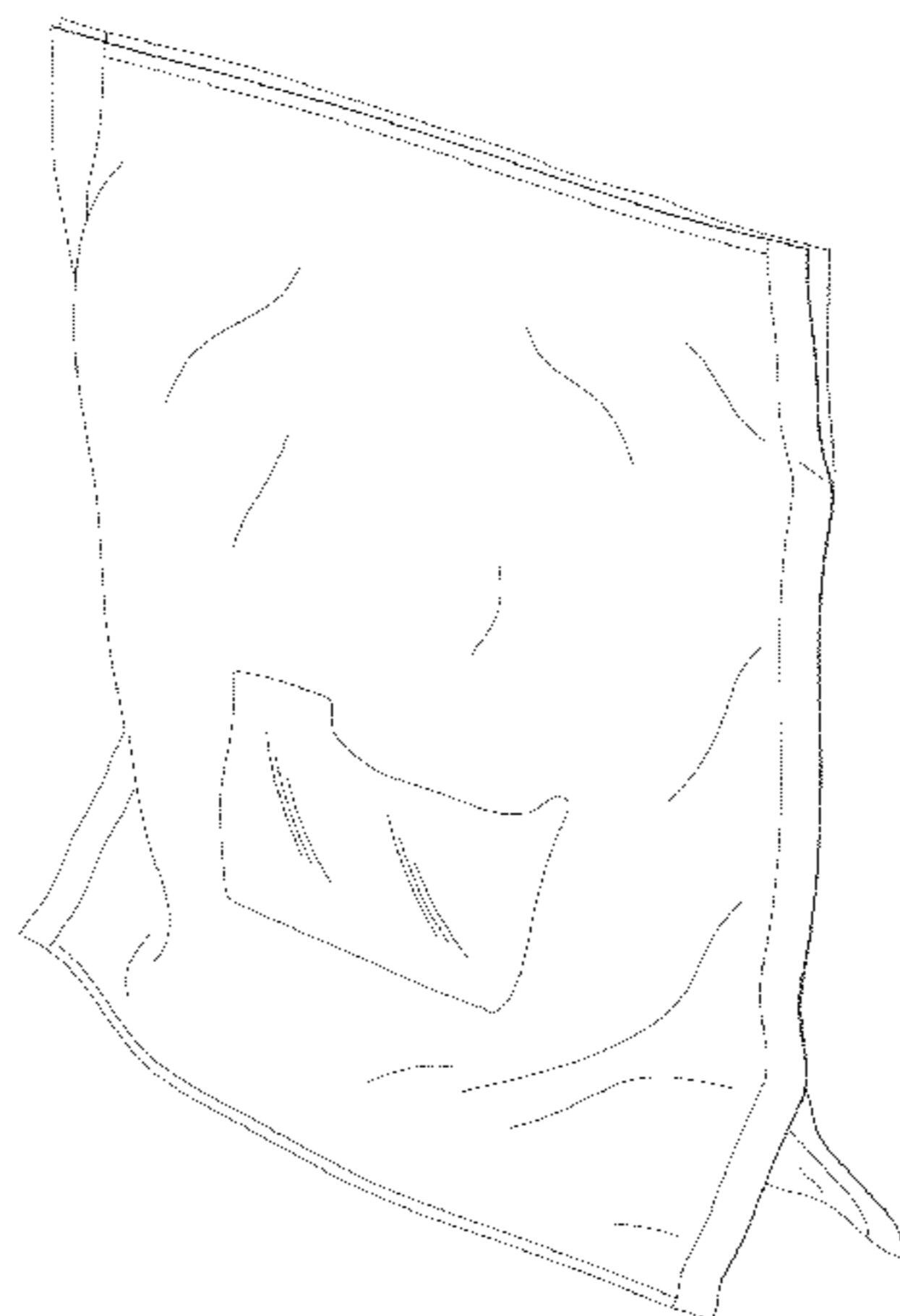

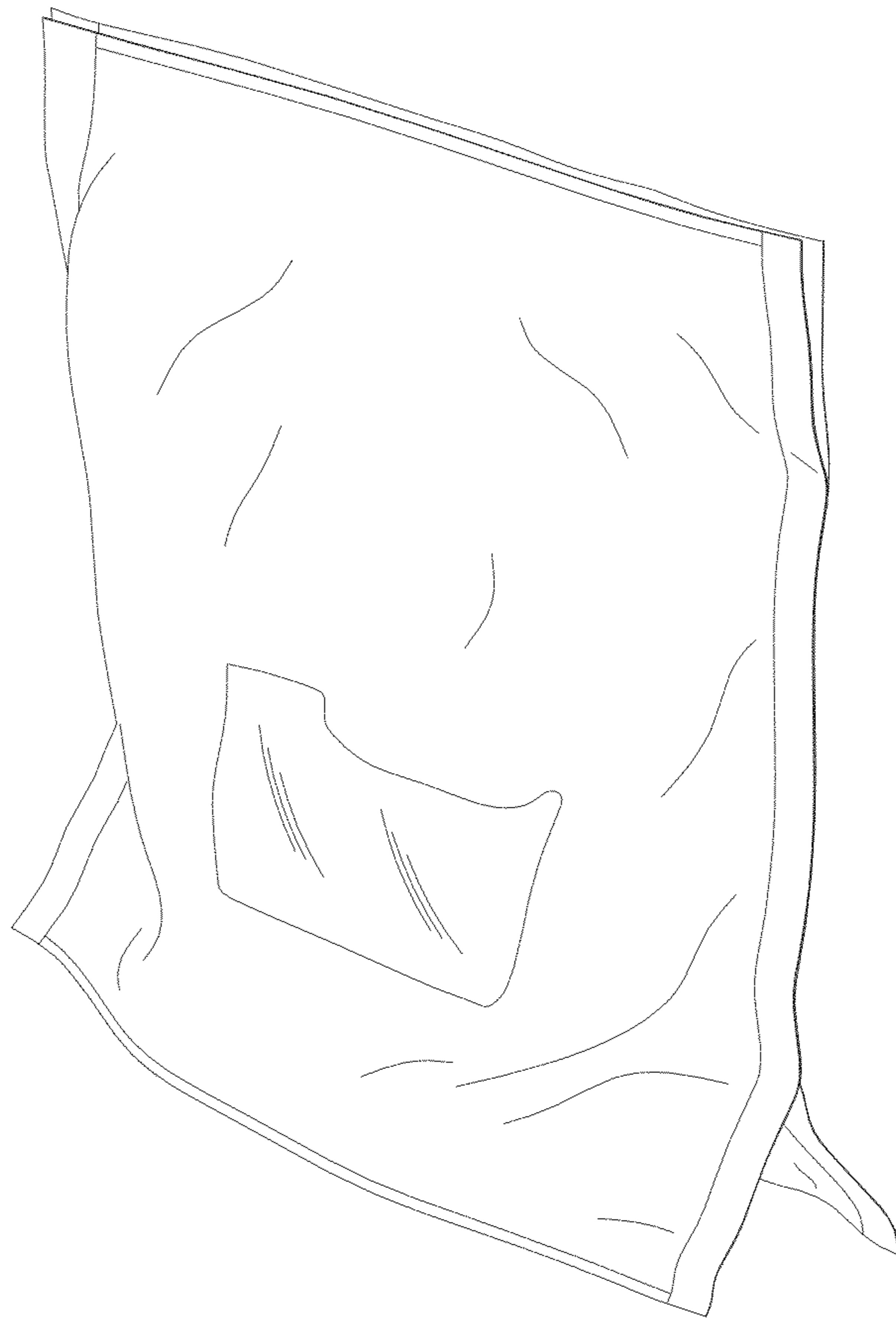

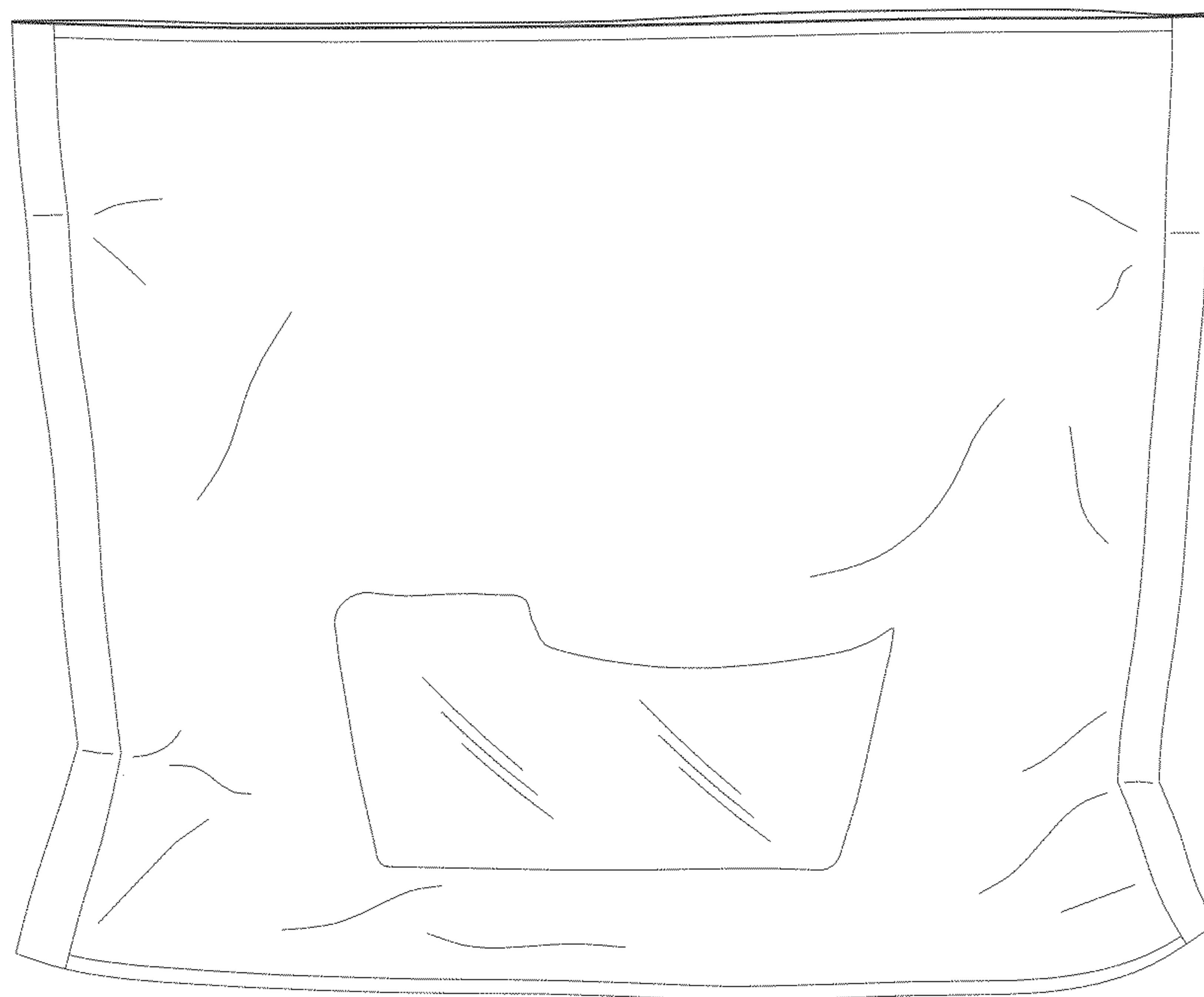

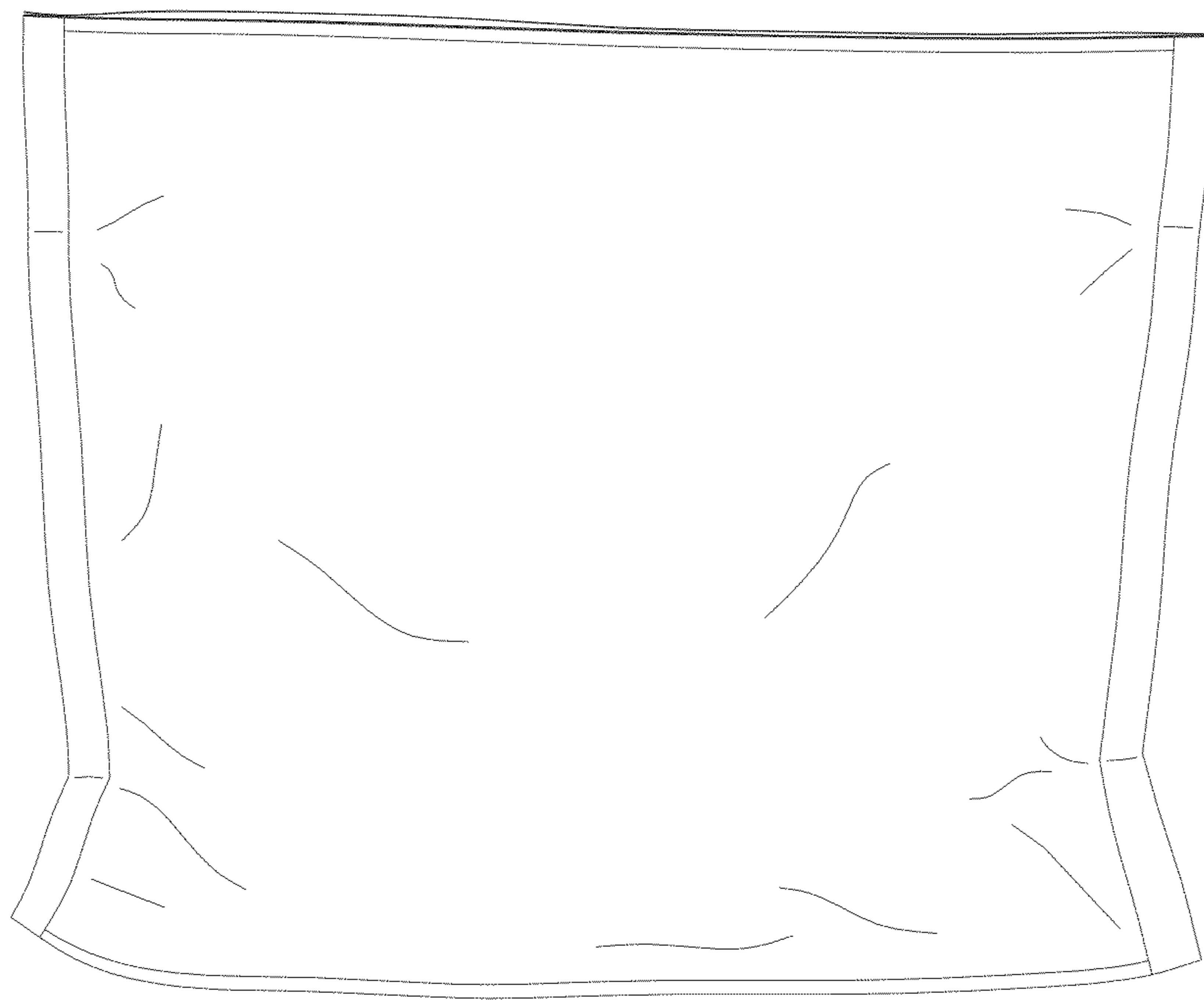

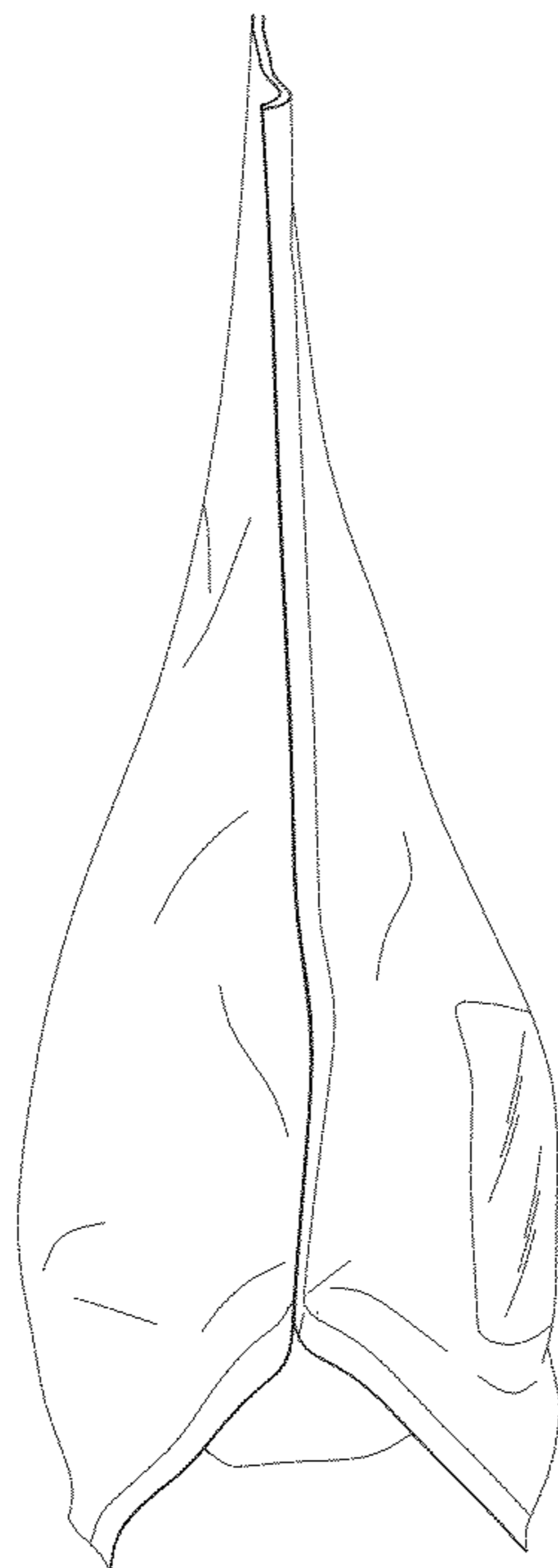

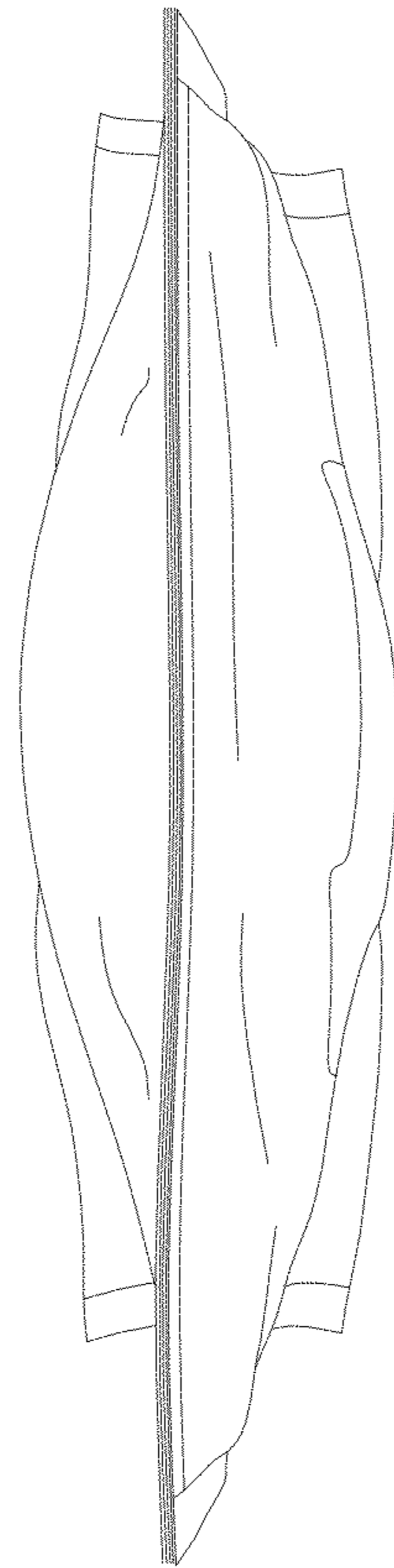
