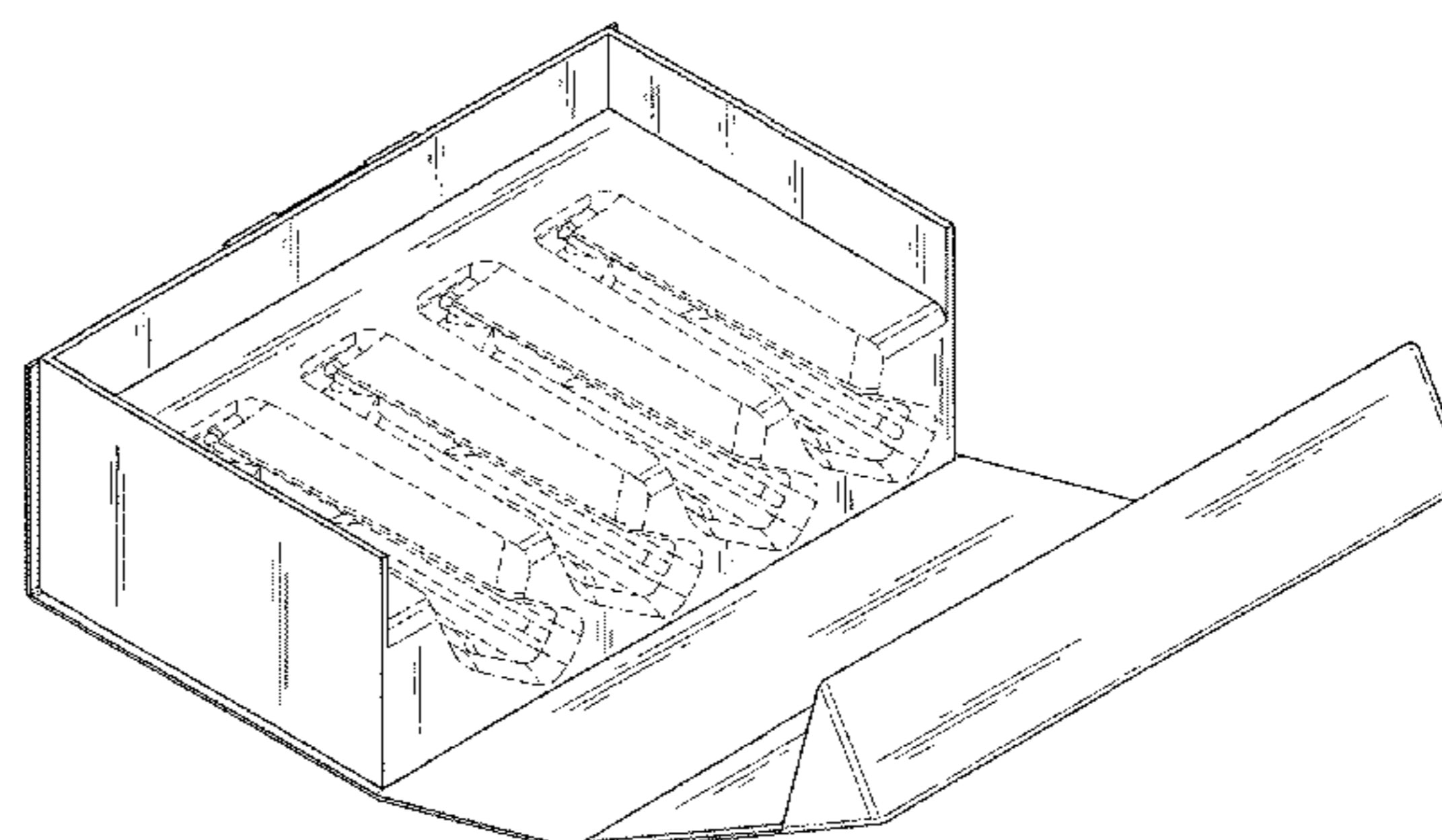
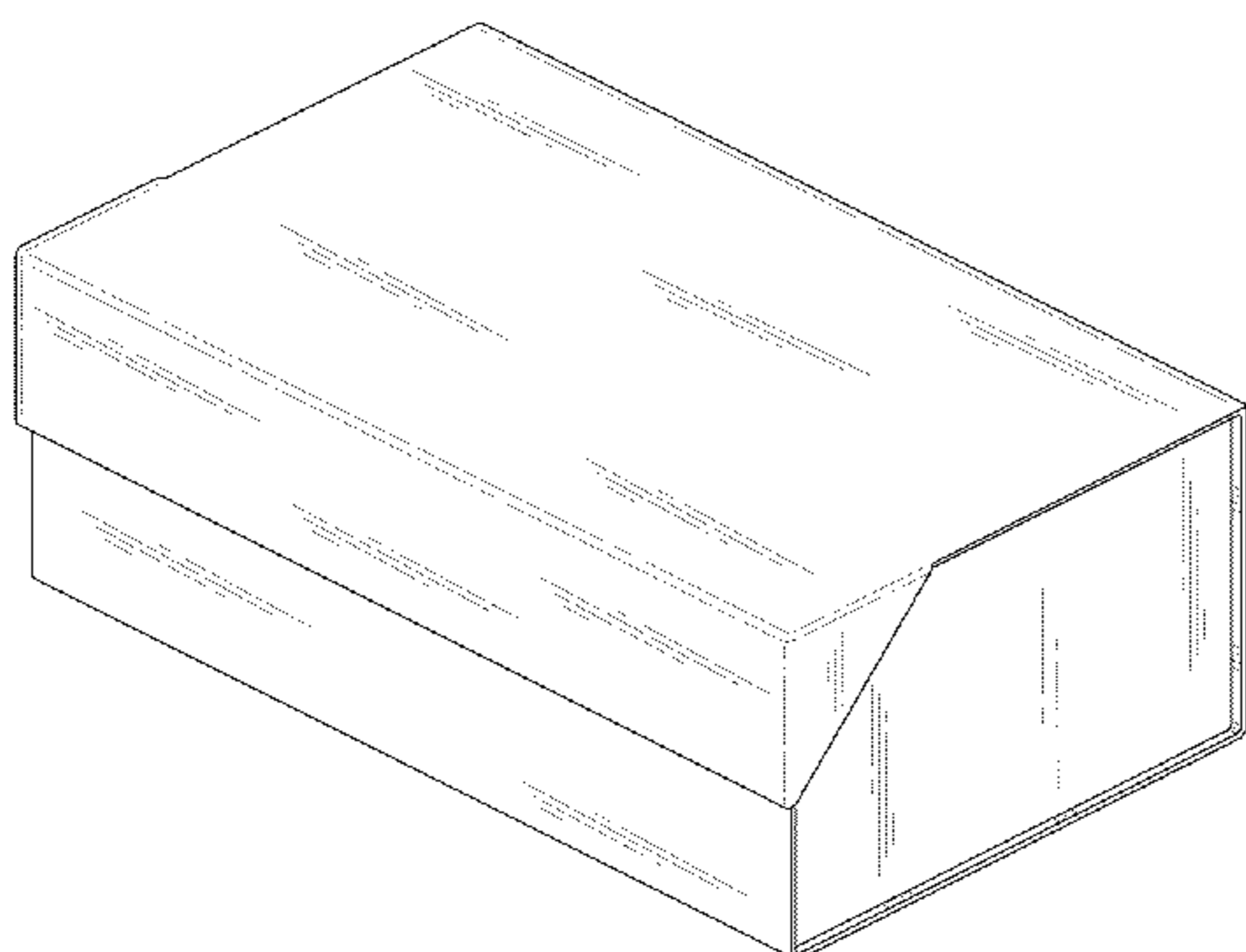
(57) **CLAIM**

We claim the ornamental design for a cartridge dispenser, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of the cartridge dispenser of the present invention in its closed configuration.
FIG. 2 is a front elevation of the cartridge dispenser of the present invention in its closed configuration.
FIG. 3 is a rear elevation of the cartridge dispenser of the present invention in its closed configuration.
FIG. 4 is a right side elevation of the cartridge dispenser of the present invention in its closed configuration.
FIG. 5 is a left side elevation of the cartridge dispenser of the present invention in its closed configuration.
FIG. 6 is a top plan view of the cartridge dispenser of the present invention in its closed configuration.
FIG. 7 is a bottom plan view of the cartridge dispenser of the present invention in its closed configuration.
FIG. 8 is an isometric view of the cartridge dispenser of the present invention in its open configuration.
FIG. 9 is a front elevation of the cartridge dispenser of the present invention in its open configuration.
FIG. 10 is a rear elevation of the cartridge dispenser of the present invention in its open configuration.
FIG. 11 is a right side elevation of the cartridge dispenser of the present invention in its open configuration.
FIG. 12 is a left side elevation of the cartridge dispenser of the present invention in its open configuration.
FIG. 13 is a top plan view of the cartridge dispenser of the present invention in its open configuration; and,
FIG. 14 is a bottom plan view of the cartridge dispenser of the present invention in its open configuration.
The broken lines in FIGS. 8 and 13 depict parts of the cartridge dispenser that form no part of the claimed design.

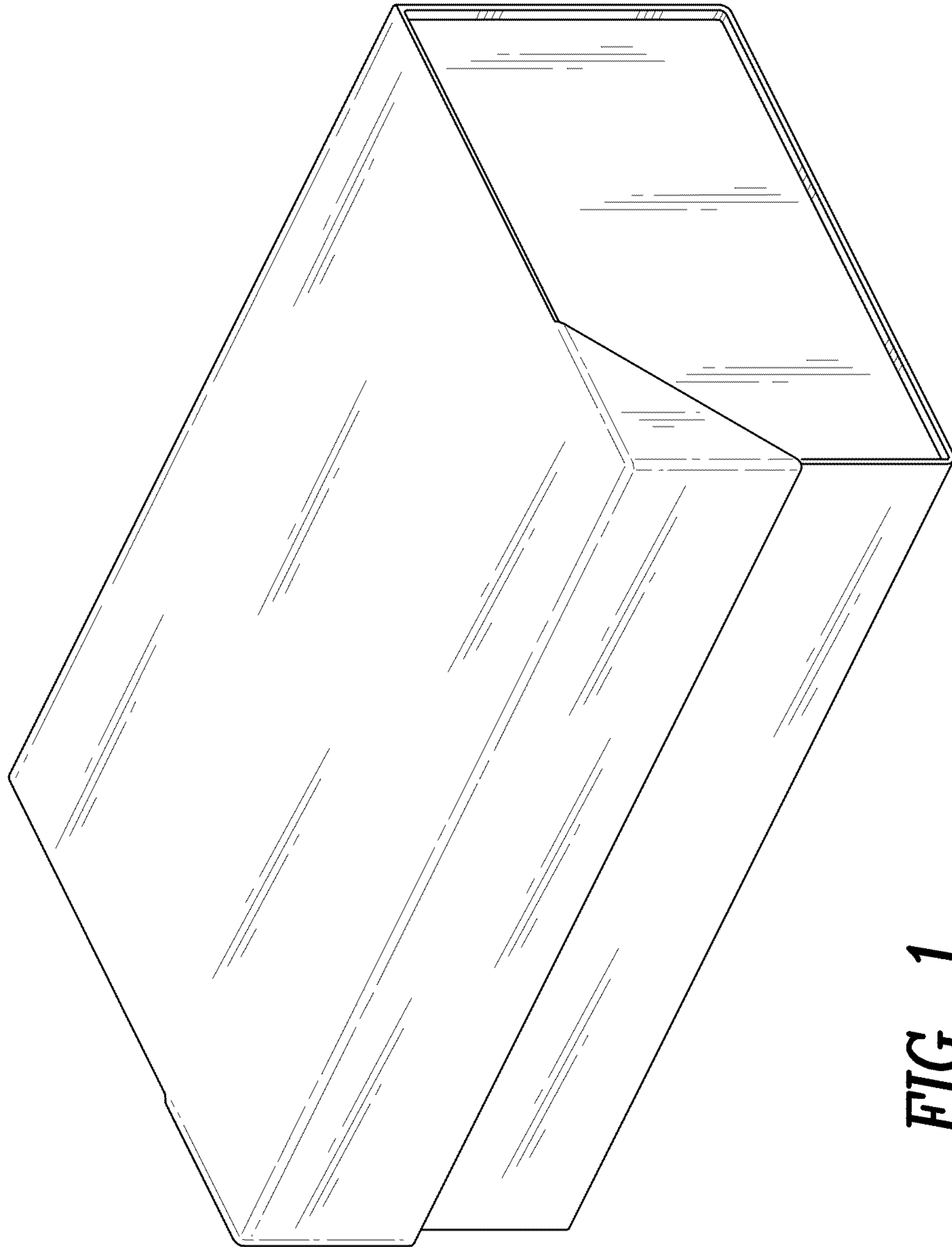

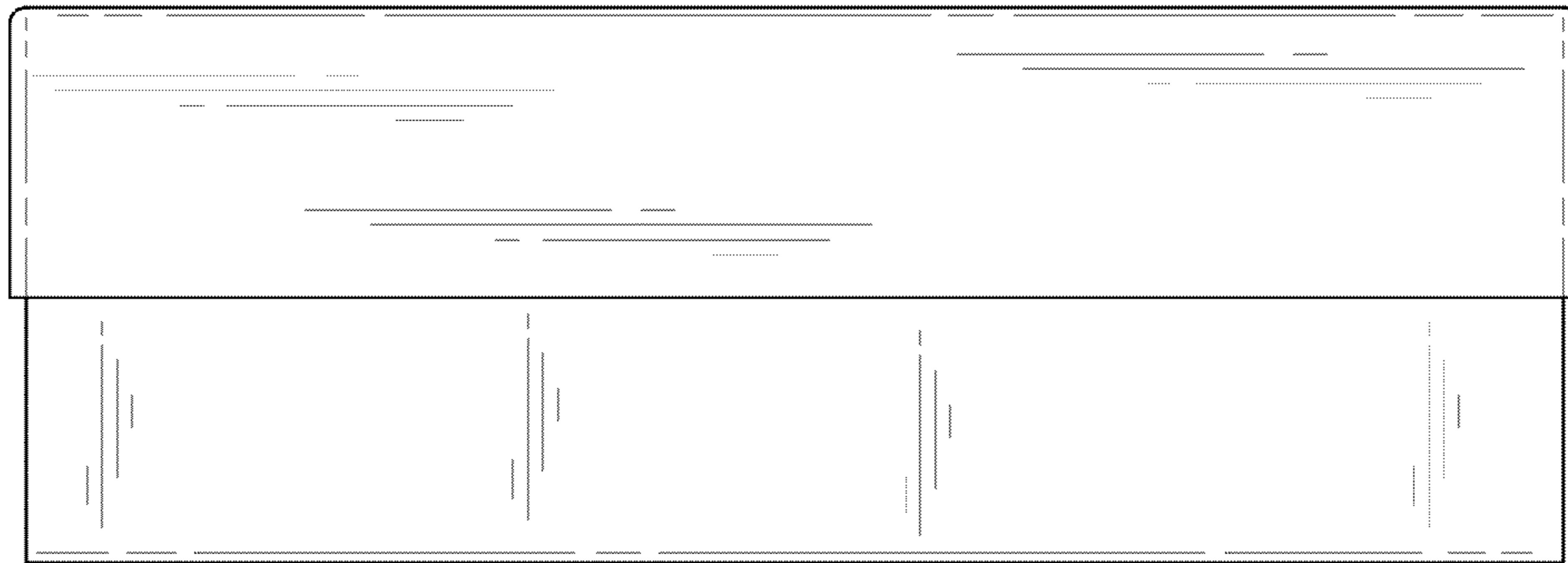

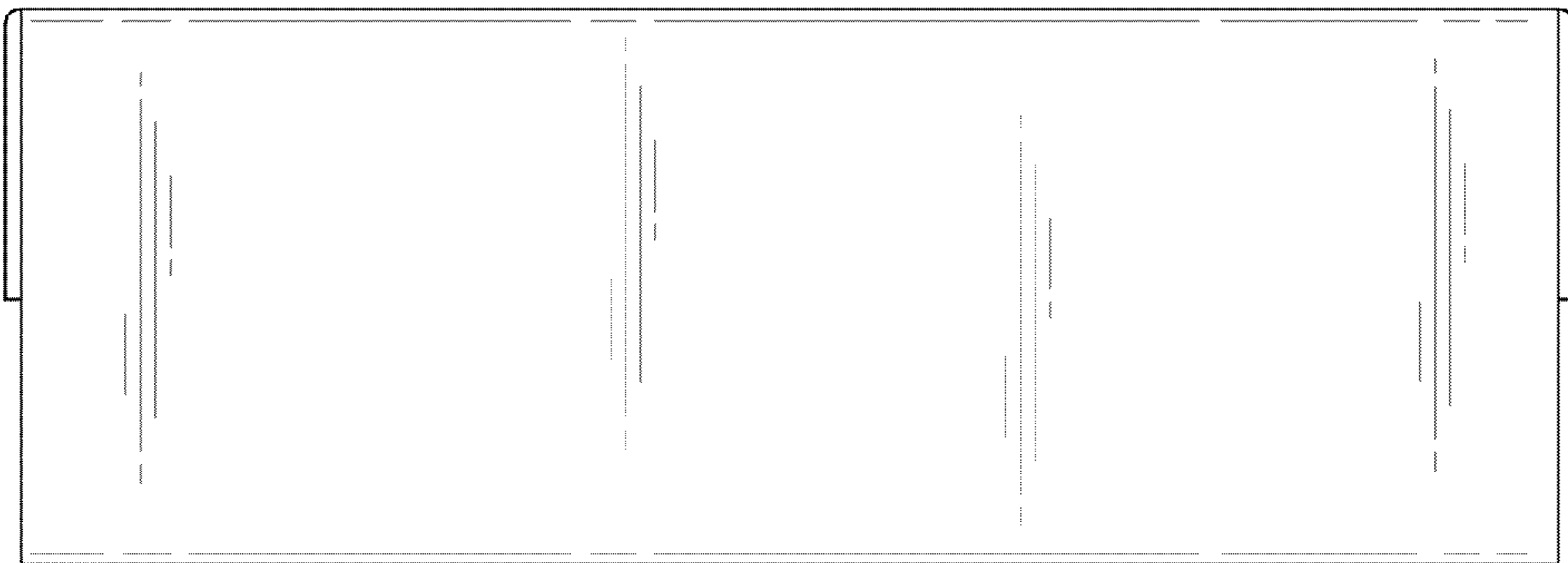

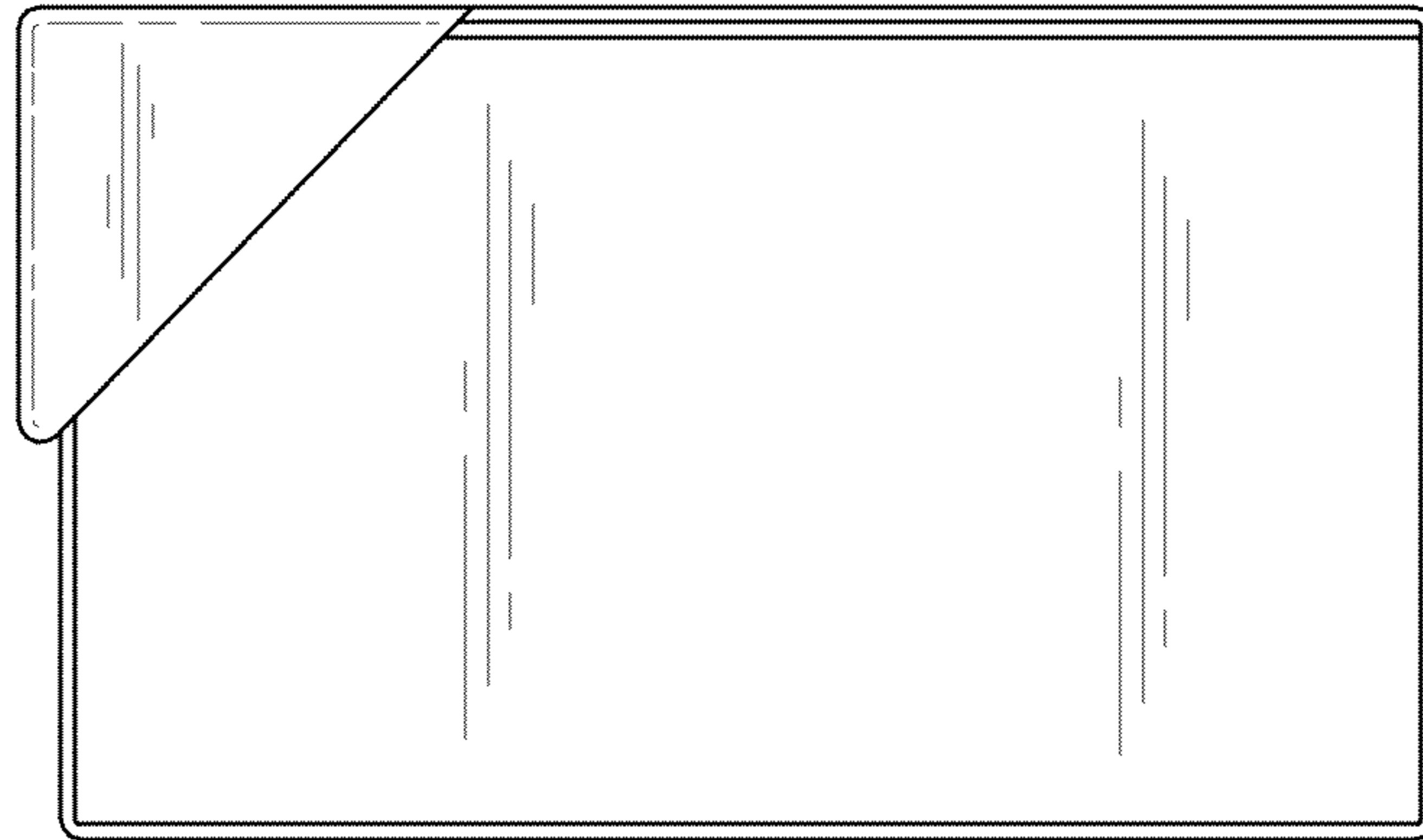

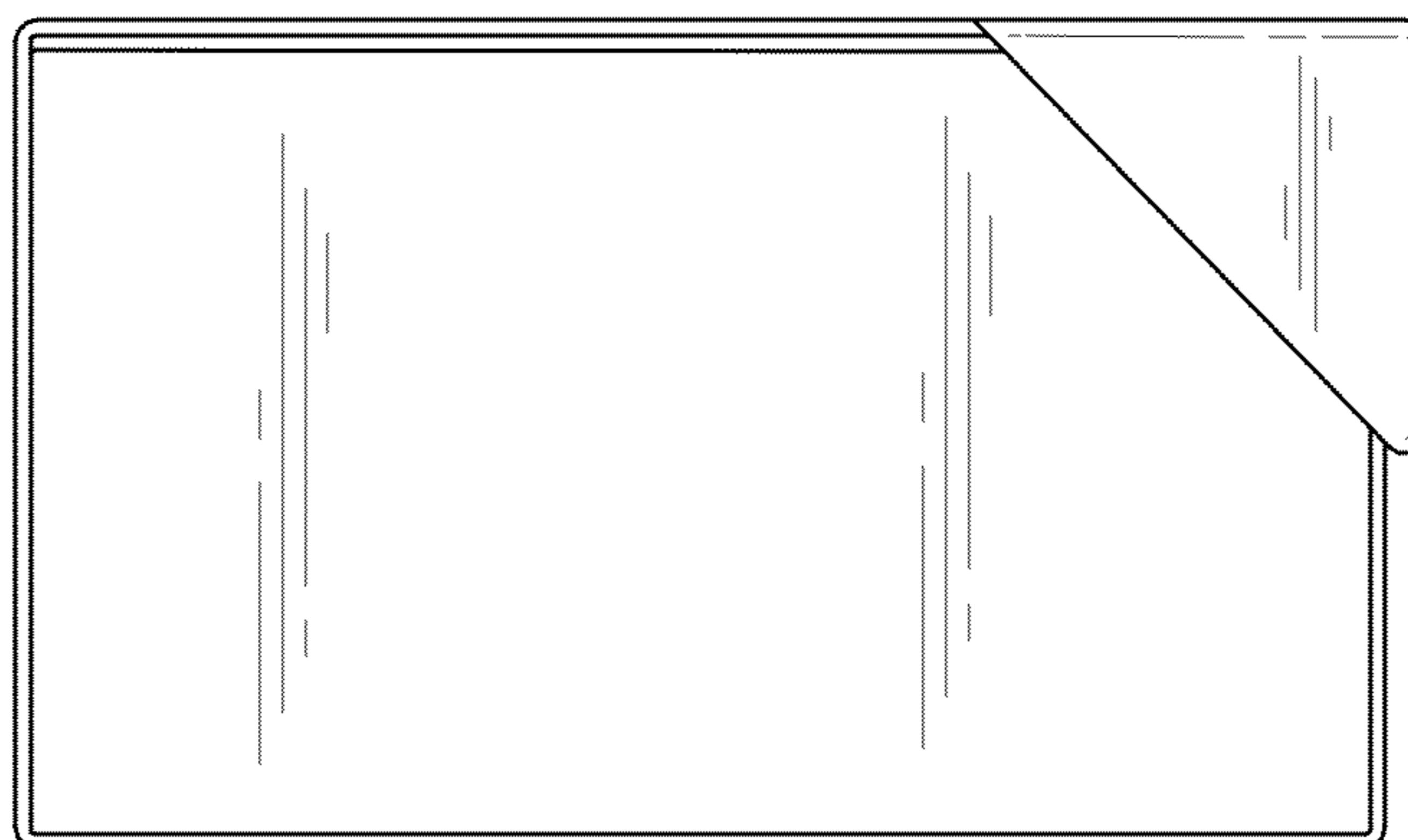

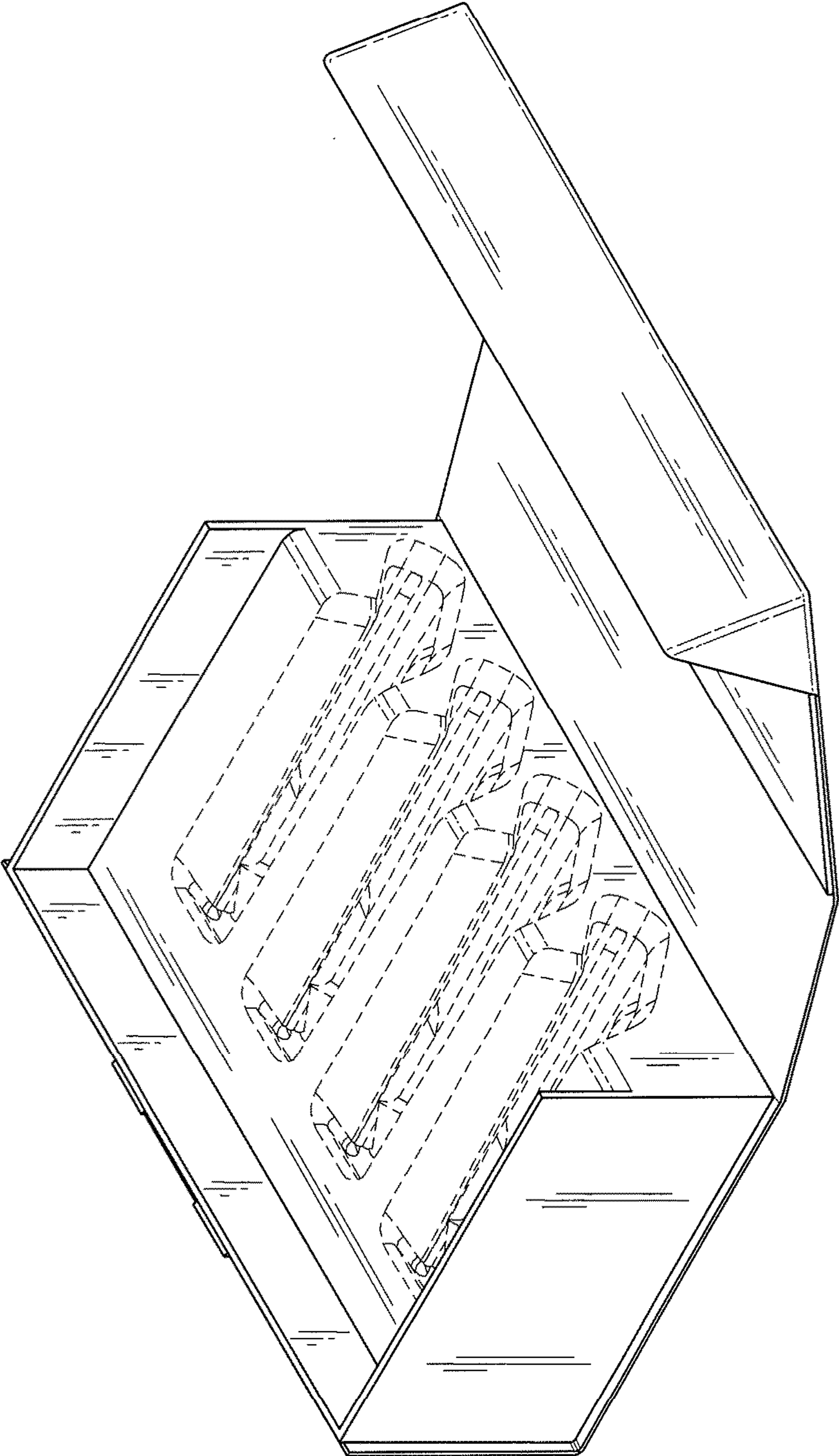

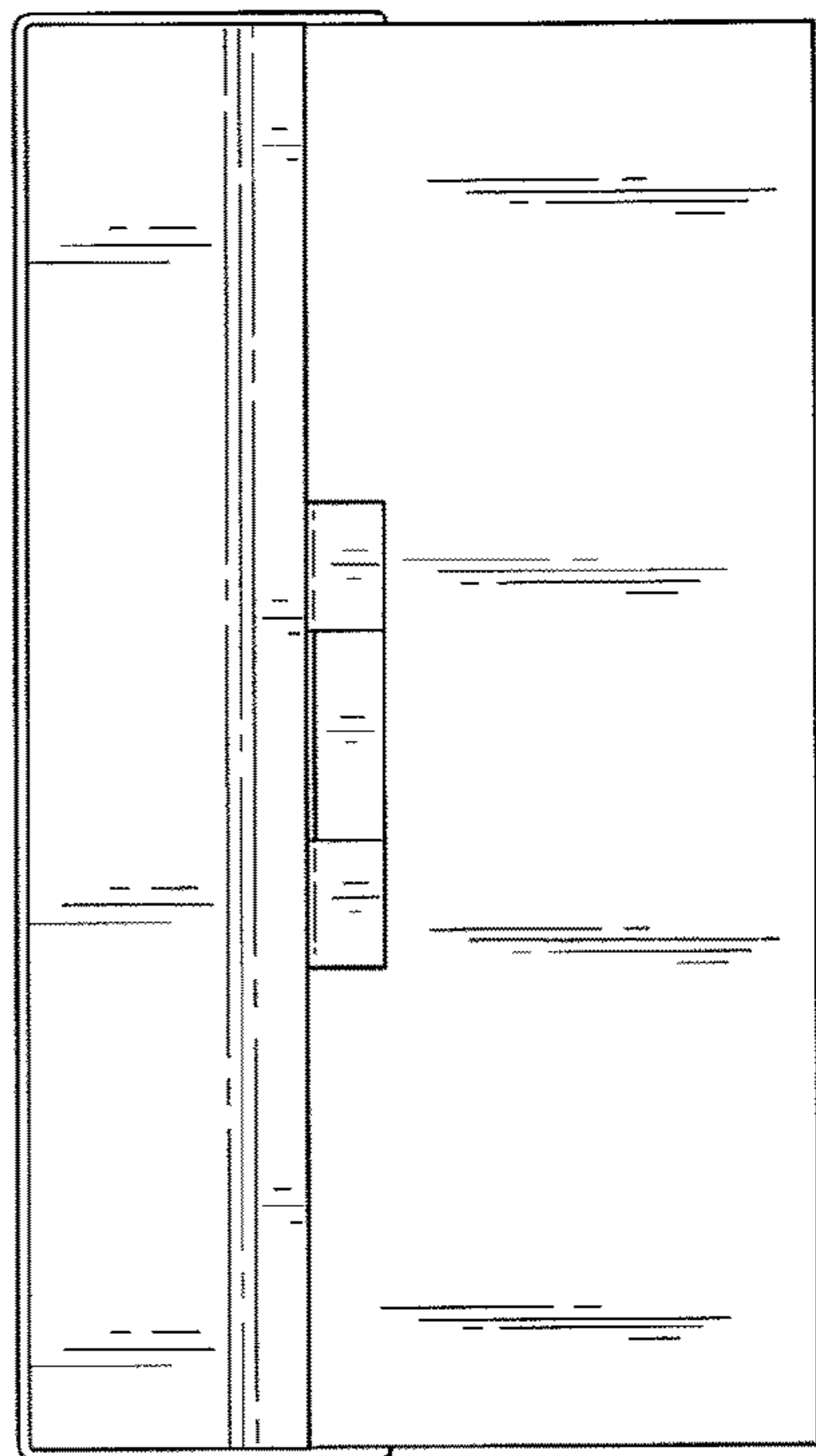

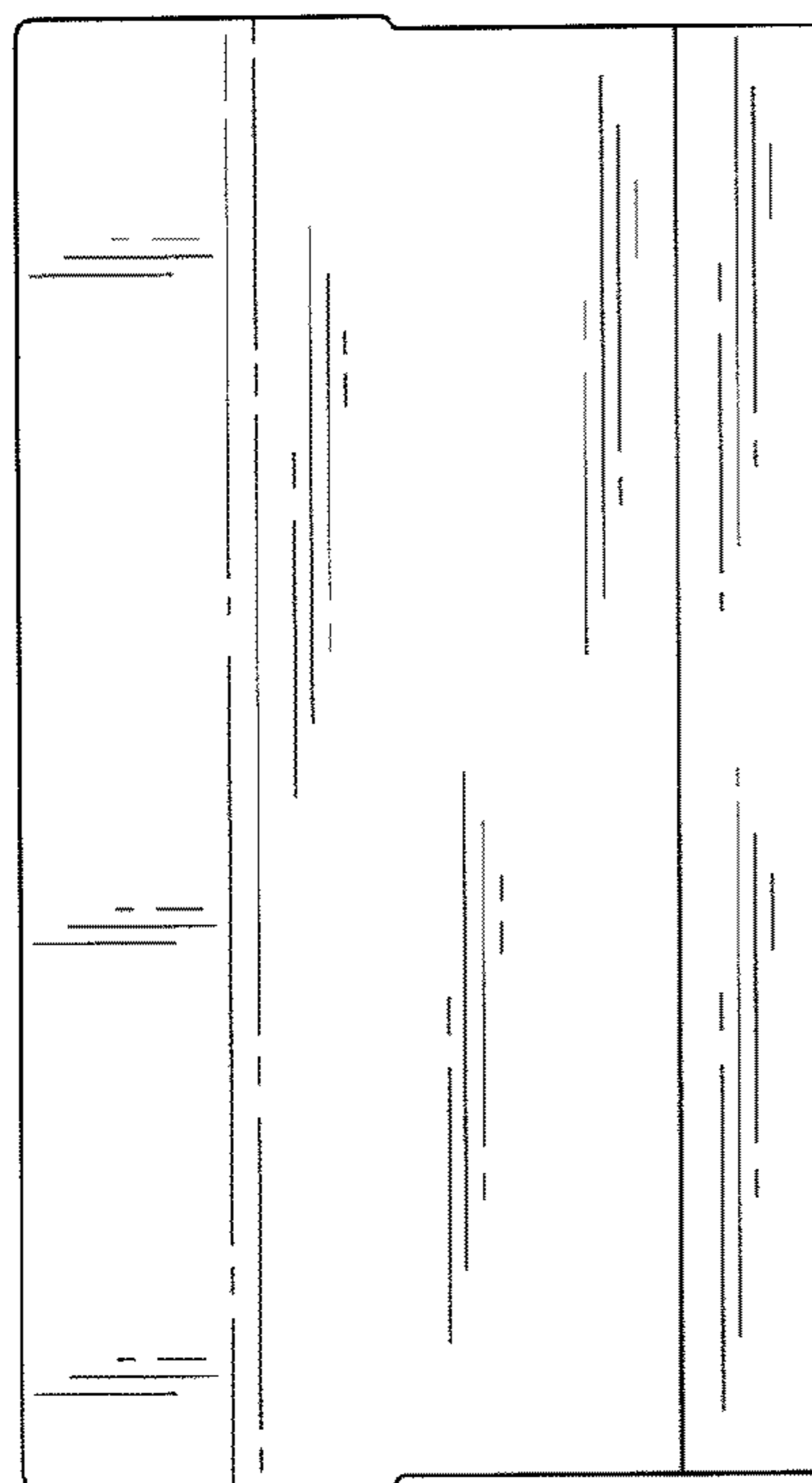

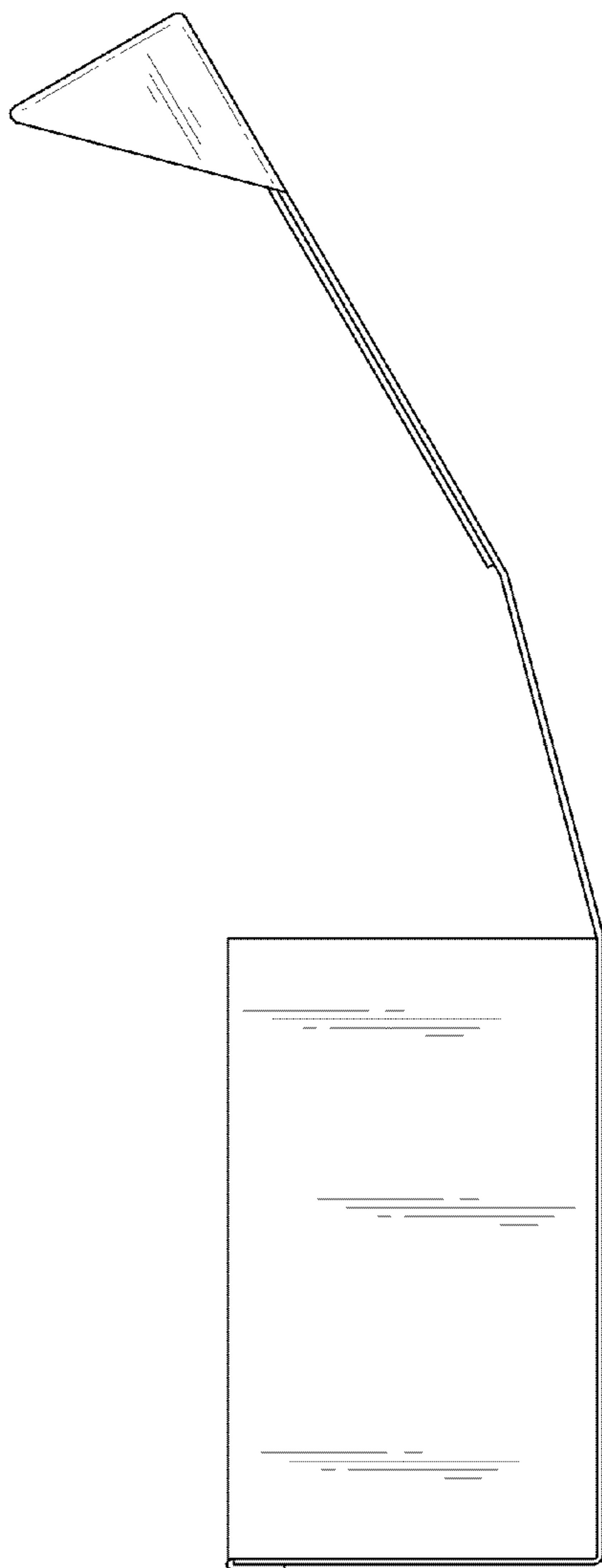

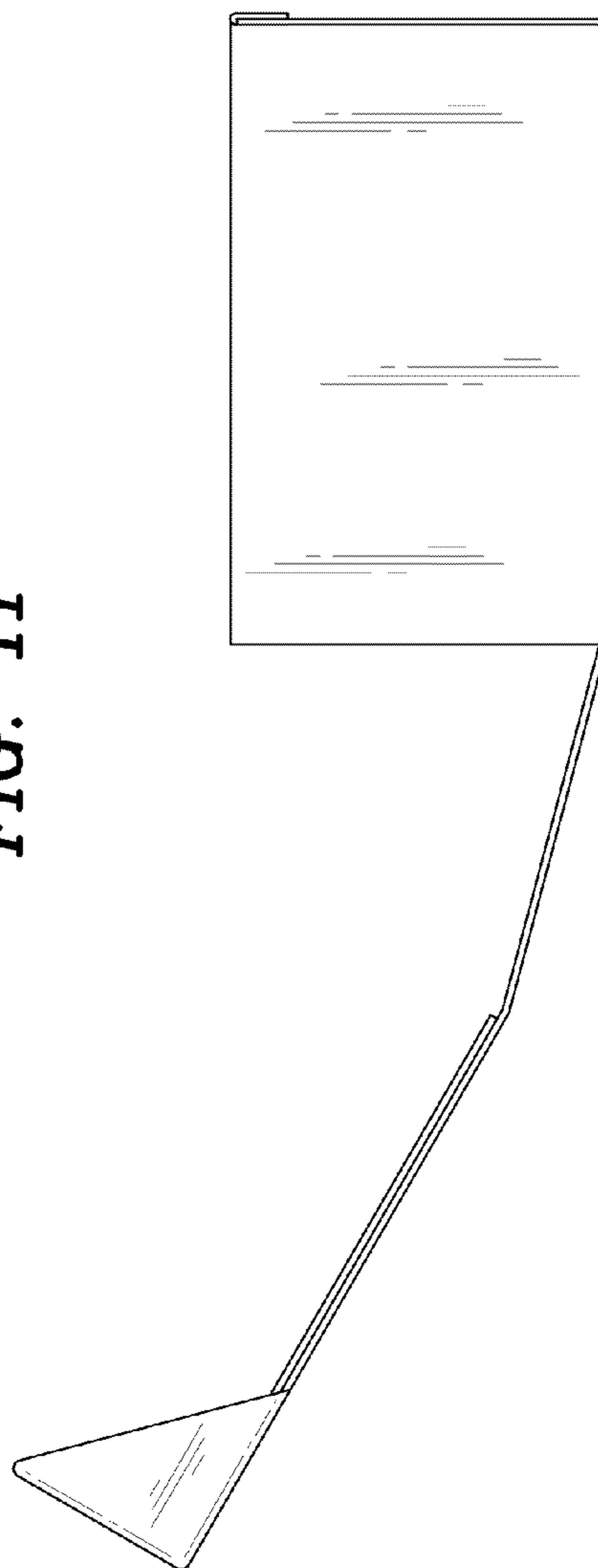

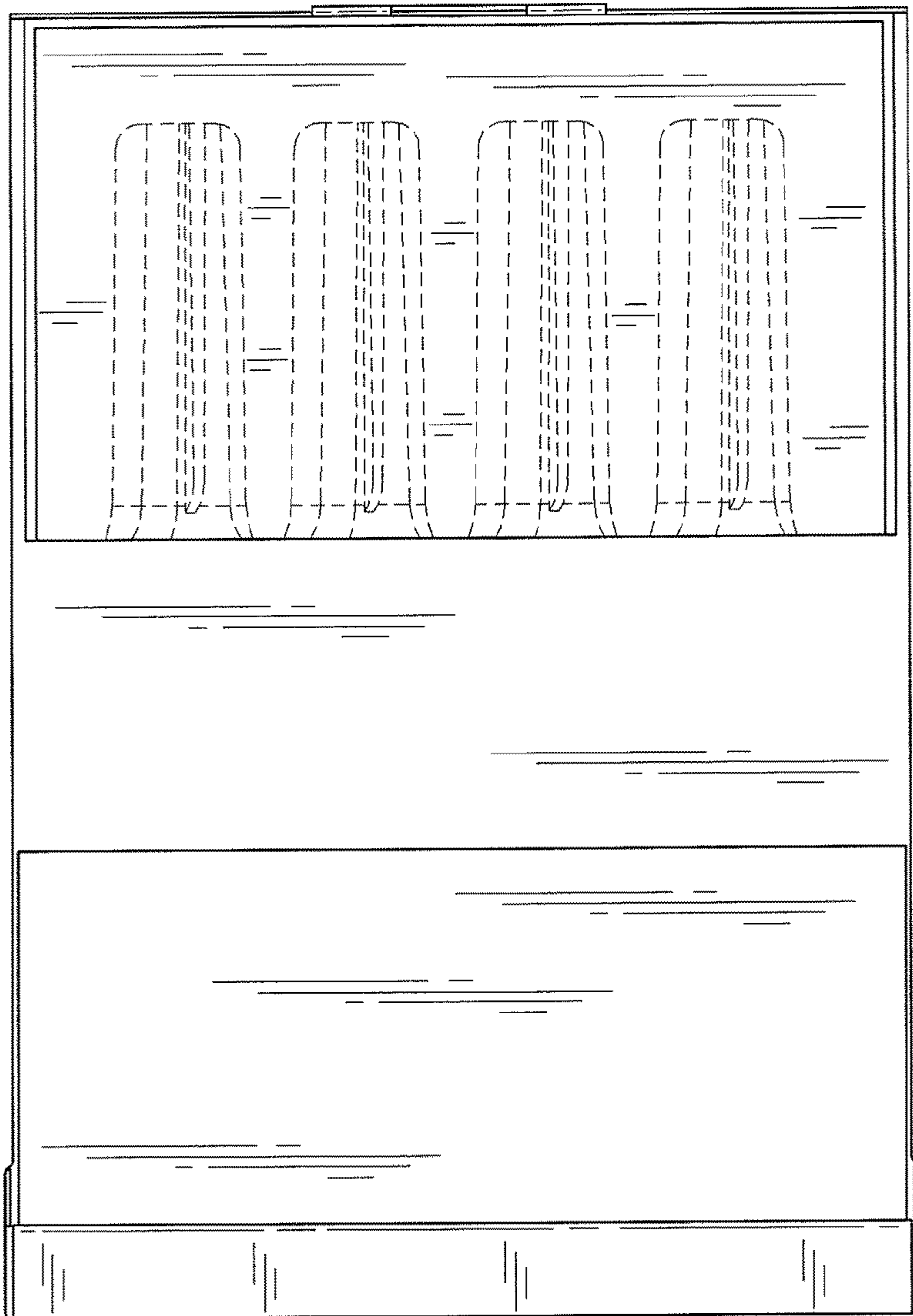

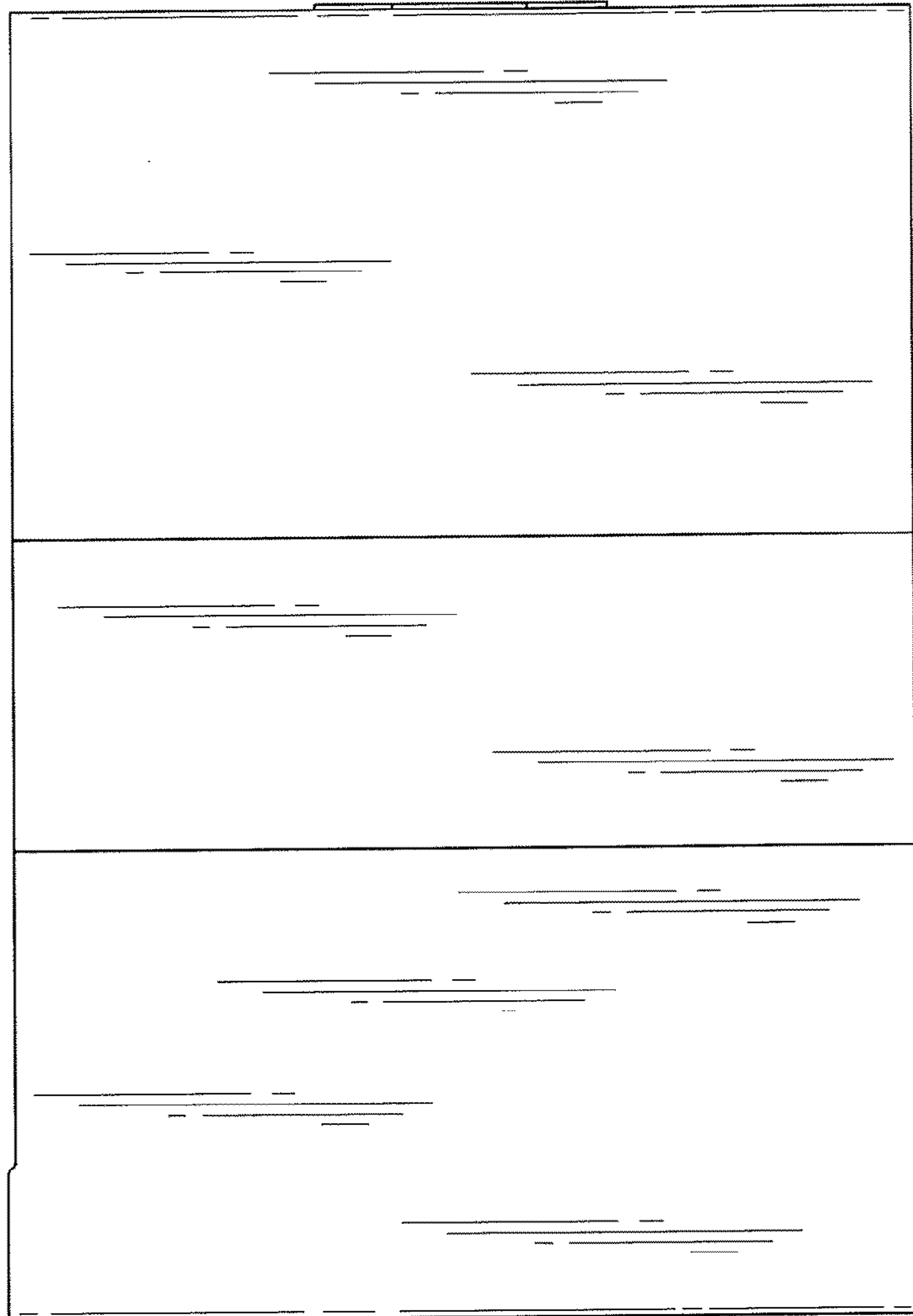
