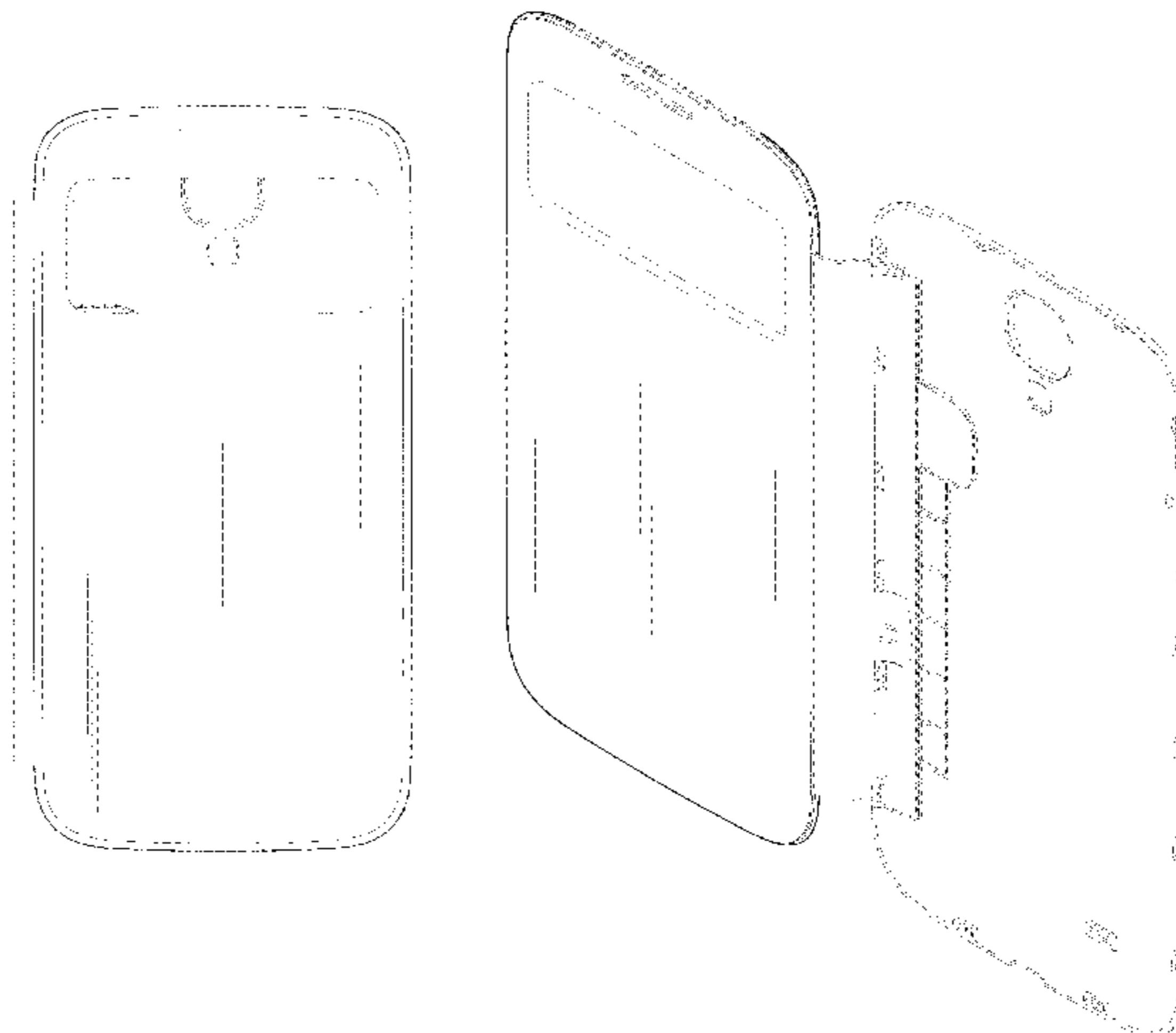
(57) **CLAIM**

We claim the ornamental design for a case for electronic device, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a case for electronic device showing my new design;

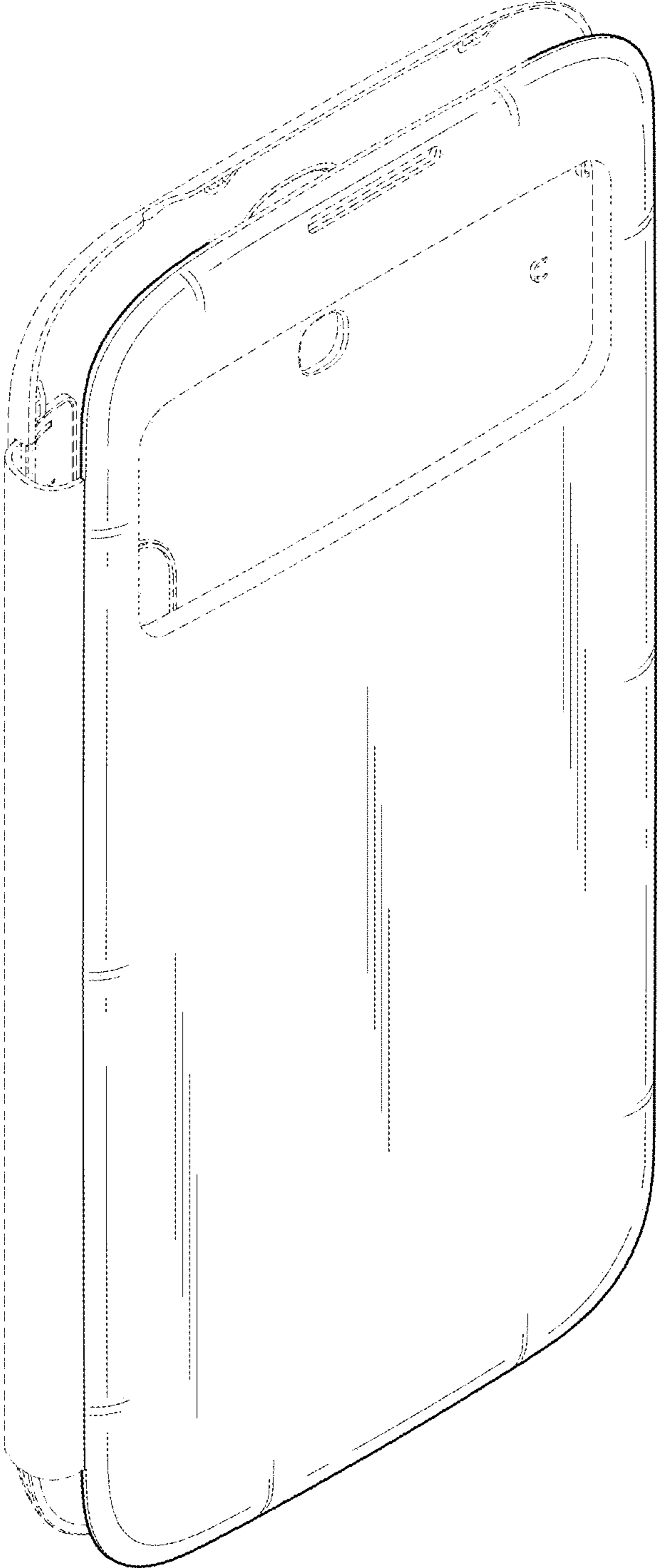

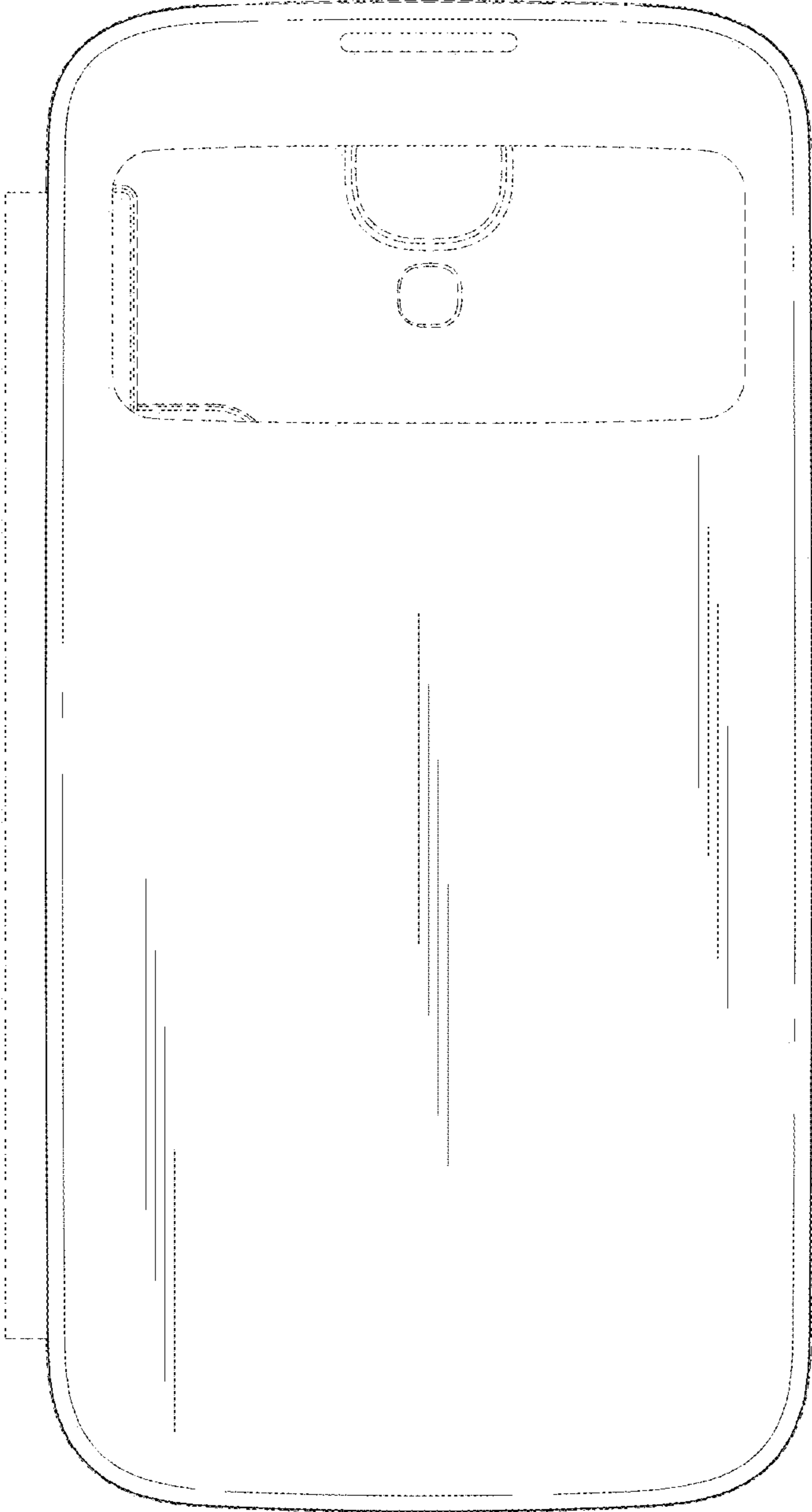

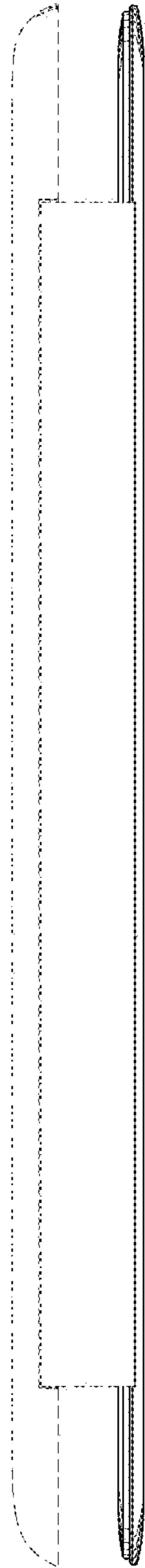

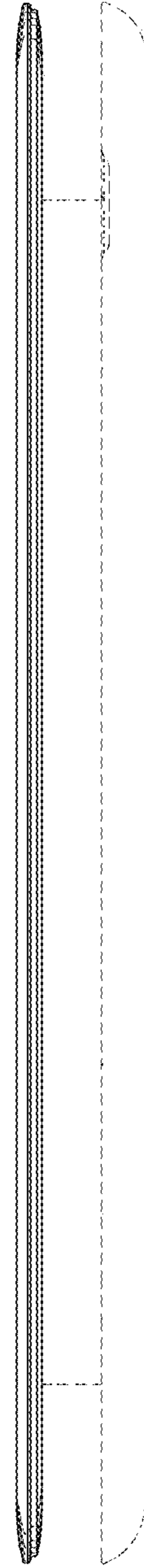

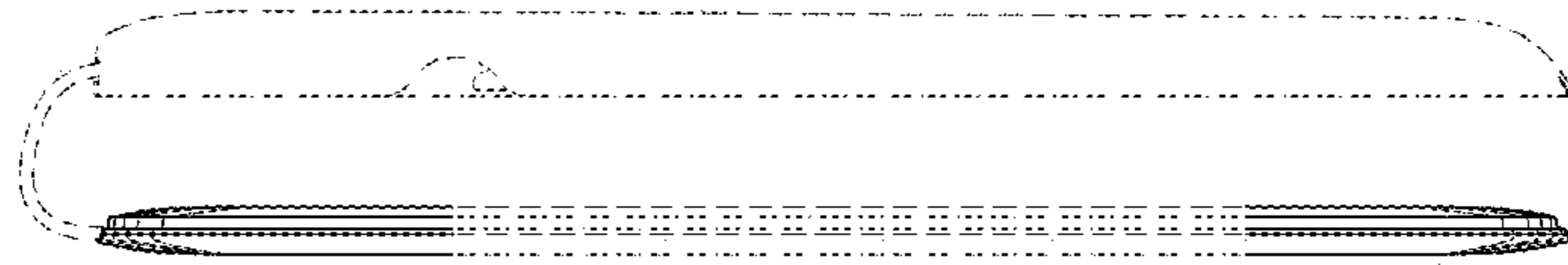

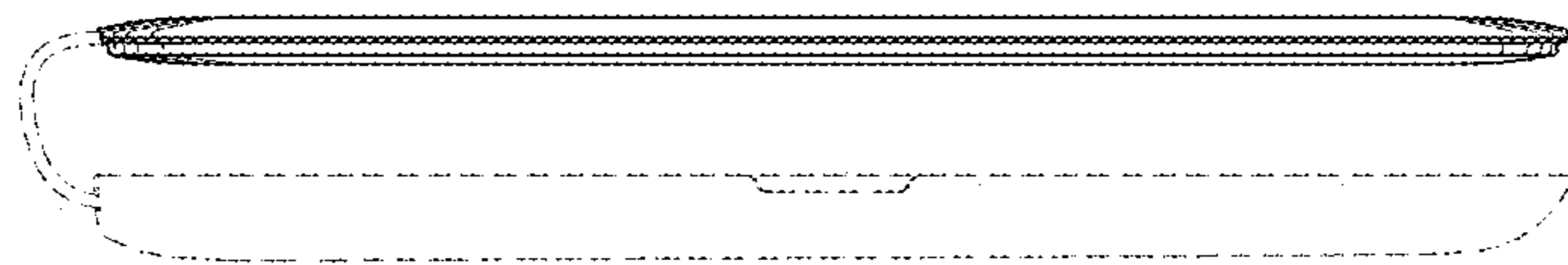

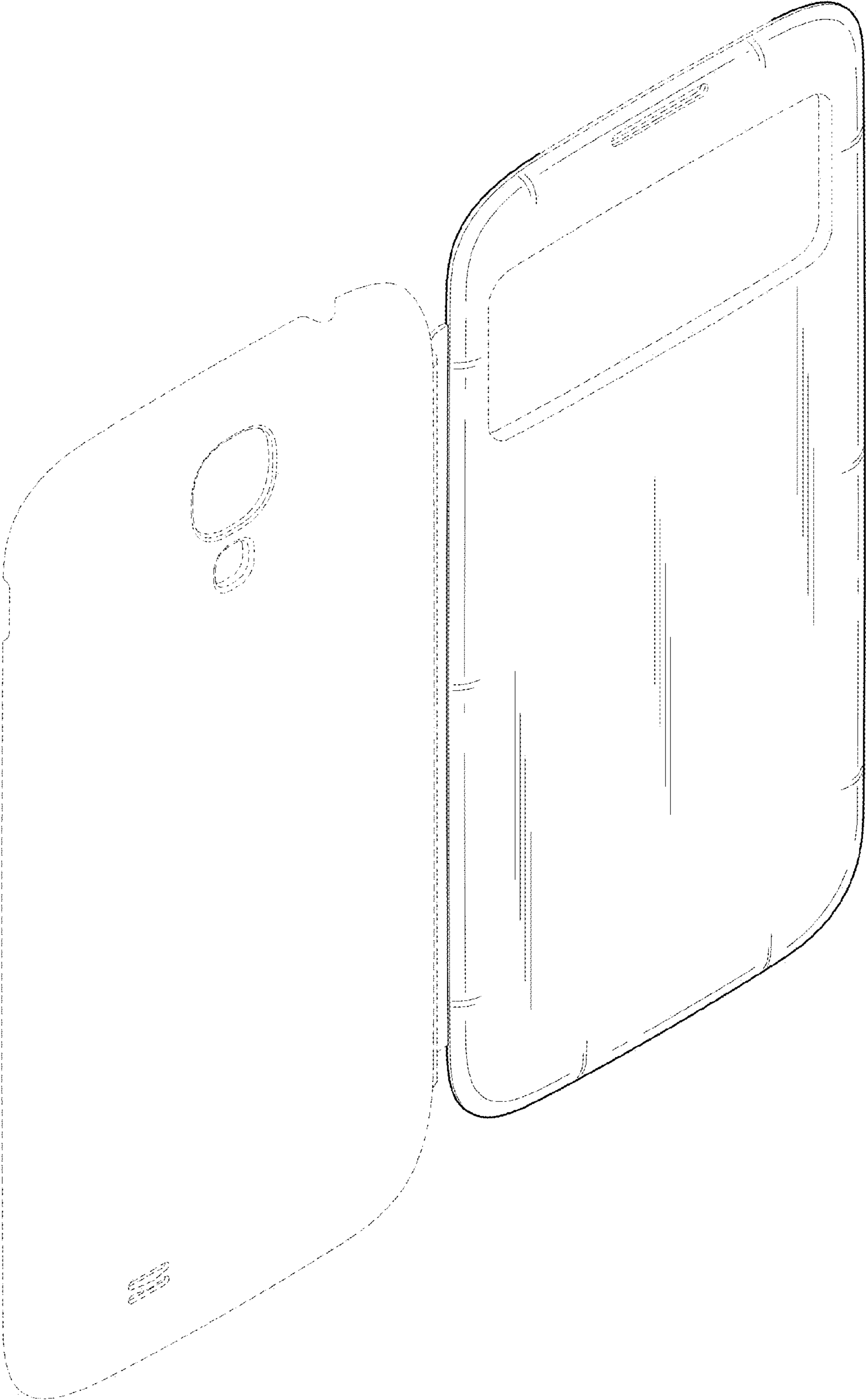
