FIG. 13 is a sixth image thereof;

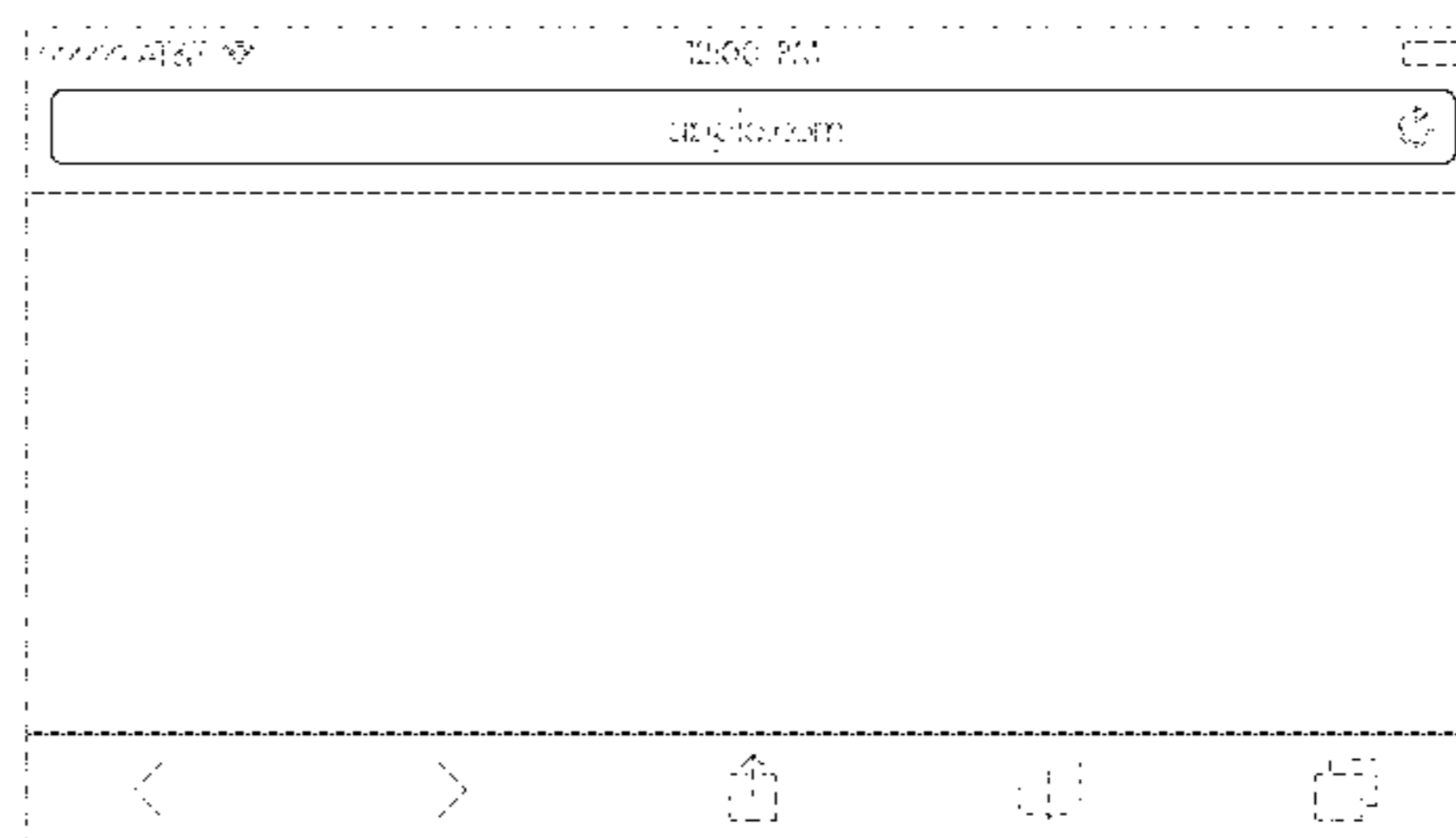
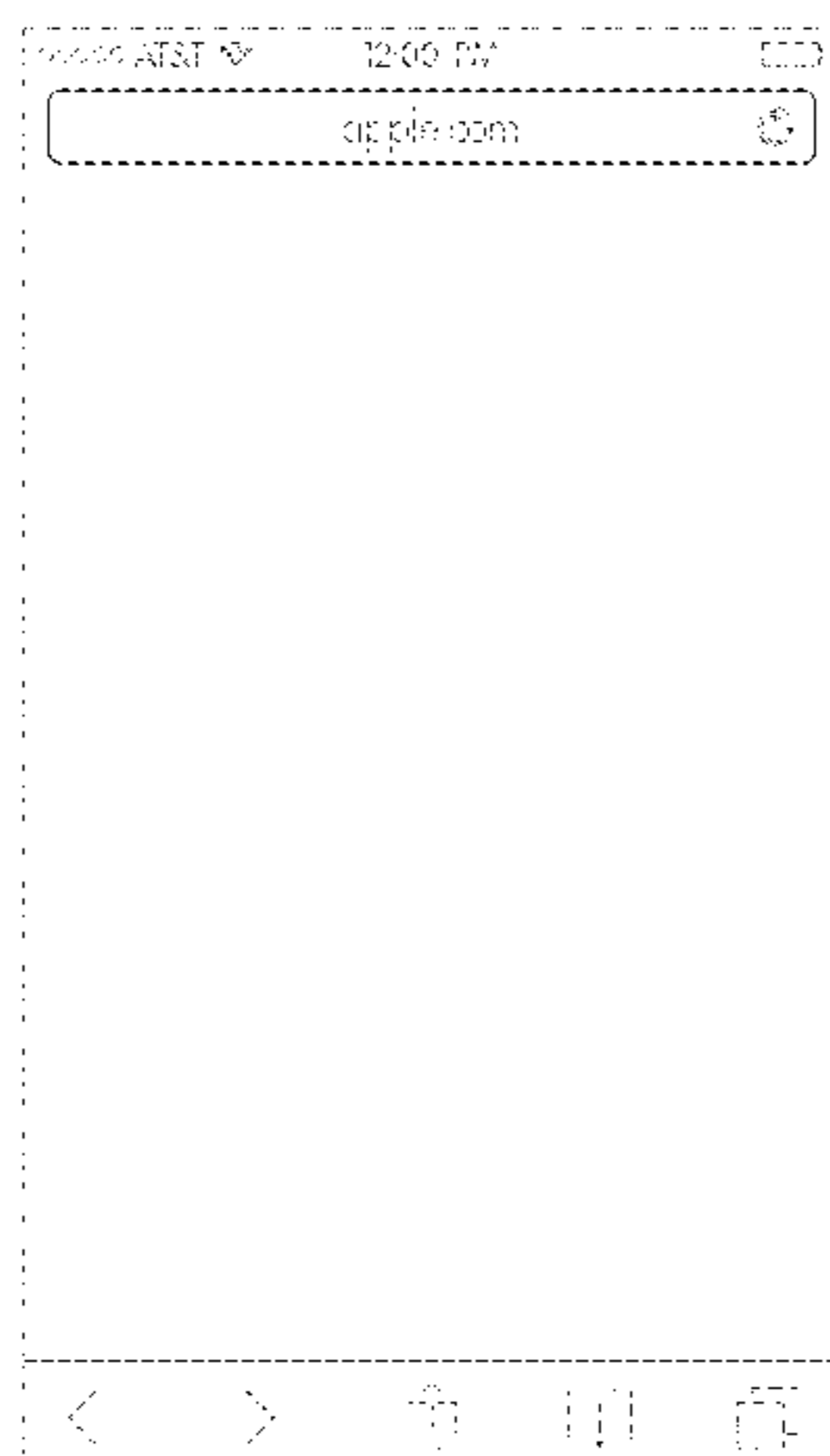
FIG. 14 is a seventh image thereof; and,

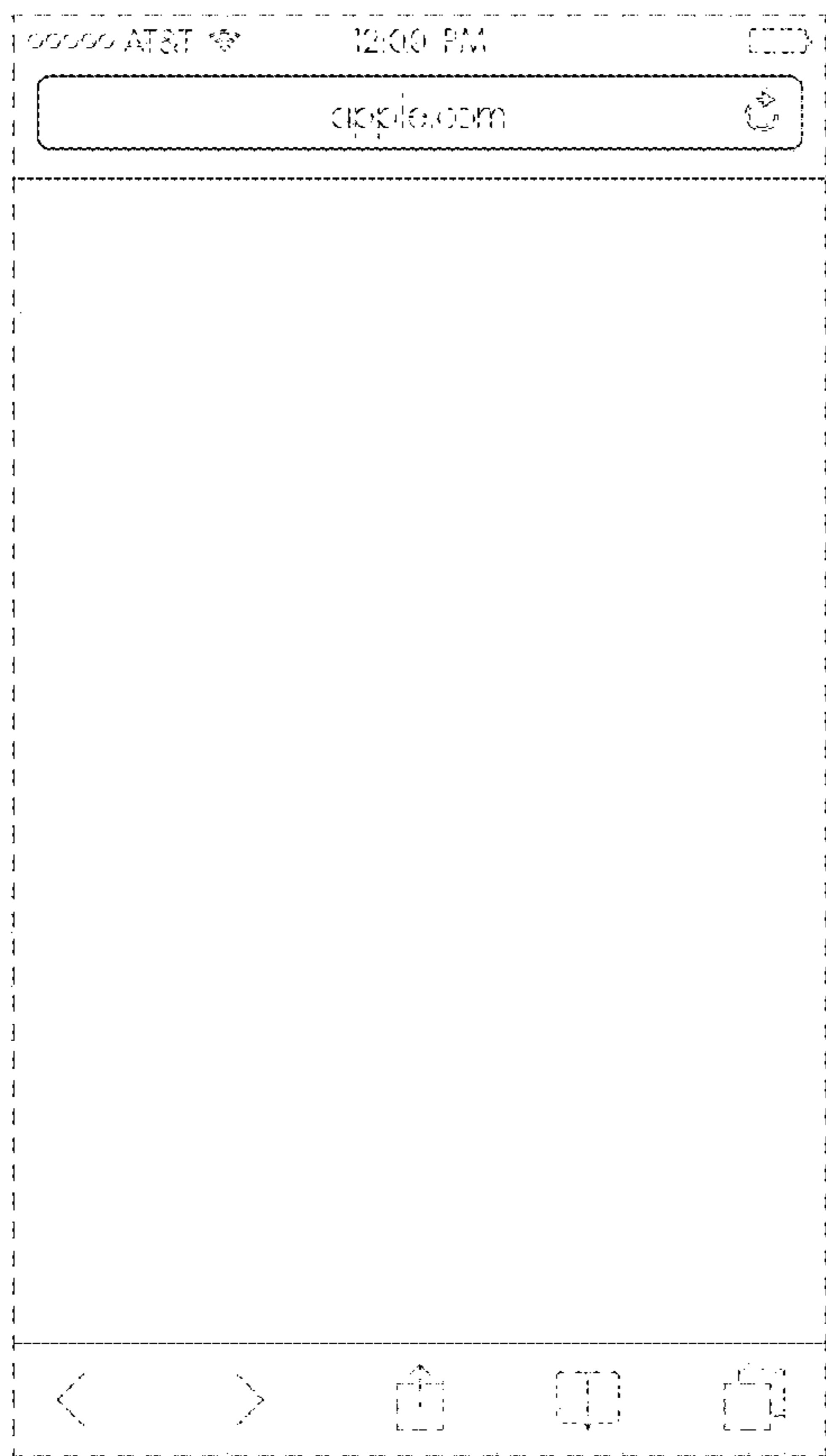

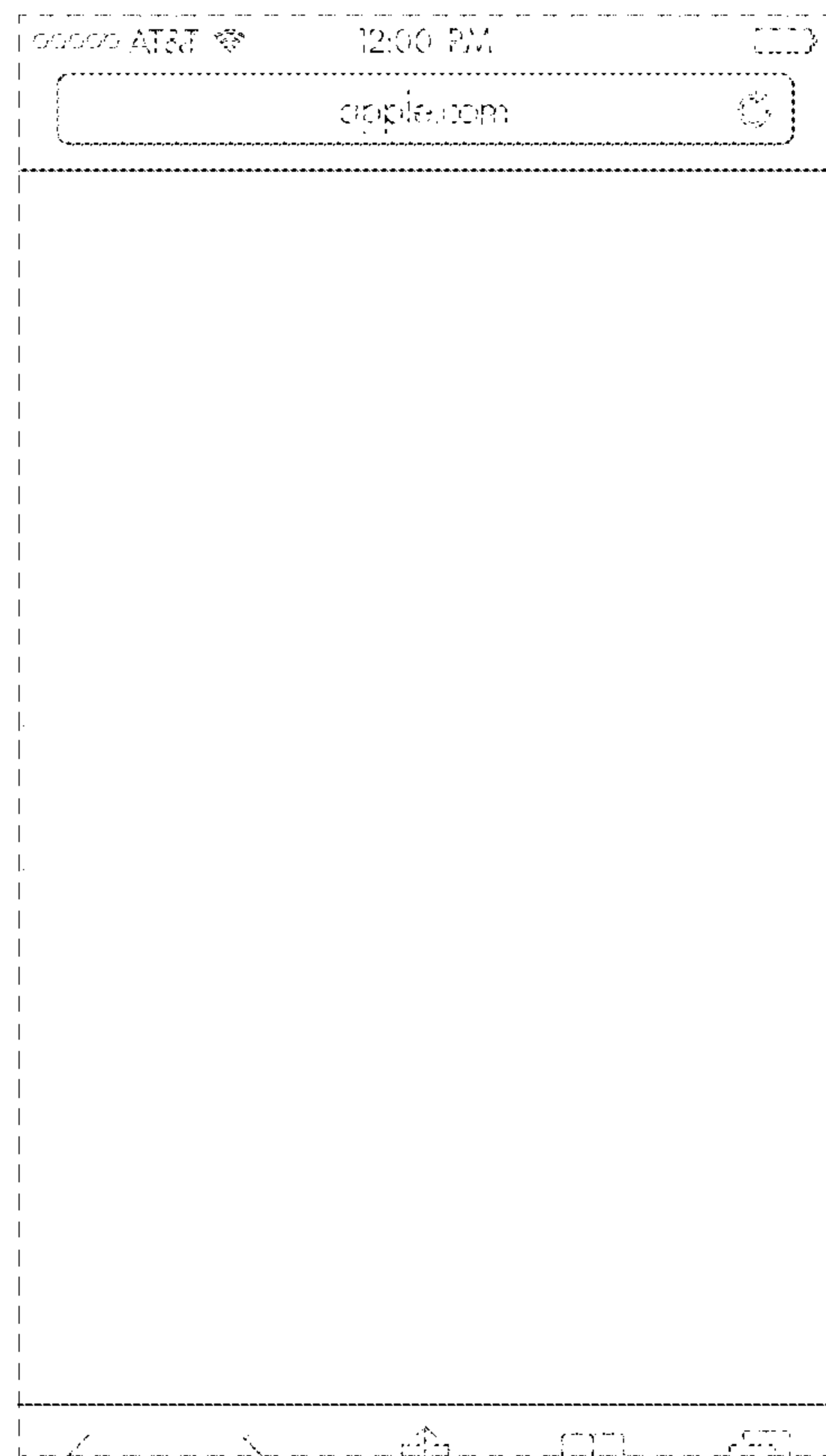

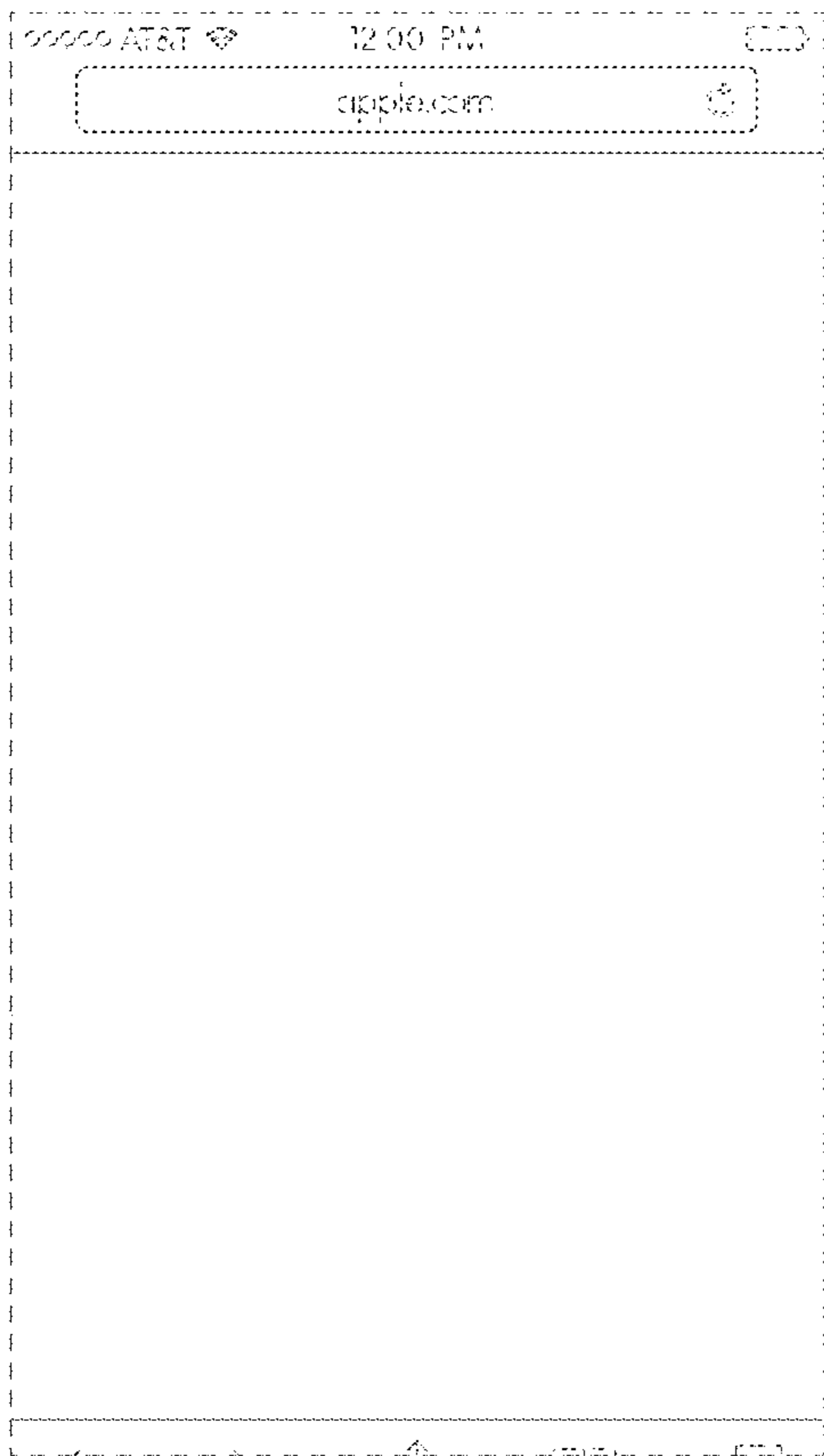

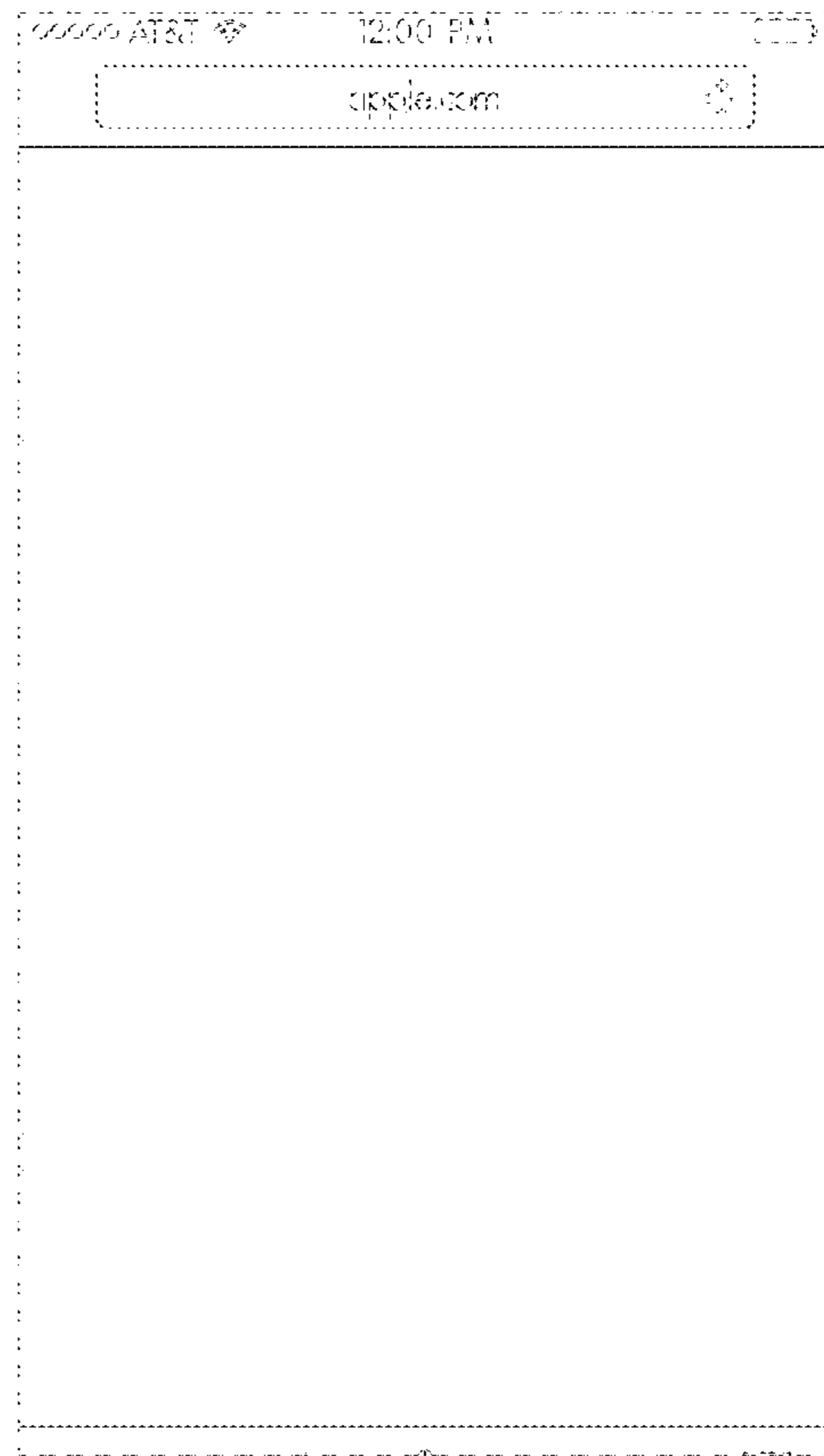

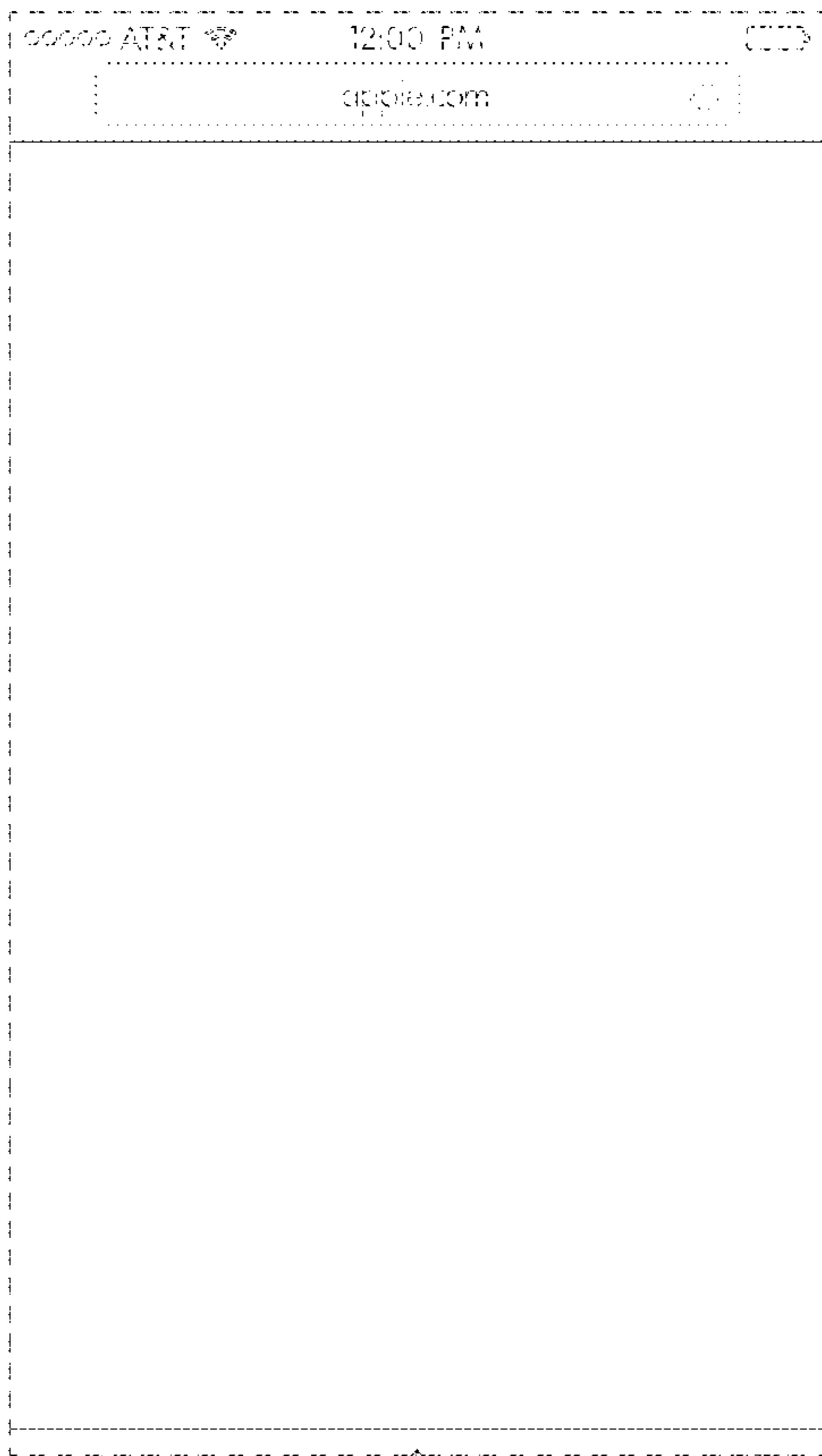

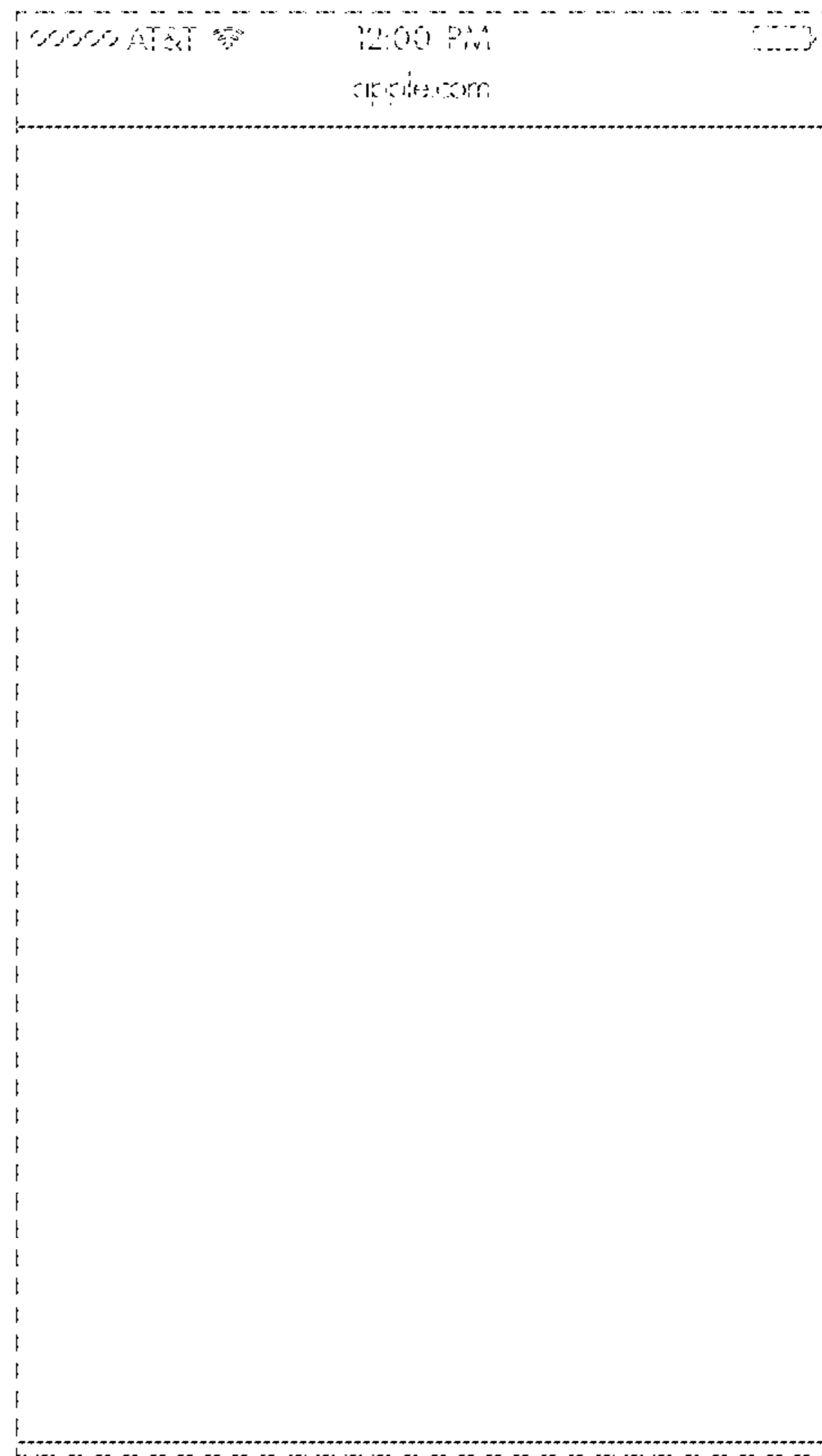

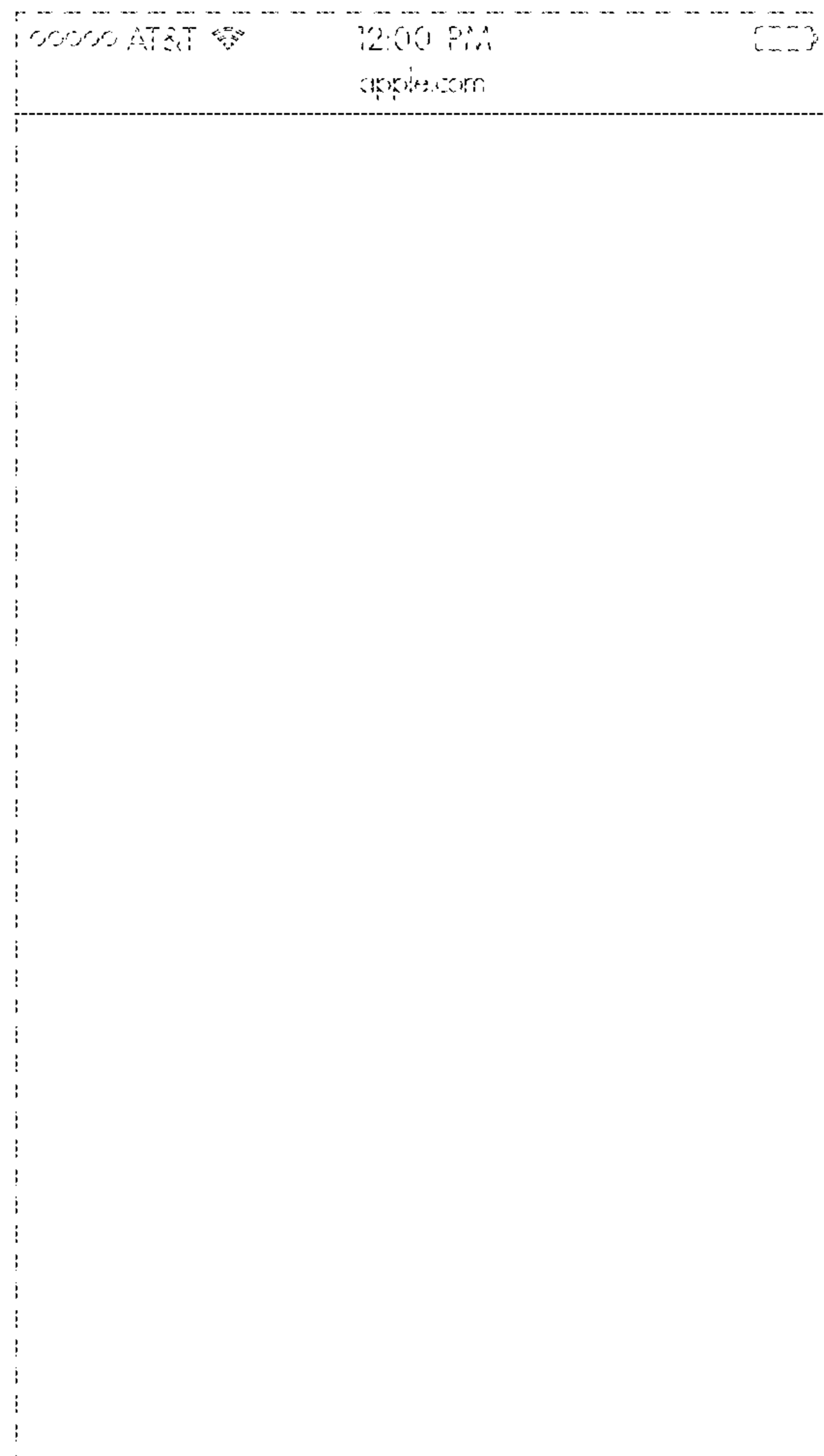

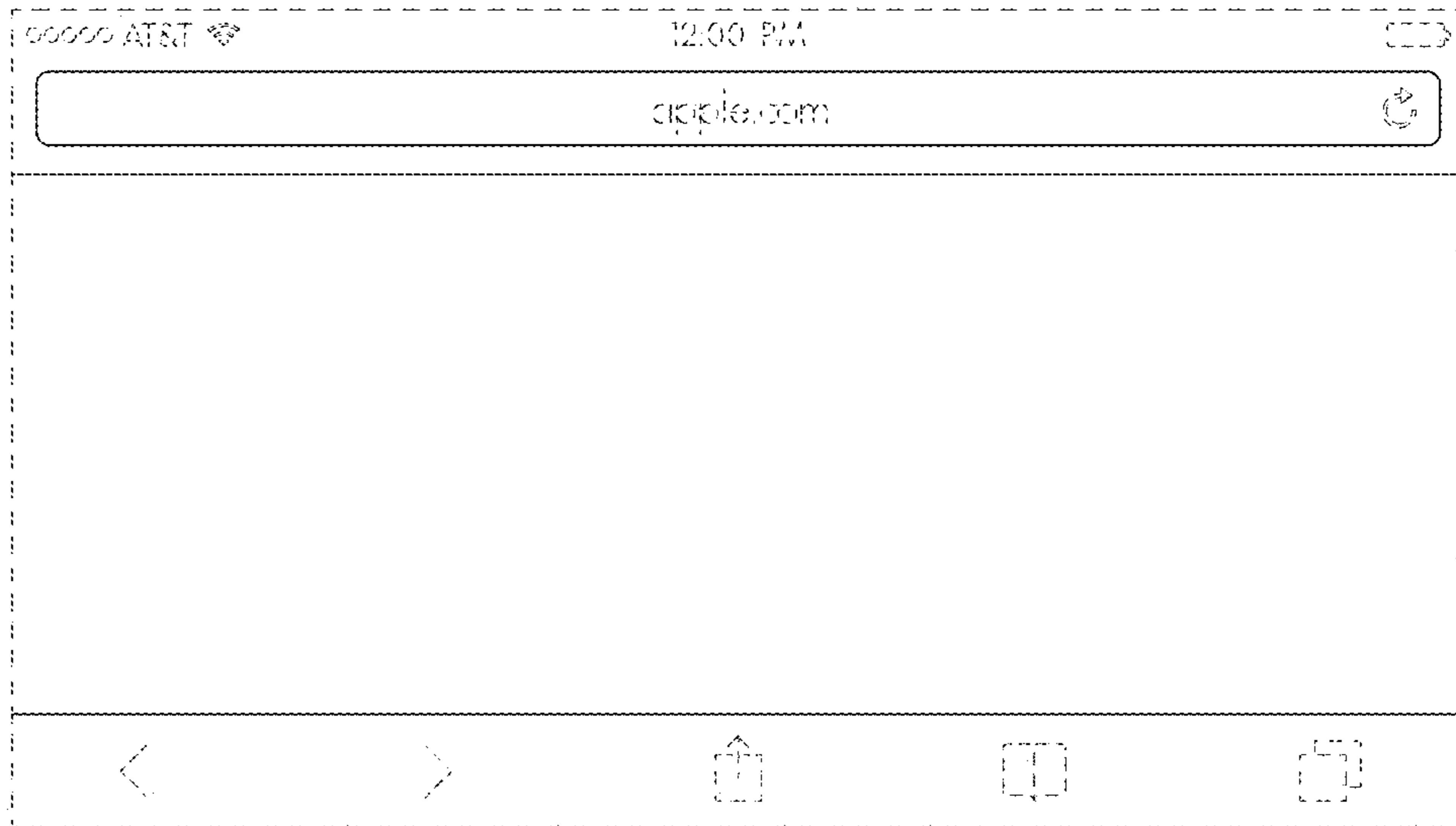

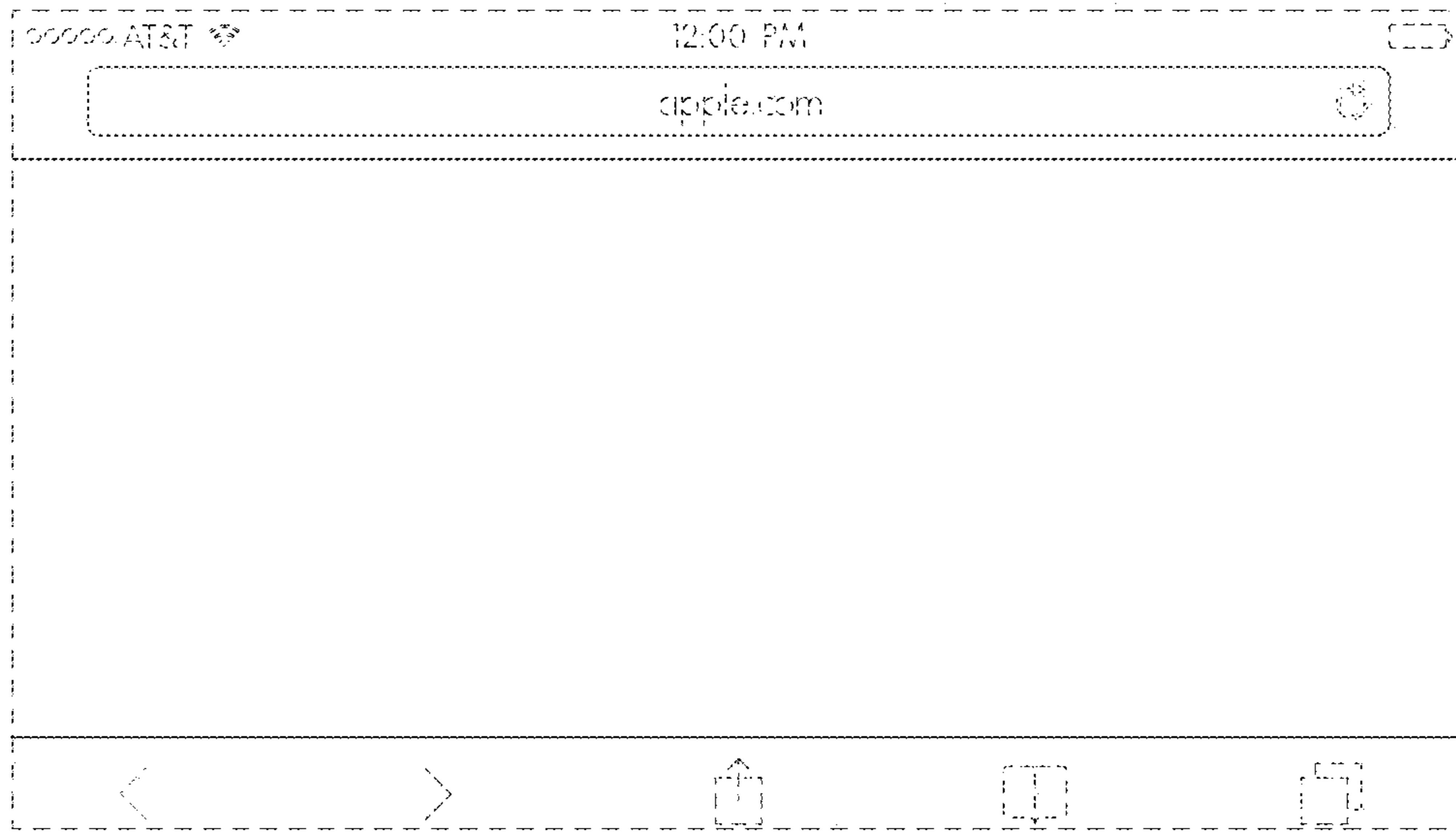

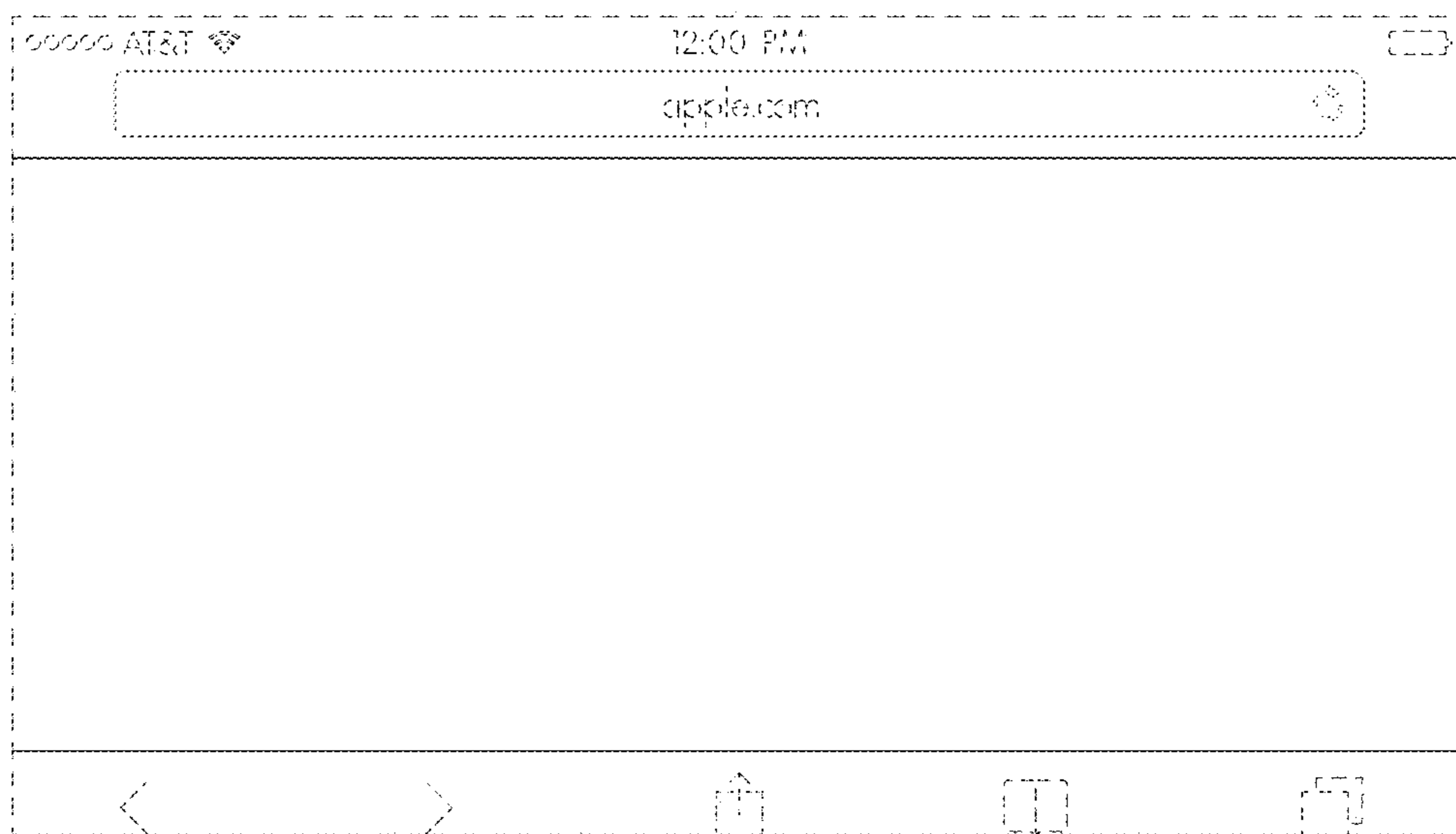

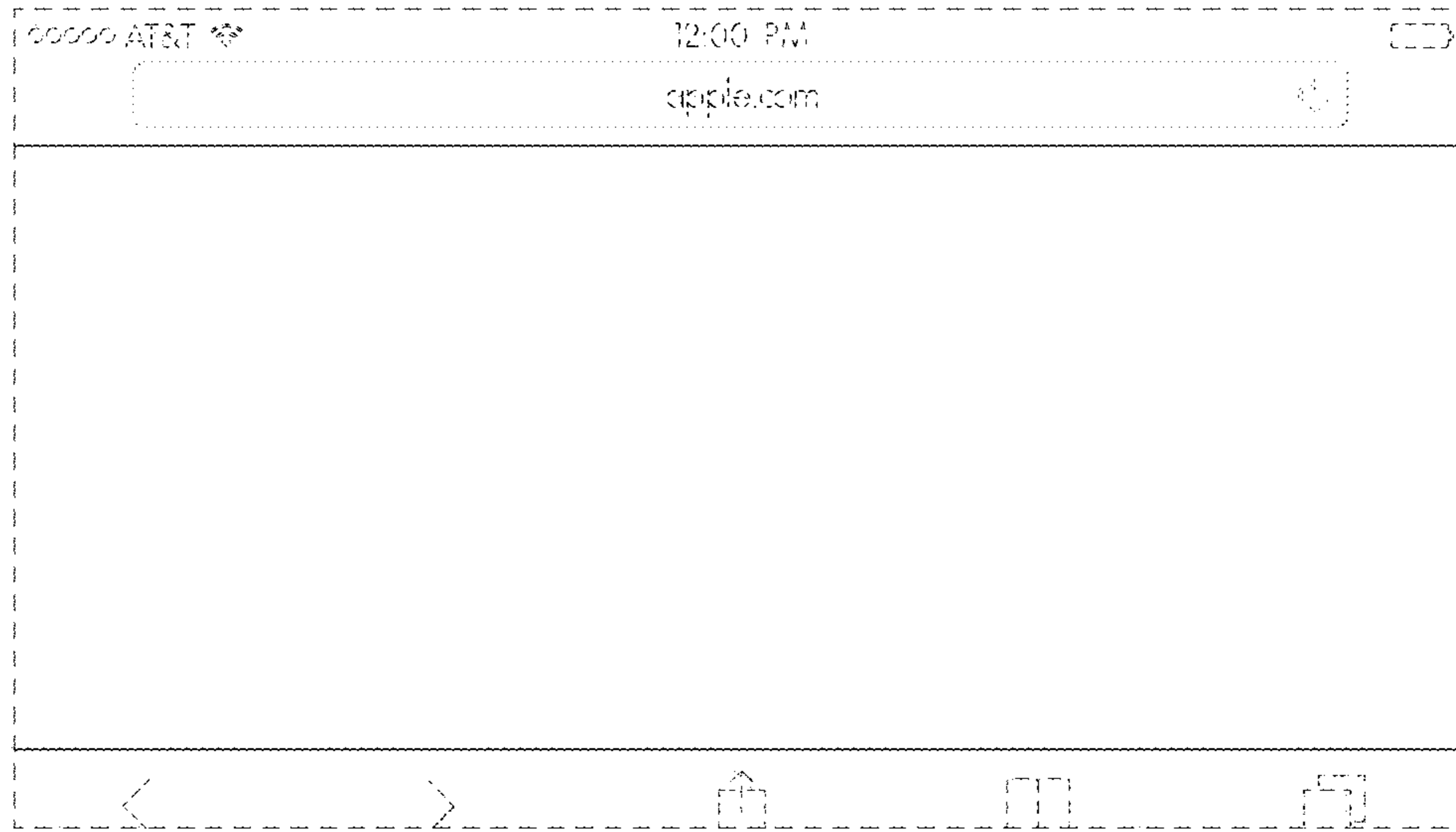

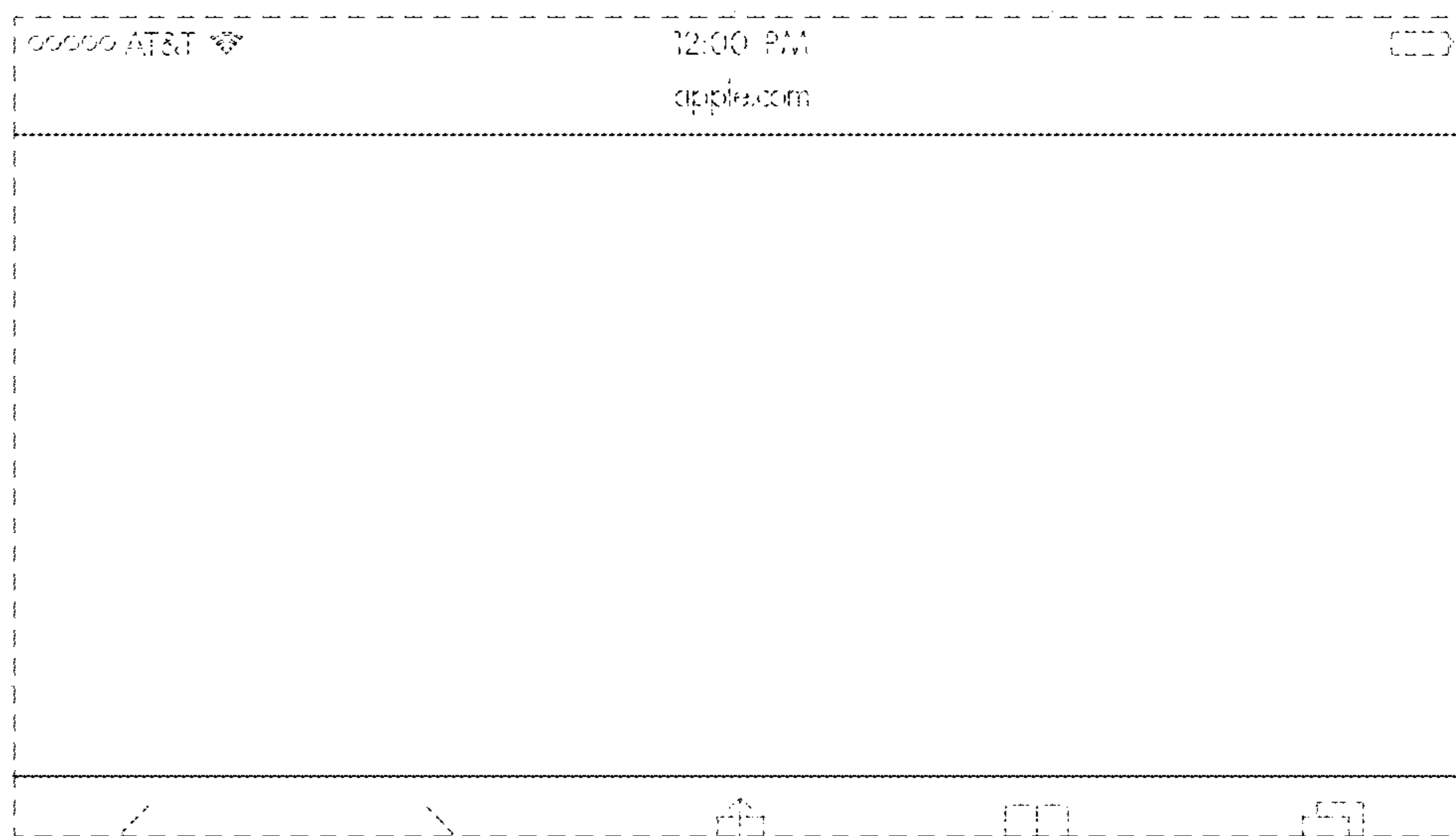

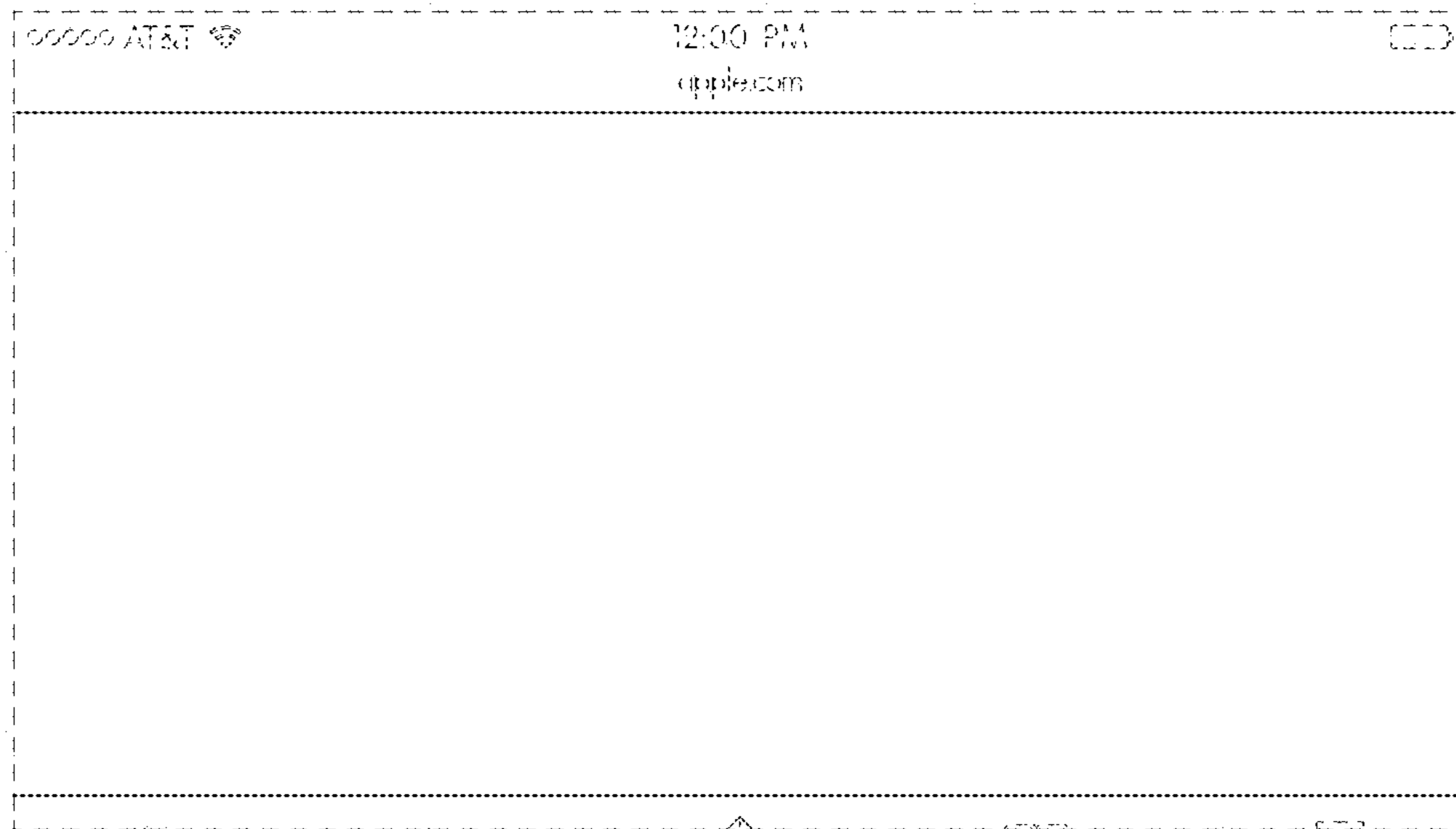

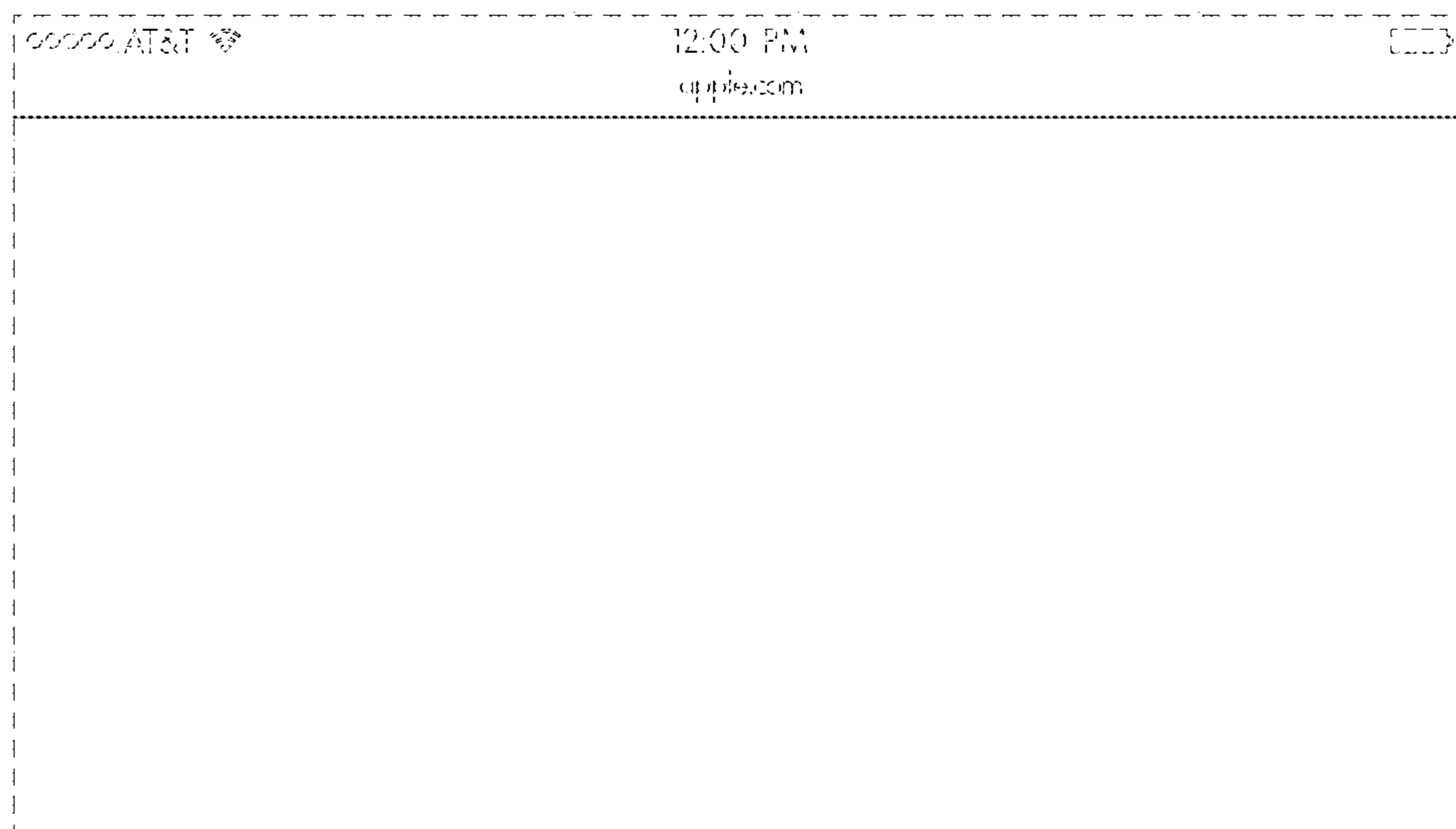
