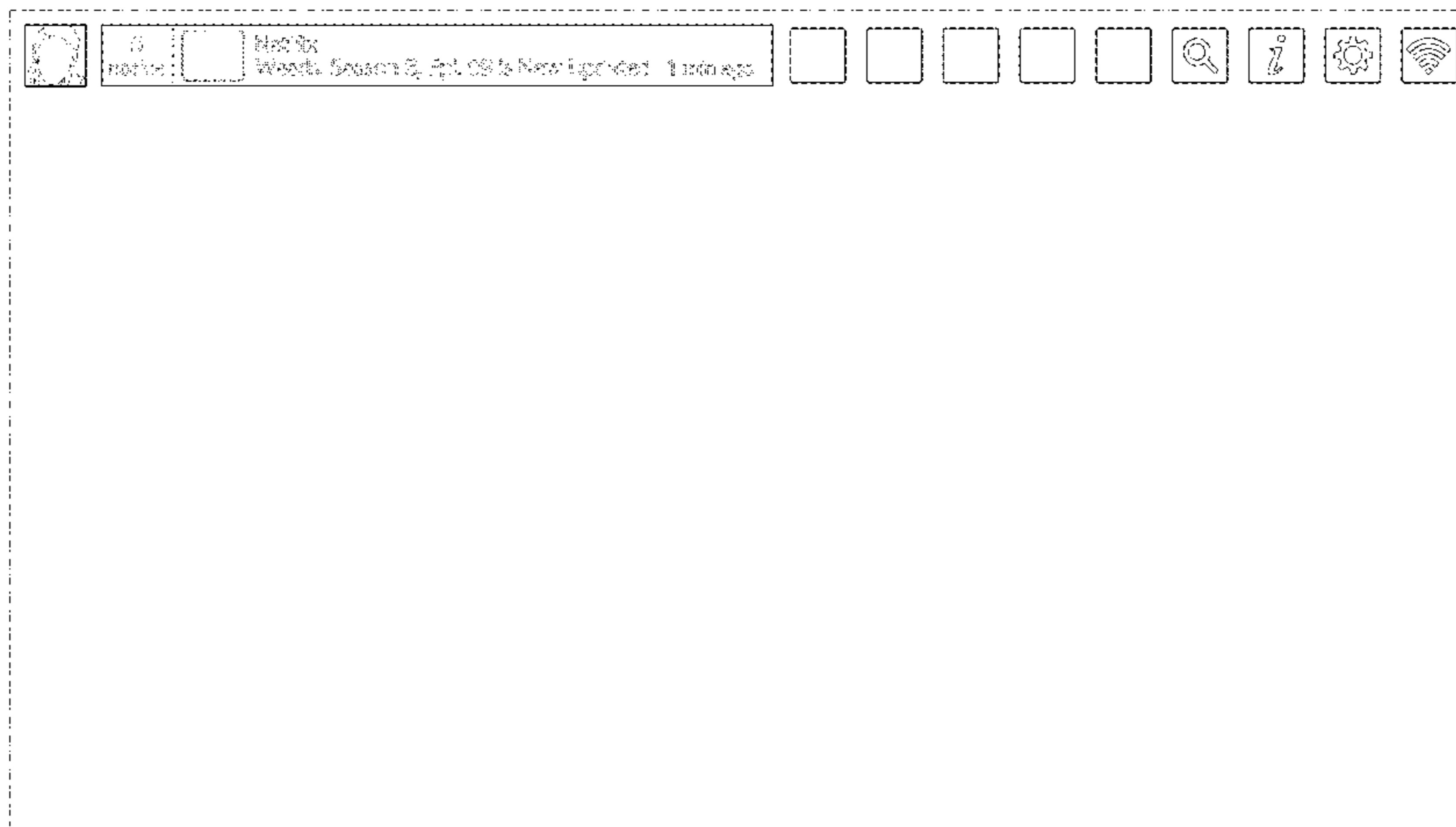

(57) **CLAIM**
The ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display screen or portion thereof with graphical user interface, showing our new design; FIG. 2 is a front view thereof, in which a display device in broken lines is provided to illustrate an example environment; and, FIG. 3 is an alternate front view thereof. The broken lines shown in the drawings represent portions of the display screen or portion thereof with graphical user interface and environment that form no part of the claimed design.

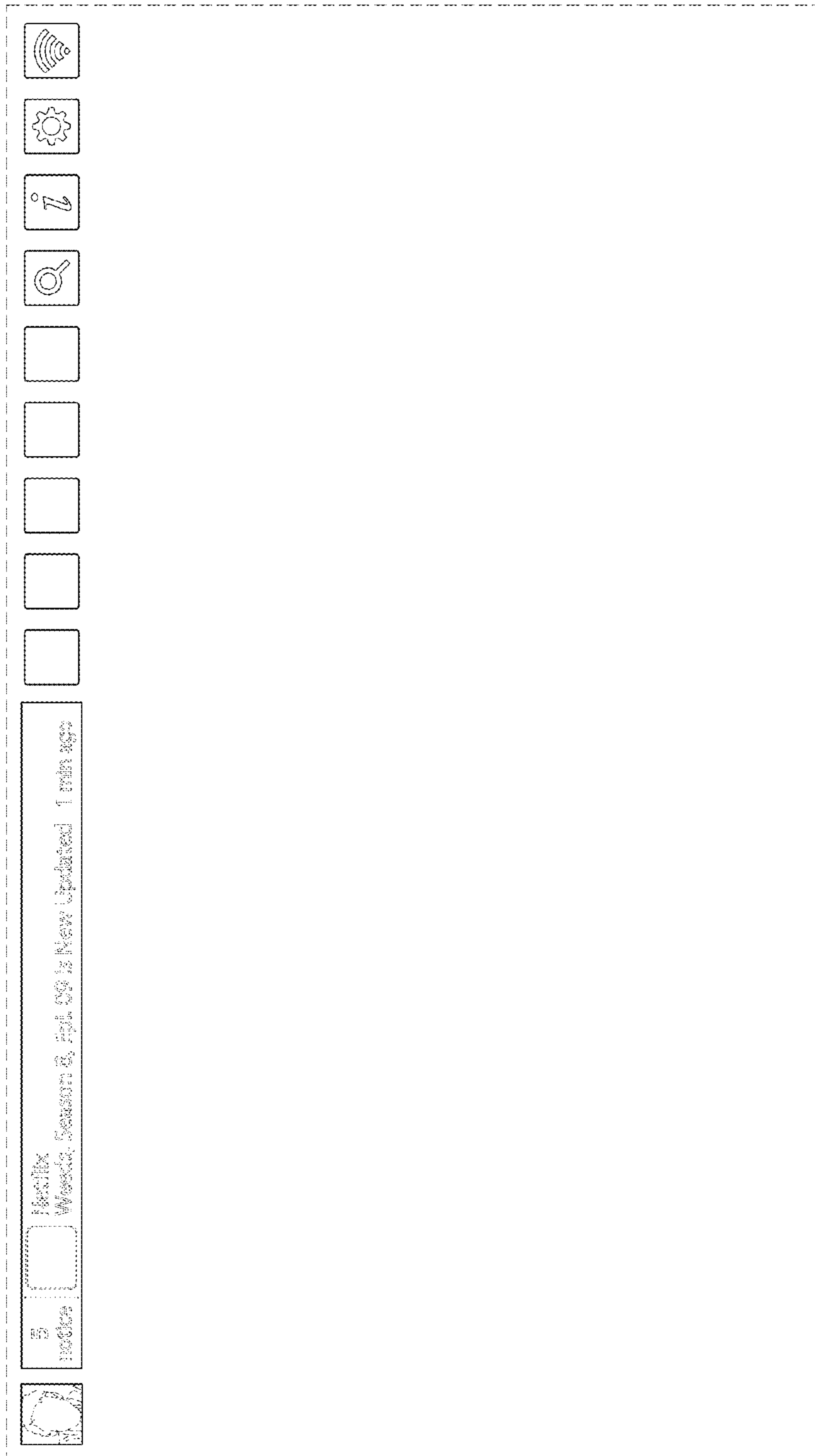

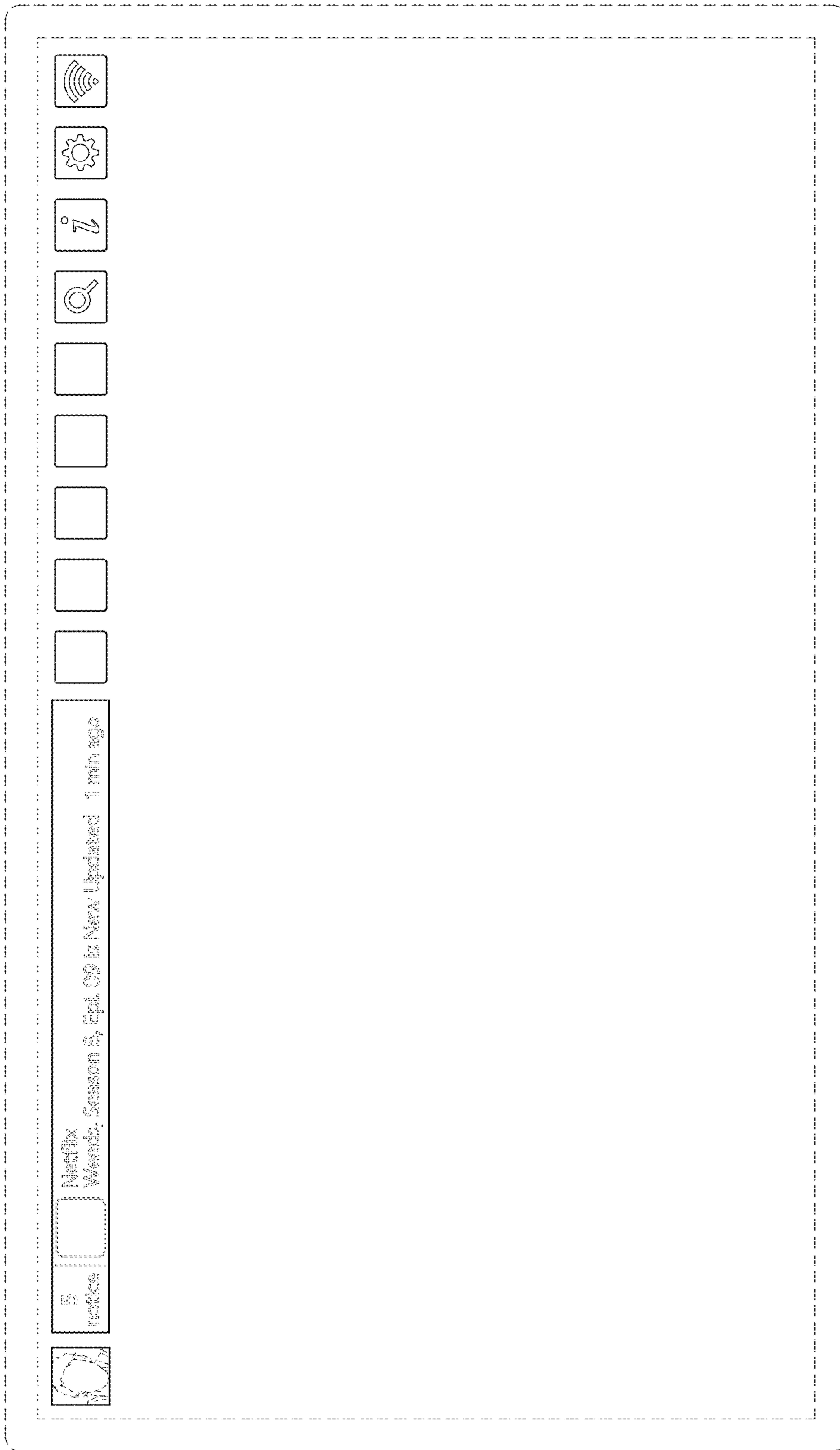
