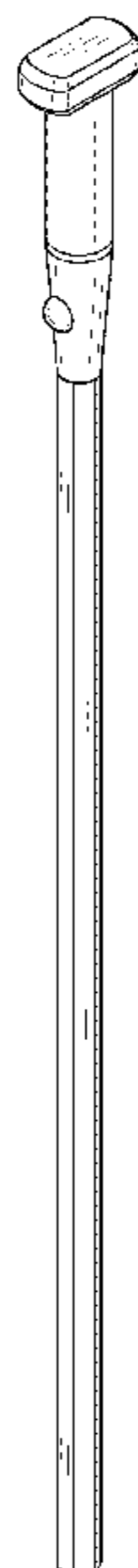

(57) **CLAIM**
The ornamental design for a hexagonal trimmer line, as shown and described.

DESCRIPTION

FIG. 1 is a side view of a hexagonal trimmer line showing my new design, an opposite side view being a mirror image thereof;
FIG. 2 is a front view of the hexagonal trimmer line;
FIG. 3 is a back view of the hexagonal trimmer line;
FIG. 4 is a top view of the hexagonal trimmer line;
FIG. 5 is a bottom view of the hexagonal trimmer line; and,
FIG. 6 is a top front side perspective view of the hexagonal trimmer line.

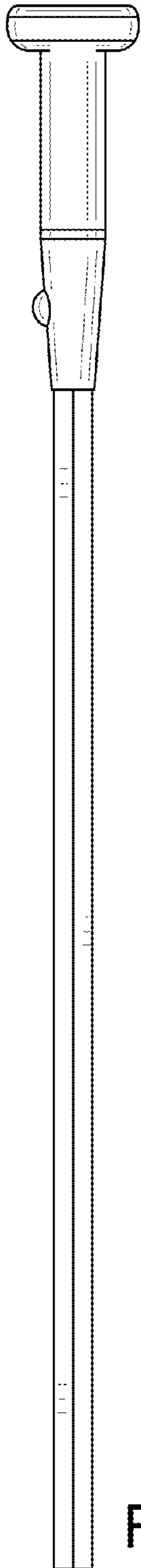

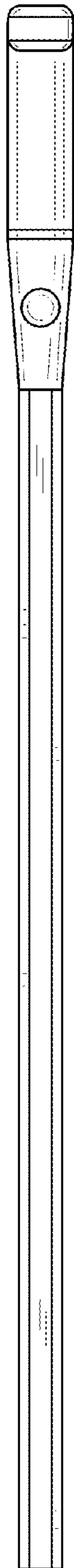

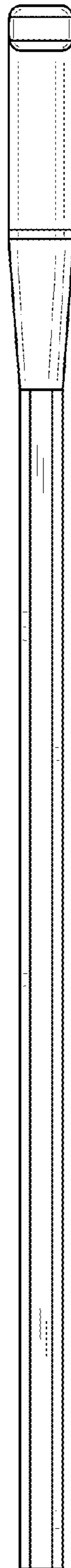

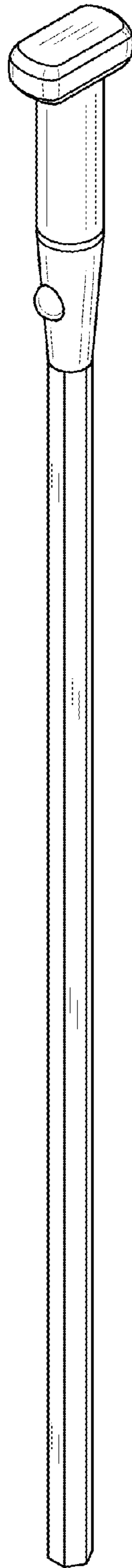
