FIG. 21 is a top, front perspective view of the third embodiment;

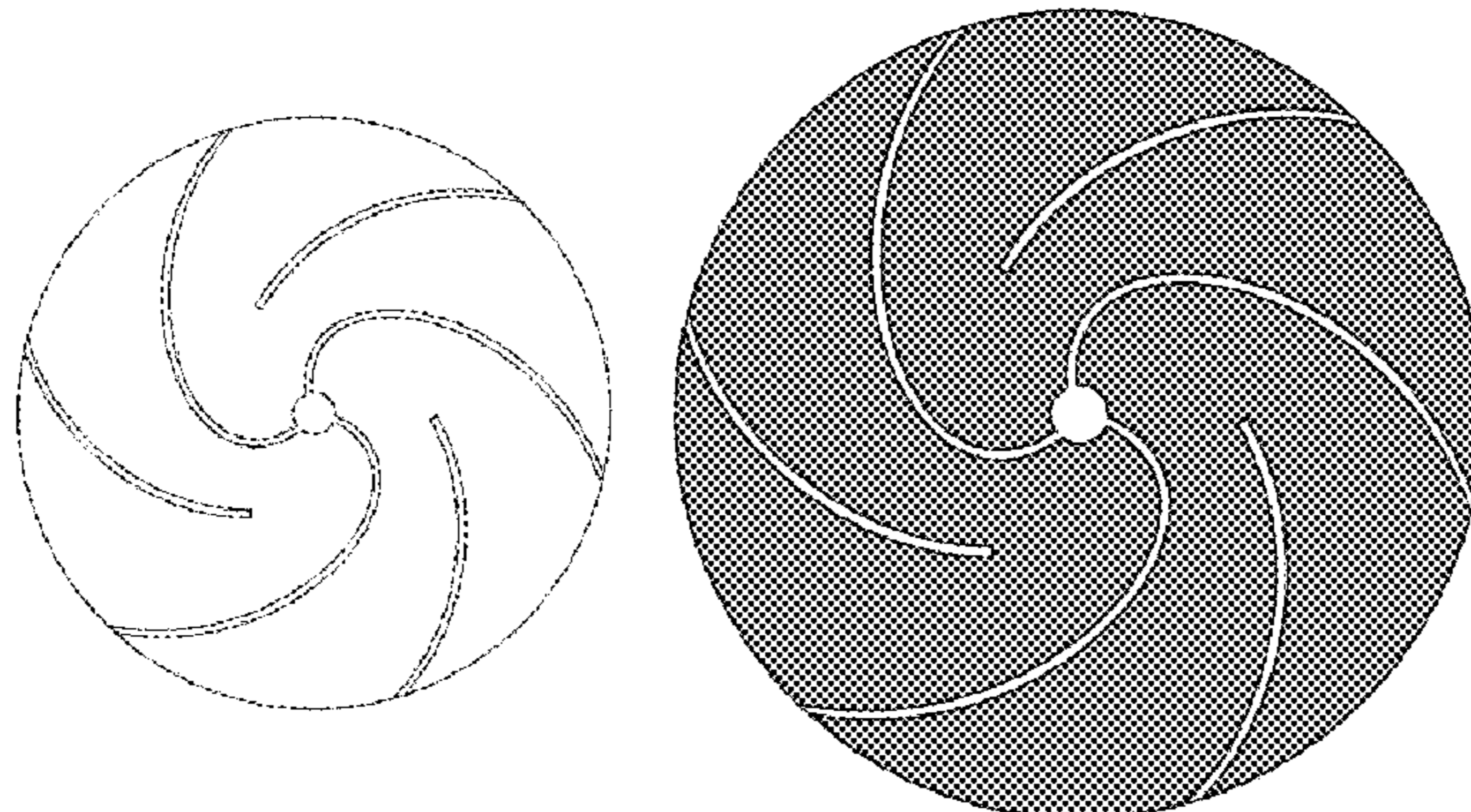


FIG. 22 is a top plan view of a fourth embodiment of my ornamental design for a grinding disc;

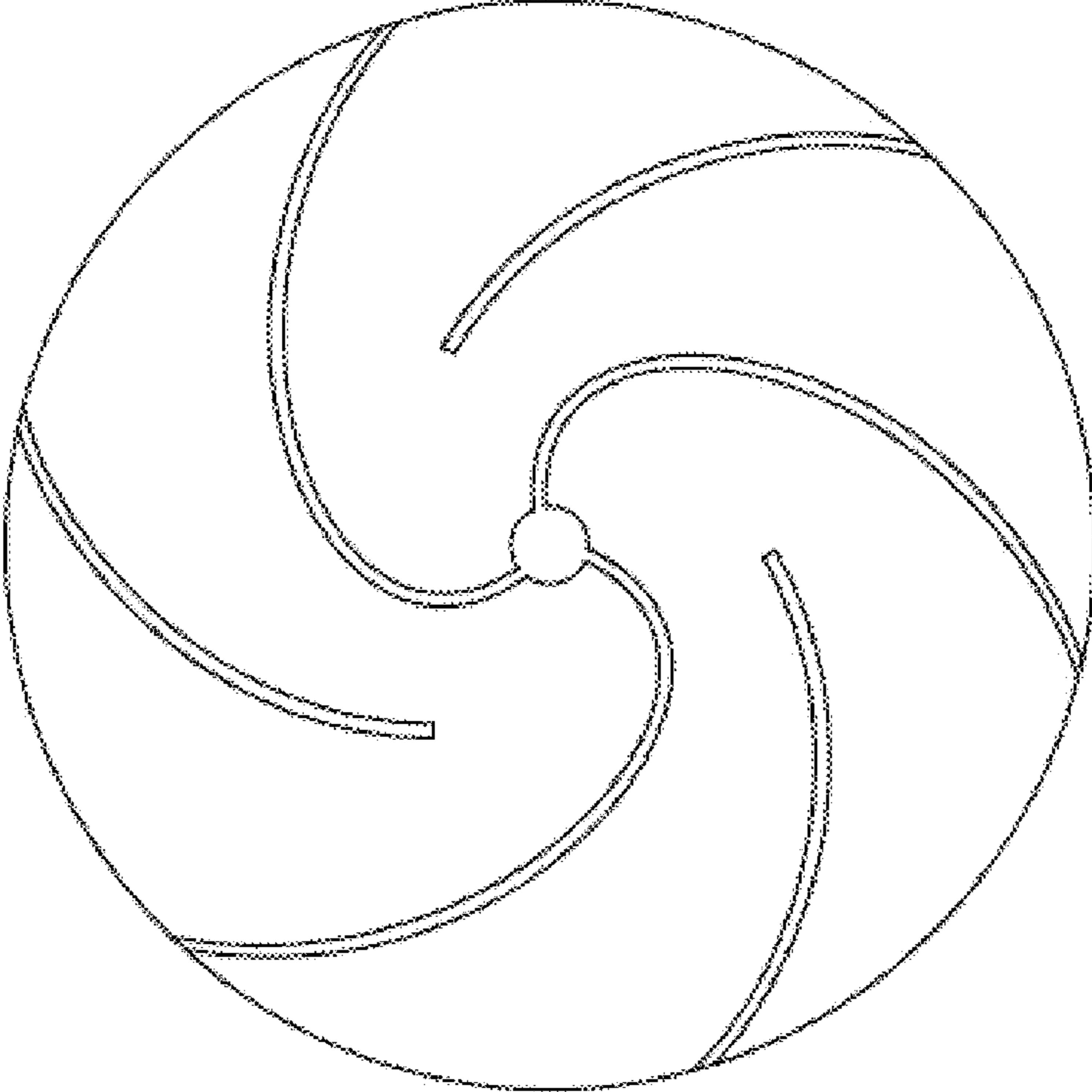

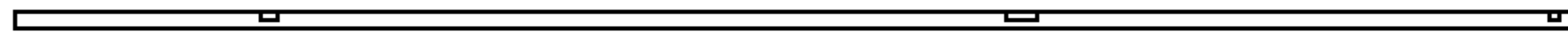

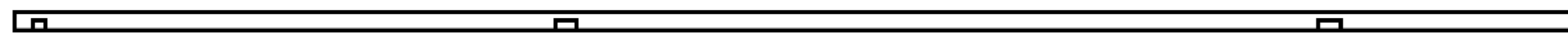

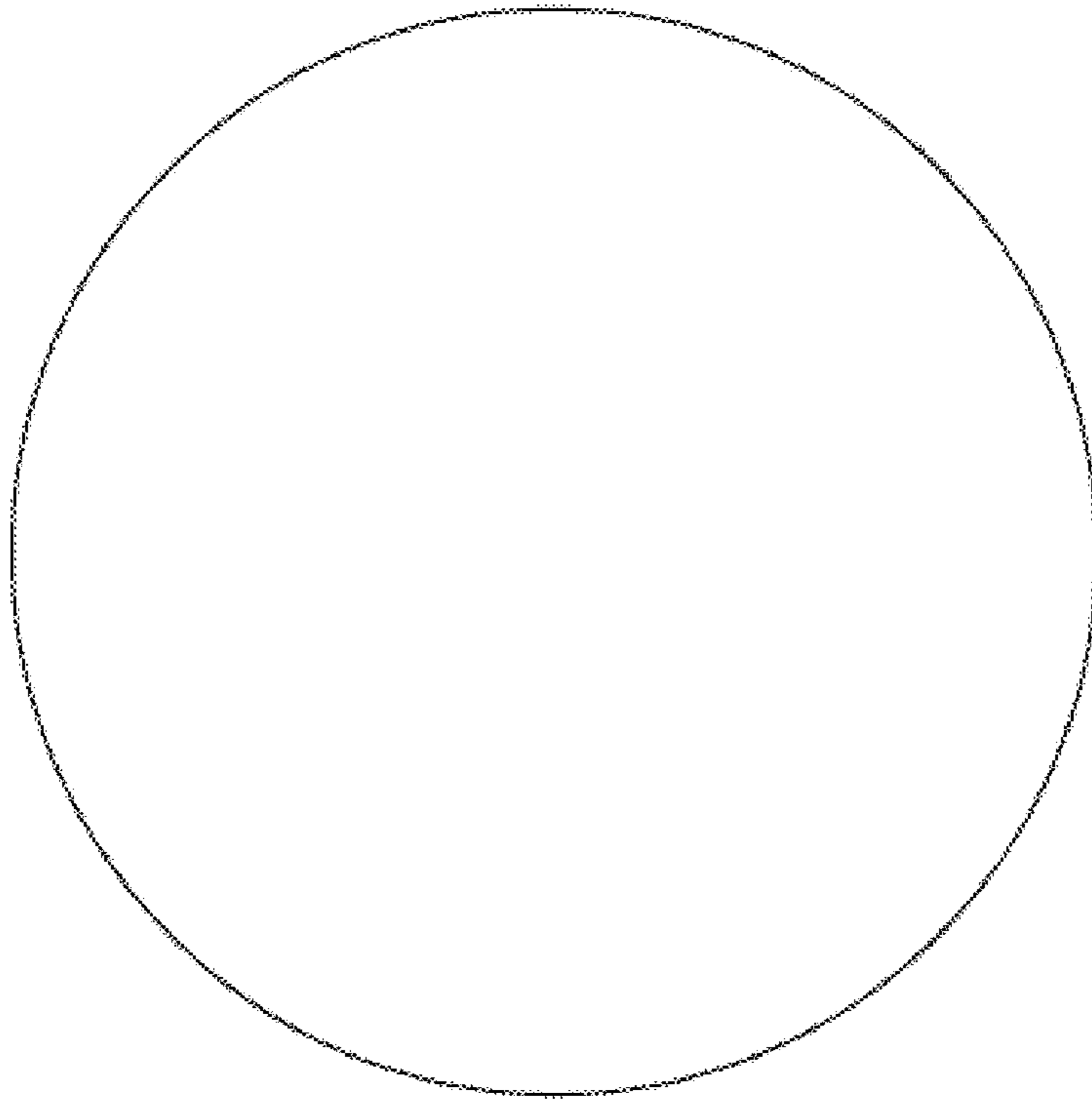

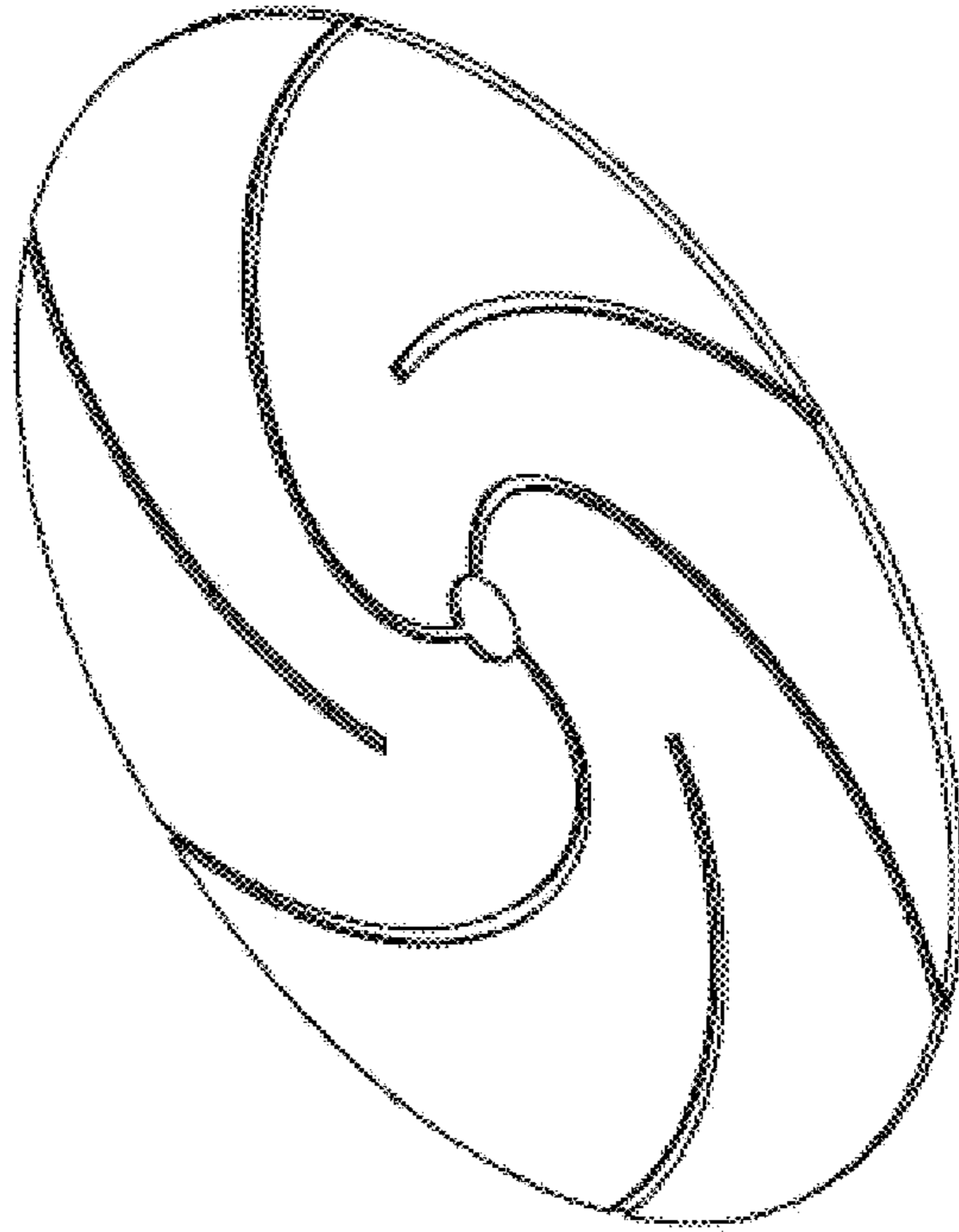

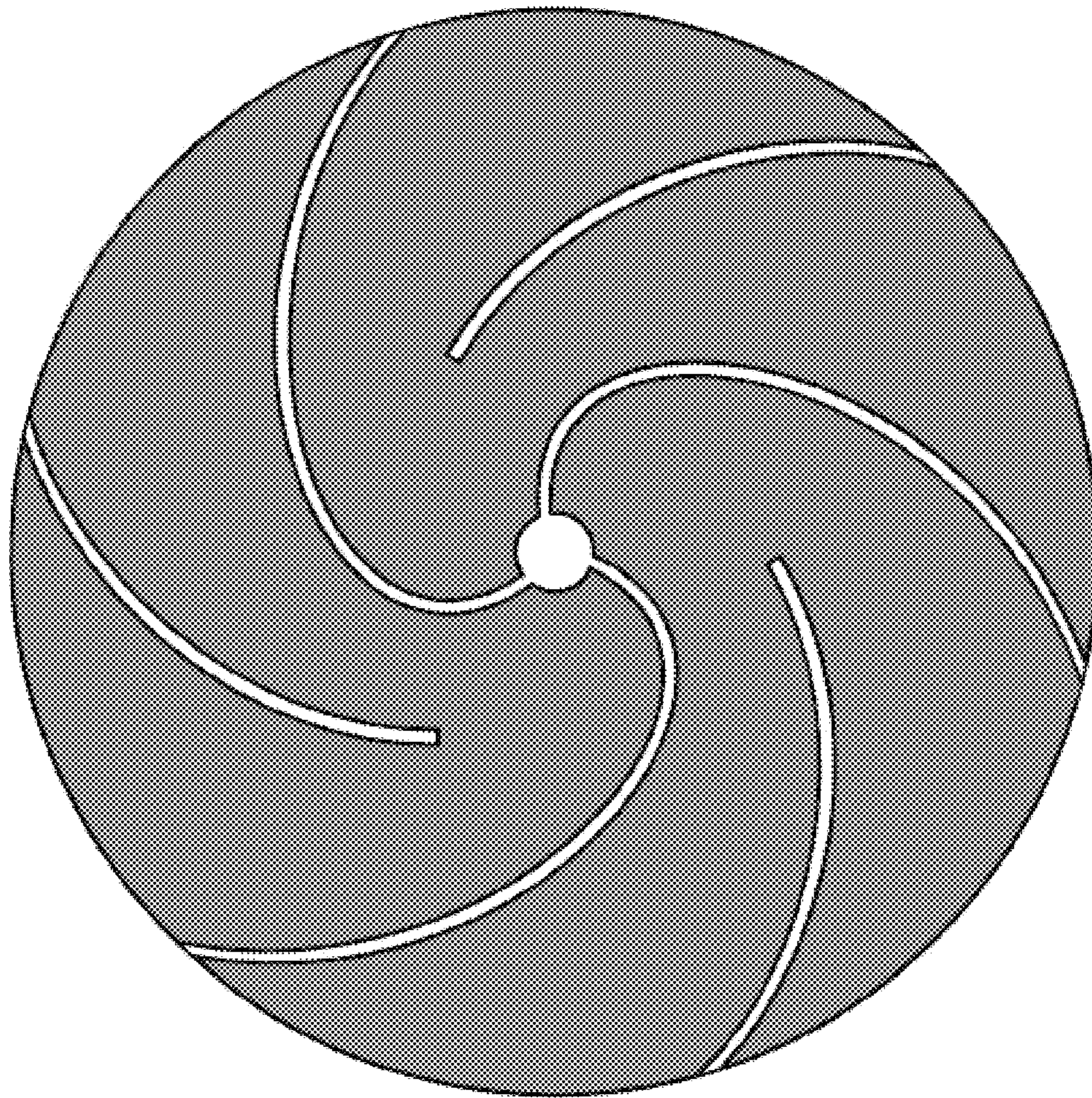

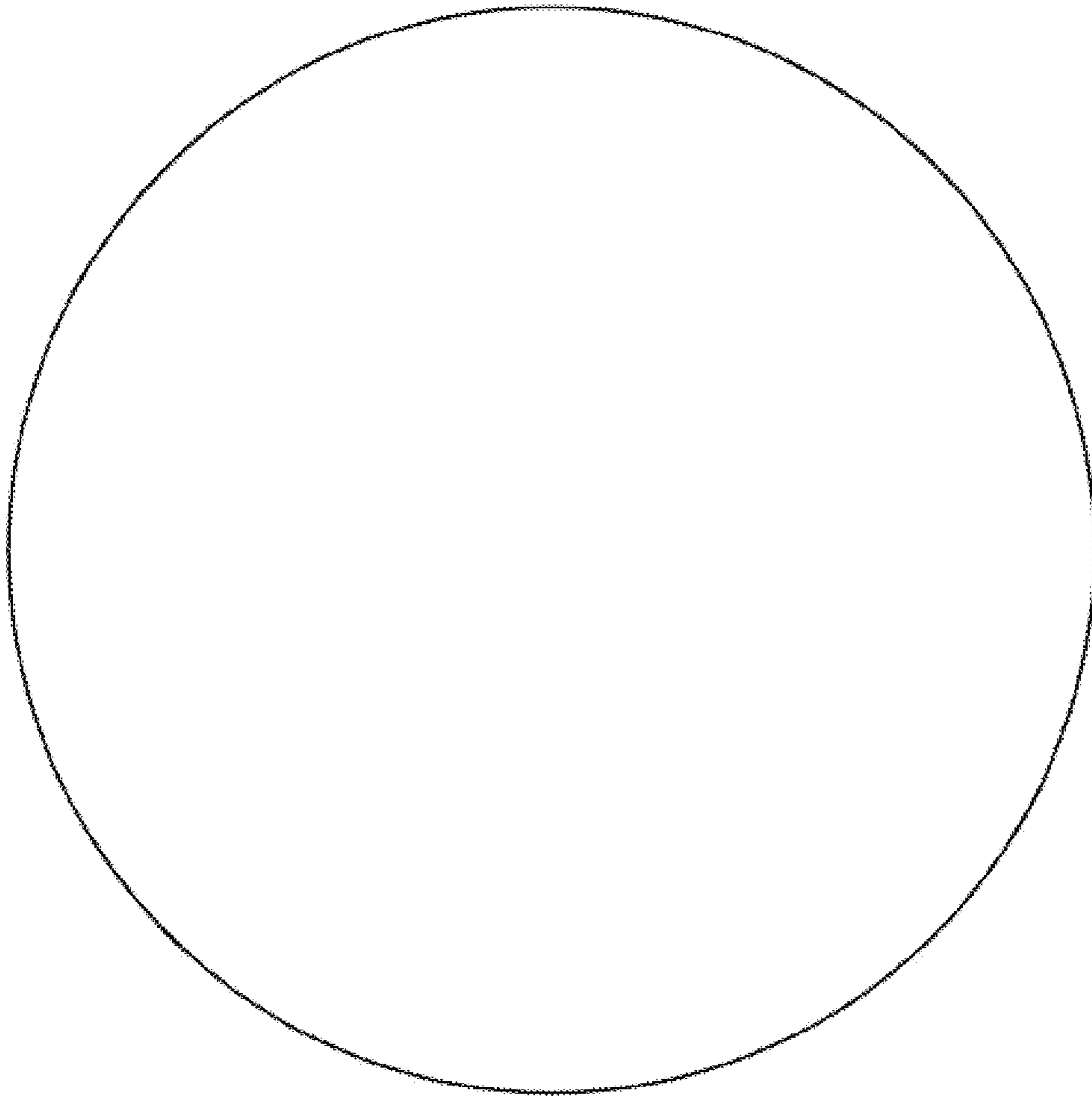

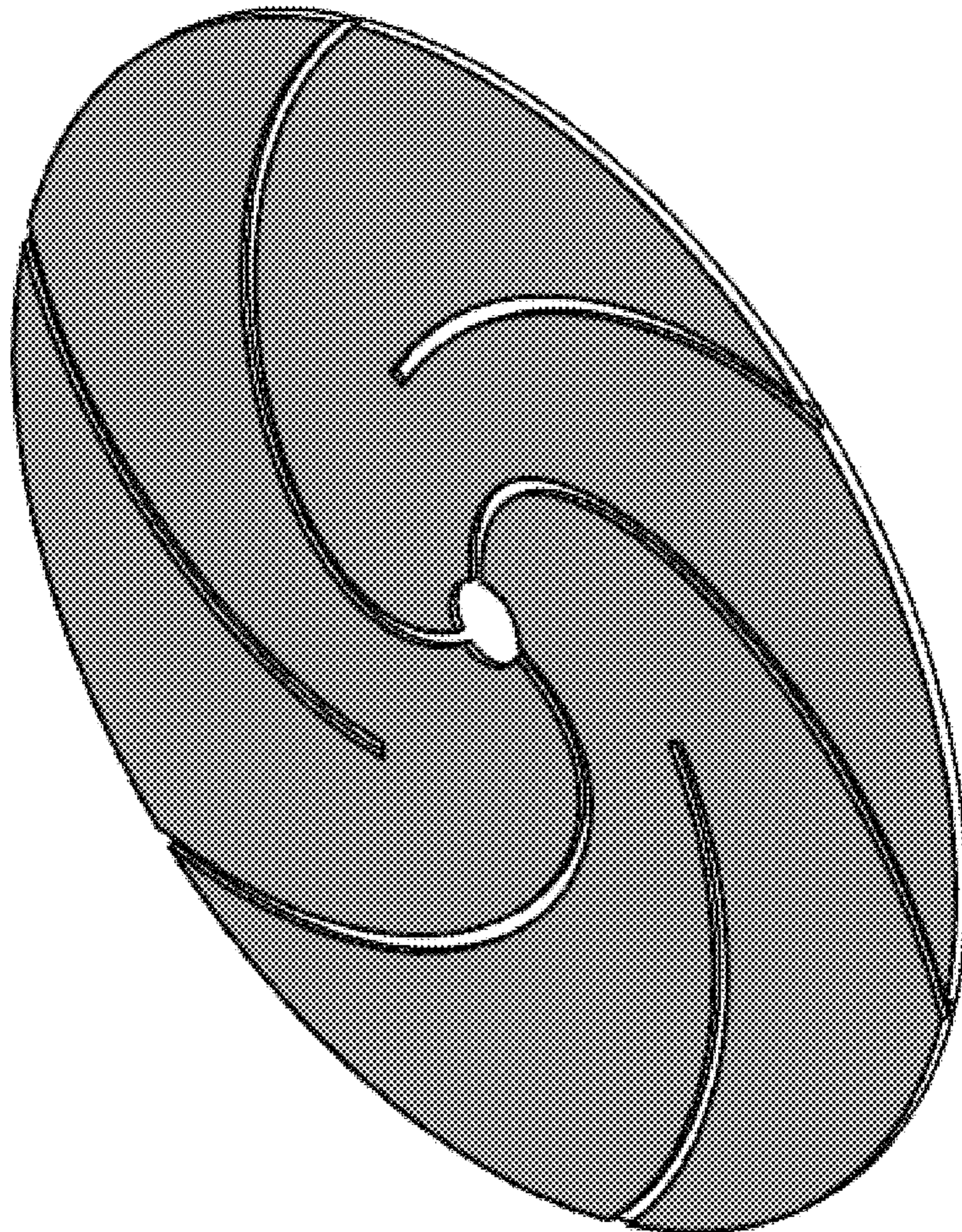

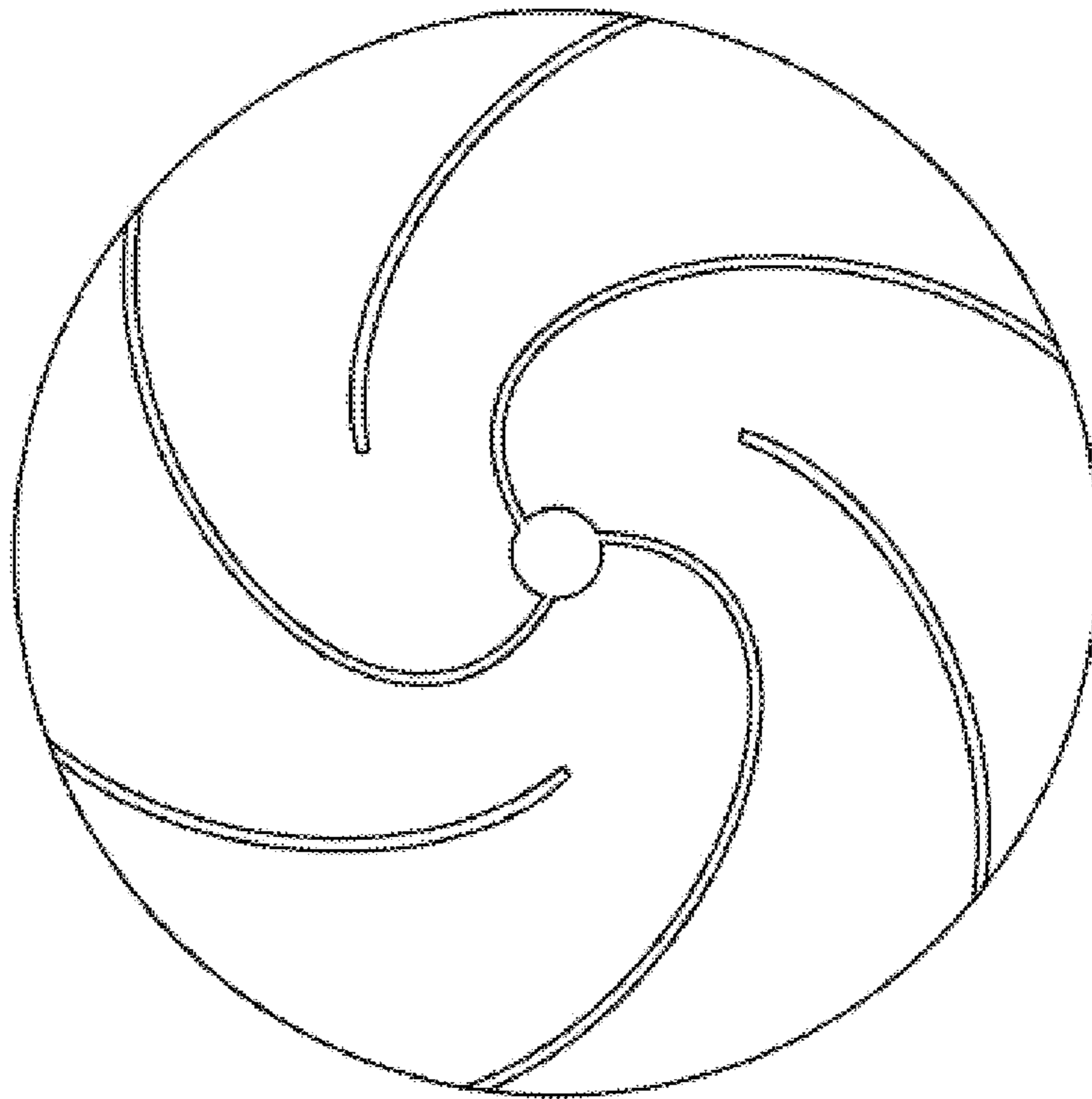

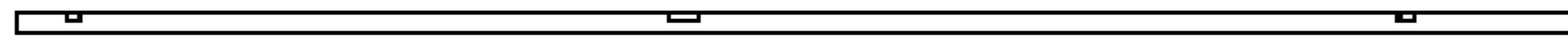

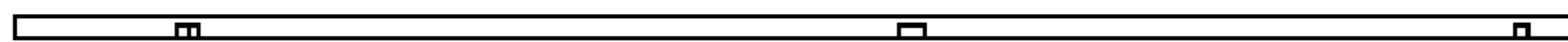

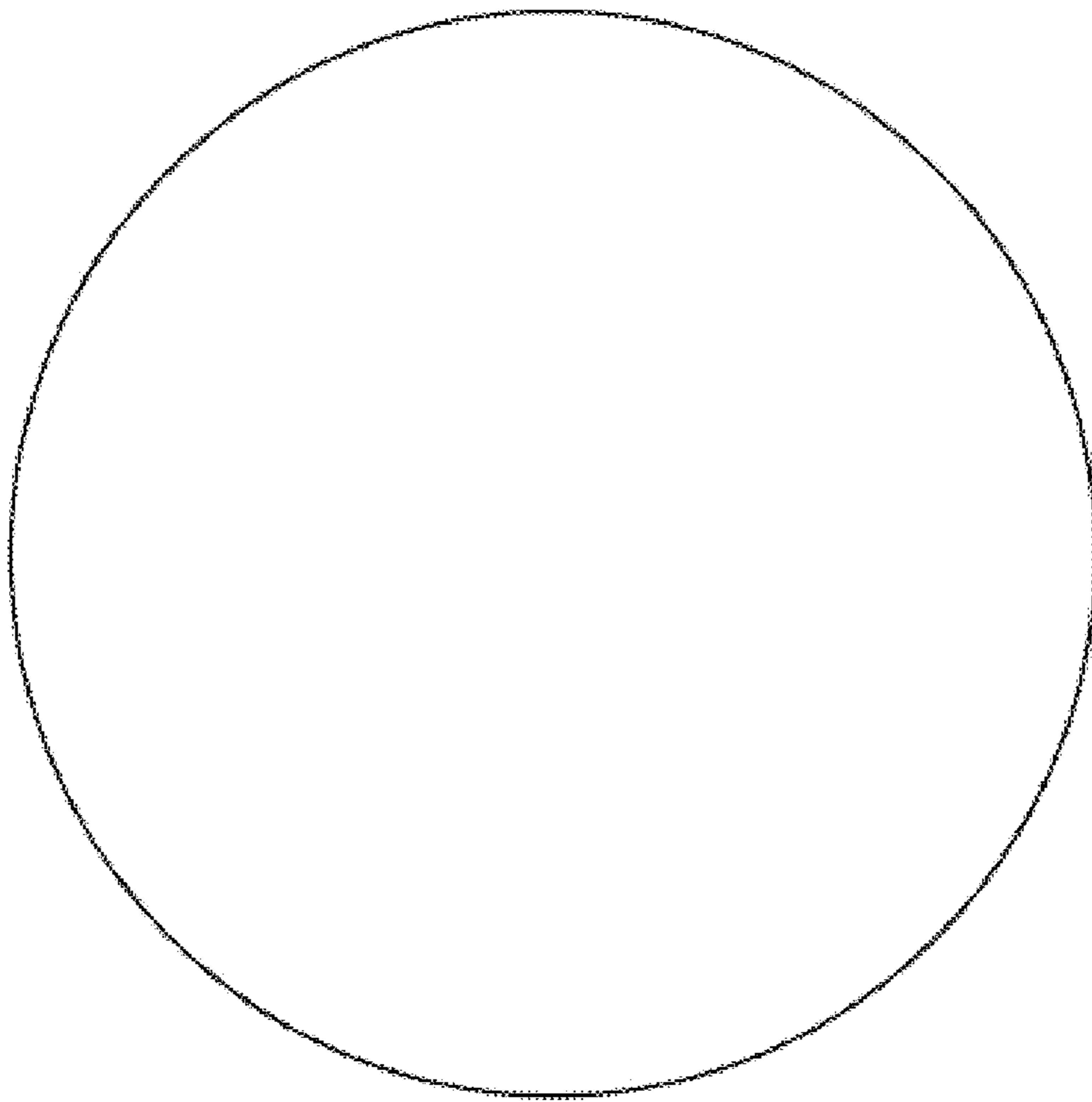

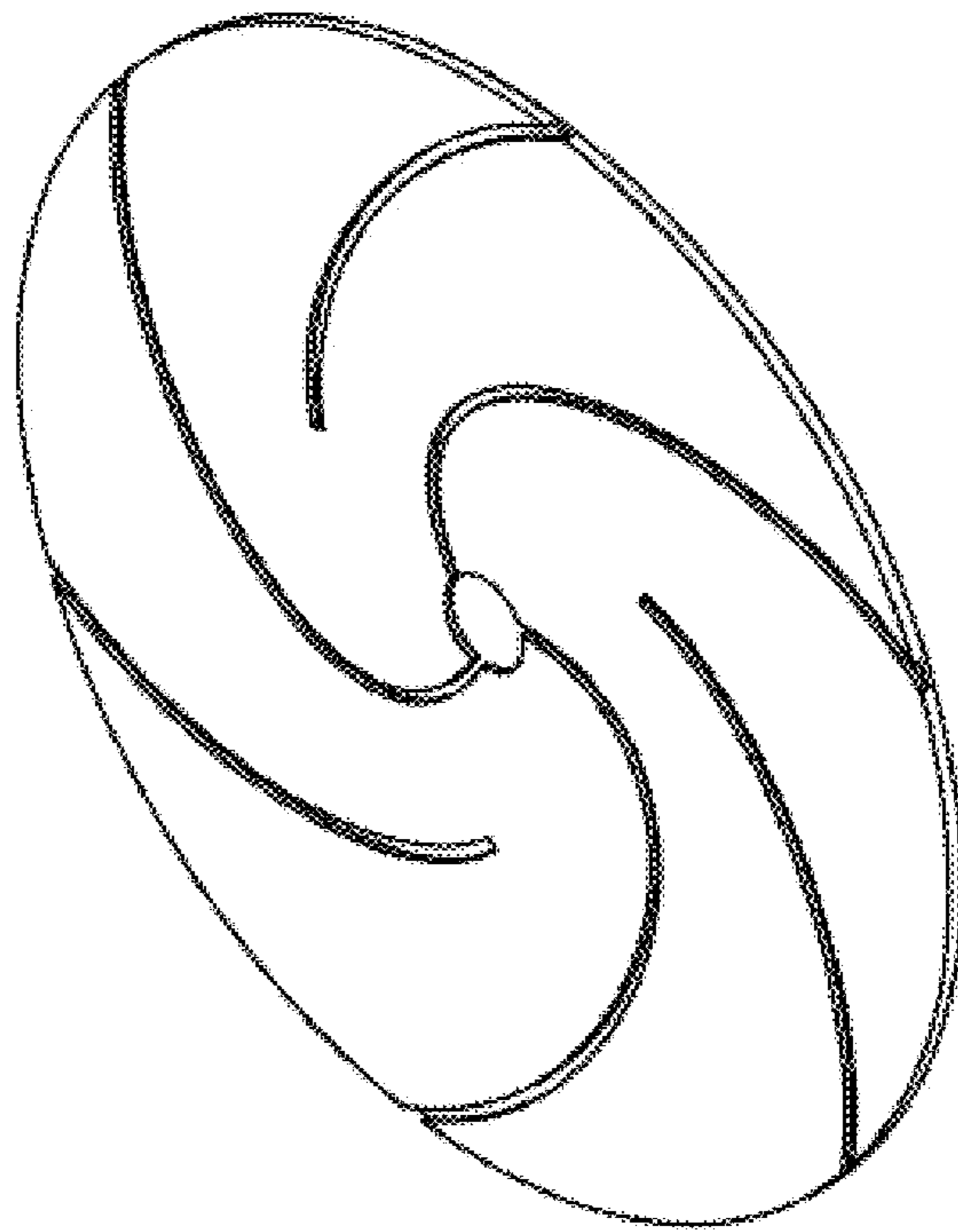

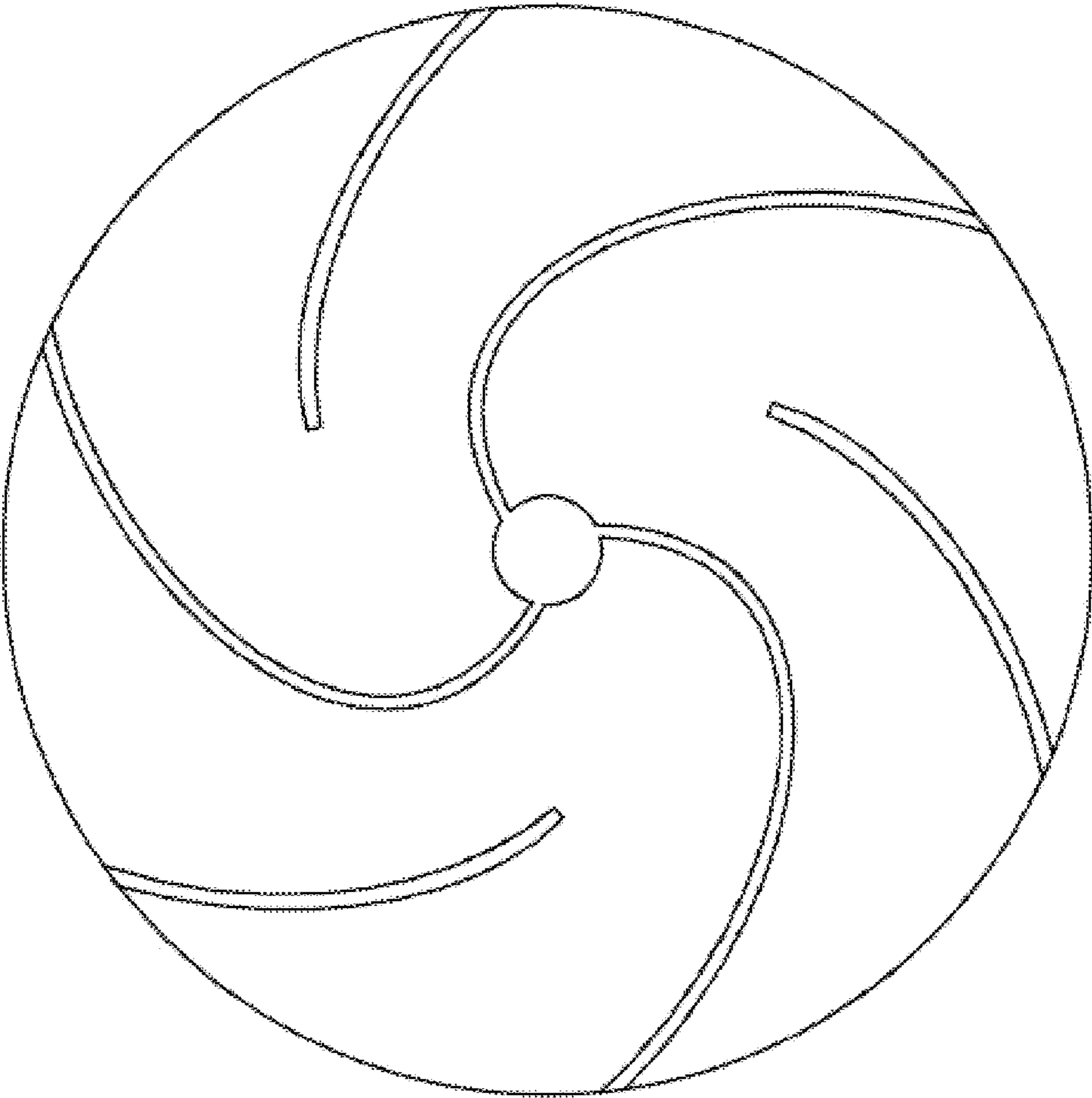

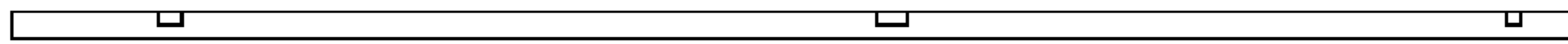

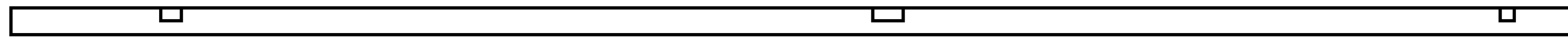

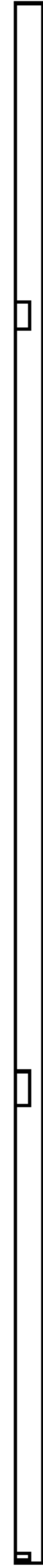

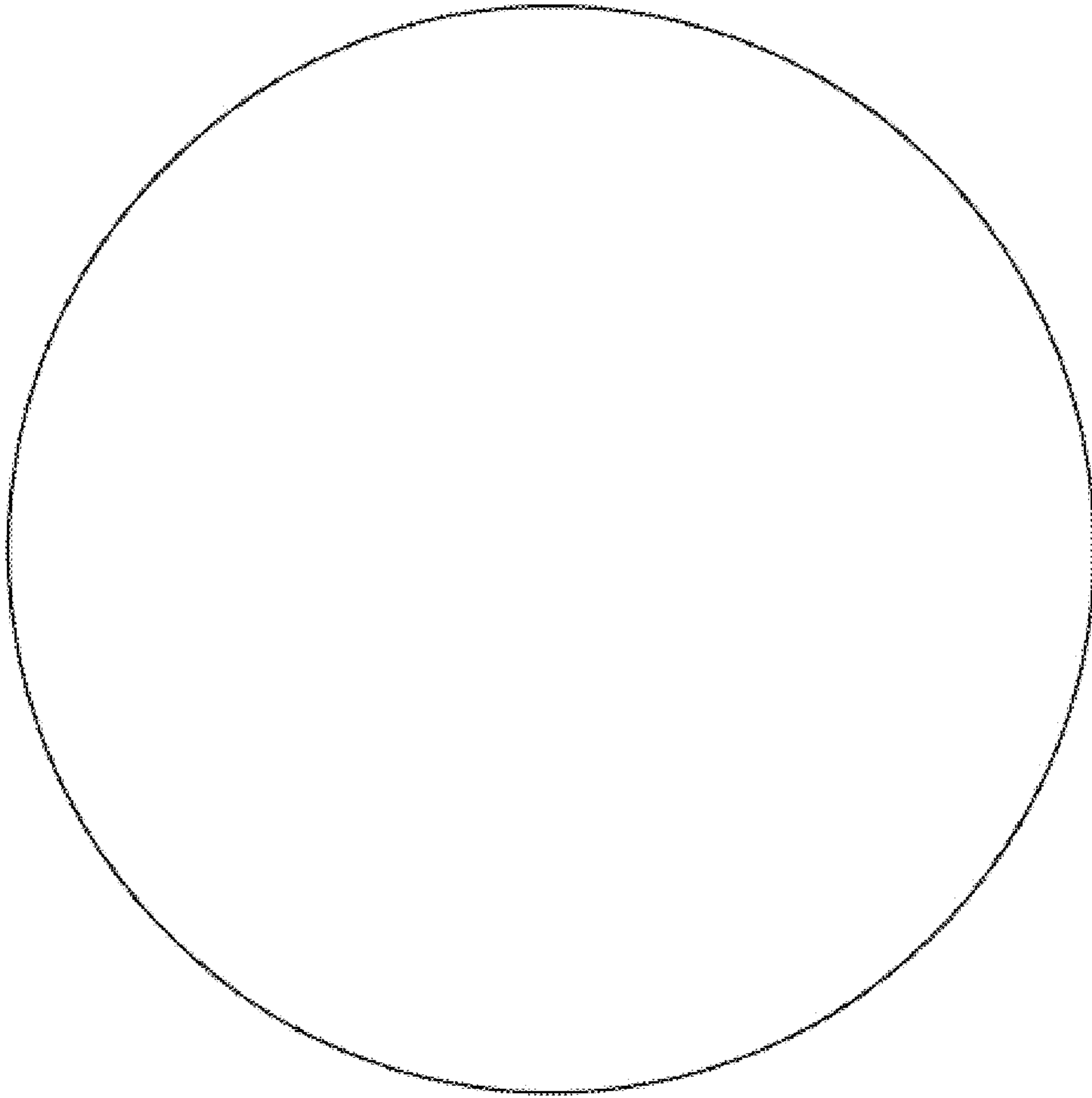

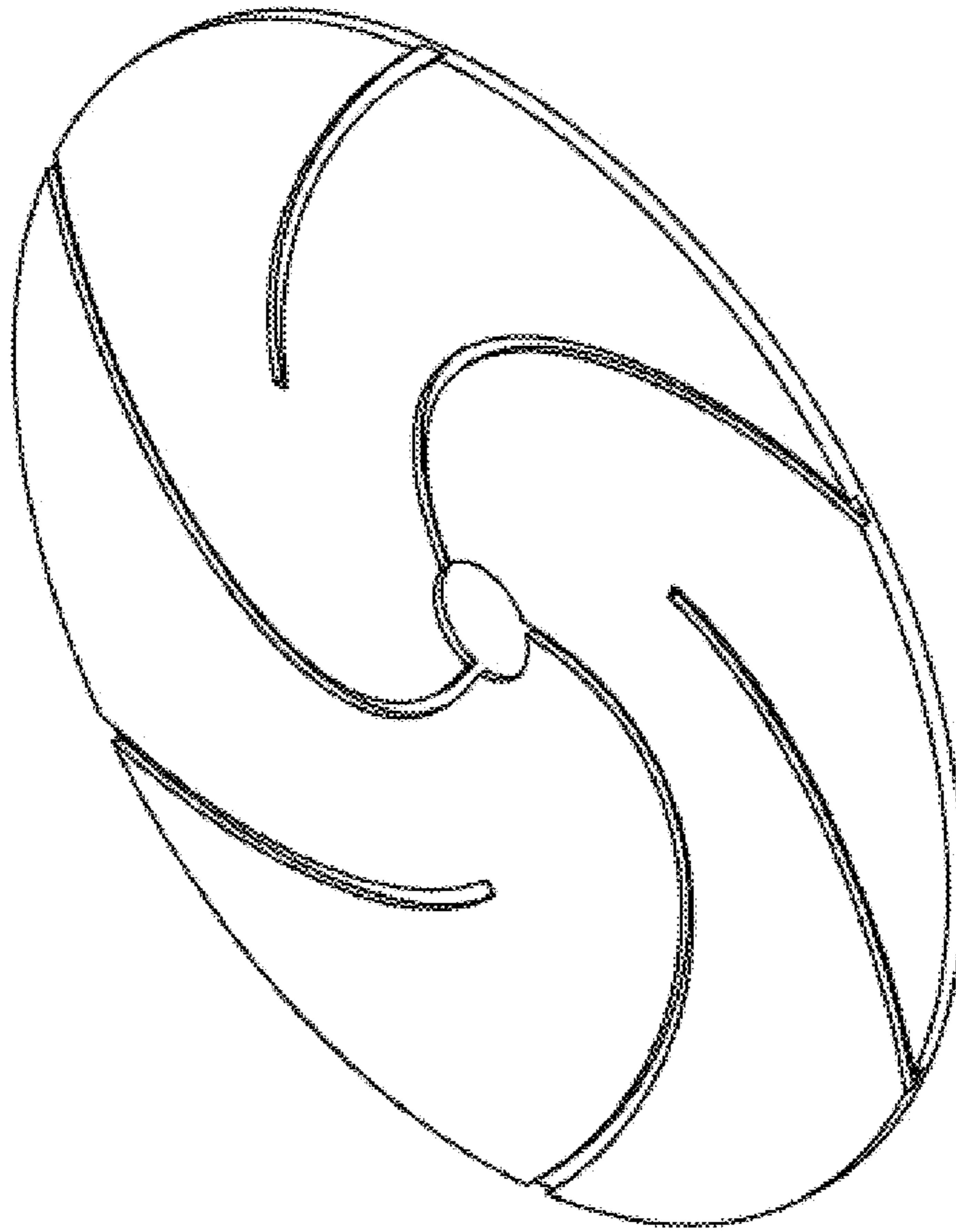

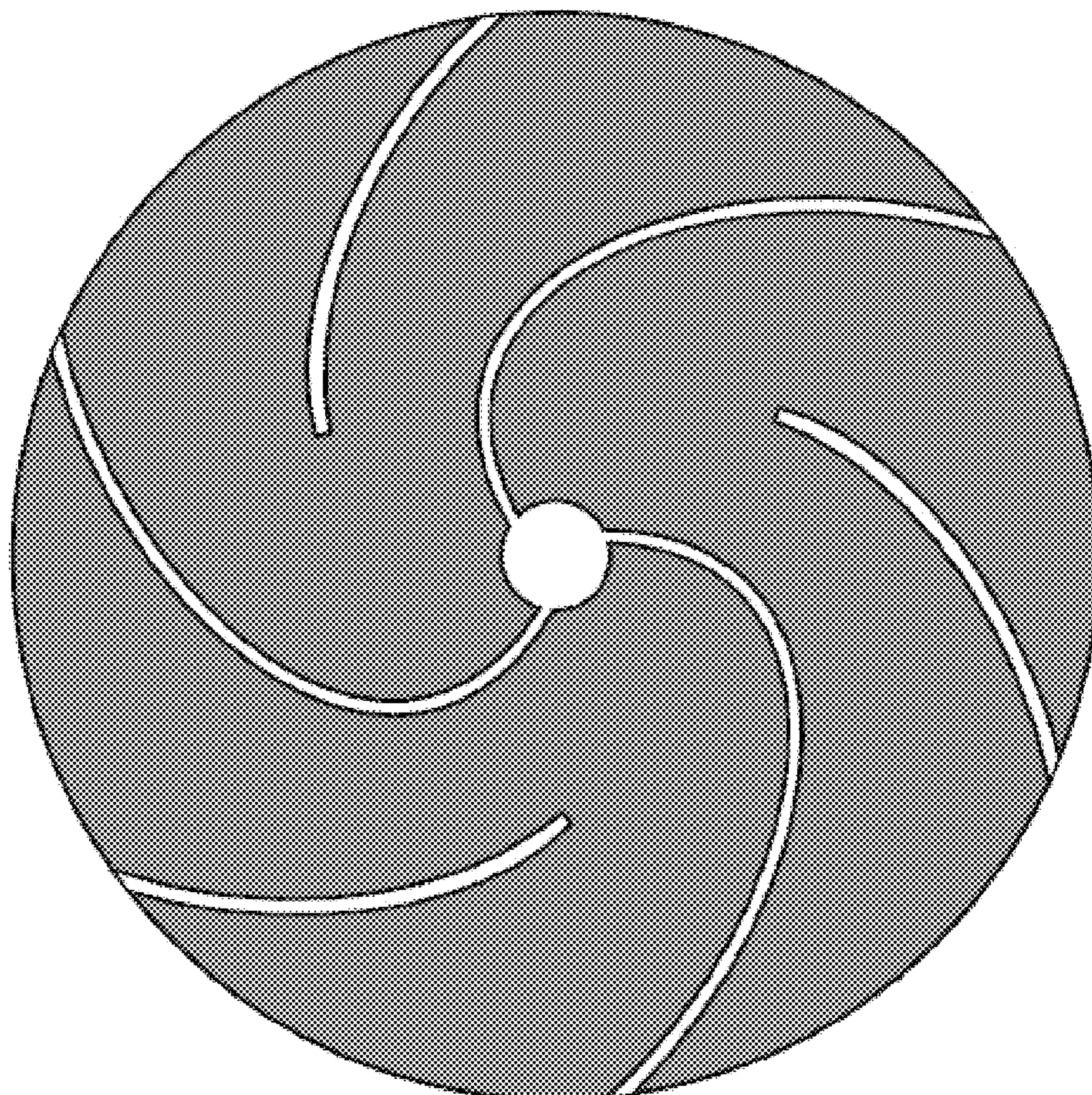

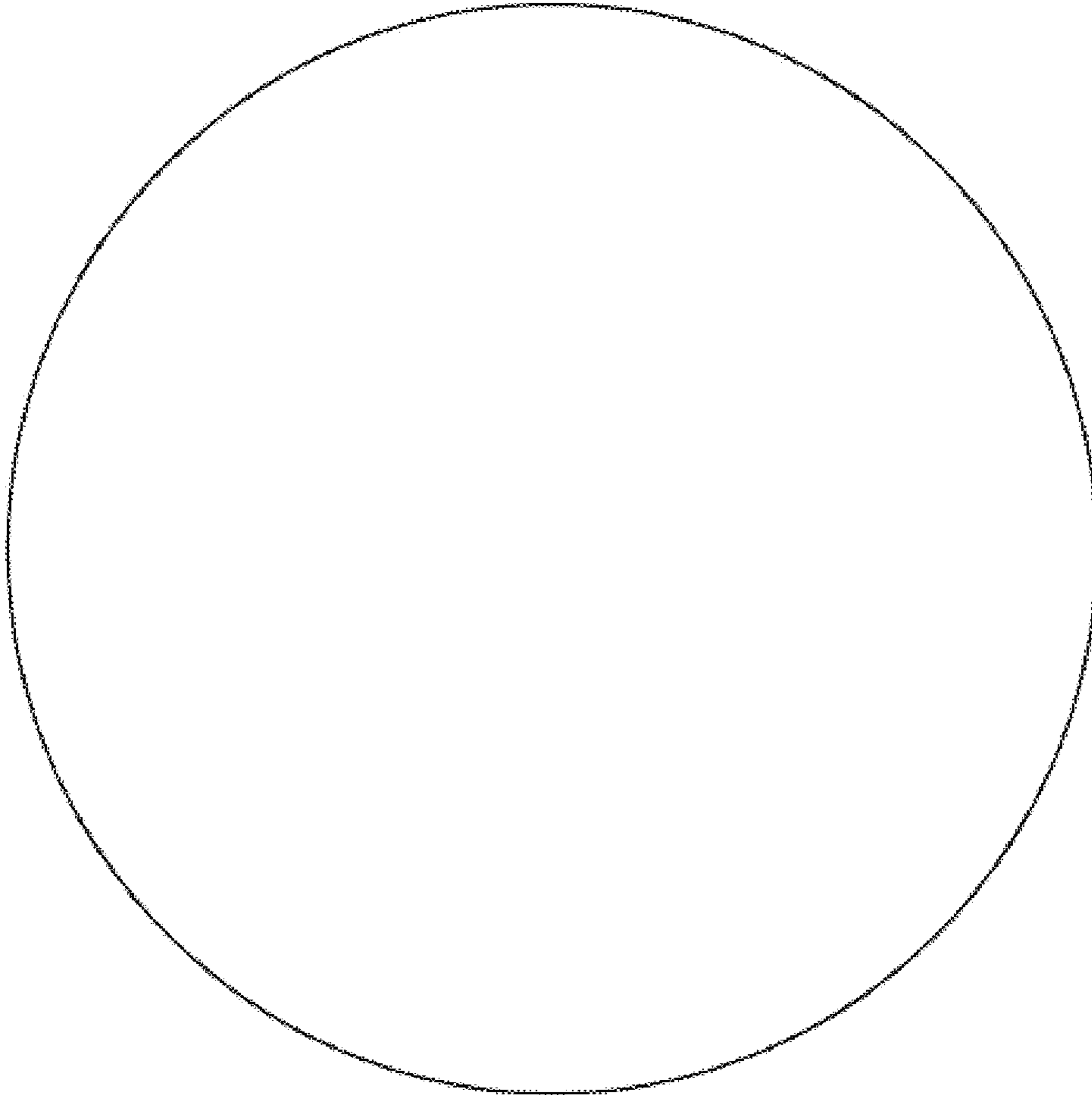

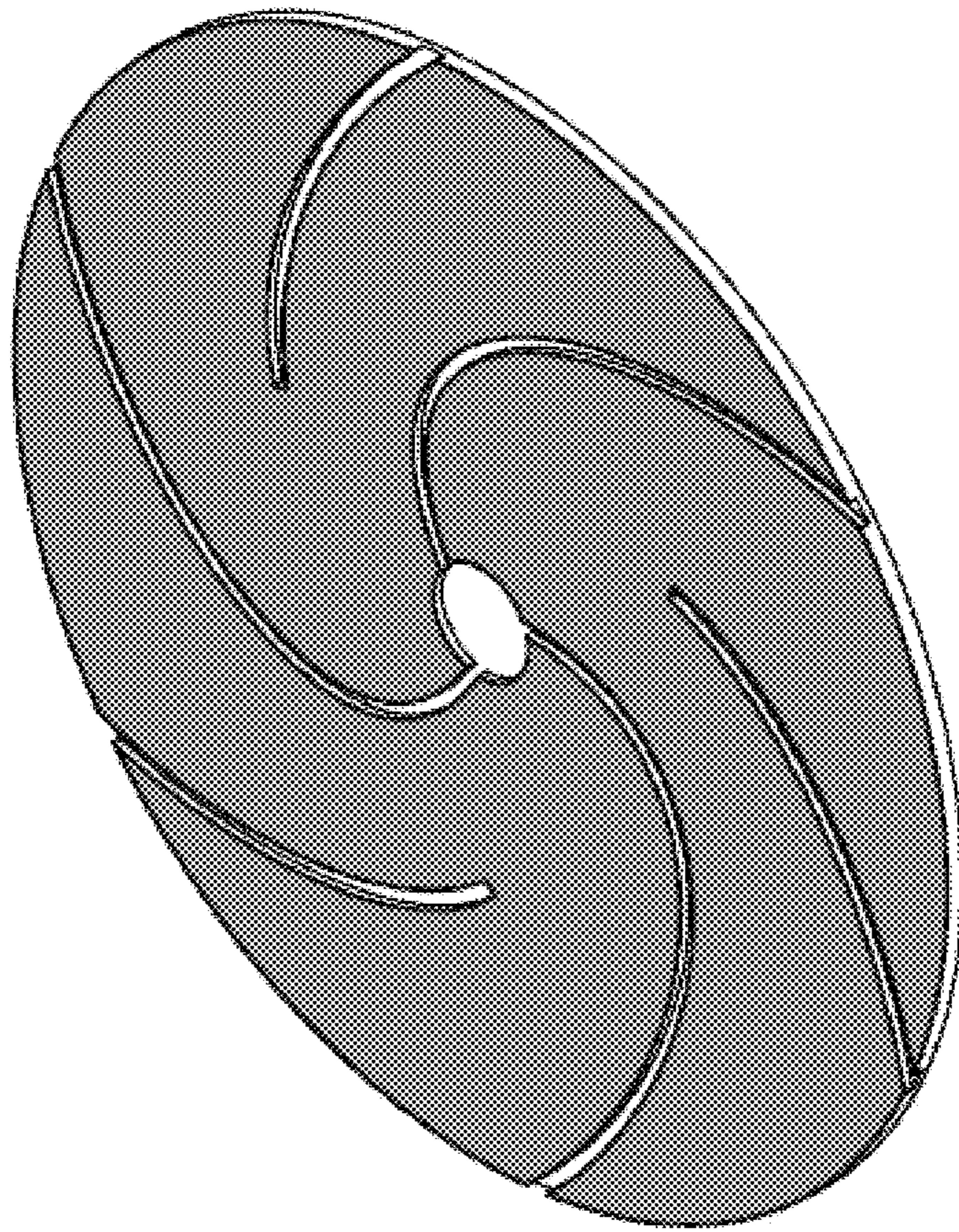

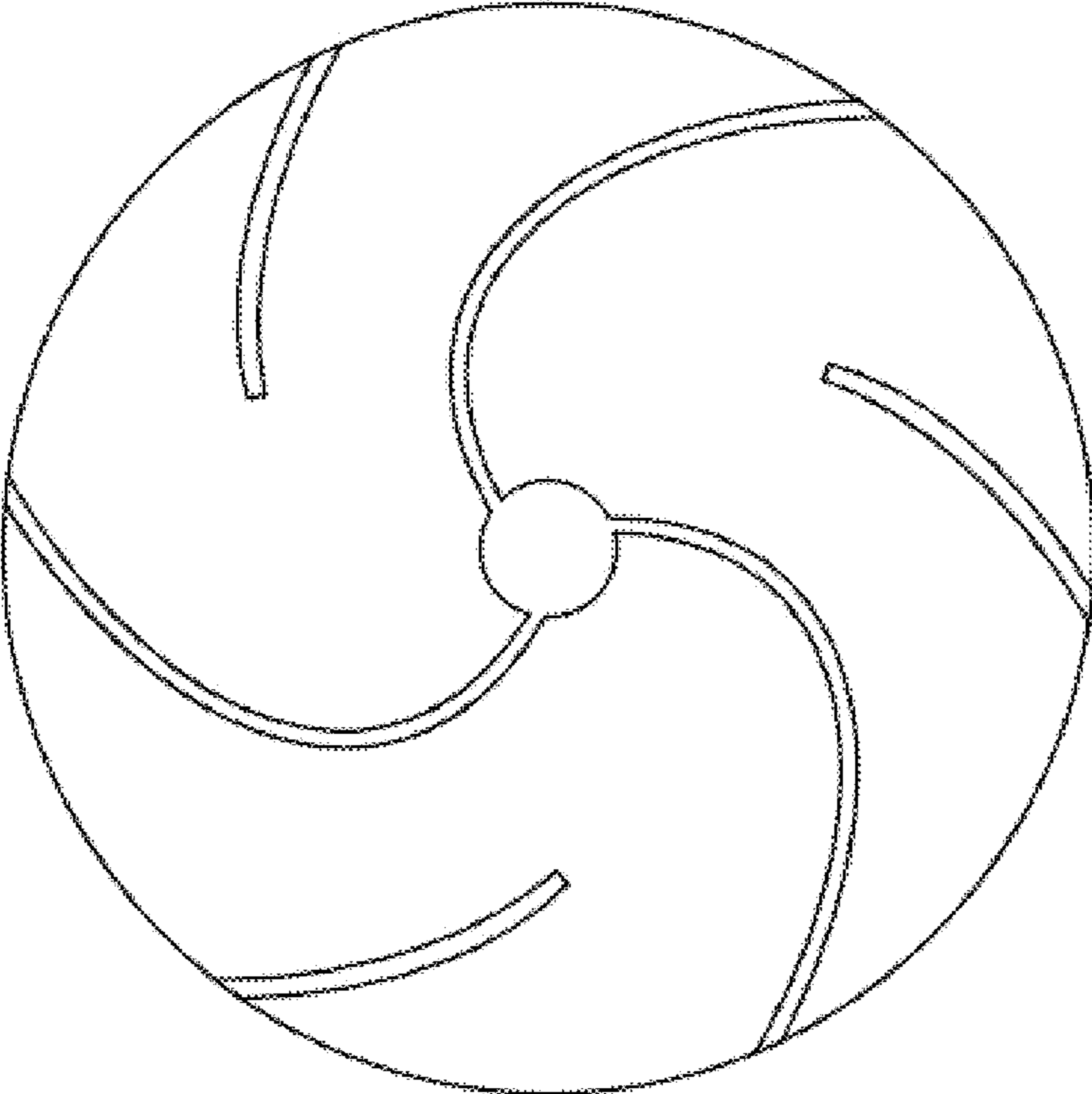

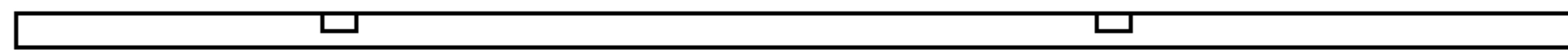

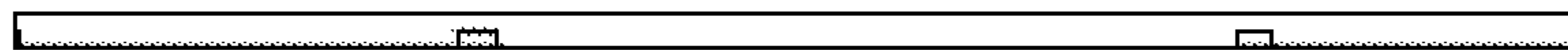

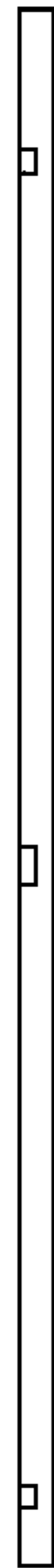

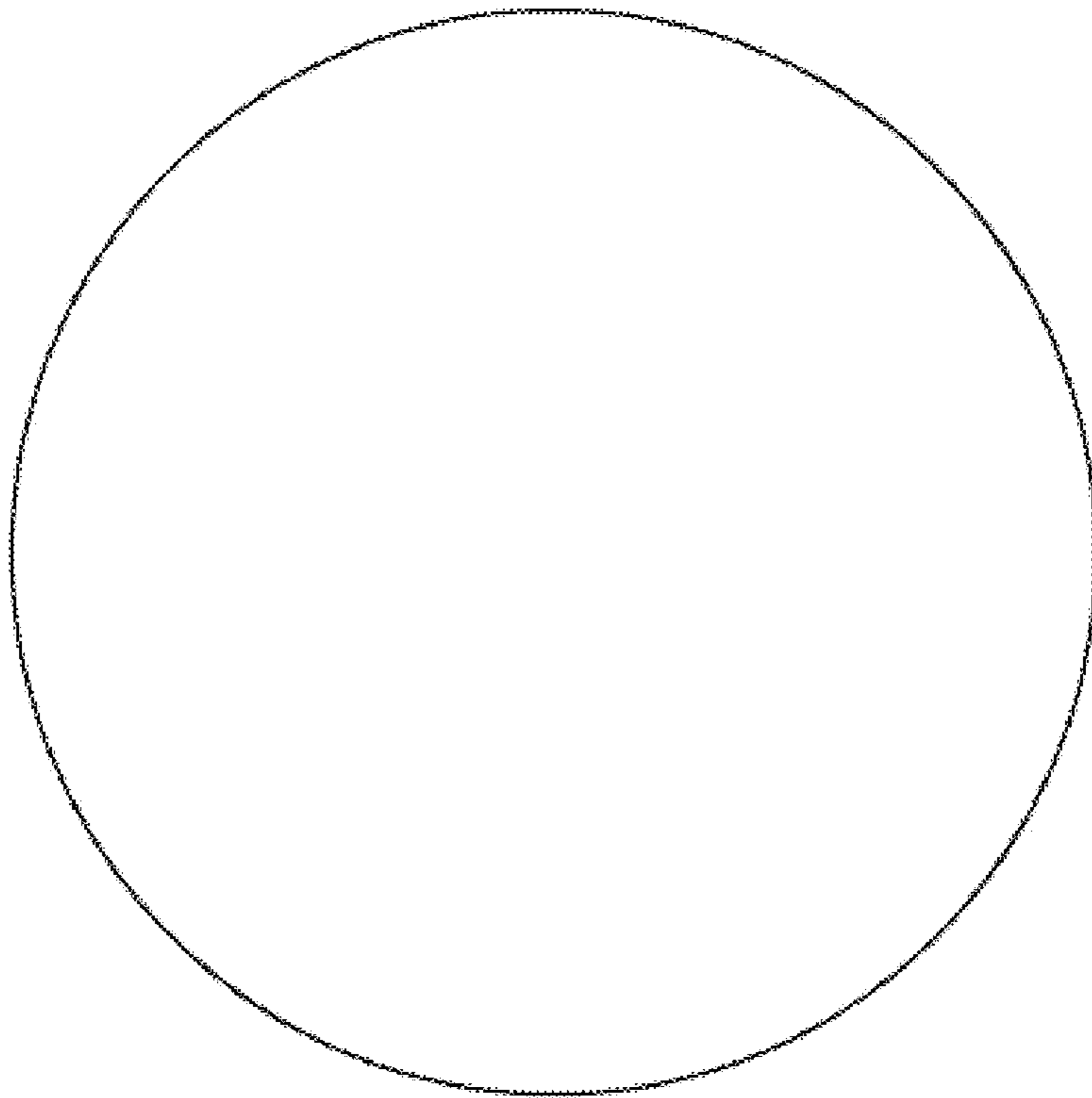

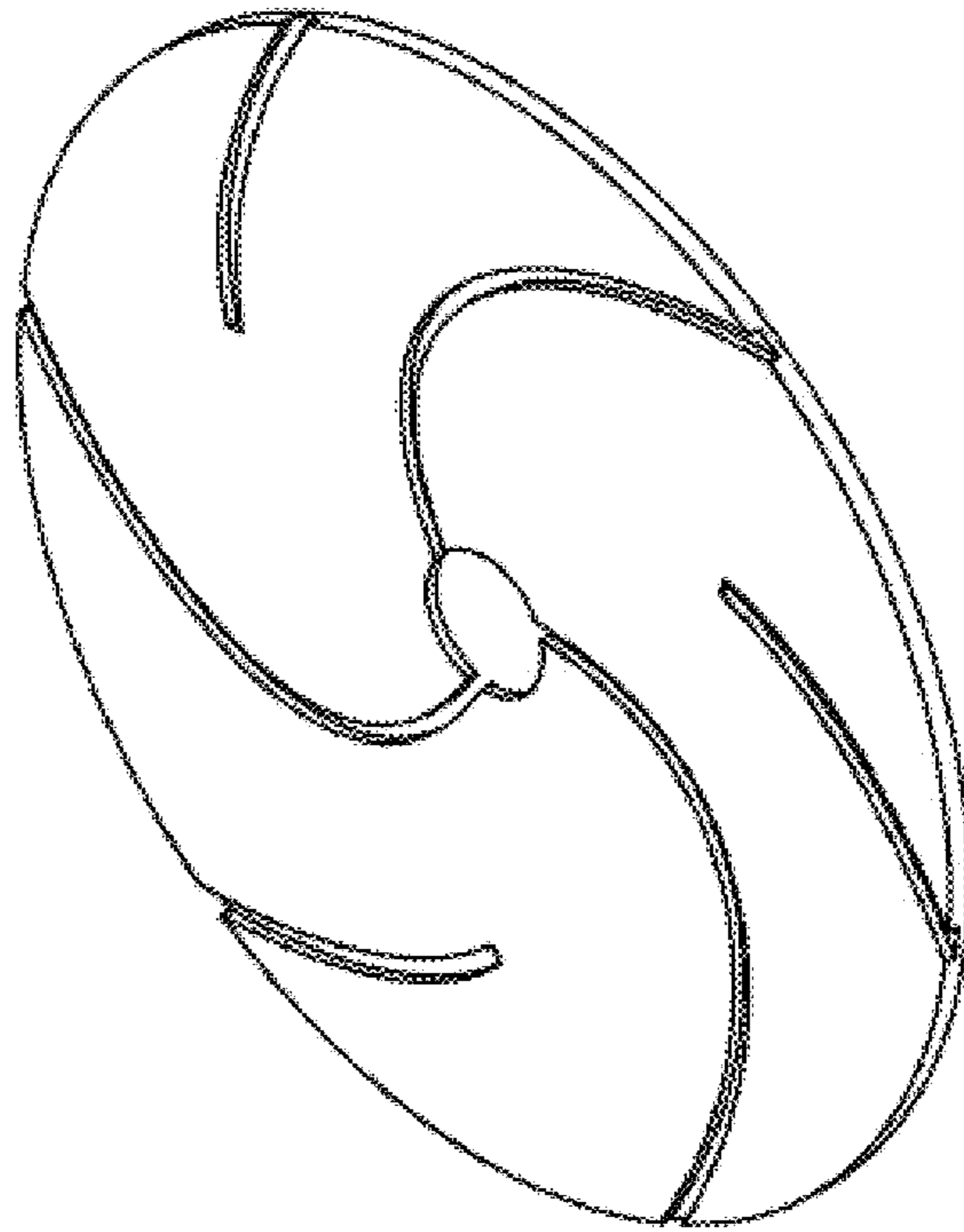
