(57) **CLAIM**
The ornamental design for an adhesive tape for cleaning with patterns printed thereon, as shown and described.

DESCRIPTION

FIG. 1 is a surface view of an adhesive tape for cleaning with patterns printed thereon showing our new design, wherein English words and numerals are indicated by broken lines; and, FIG. 2 is a reference surface view thereof, wherein the broken lines are indicated by solid lines. 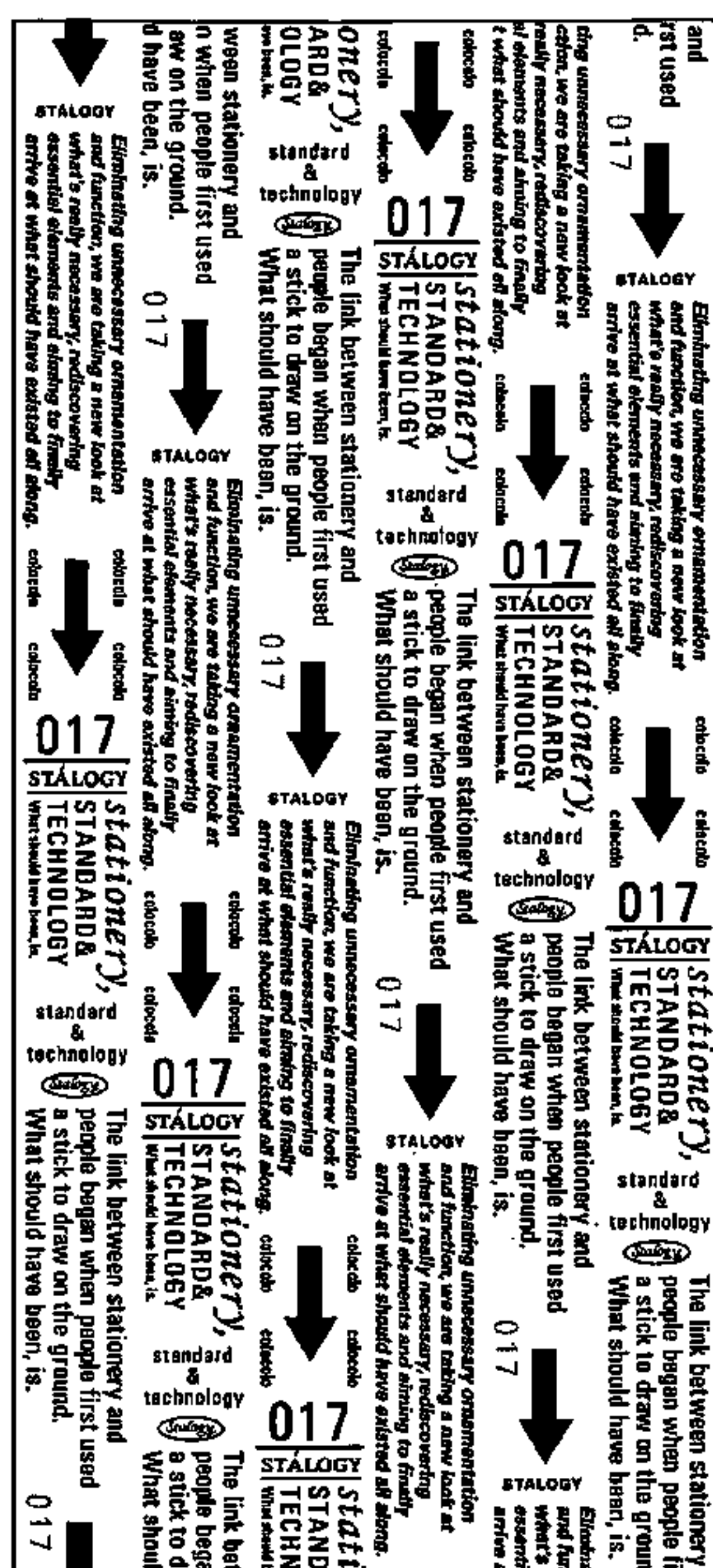
