(57) **CLAIM**

I claim the ornamental design for a casino gaming cloth, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a first embodiment of a casino gaming cloth embodying my new design;

 FIG. 5 is a top plan view of a fifth embodiment thereof; and,

 The bottom surface and the side surfaces are not shown and do not form any part of the claimed design.  
 The grey scale surface shading designates different colored regions of the cloth layout.
