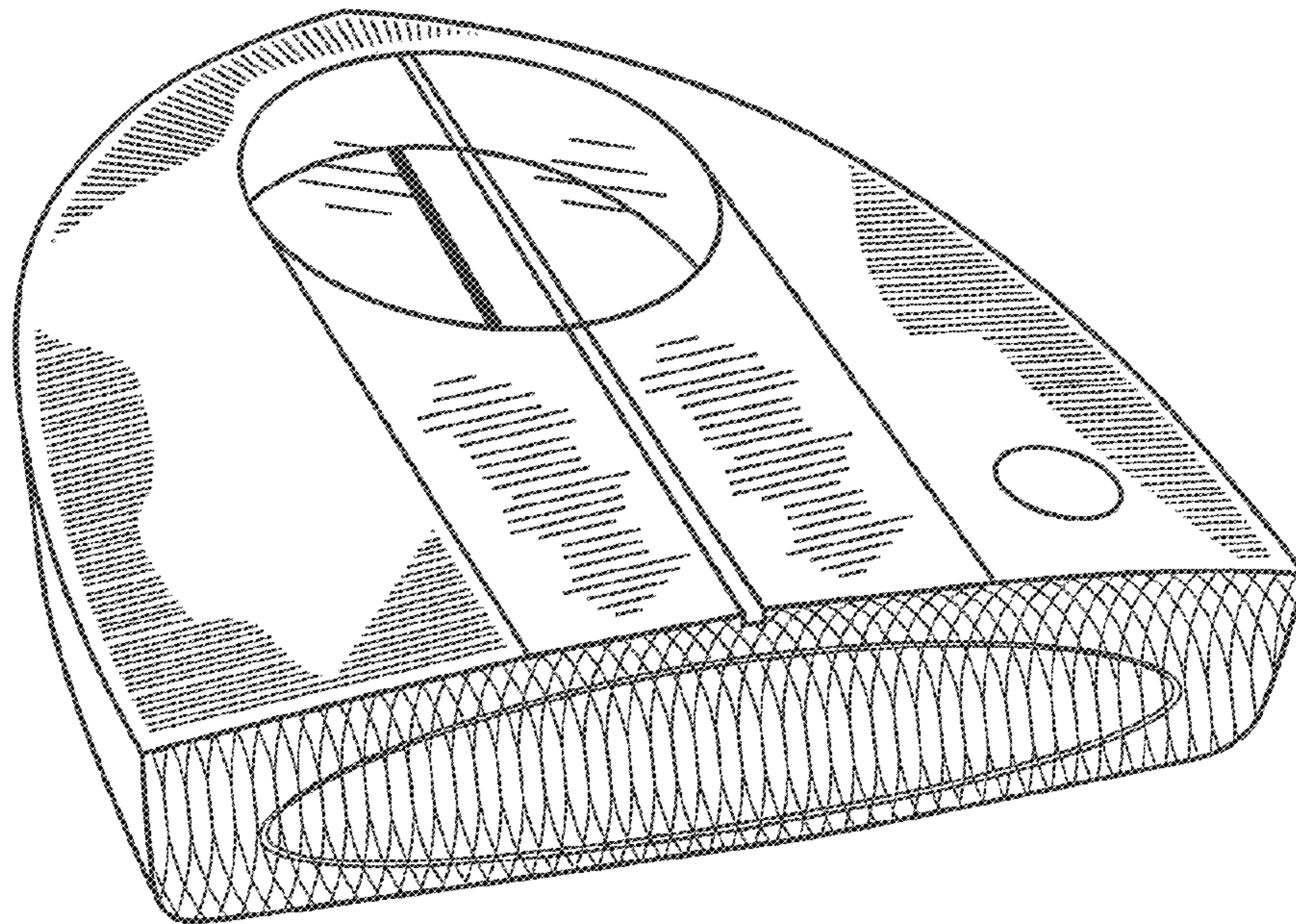
(57) **CLAIM**

The ornamental design for a putter head, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a putter head showing my new design, viewed from the above and front;
 FIG. 2 is another perspective view of the putter head of FIG. 1, viewed from the above and rear;
 FIG. 3 is another perspective view of the putter head of FIG. 1, viewed from below;
 FIG. 4 is a top plan view of the putter head of FIG. 1;
 FIG. 5 is a bottom plan view of the putter head of FIG. 1;
 FIG. 6 is a front elevation view of the putter head of FIG. 1;

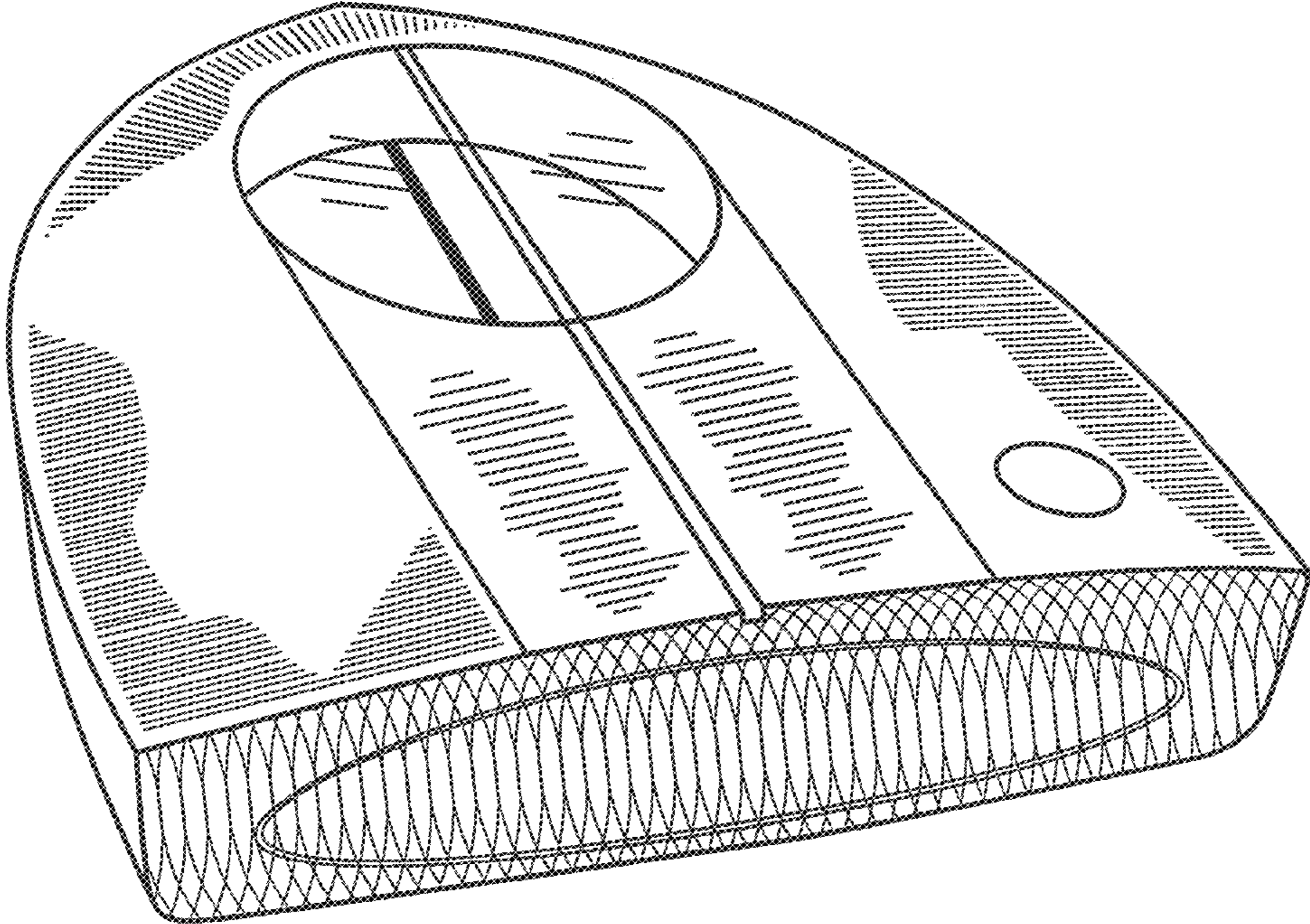

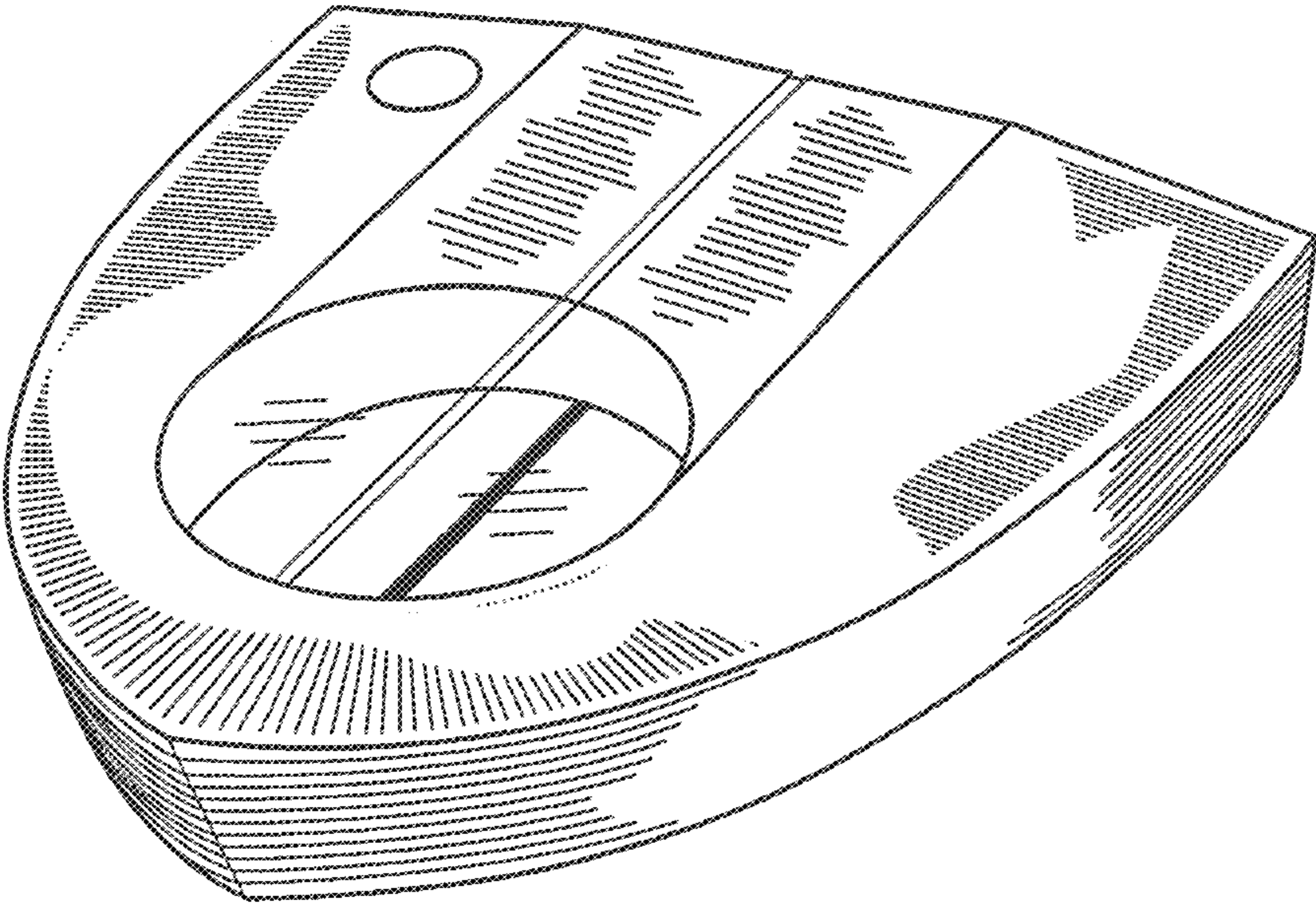

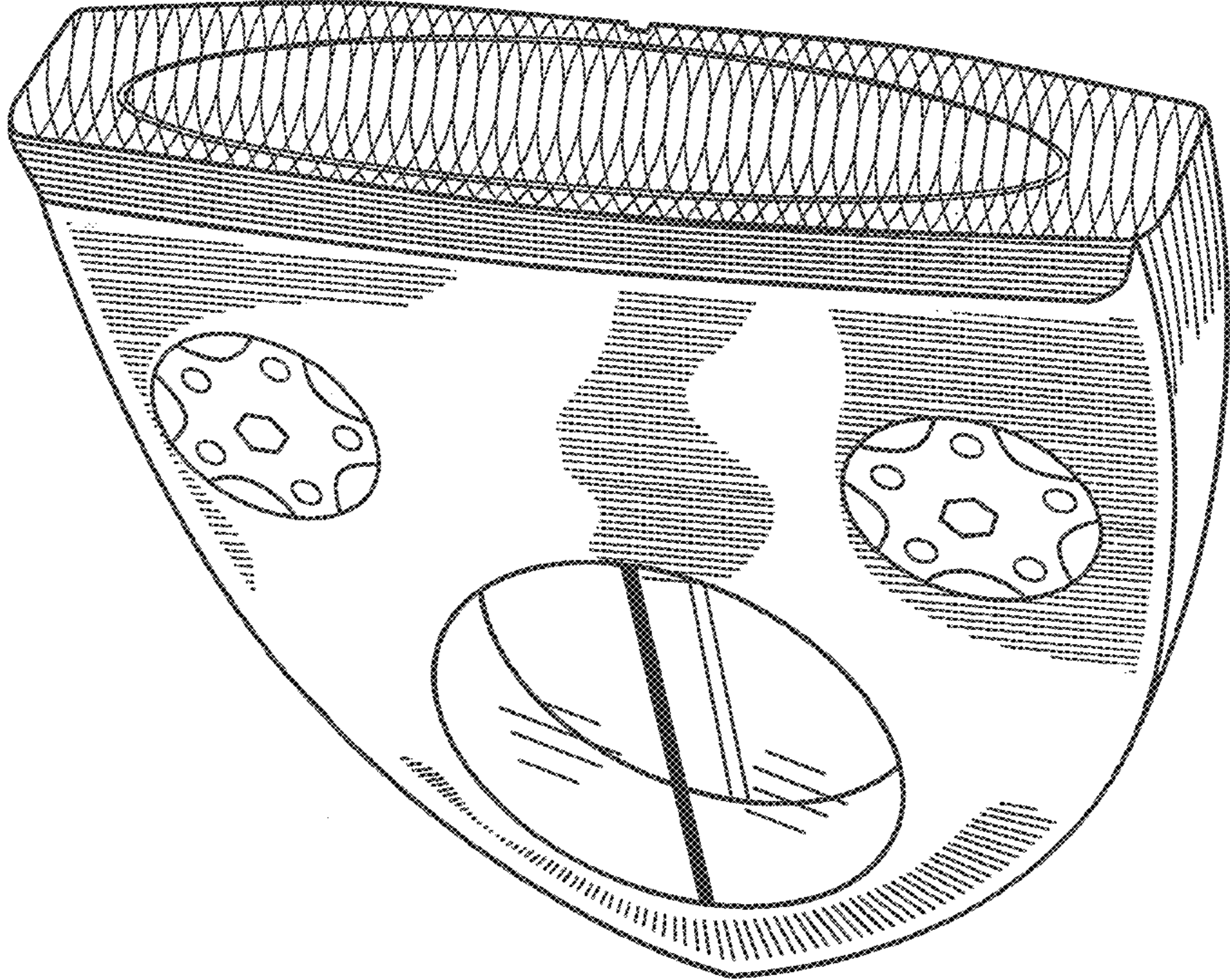

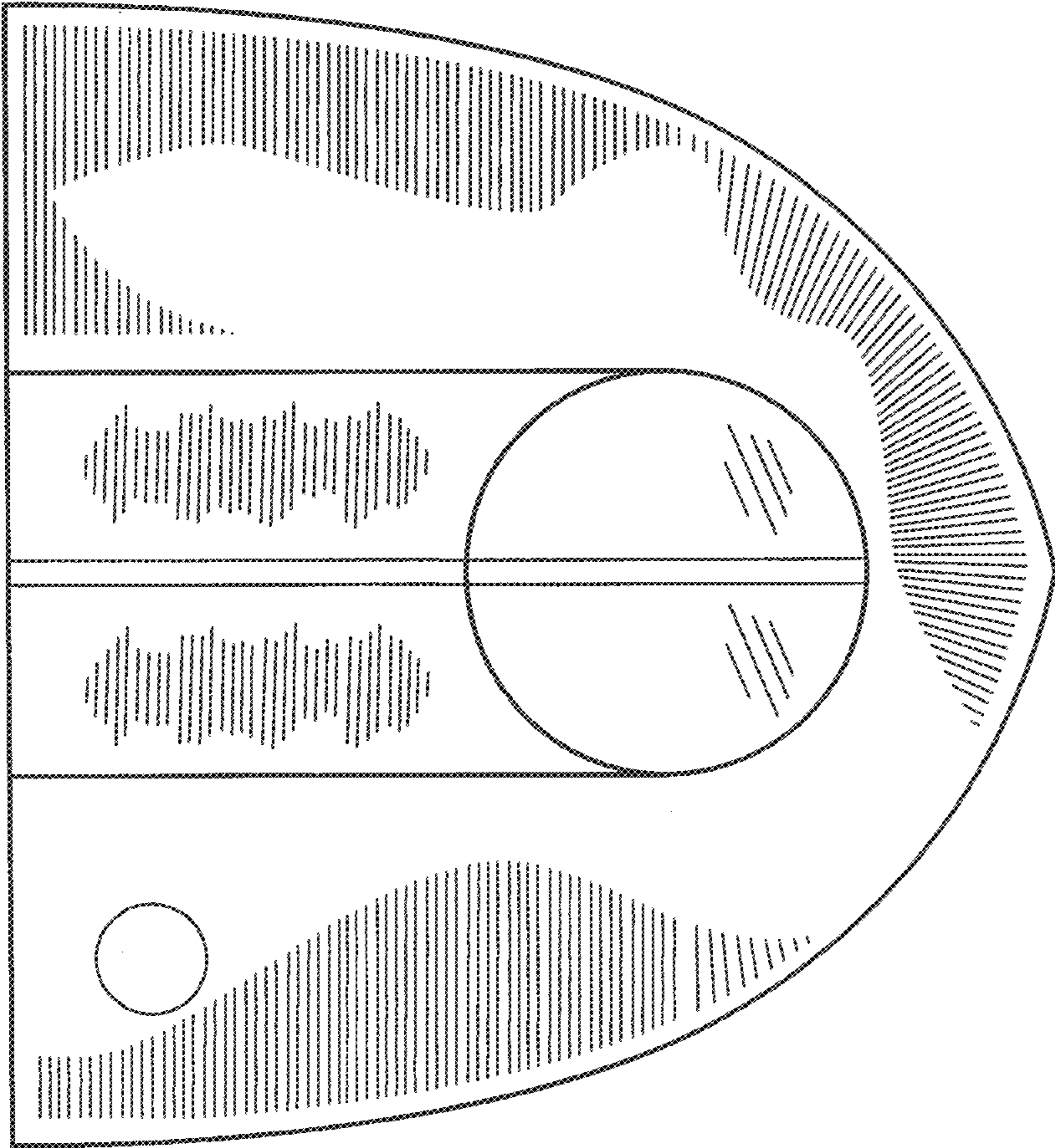

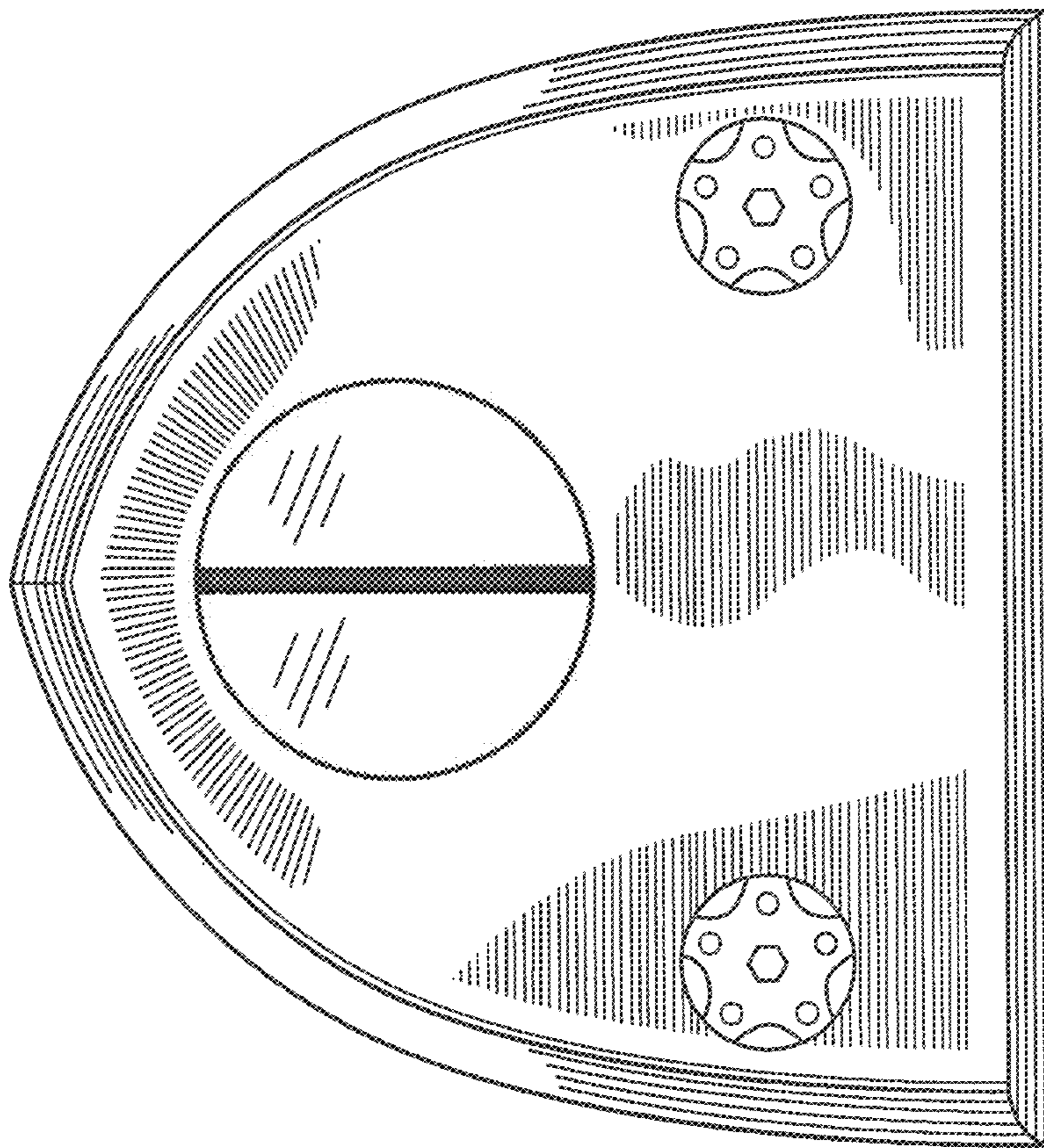

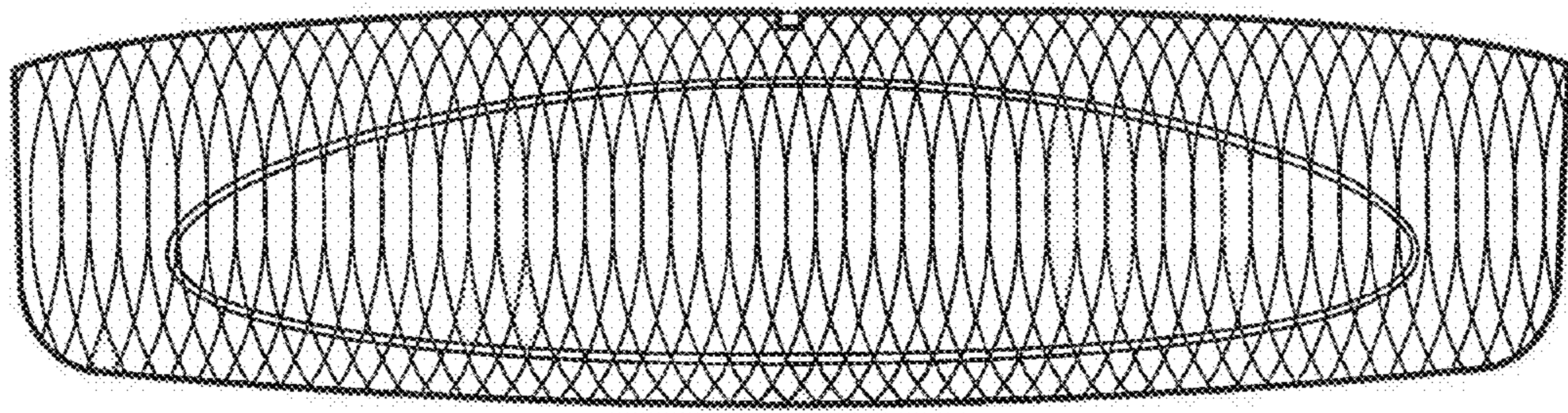

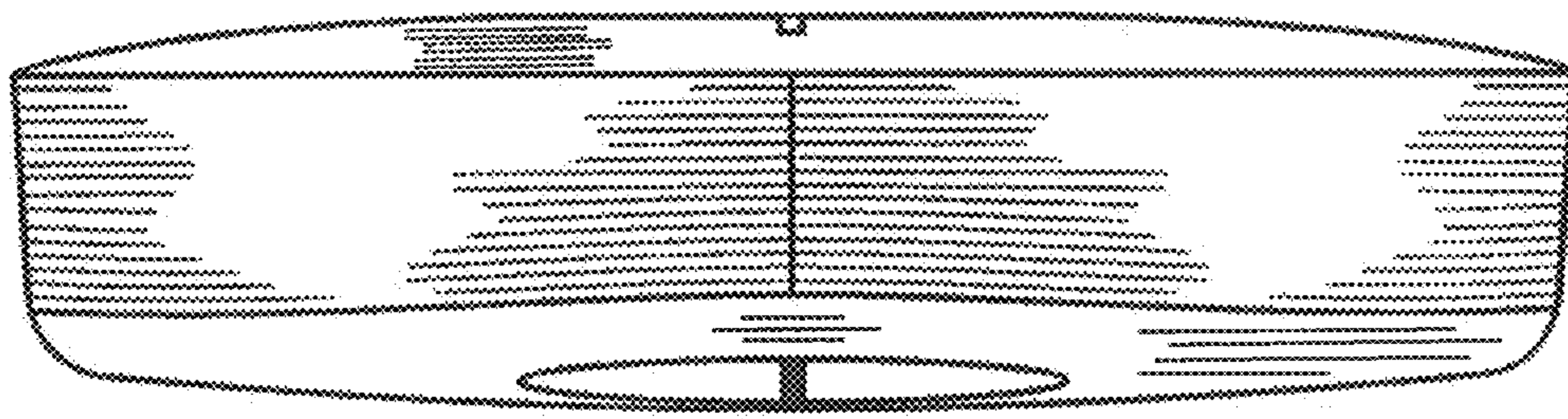

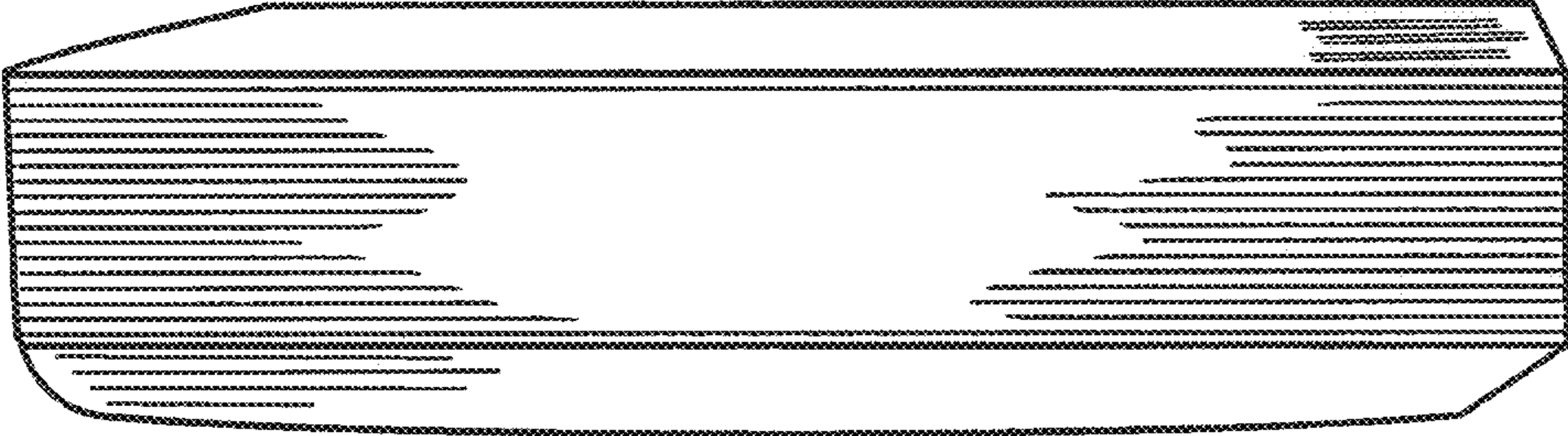
