FIG. 2 is a rear view of the optical sight reticle, the portions in phantom forming no portion of the claimed invention;

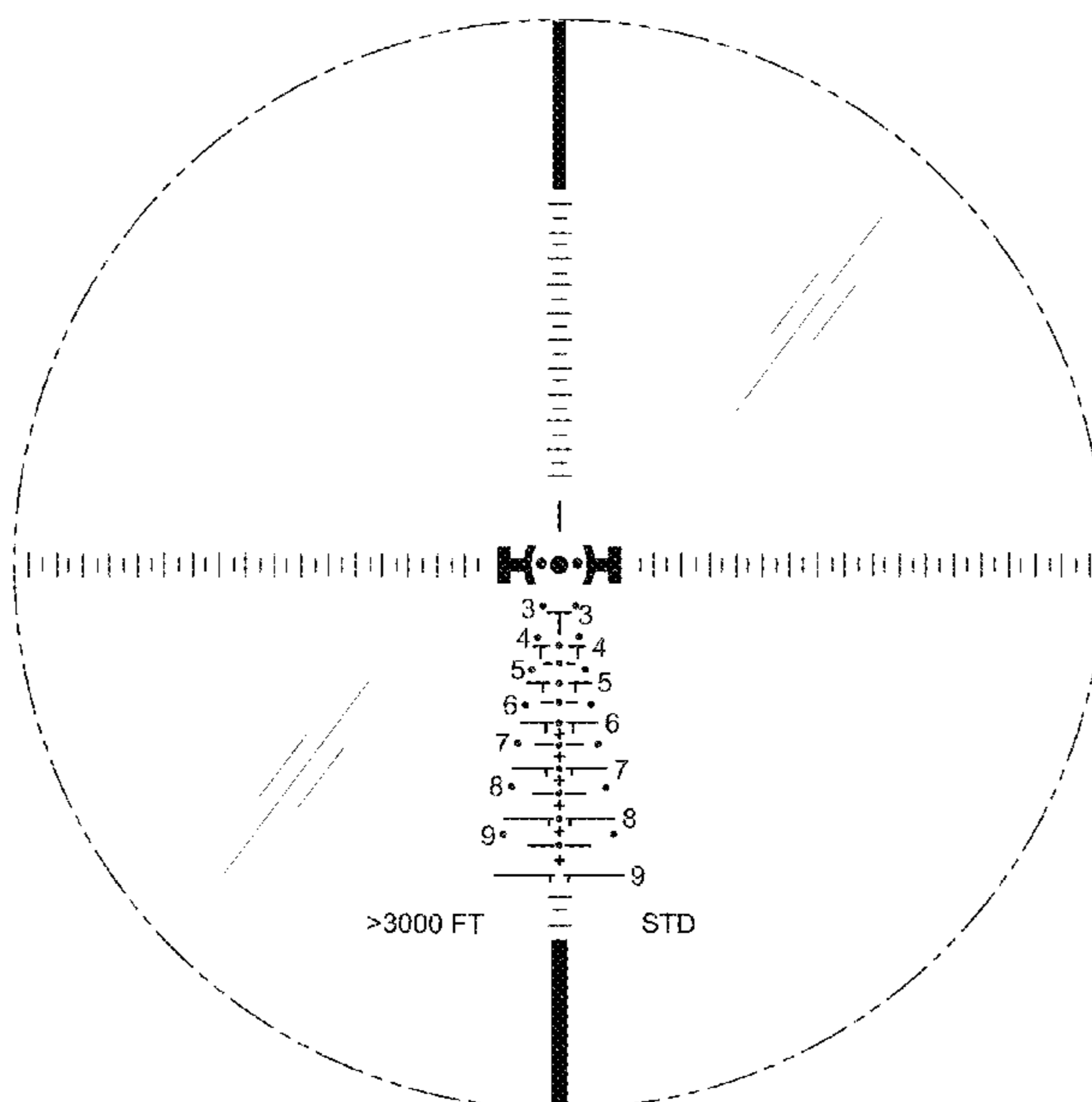

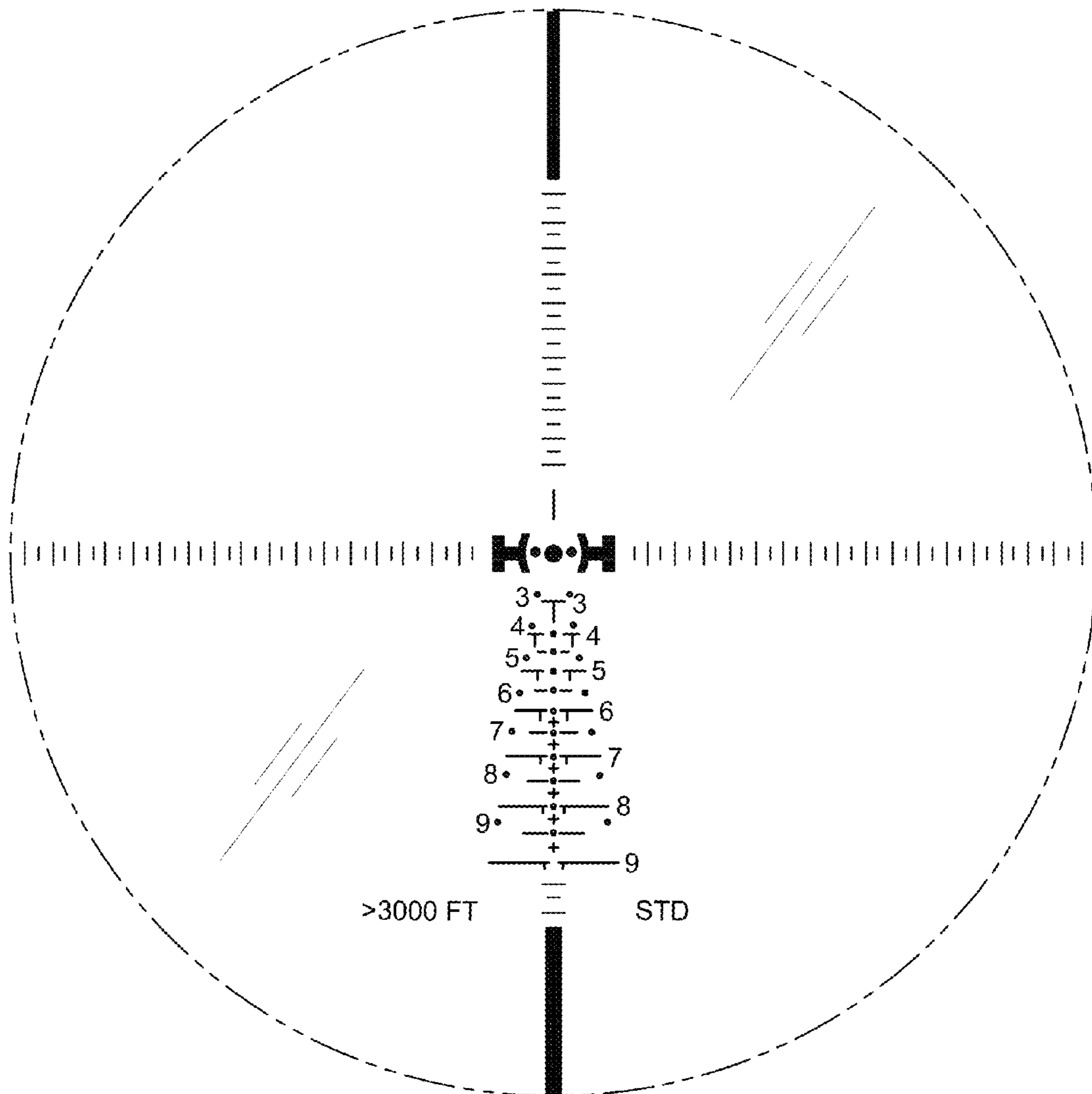

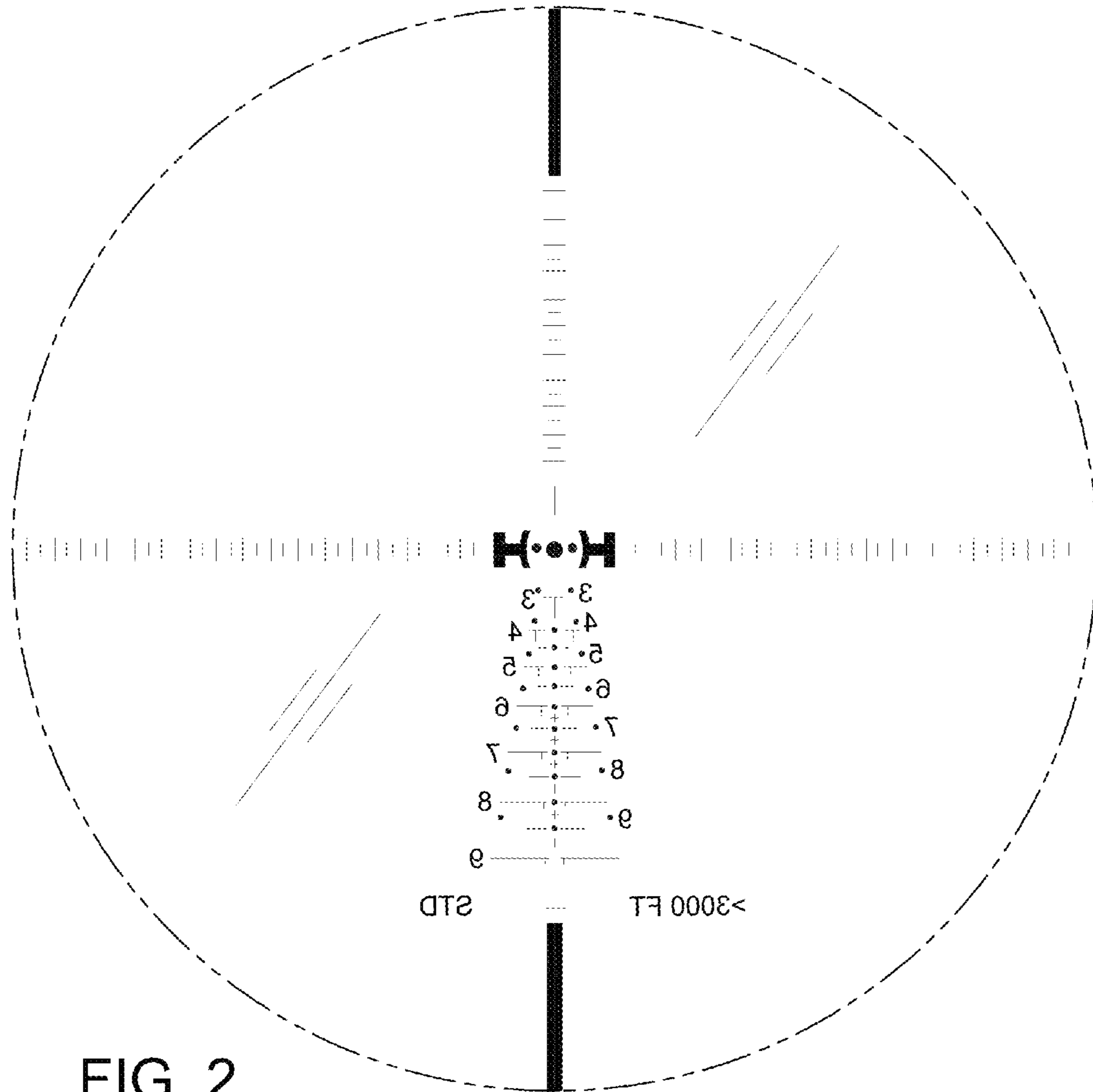

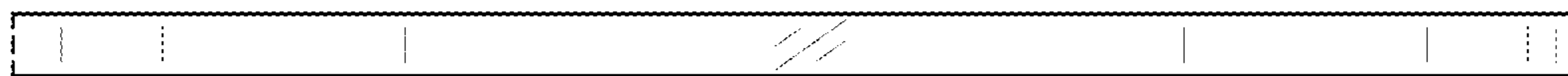

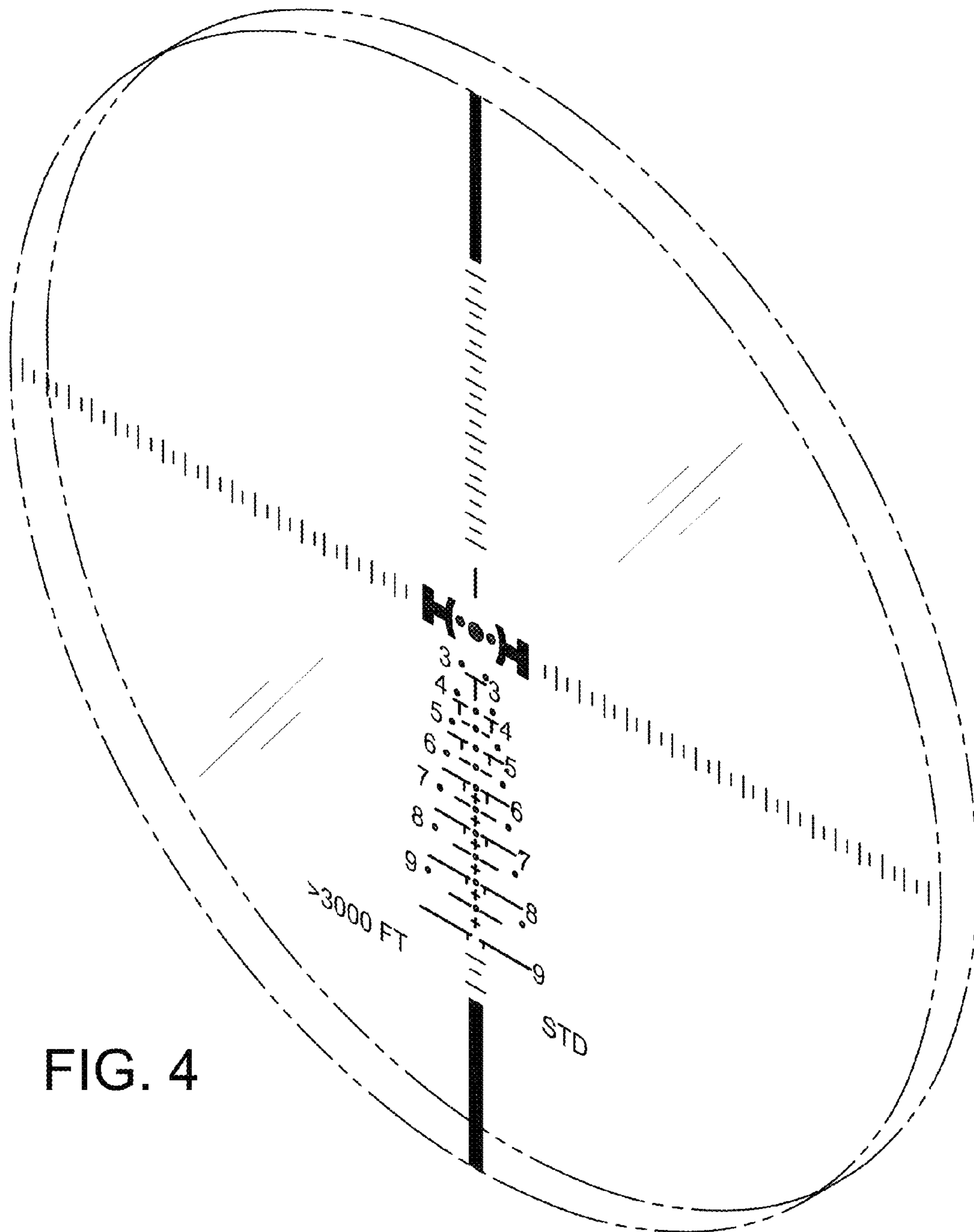
