FIG. 1;

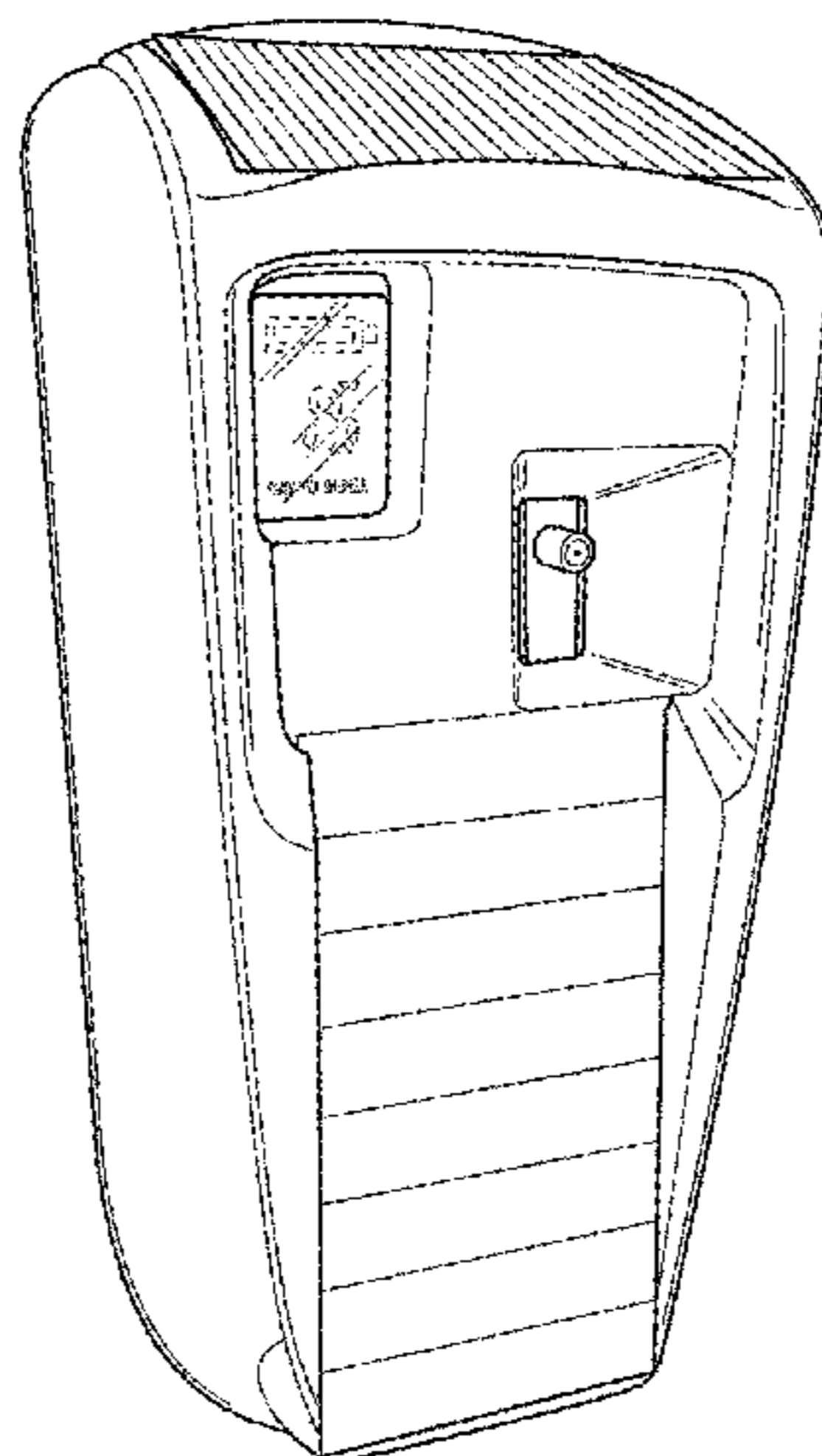
FIG. 5 is a second side view of the fragrance sprayer, as shown

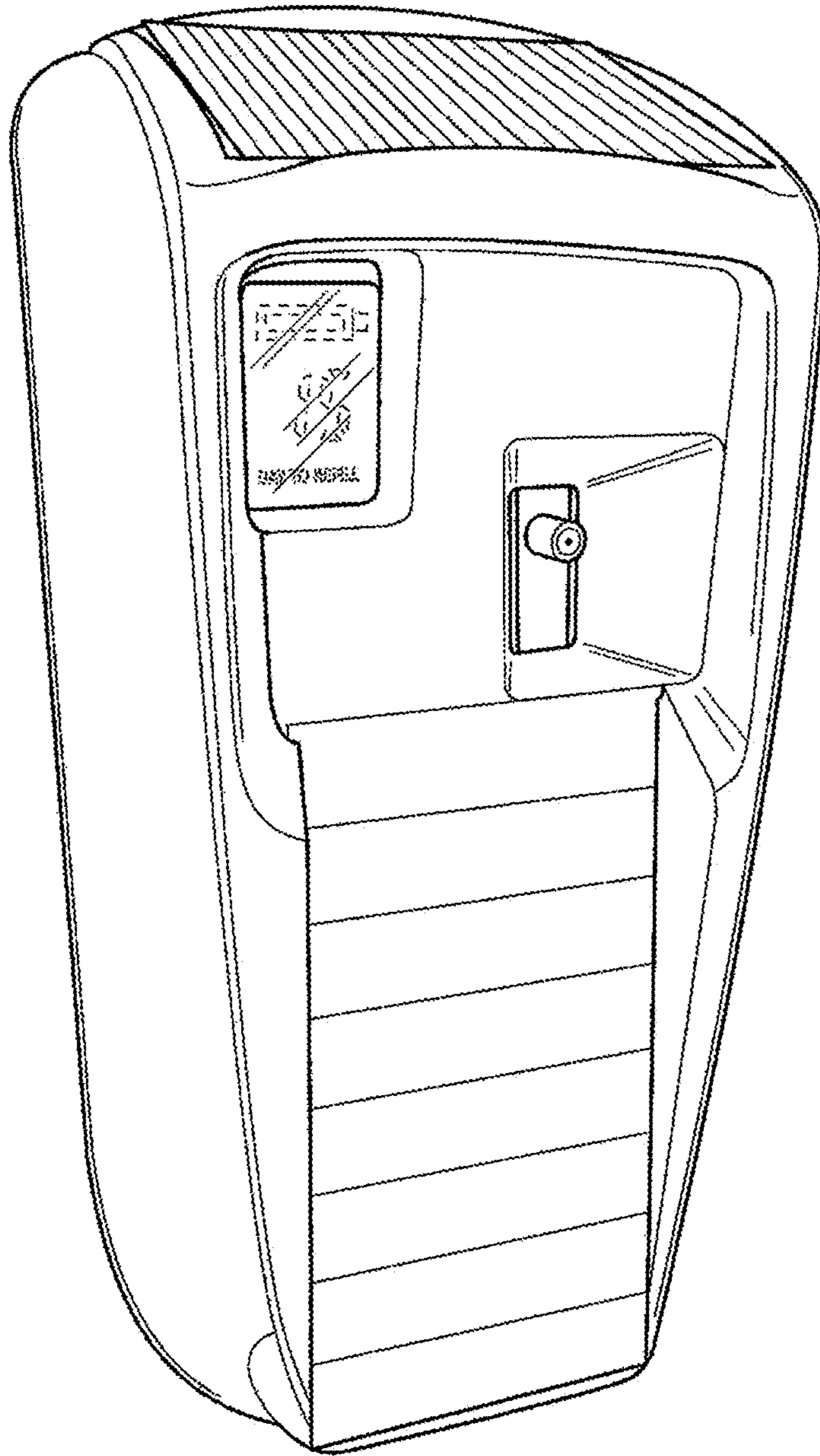

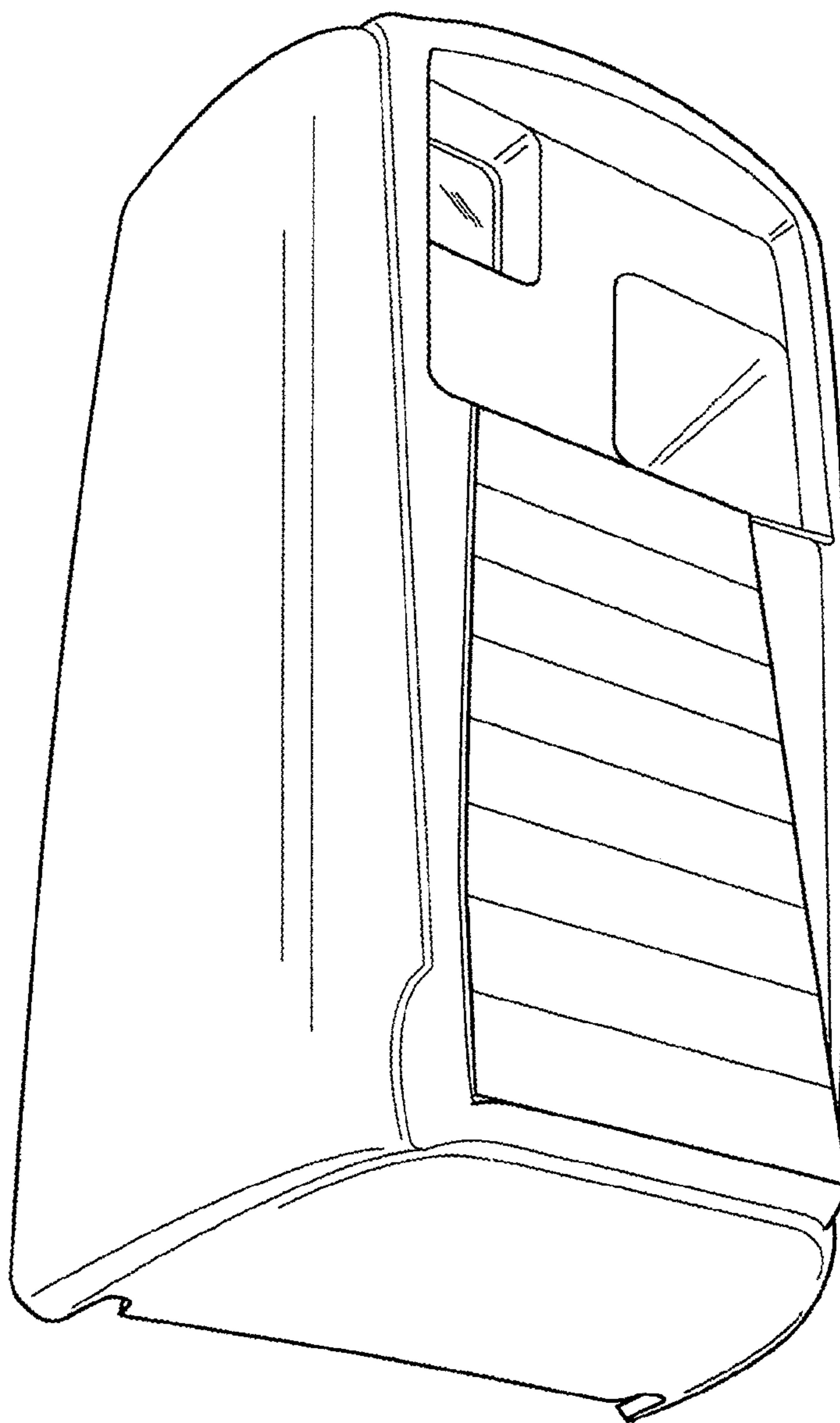

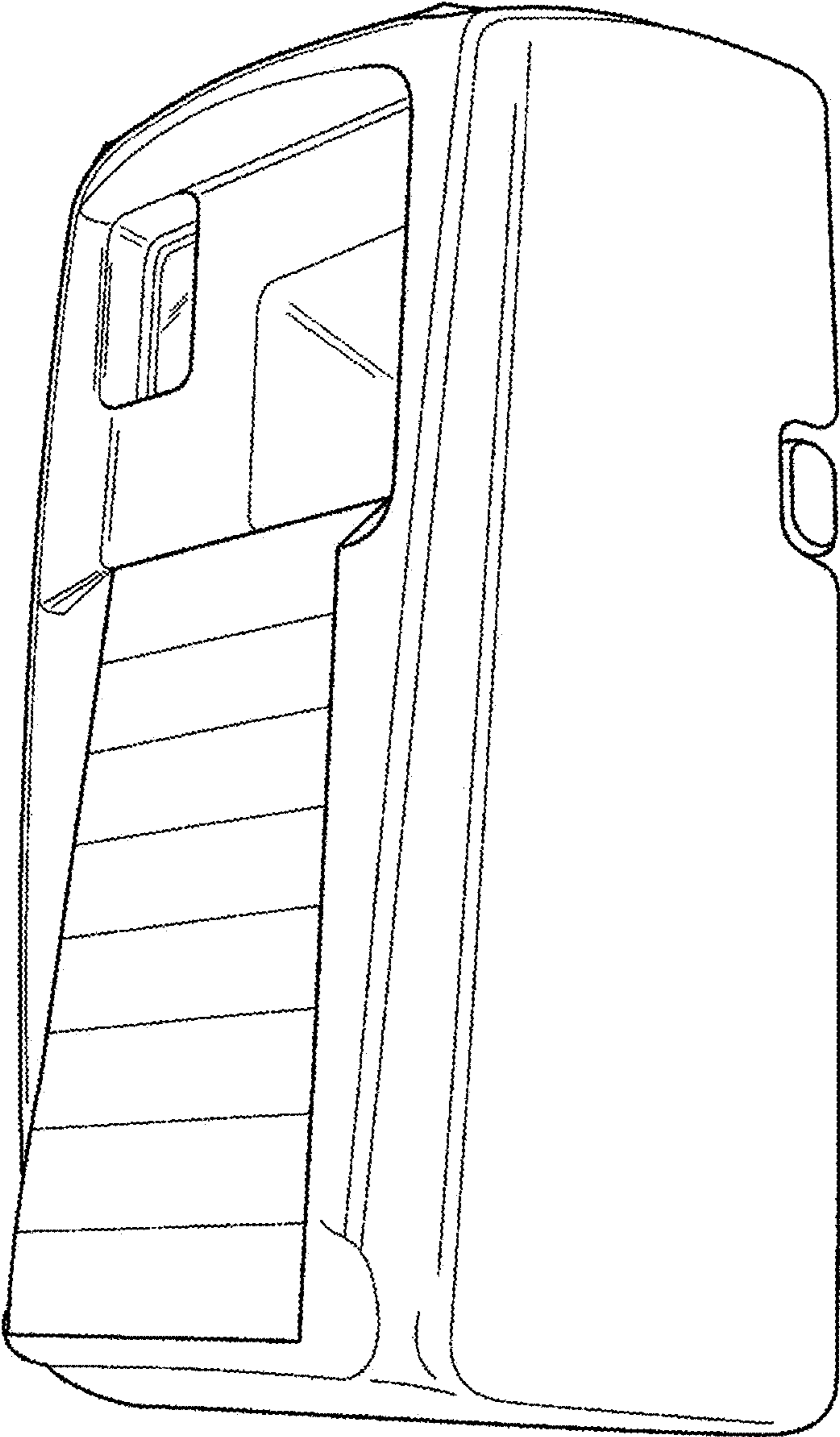

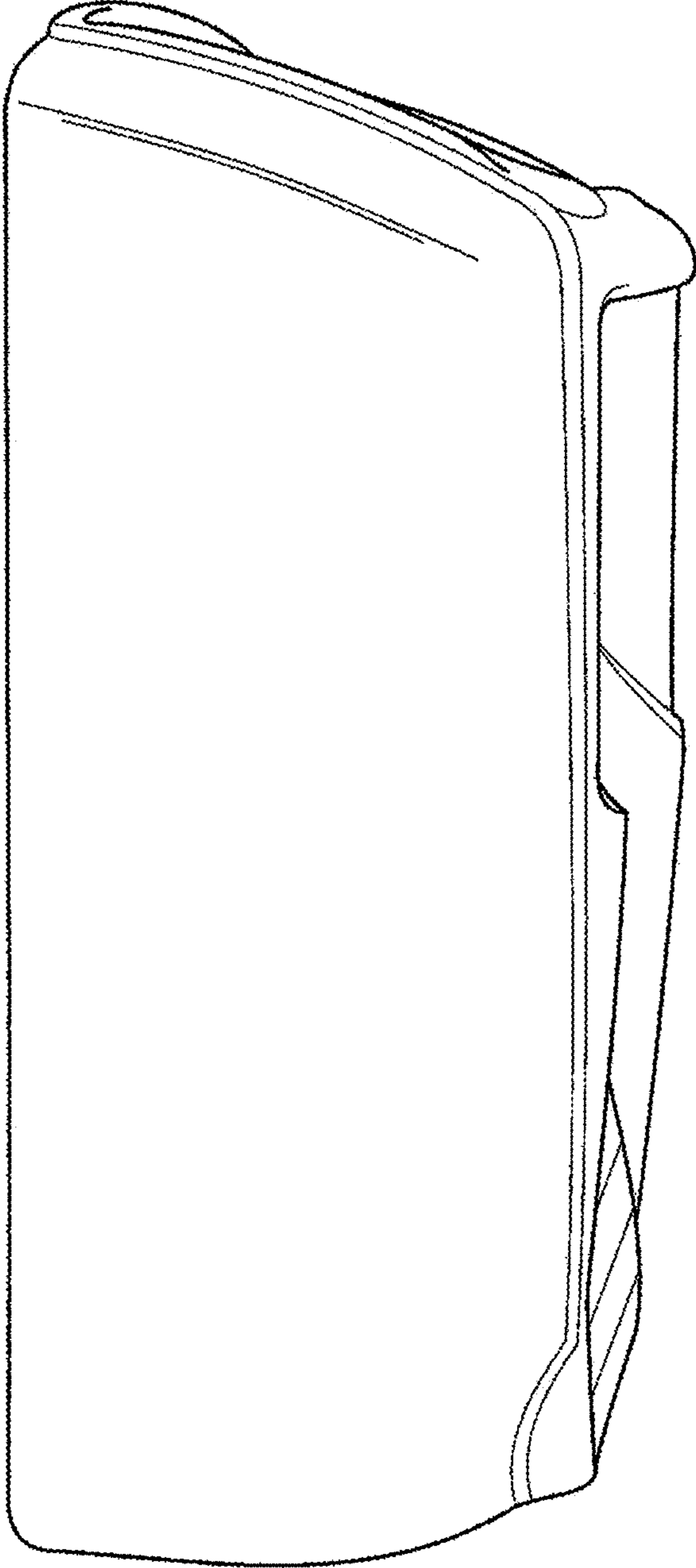

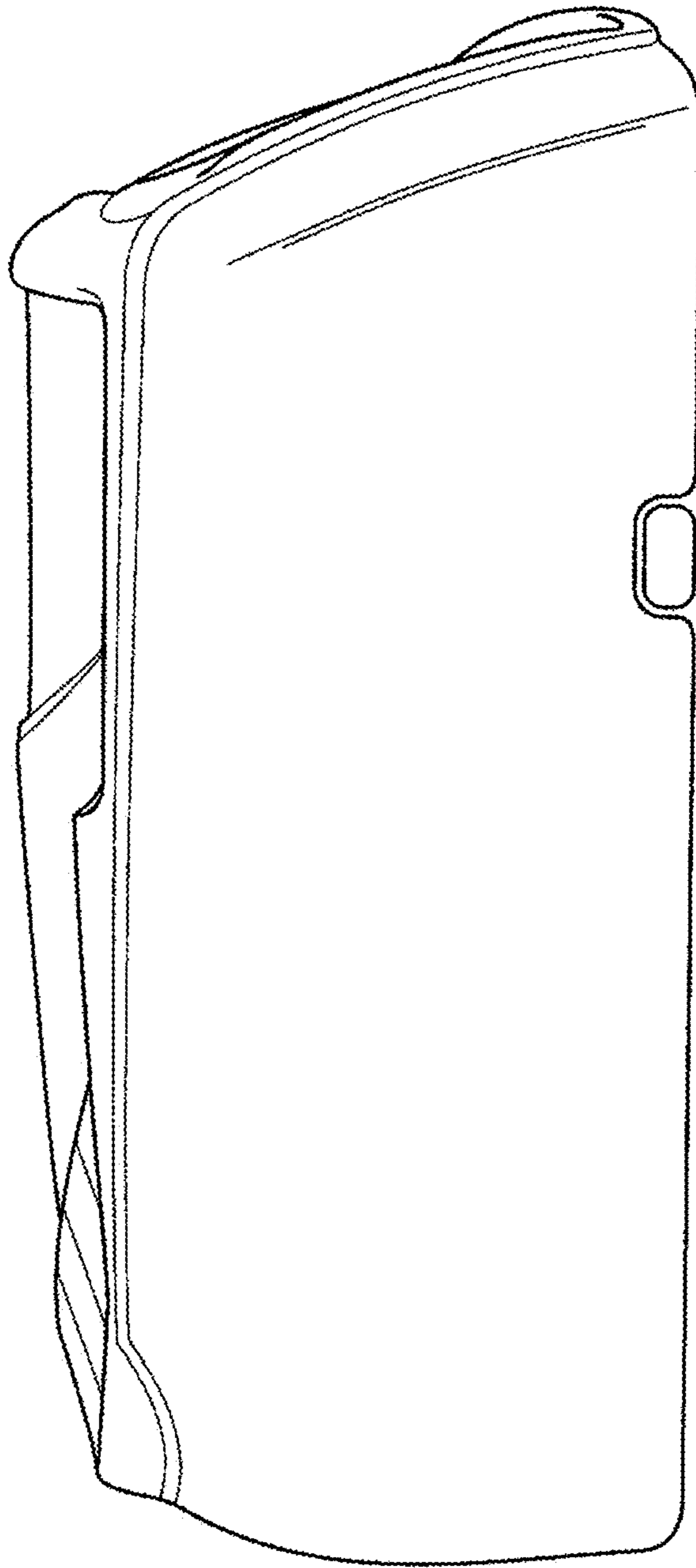

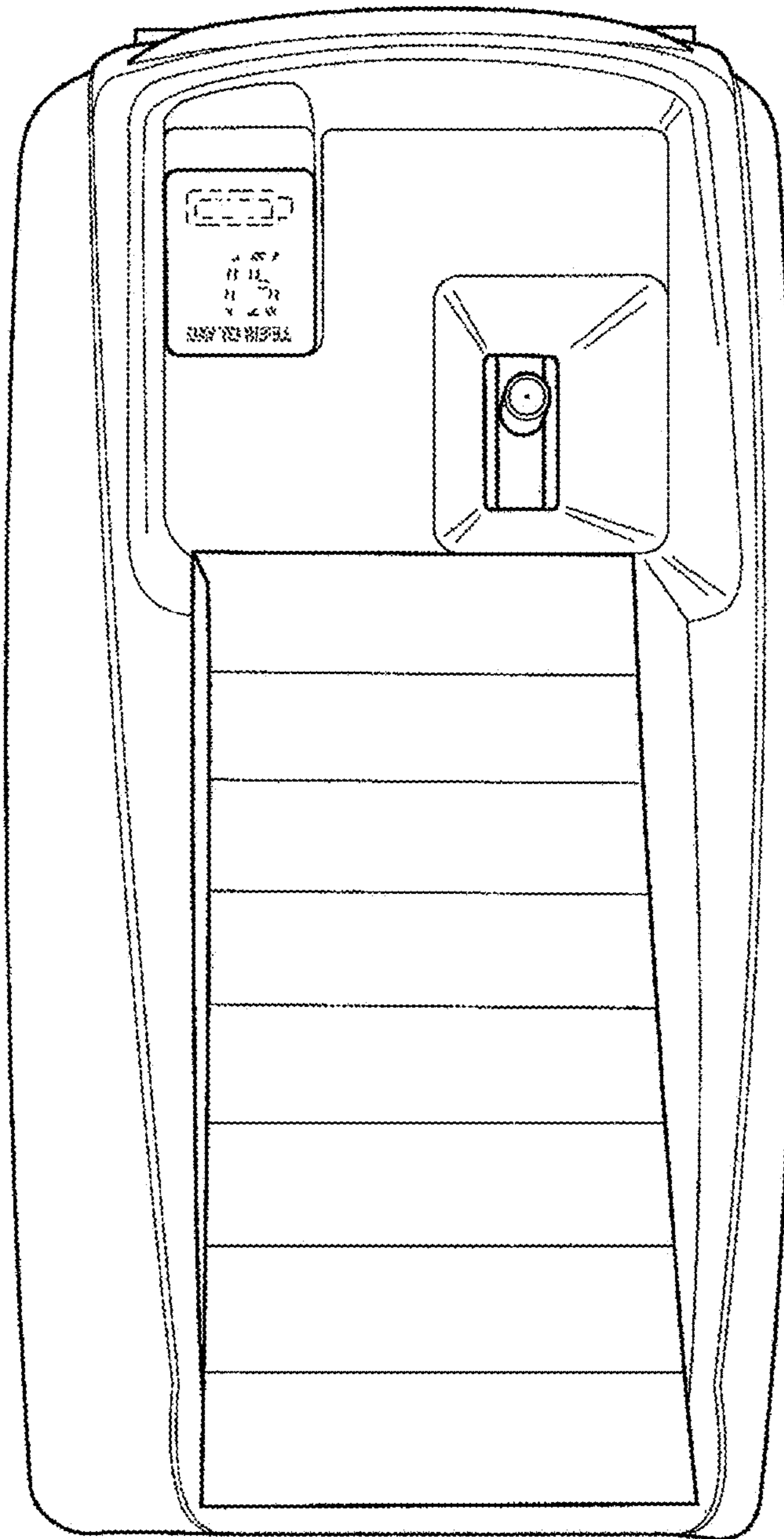

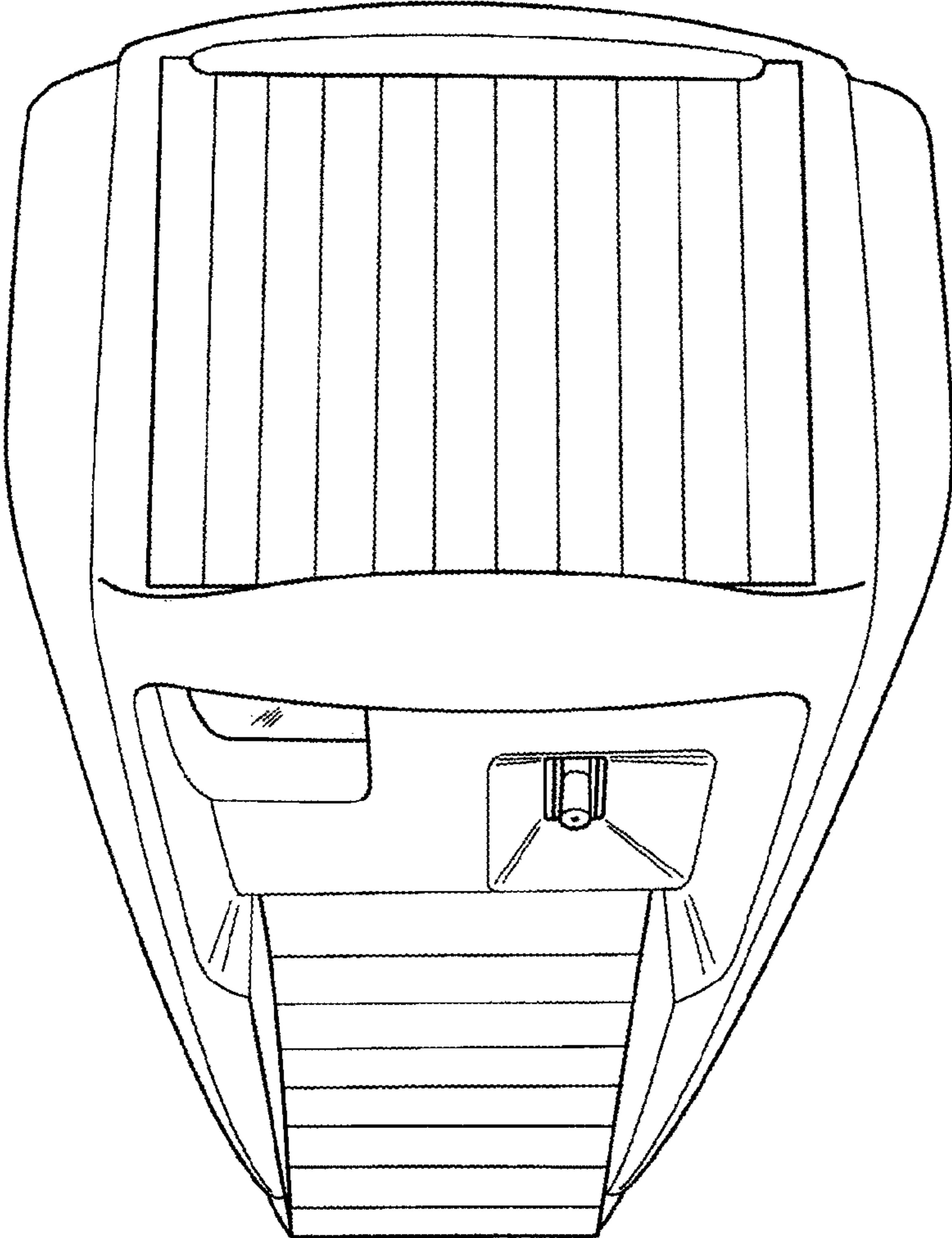
