(57) **CLAIM**

The ornamental design for a vehicle headlamp, as shown and described.

DESCRIPTION

FIG. 1 is front view of a passenger side vehicle headlamp showing our new design;

FIG. 2 is a side perspective view thereof;

FIG. 3 is a top view thereof;

FIG. 4 is a bottom view thereof;

FIG. 5 is a driver side perspective view of a second embodiment of the vehicle headlamp thereof, with the vehicle headlamp from the opposite side of the vehicle being depicted in first embodiment;

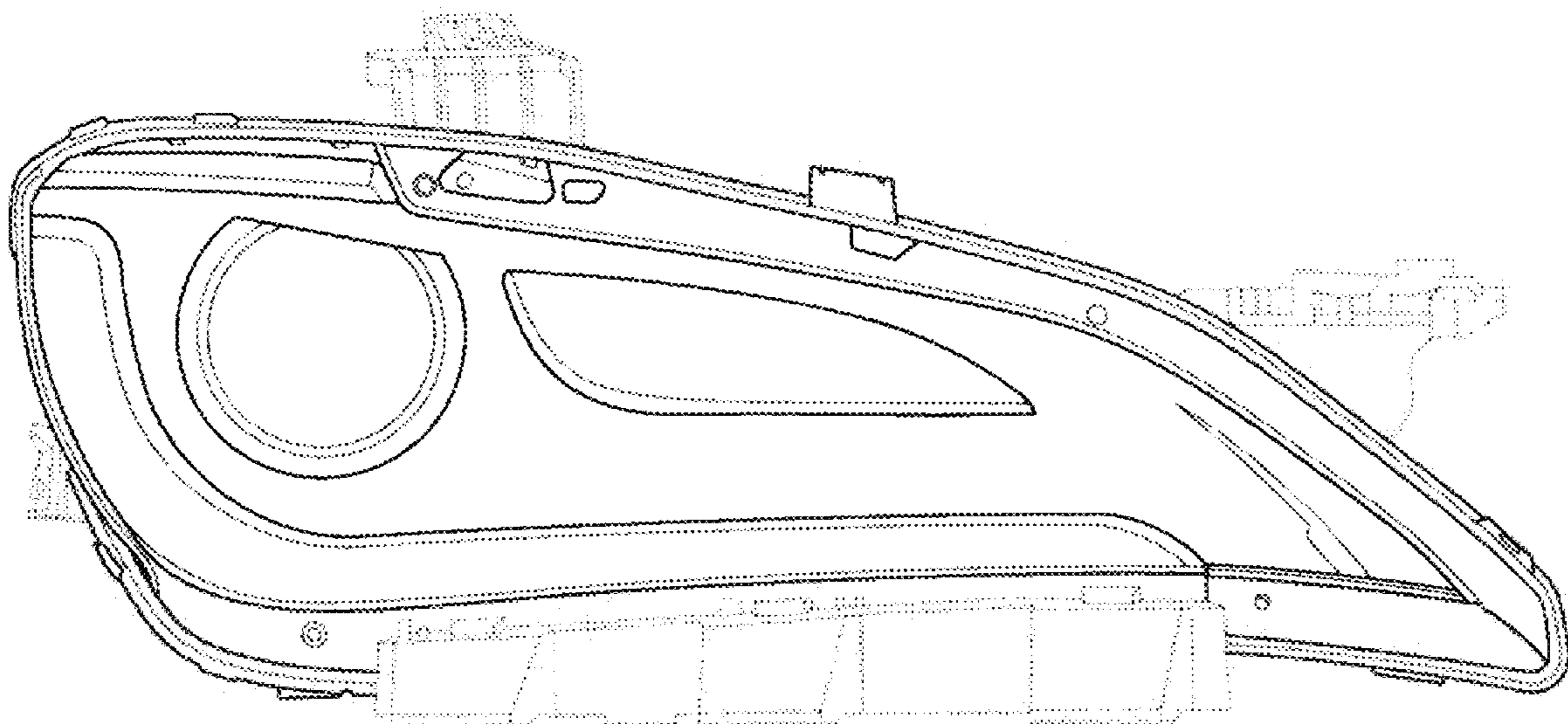
FIG. 6 is a side perspective view thereof;

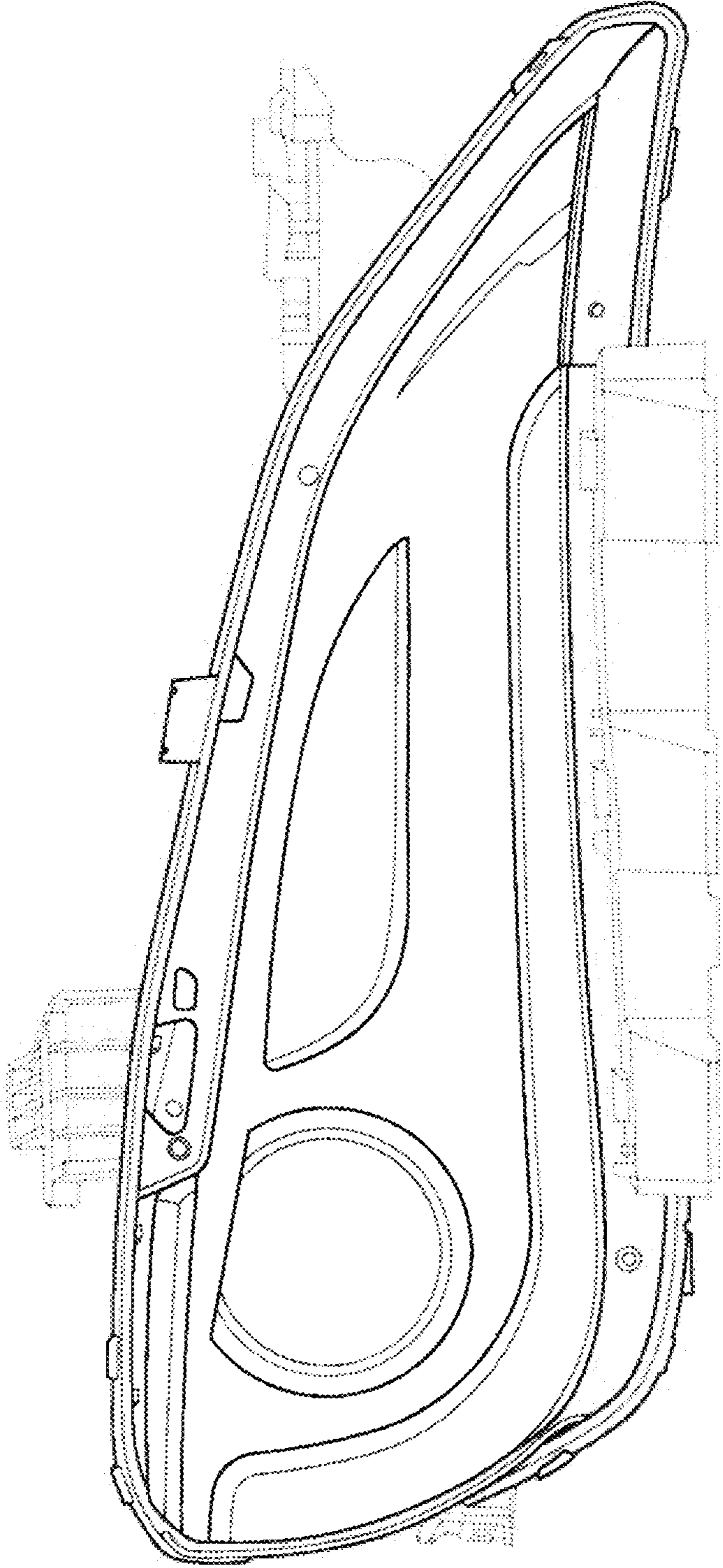

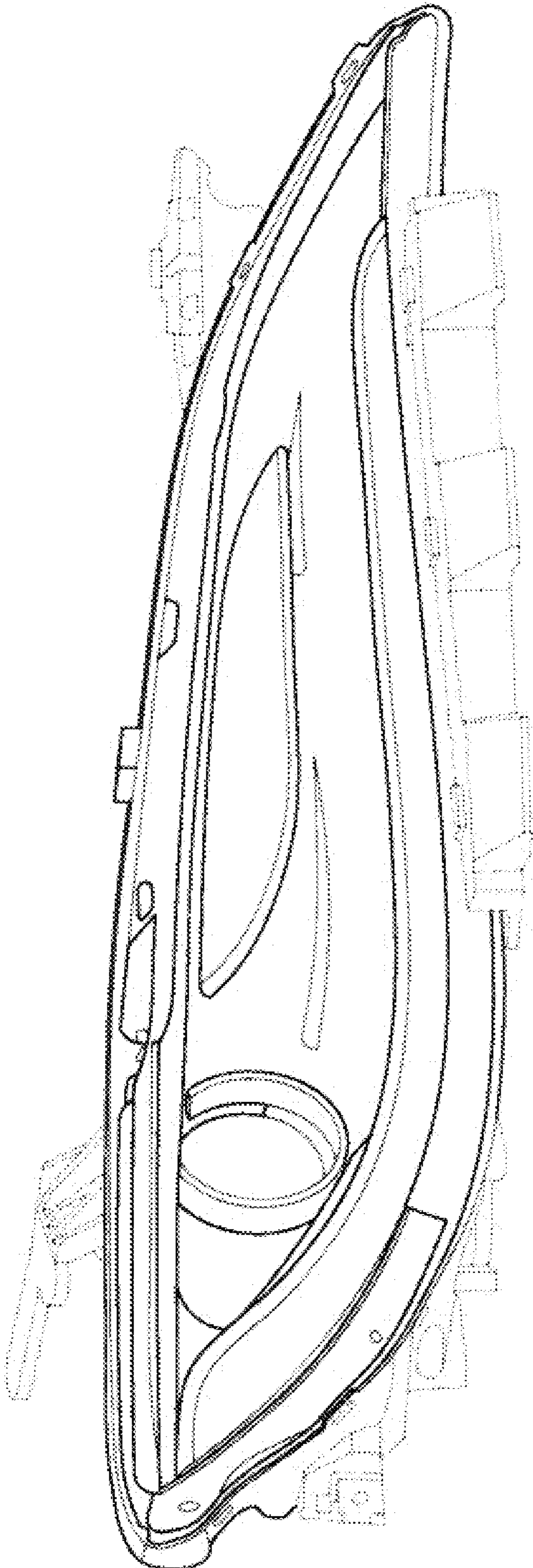

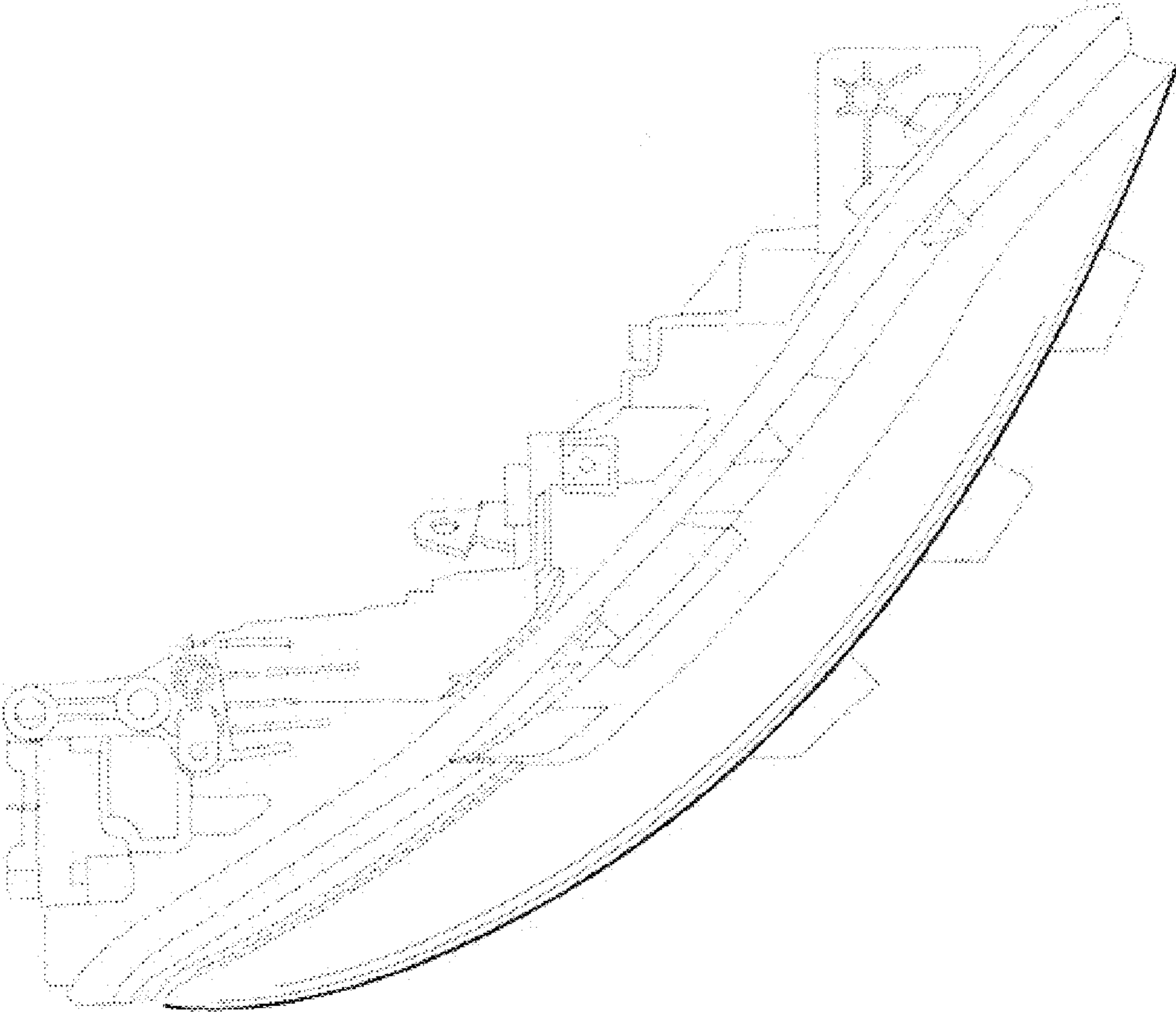

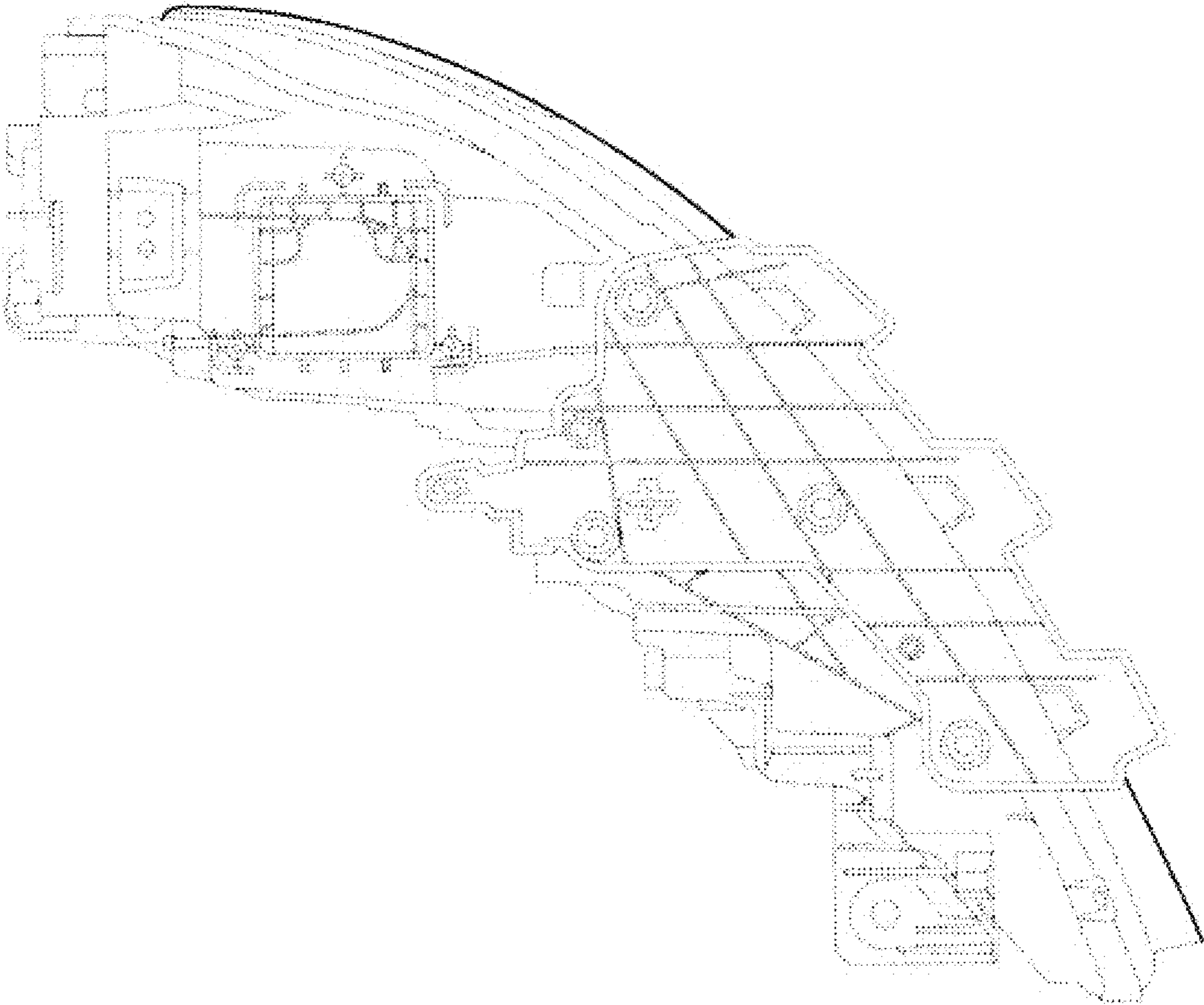

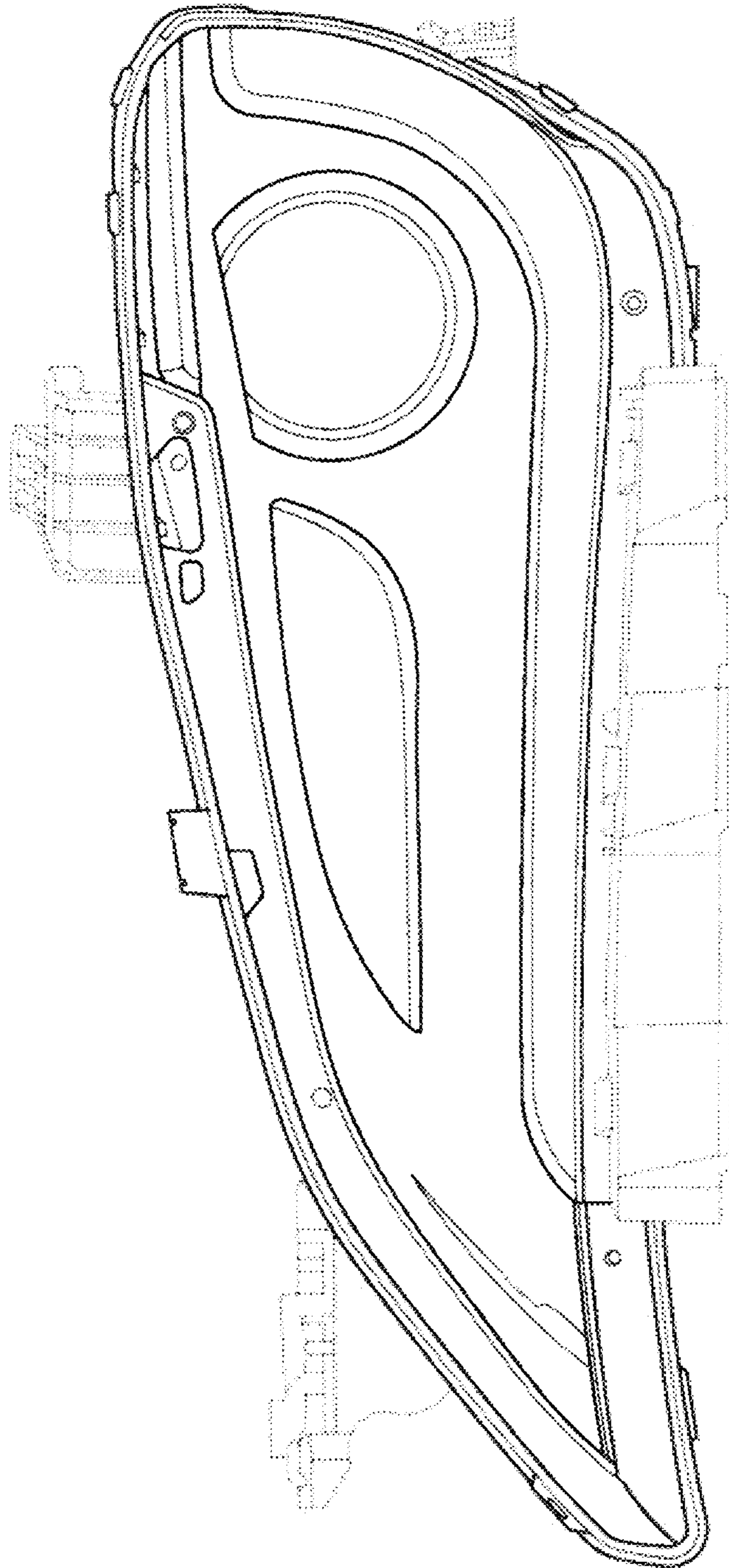

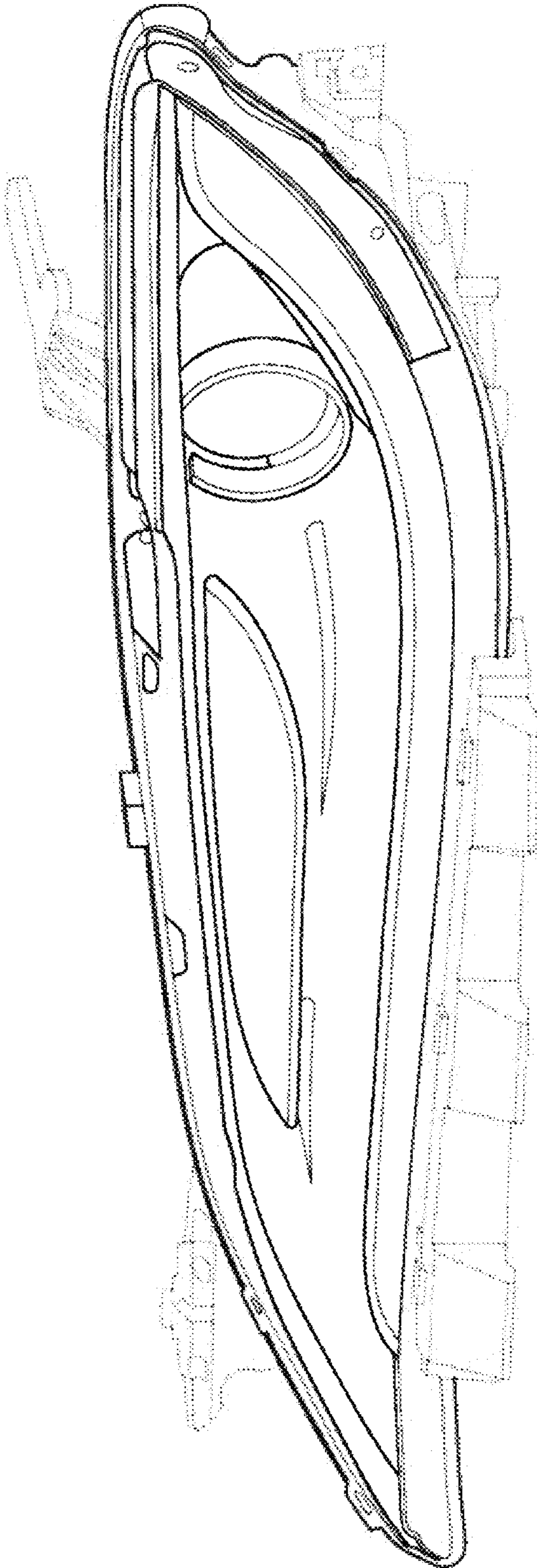

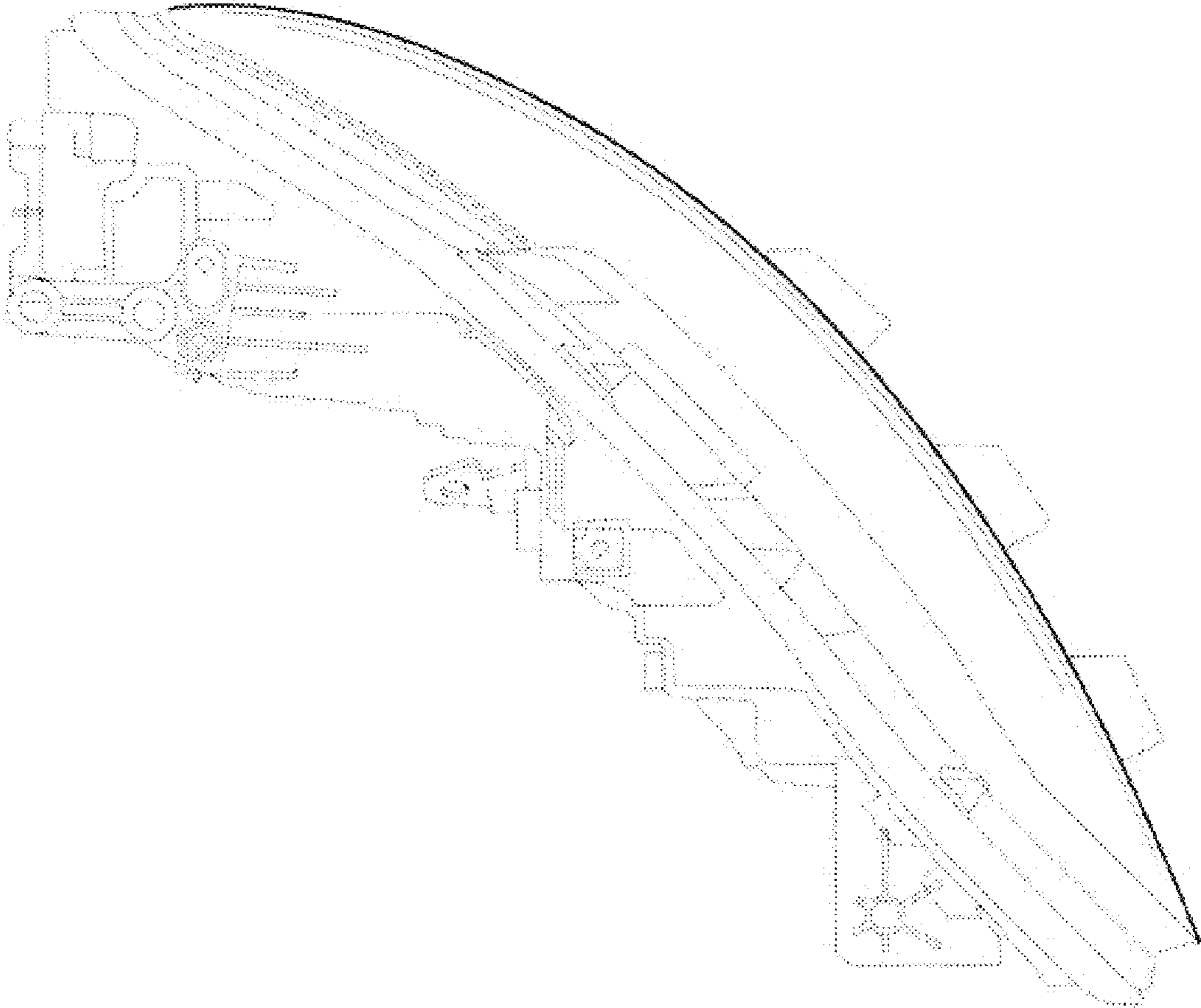

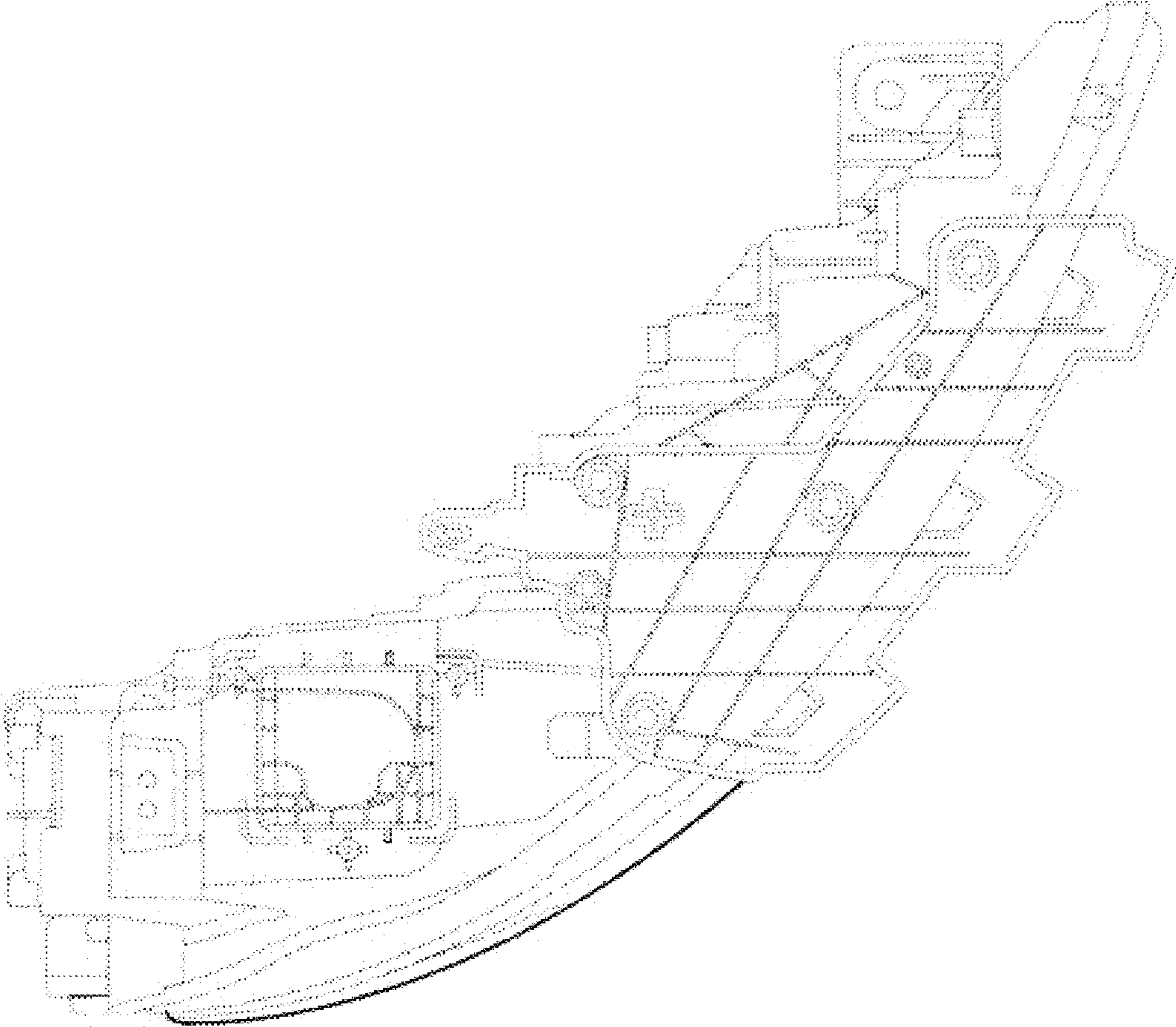
