FIG. 5 is a right side view thereof.

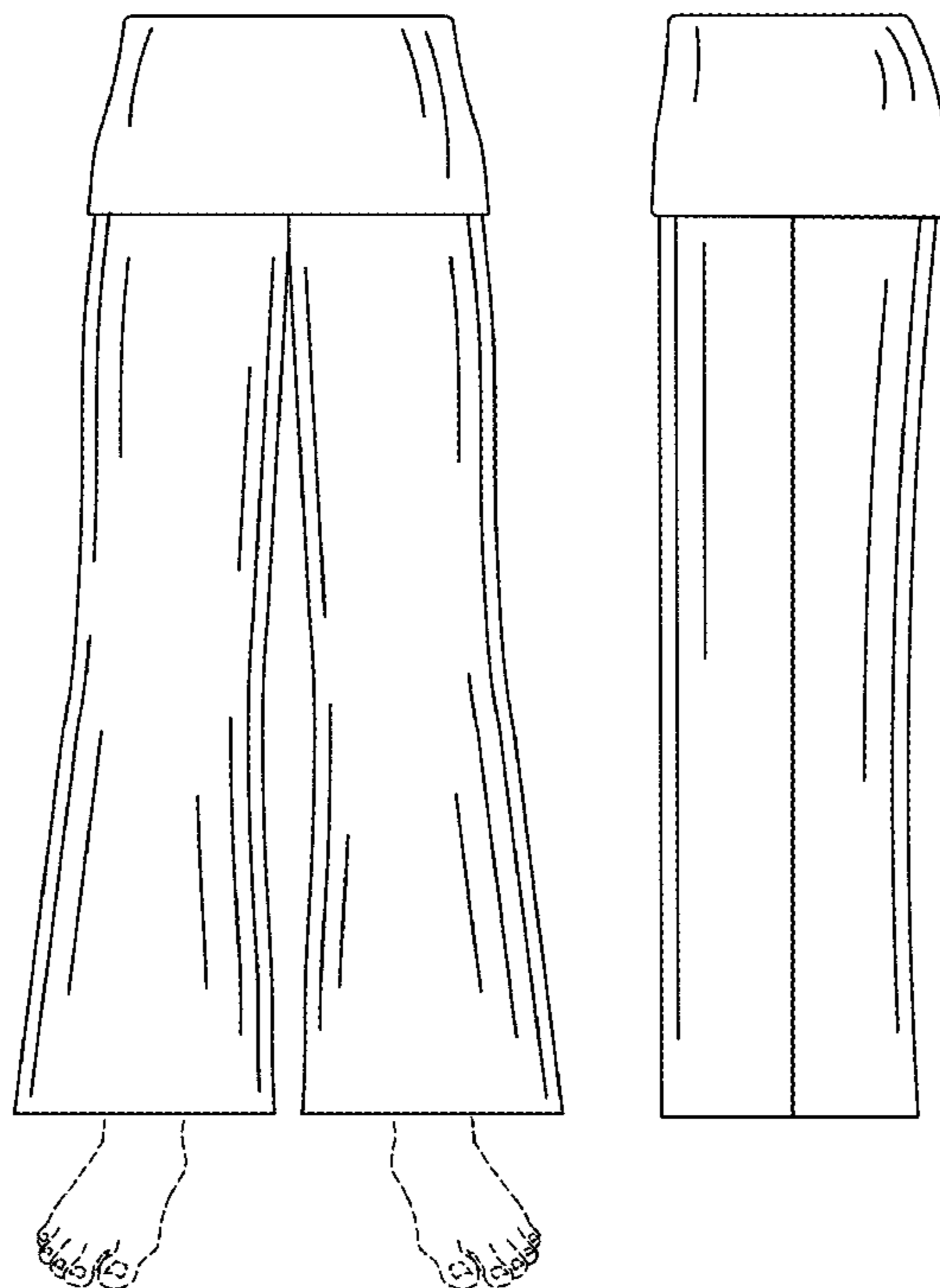
FIG. 6 is an enlarged top view thereof.

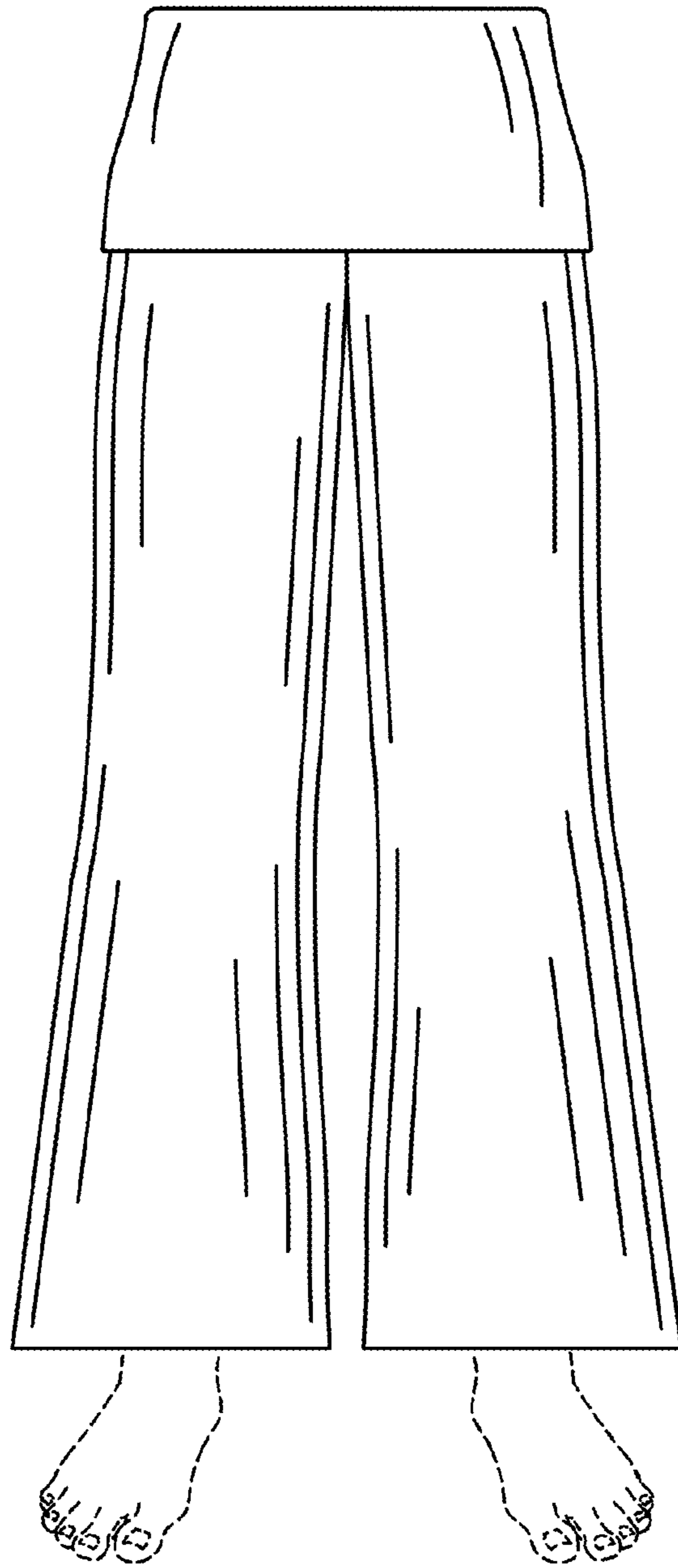

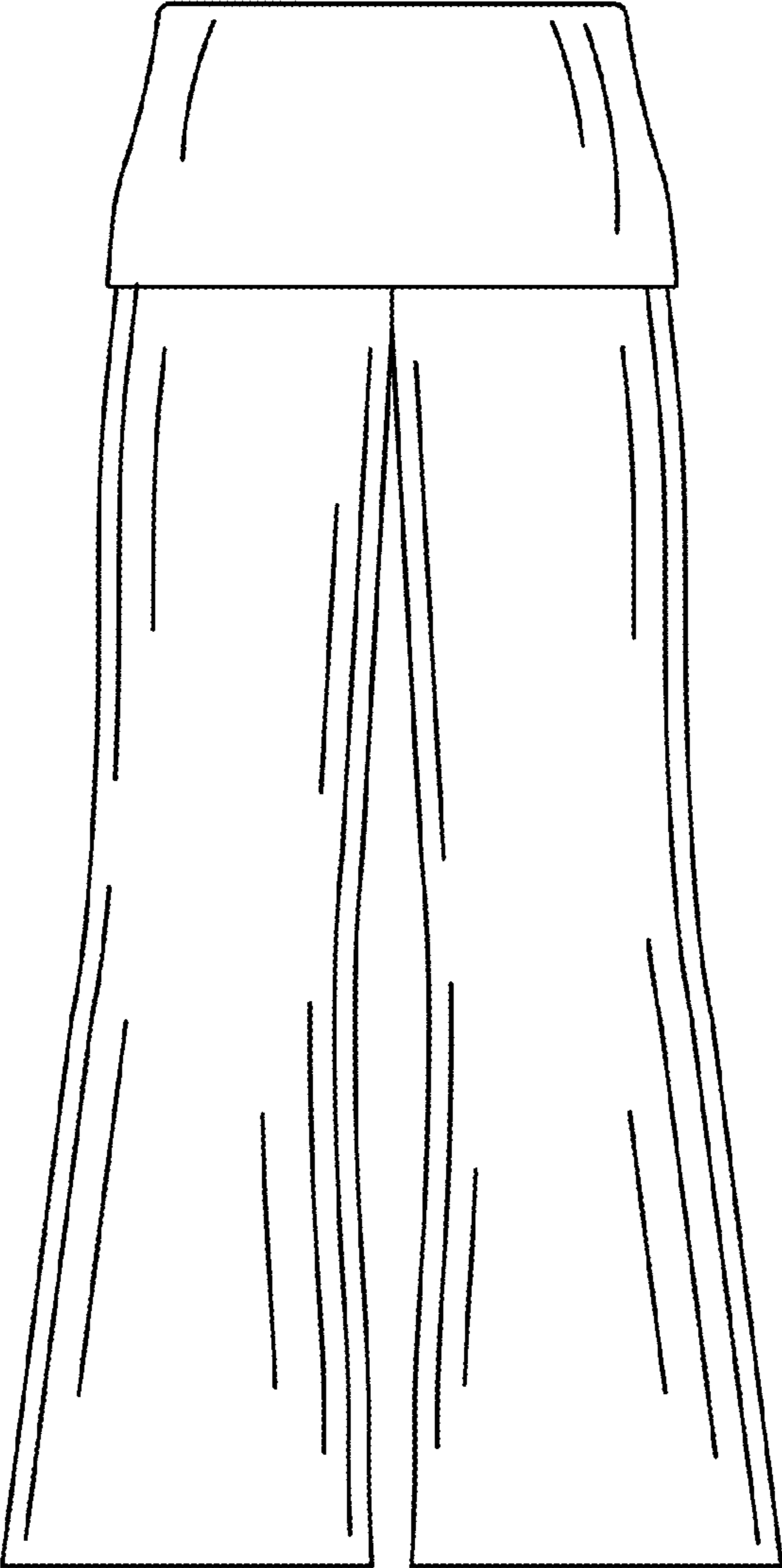

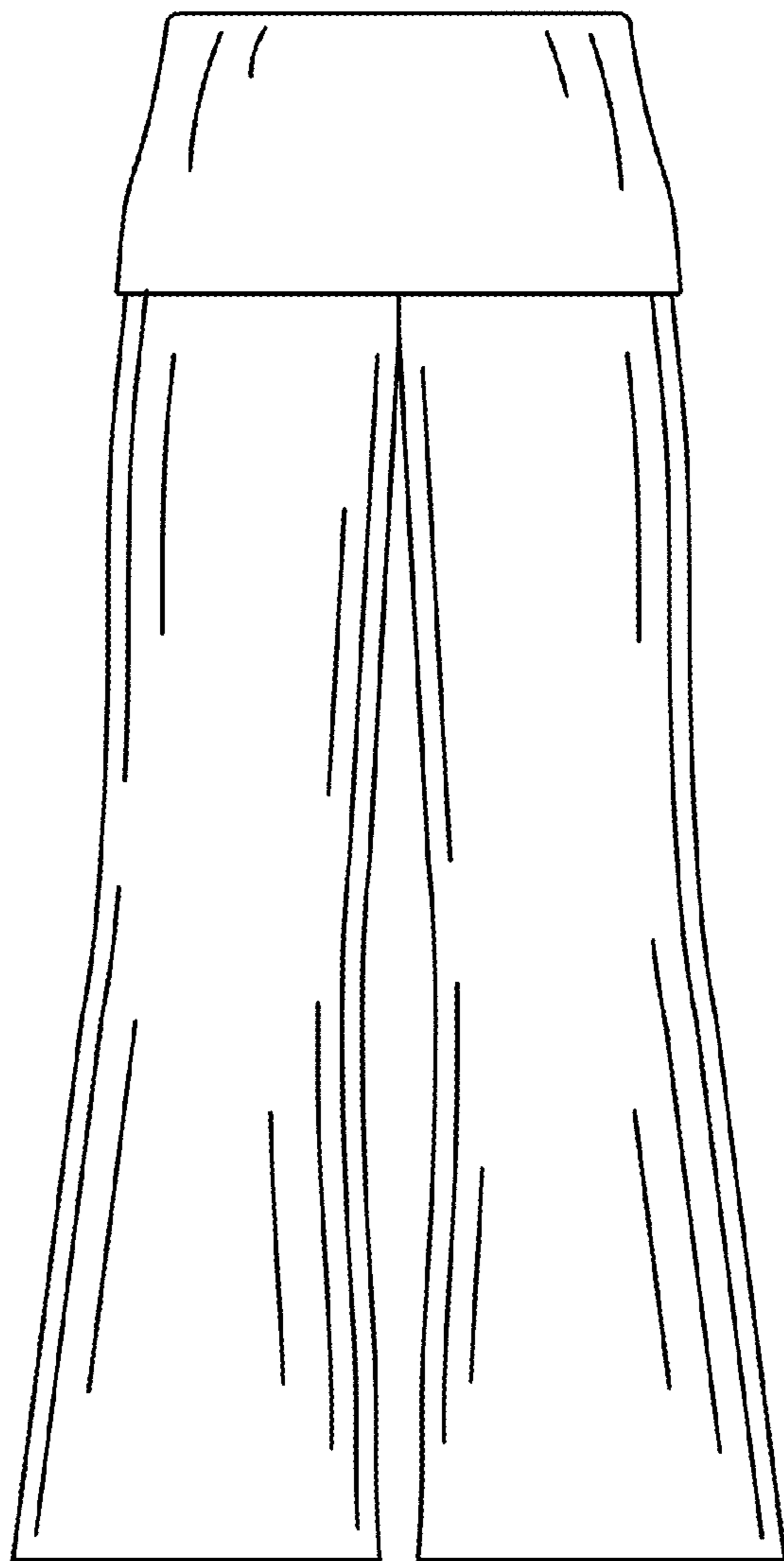

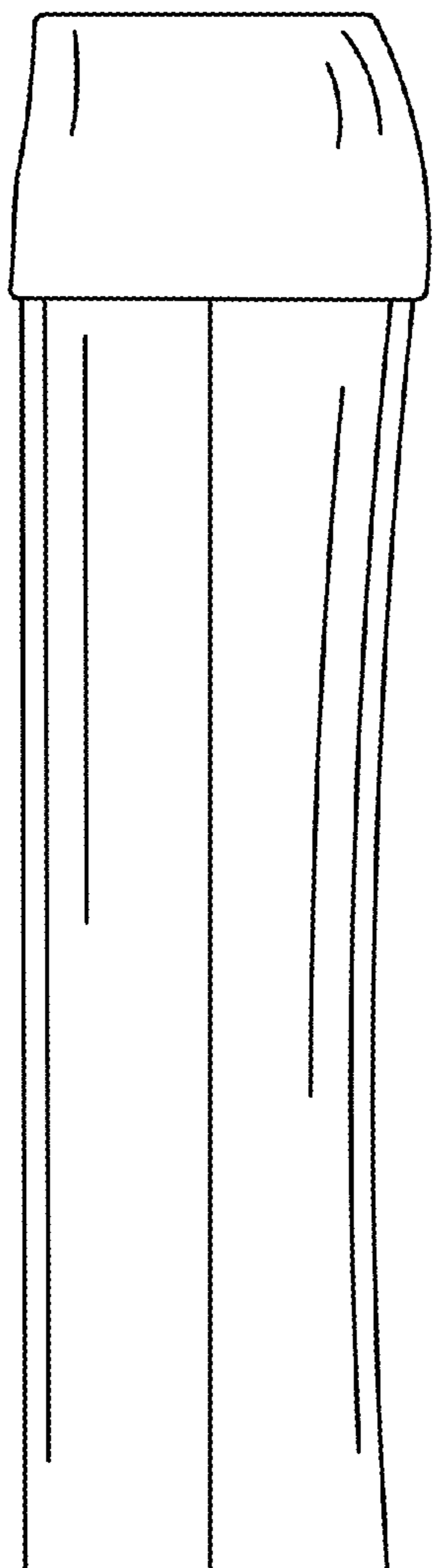

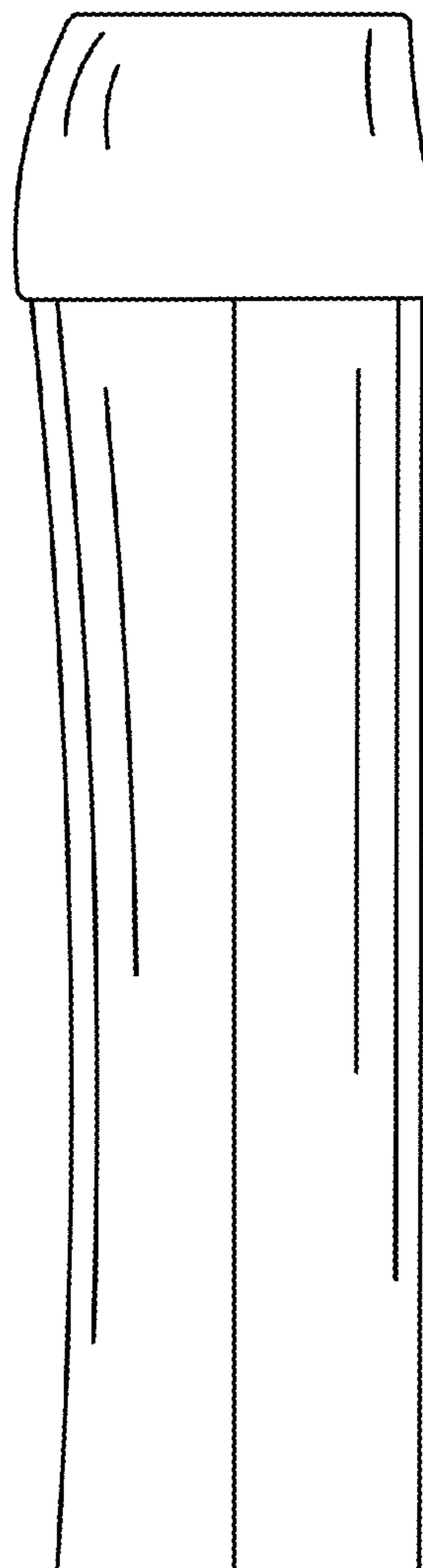

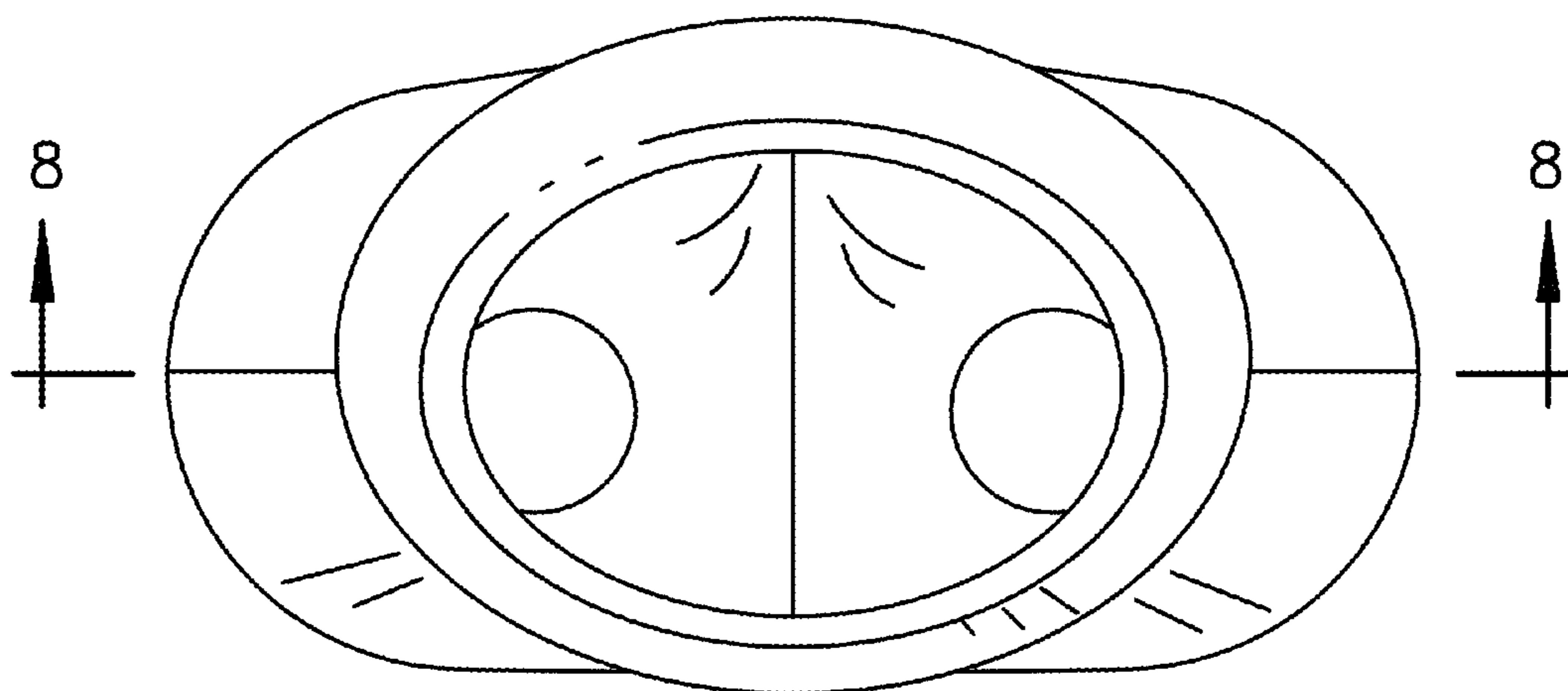

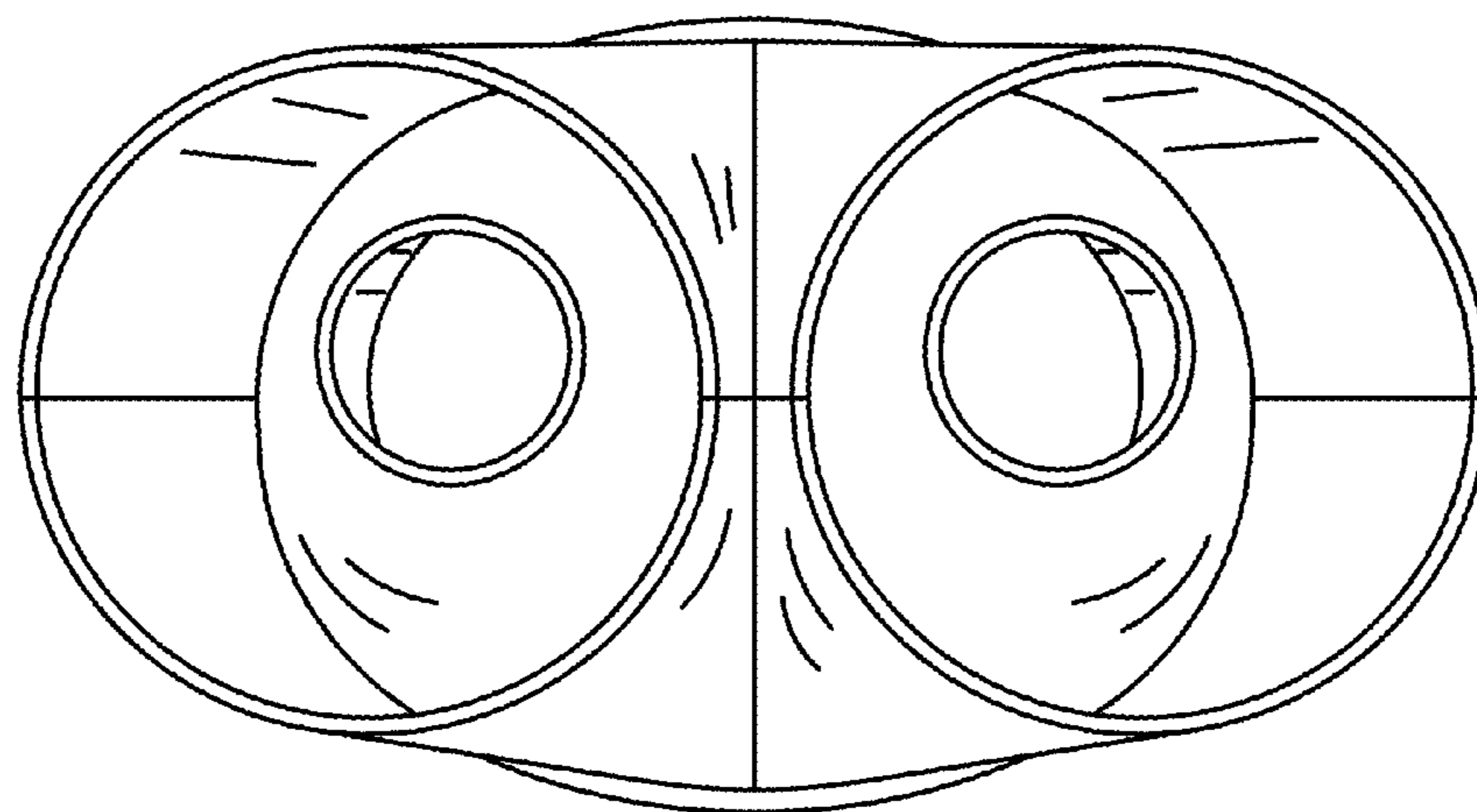

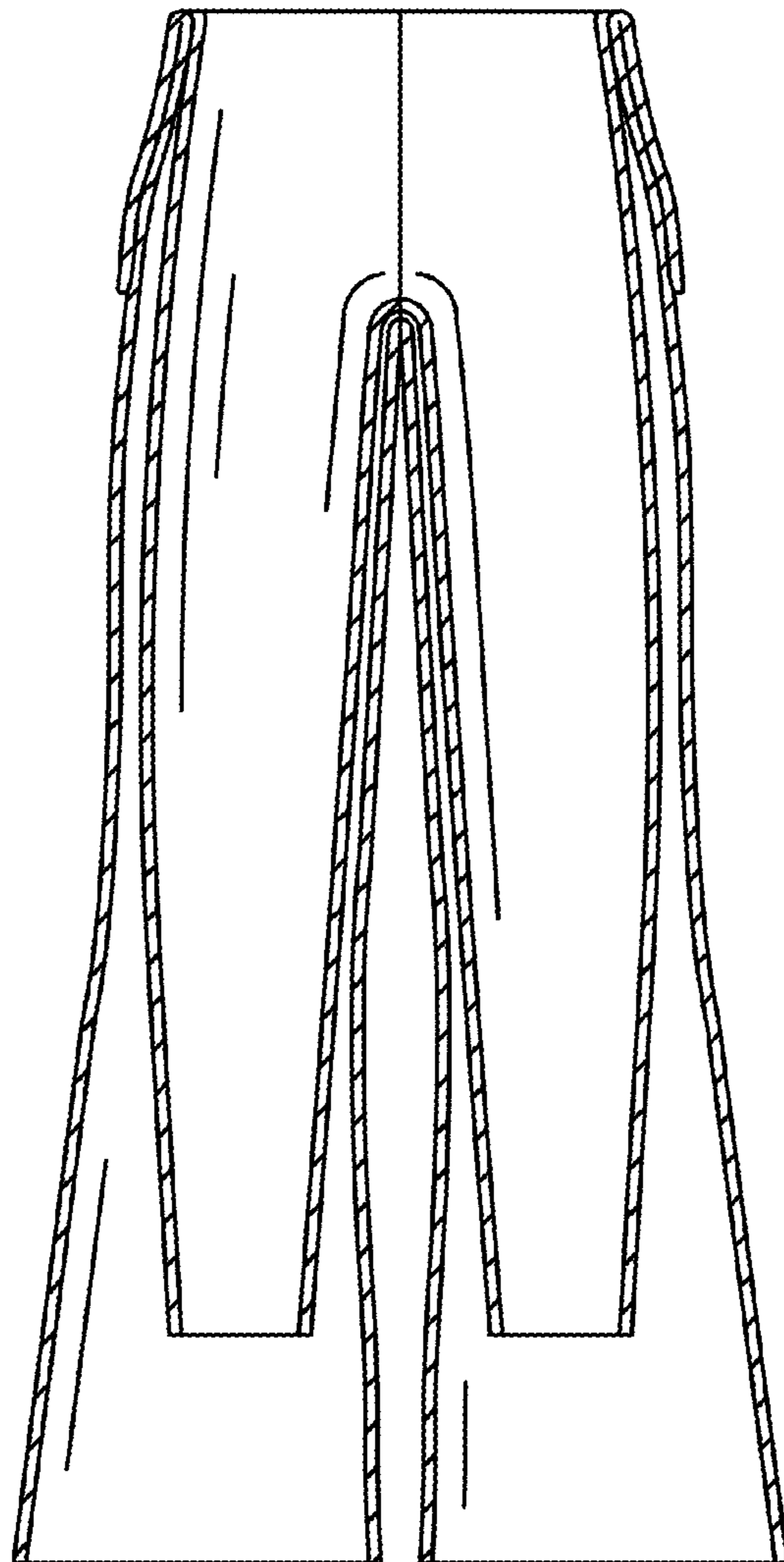
