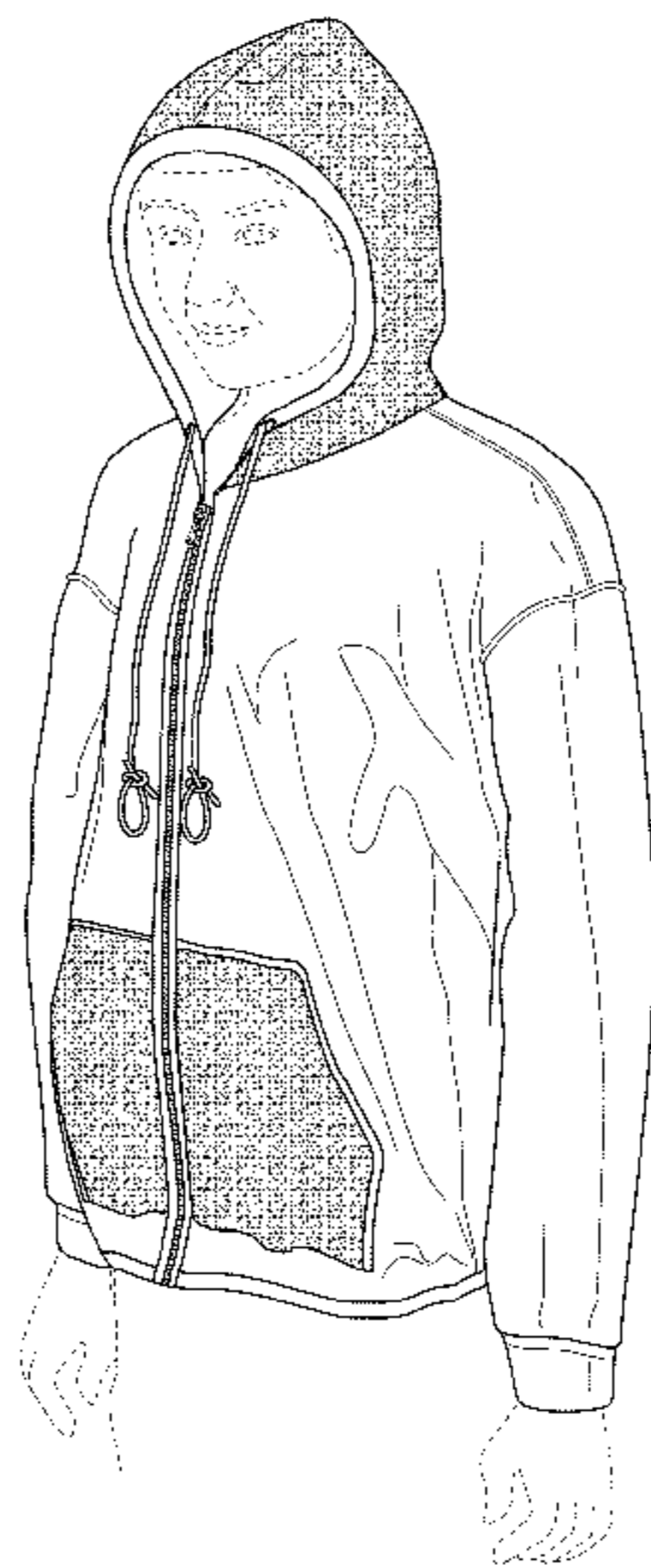
(57) **CLAIM**

I claim the ornamental design for a hooded garment, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a hooded garment, showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a right-side elevational view thereof, the left-side elevational view being a mirror image thereof;
FIG. 5 is a top plan view thereof; and,
FIG. 6 is a bottom plan view thereof.
The broken lines showing a person in FIG. 1 depict environmental matter and form no part of the claimed design. The contrasting shading on the hood and pocket portion of the garment represents a contrasting color or fabric added thereto.

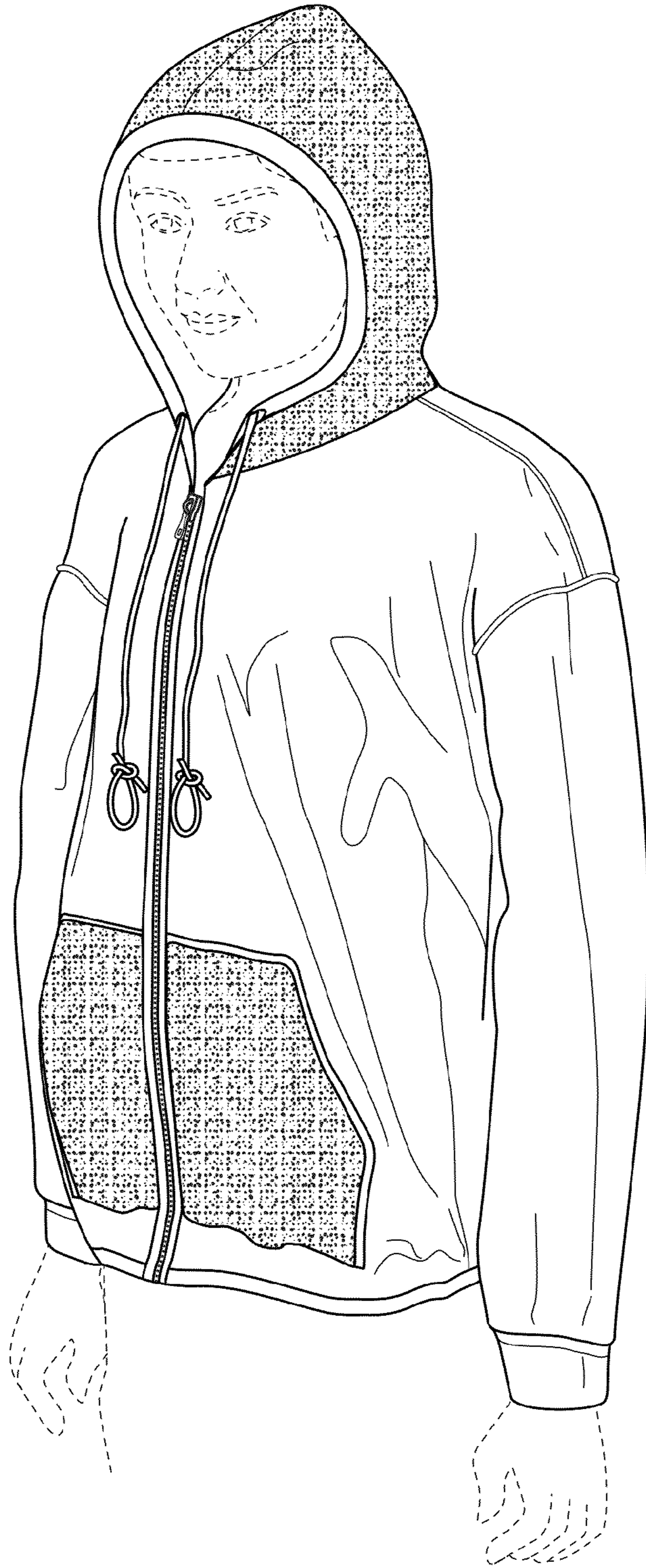

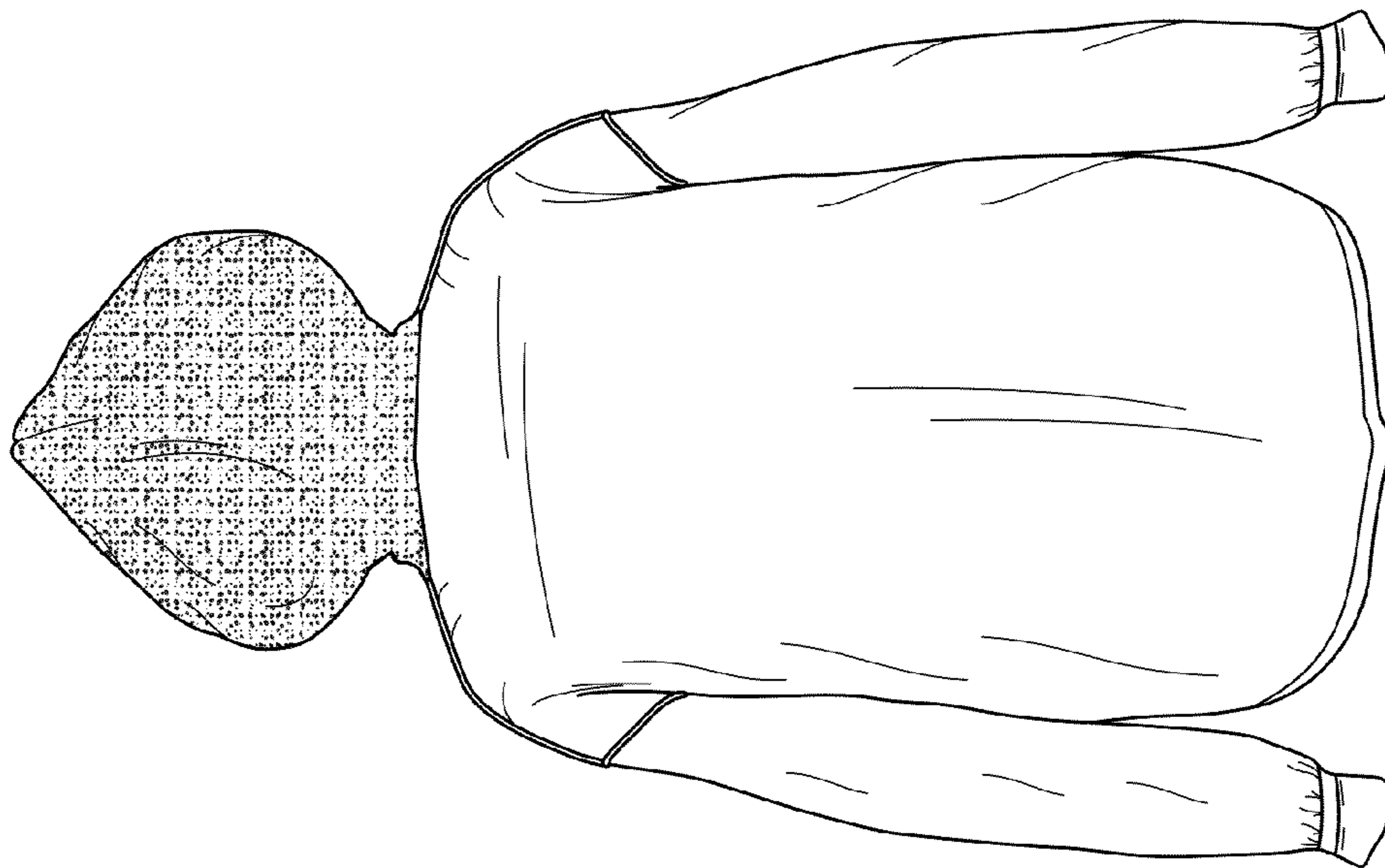

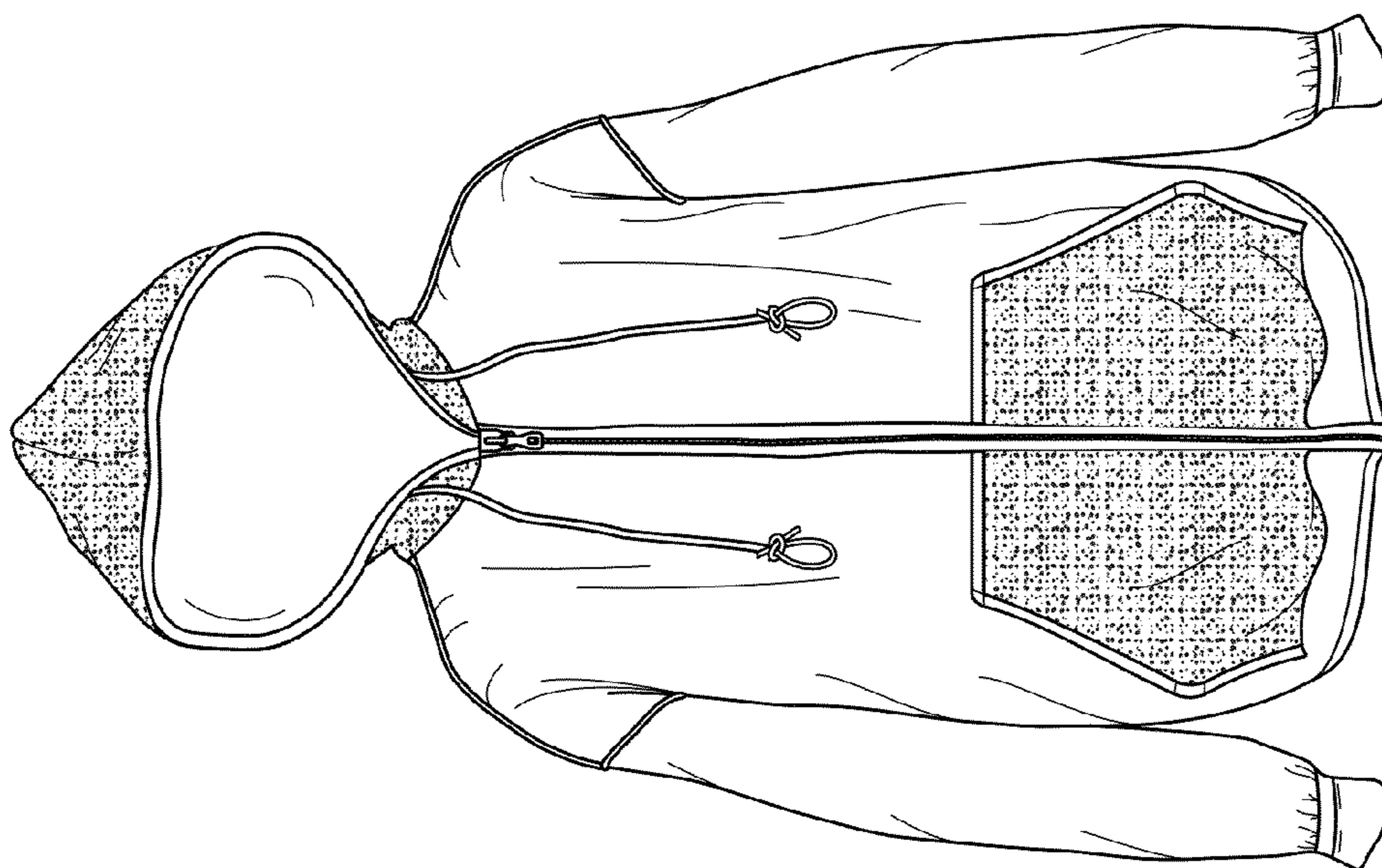

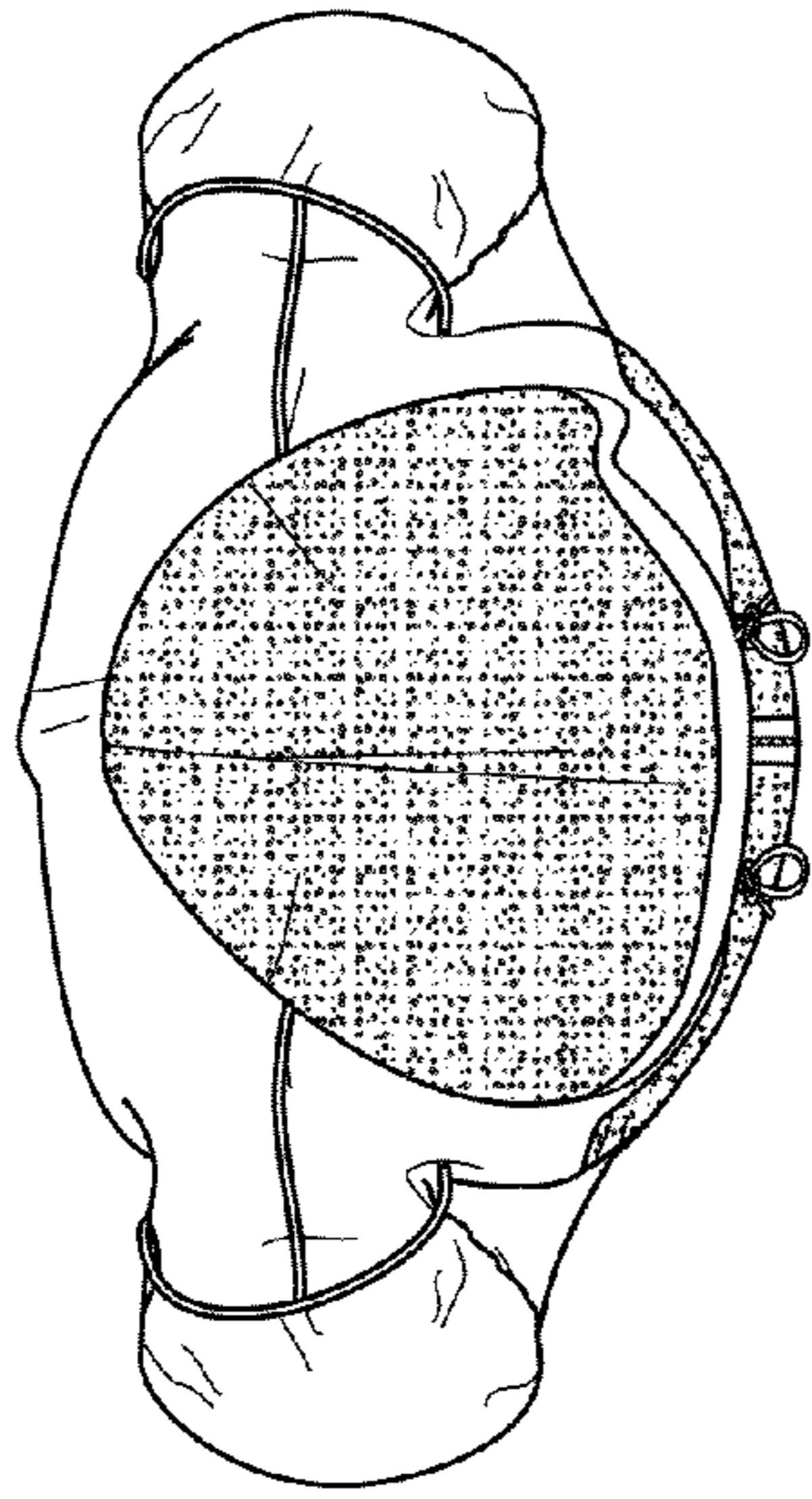

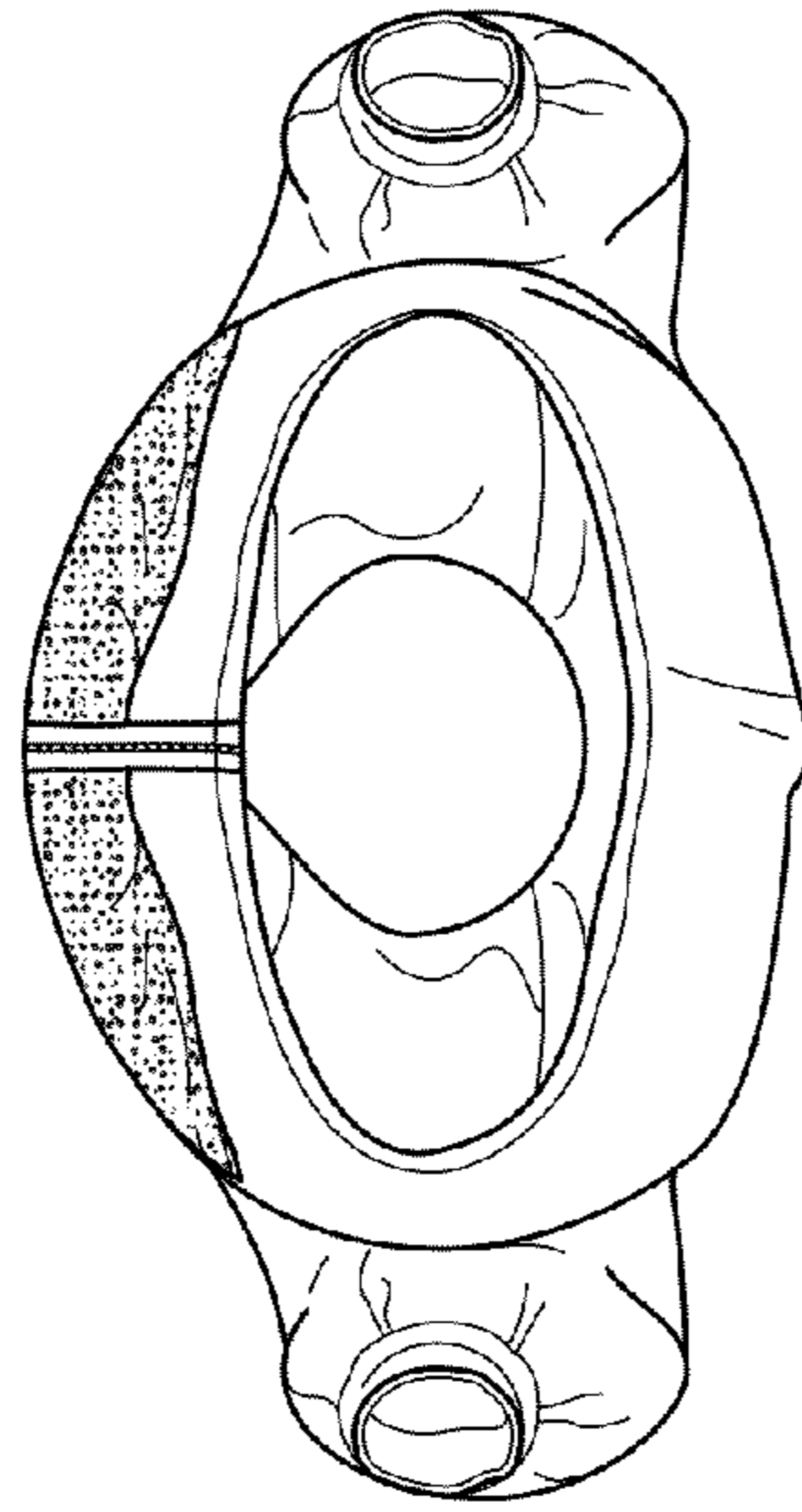

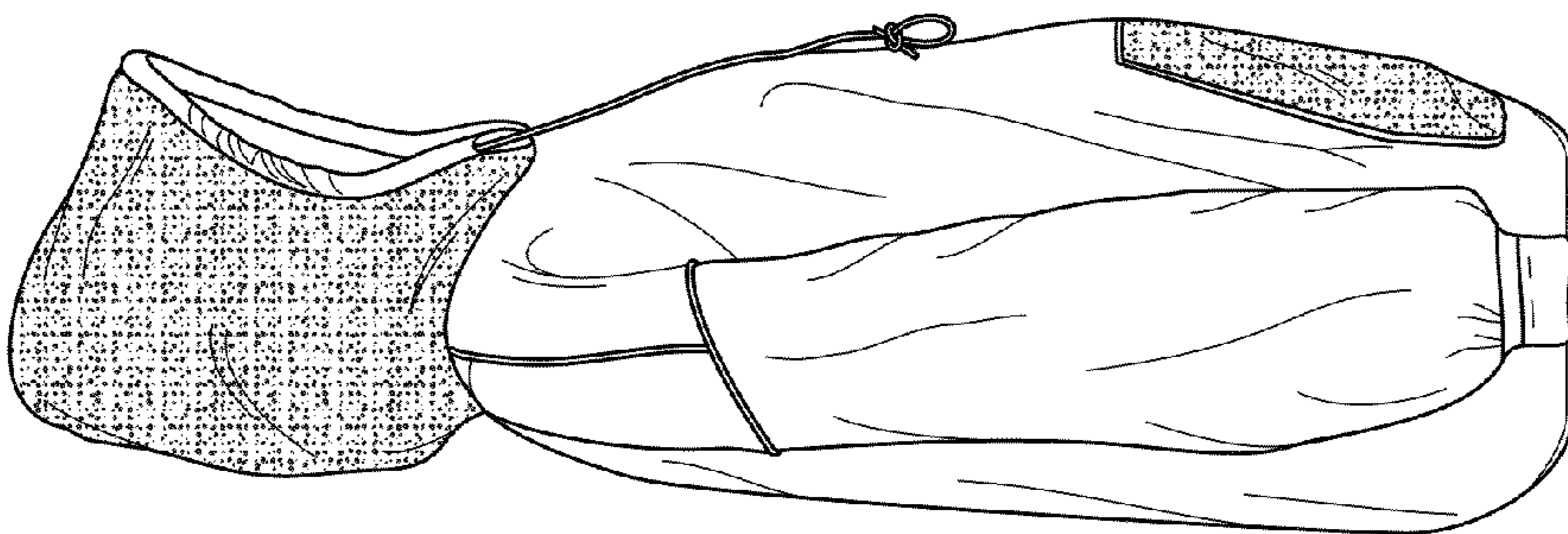
