I claim the ornamental design for a baby neck tie bib, as shown and described.

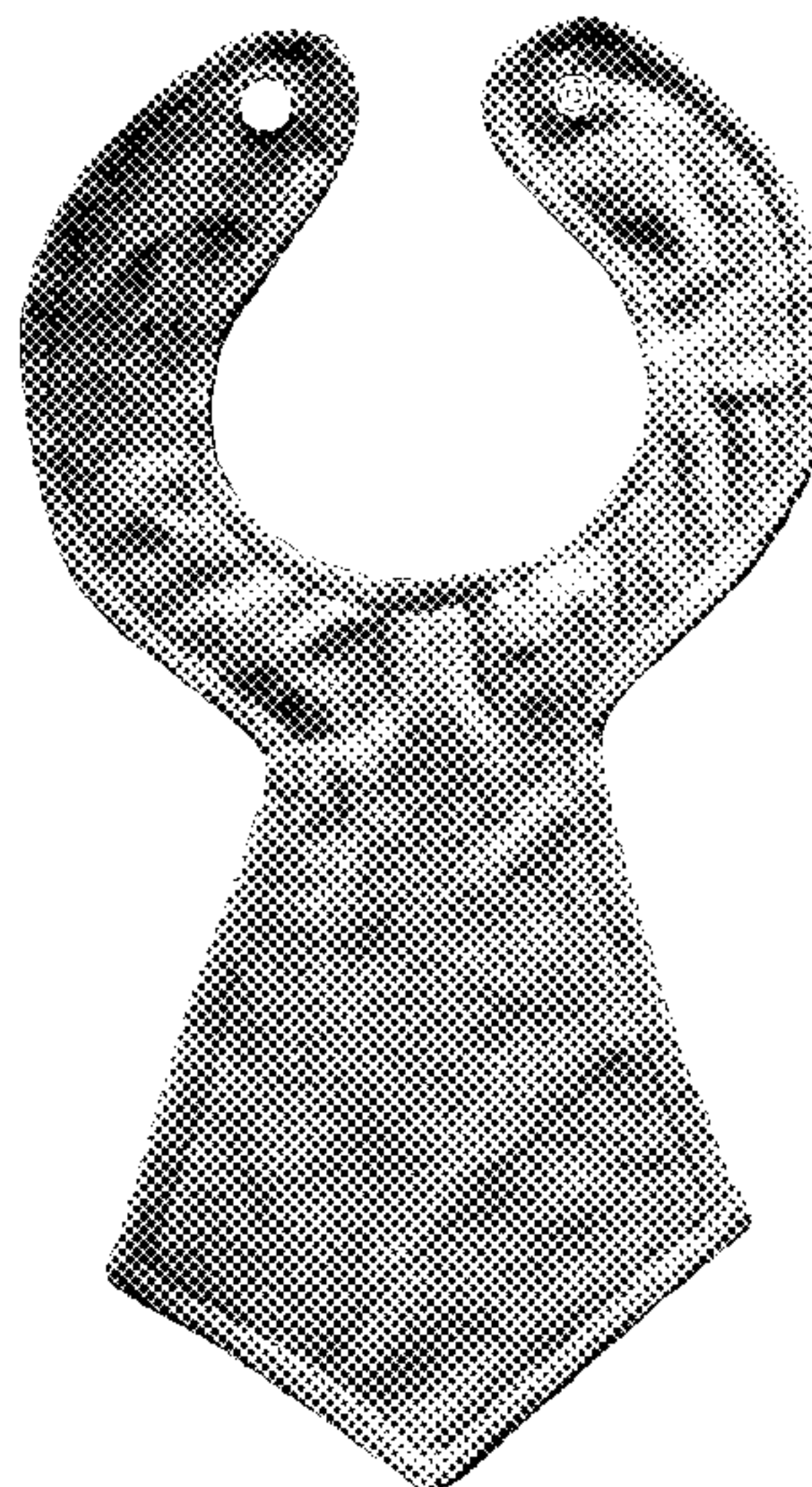
DESCRIPTION

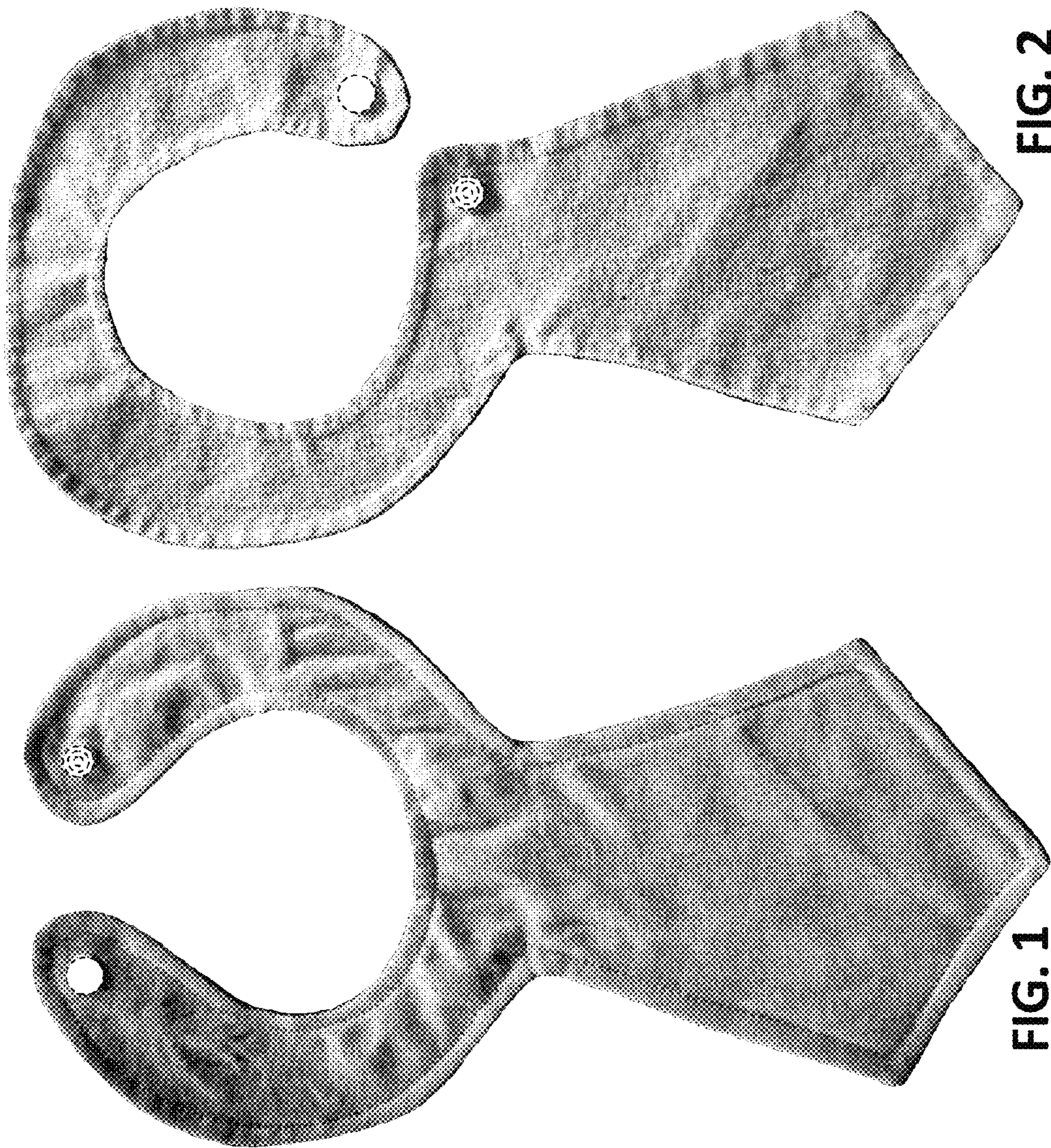
