DESCRIPTION

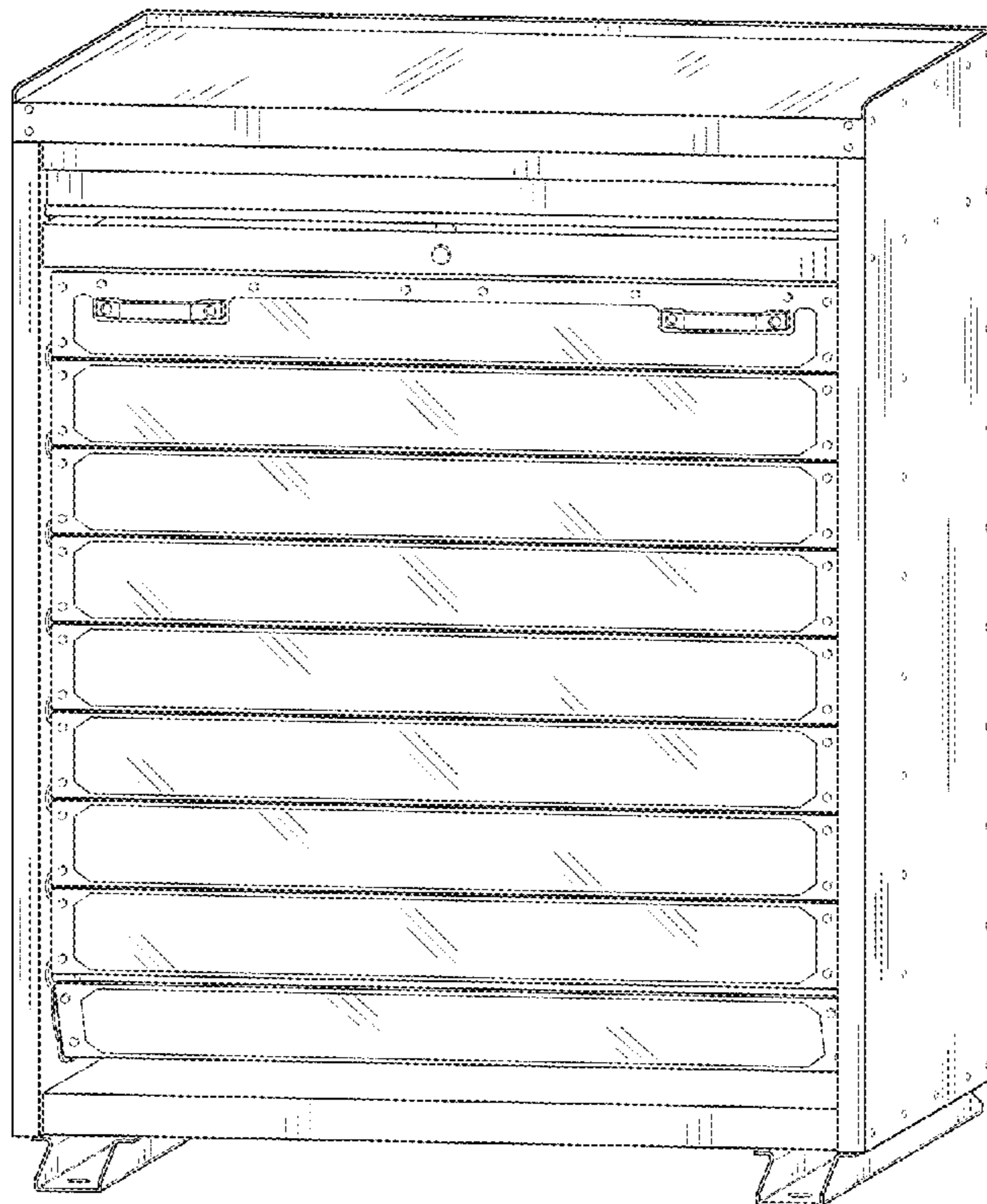
FIG. 1 is an isometric view of the brake tool cabinet showing the new design;

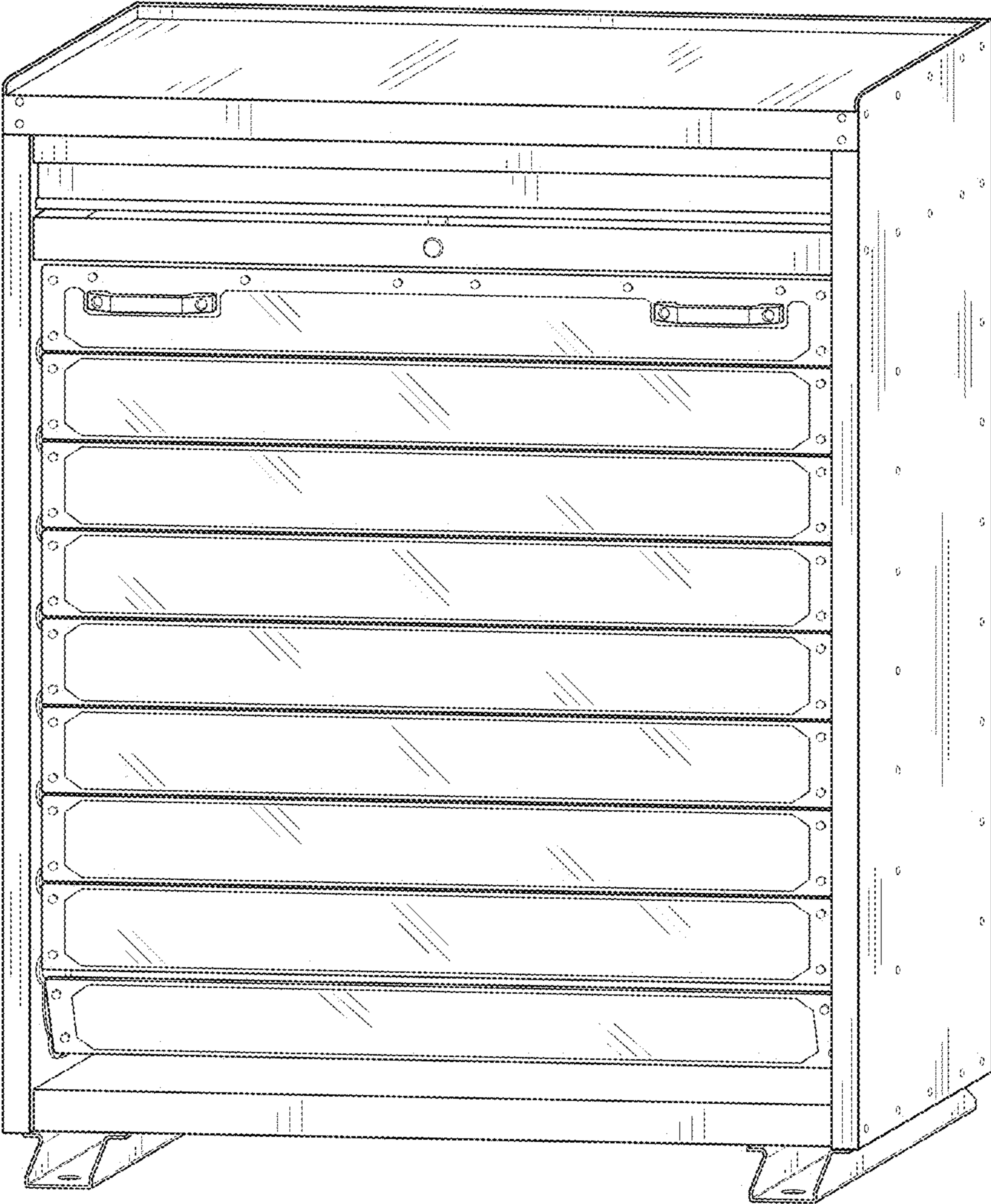

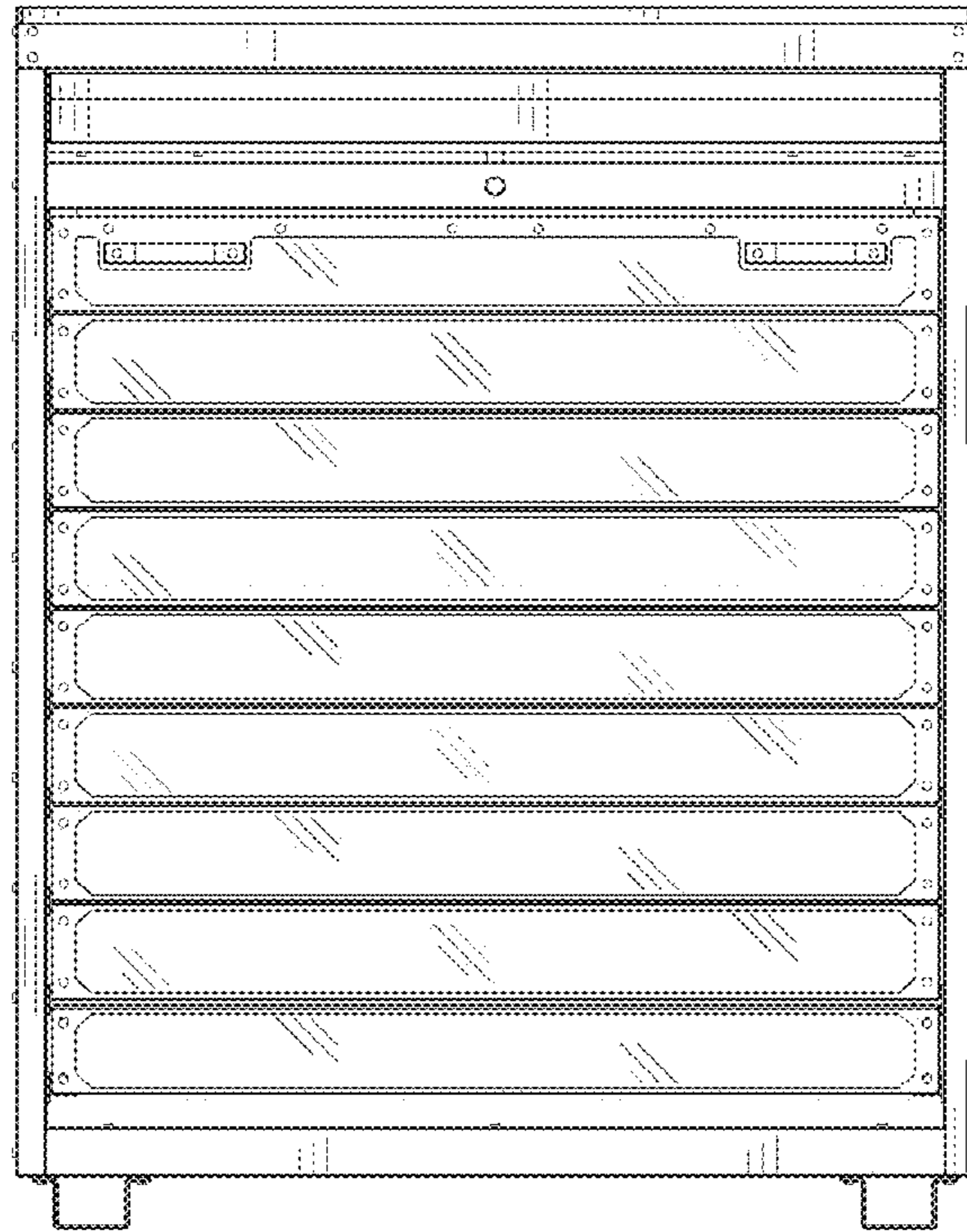

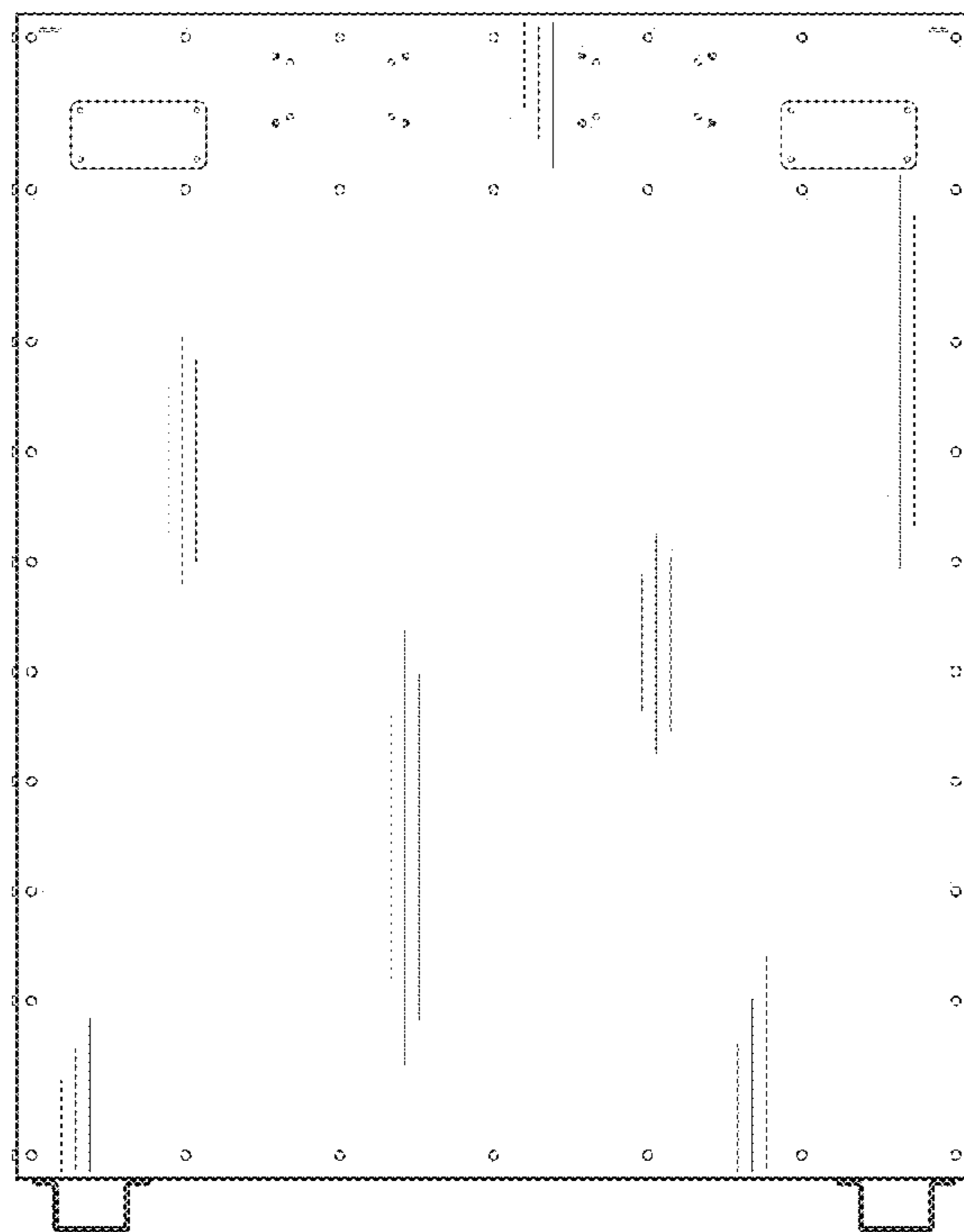

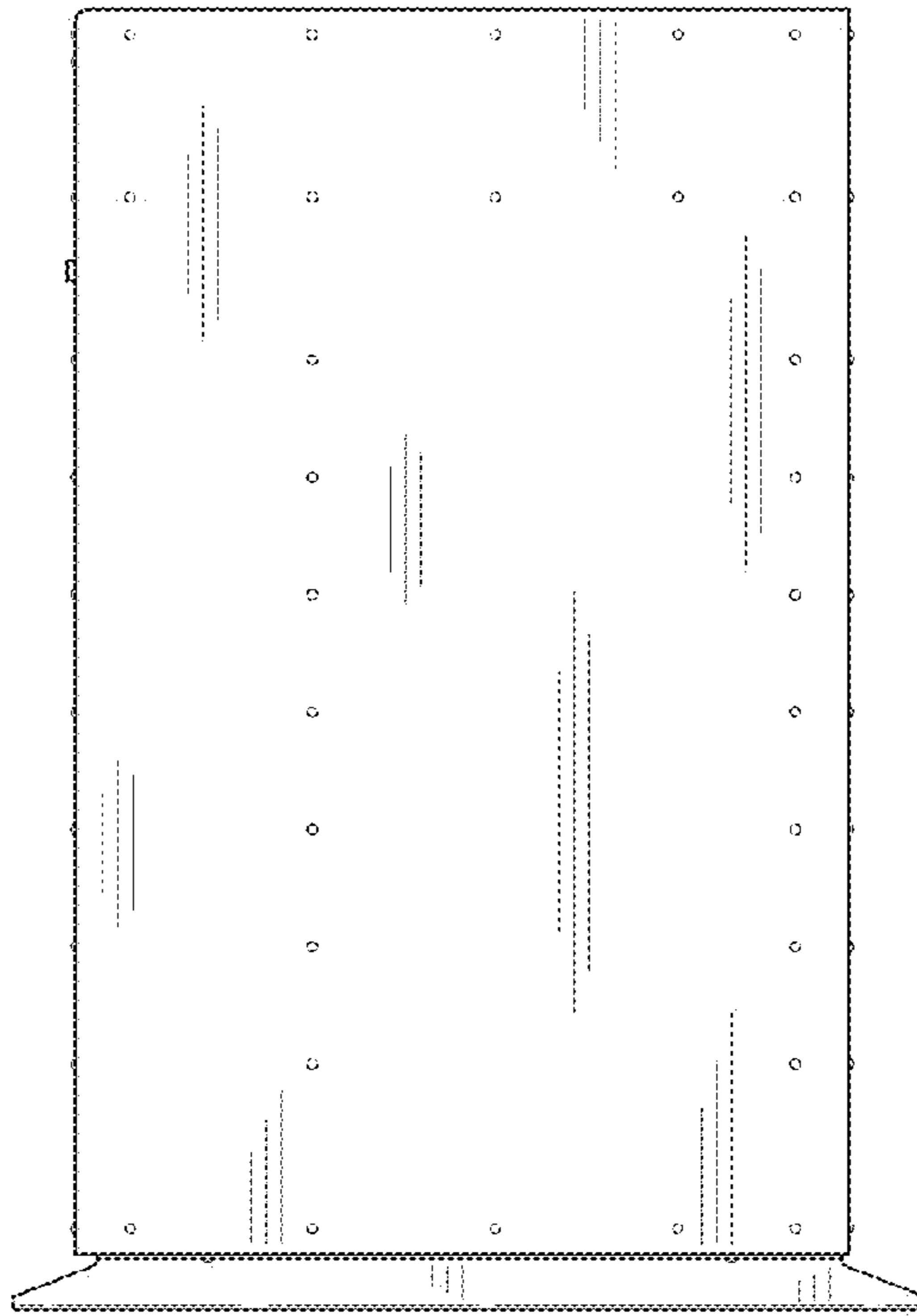

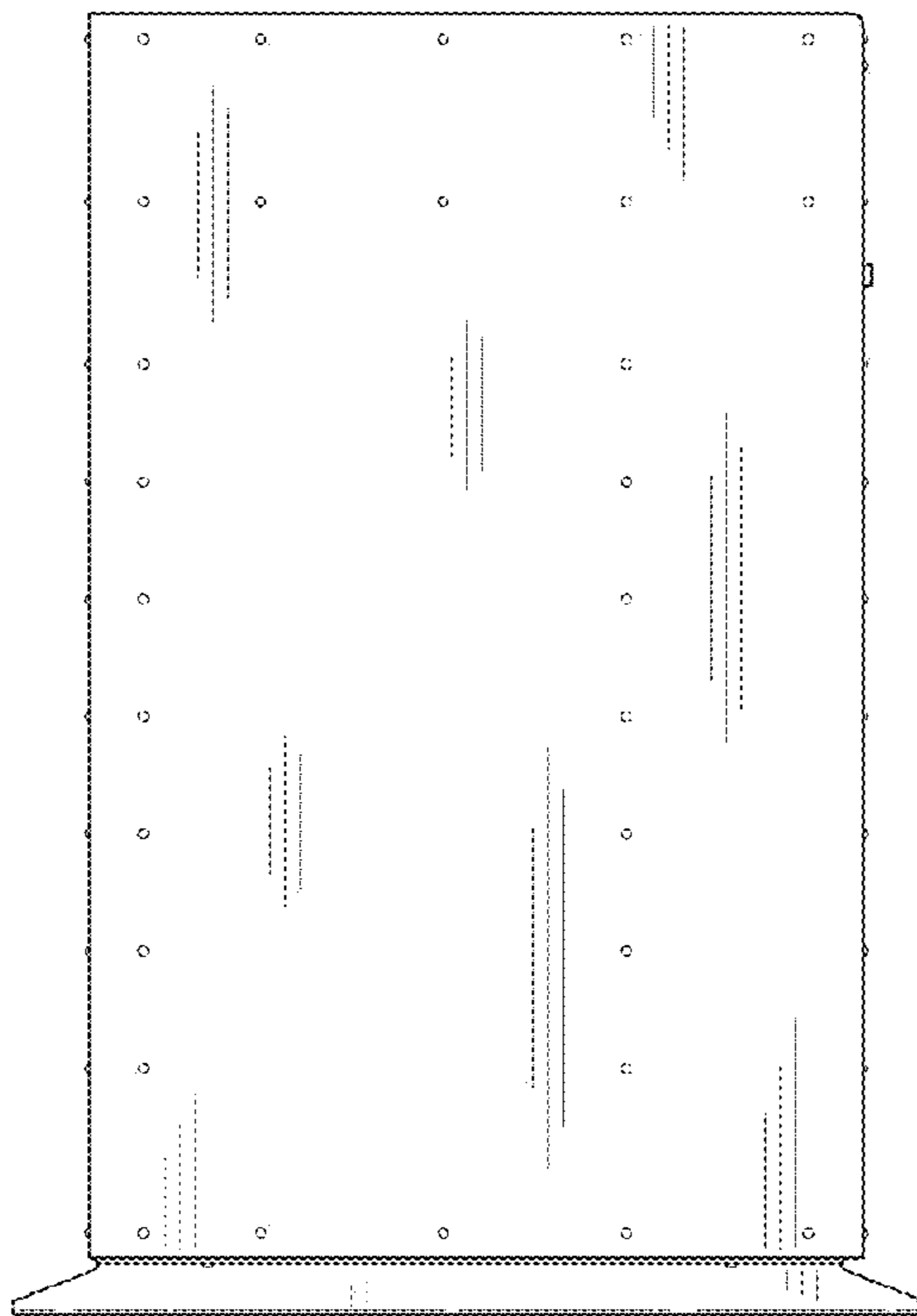

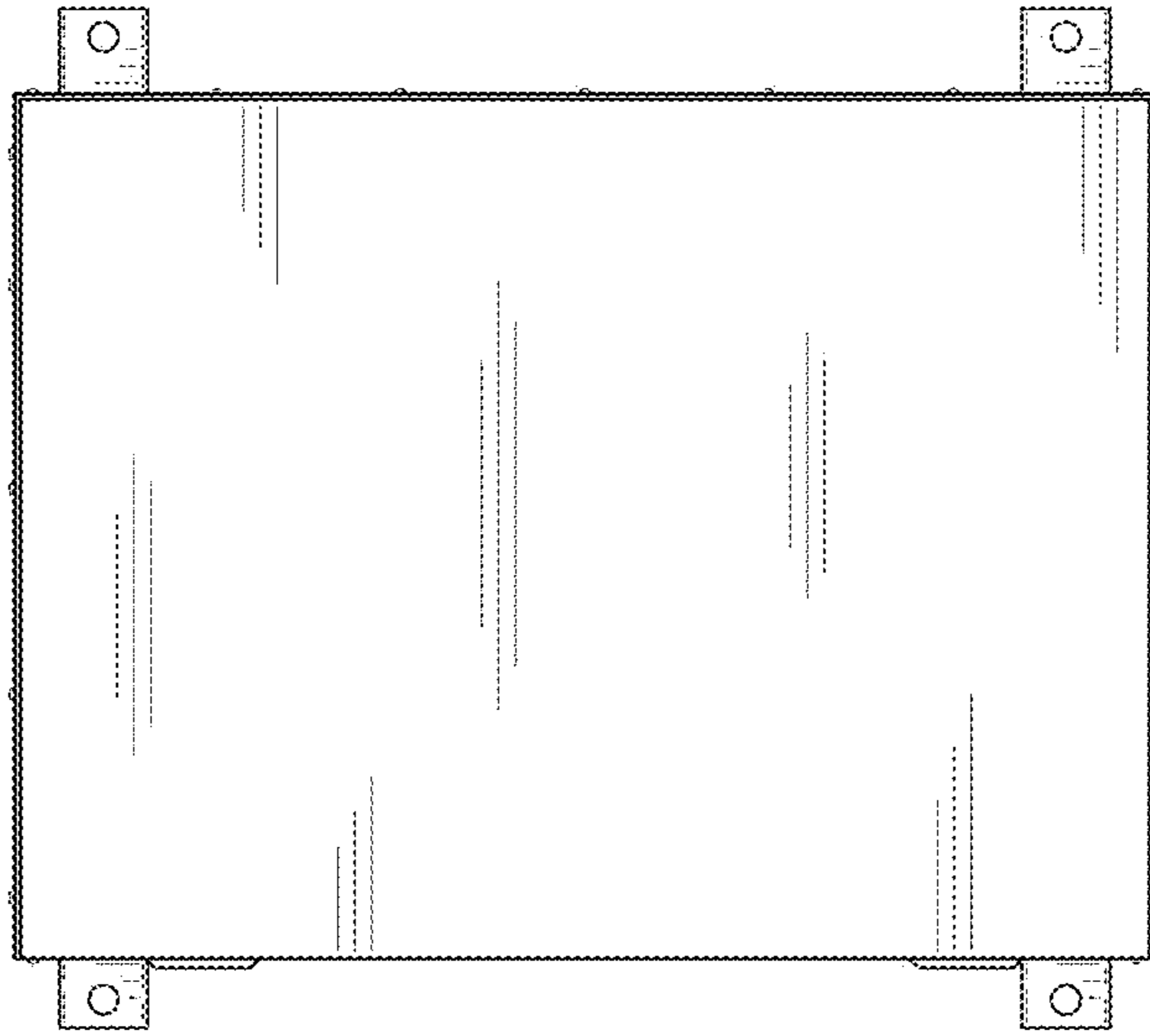

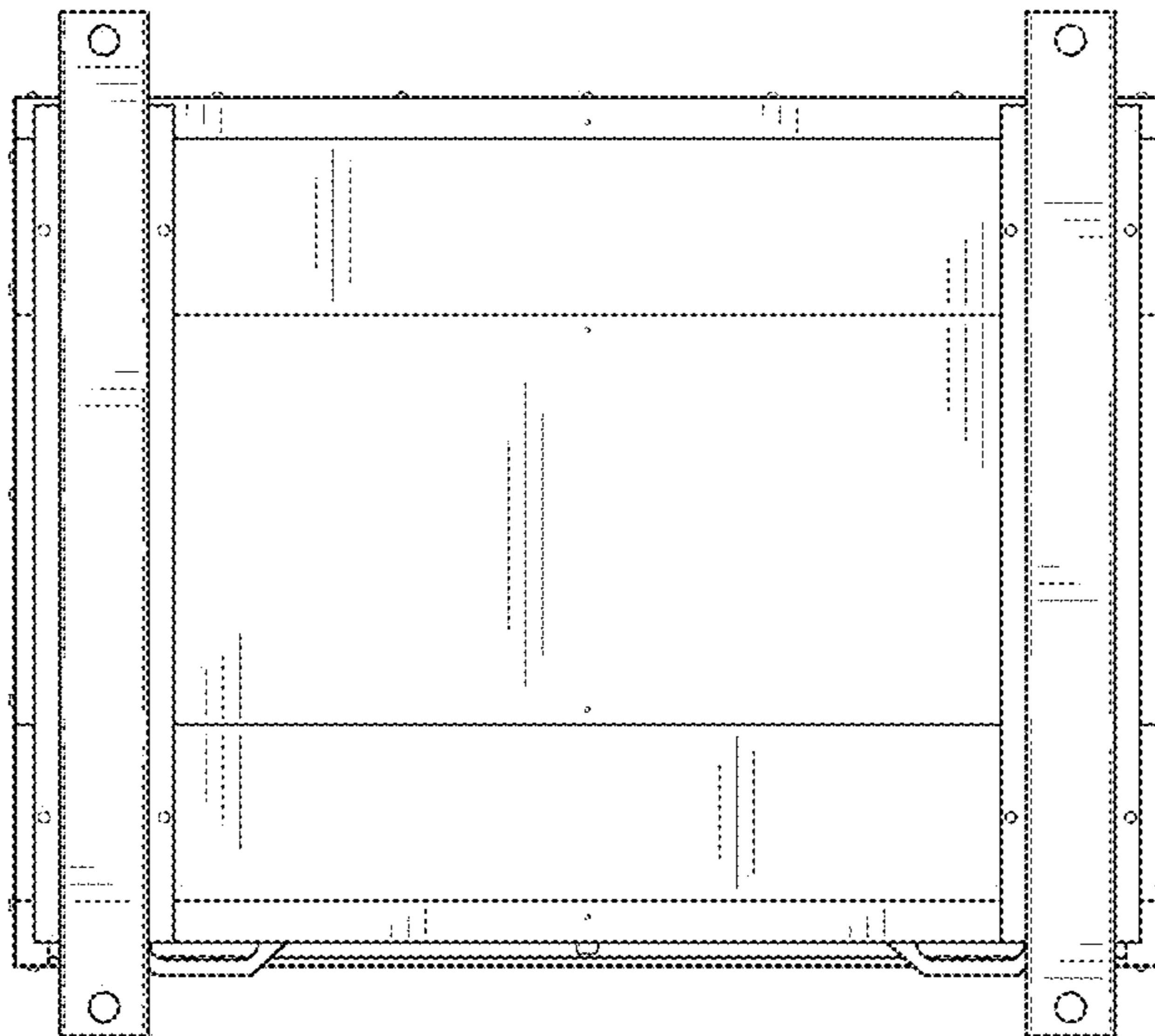
