(57) **CLAIM**

I claim the ornamental design for a high heeled shaped mer-  
chandise display, as shown and described.

FIG. 8 is a bottom perspective view thereof.

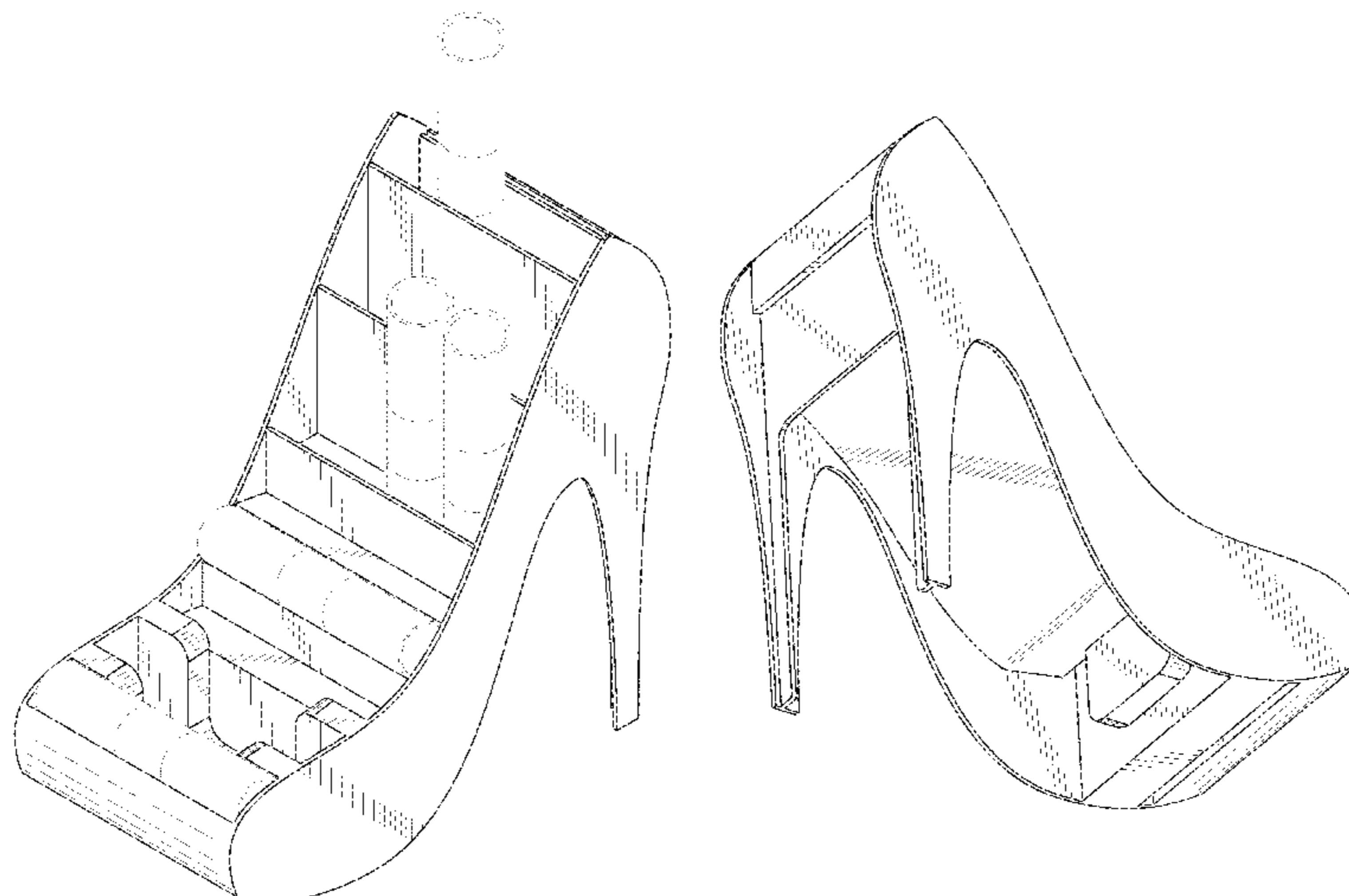

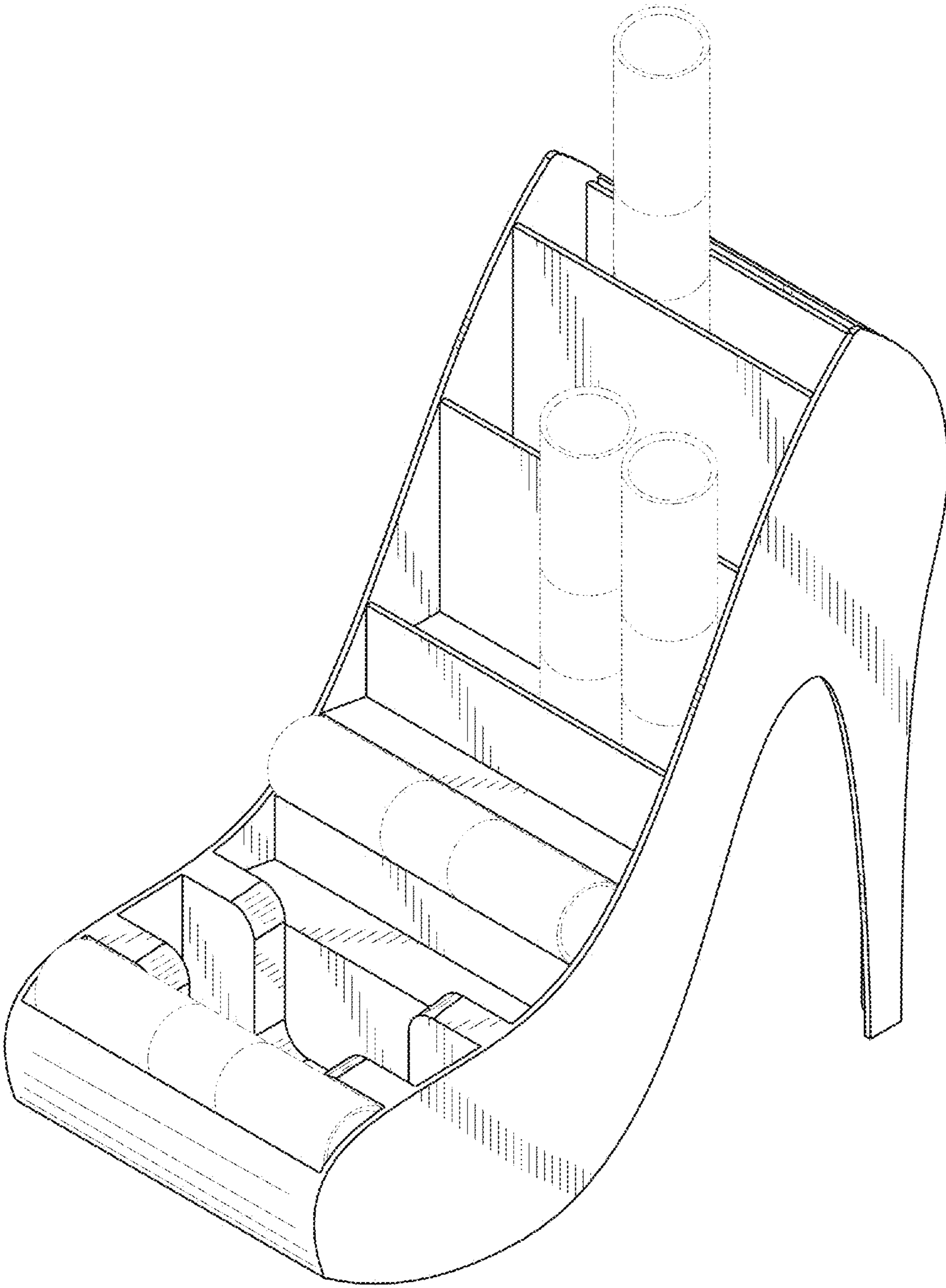
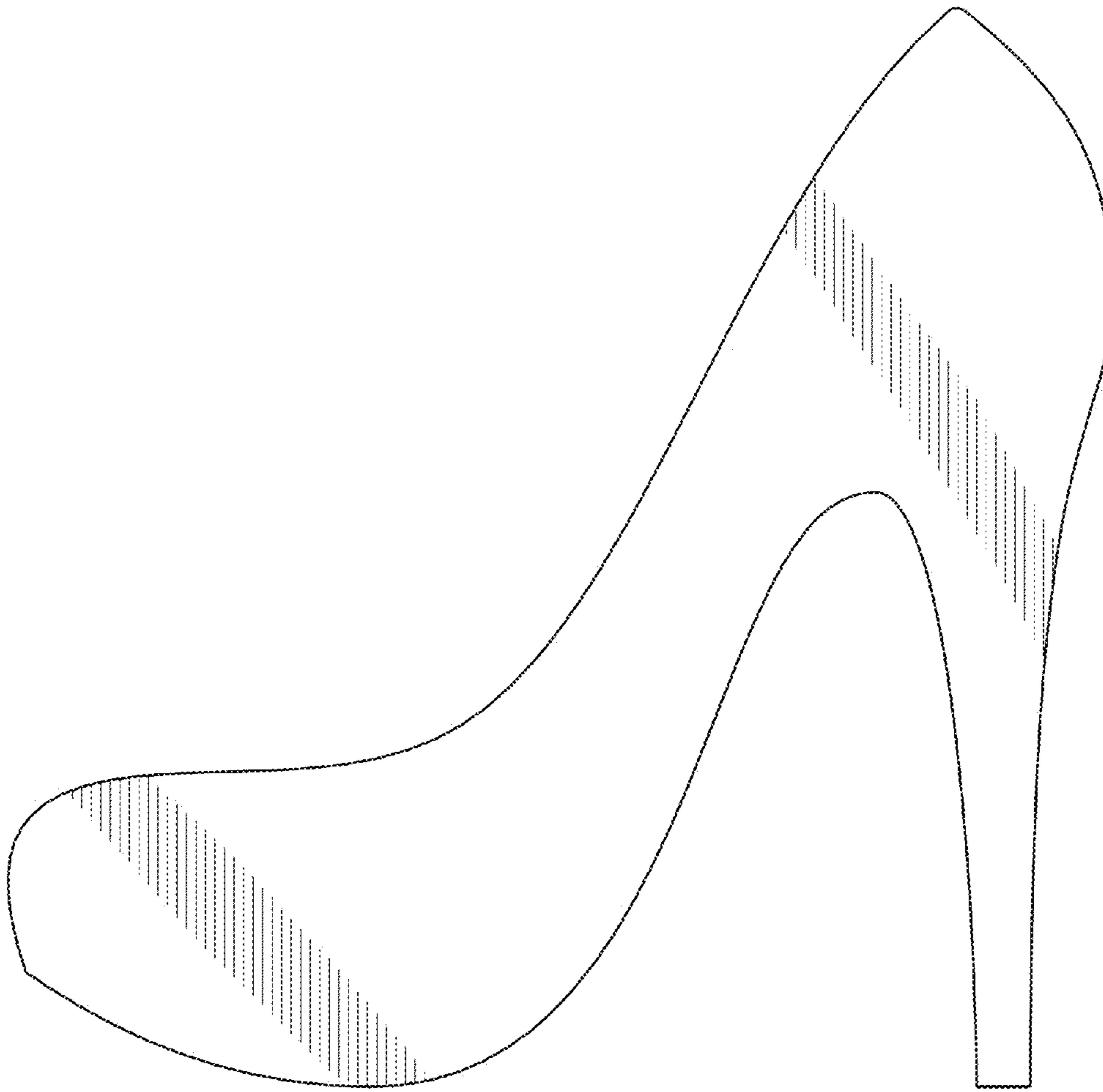
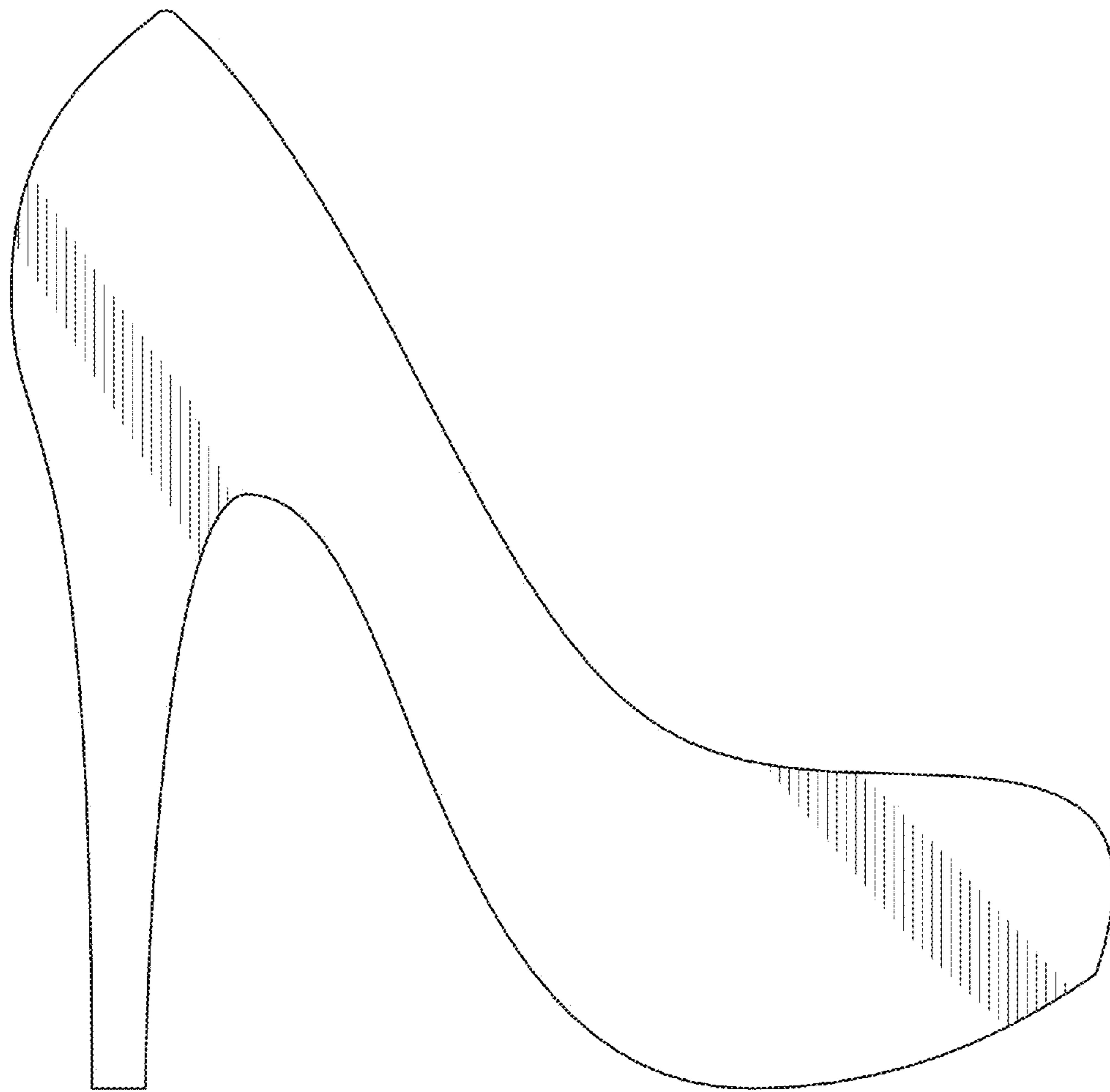

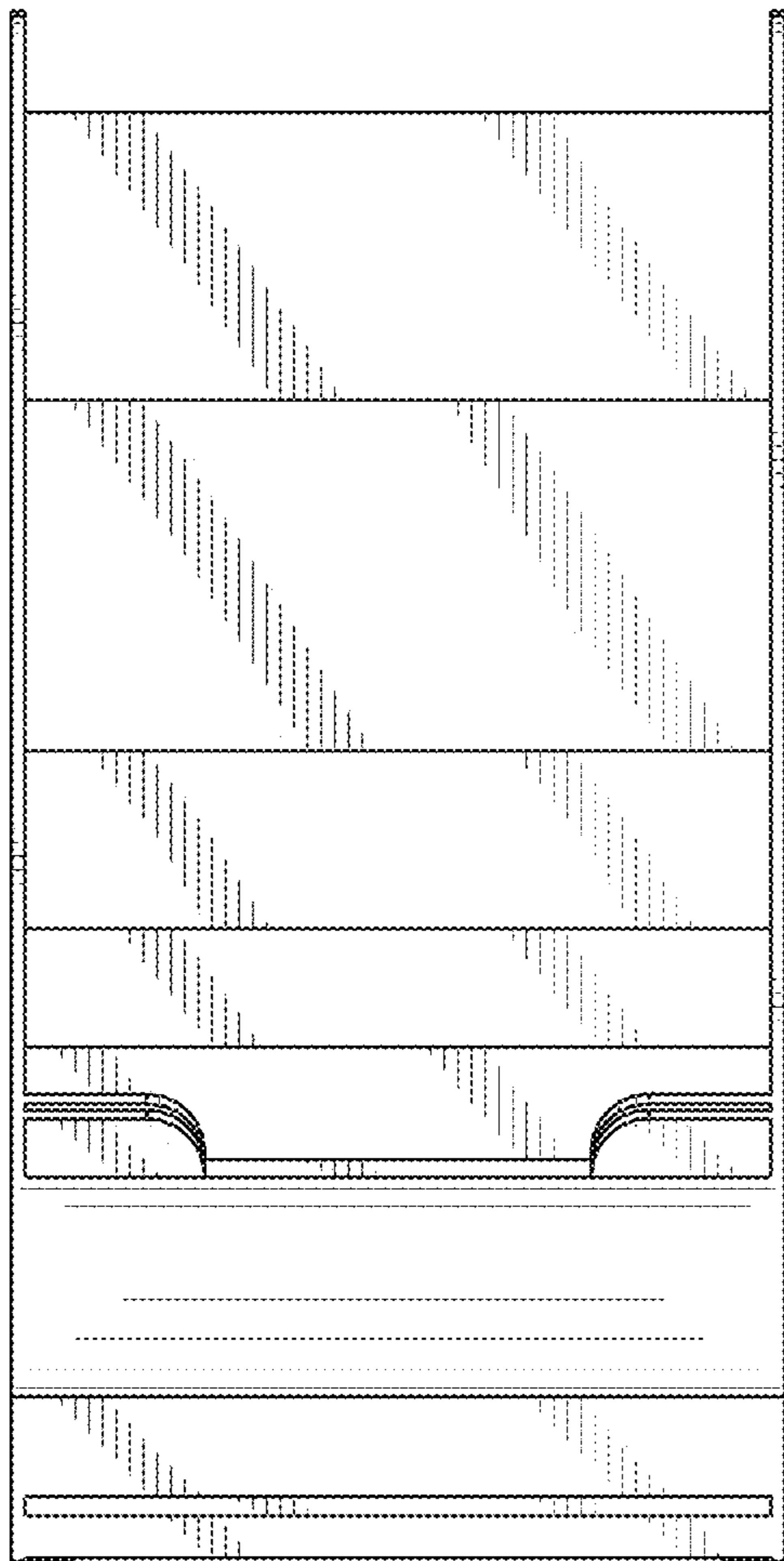

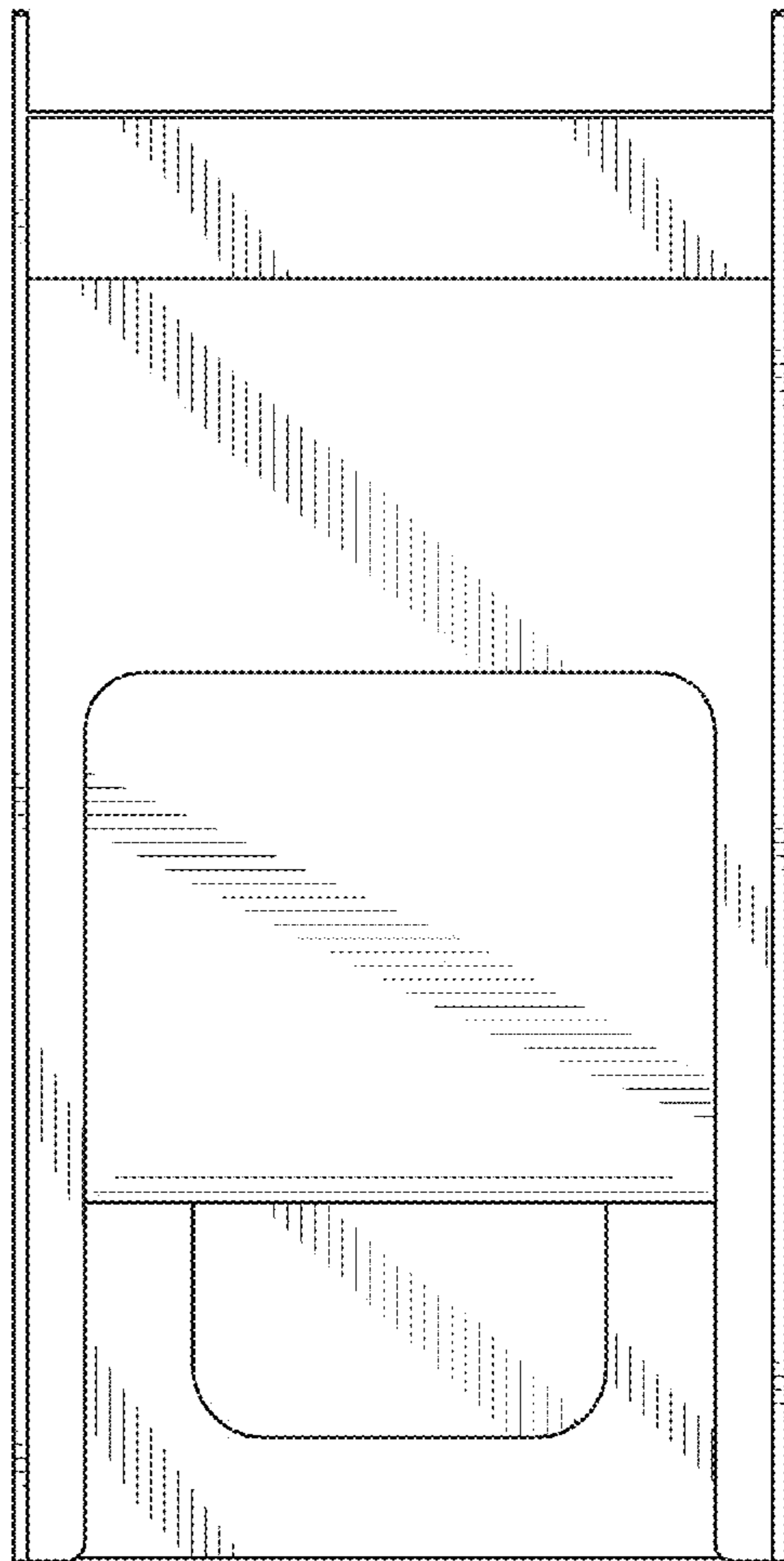
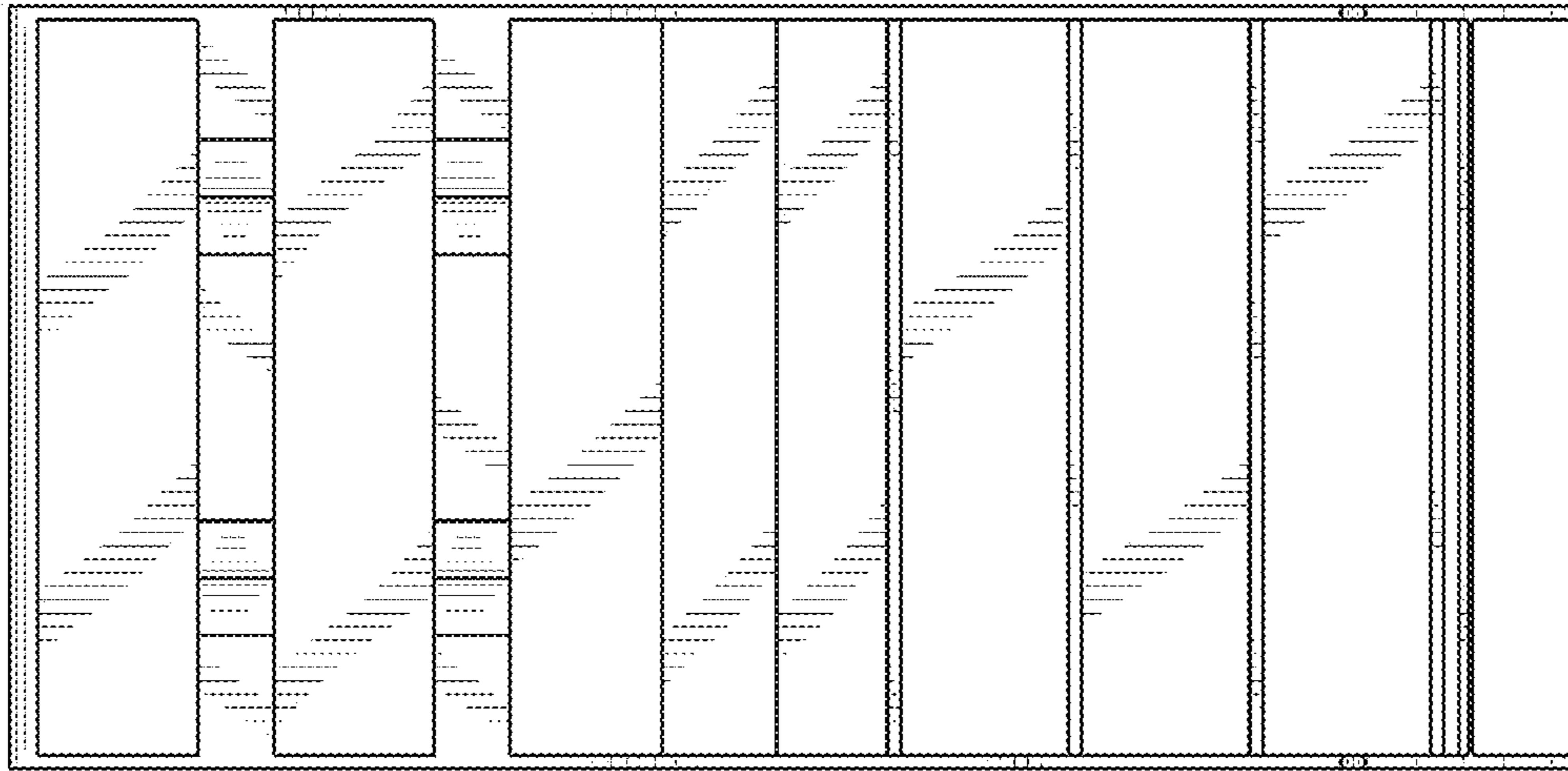
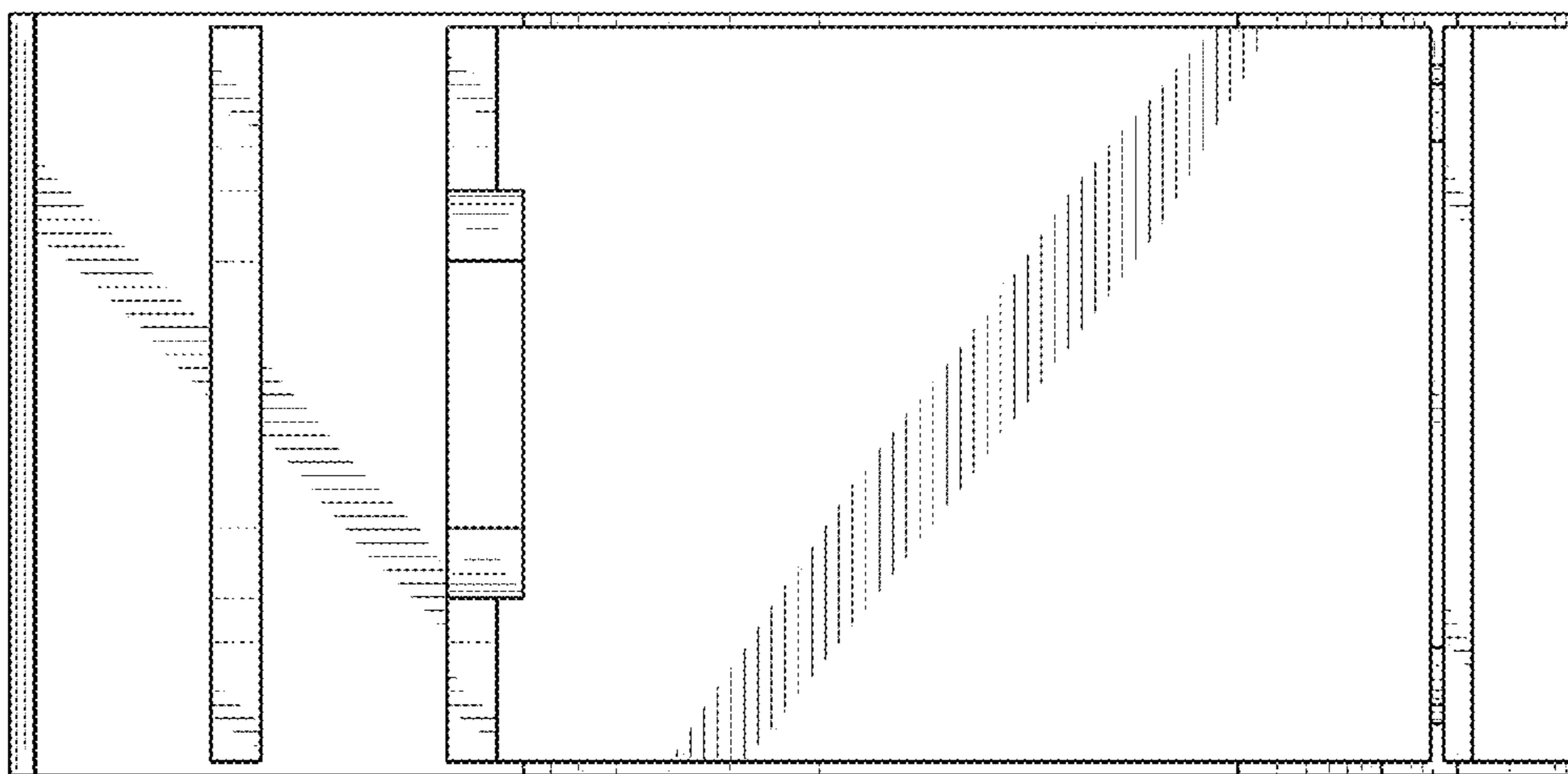


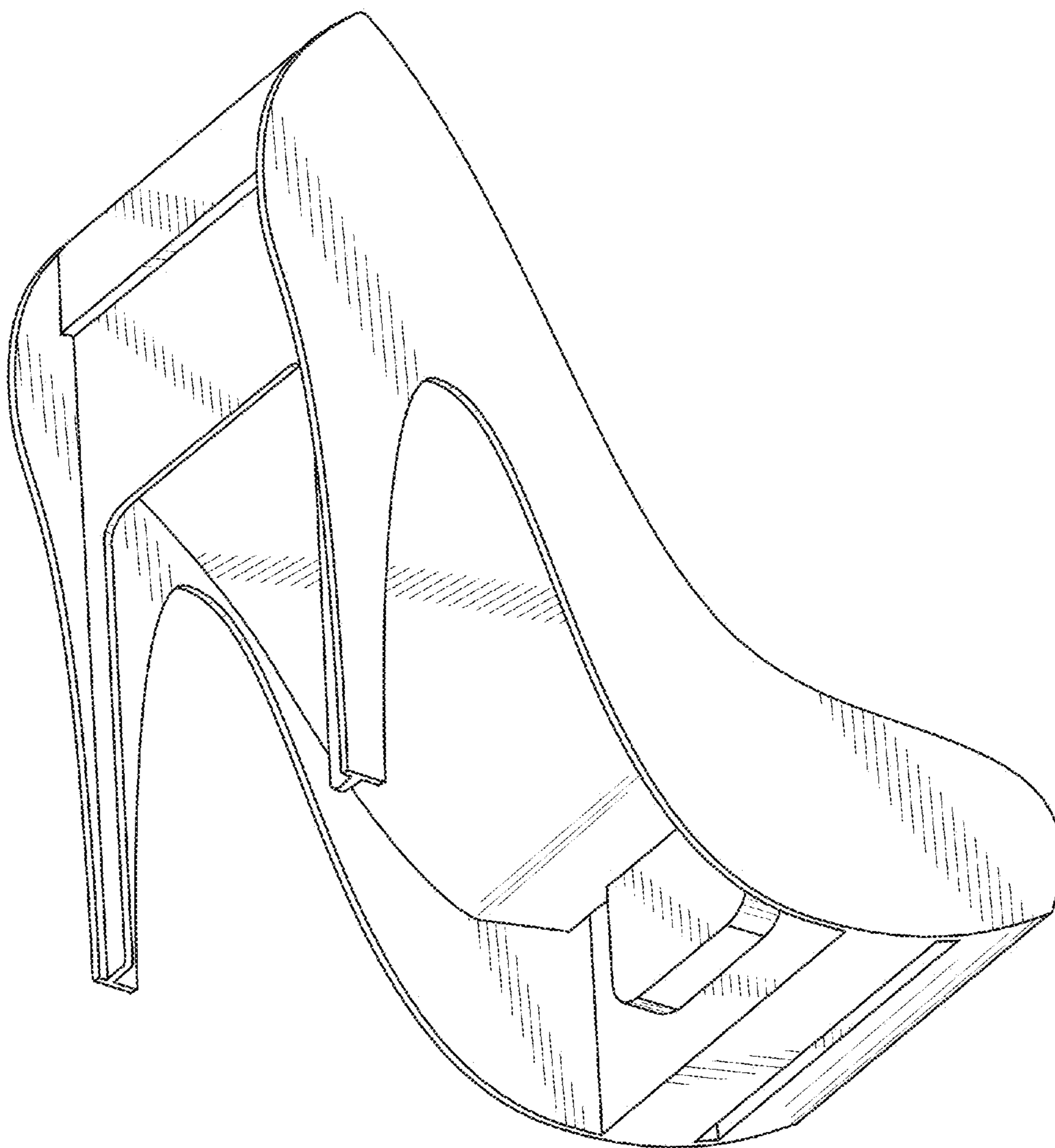
