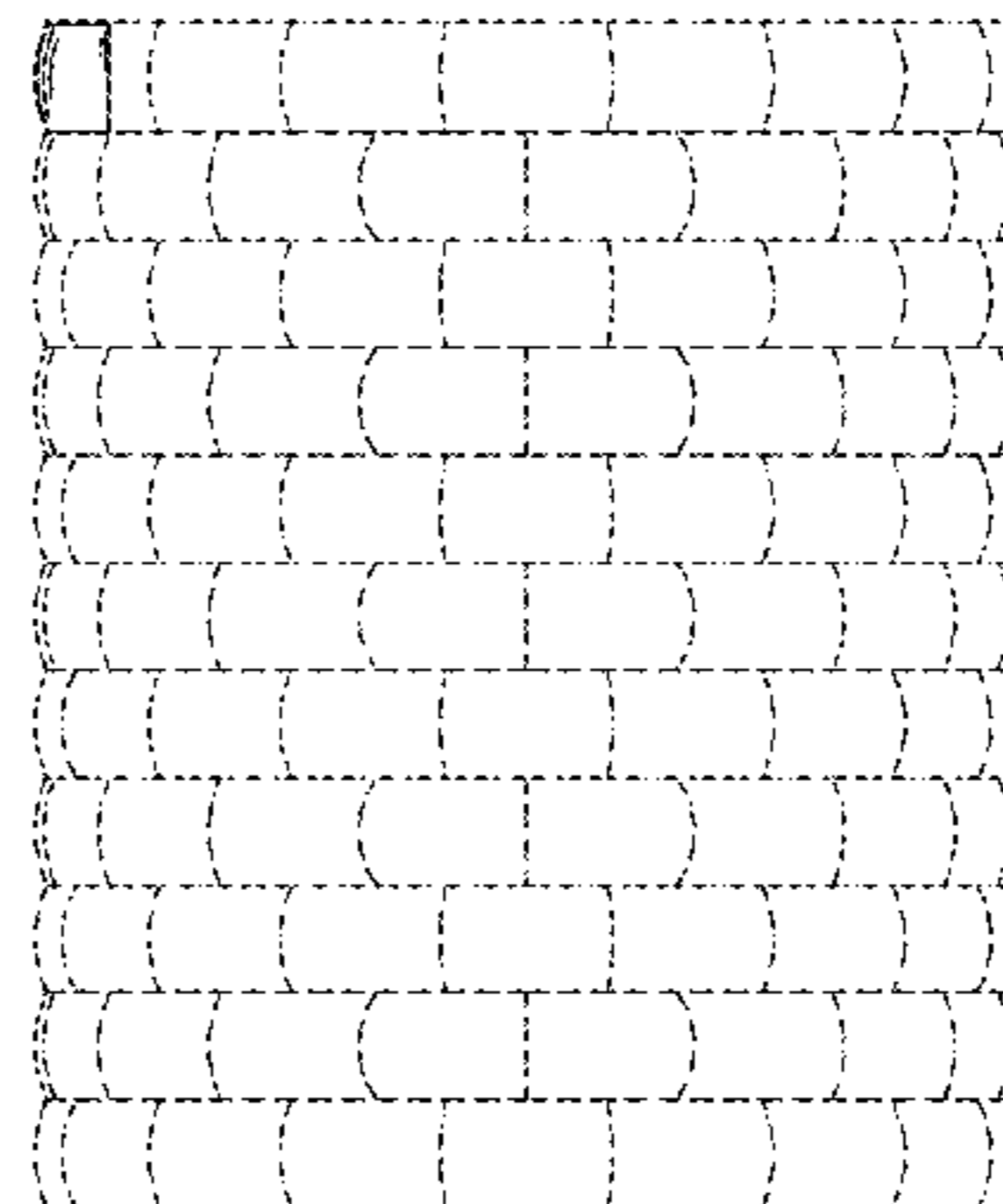
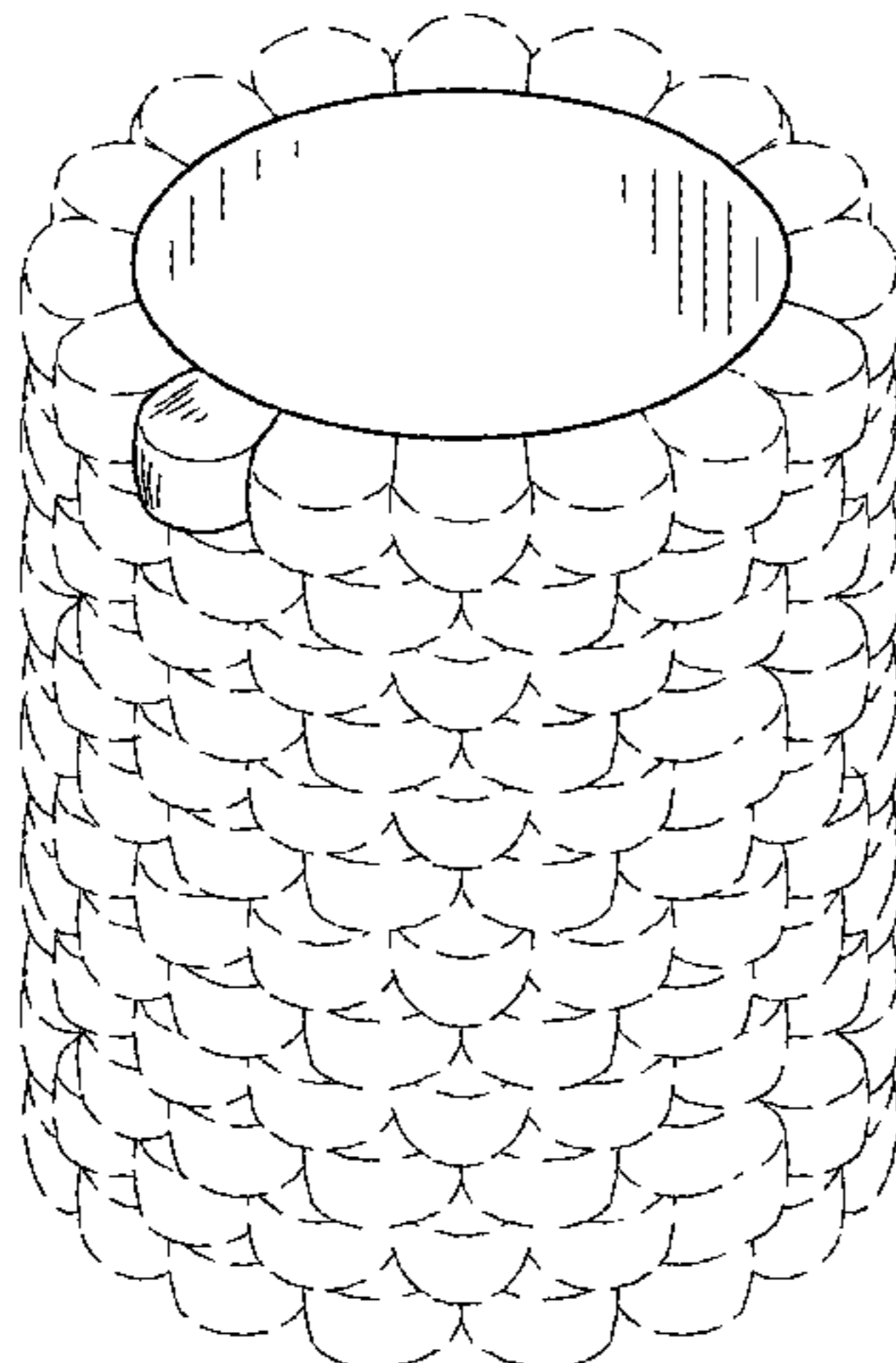
(57) **CLAIM**

The ornamental design for a beverage sleeve, as shown and  
described.

**DESCRIPTION**

FIG. 1 is a top, front perspective view of a beverage sleeve  
showing my new design;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a front elevational view thereof;  
FIG. 4 is a right elevational view thereof;  
FIG. 5 is a rear elevational view thereof;  
FIG. 6 is a left elevational view thereof; and,  
FIG. 7 is a bottom plan view thereof.  
The broken lines shown in FIGS. 1-7 represent portions of the  
beverage sleeve that form no part of the claimed design.

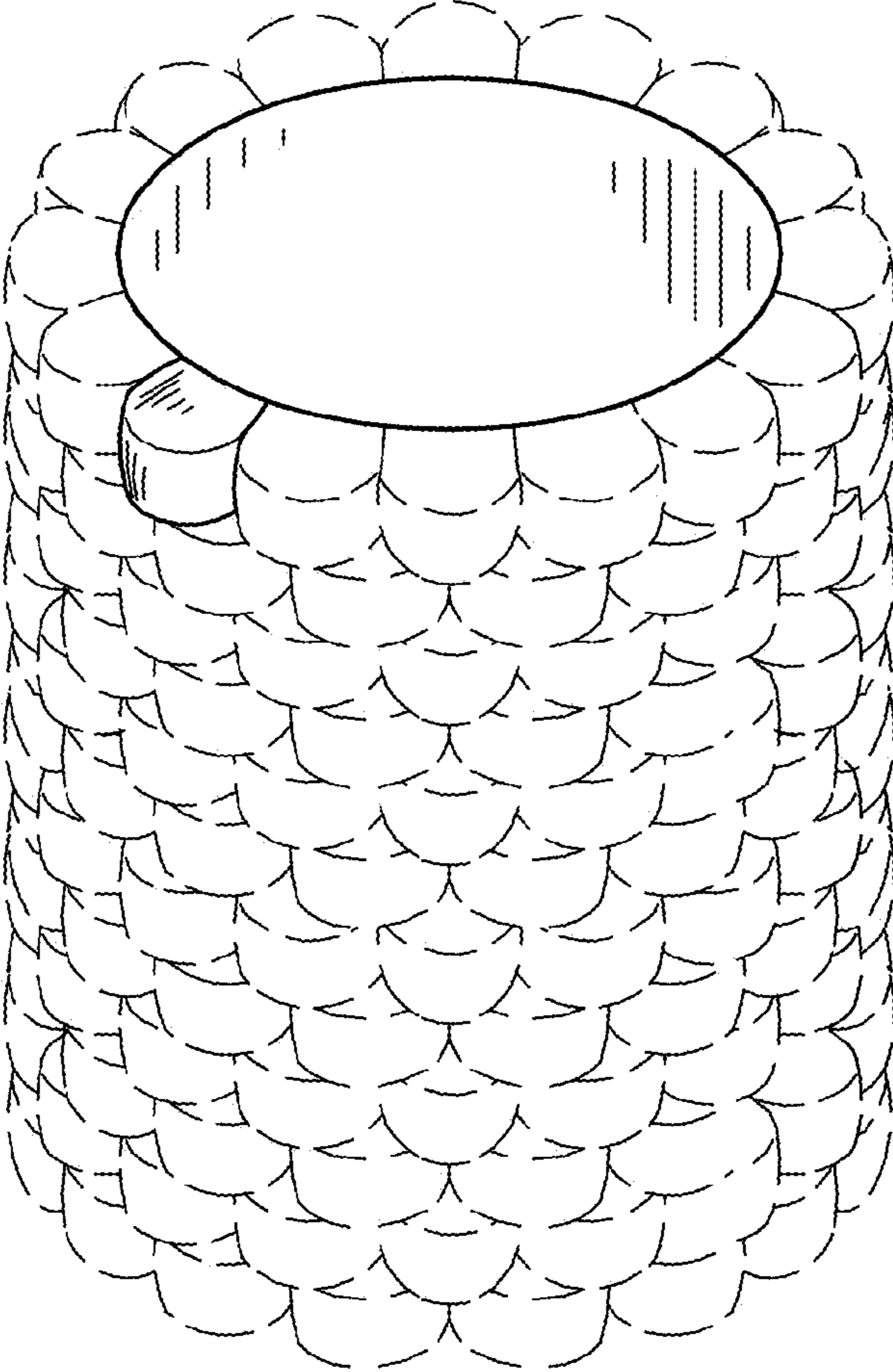

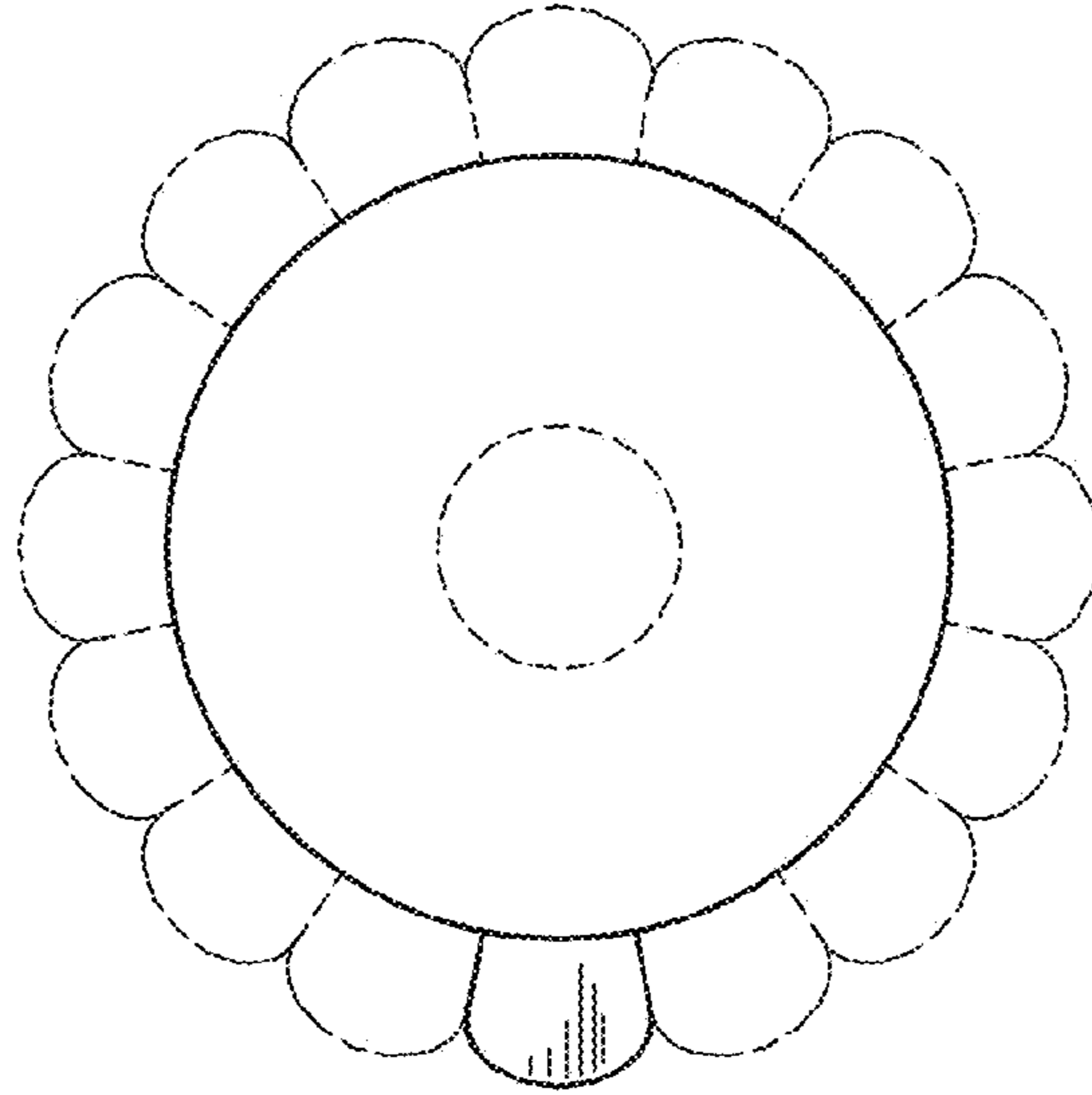

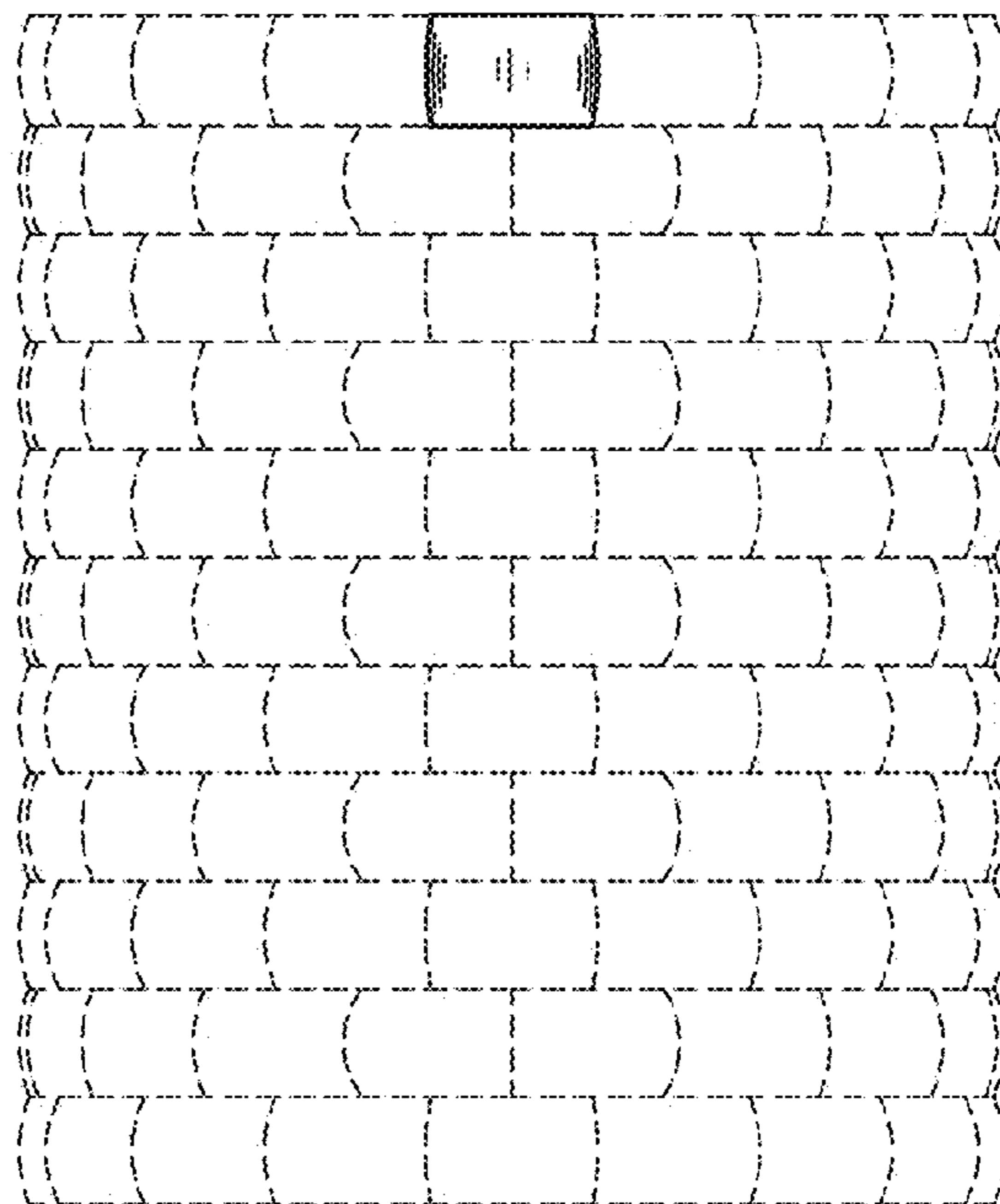

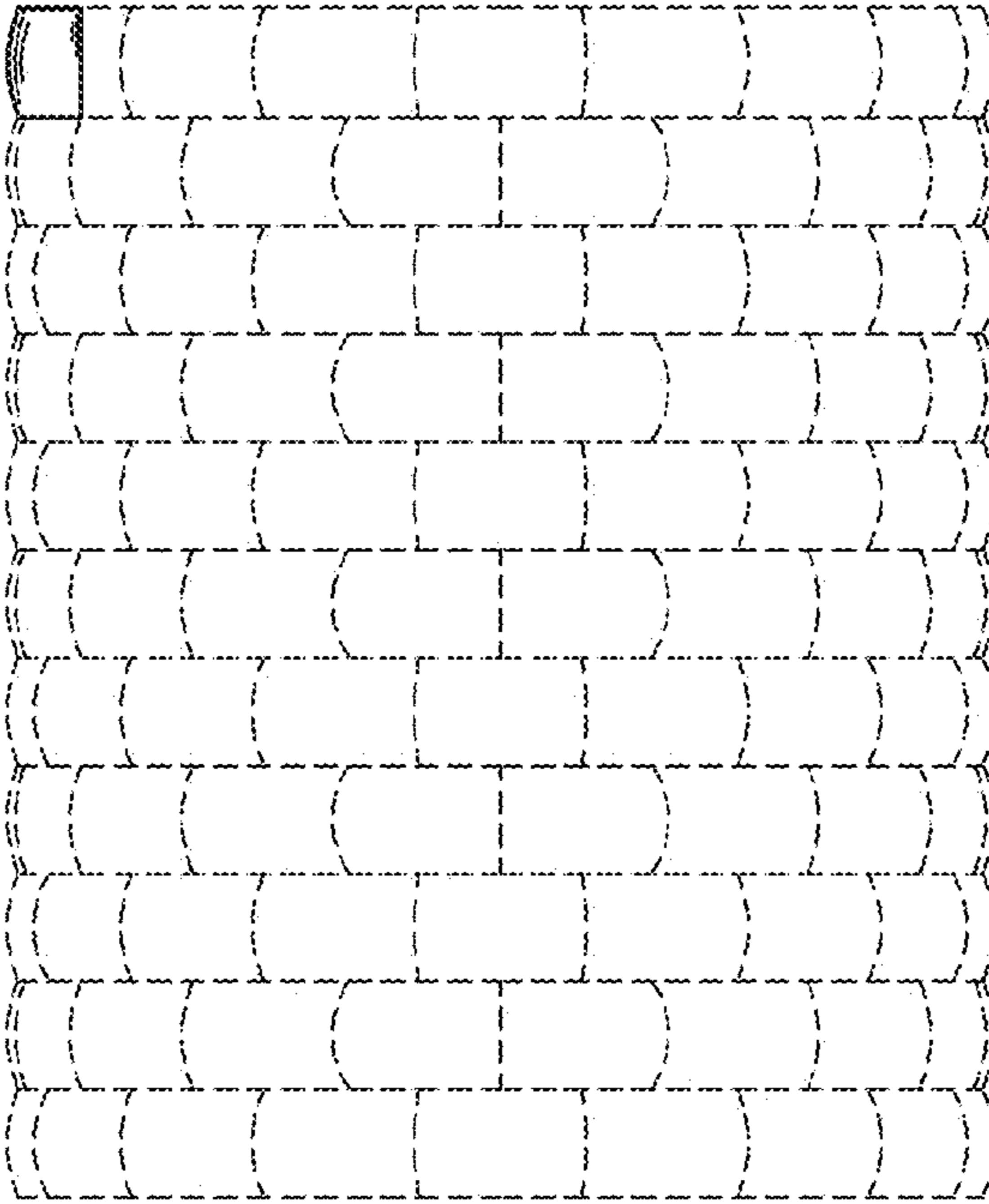

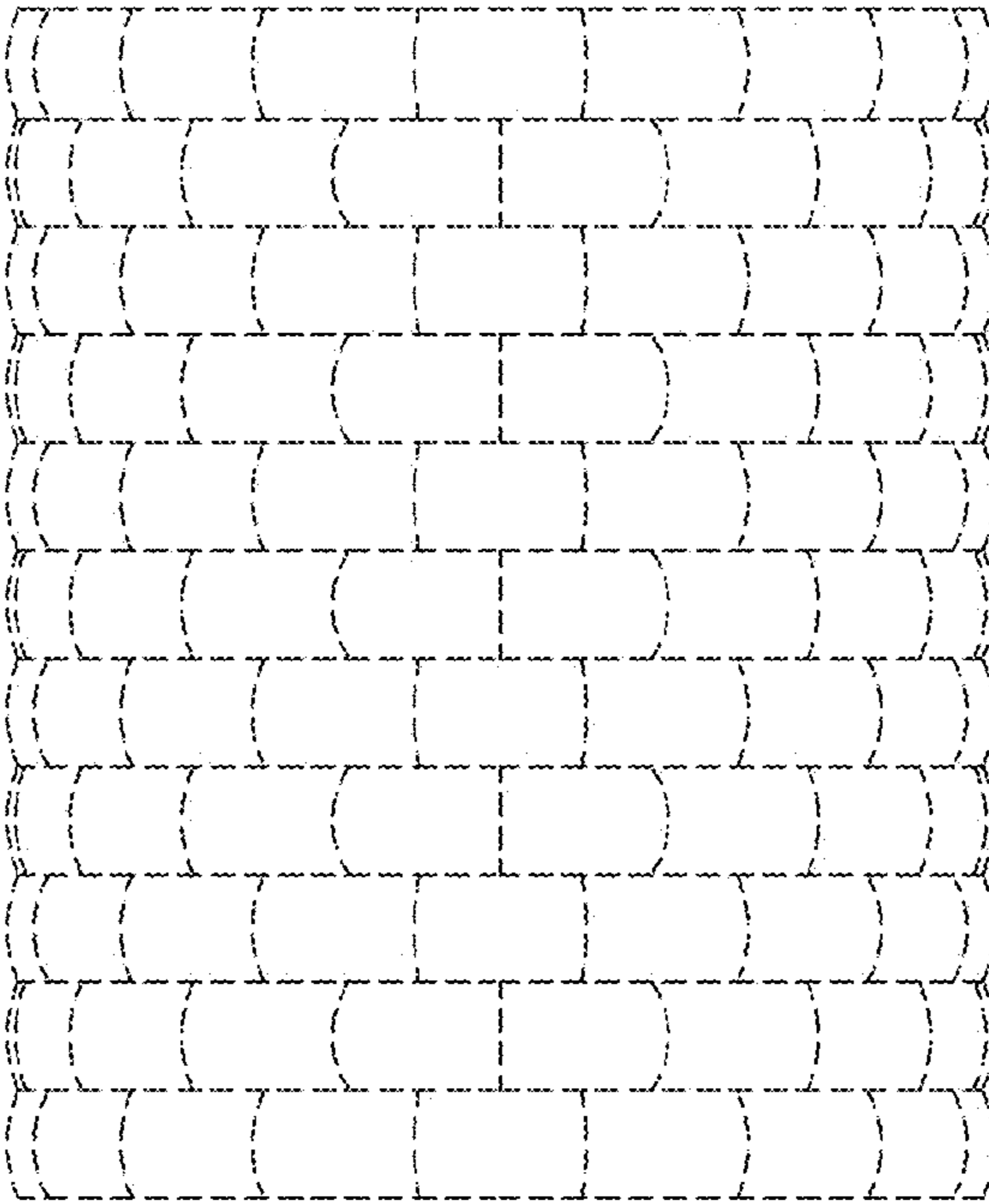
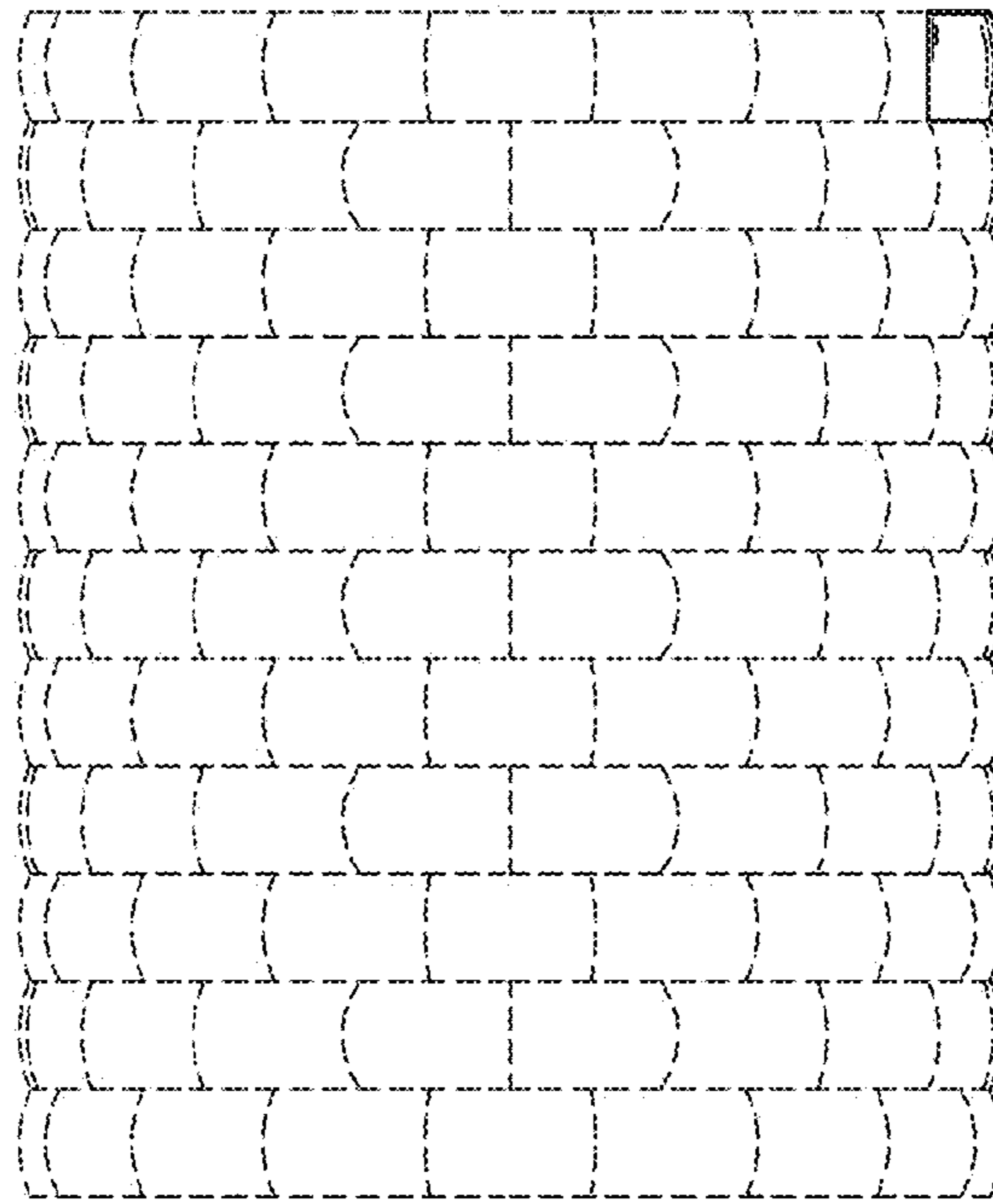
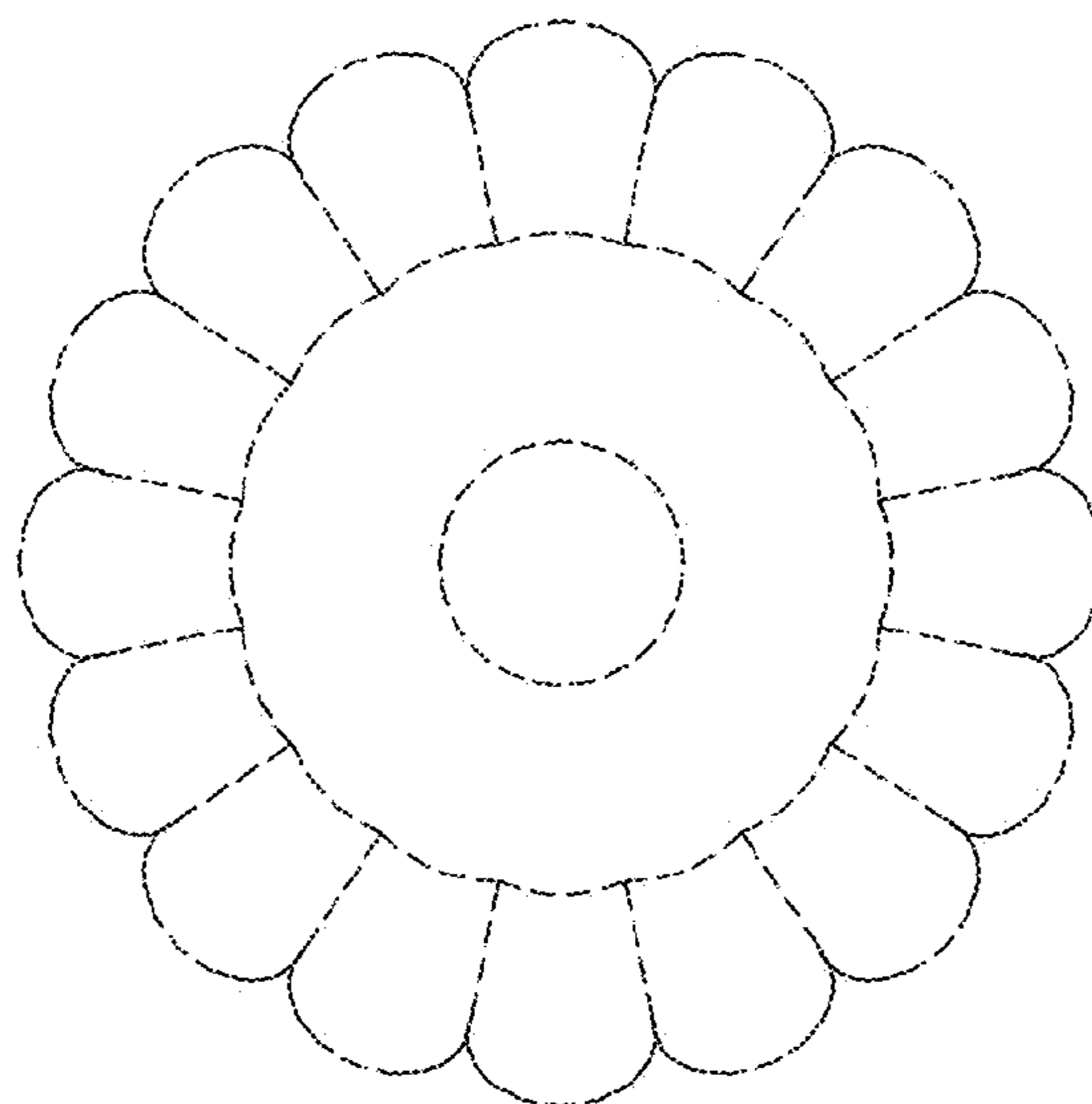
