The ornamental design for a pull me up, as shown and described.

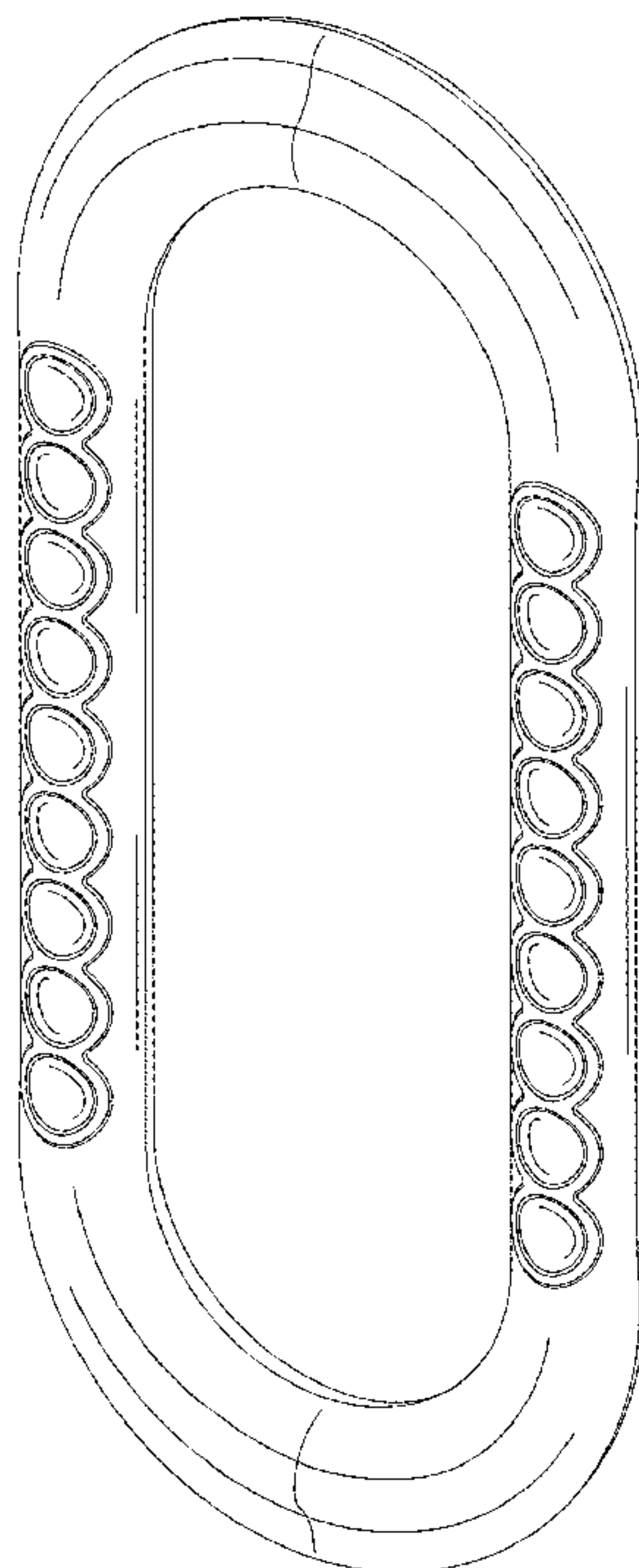

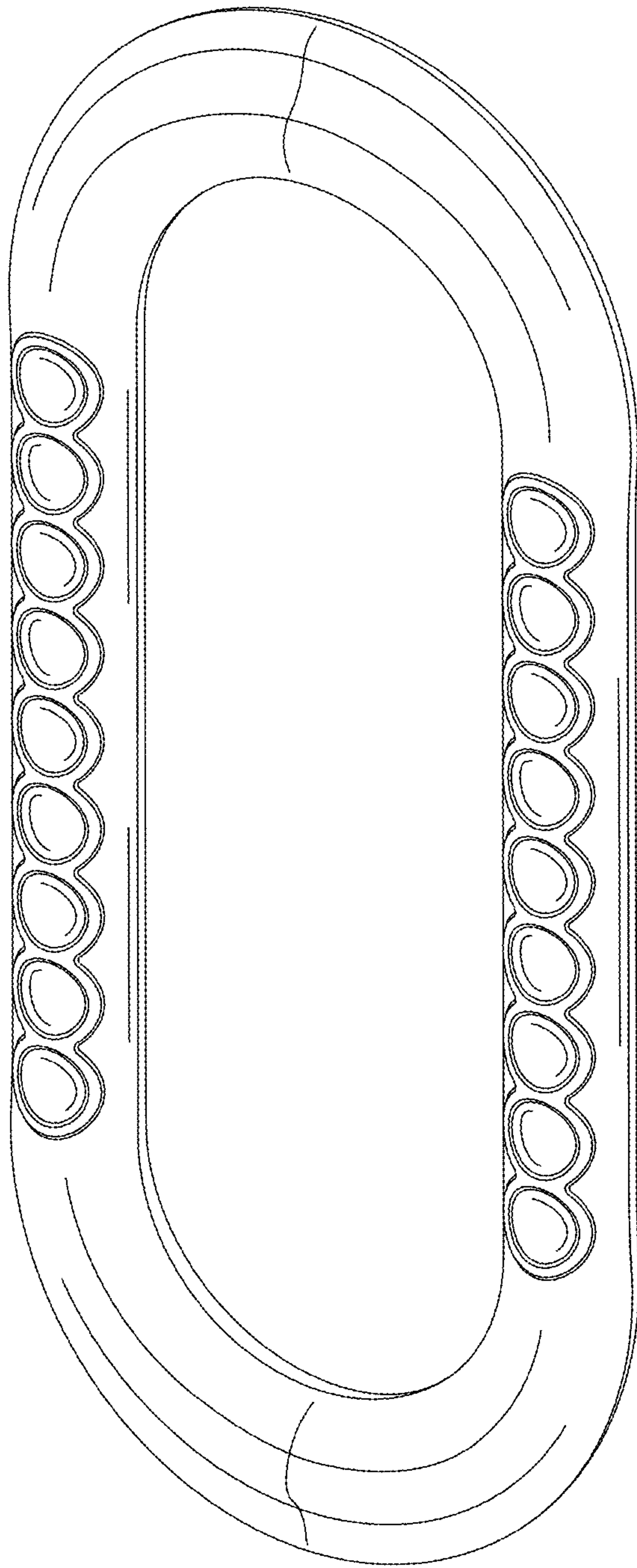

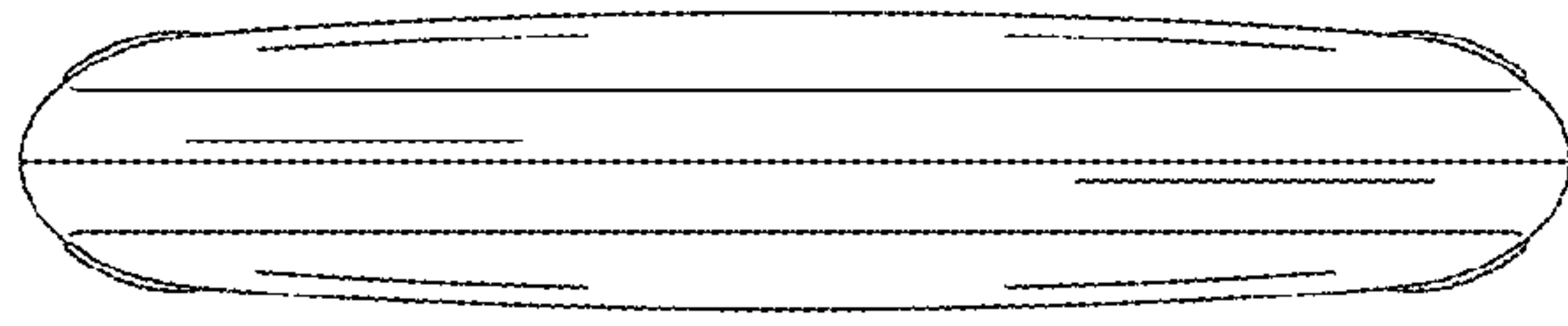

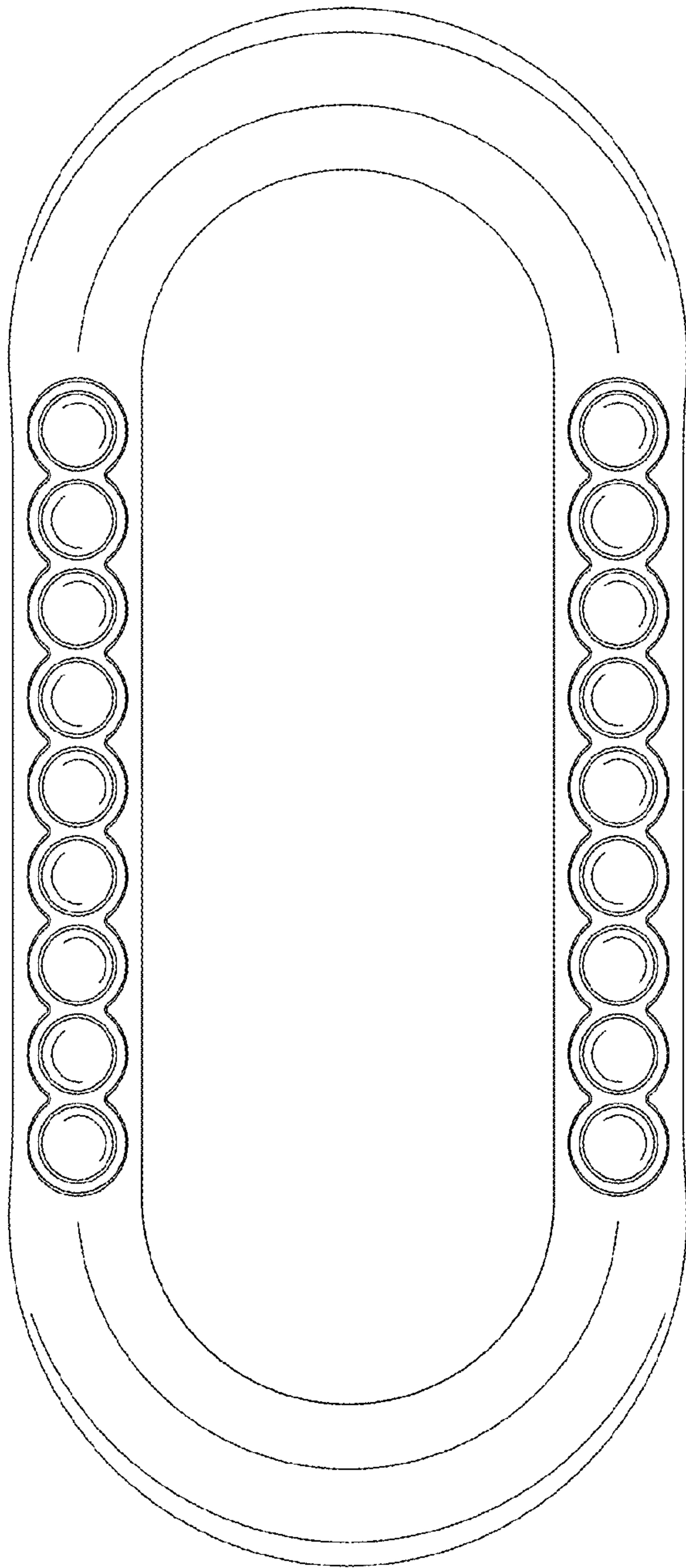

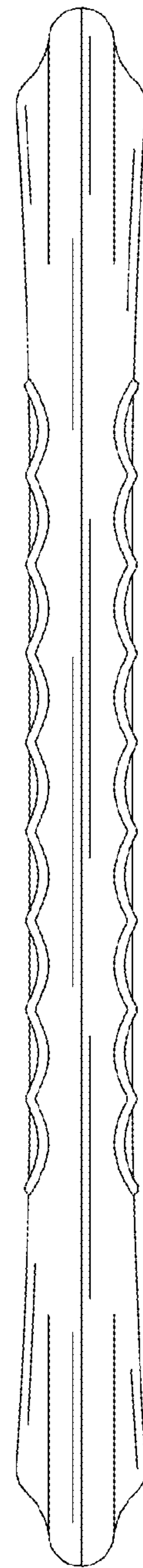
