FIG. 3 is a left side view of the bracket support of FIG. 1.

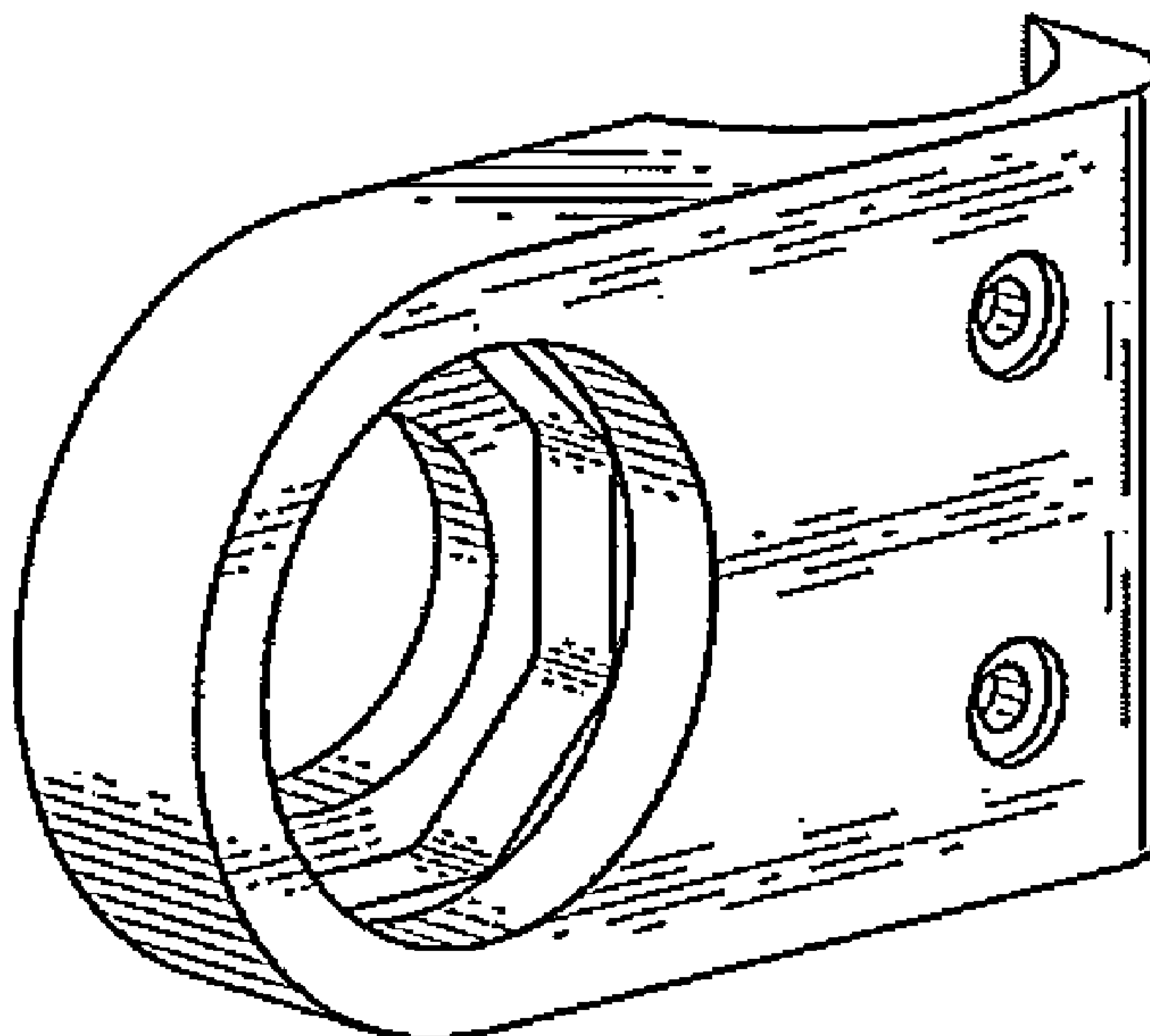
FIG. 4 is a top view of the bracket support of FIG. 1; with the bottom view being a mirror image of.

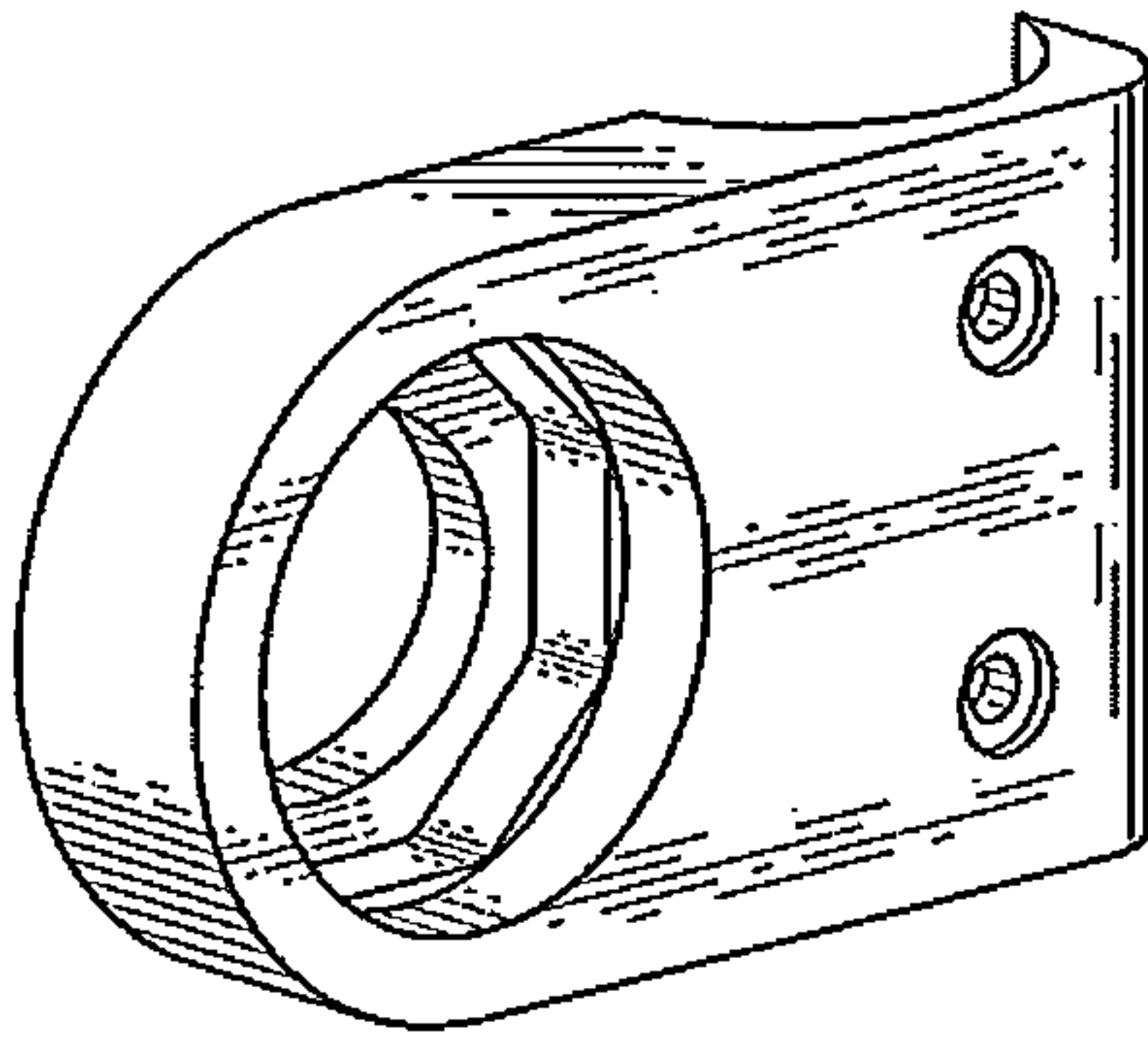

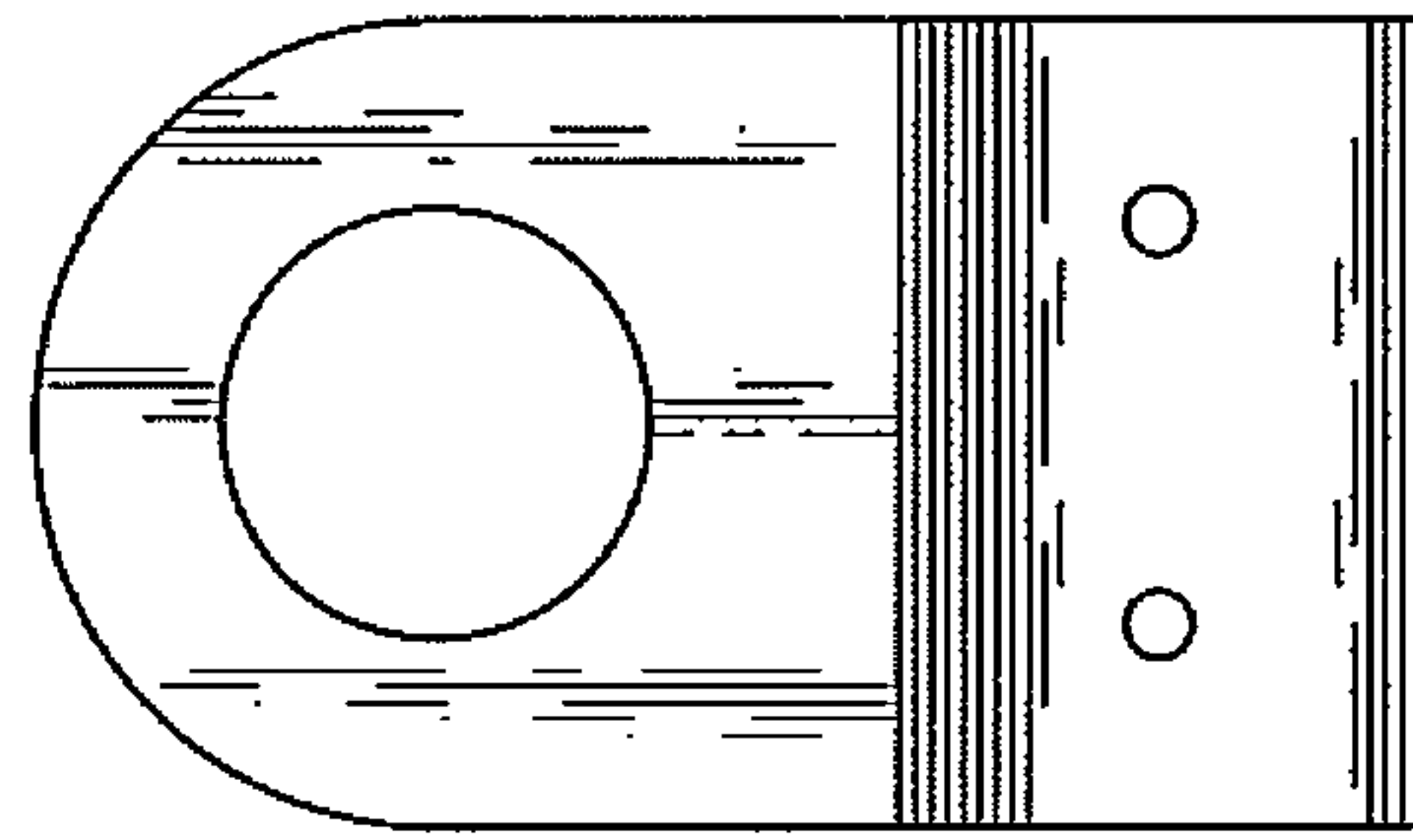

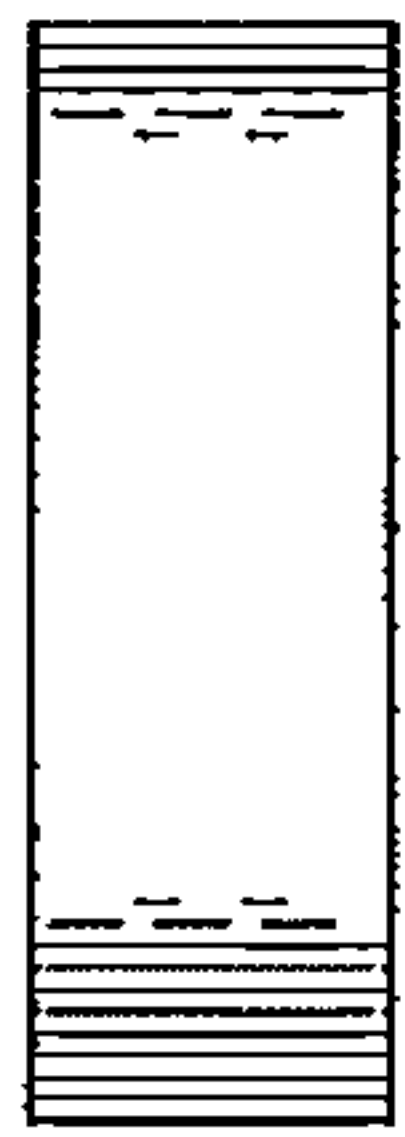

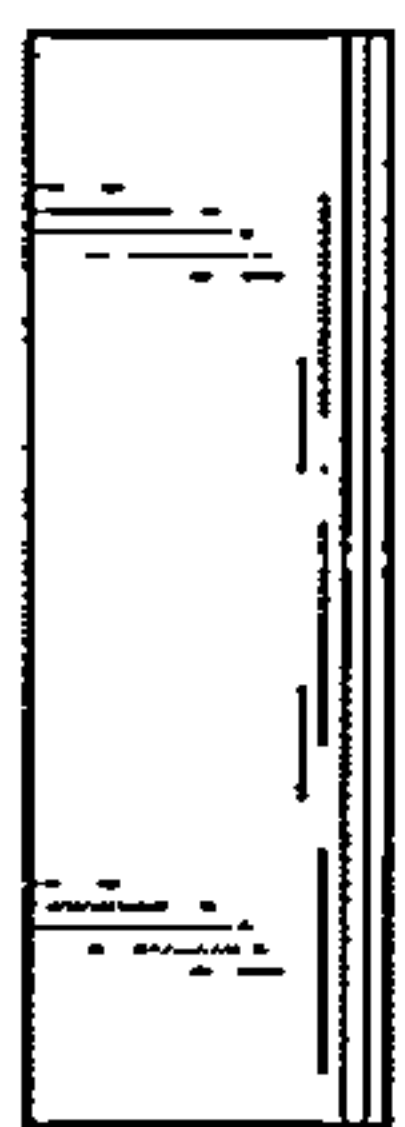

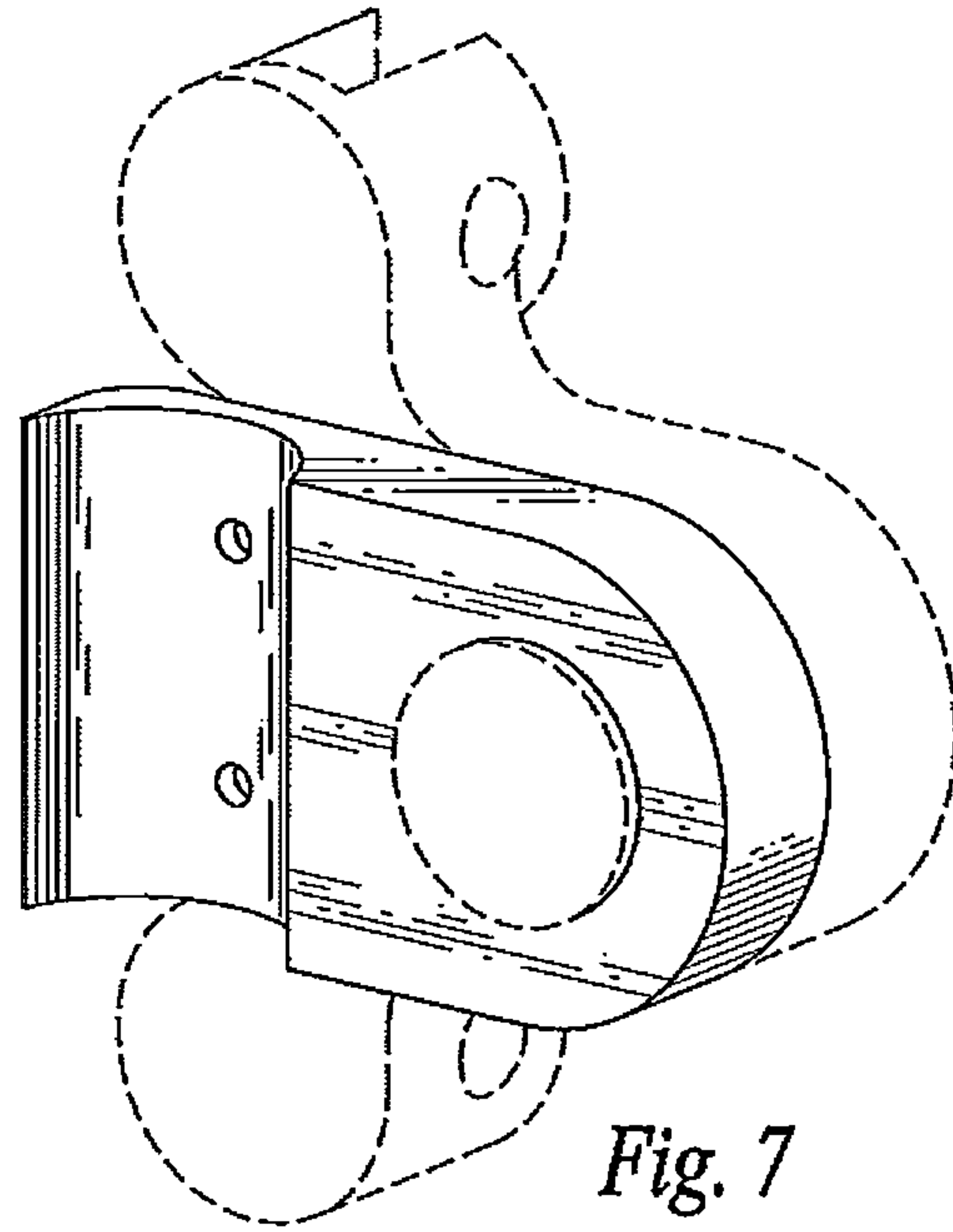

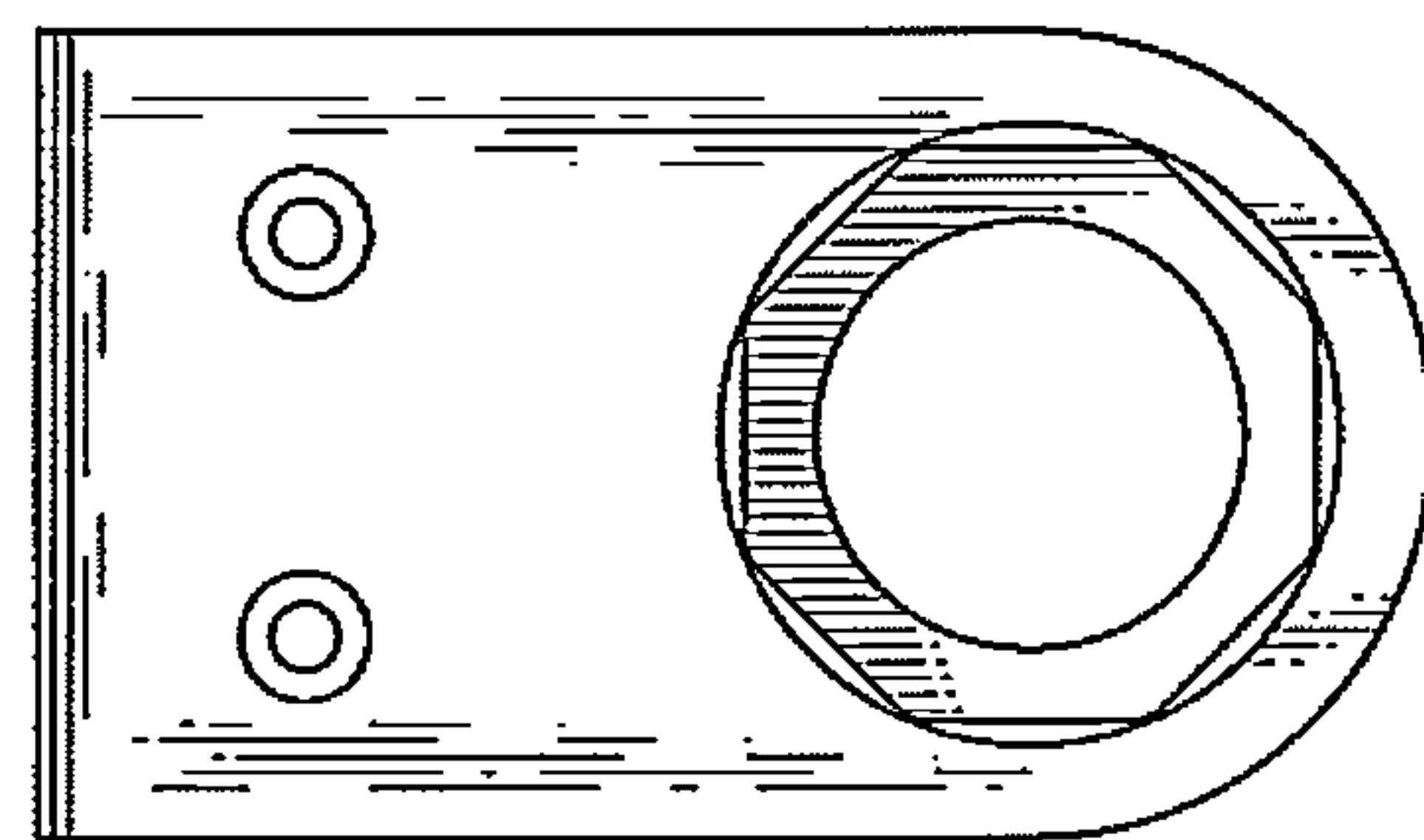
