The ornamental design for a line weight indicator dial, as shown and described.

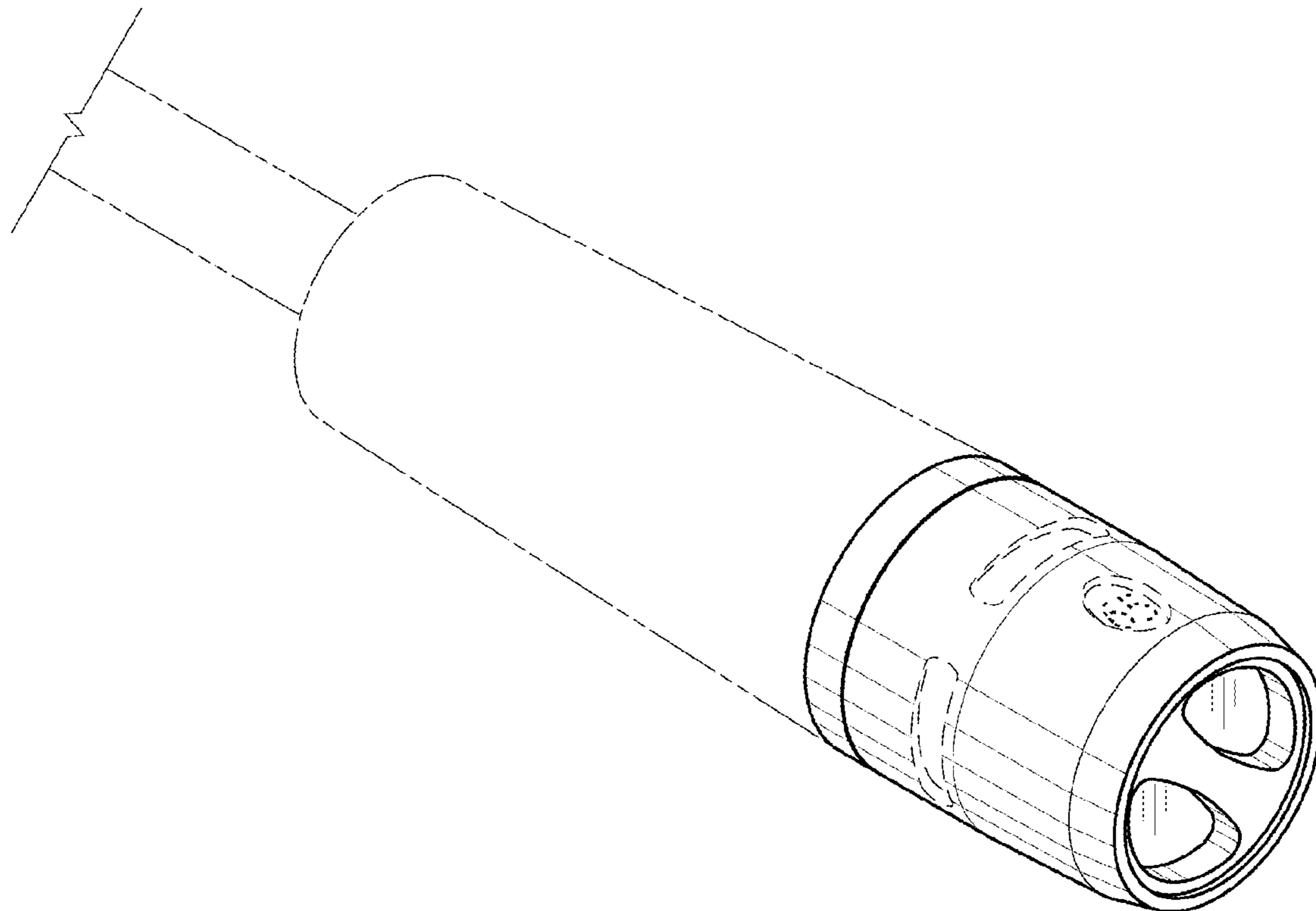
DESCRIPTION

FIG. 1 is a front elevation view of the line weight indicator dial showing my new design;

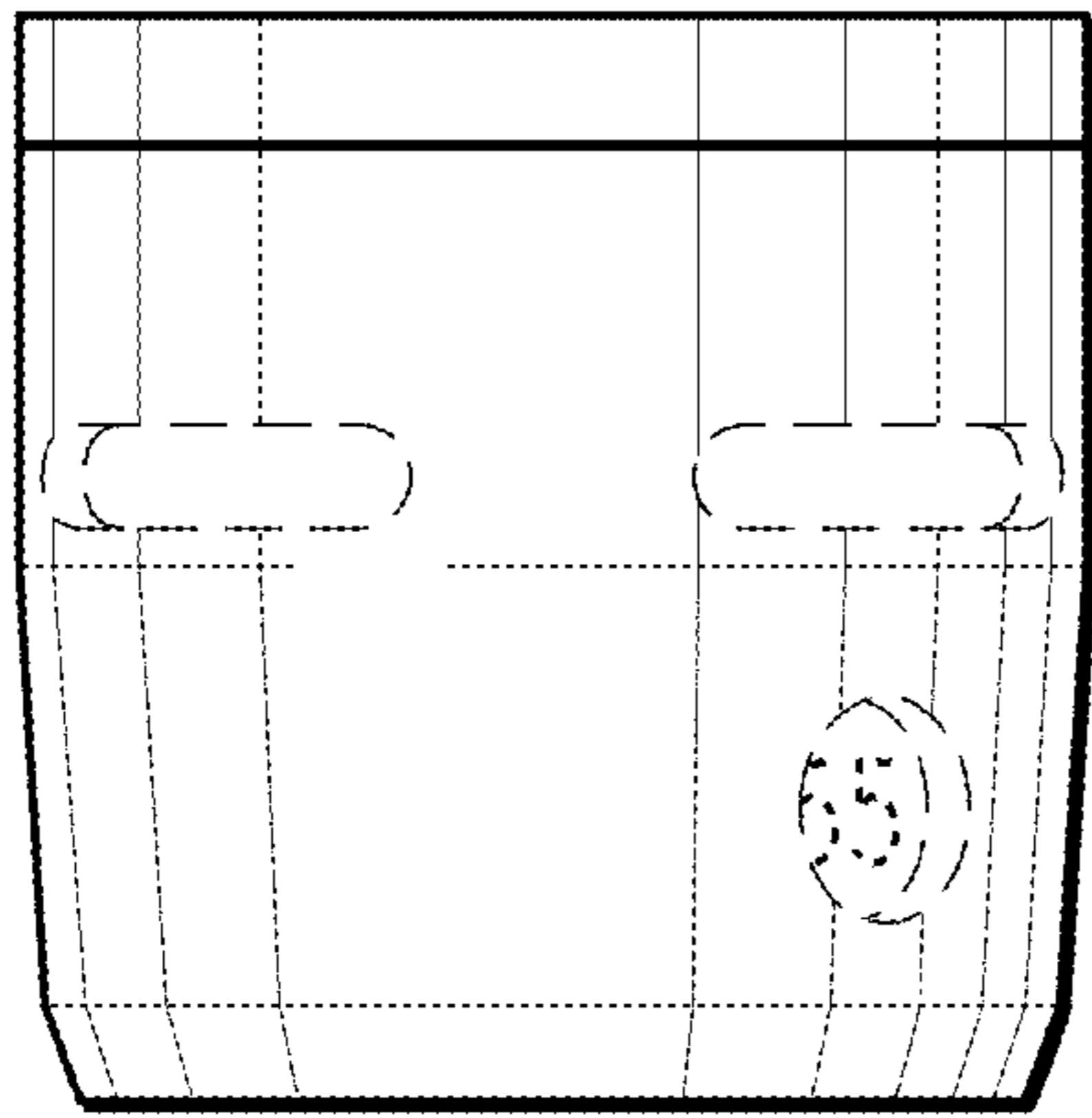

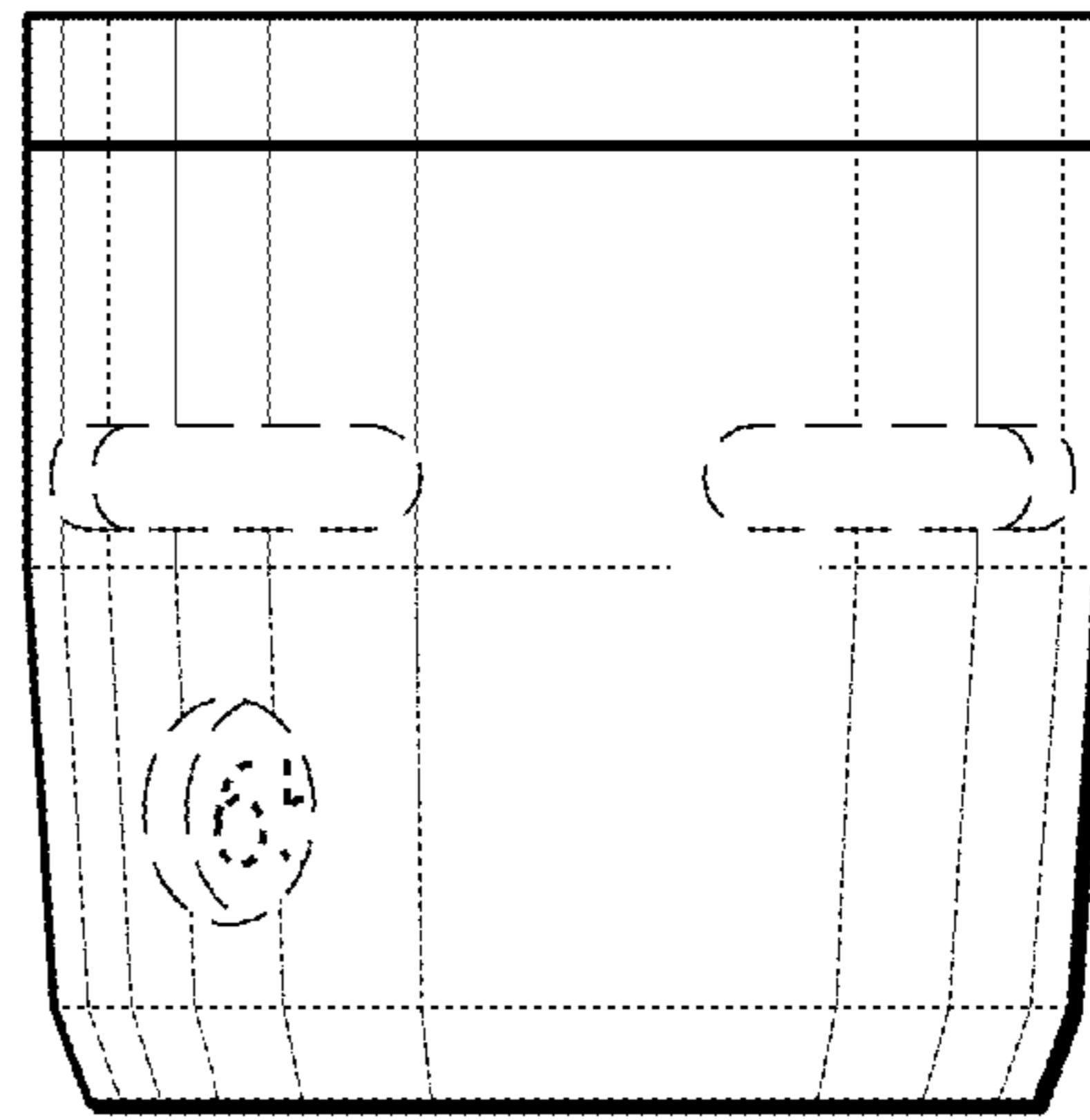

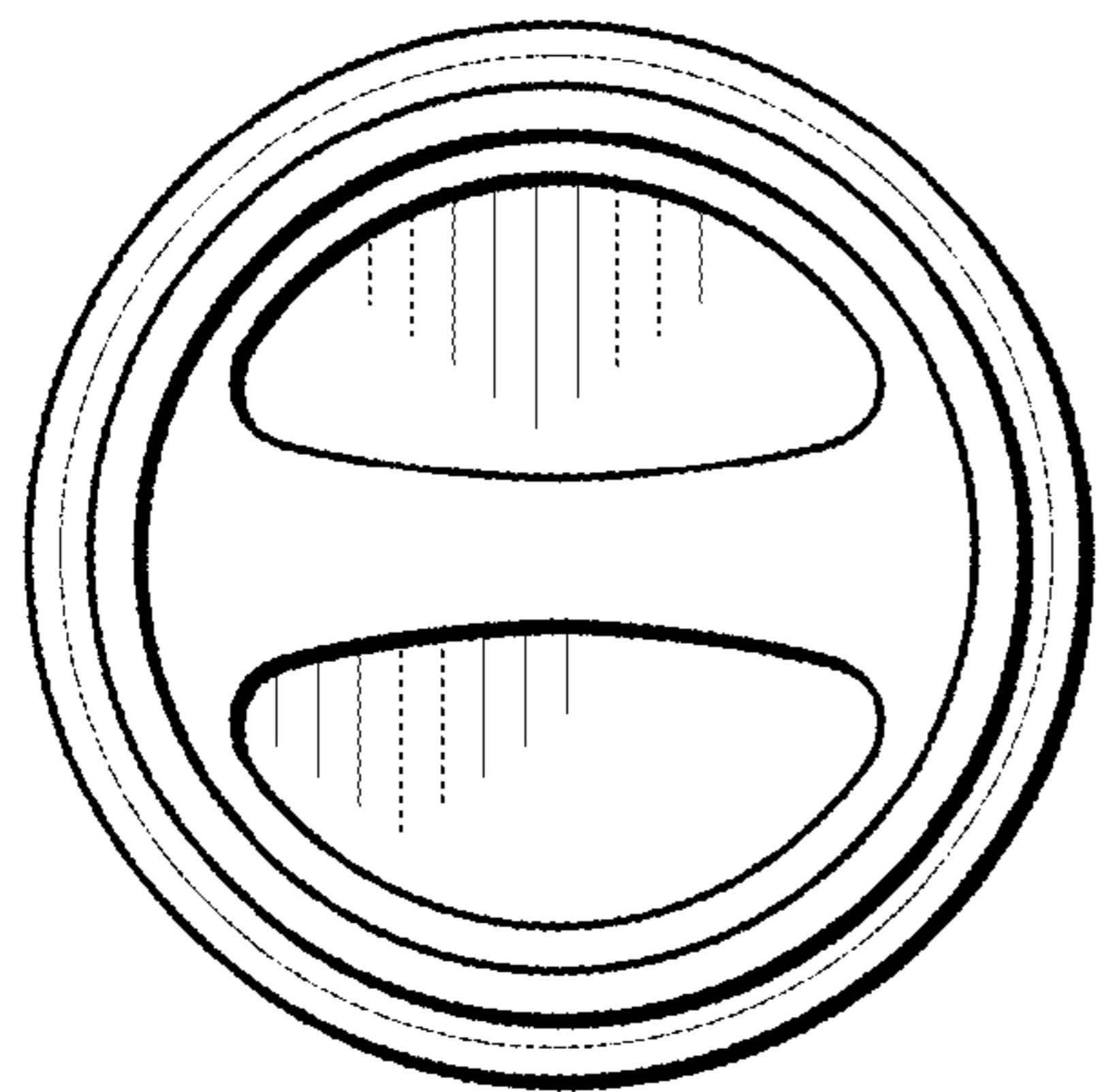

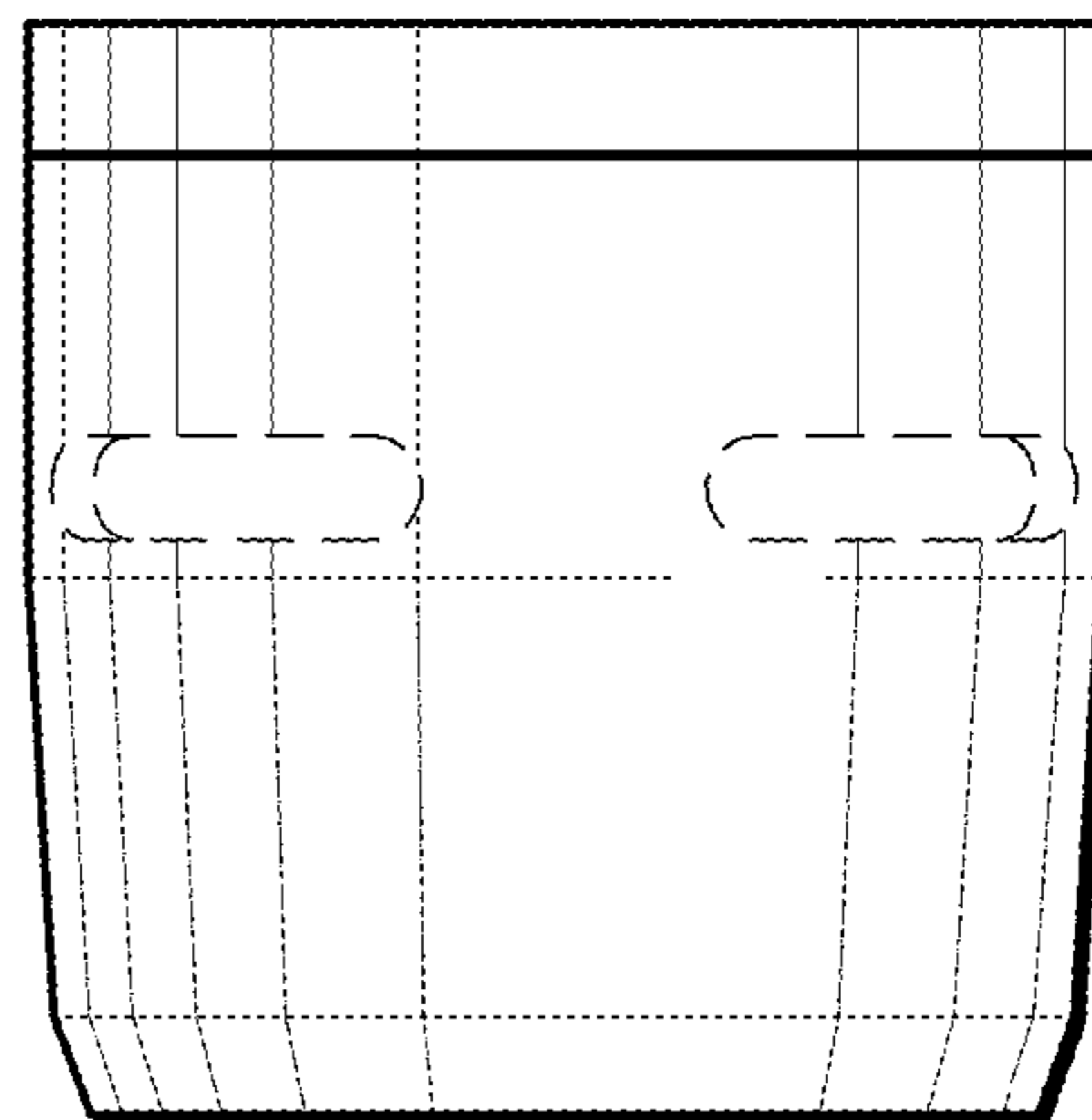

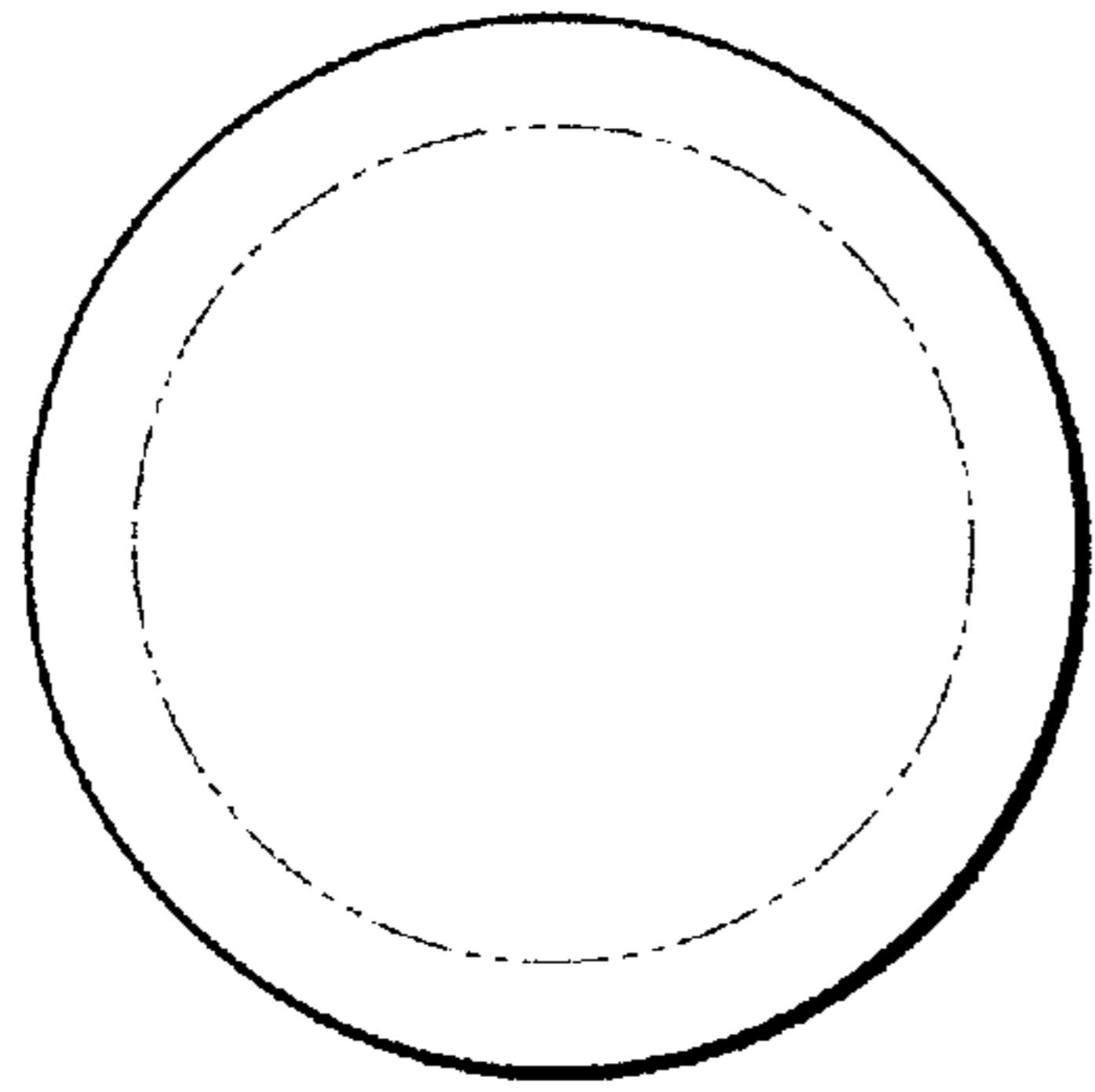

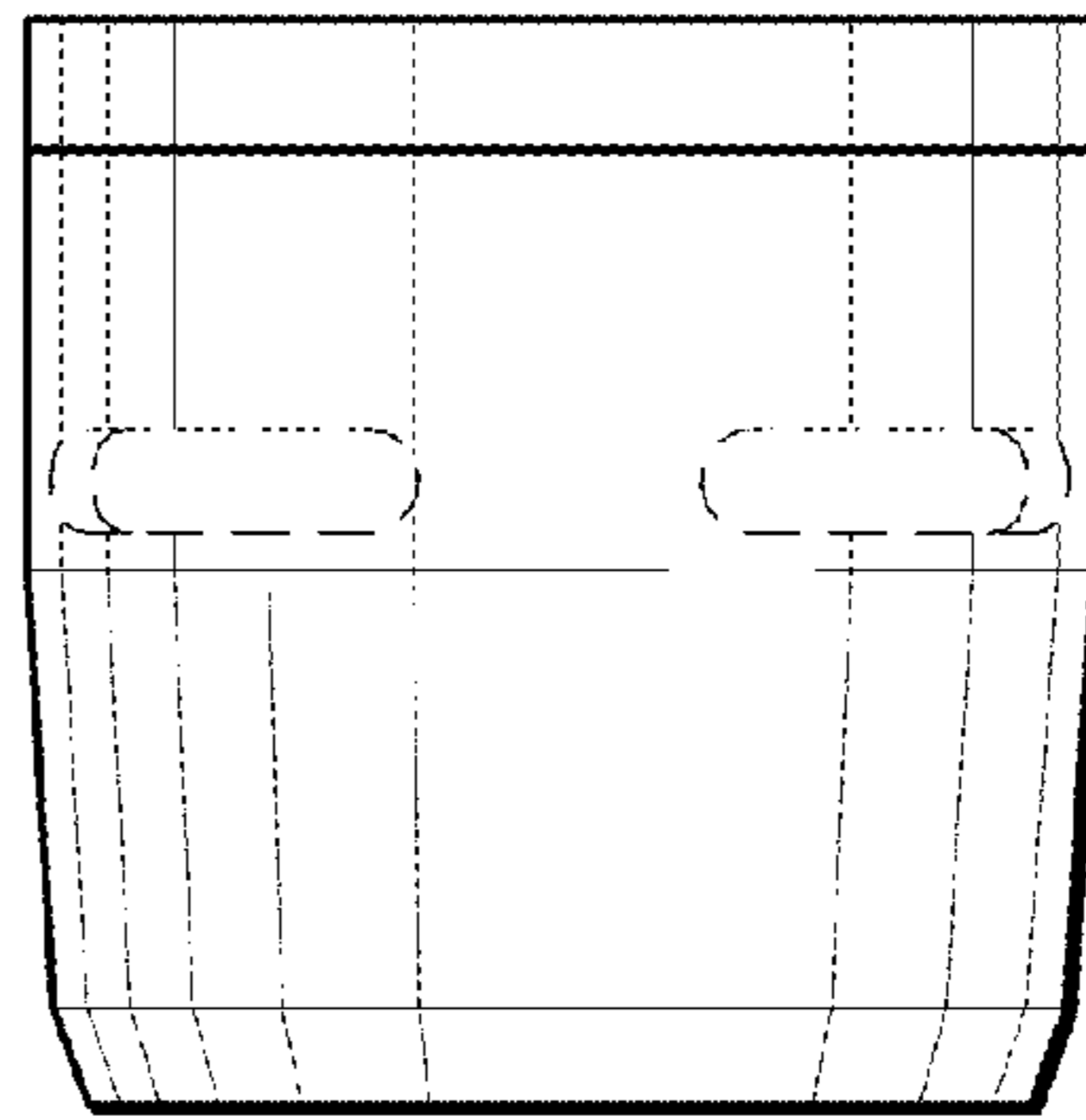

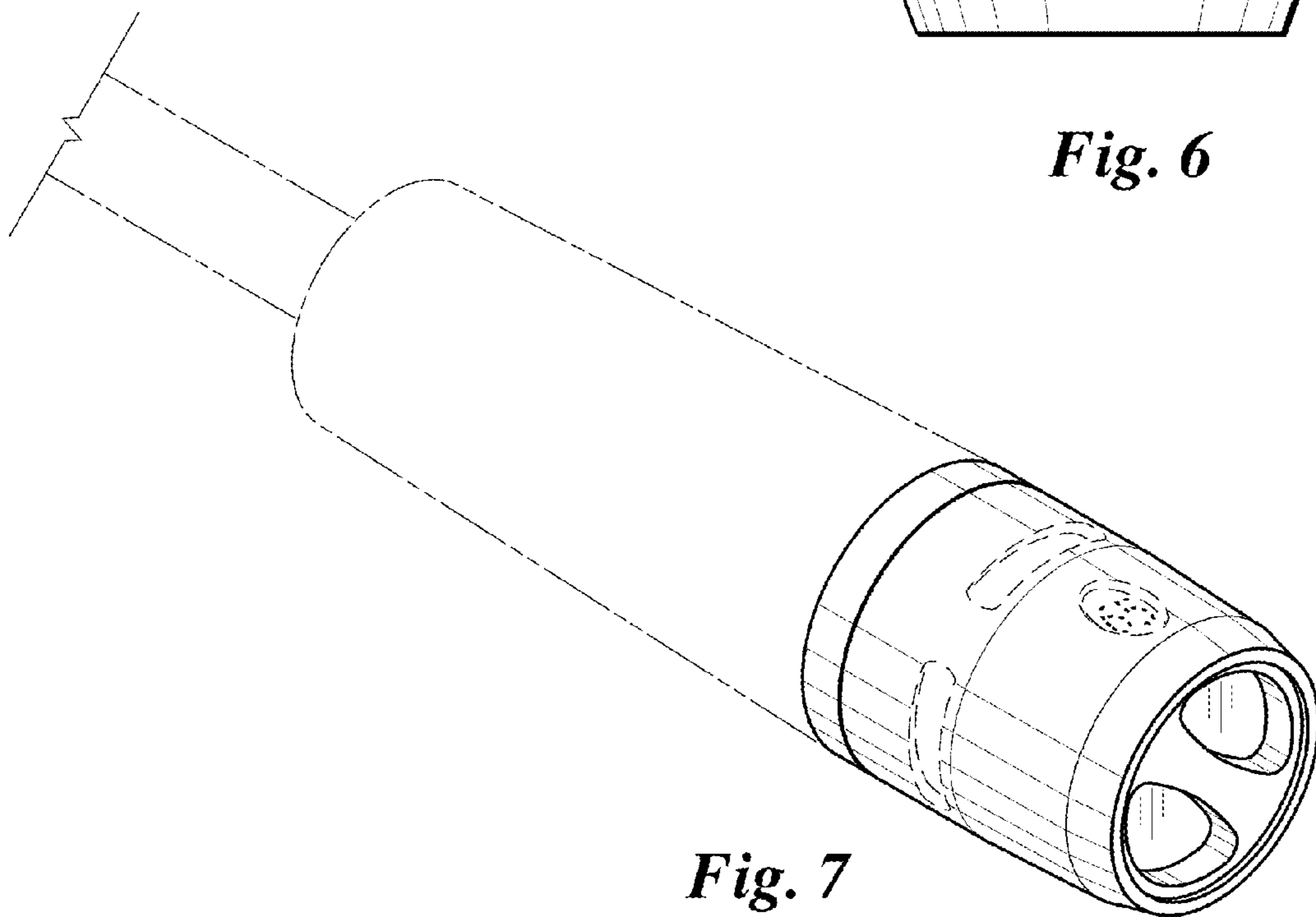
