(57) **CLAIM**

The ornamental design for a bicycle wheel skewer, as shown and described.

DESCRIPTION

FIG. 1 is a perspective top view of the nut of the invented bicycle wheel skewer.

FIG. 2 is a perspective bottom view of the nut of FIG. 1.

FIG. 3 is a right side view of the nut of FIG. 1.

FIG. 4 is a left side view of the nut of FIG. 1.

FIG. 5 is a rear view of the nut of FIG. 1.

FIG. 6 is a front view of the nut of FIG. 1.

FIG. 7 is a top view of the nut of FIG. 1.

FIG. 8 is a bottom view of the nut of FIG. 1.

FIG. 9 is a top view of the bolt of the invented bicycle wheel skewer.

FIG. 10 is a bottom view of the bolt of FIG. 9.

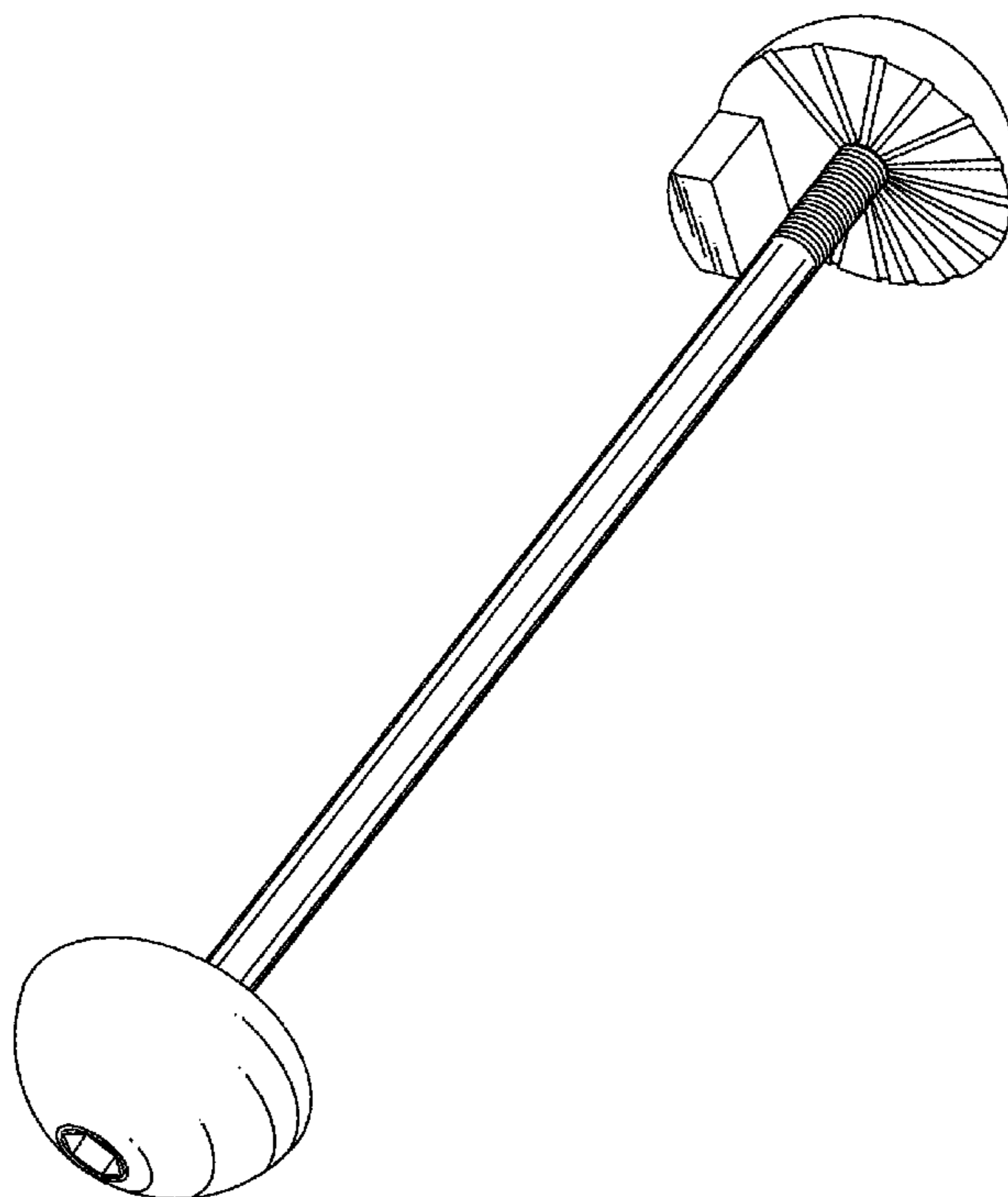
FIG. 11 is a front view of the bolt of FIG. 9. The Back View is the same and not shown.

FIG. 12 is a left side view of a bolt of FIG. 9. The right side view is identical and not shown; and,

FIG. 13 is an assembled perspective view of the invented bicycle wheel skewer using the parts [nut and bolt] shown in FIGS. 1-12.

The nut and bolt of the bicycle wheel skewer are shown separately in FIGS. 1-8 and FIGS. 9-12 respectively for ease of illustration.

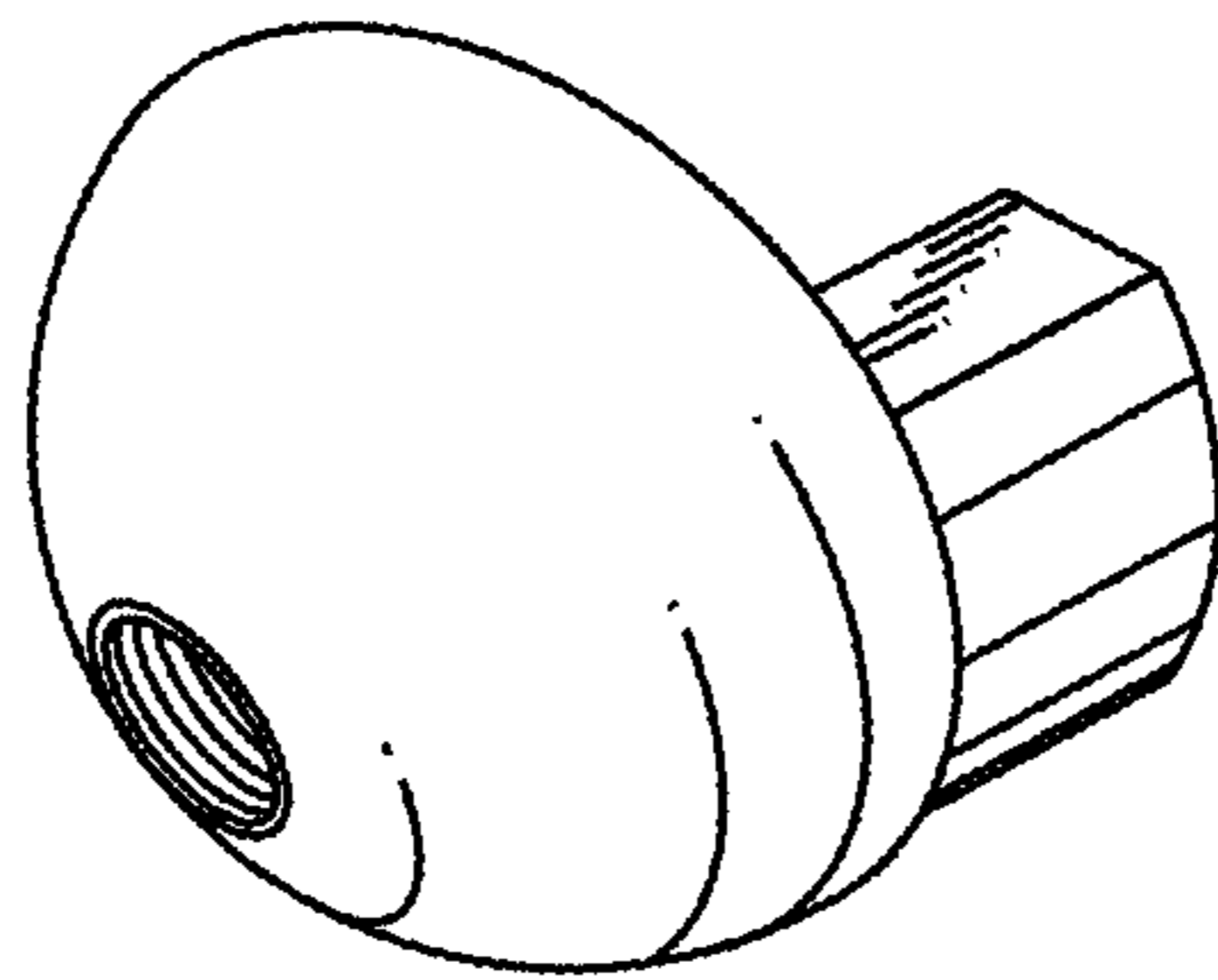

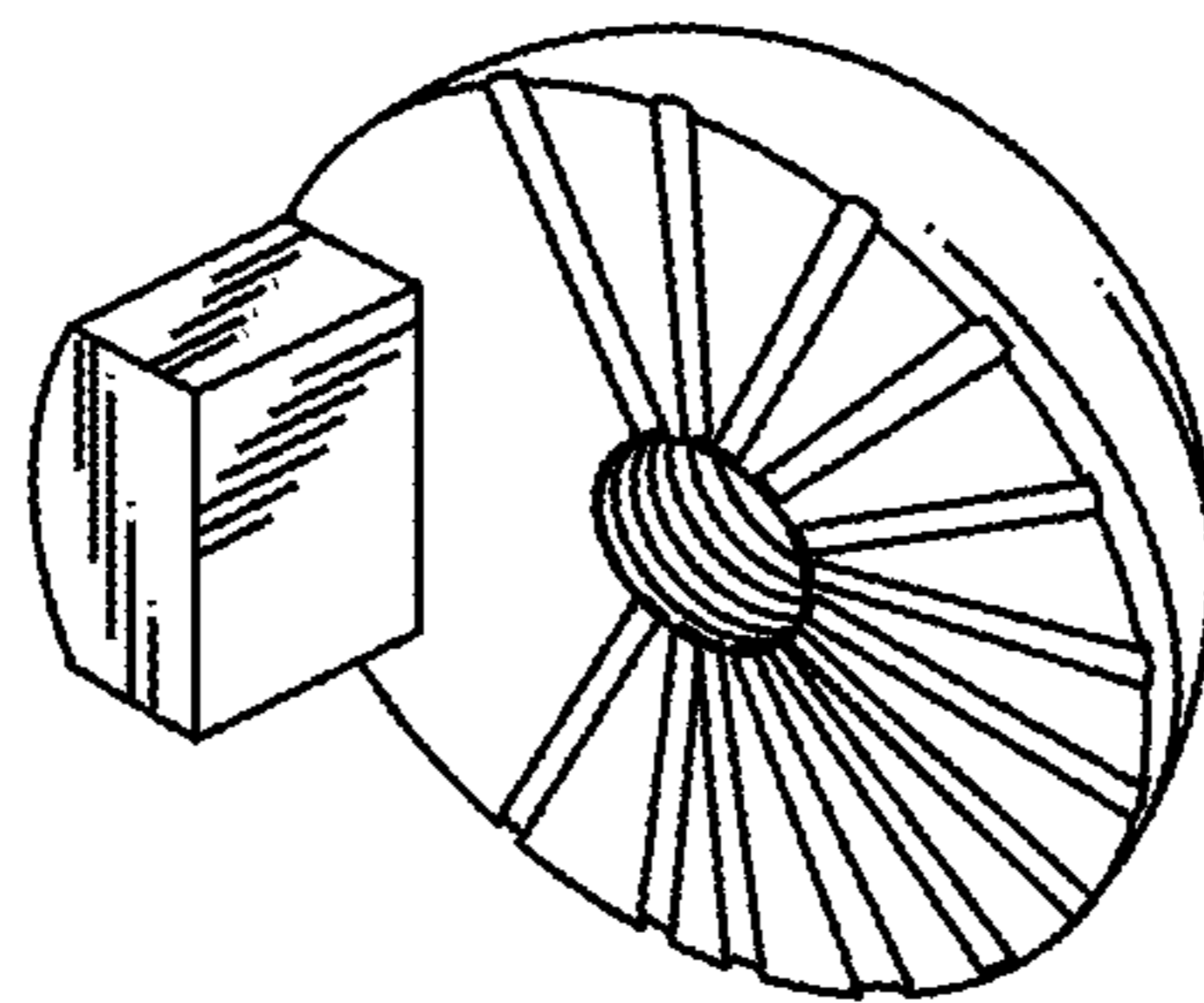

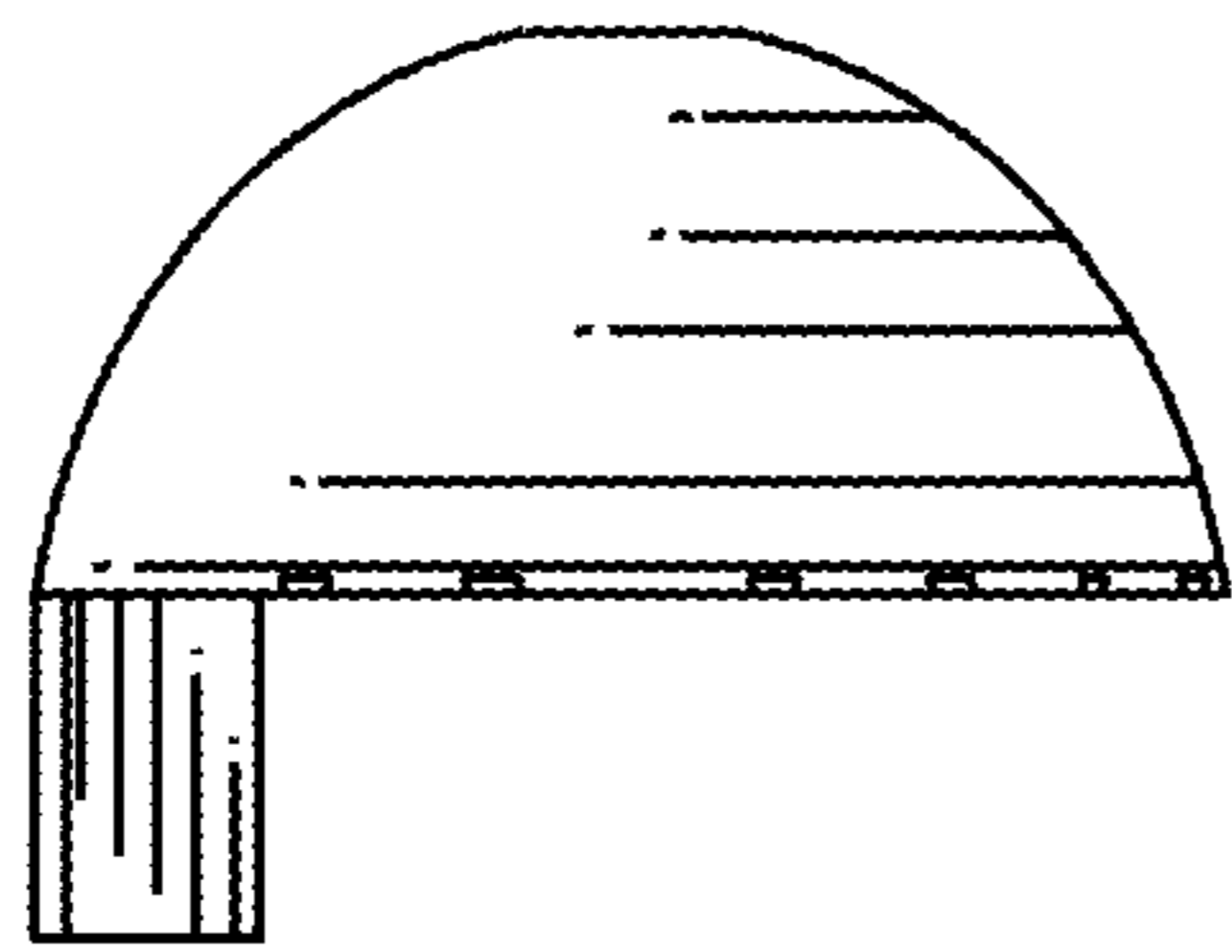

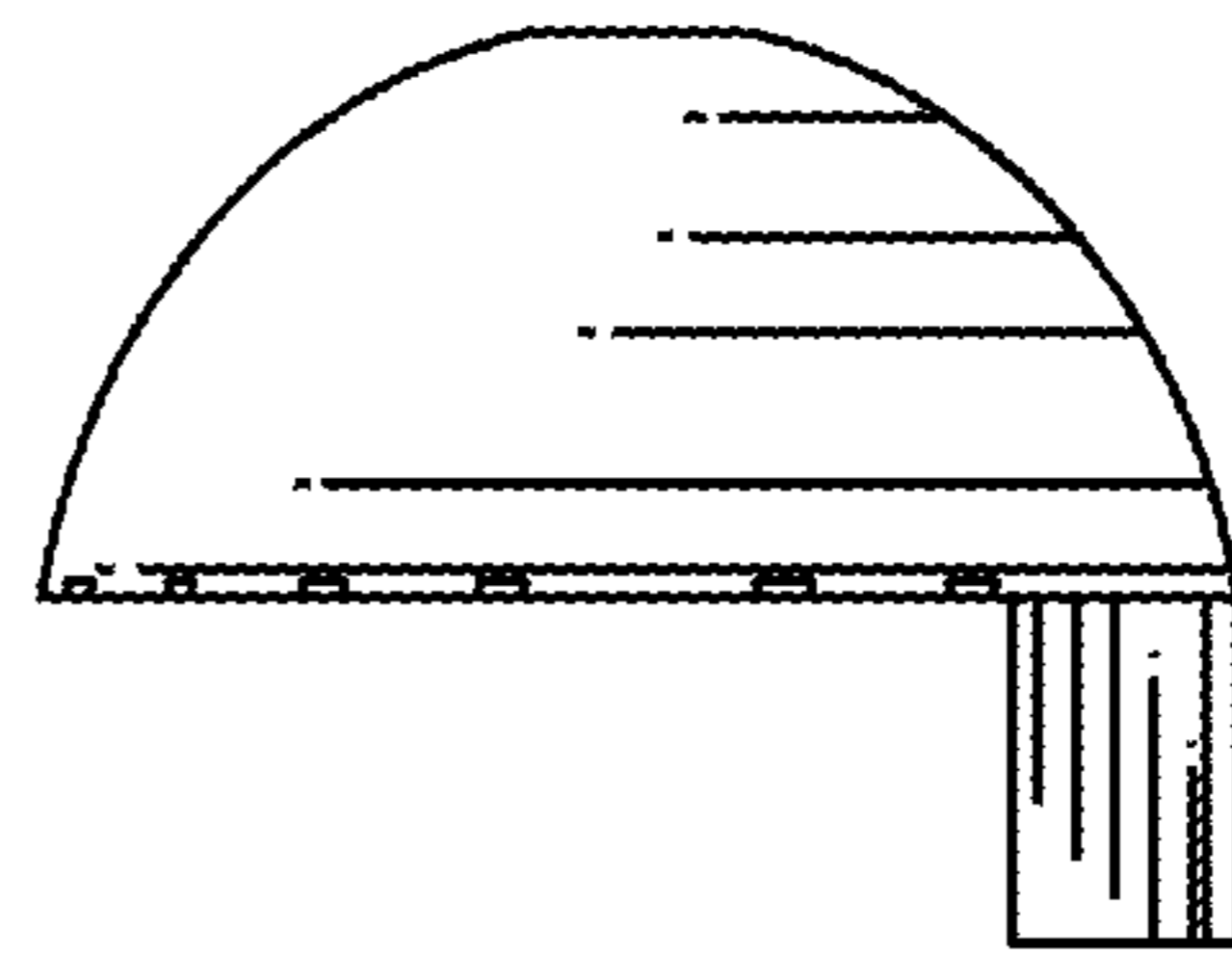

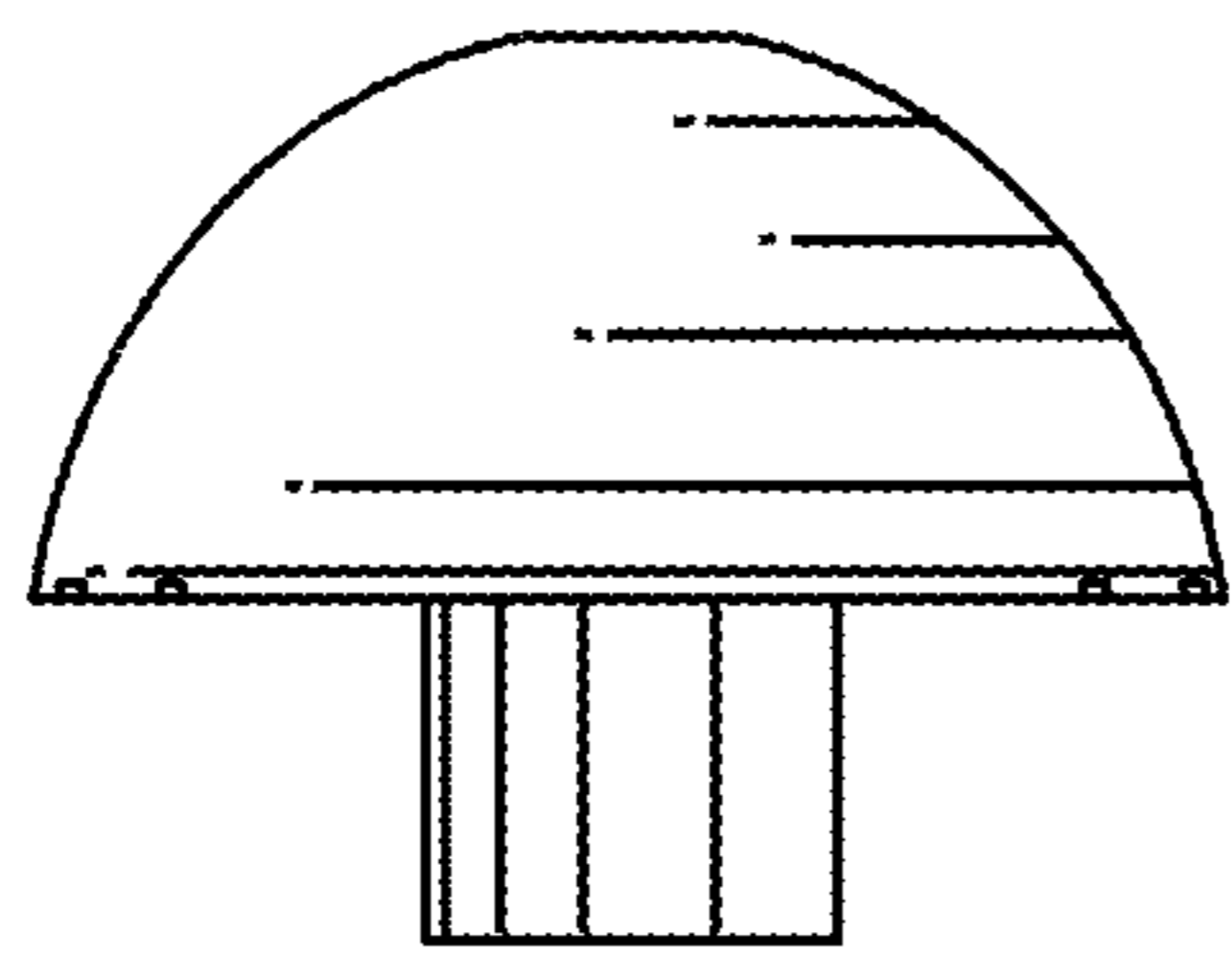

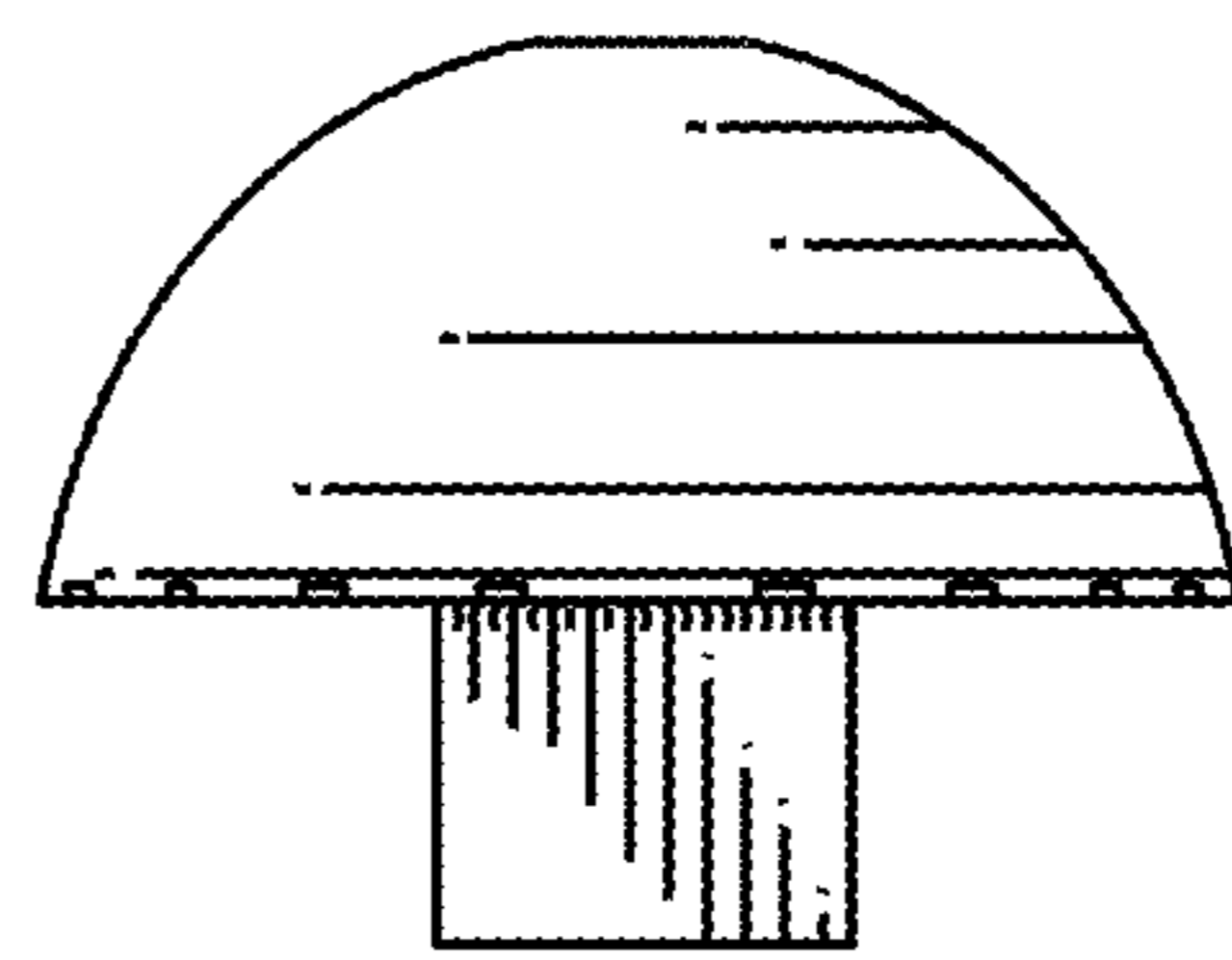

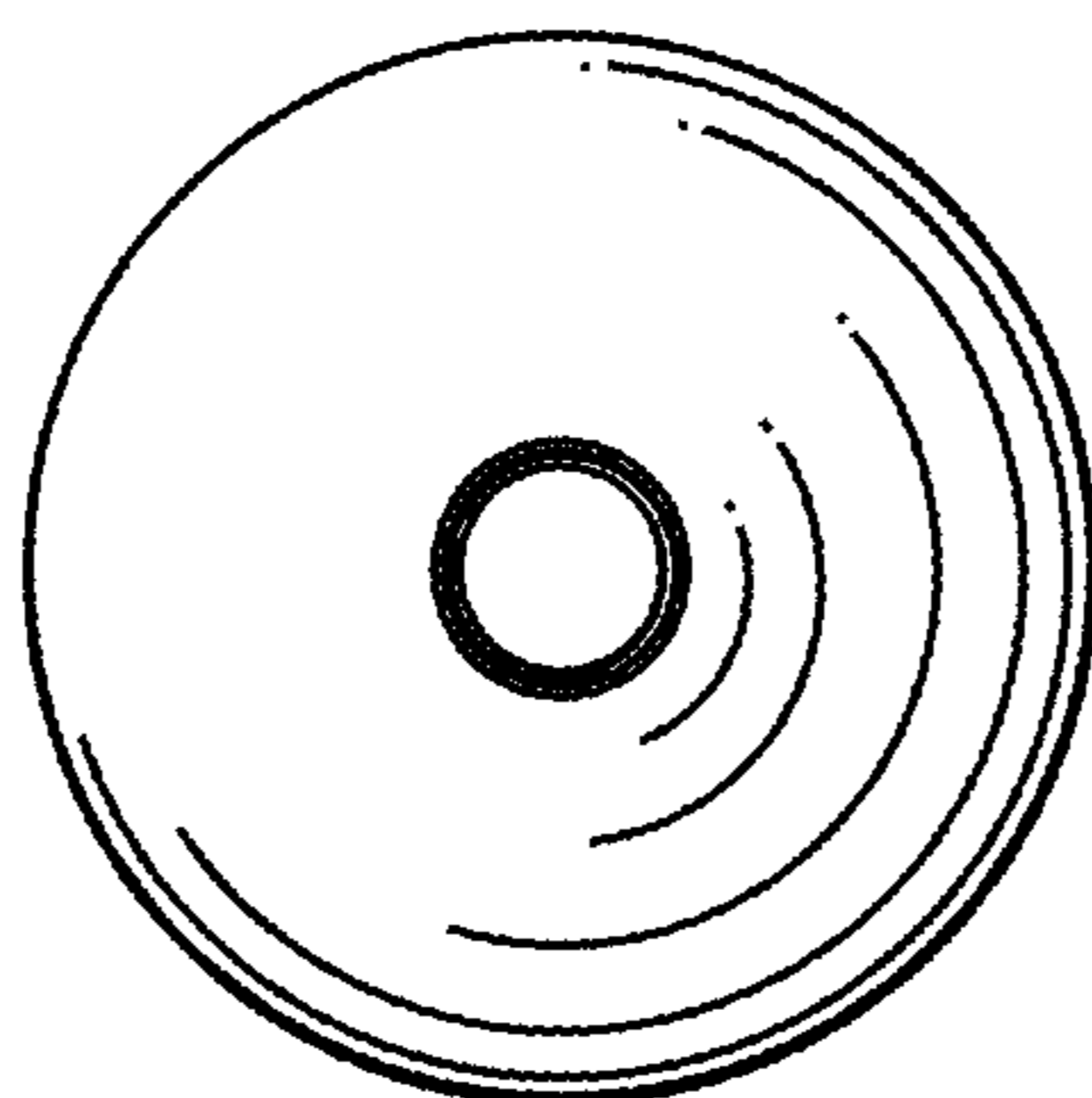

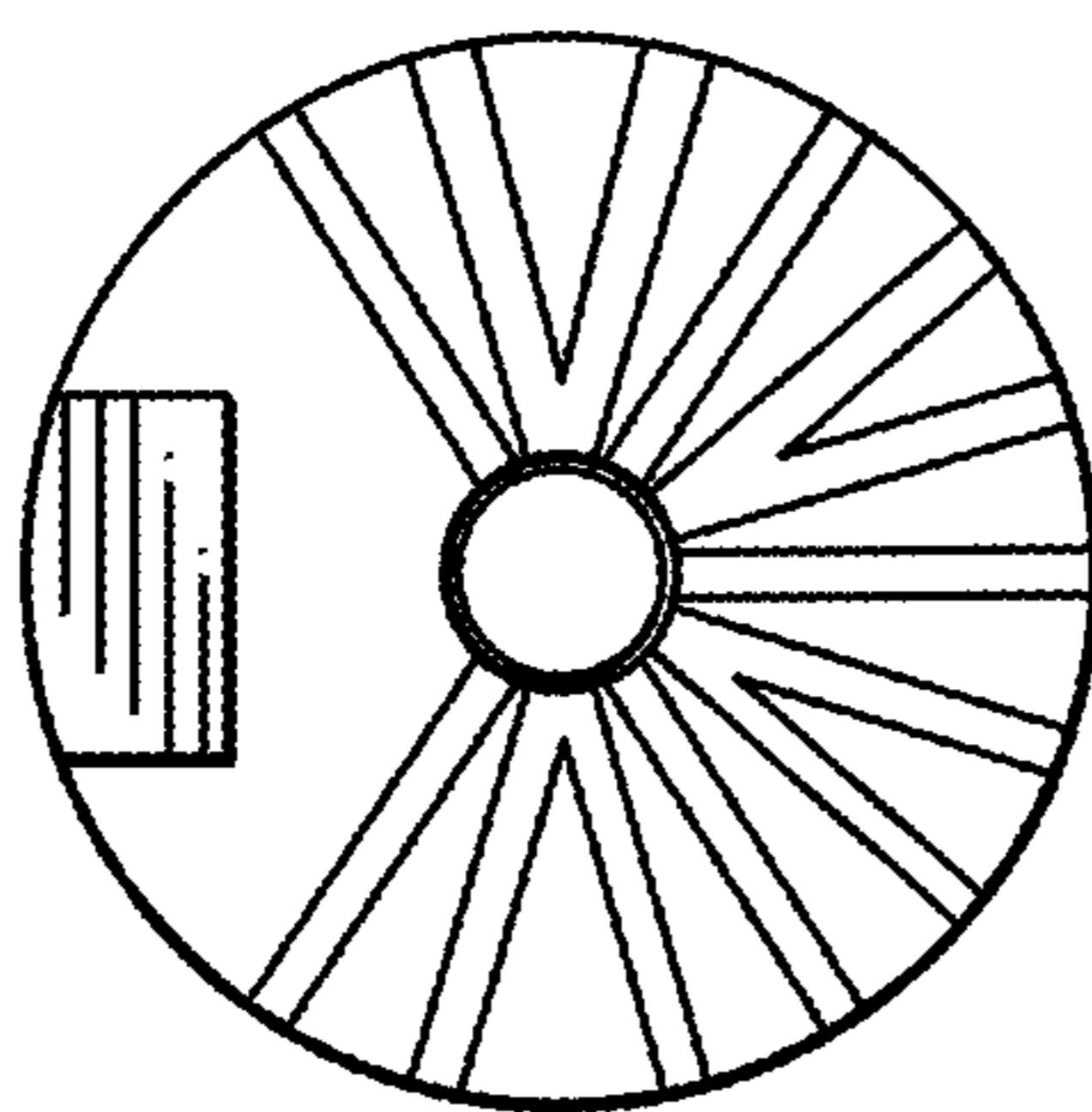

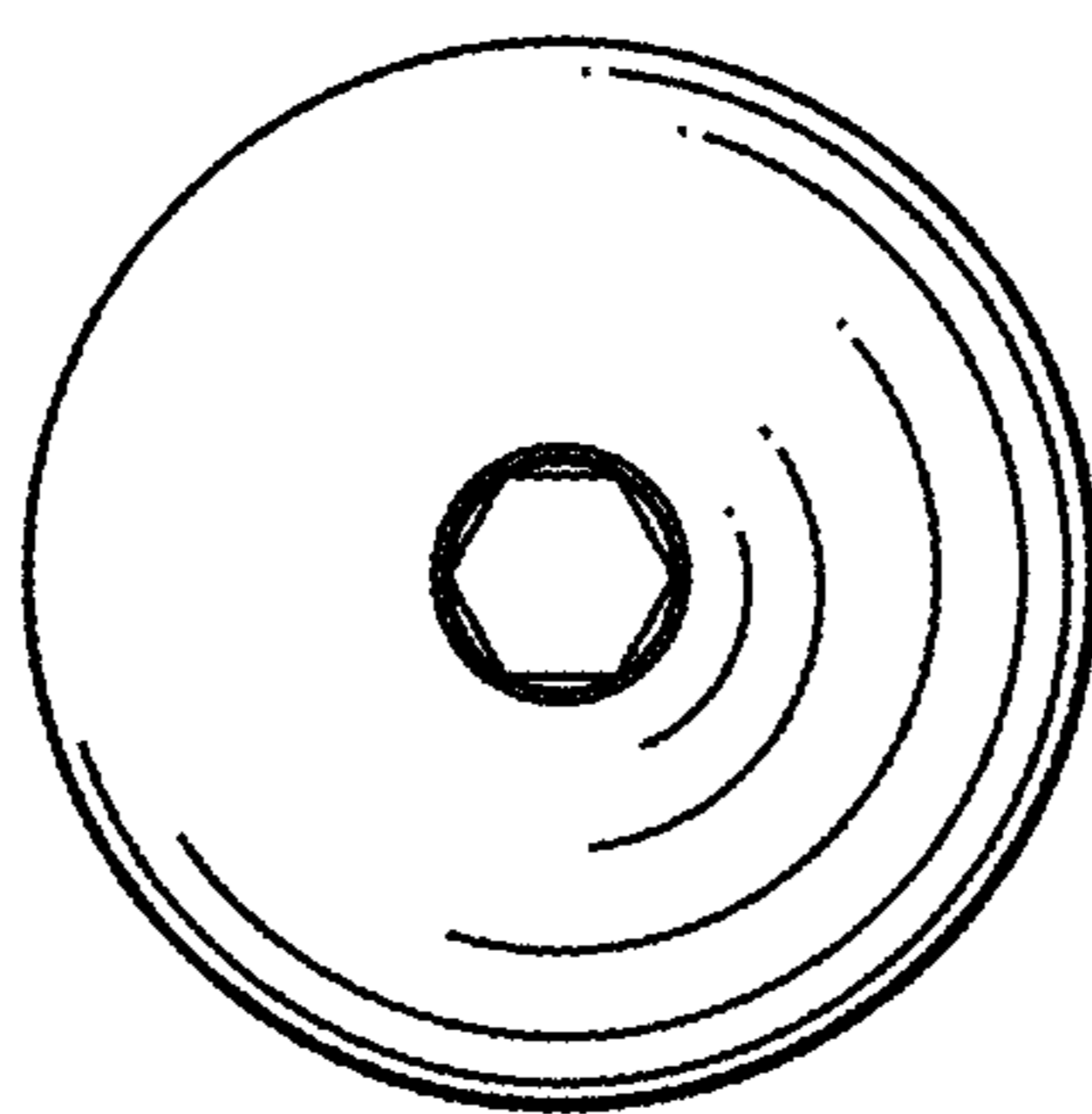

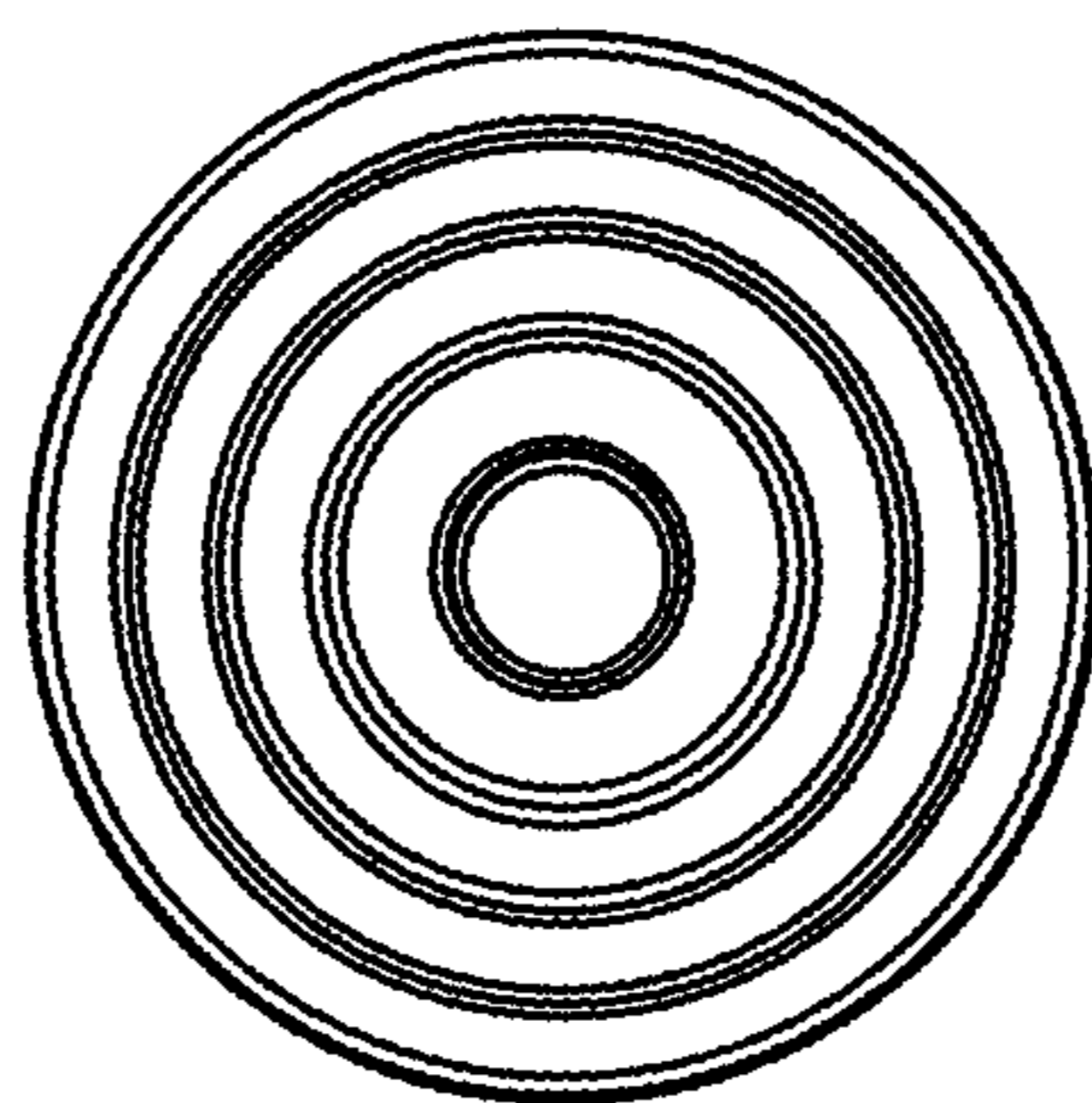

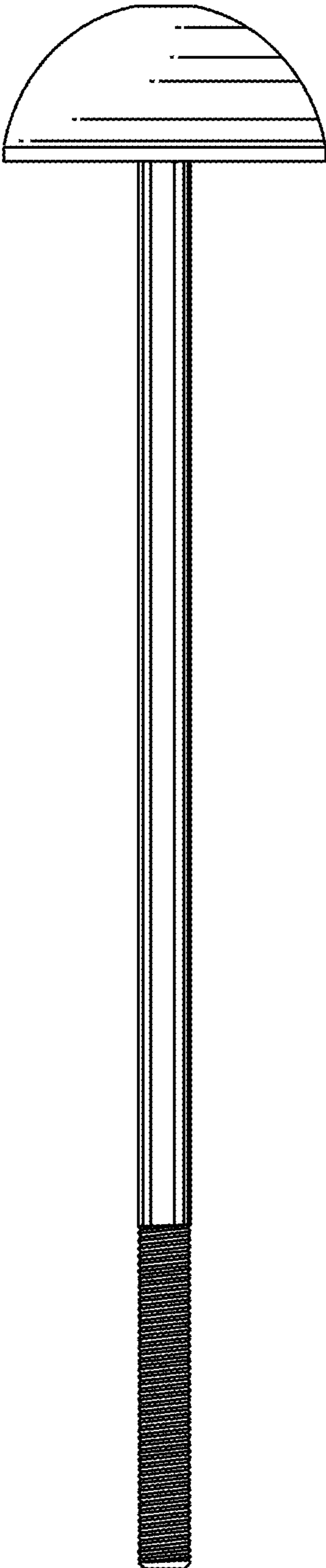

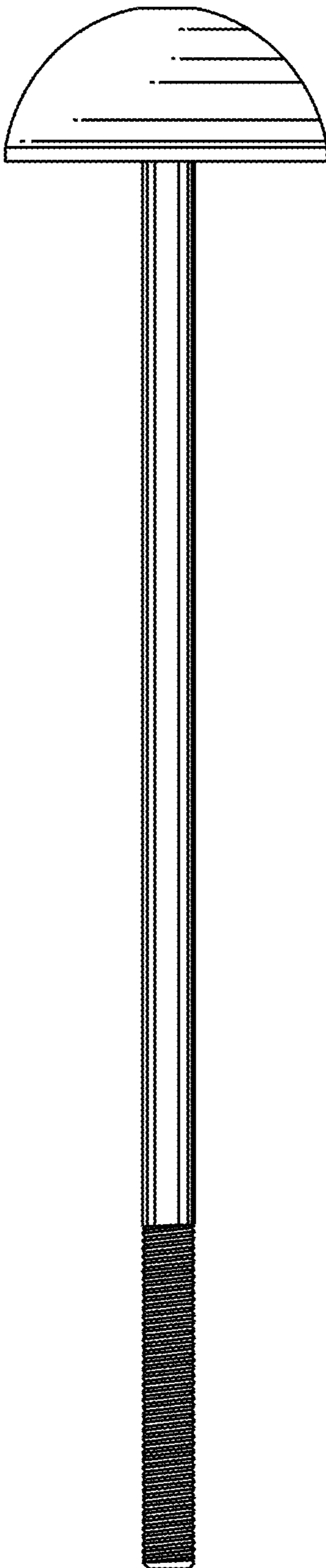

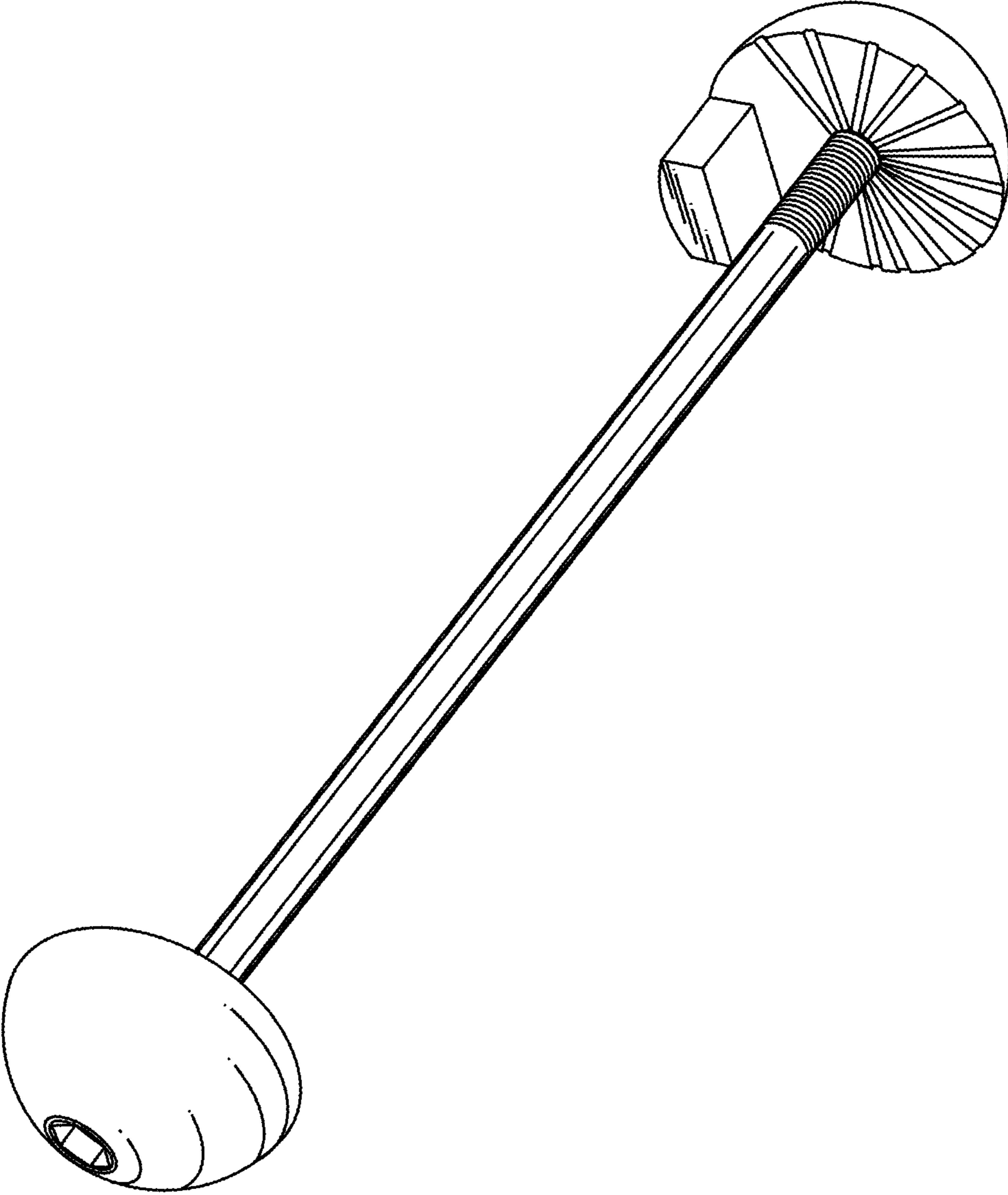
