(57) **CLAIM**

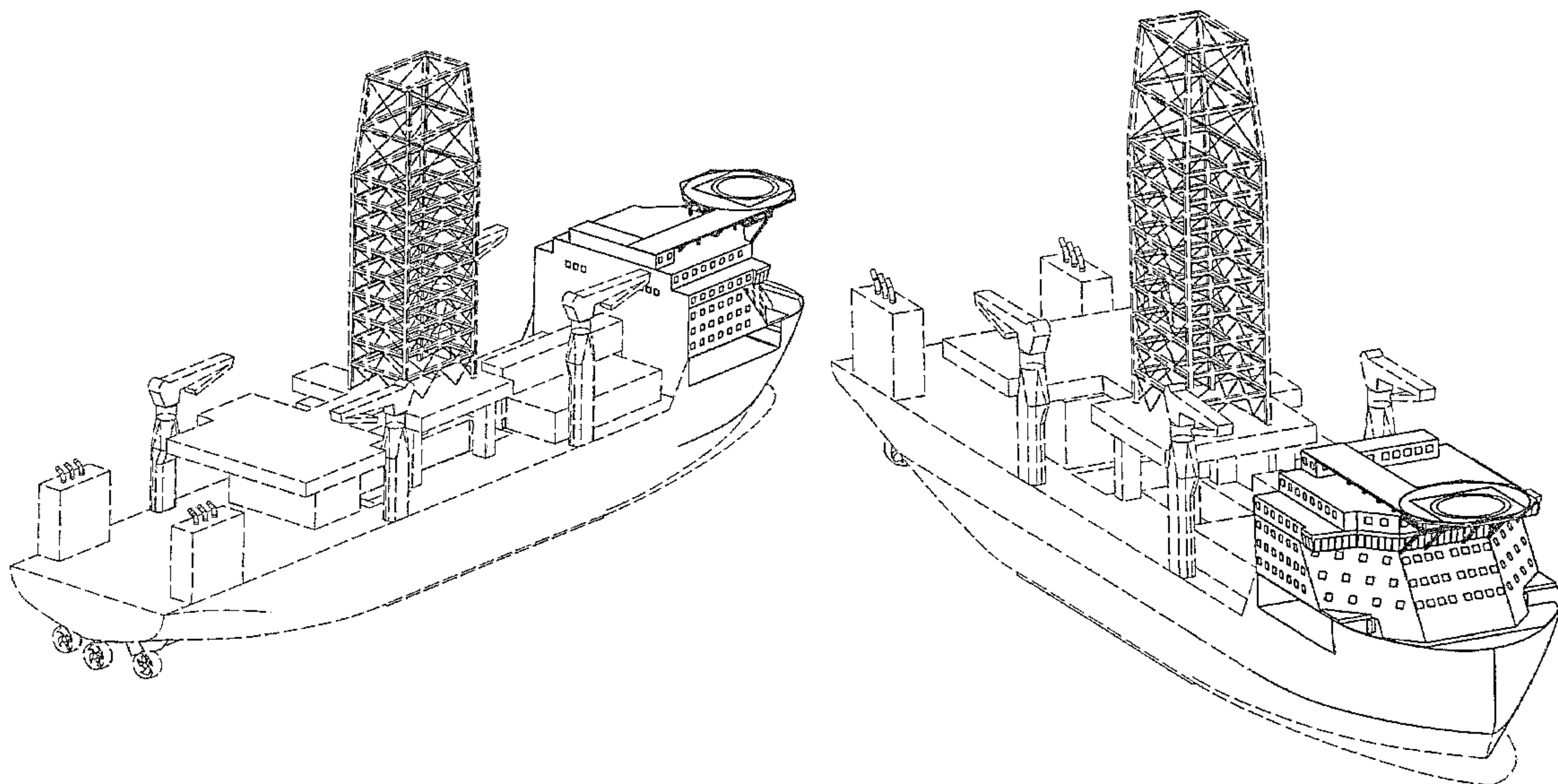
The ornamental design for a fore part of a drilling ship, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of my new fore part of a drilling ship;  
FIG. 2 is a perspective view of my new fore part of a drilling ship from the end opposite that of FIG. 1;  
FIG. 3 is a side elevational view of my new fore part of a drilling ship of FIG. 1;  
FIG. 4 is a side elevational view of my new fore part of a drilling ship from the side opposite that of FIG. 3;  
FIG. 5 is an end view of my new fore part of a drilling ship of FIG. 1;  
FIG. 6 is an end view of my new fore part of a drilling ship from the end opposite that of FIG. 5; and,  
FIG. 7 is a top plan view of my new fore part of a drilling ship of FIG. 1.

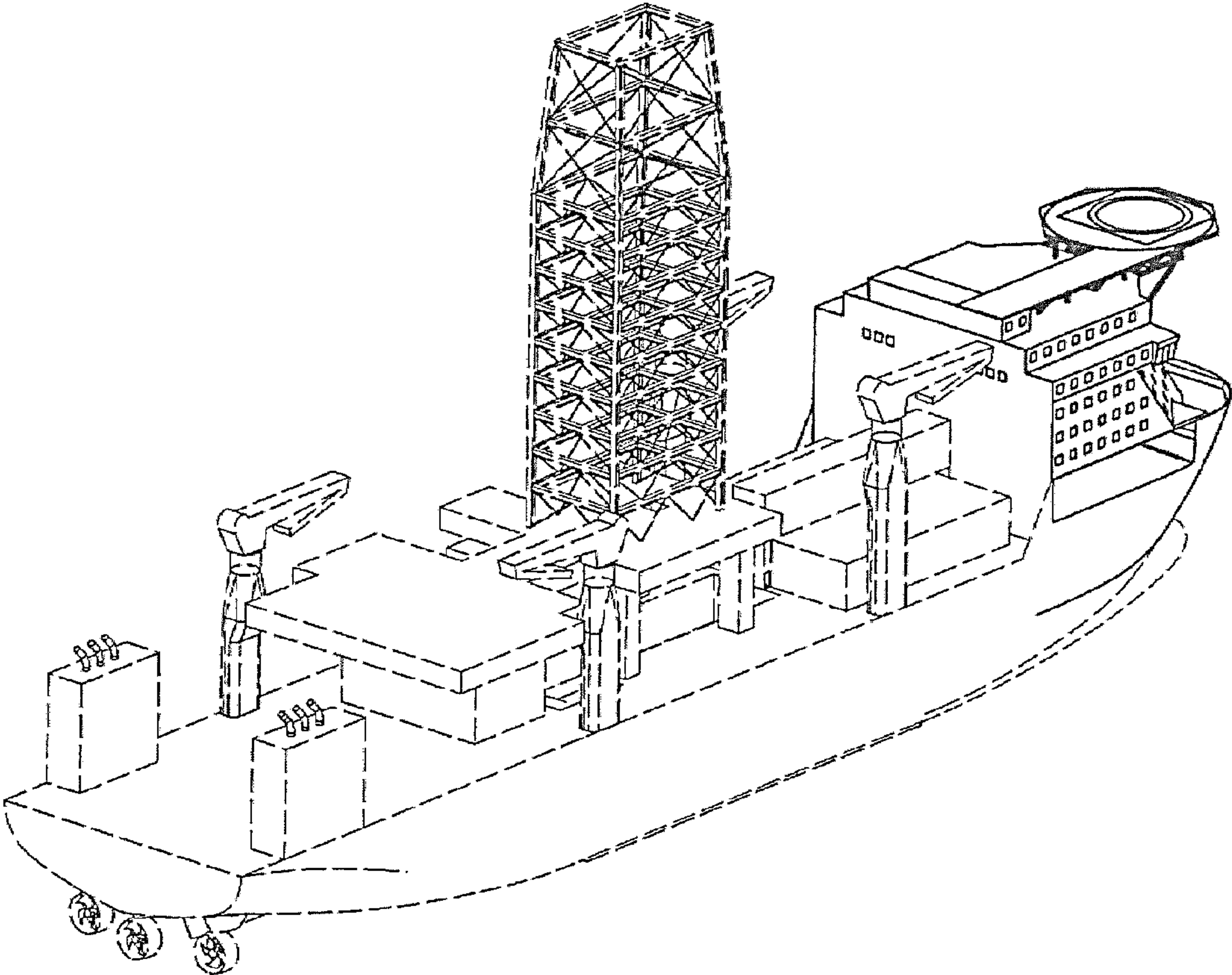

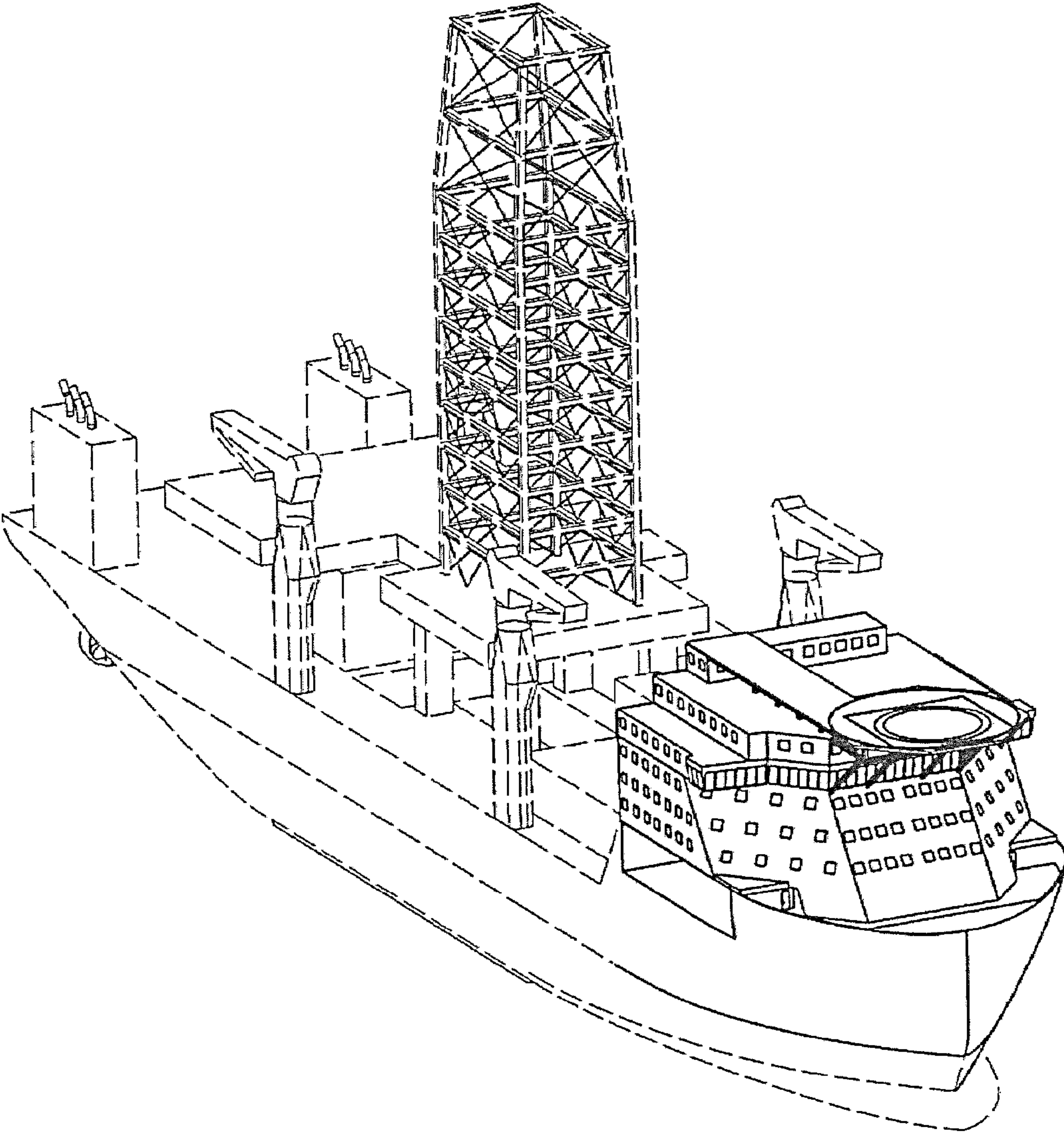

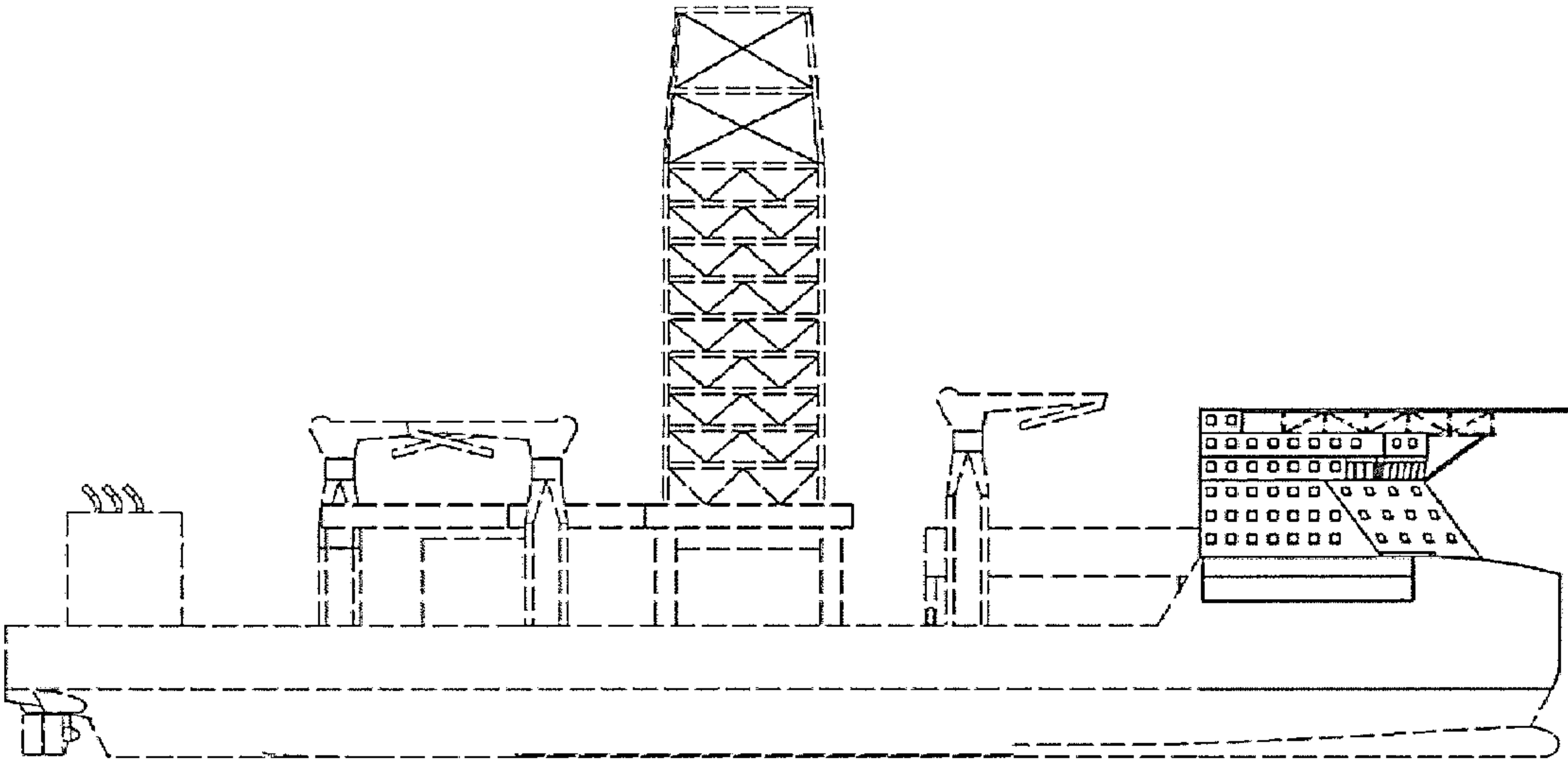

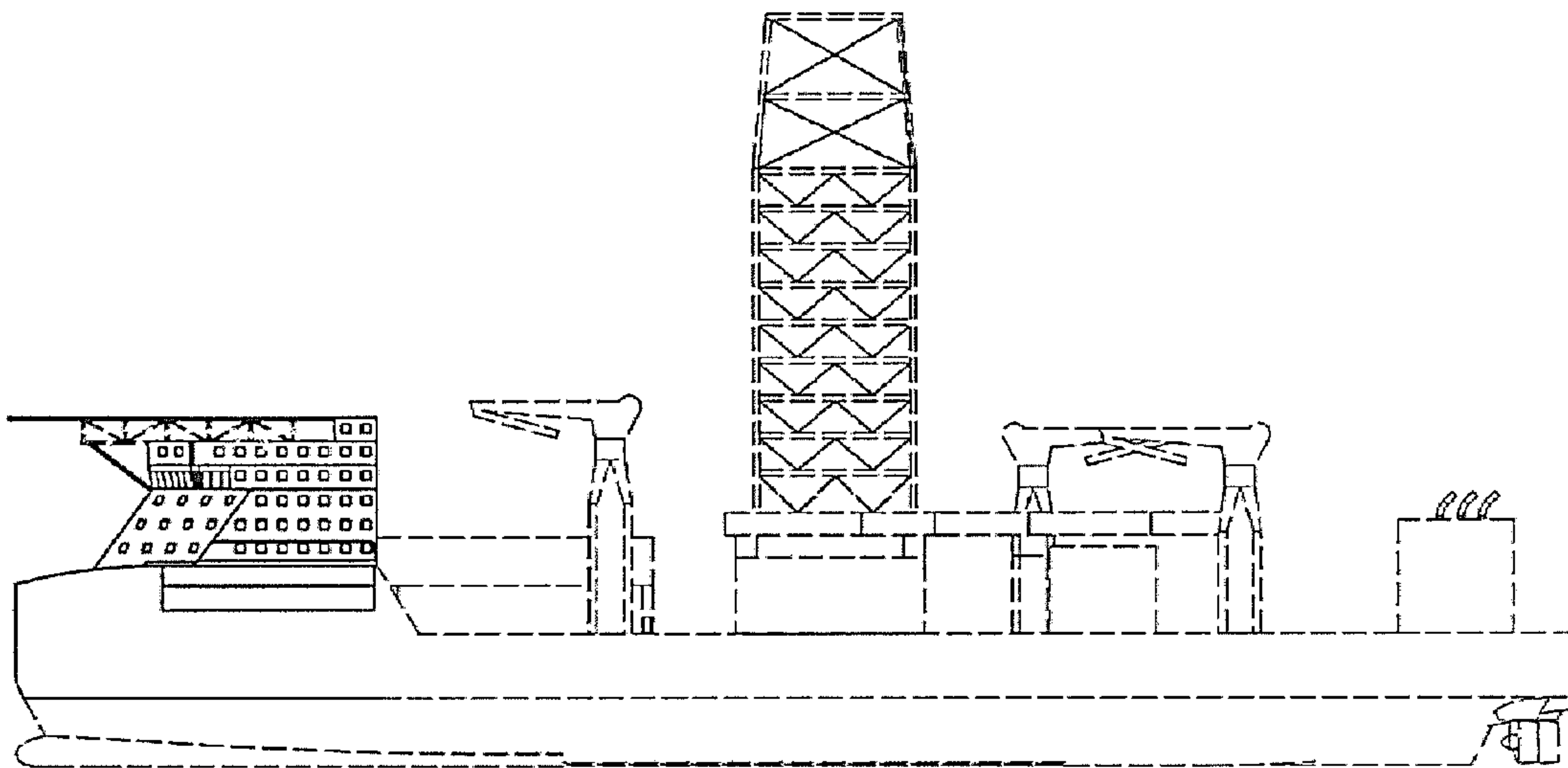

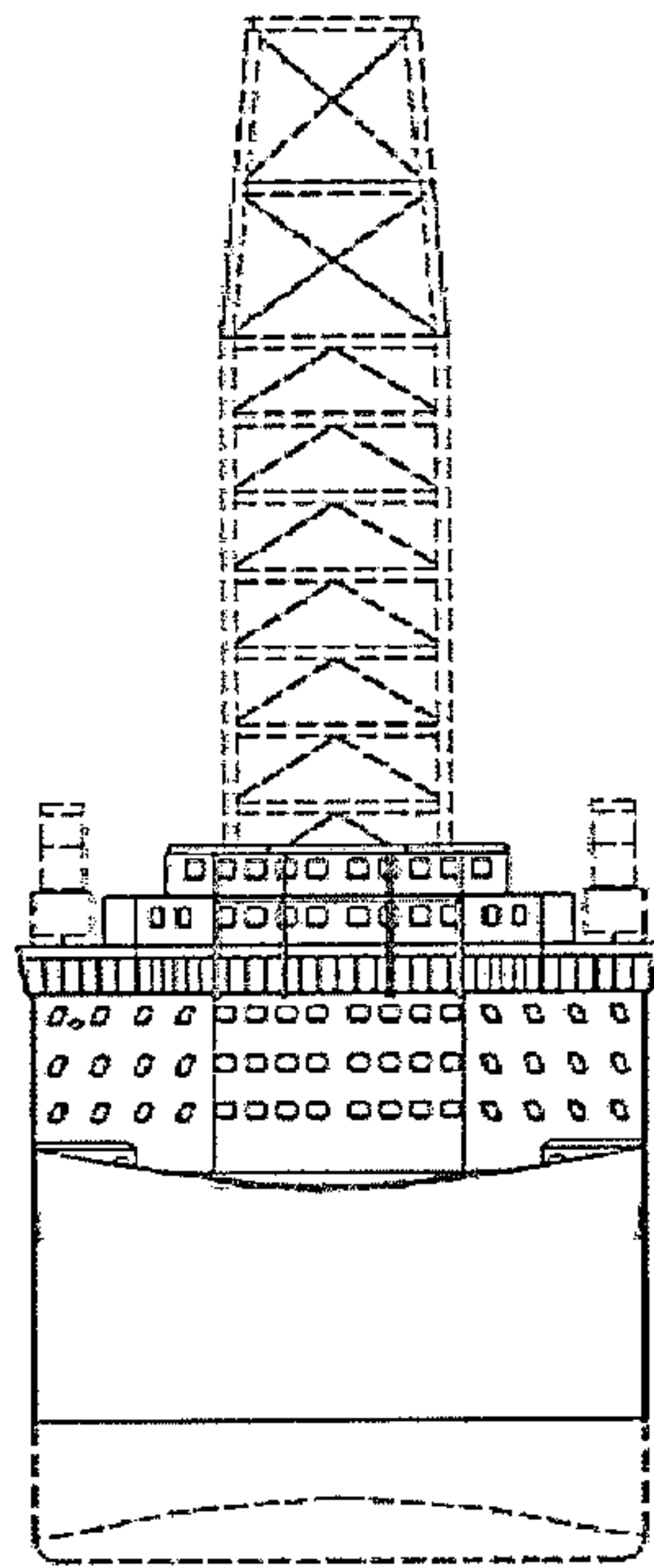

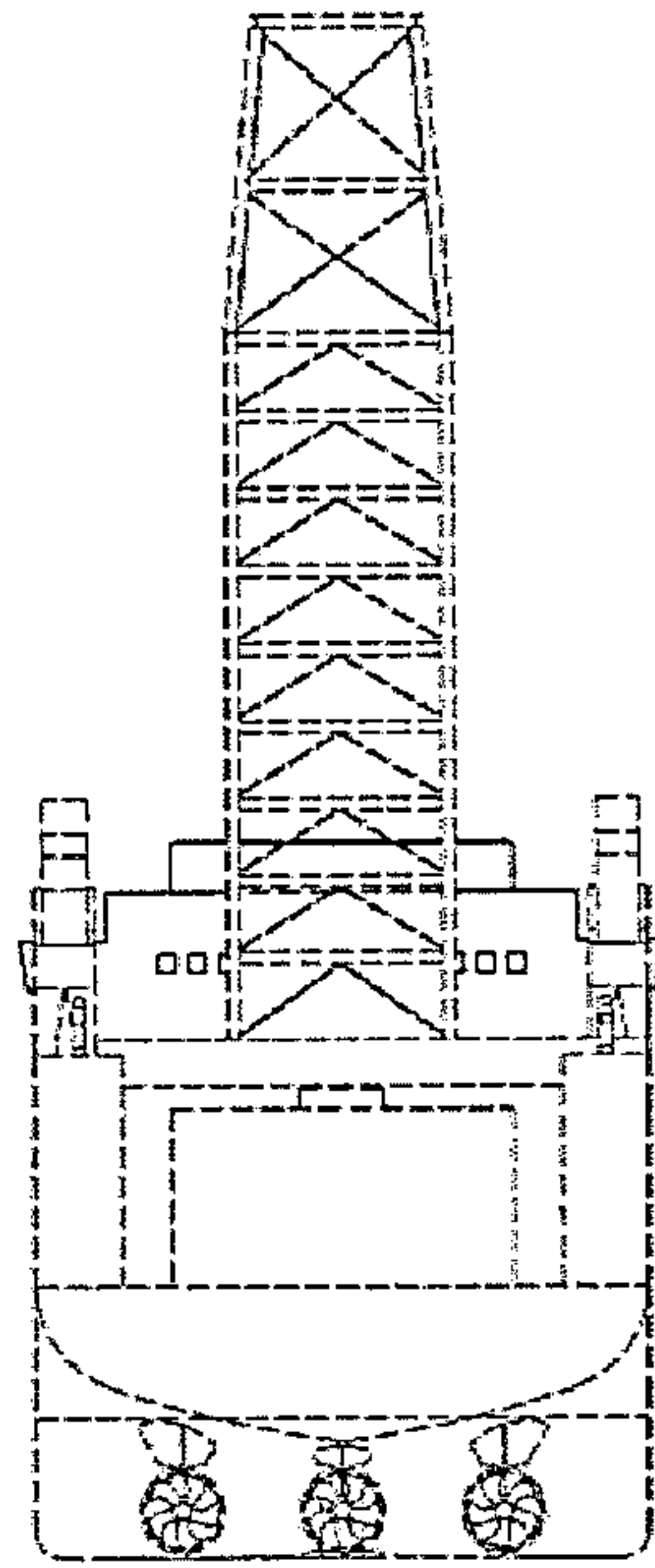

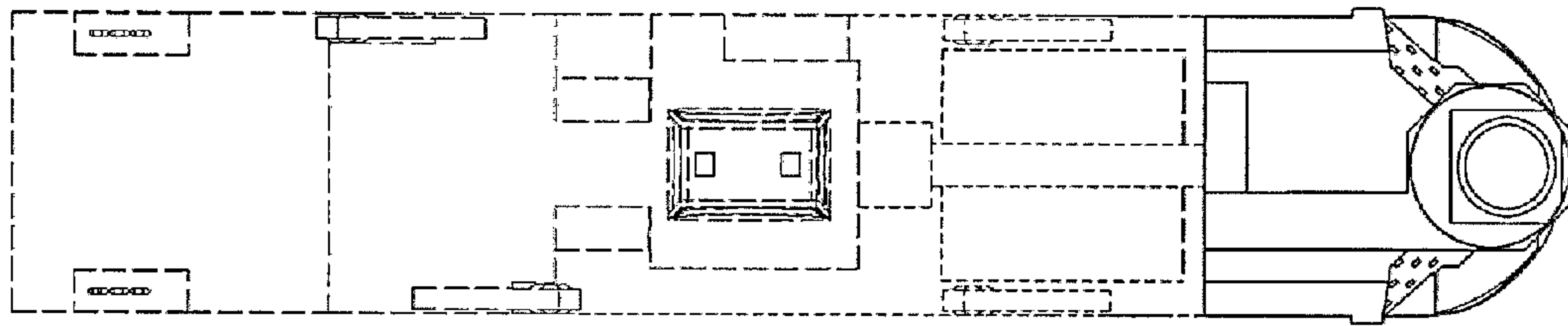
