 FIG. 10 depicts the front view of the extended vehicular armrest of the present invention.

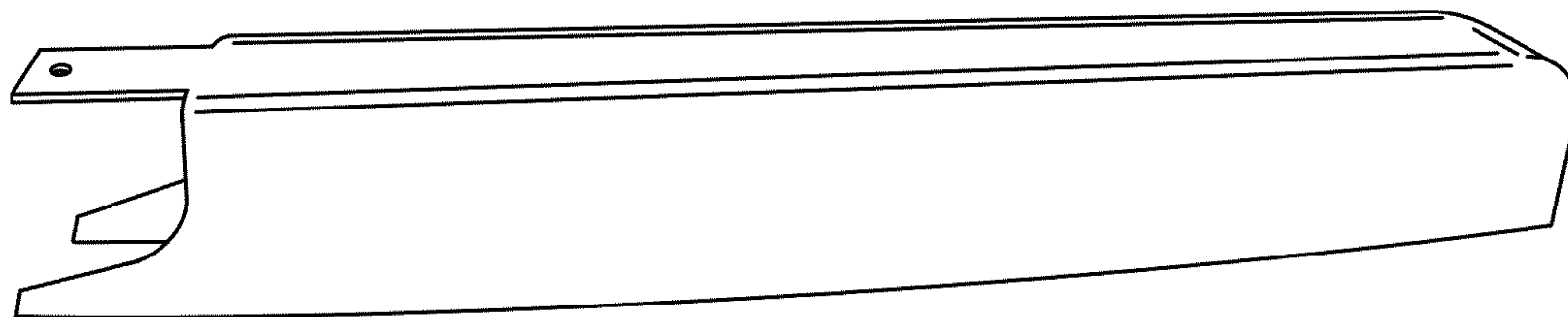

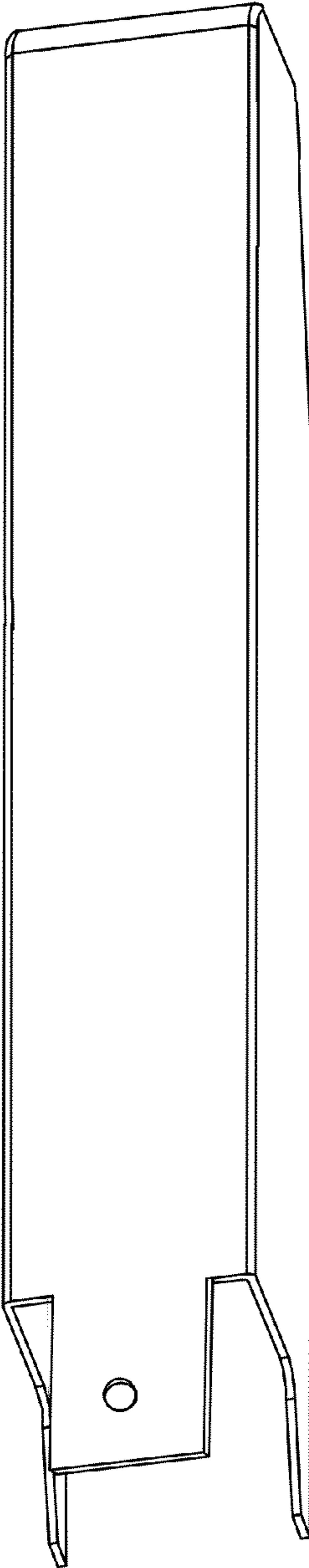

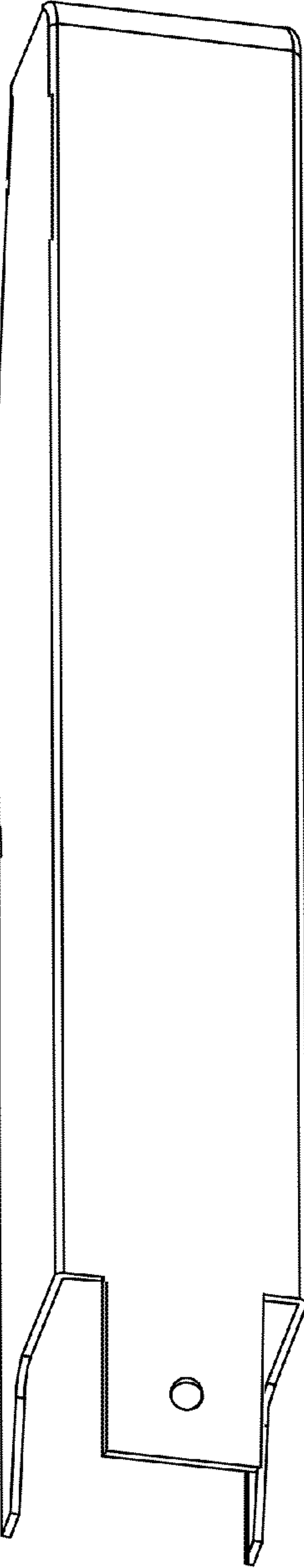
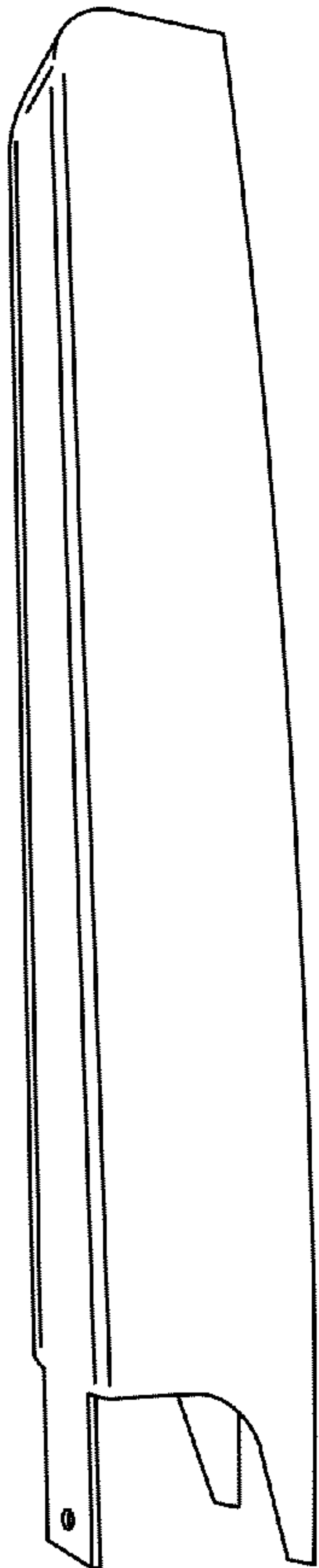

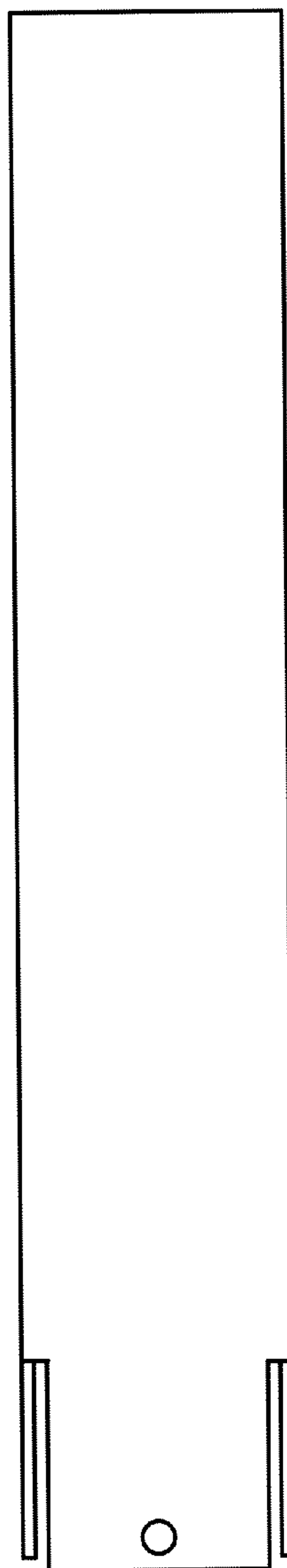

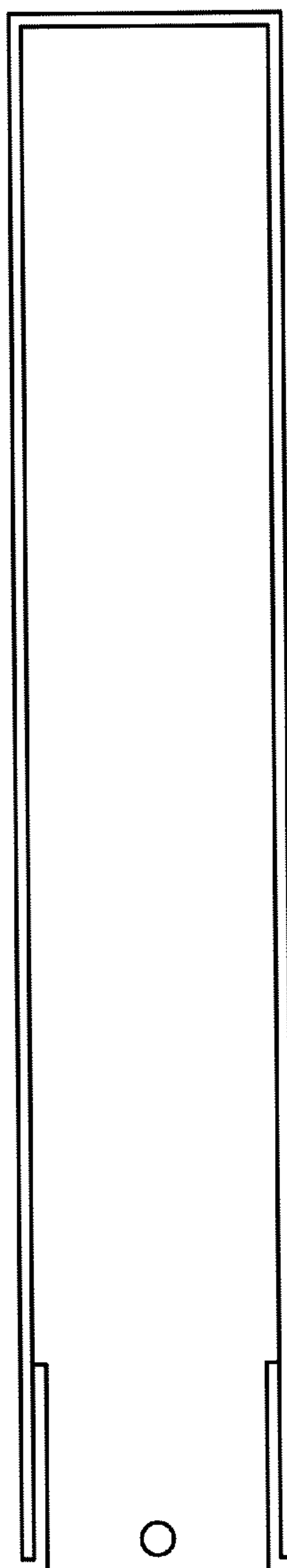

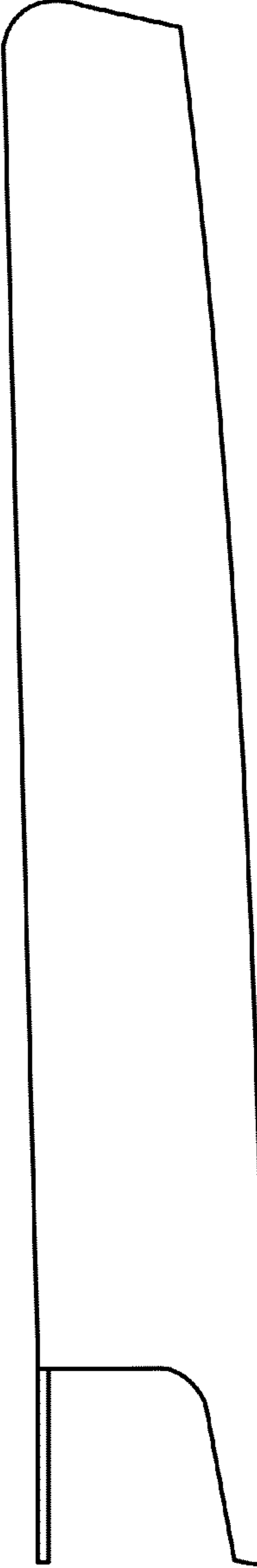

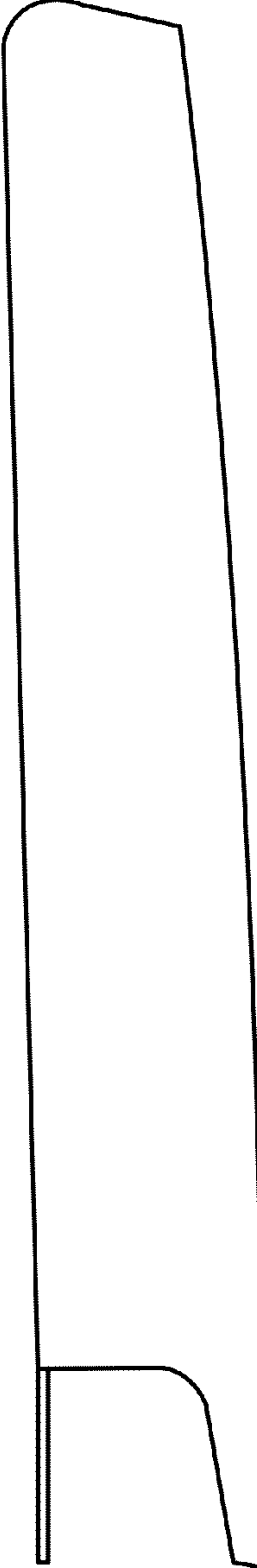

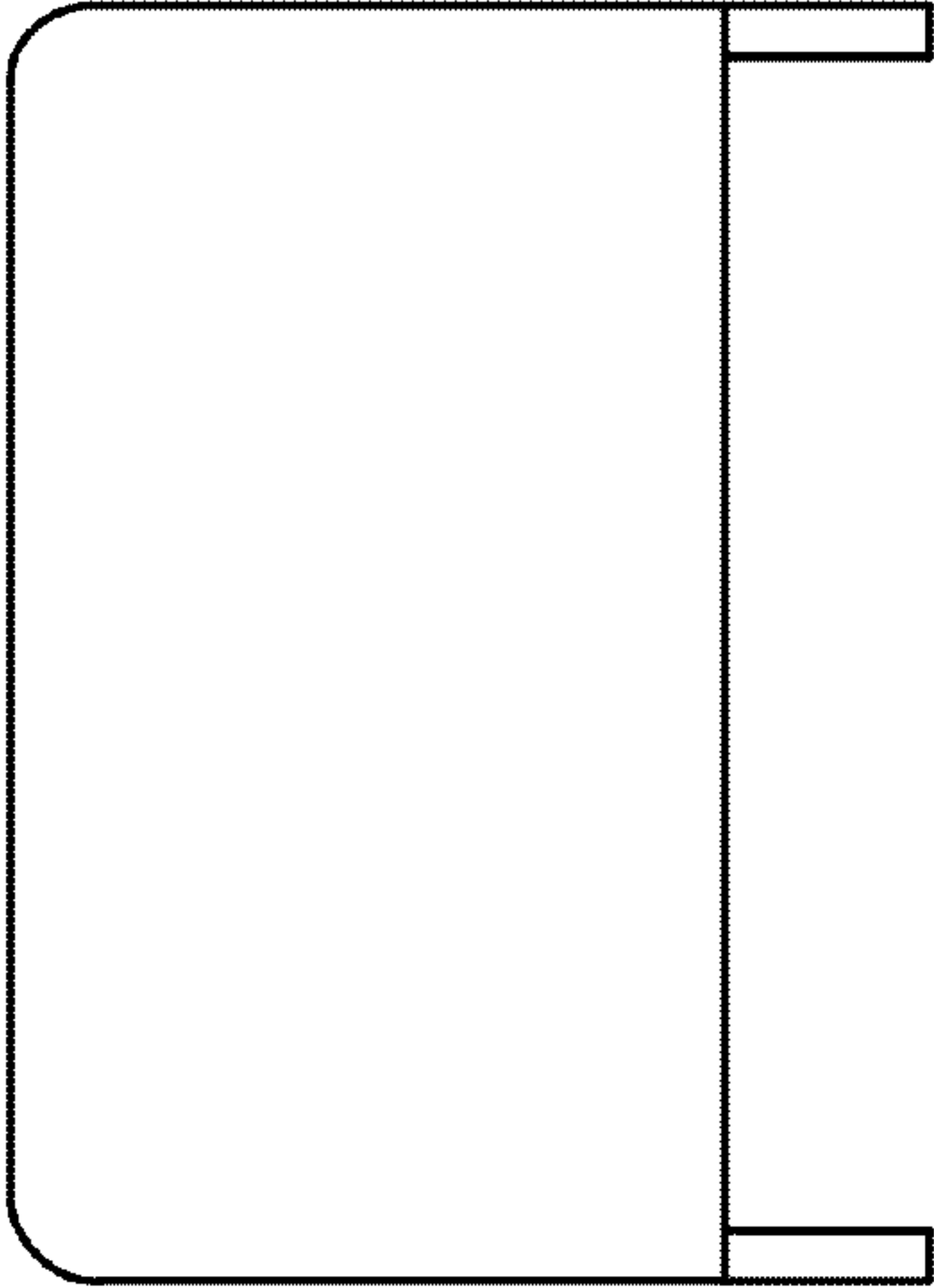

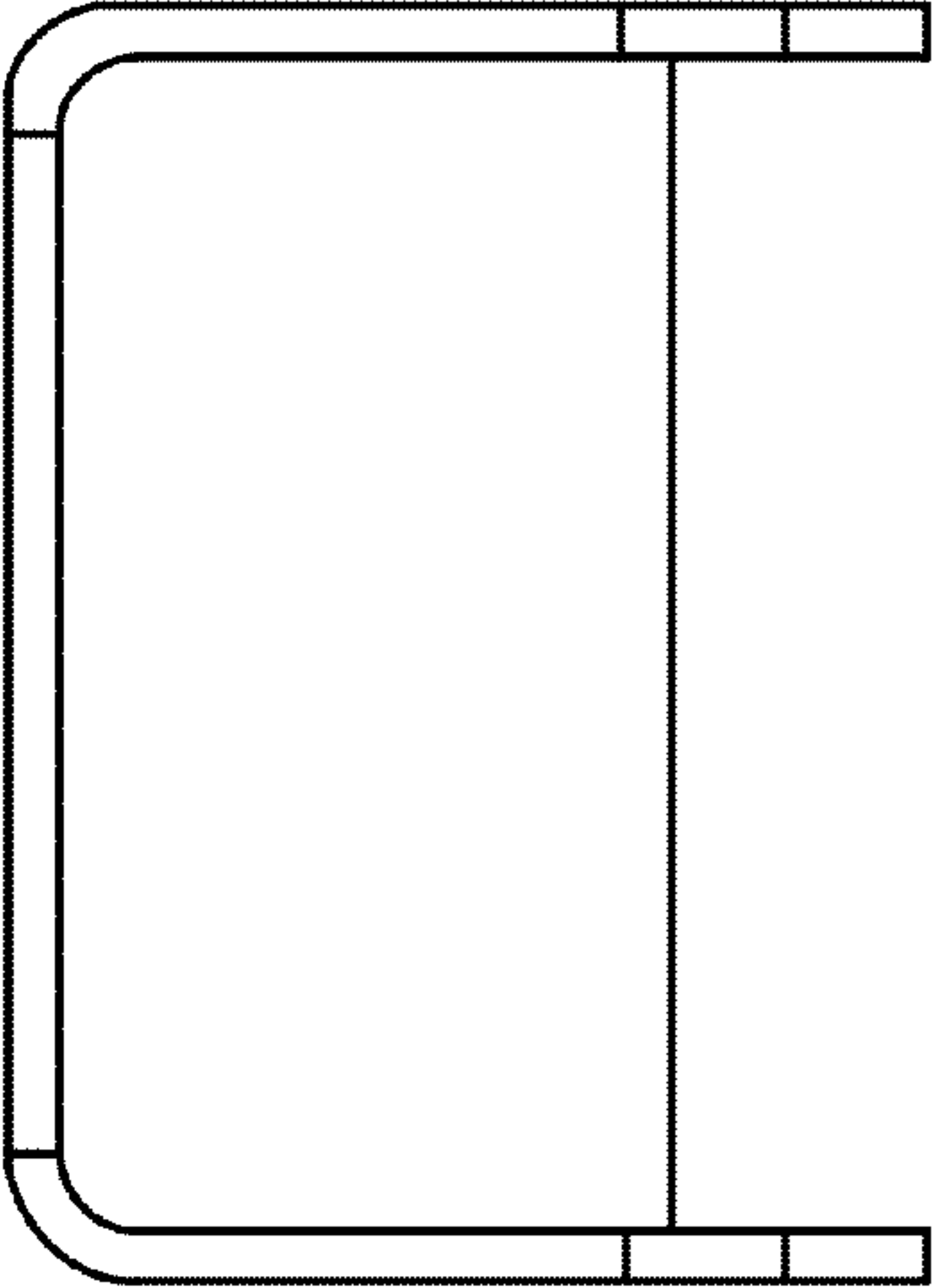
