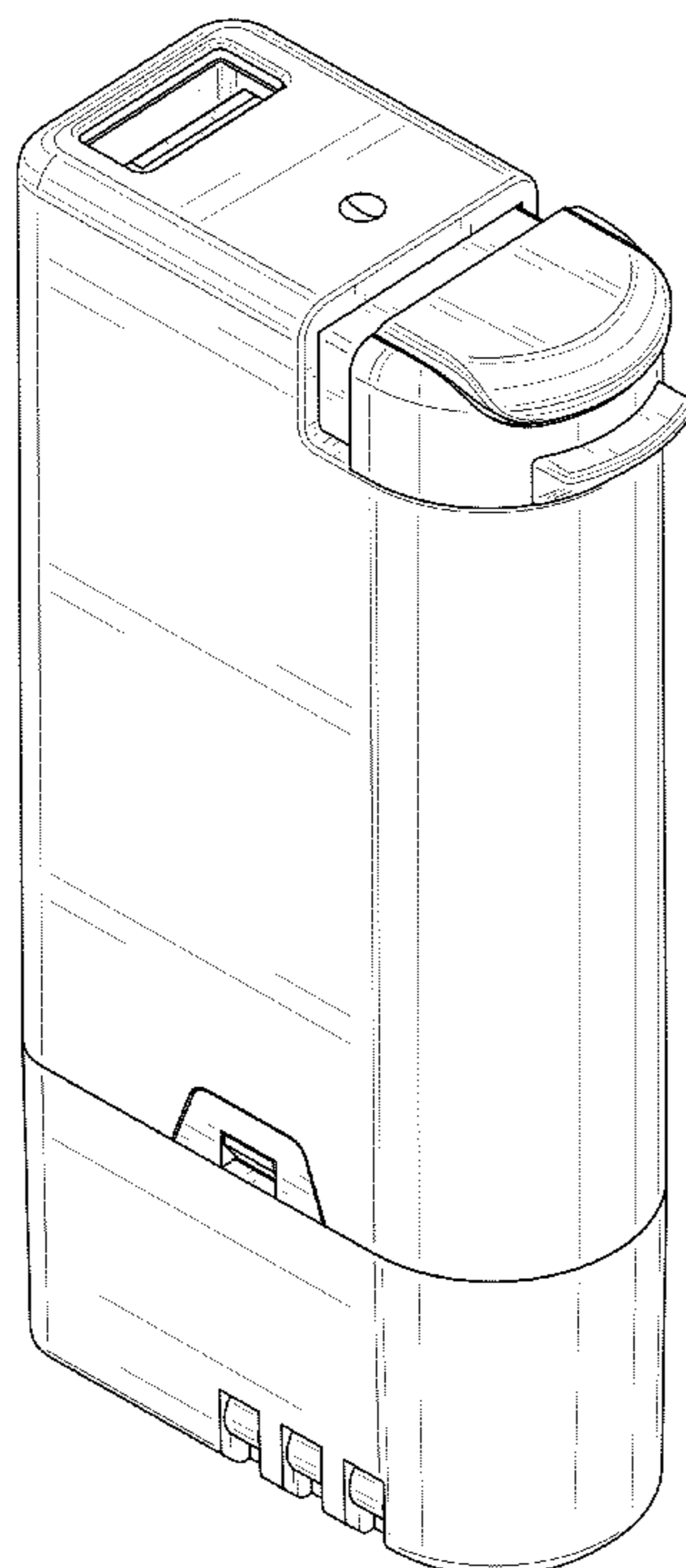
(57) **CLAIM**

I claim the design for a battery pack, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a battery pack showing my new design;
FIG. 2 is a front view of the design of FIG. 1;
FIG. 3 is a right side view of the design of FIG. 1;
FIG. 4 is a left side view of the design of FIG. 1;
FIG. 5 is a rear view of the design of FIG. 1;
FIG. 6 is a top view of the design of FIG. 1; and,
FIG. 7 is a bottom view of the design of FIG. 1.
The broken line shown in the drawings of the battery pack are included for the purpose of illustrating environmental structure, and form no part of the claimed design.

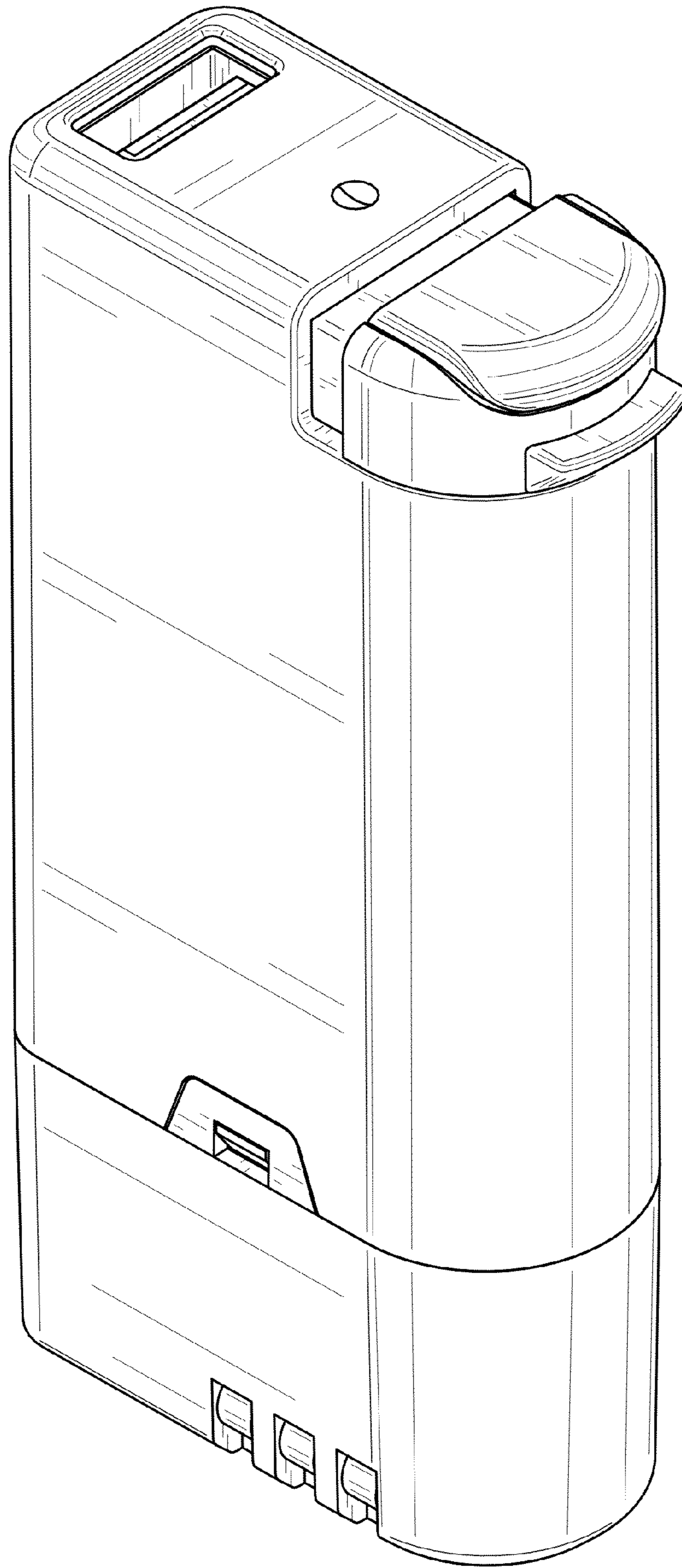

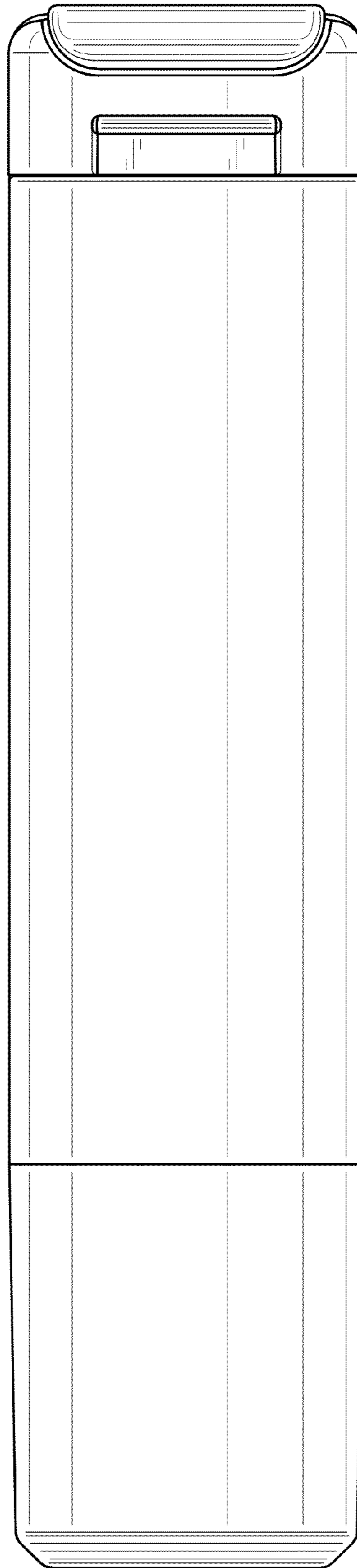

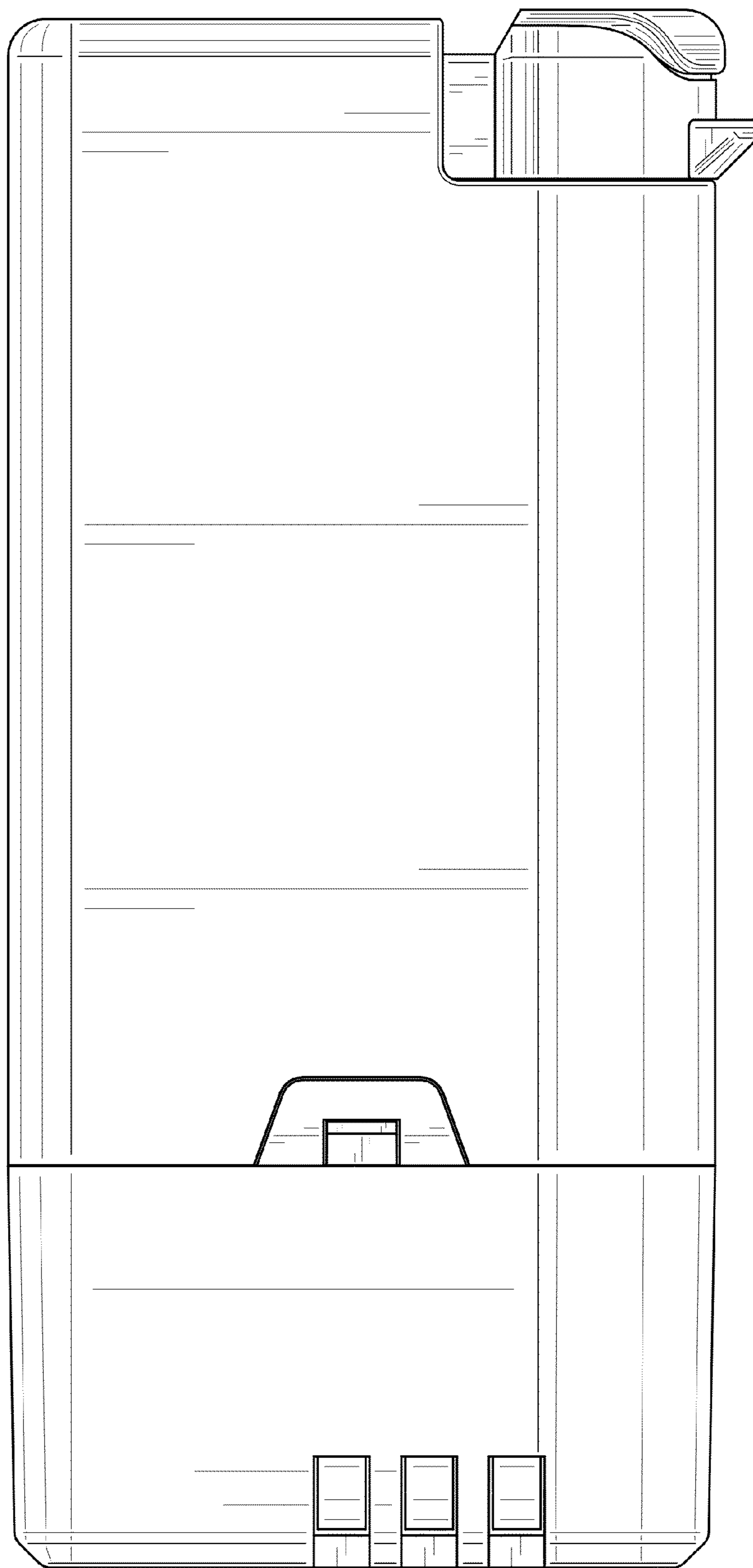

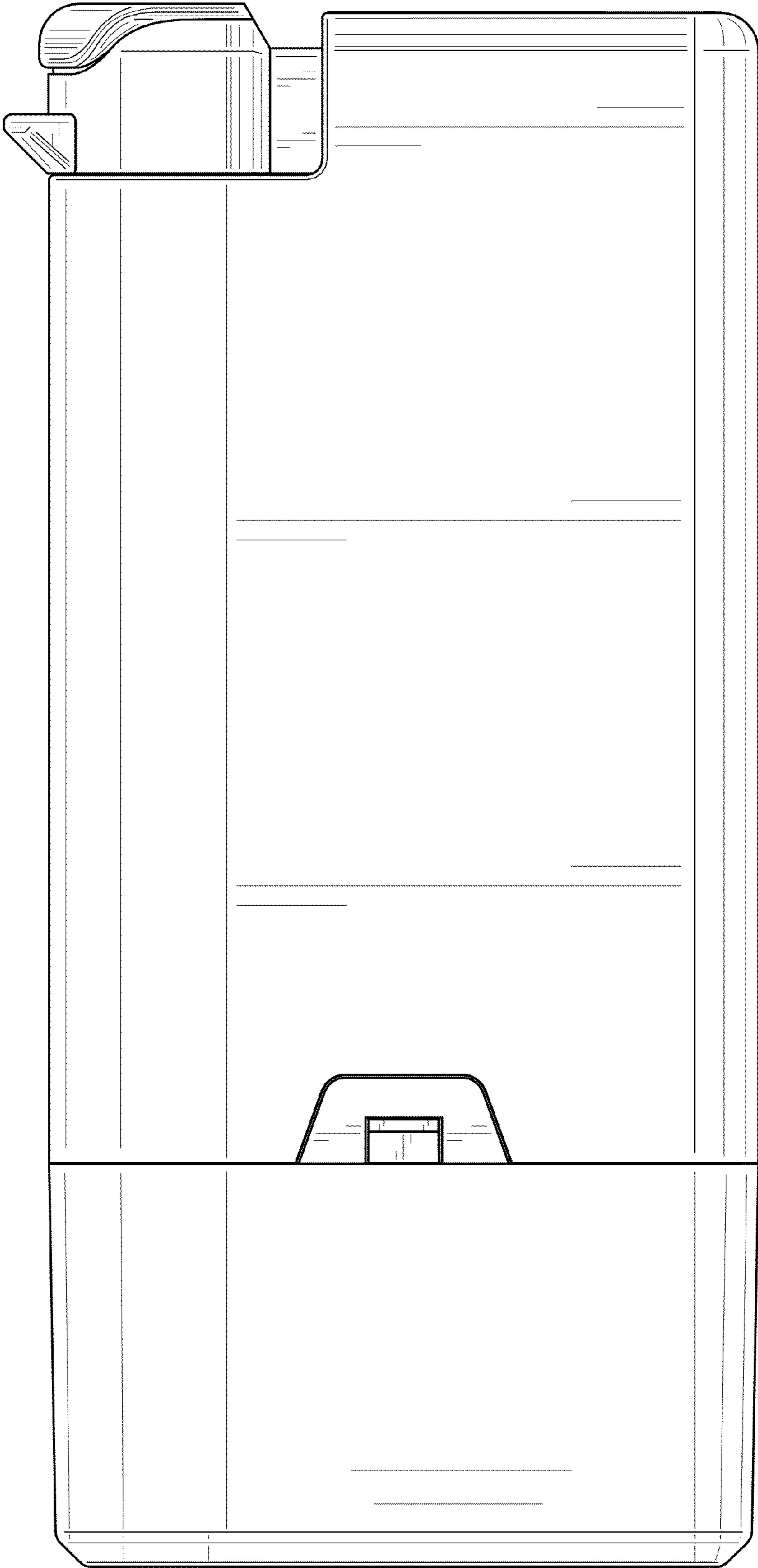

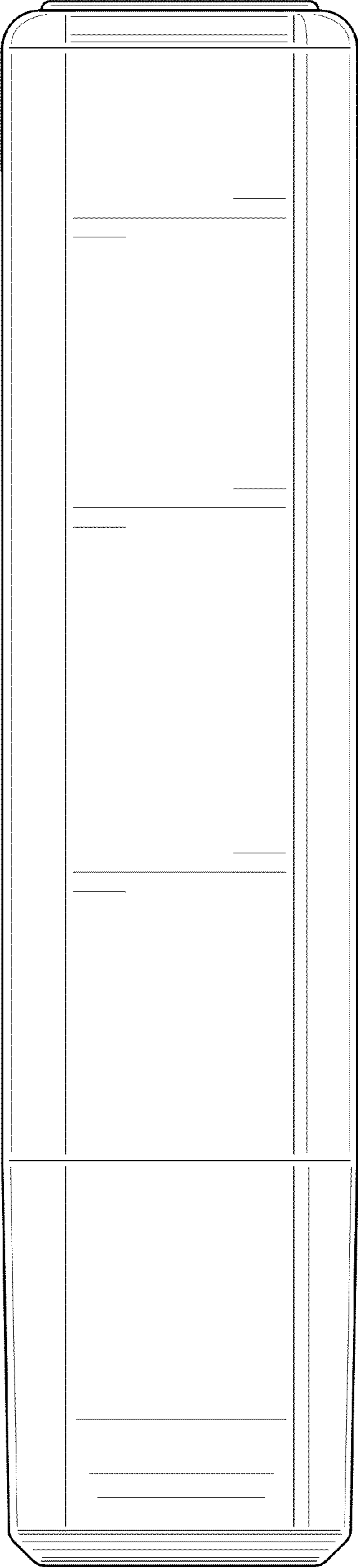

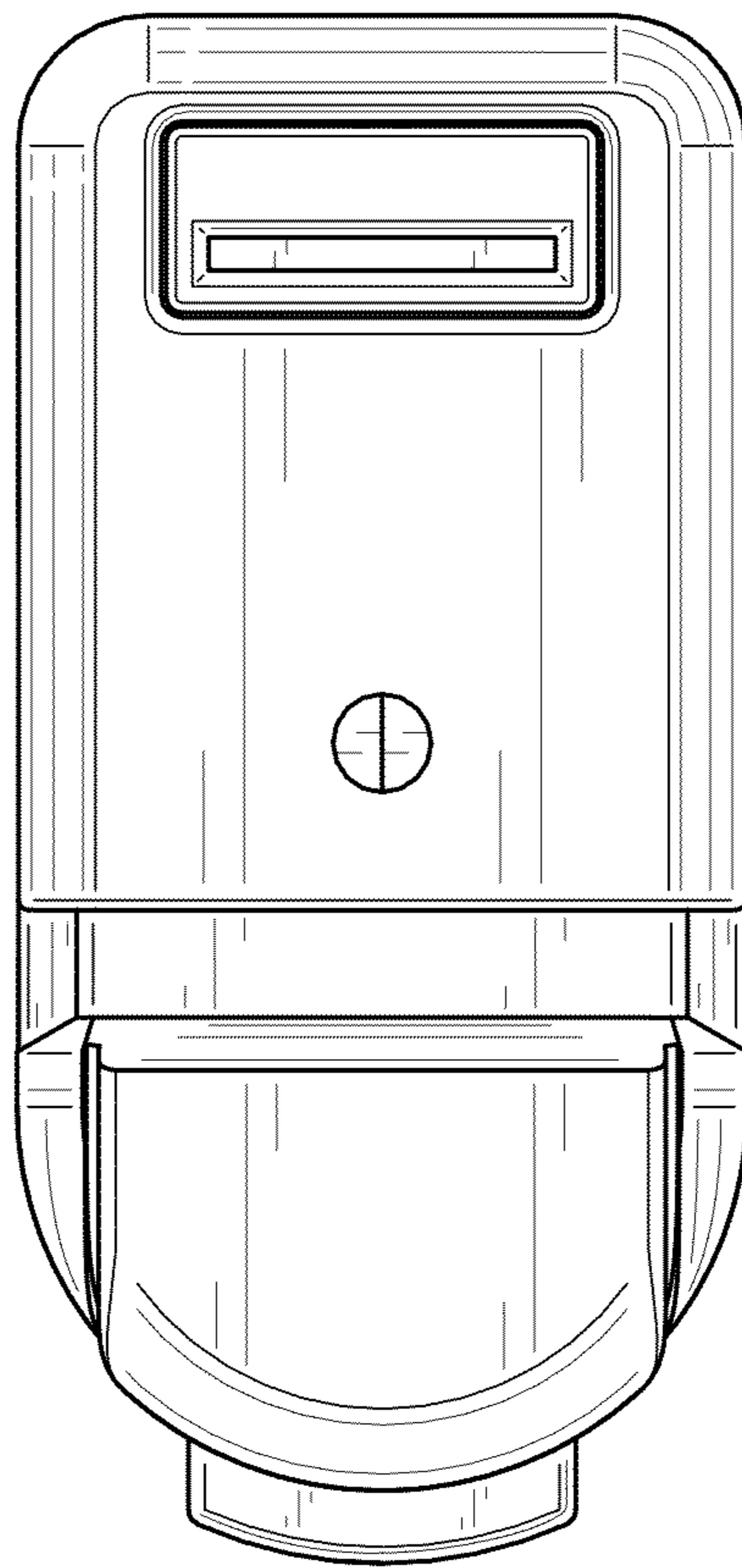

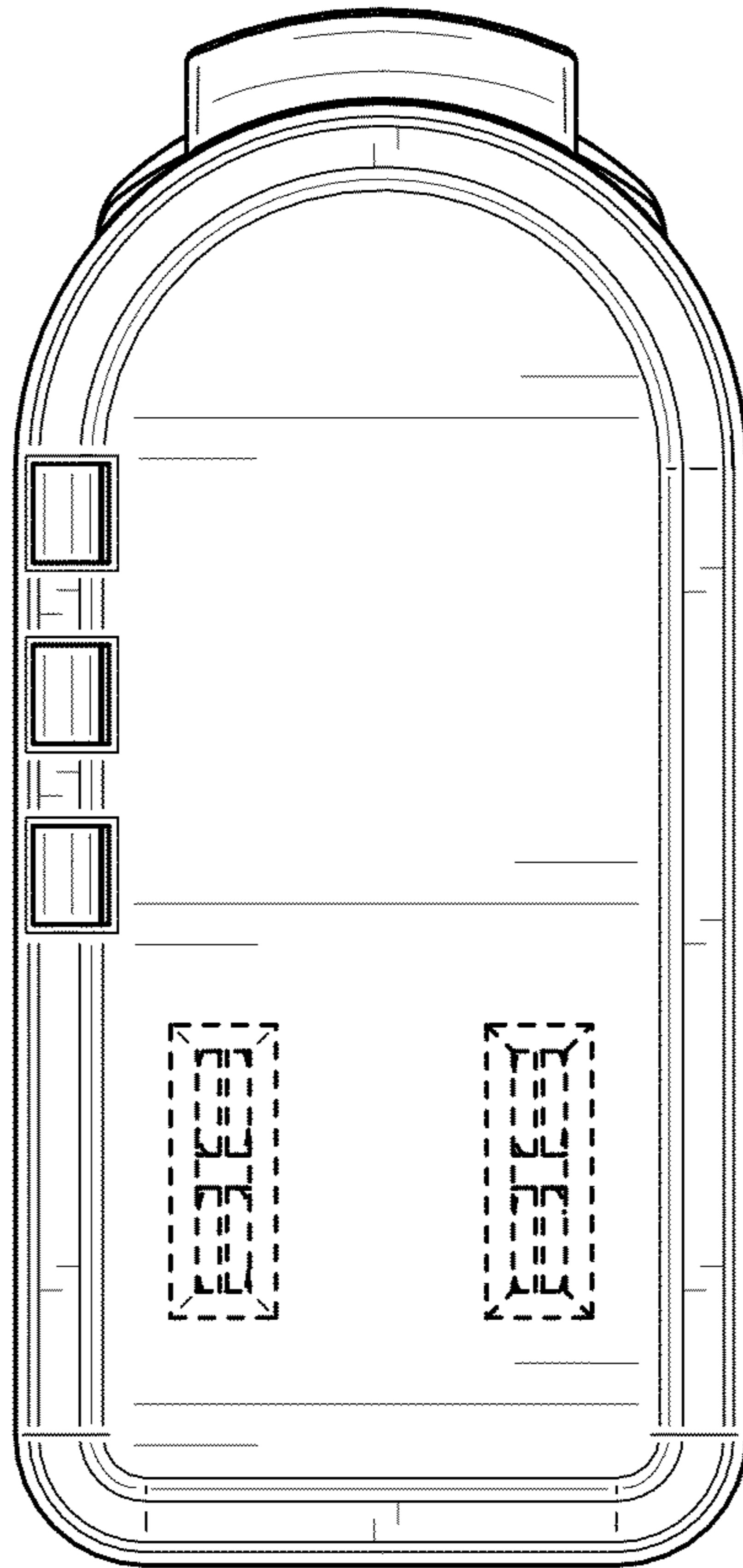
