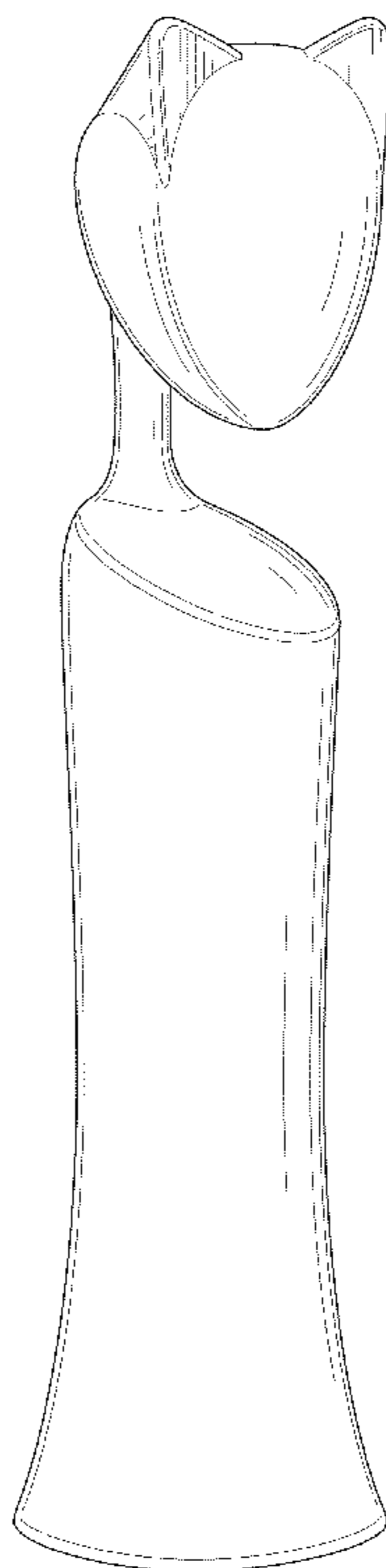

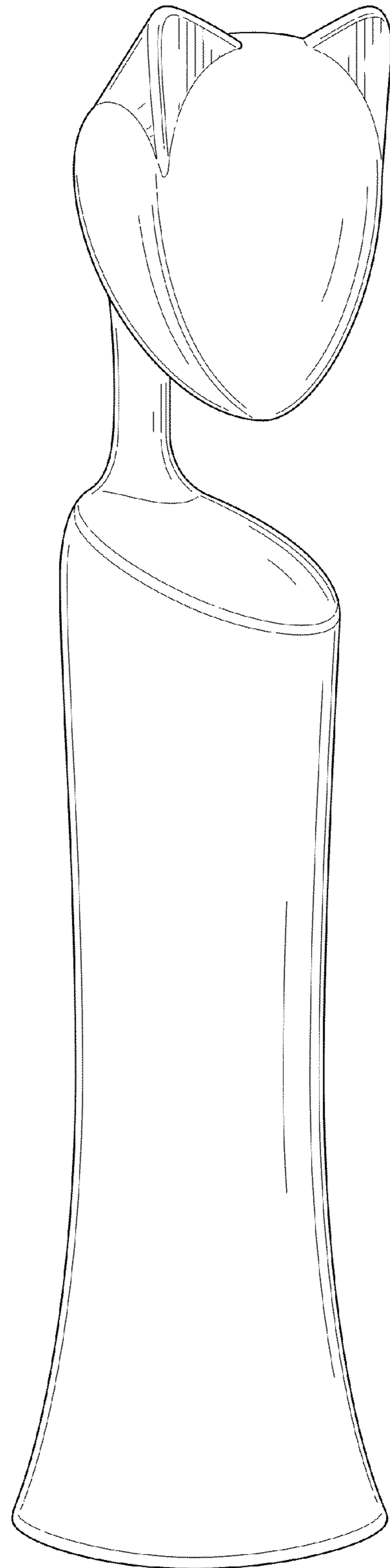
(57) **CLAIM**

**DESCRIPTION**

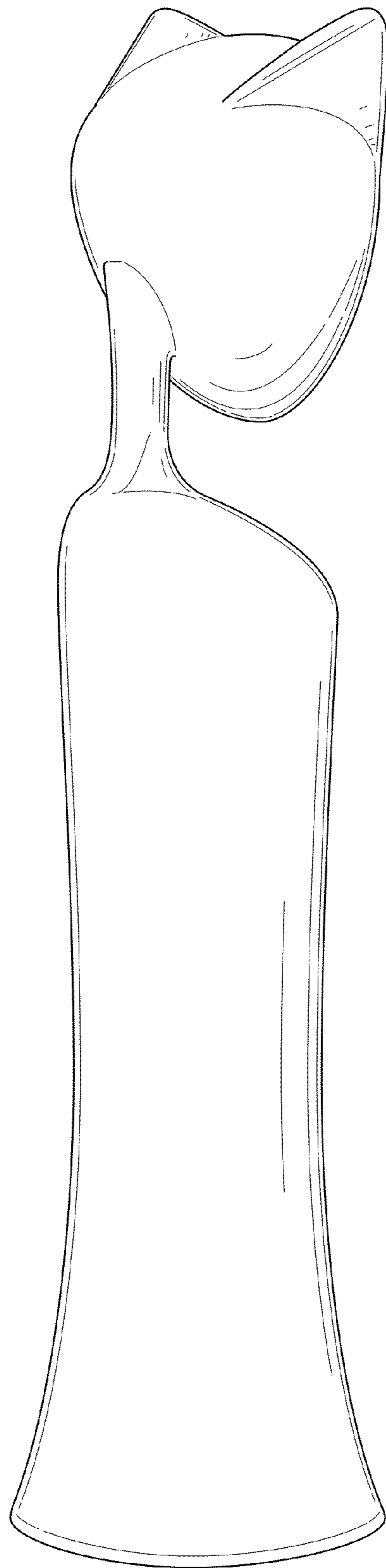
FIG. 1 is a top, right and front perspective view of a wireless speaker showing my new design;

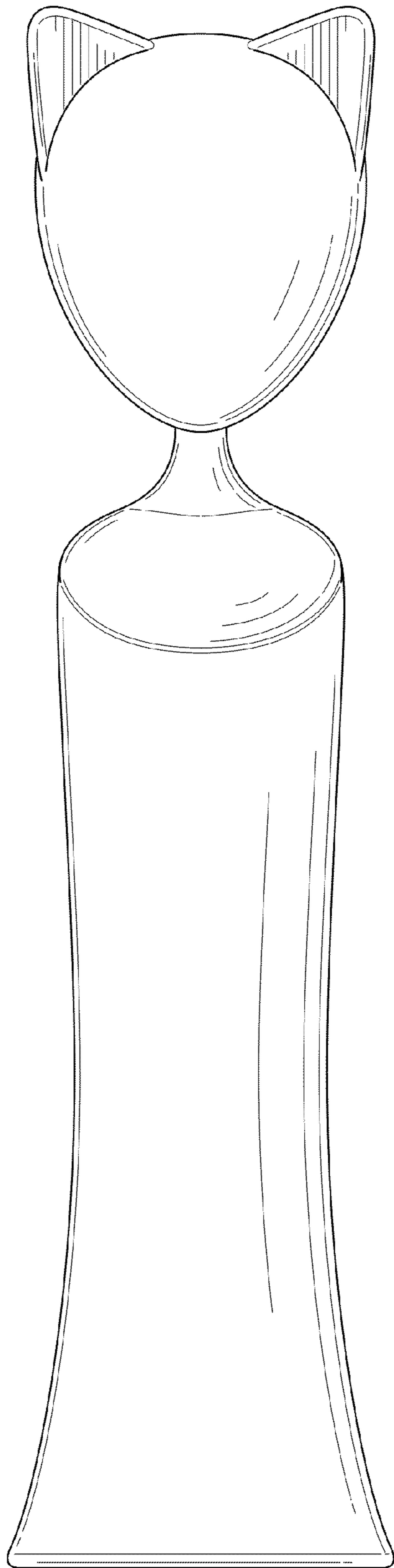

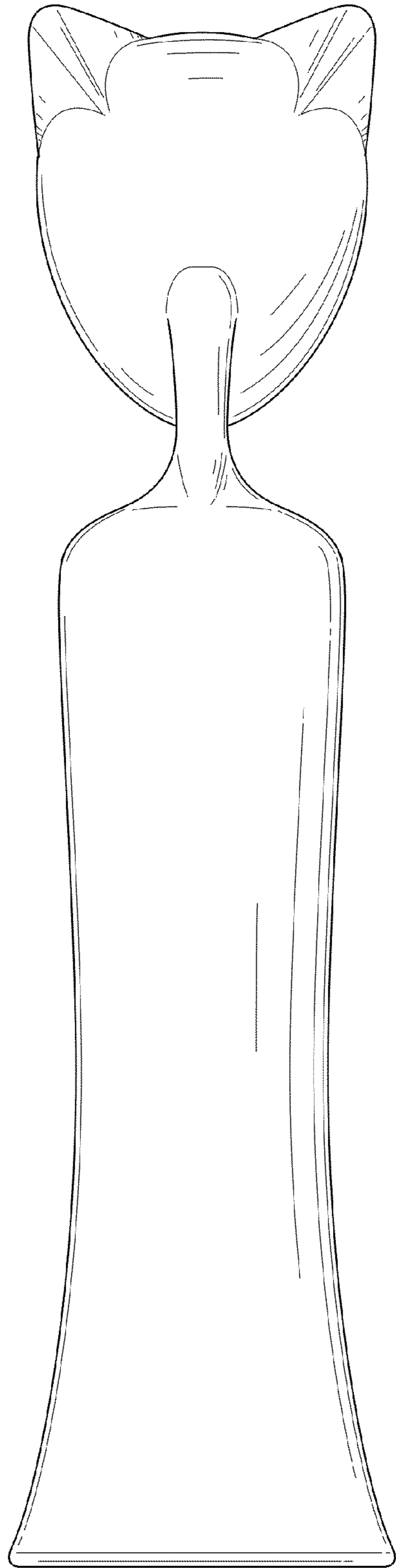
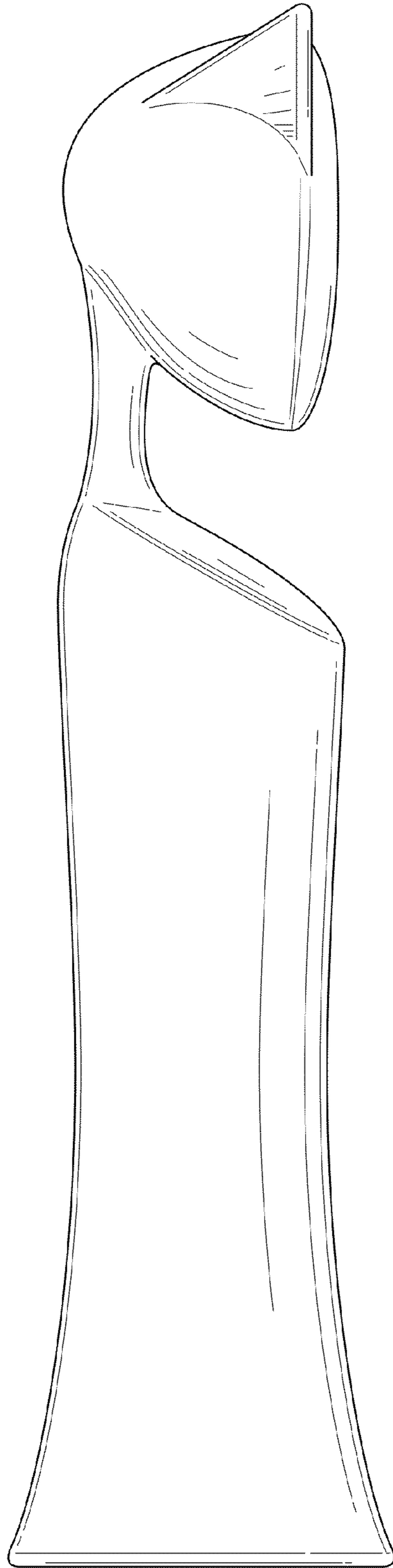
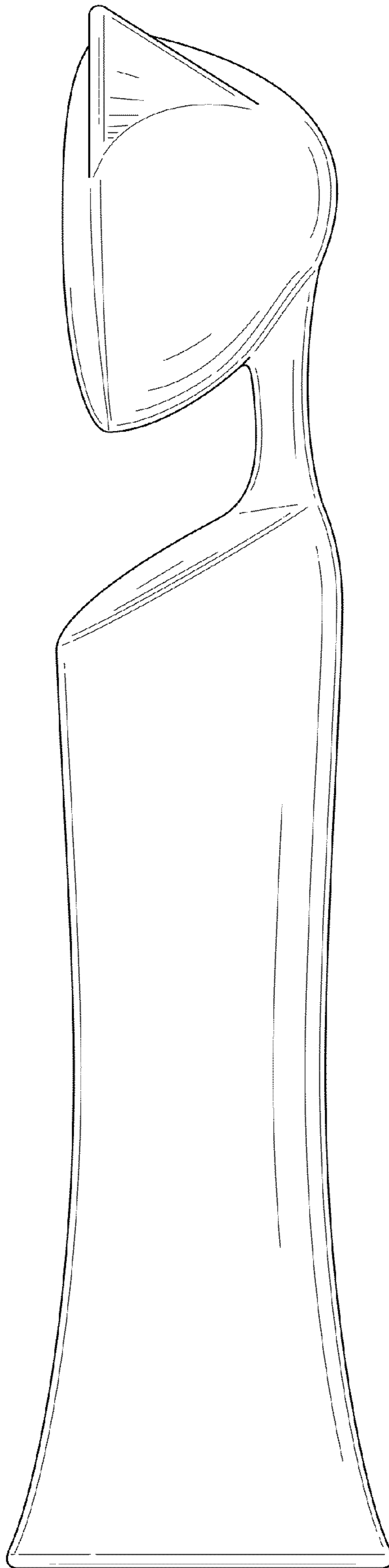

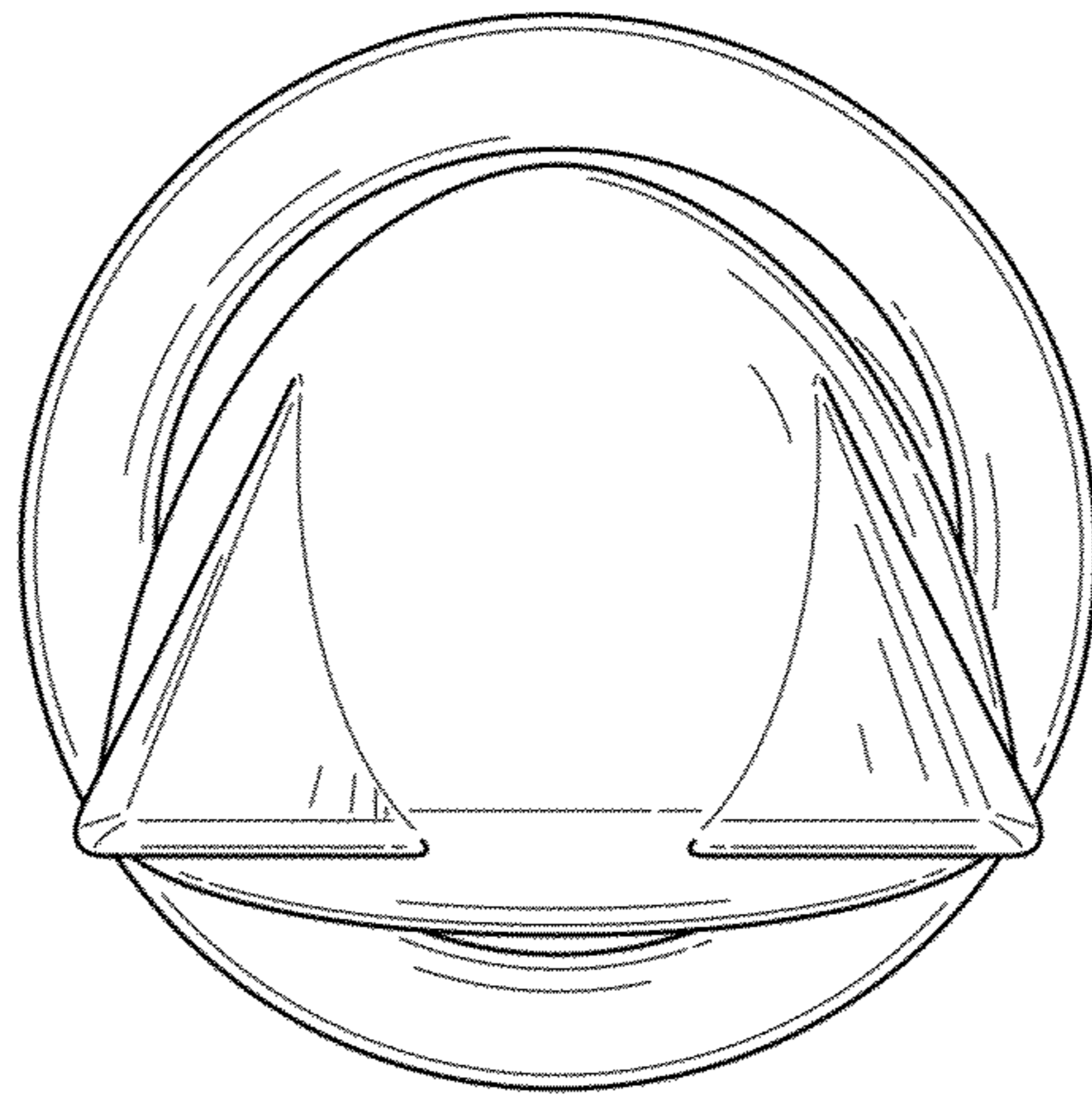
