The ornamental design for a case for electronic devices, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a case for electronic devices showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a right side elevational view thereof;
FIG. 7 is a left side elevational view thereof; and,
FIG. 8 is an exploded view thereof in which the components of the case are shown separated for clarity of disclosure.

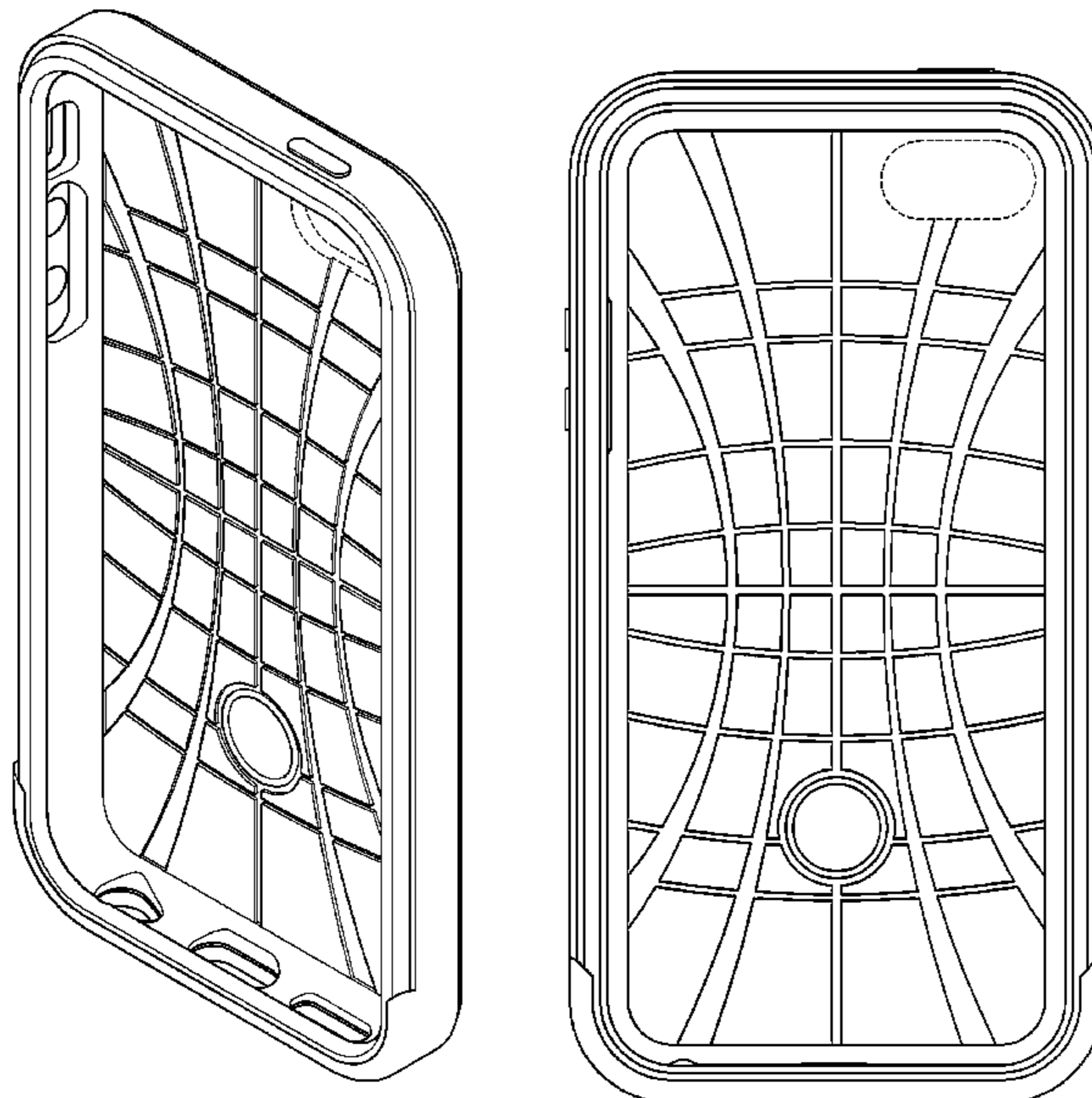

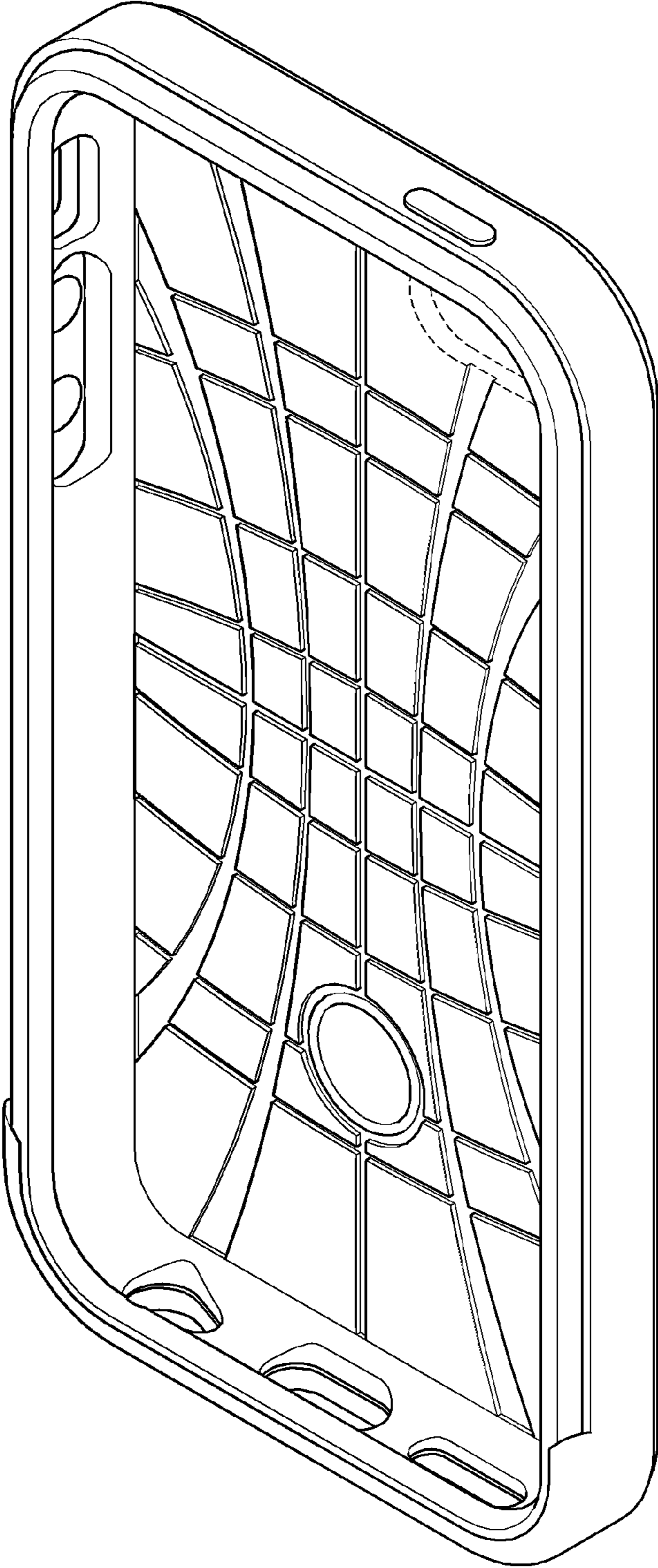

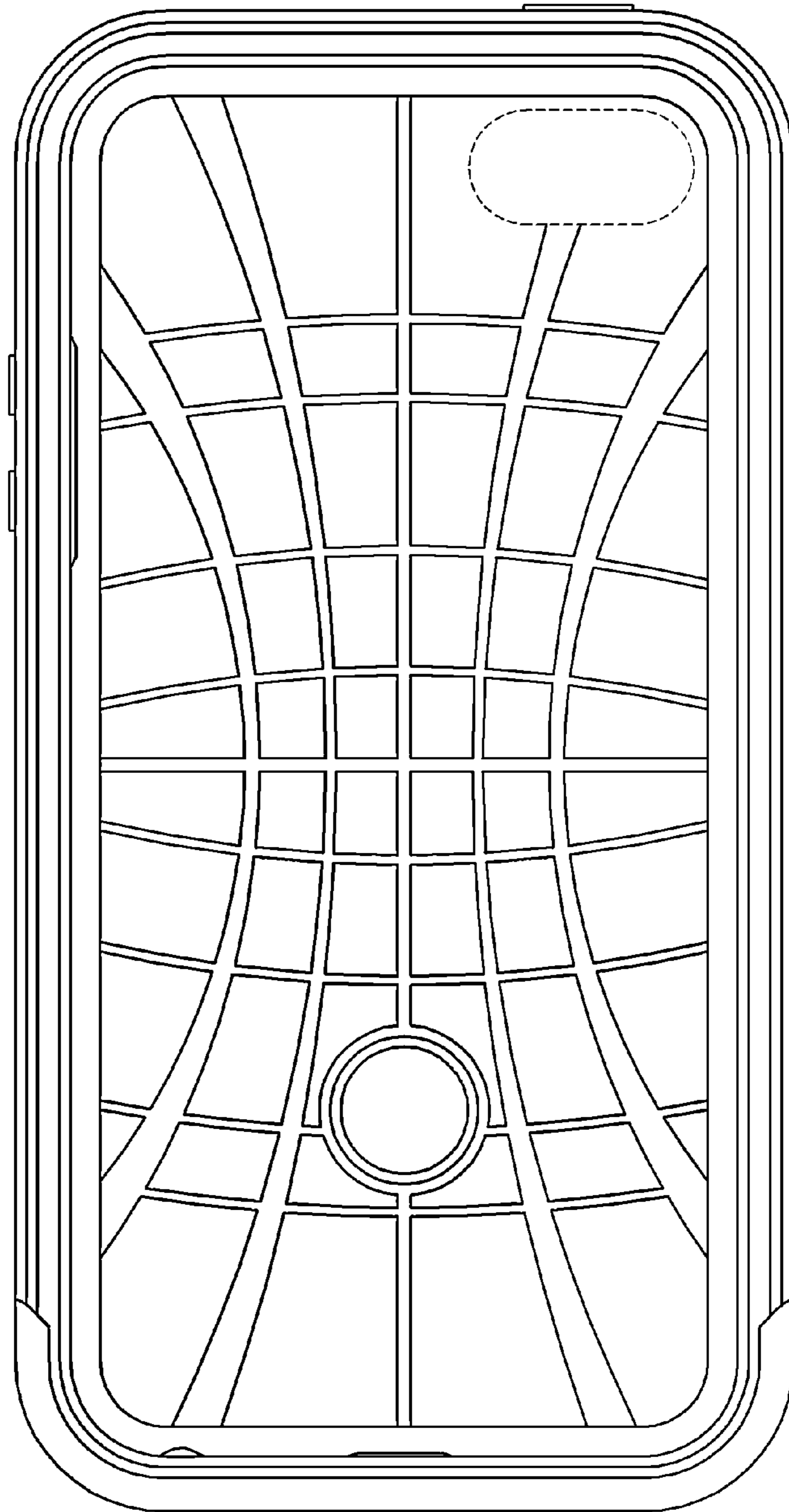

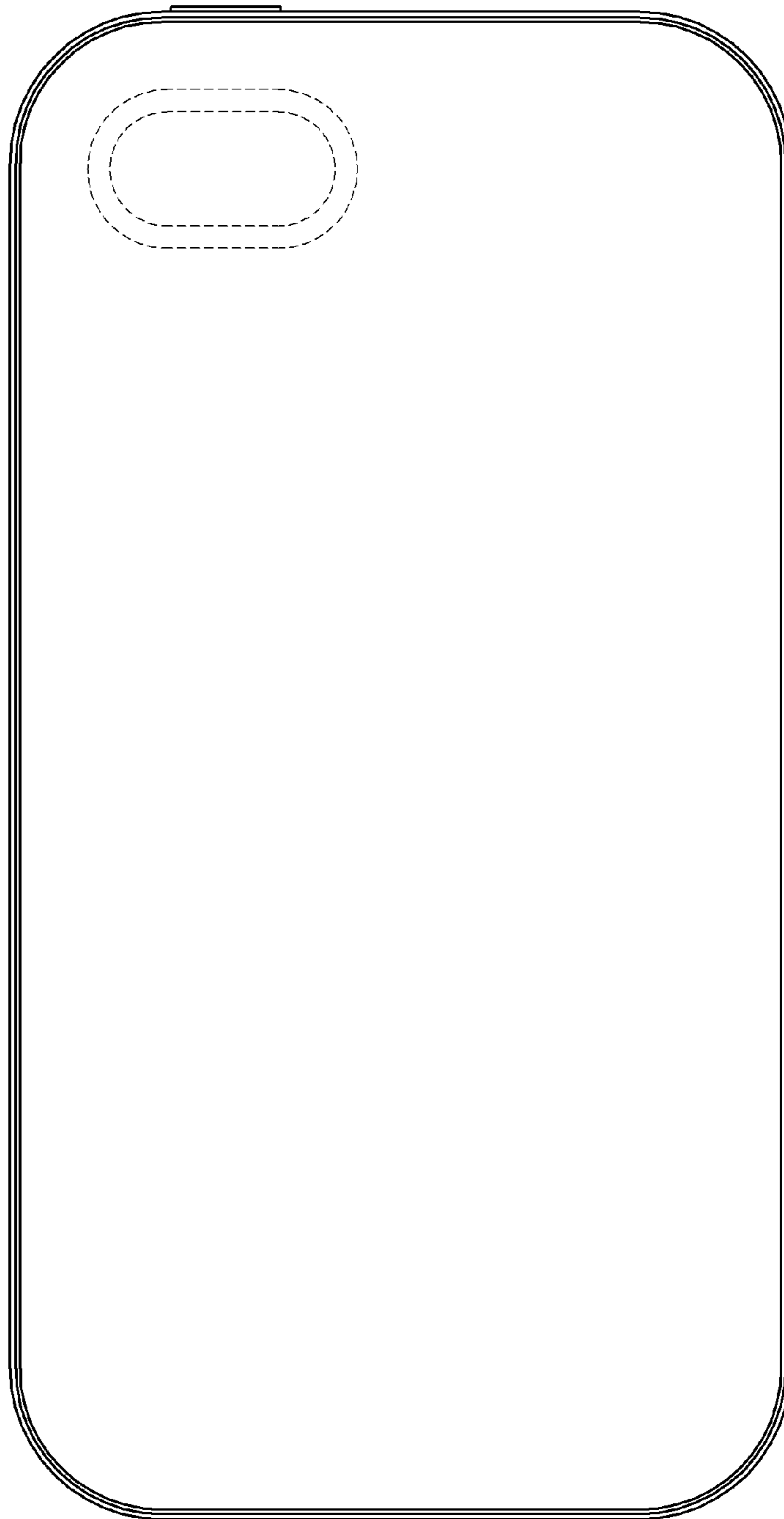

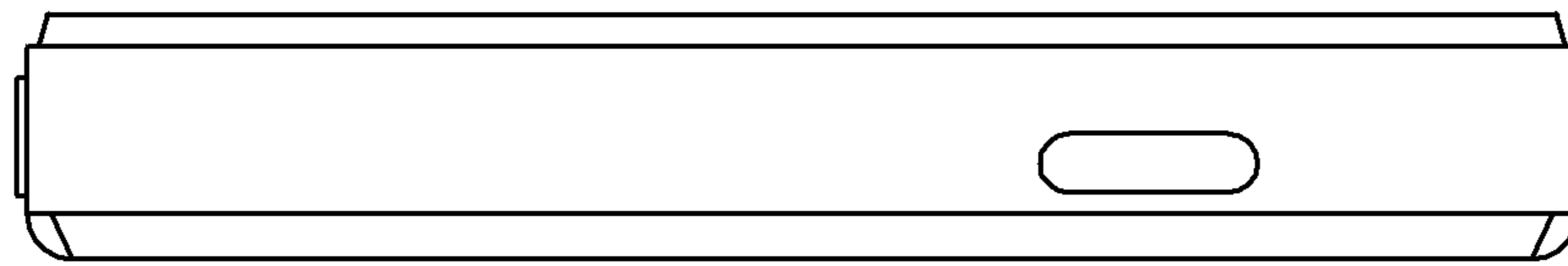

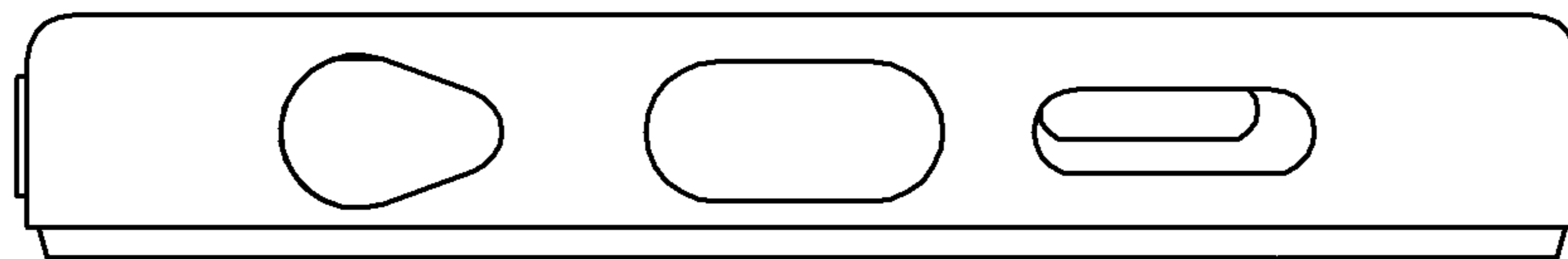

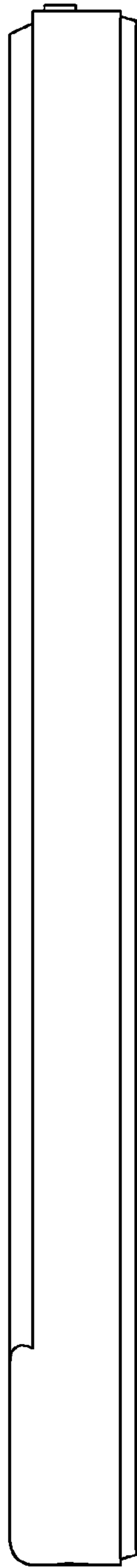

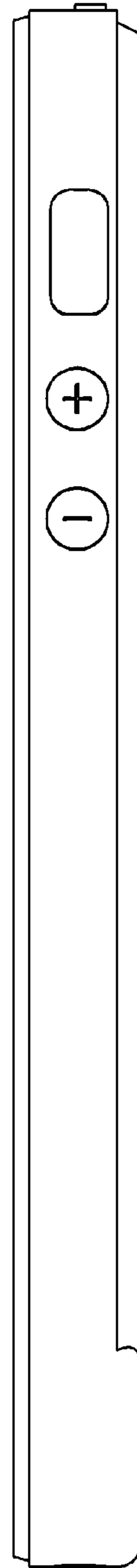
