(57) **CLAIM**

I claim the ornamental design for a cultivating cutting disc, as shown.

DESCRIPTION

FIG. 1 is a perspective view of a cultivating cutting disc of the present invention;

FIG. 2 is an enlarged detail view taken from portion 'II' in FIG. 1;

FIG. 3 is a front view thereof;

FIG. 4 is a rear view thereof;

FIG. 5 is a left side view thereof;

FIG. 6 is a right side view thereof;

FIG. 7 is a top view thereof; and,

FIG. 8 is a bottom view thereof.

The dashed lines in the drawings depict unclaimed portions of the cultivating cutting disc and form no part of the claimed design.

The dot-dash lines define the bounds of the claimed design and form no part thereof.

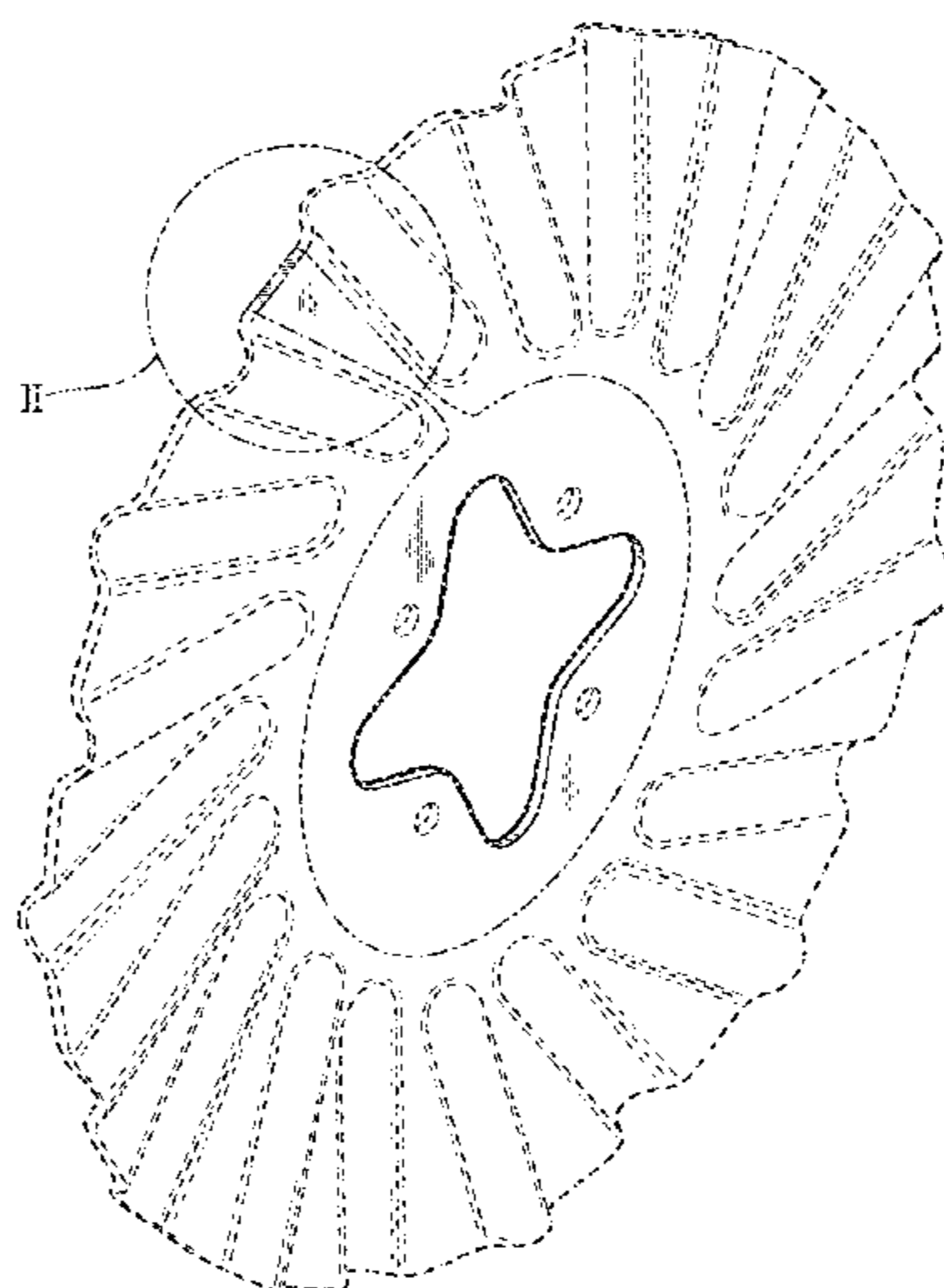
The dot-dot-dash lines depict the locations and borders of detail views and form no part of the claimed design.

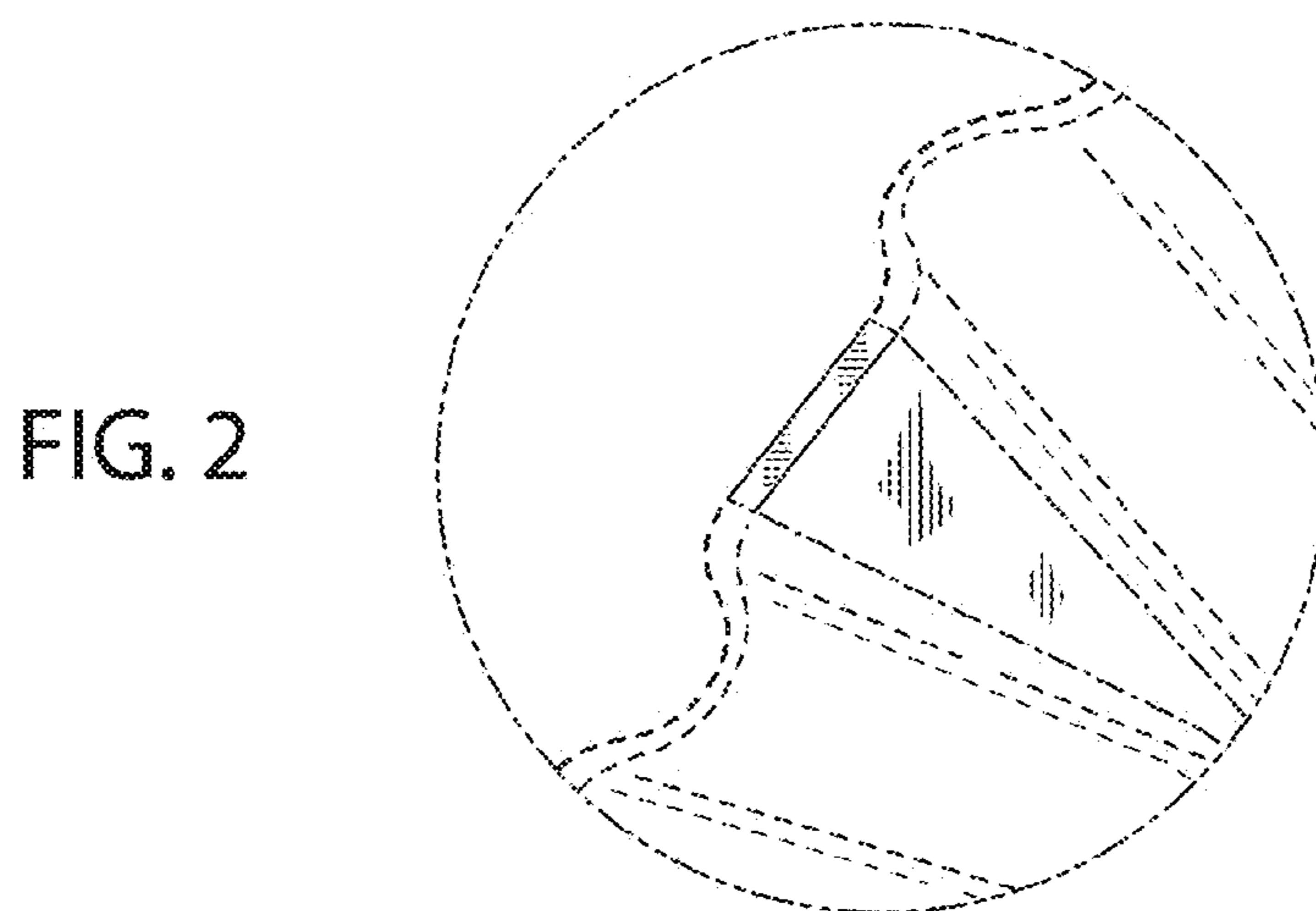
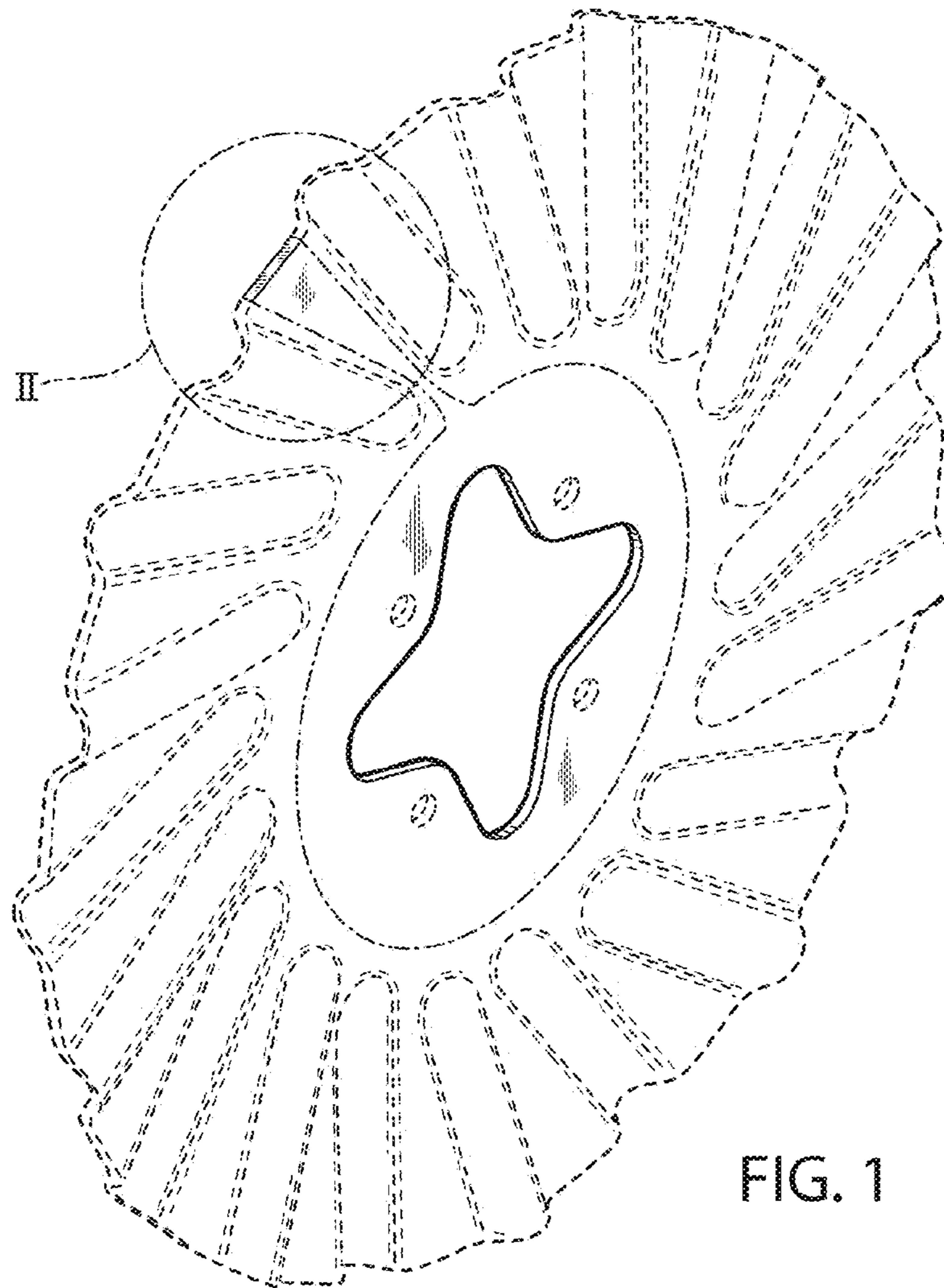

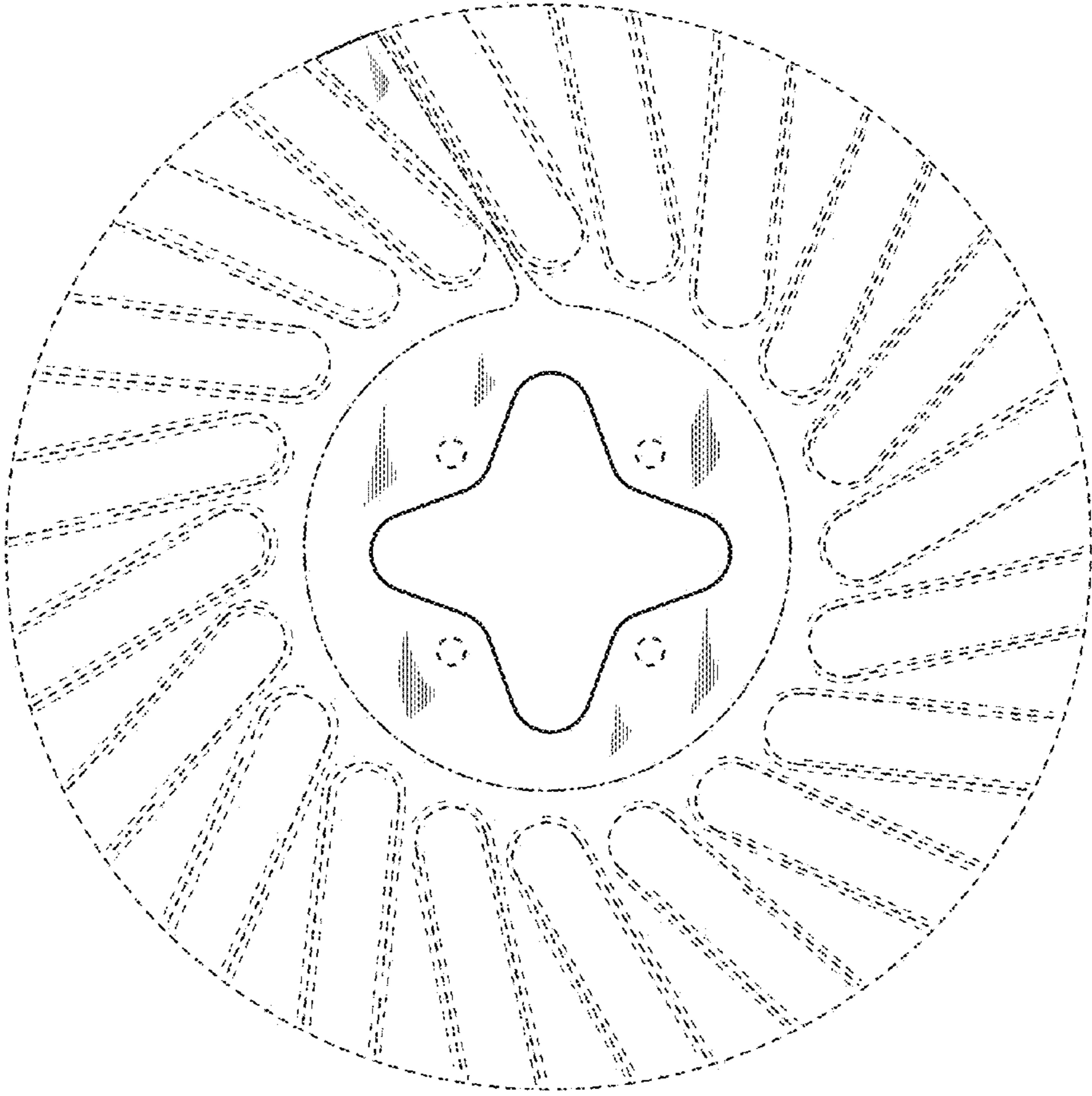

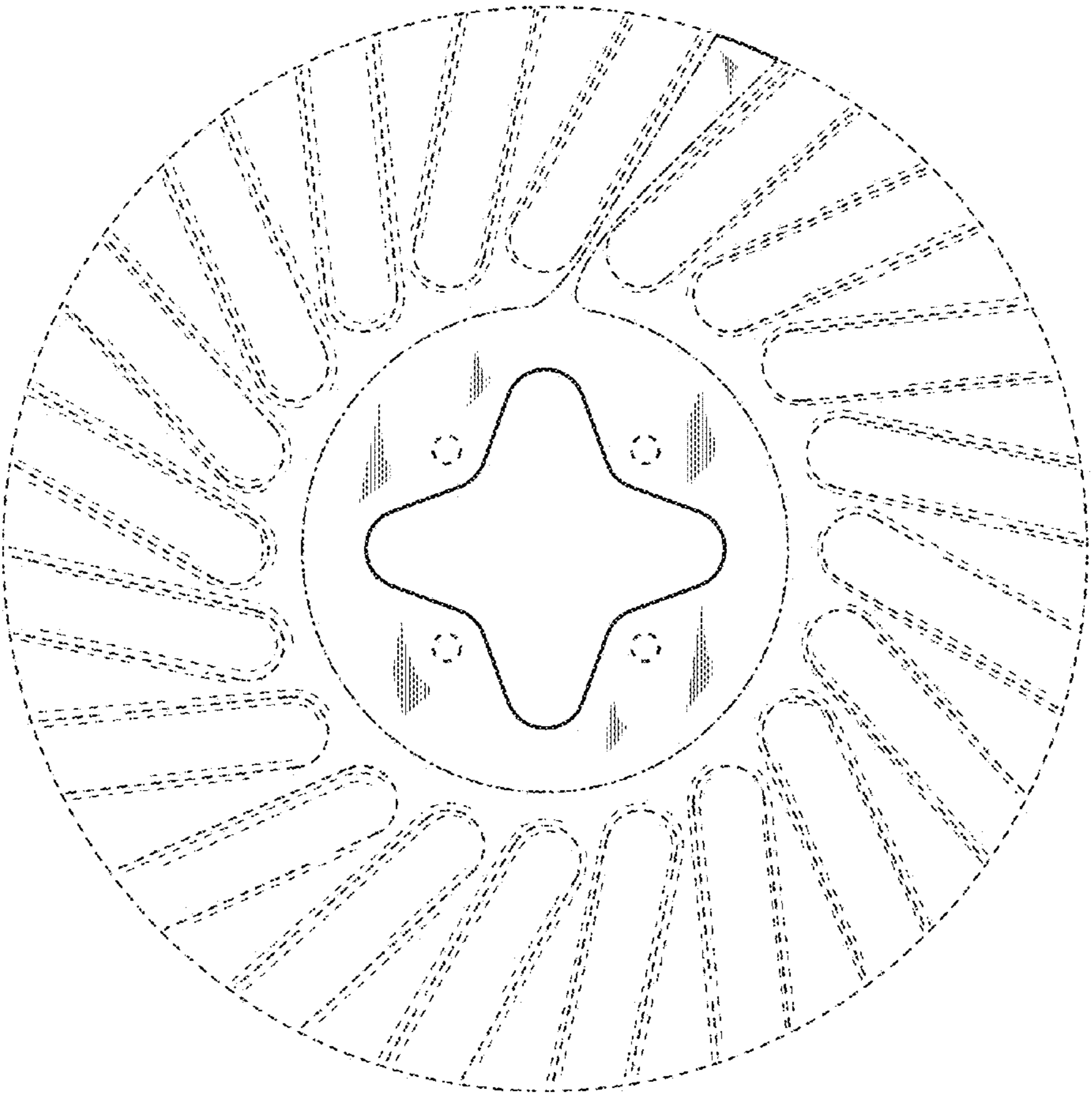

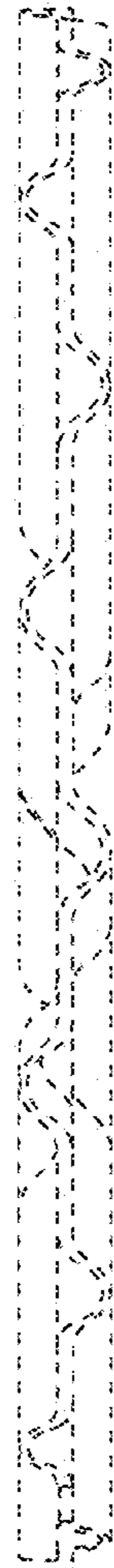

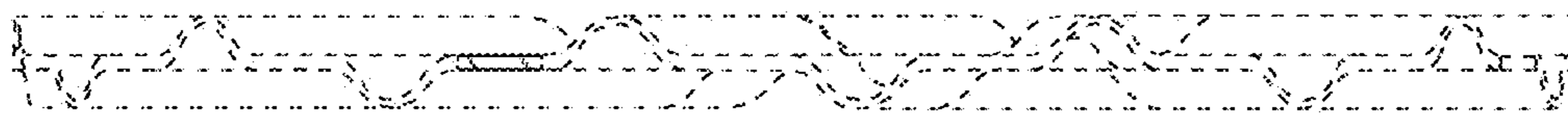

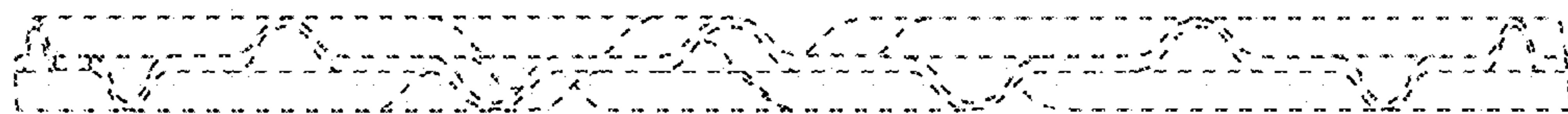
