DESCRIPTION

FIG. 1 is the front perspective view of a flashlight showing our new design;

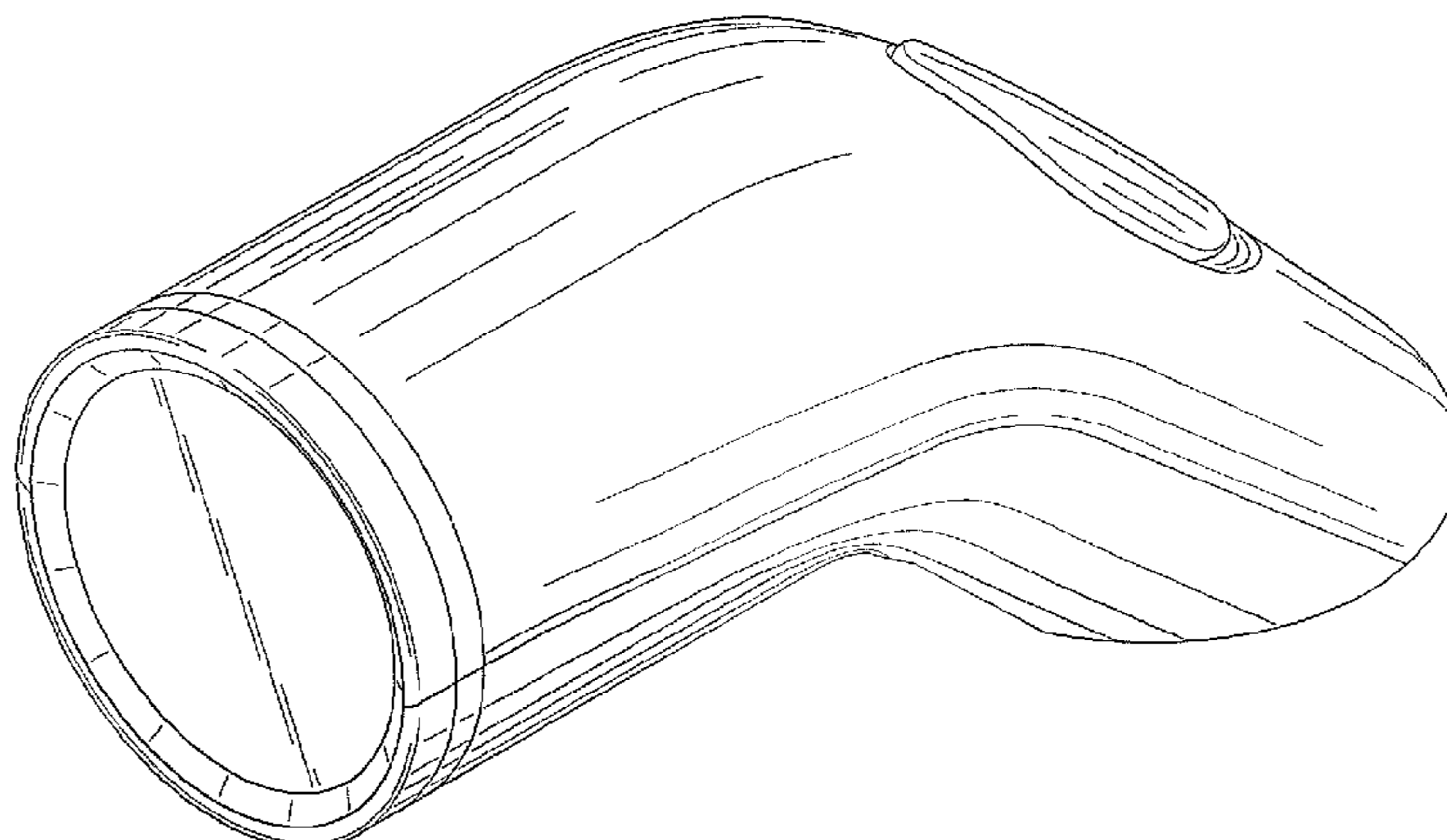

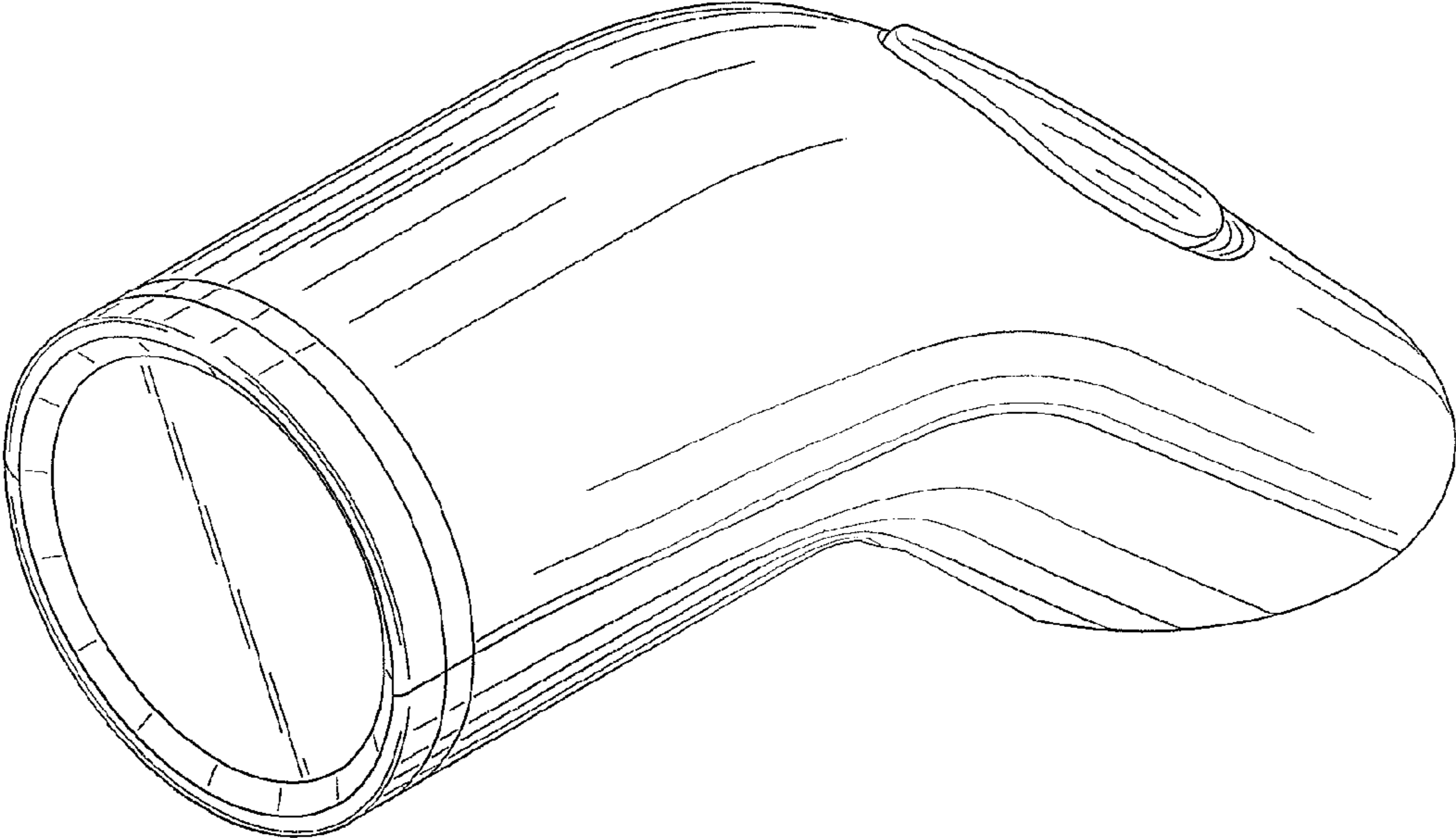

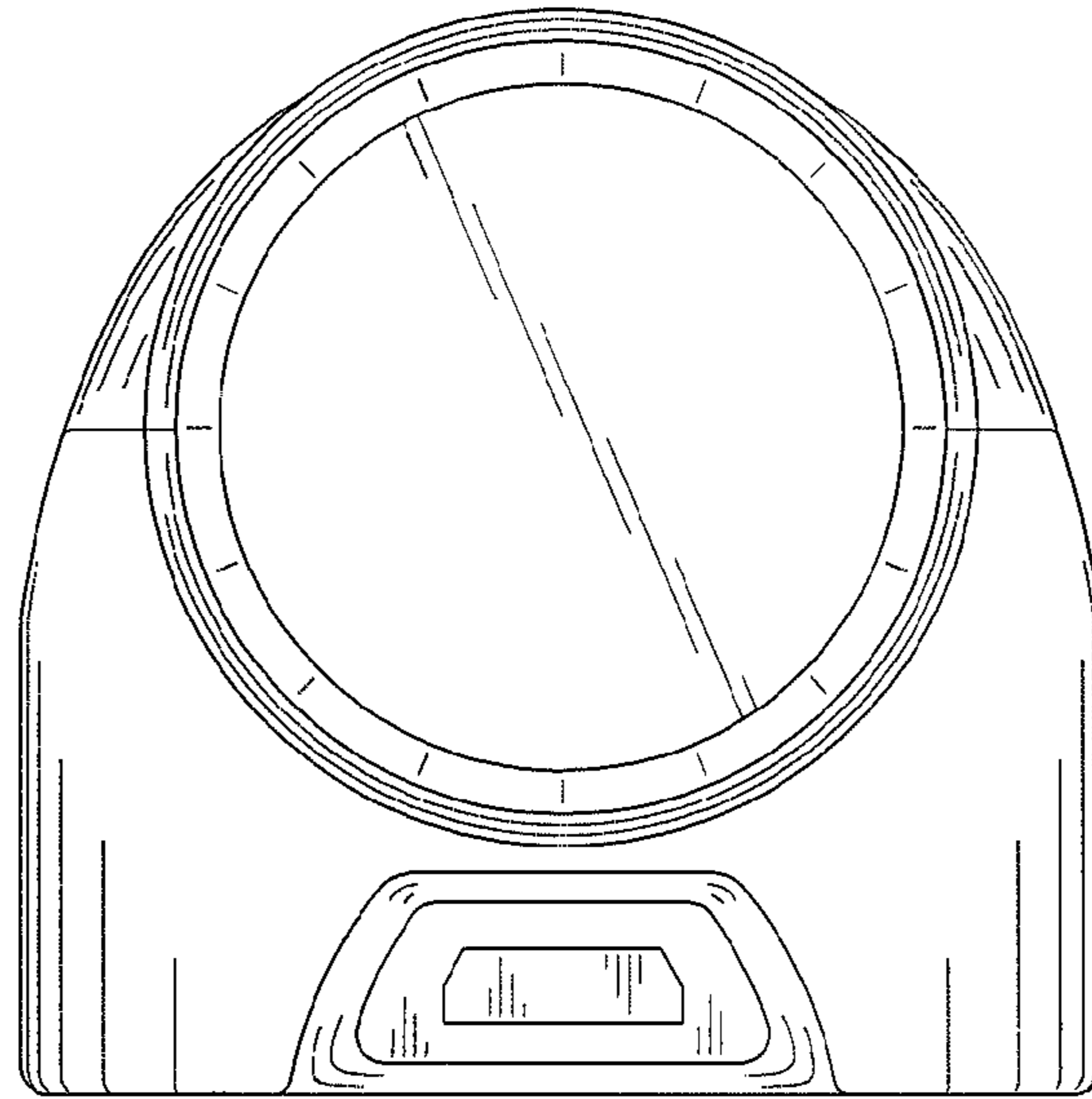

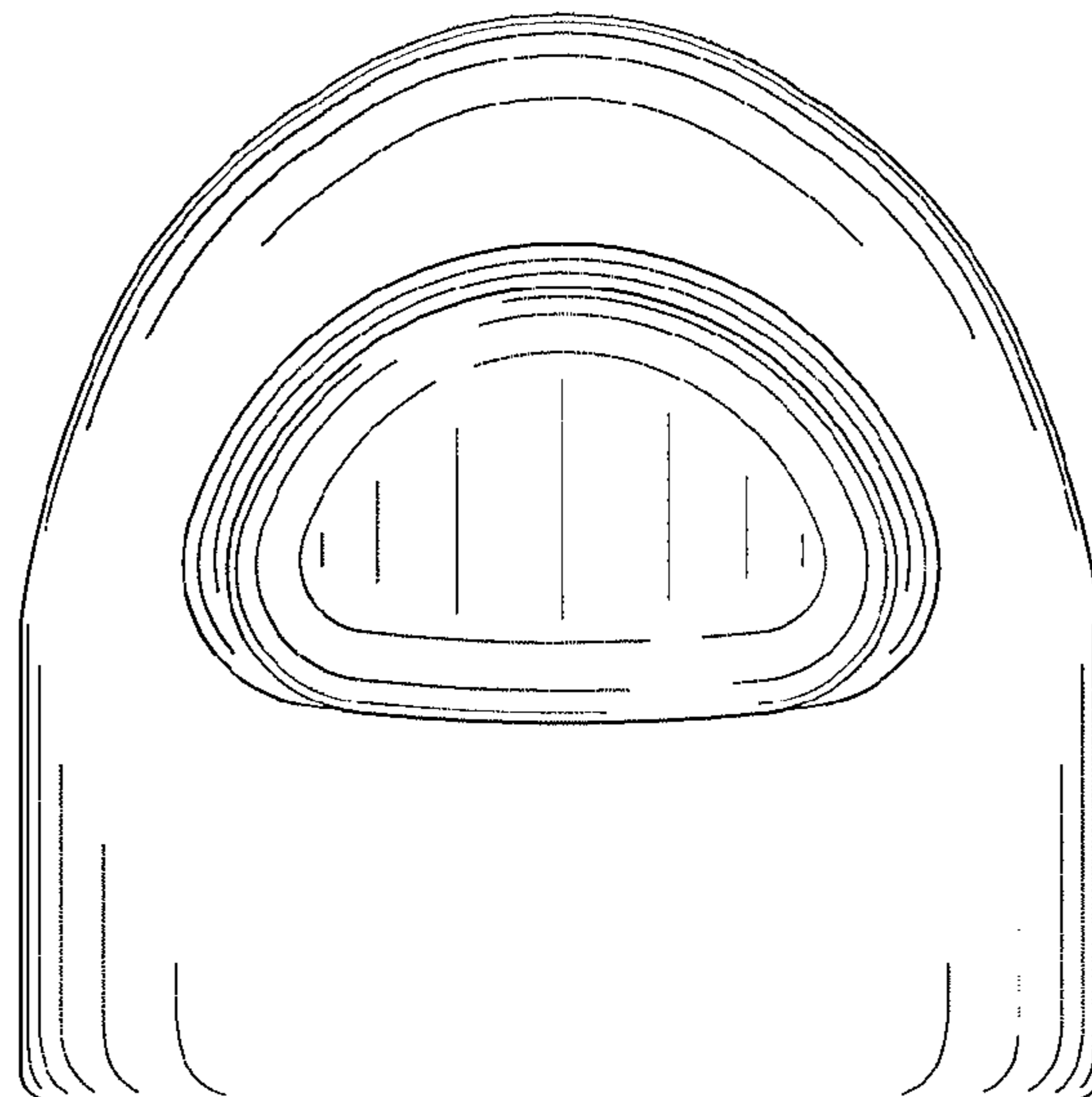

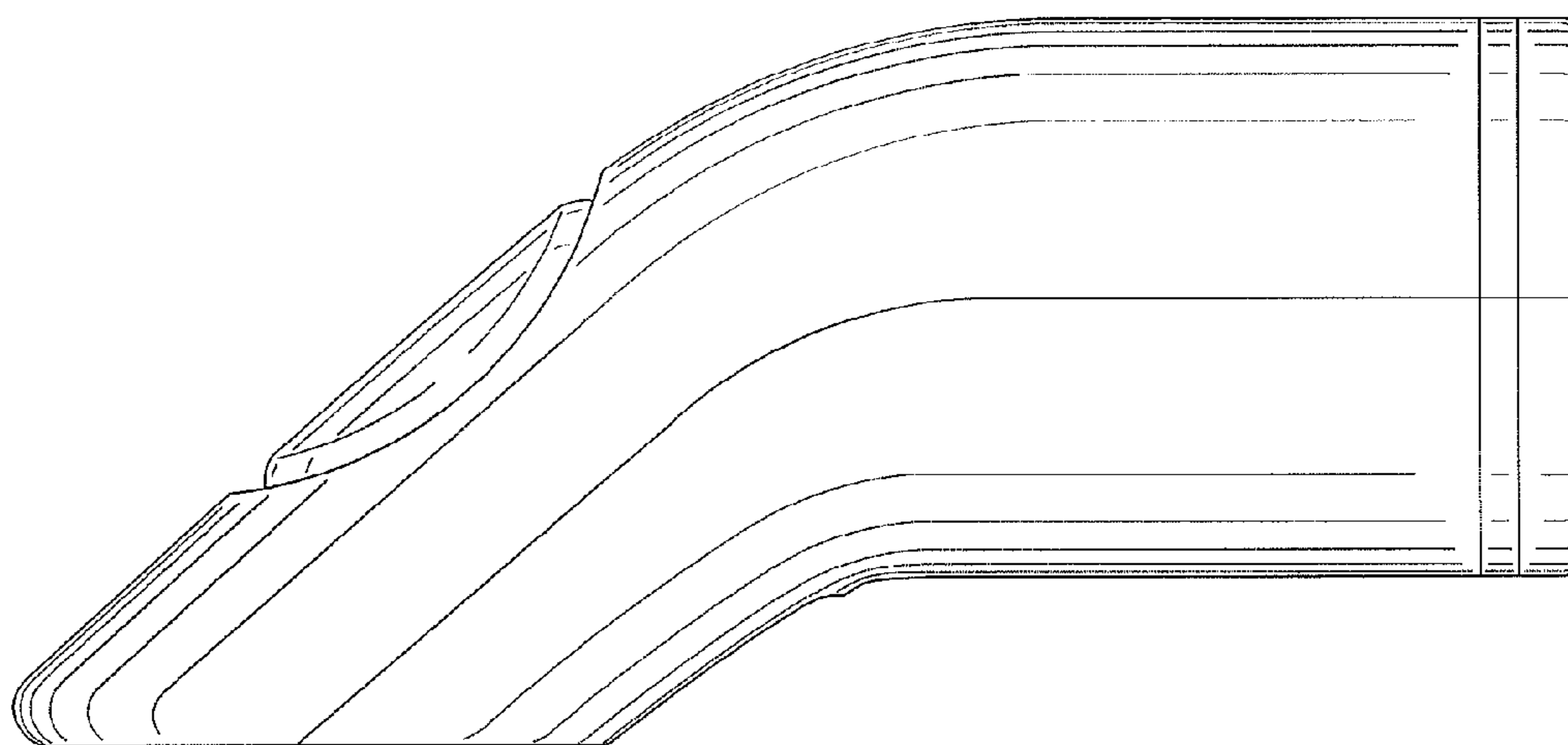

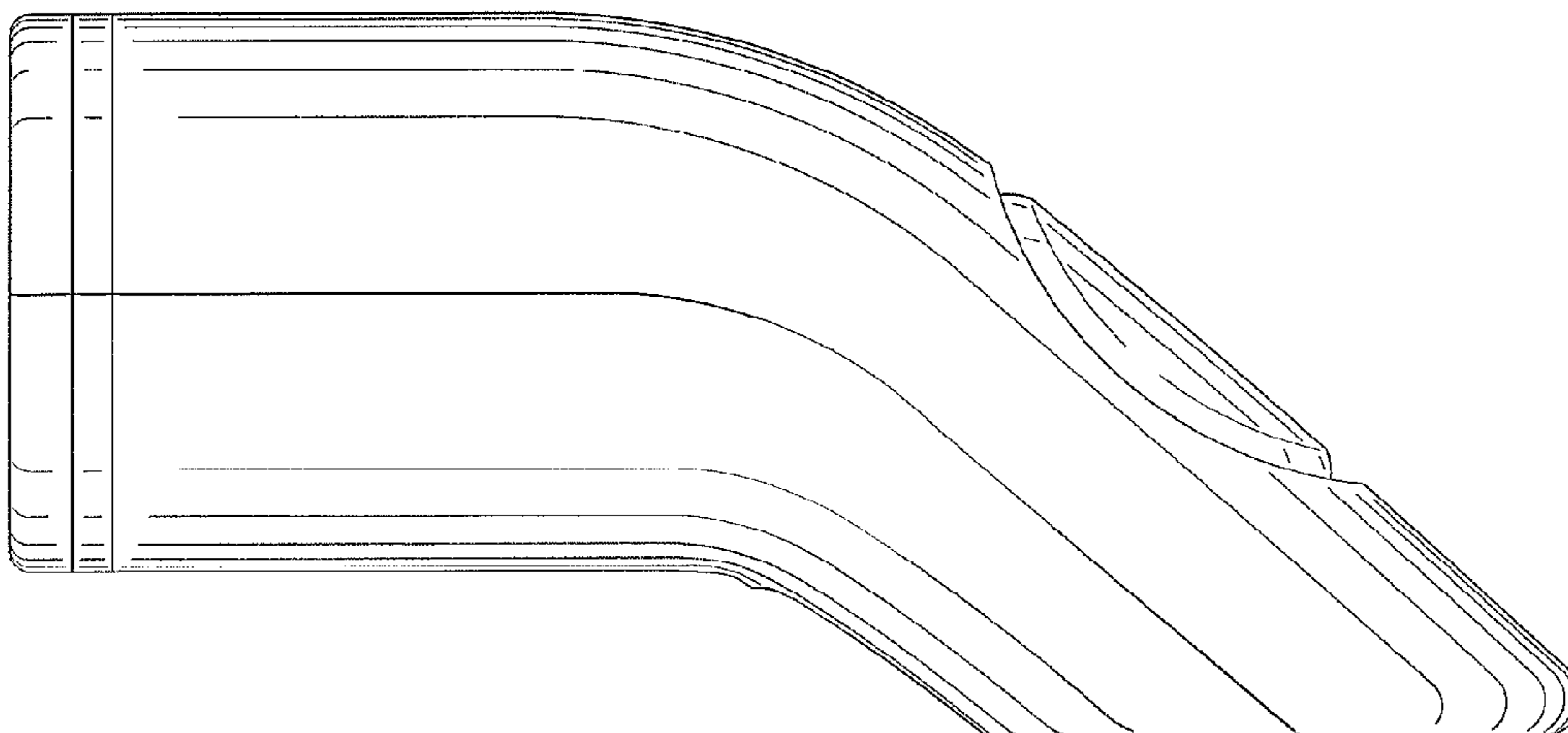

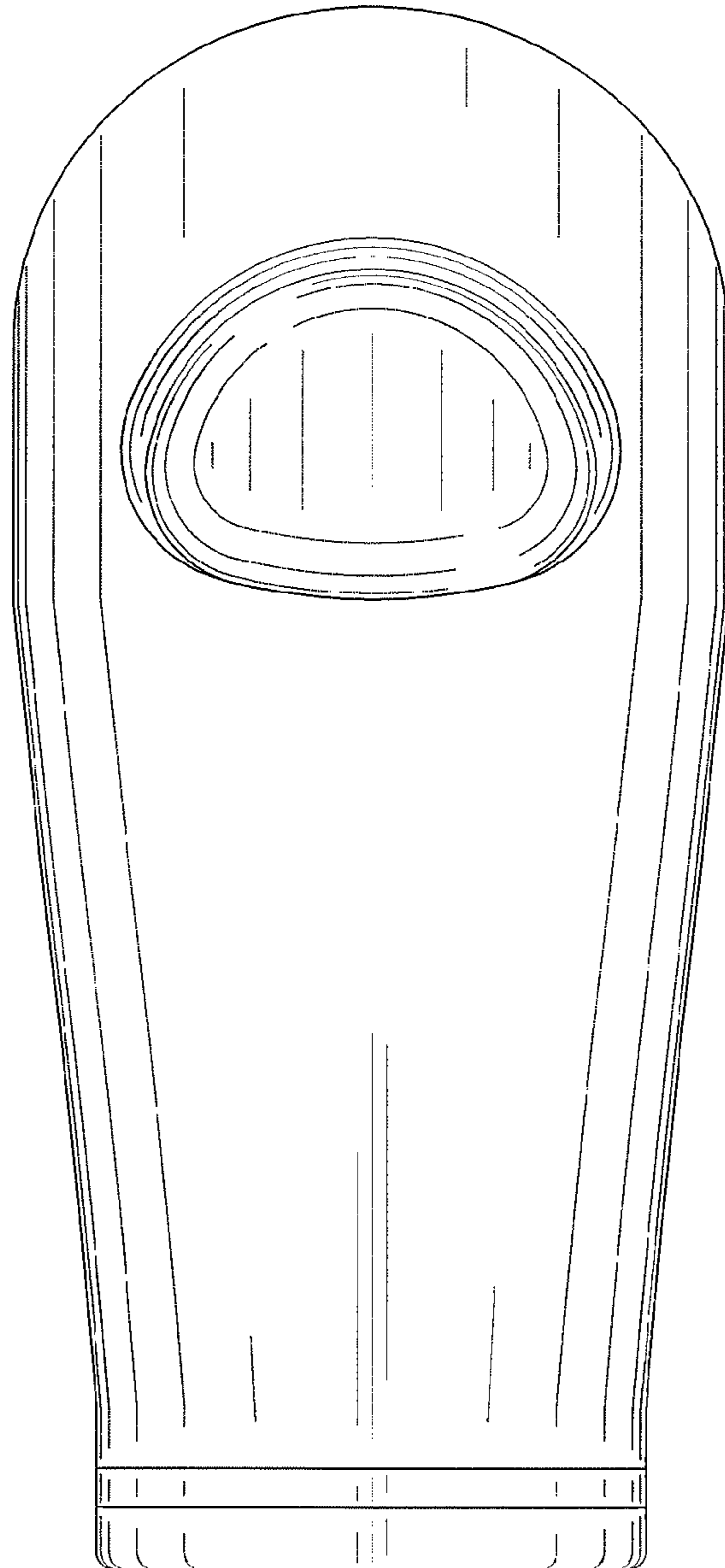

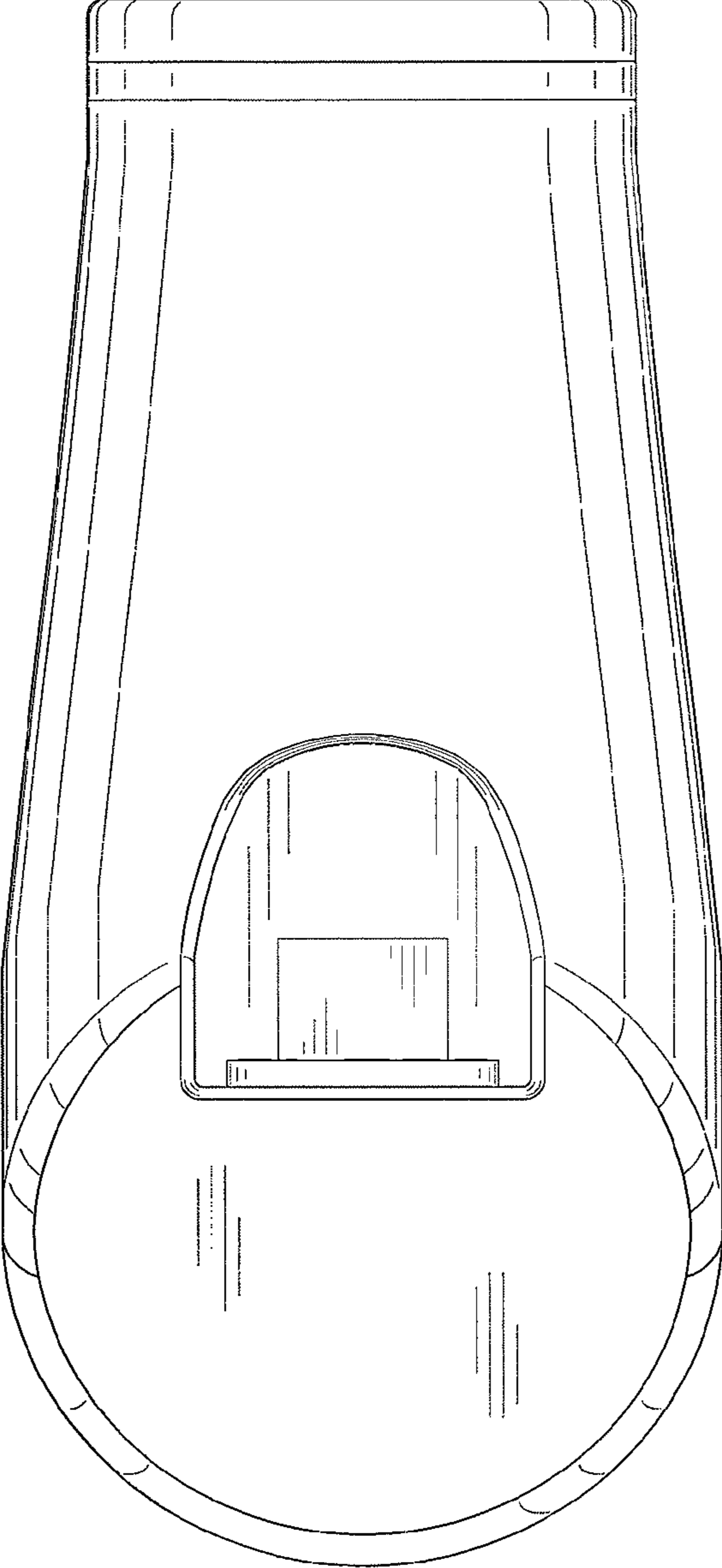
