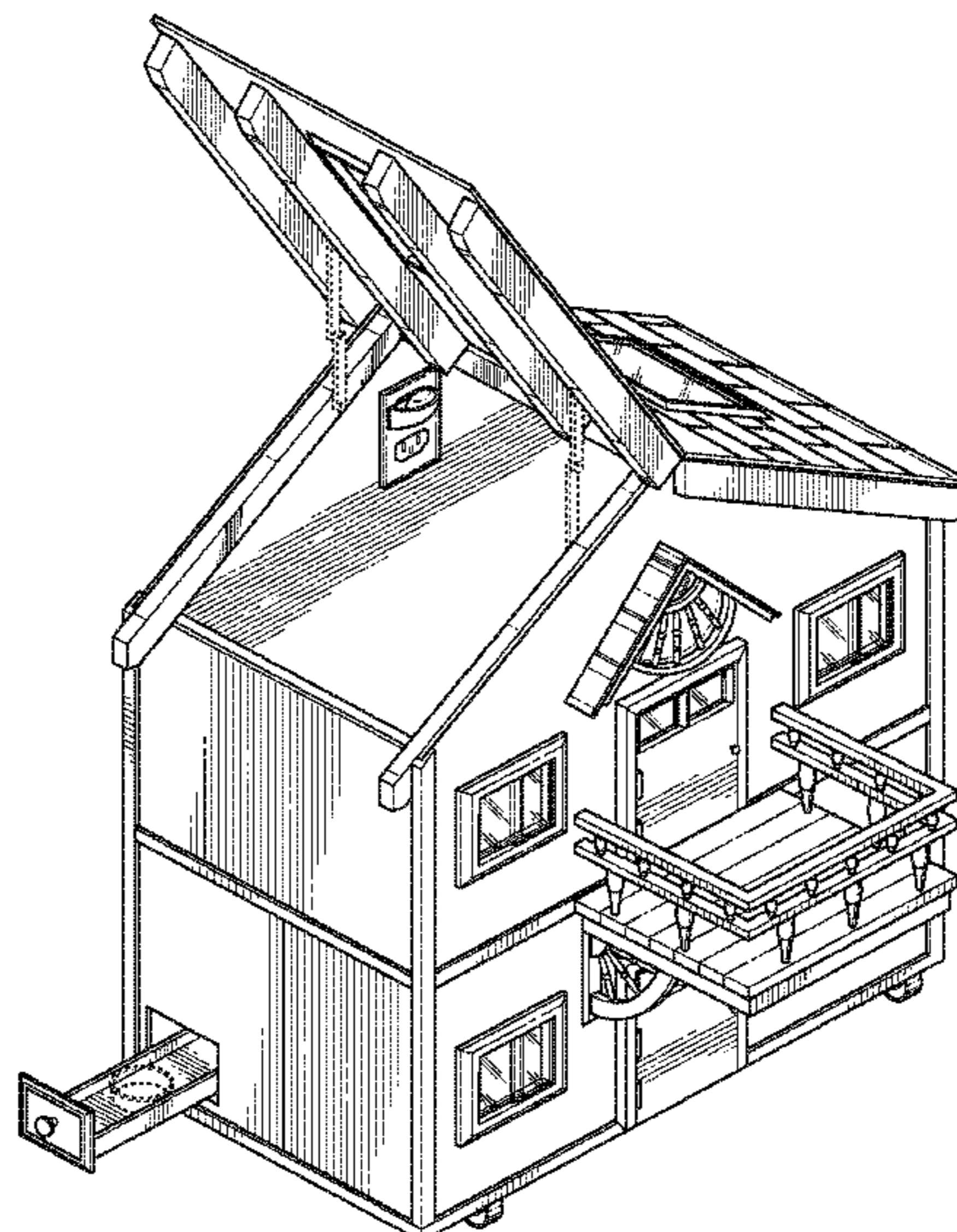
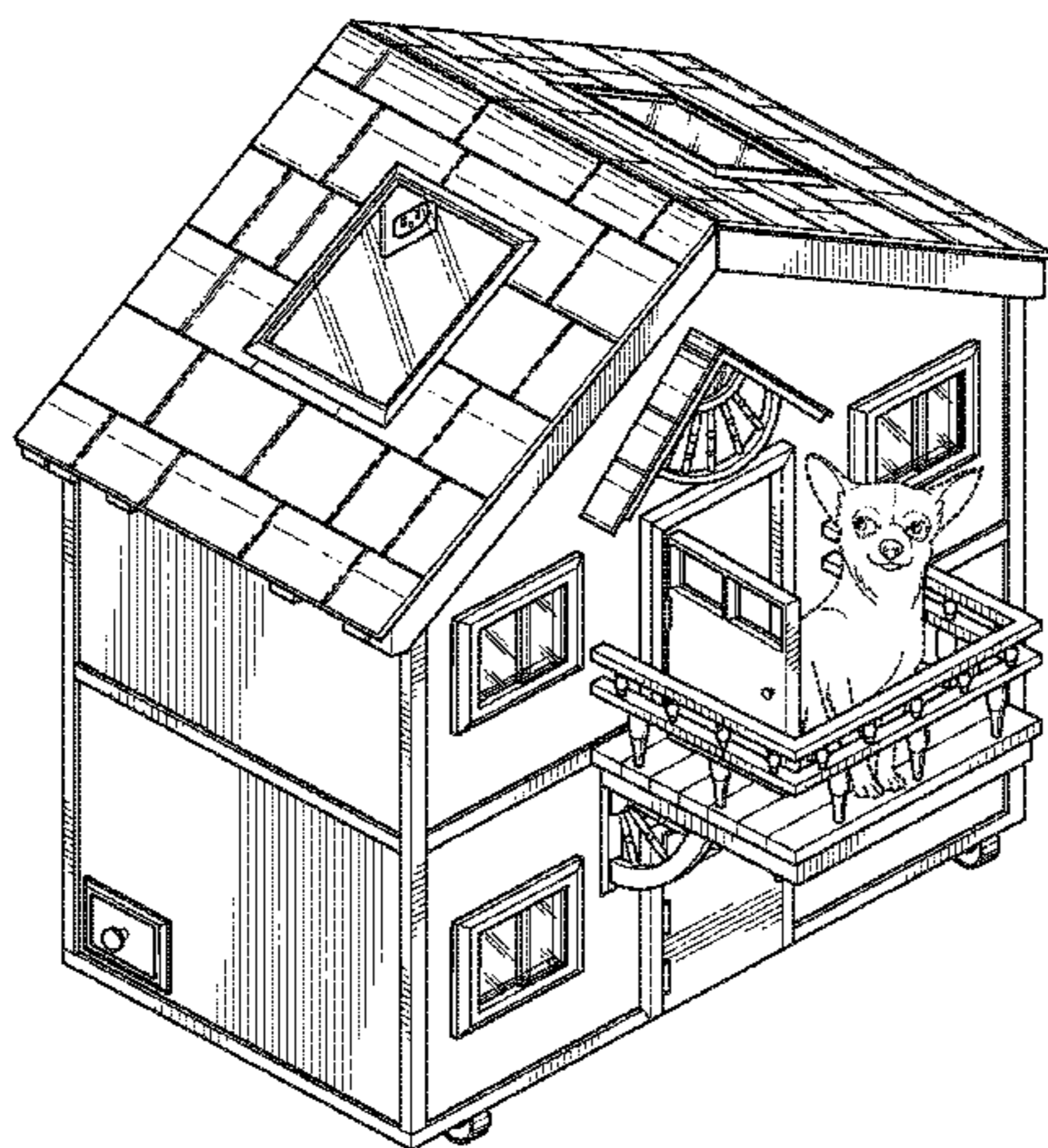
I claim the ornamental design for a home for pets, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the home for pets showing the door to the balcony in an open position;
 FIG. 2 is a perspective view thereof showing the door to the balcony in a closed position;
 FIG. 3 is a left side elevational view thereof;
 FIG. 4 is a right side elevational view thereof;
 FIG. 5 is a front elevational view thereof;
 FIG. 6 is a rear elevational view thereof;
 FIG. 7 is a bottom plan view thereof;
 FIG. 8 is a perspective view thereof showing the roof pivoted to an open position and the feeding tray opened to an extended position;
 FIG. 9 is a cross-section thereof taken along the line 9-9 in FIG. 3;
 FIG. 10 is a cross-section thereof taken along the line 10-10 in FIG. 4;
 FIG. 11 is a cross-section thereof taken along the line 11-11 in FIG. 5; and,
 FIG. 12 is a cross-section thereof taken along the line 12-12 in FIG. 6.

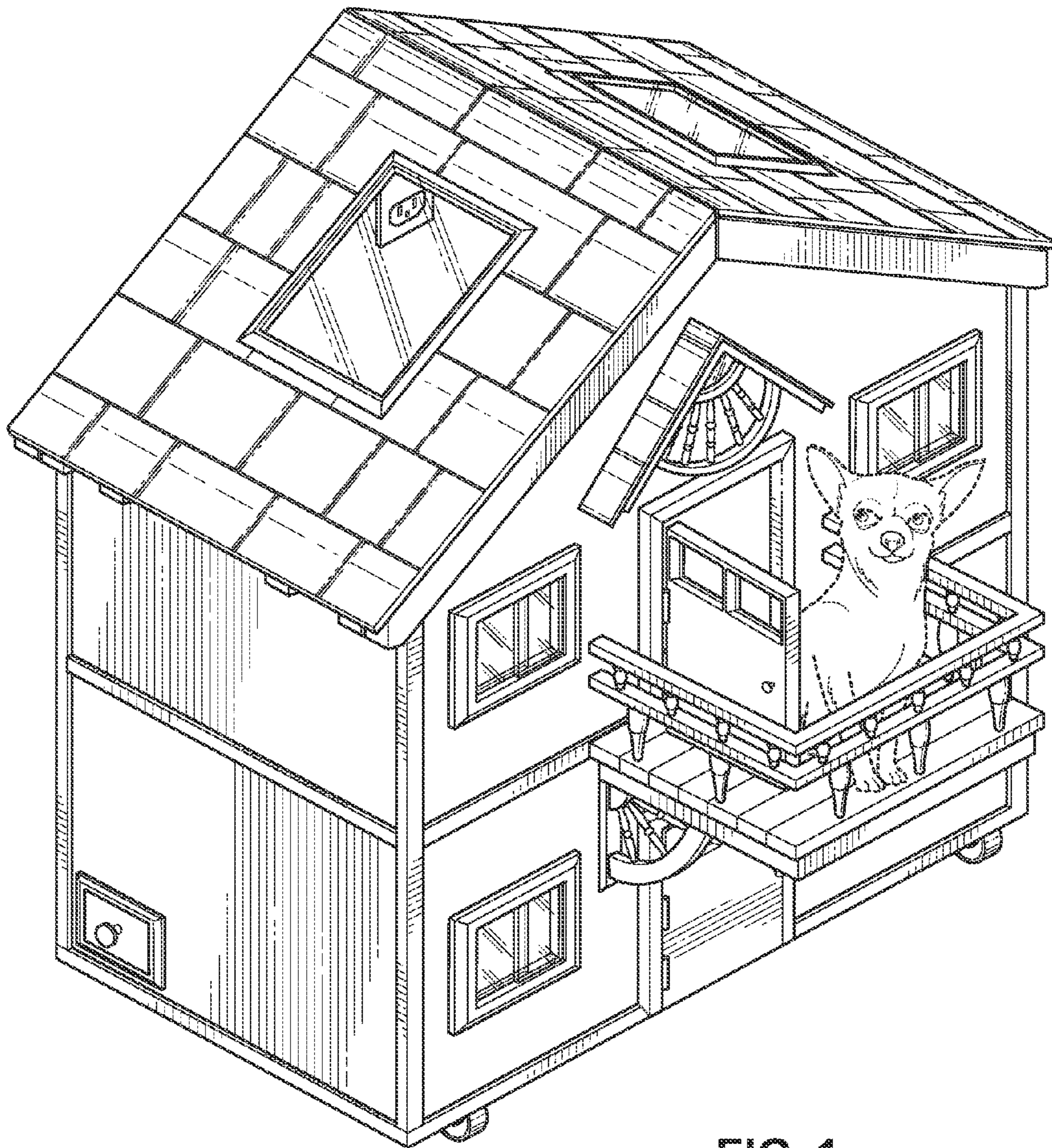

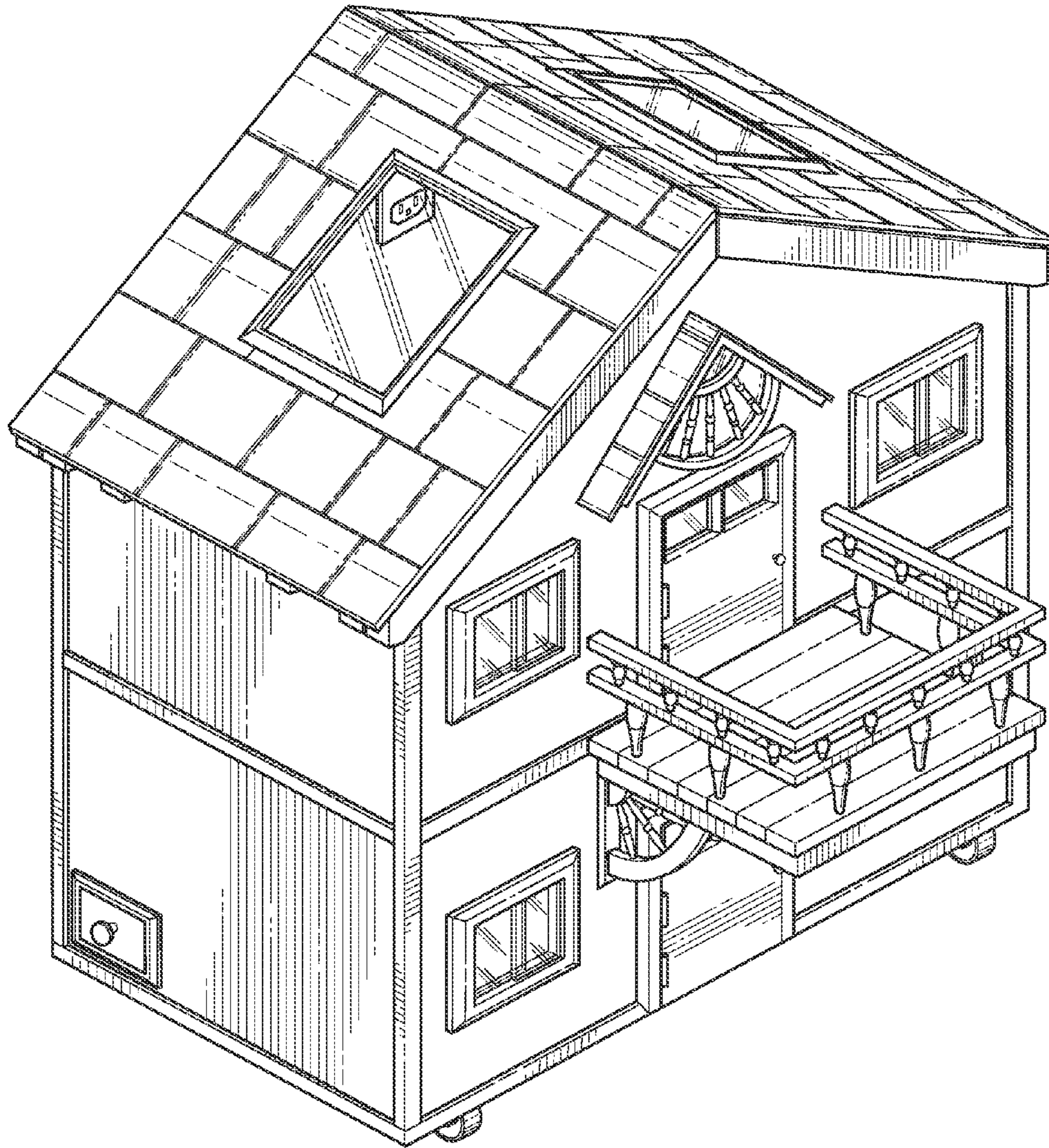

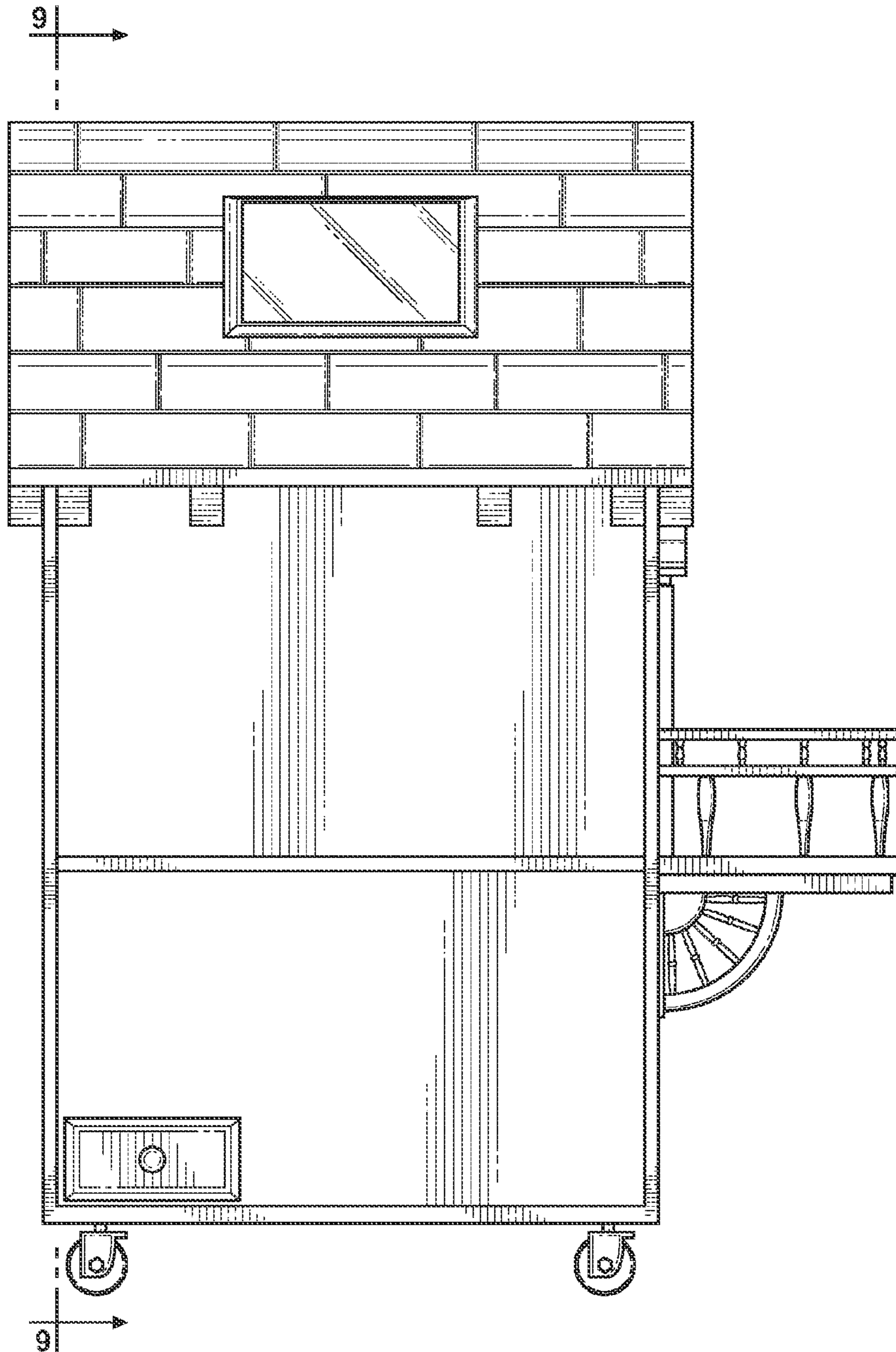

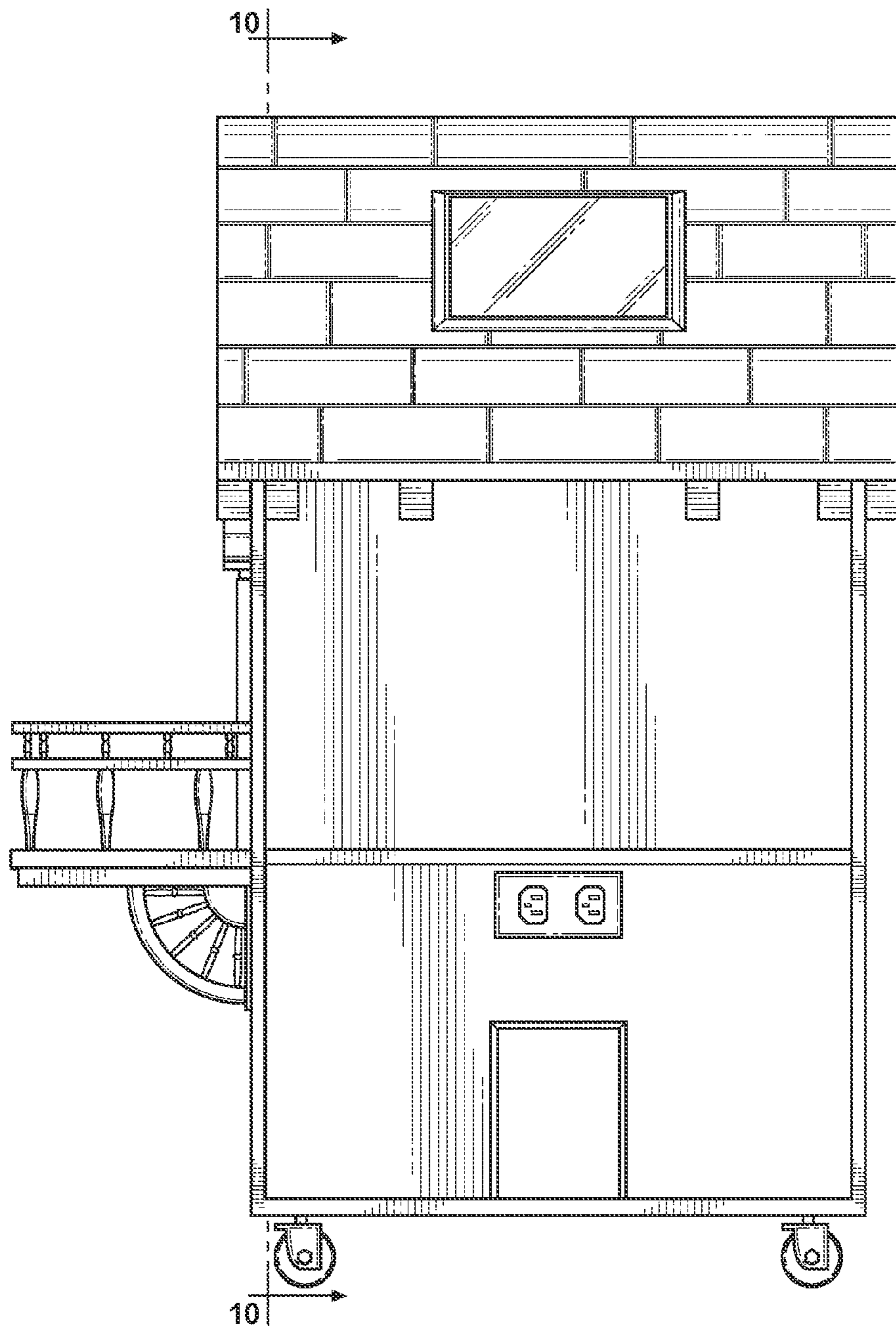

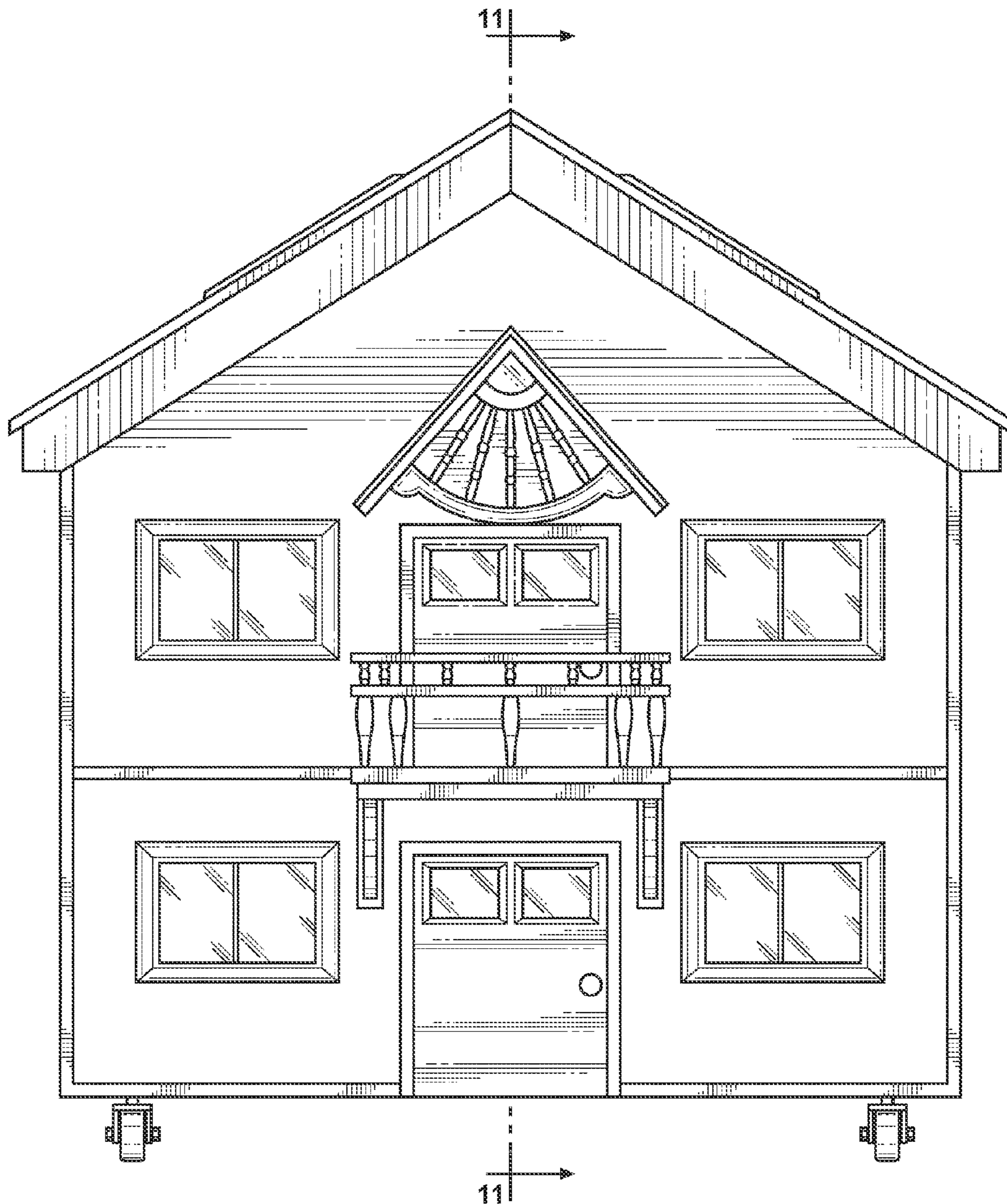

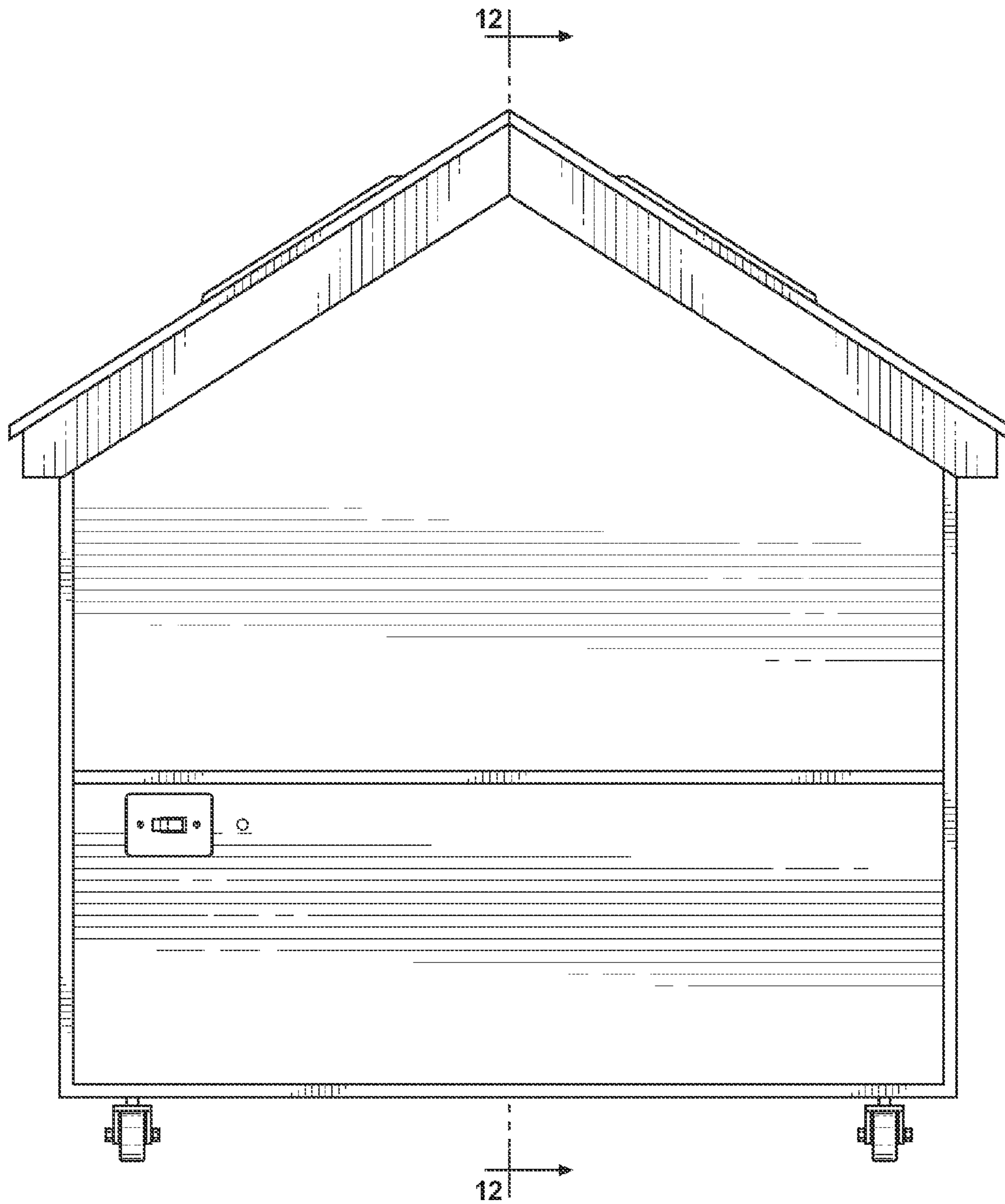

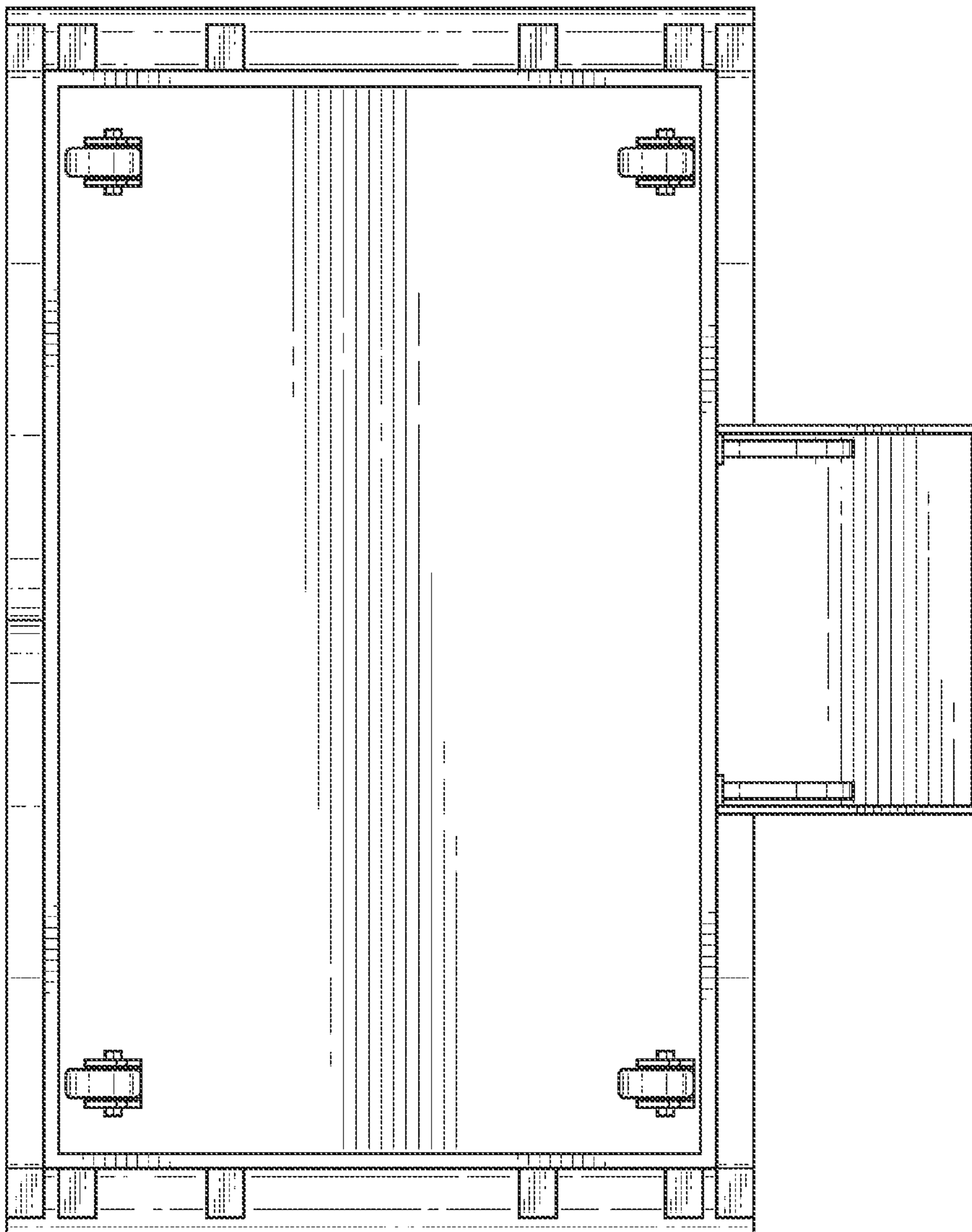

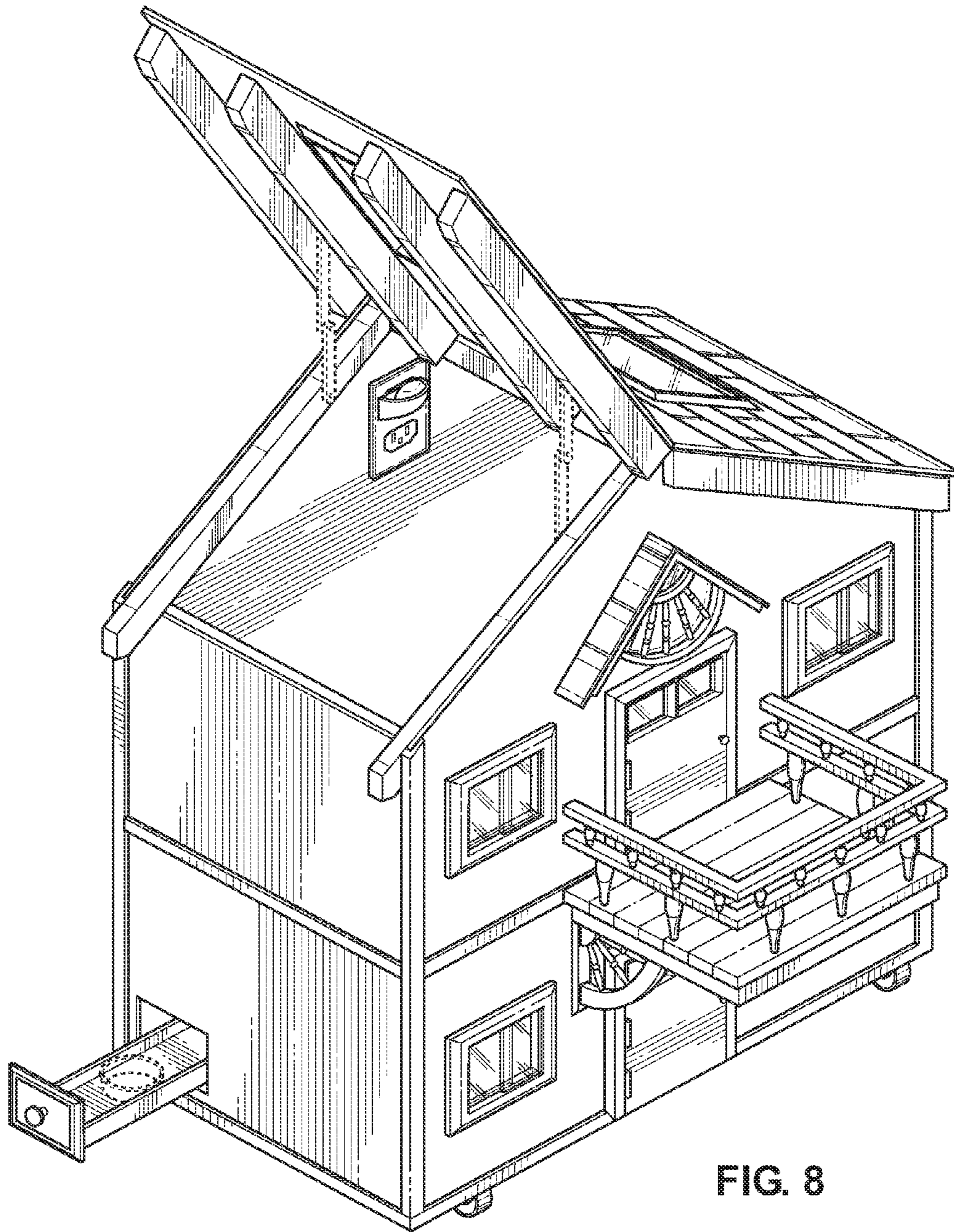

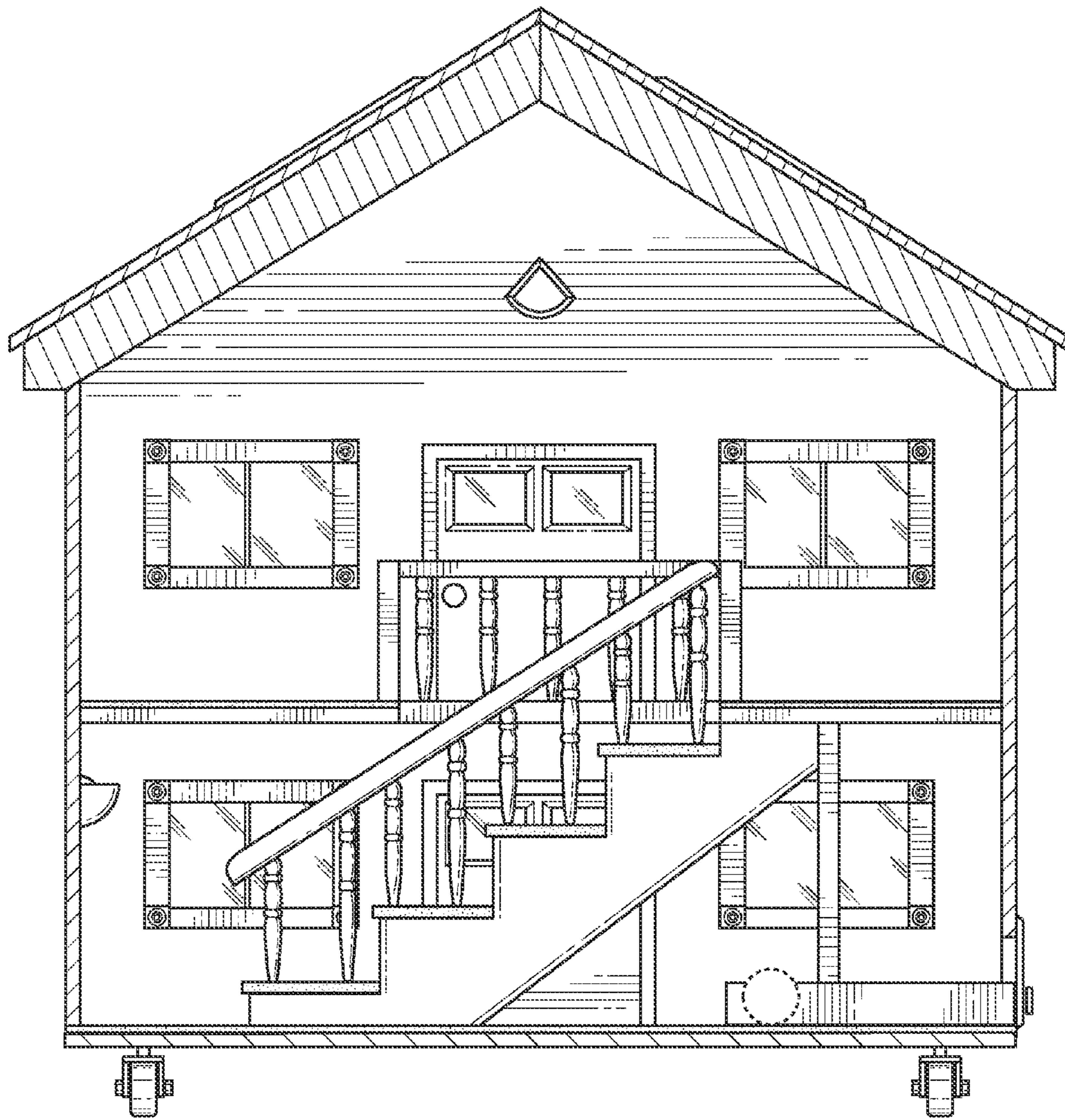

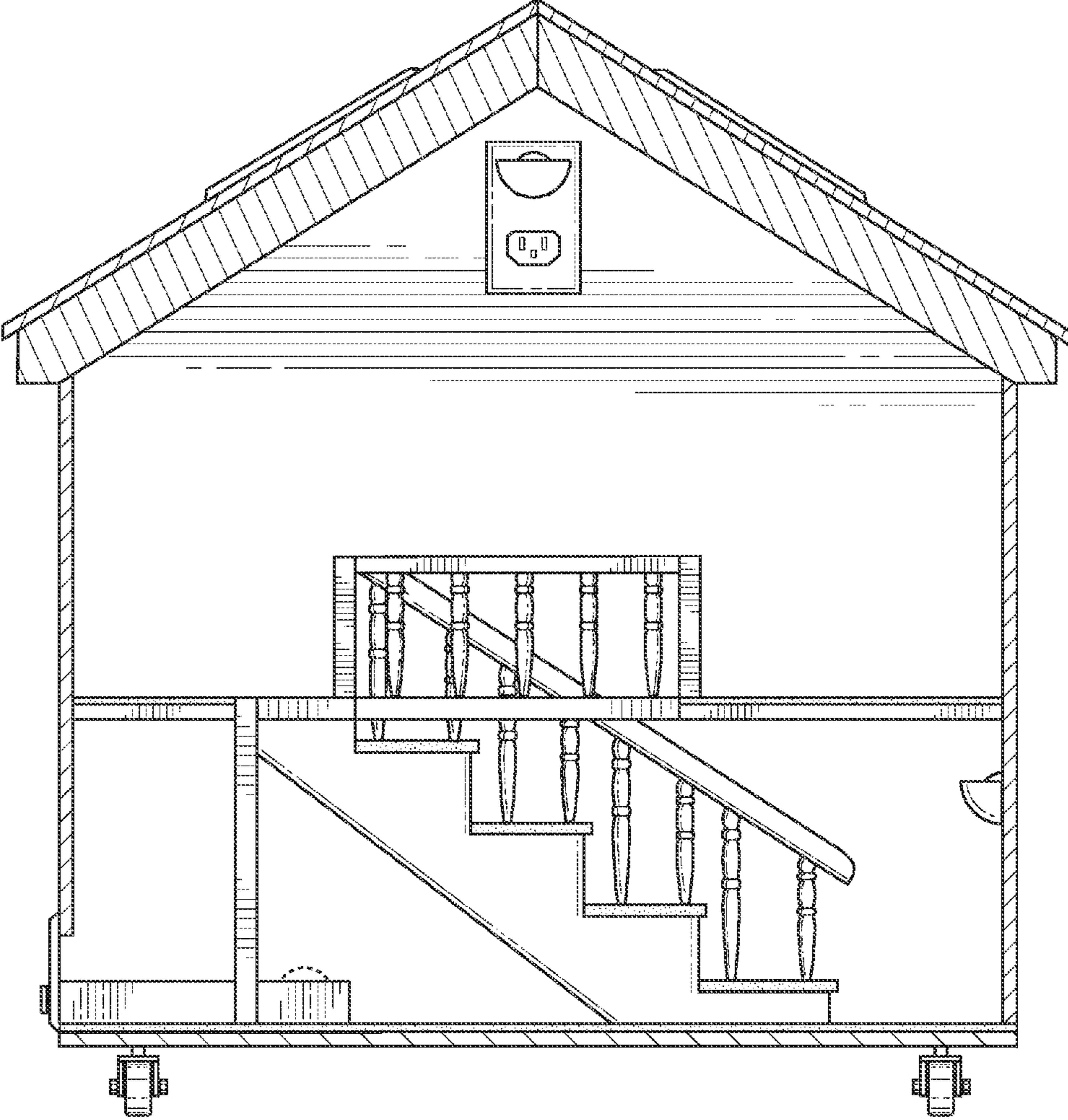

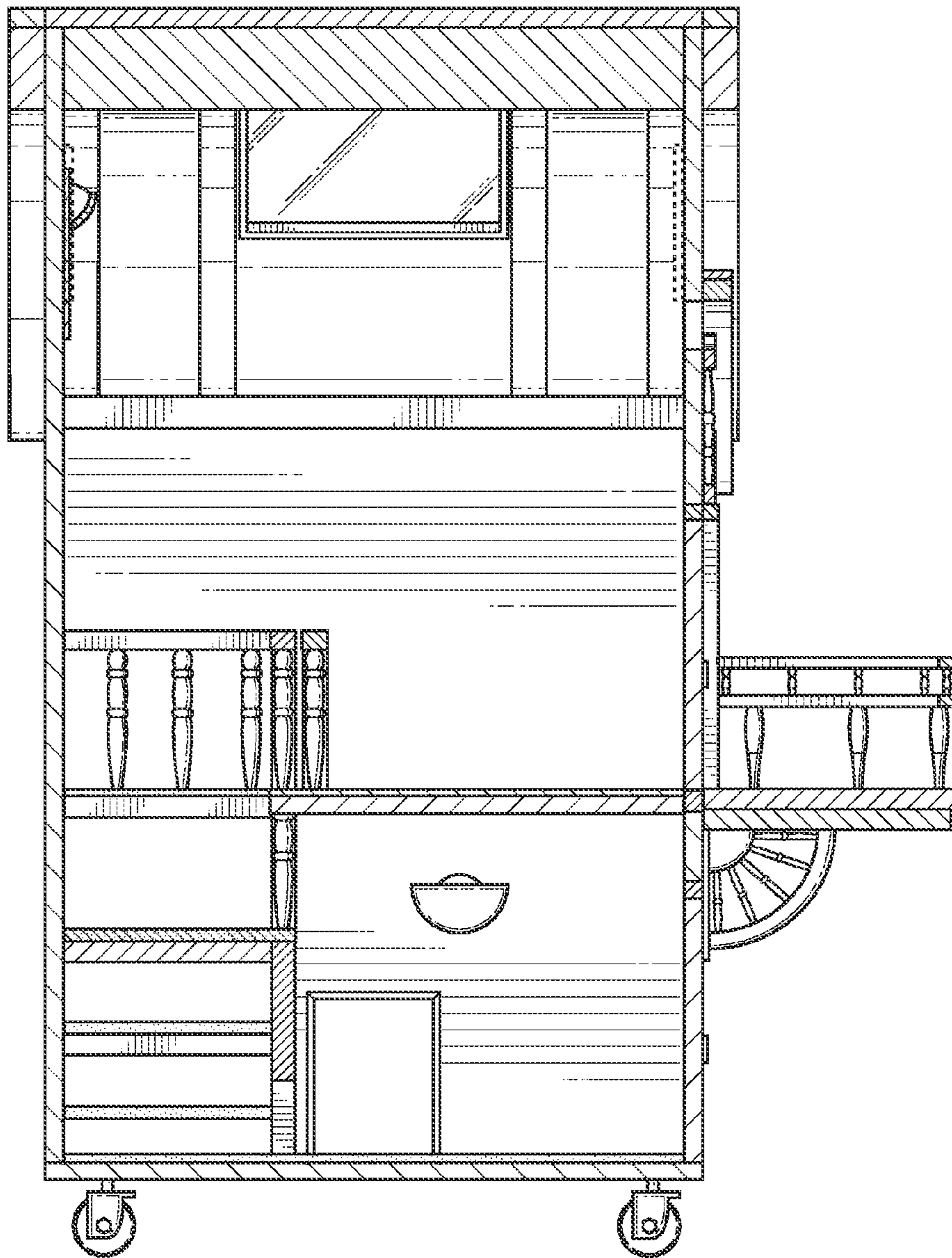

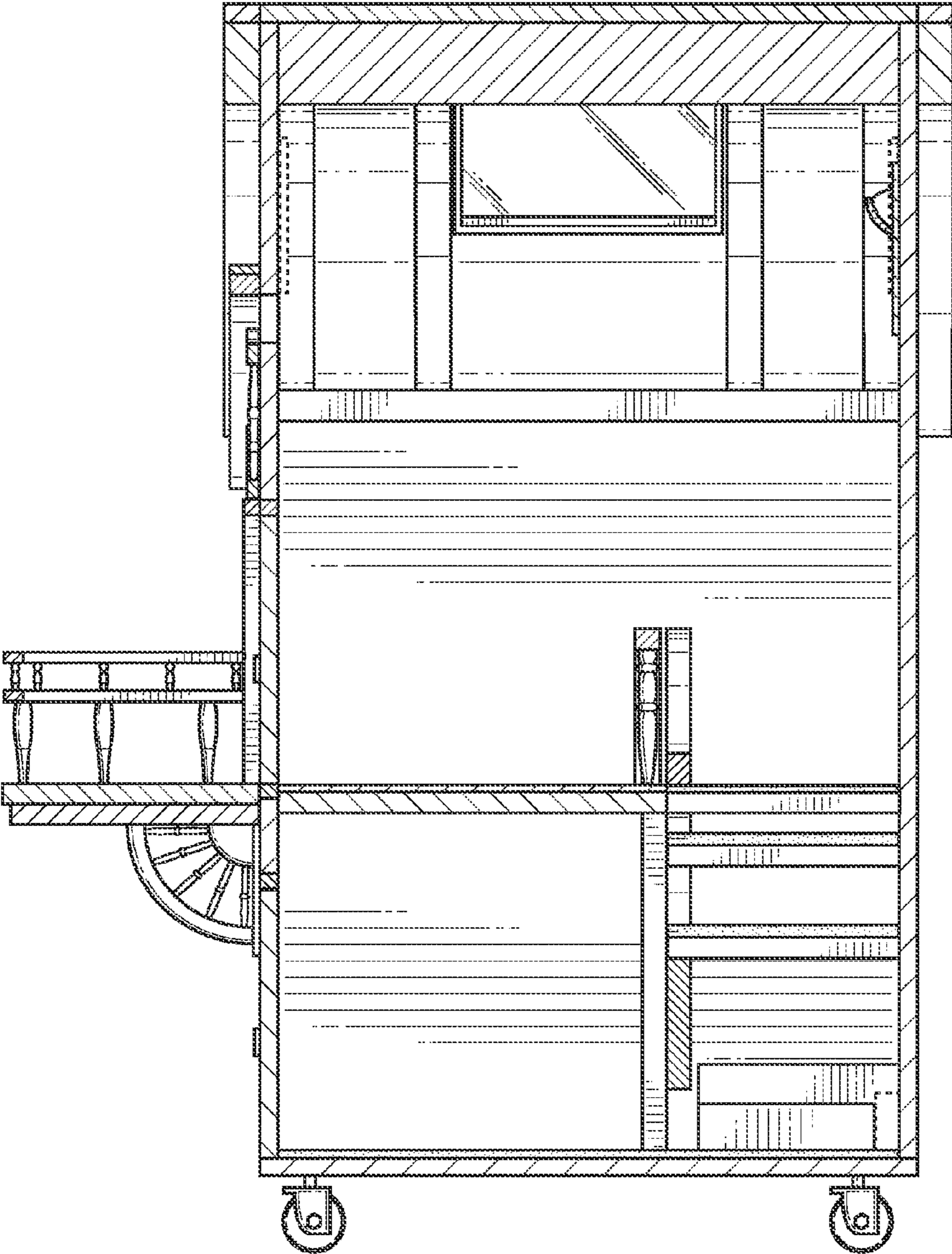
