FIG. 1 is a front perspective view of a cart showing our new design;
FIG. 2 is a side elevation view of the right and left sides, which are mirror images, of FIG. 1.
FIG. 3 is a top plan view of FIG. 1.

FIG. 5 is a back side elevation view of FIG. 1; and,

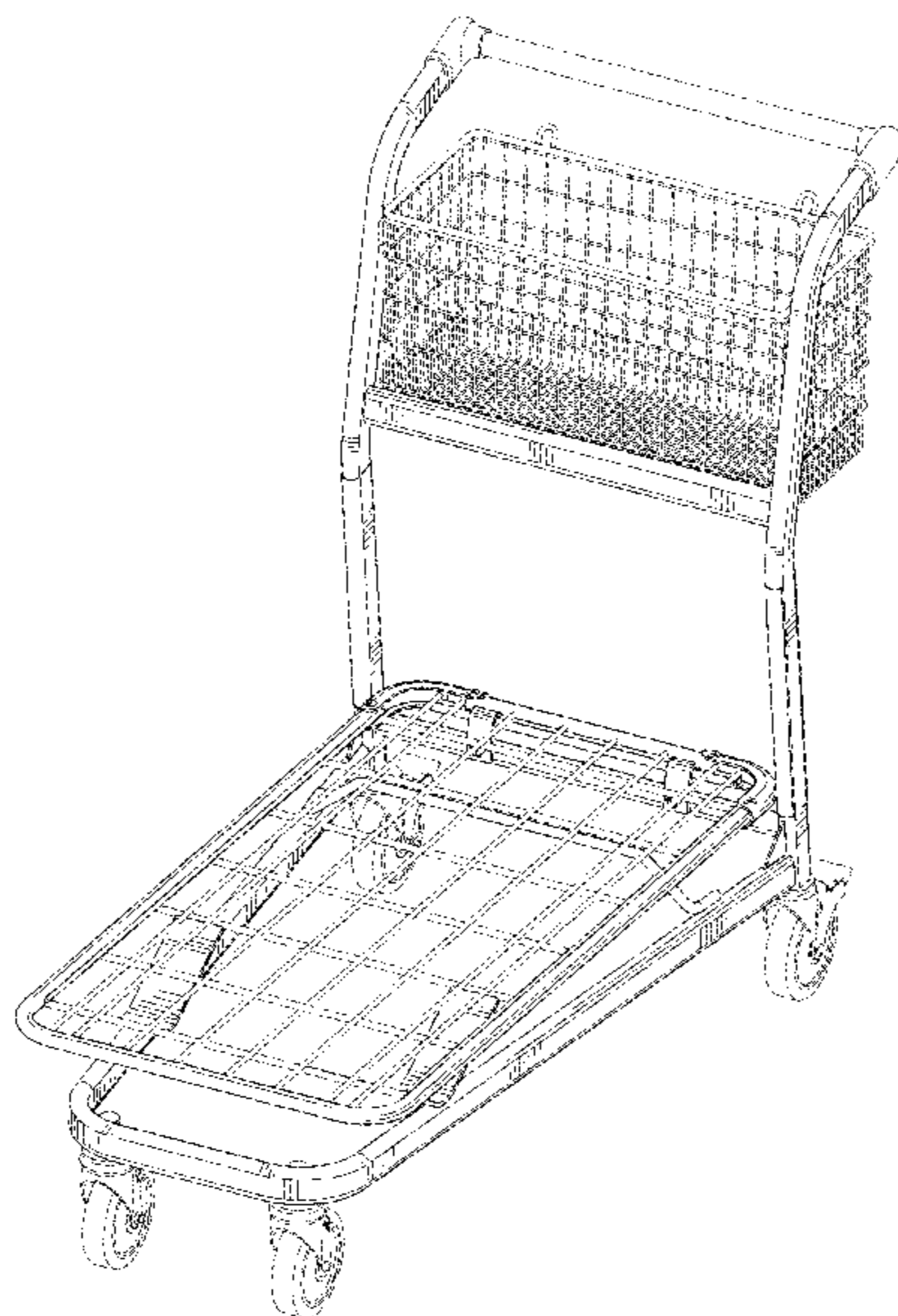

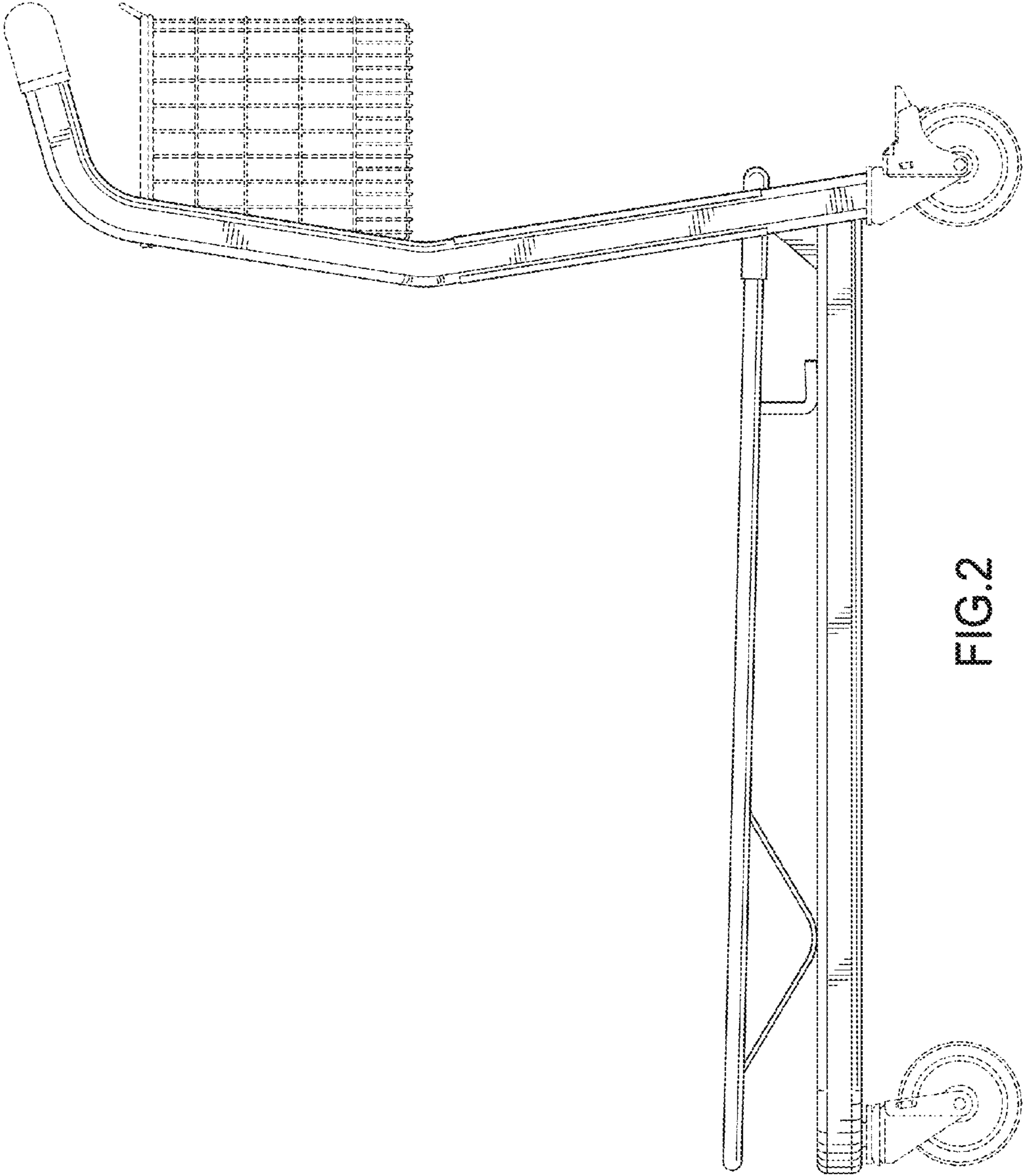

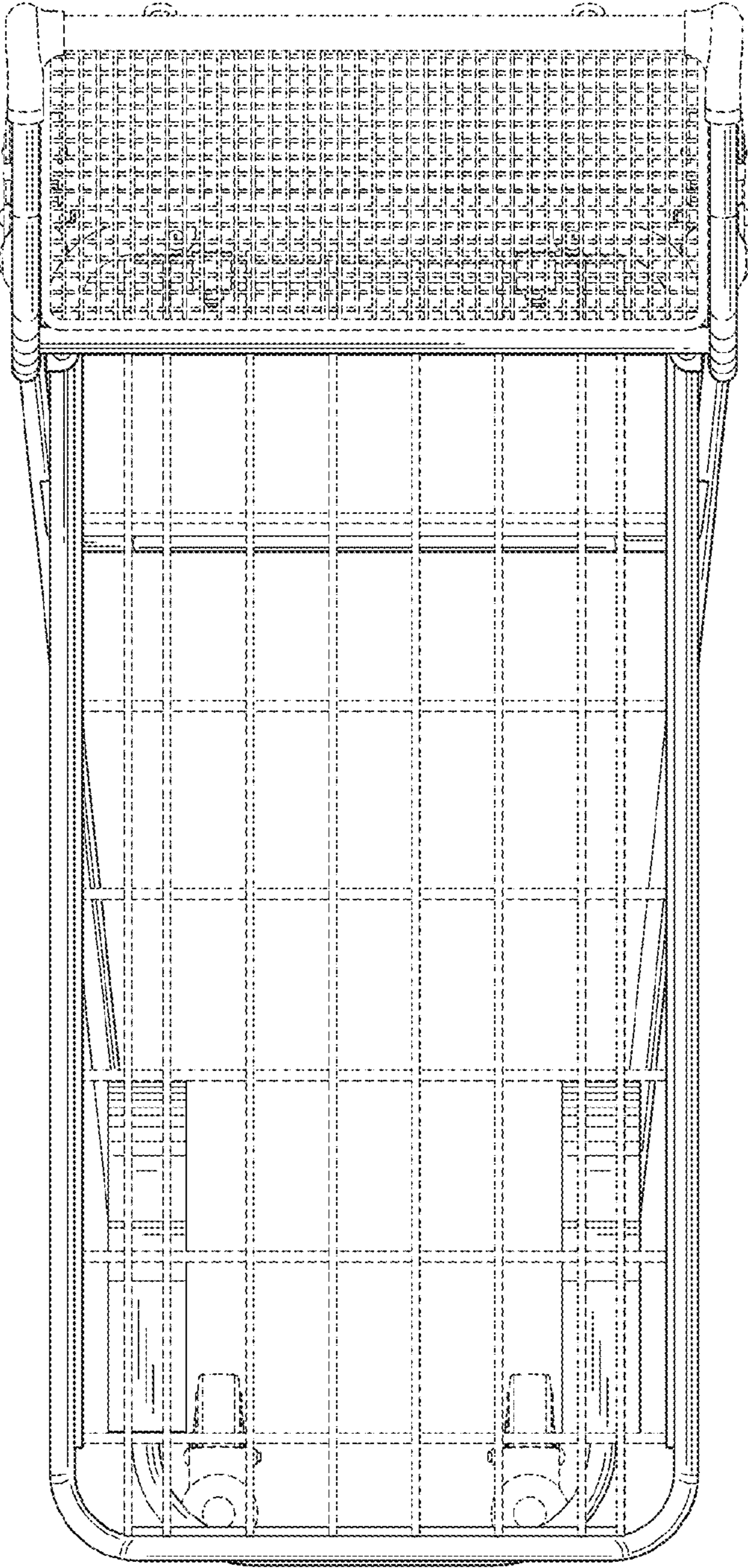

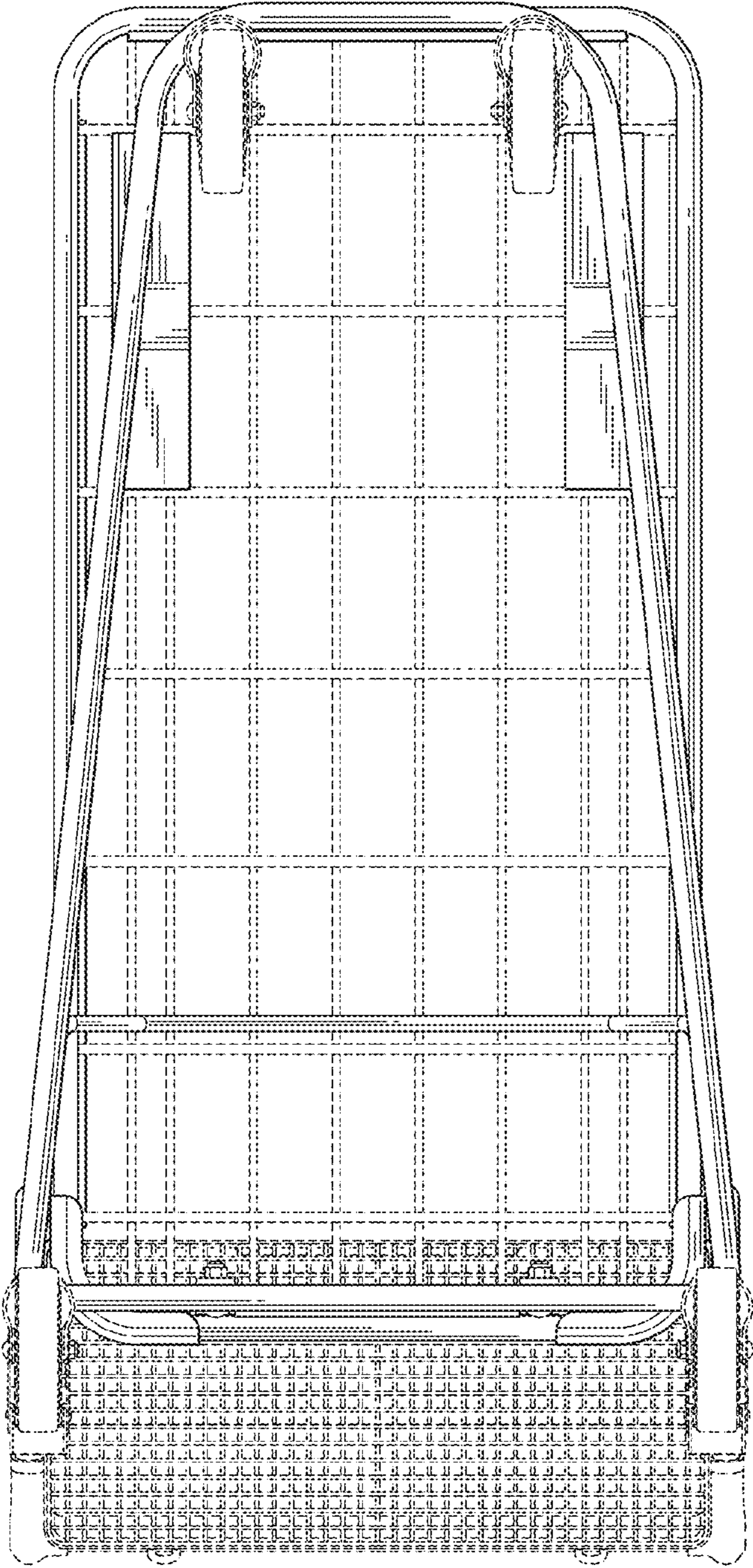

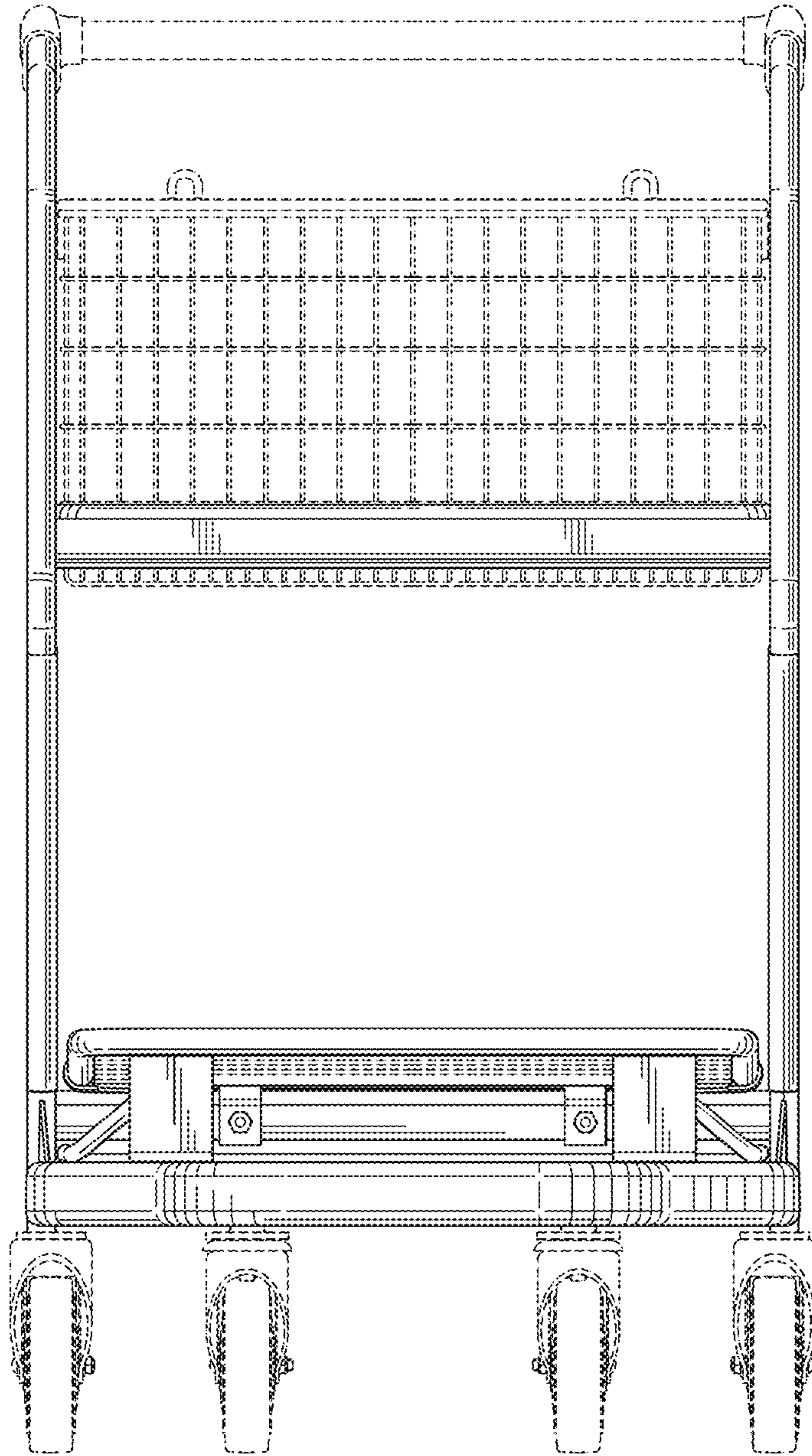

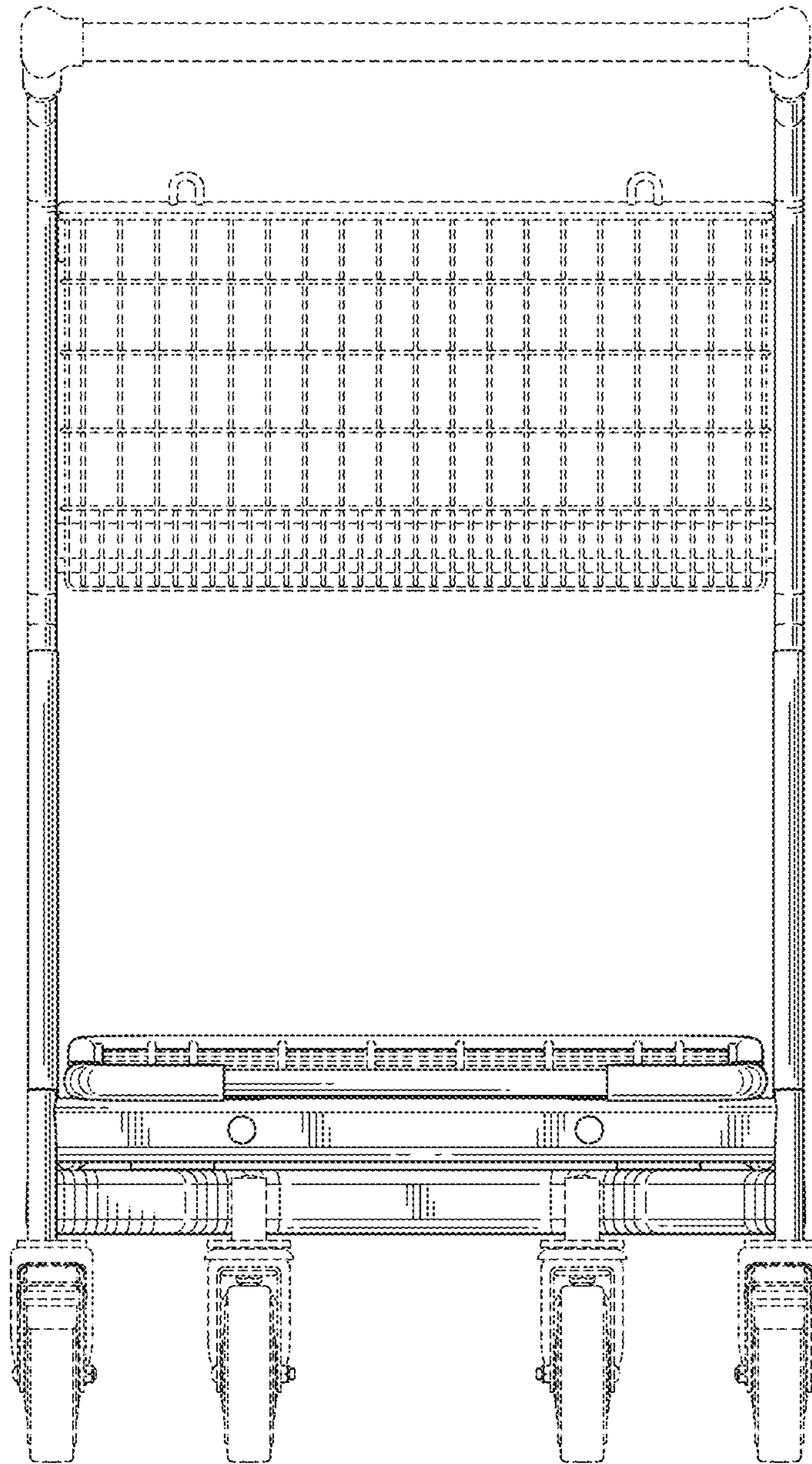
