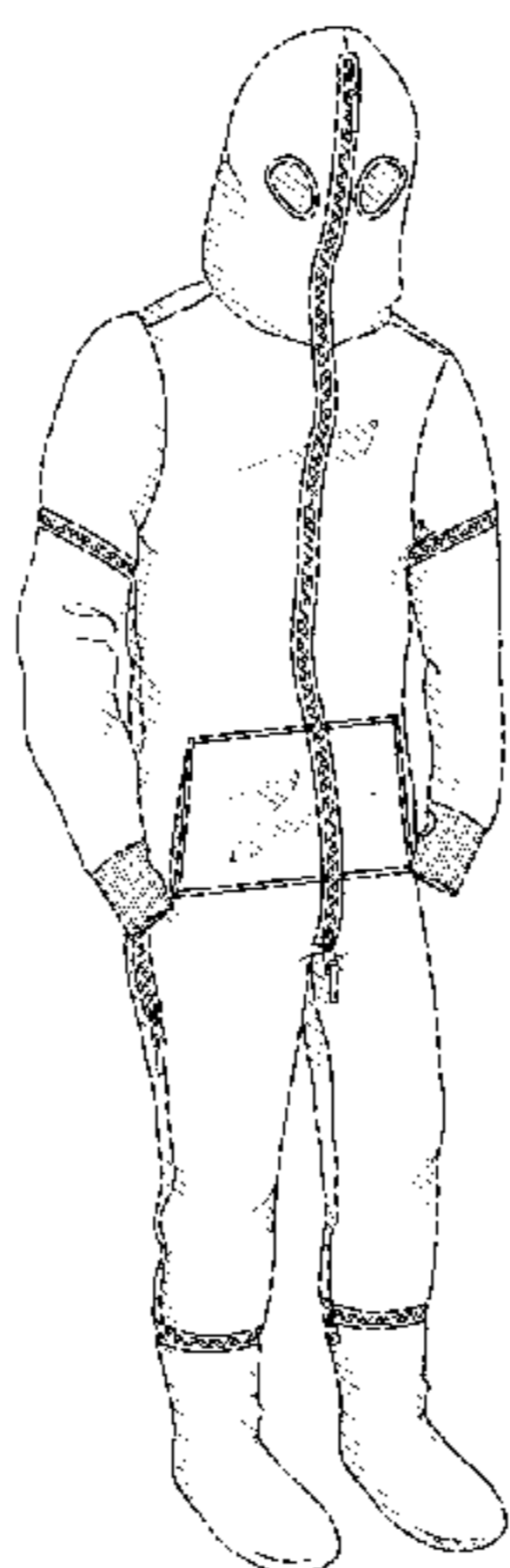
(57) **CLAIM**

The ornamental design for a lounge wear, as shown and described.

DESCRIPTION

FIG. 1 is a perspective front view of a lounge wear; FIG. 2 is a front elevation view of the lounge wear; FIG. 3 is a rear elevation view of the lounge wear; FIG. 4 is a left side elevation view of the lounge wear; the right side view being a mirror image thereof; FIG. 5 is a top plan view of the lounge wear; and, FIG. 6 is a bottom plan view of the lounge wear.

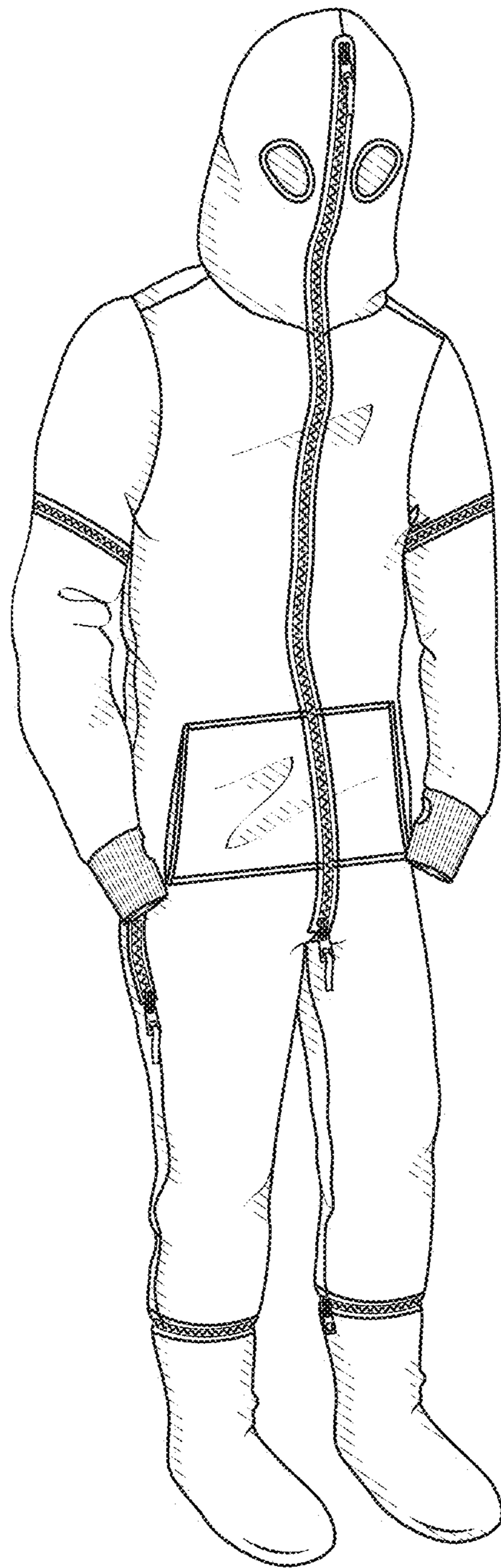

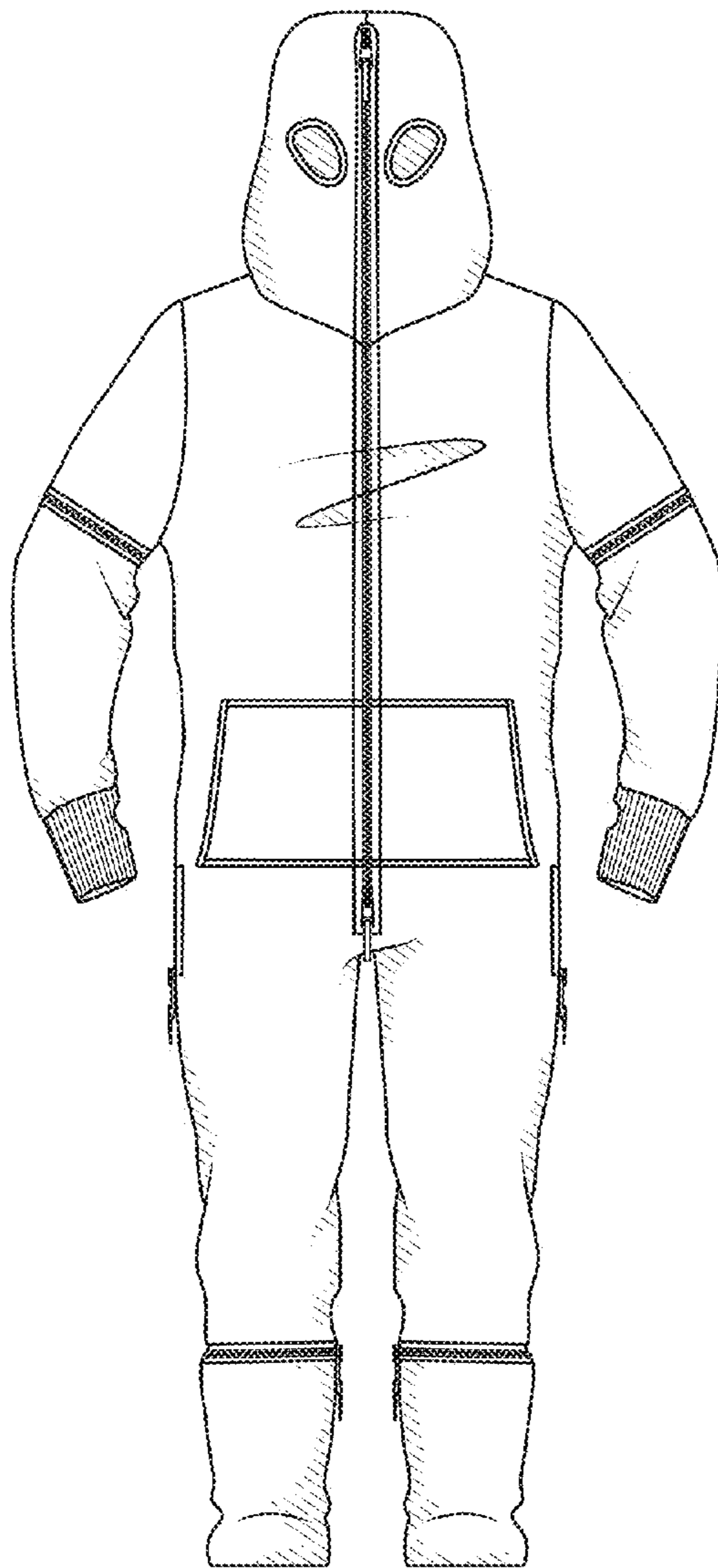

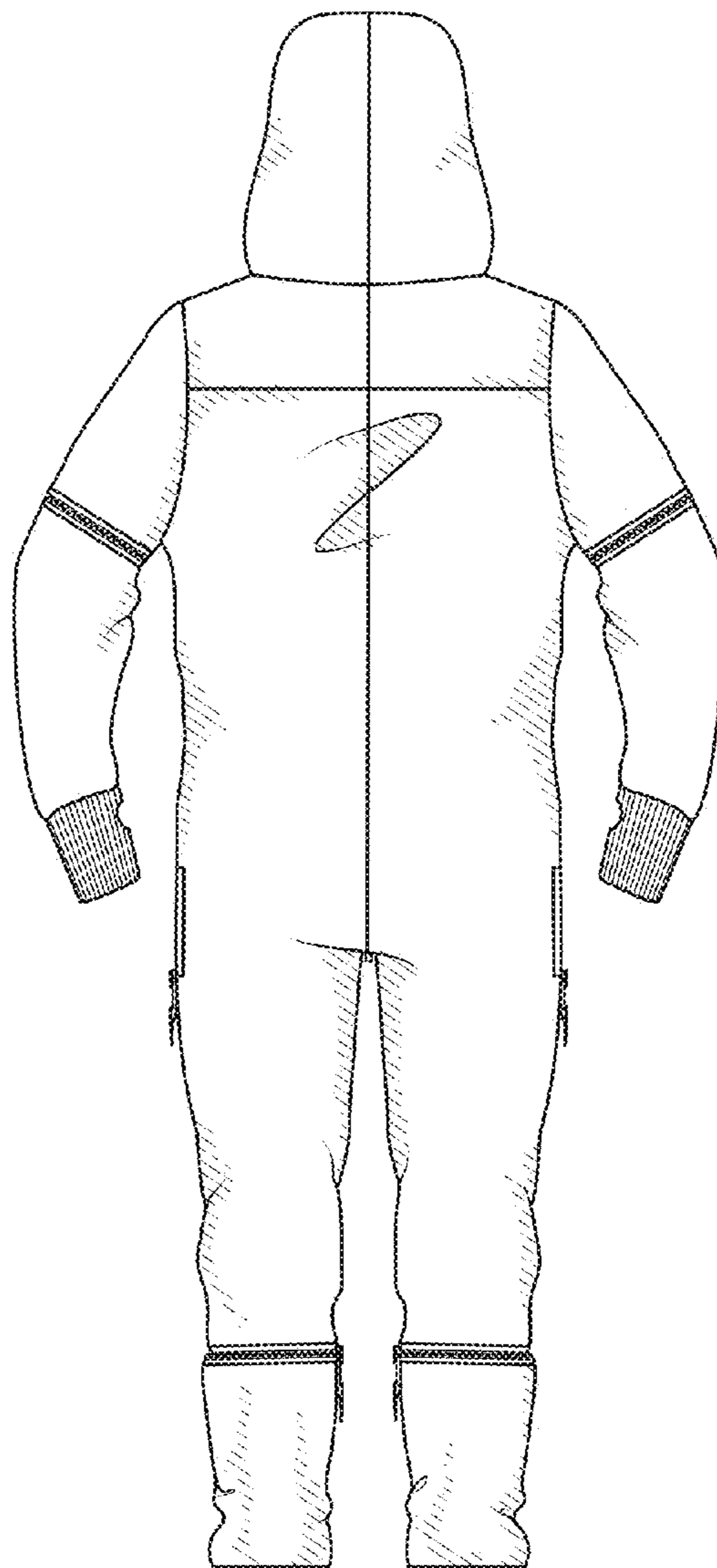

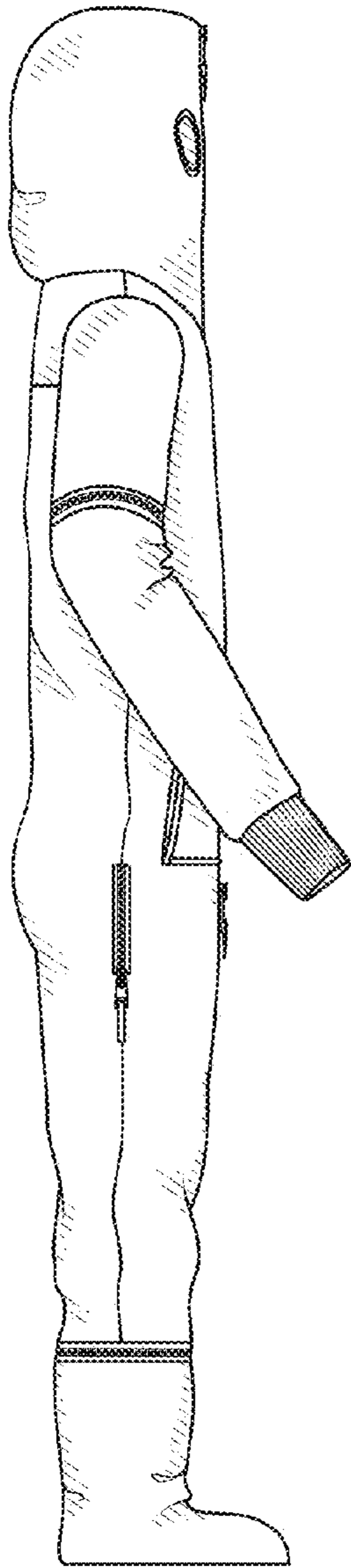

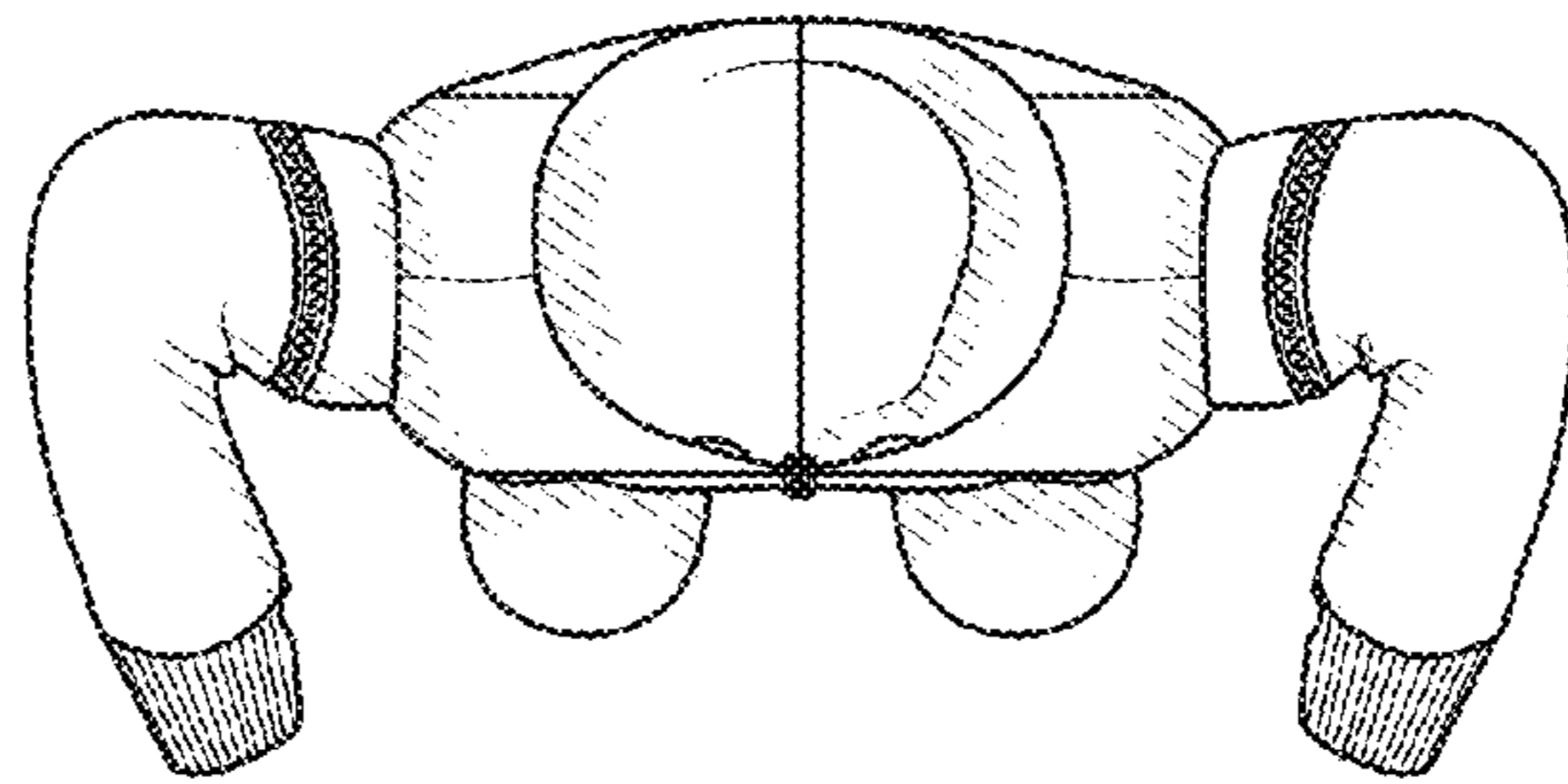

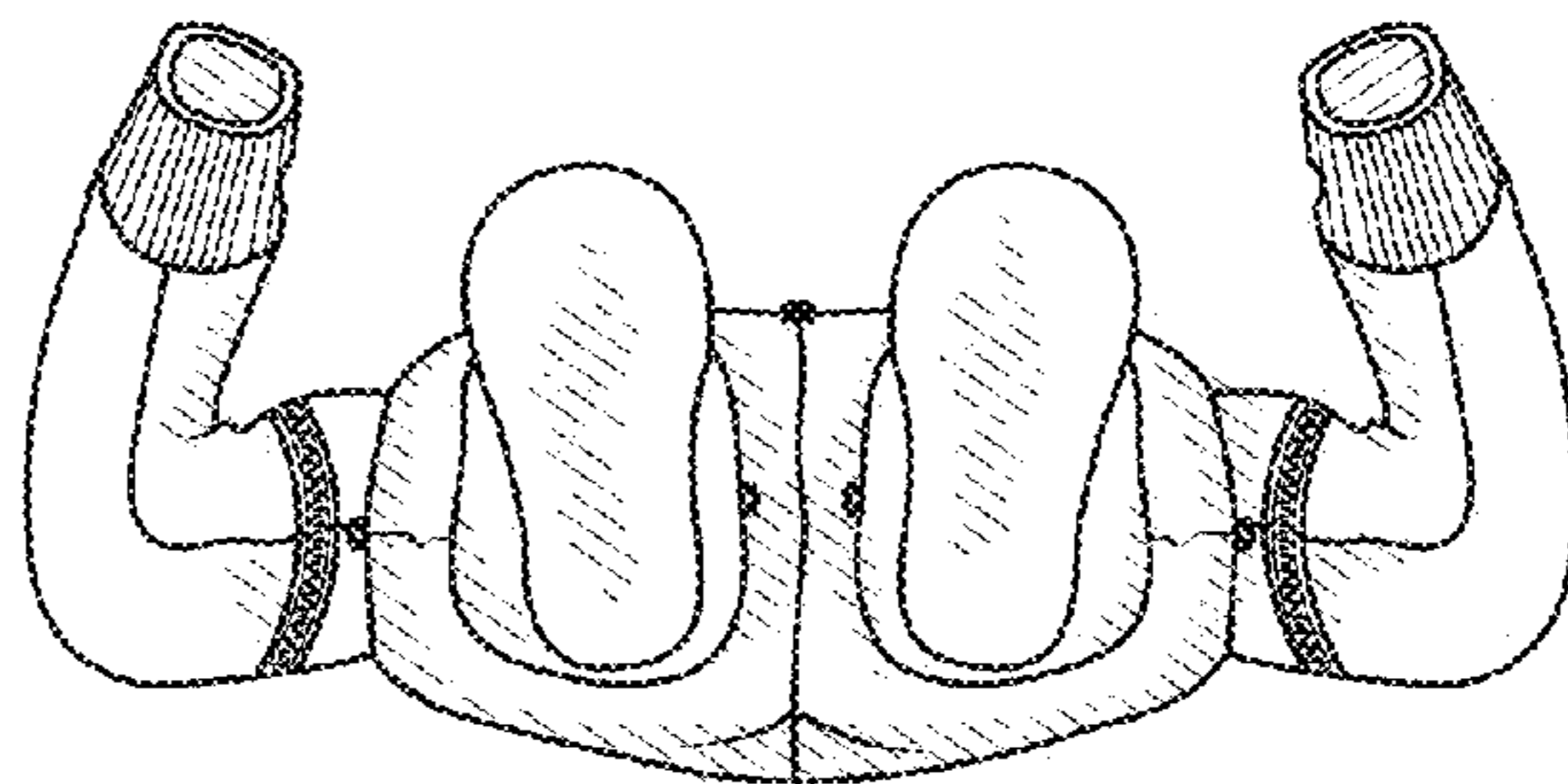
